The ornamental design for an opening of an aircraft compartment, as shown and described.

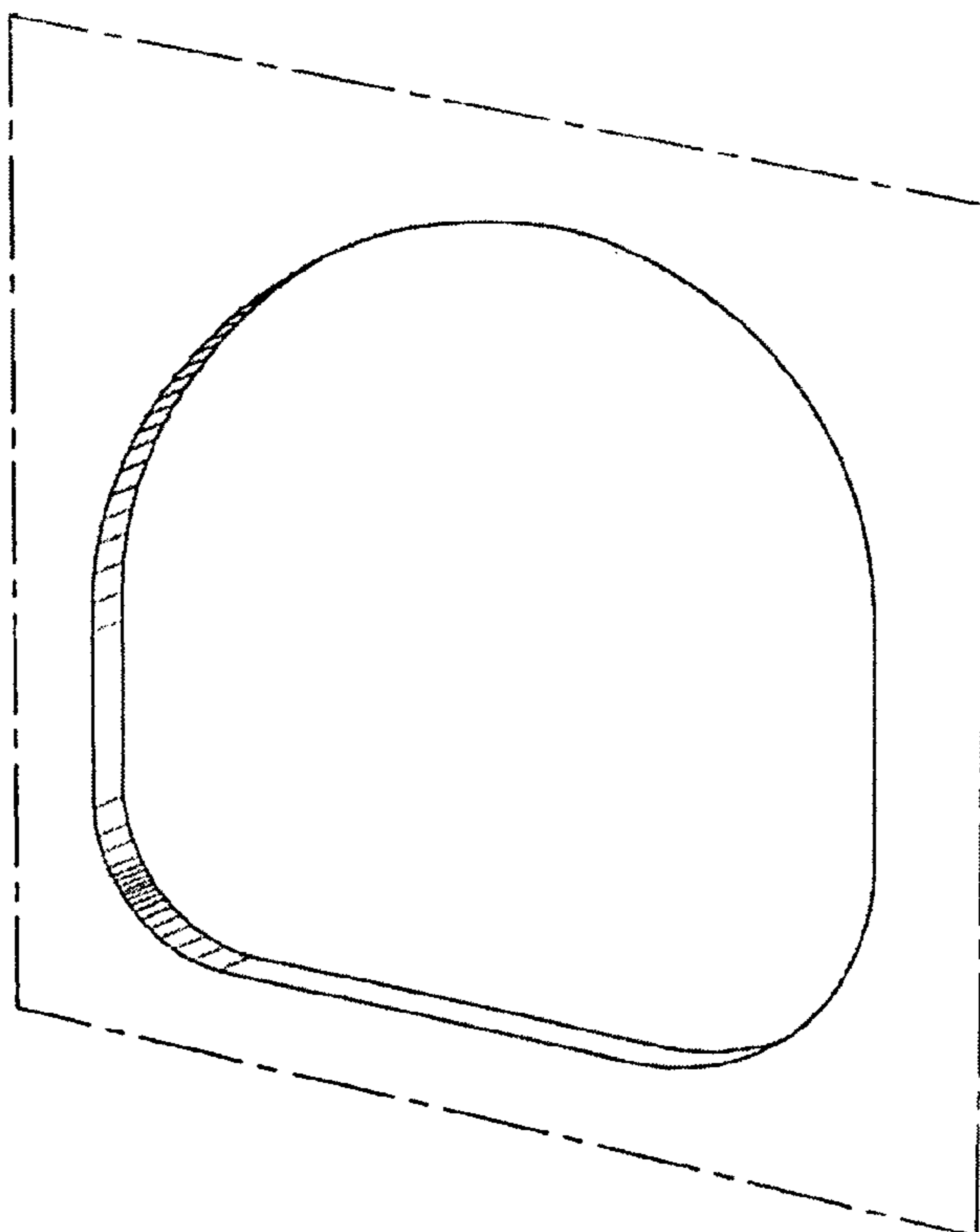
DESCRIPTION

FIG. 1 is a front view of an opening of an aircraft compartment, showing our design, the rear view being a mirror image of the front view; and,

FIG. 2 is a front left perspective view thereof.

The broken lines shown in FIGS. 1 and 2 are used to illustrate a surface for the opening of an aircraft compartment and forms no part of the claimed design.

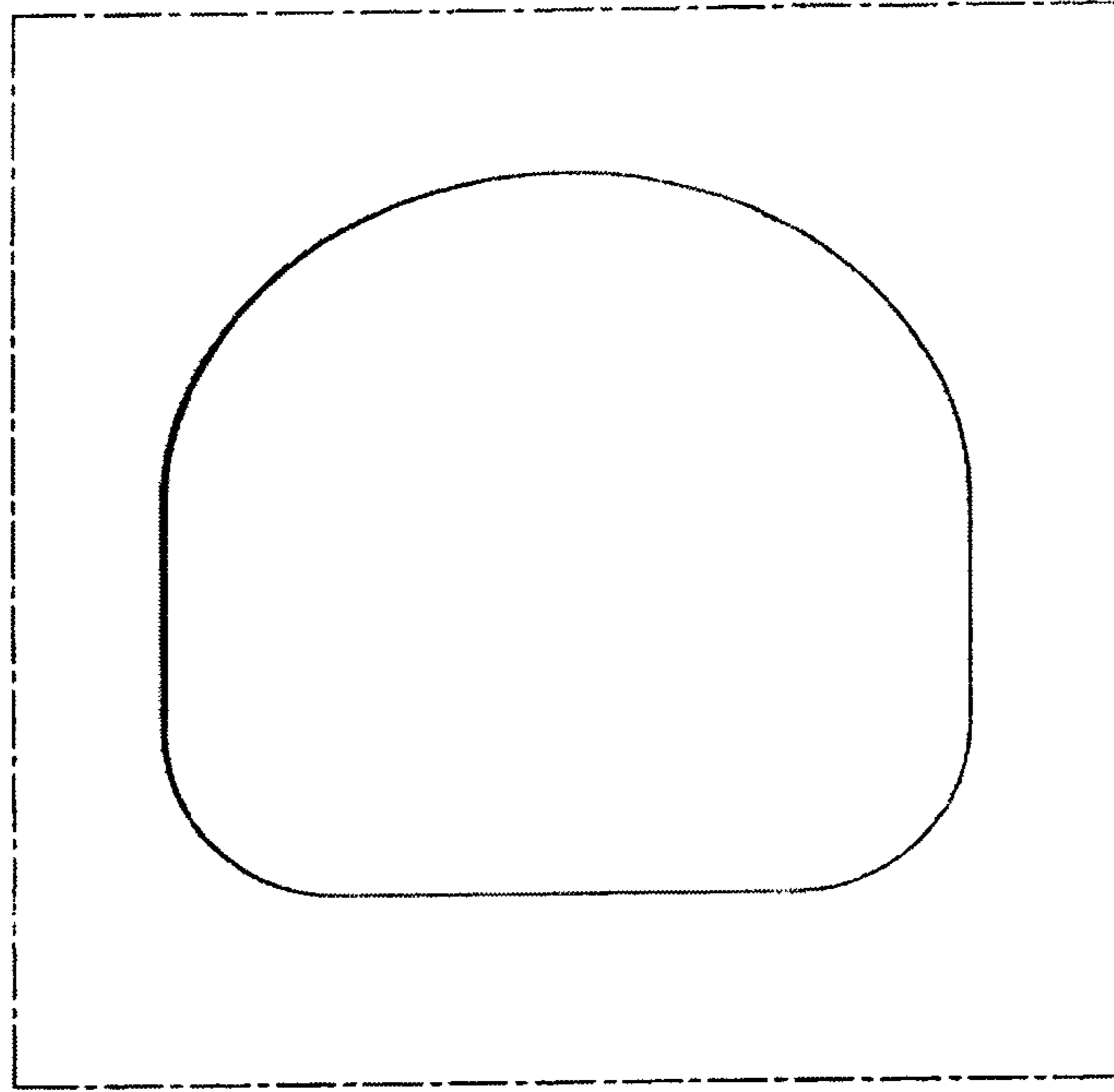

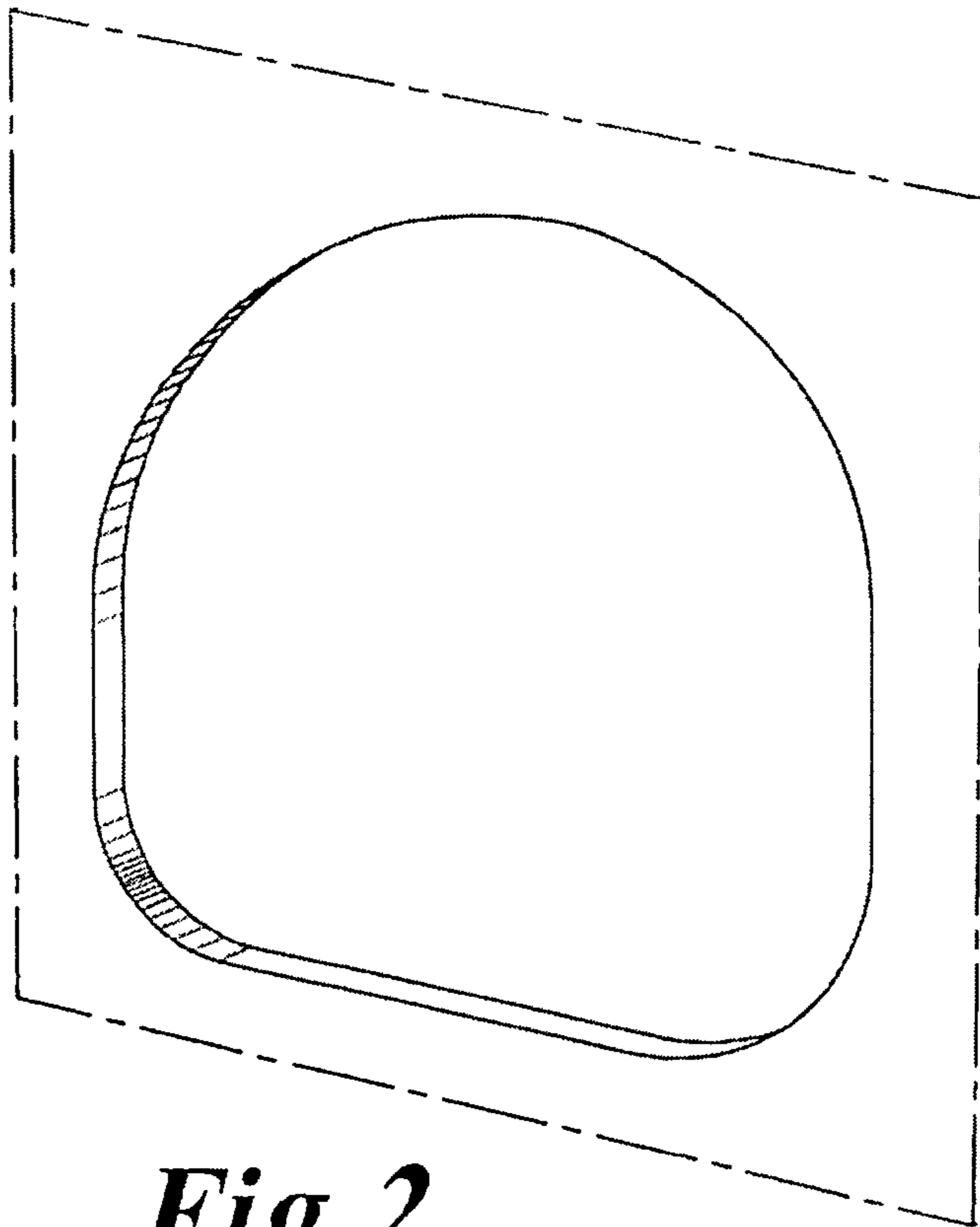
