FIG. 3 is a rear elevation view of said portable battery pack of FIG. 1;

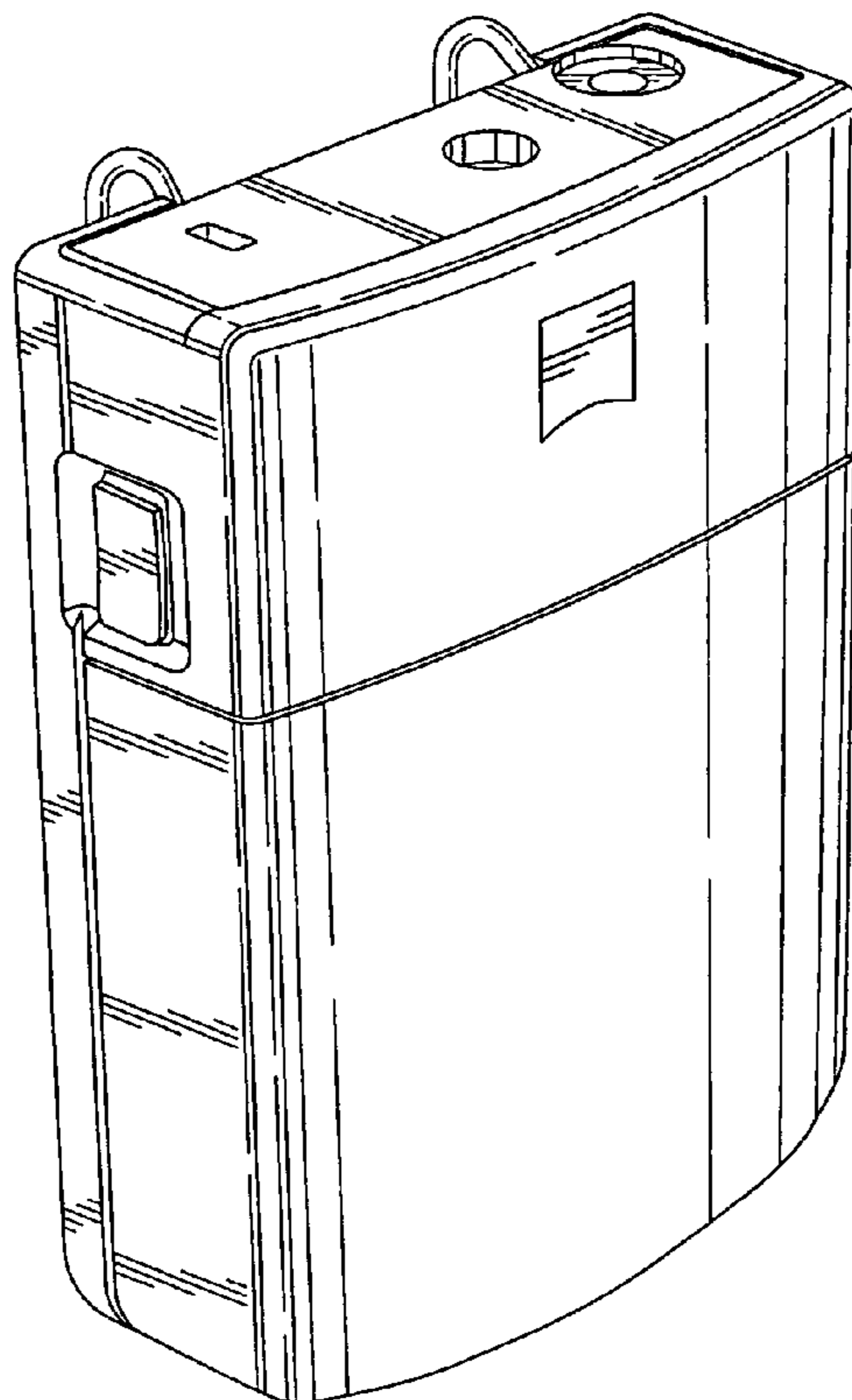
FIG. 4 is a right side elevation view of said portable battery pack of FIG. 1;

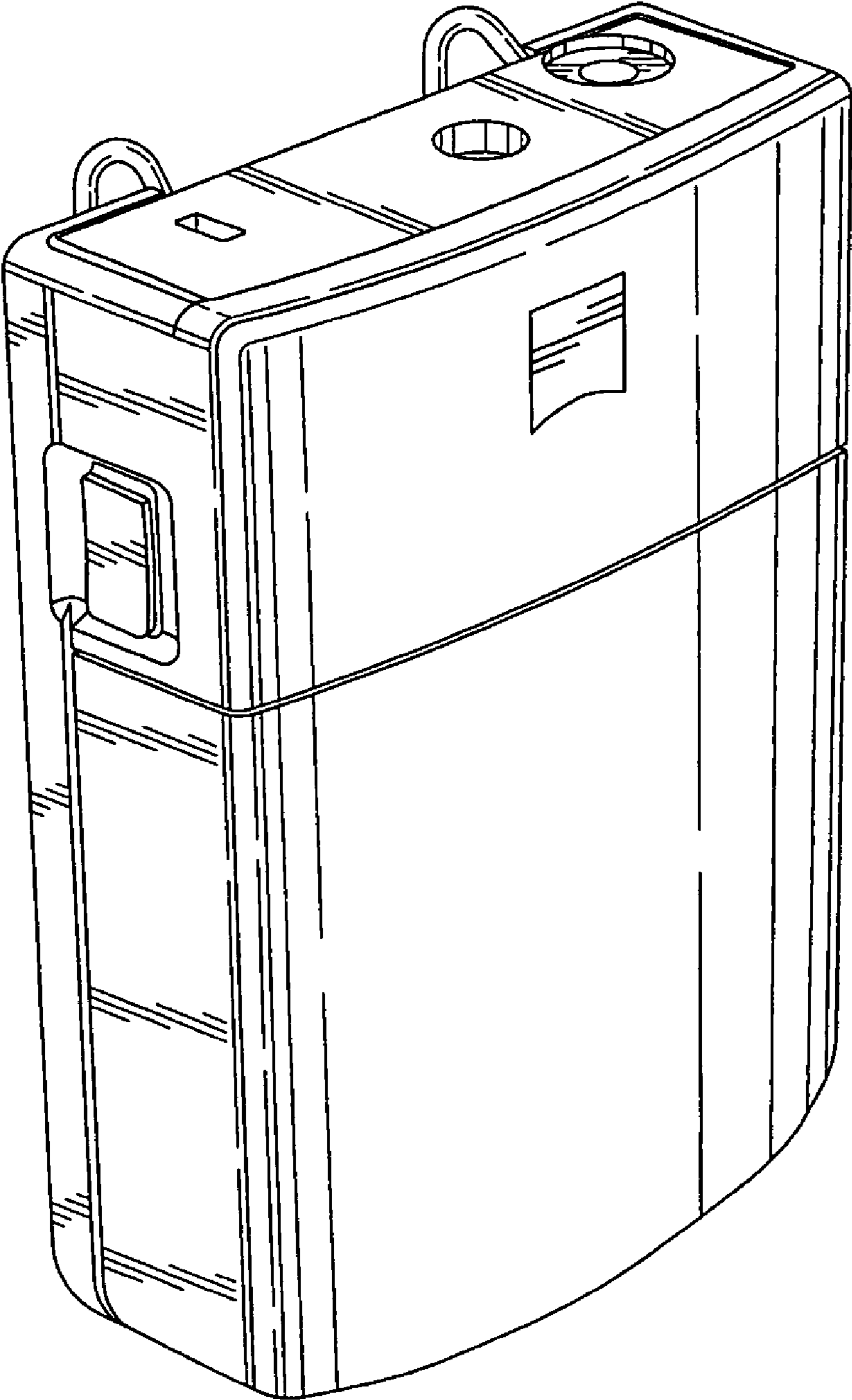

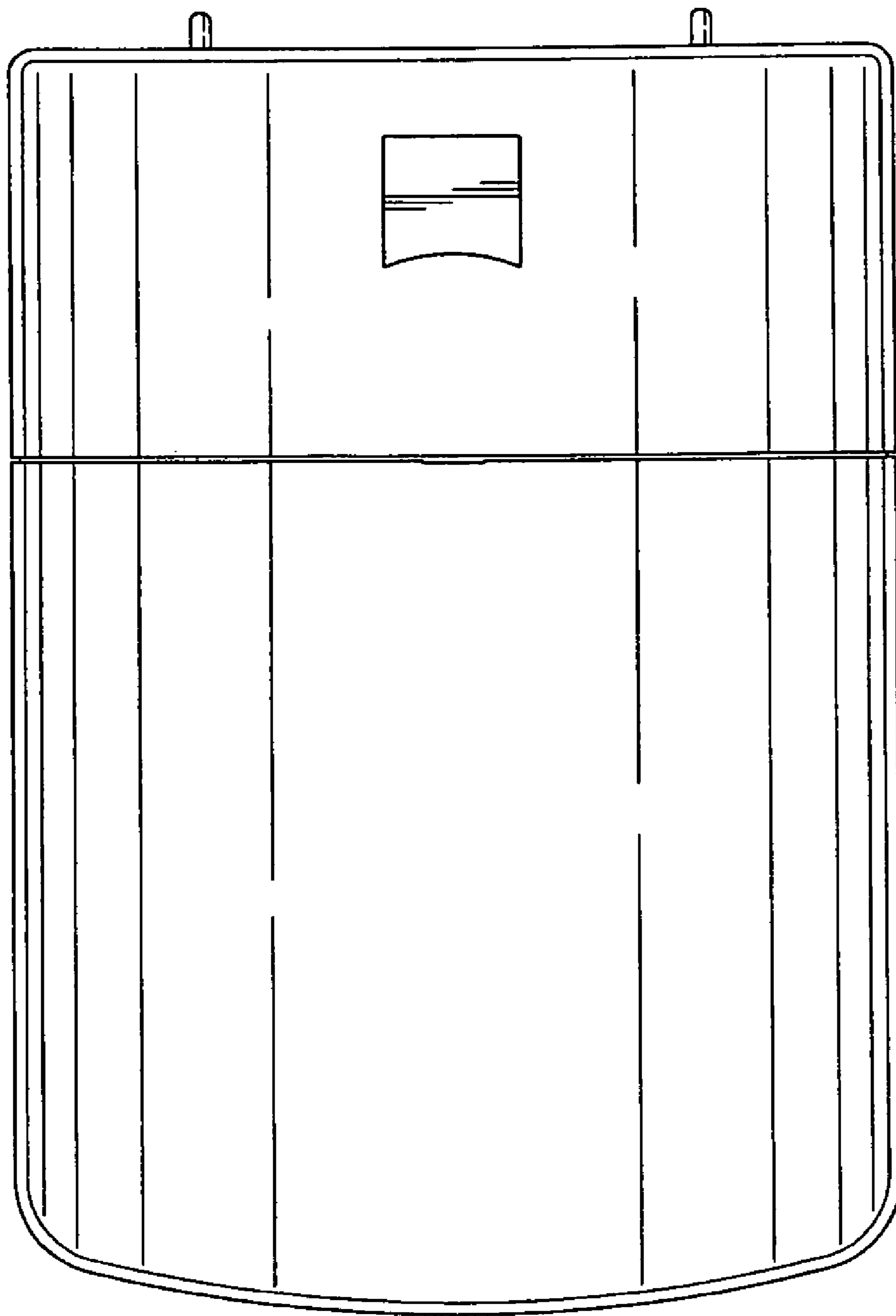

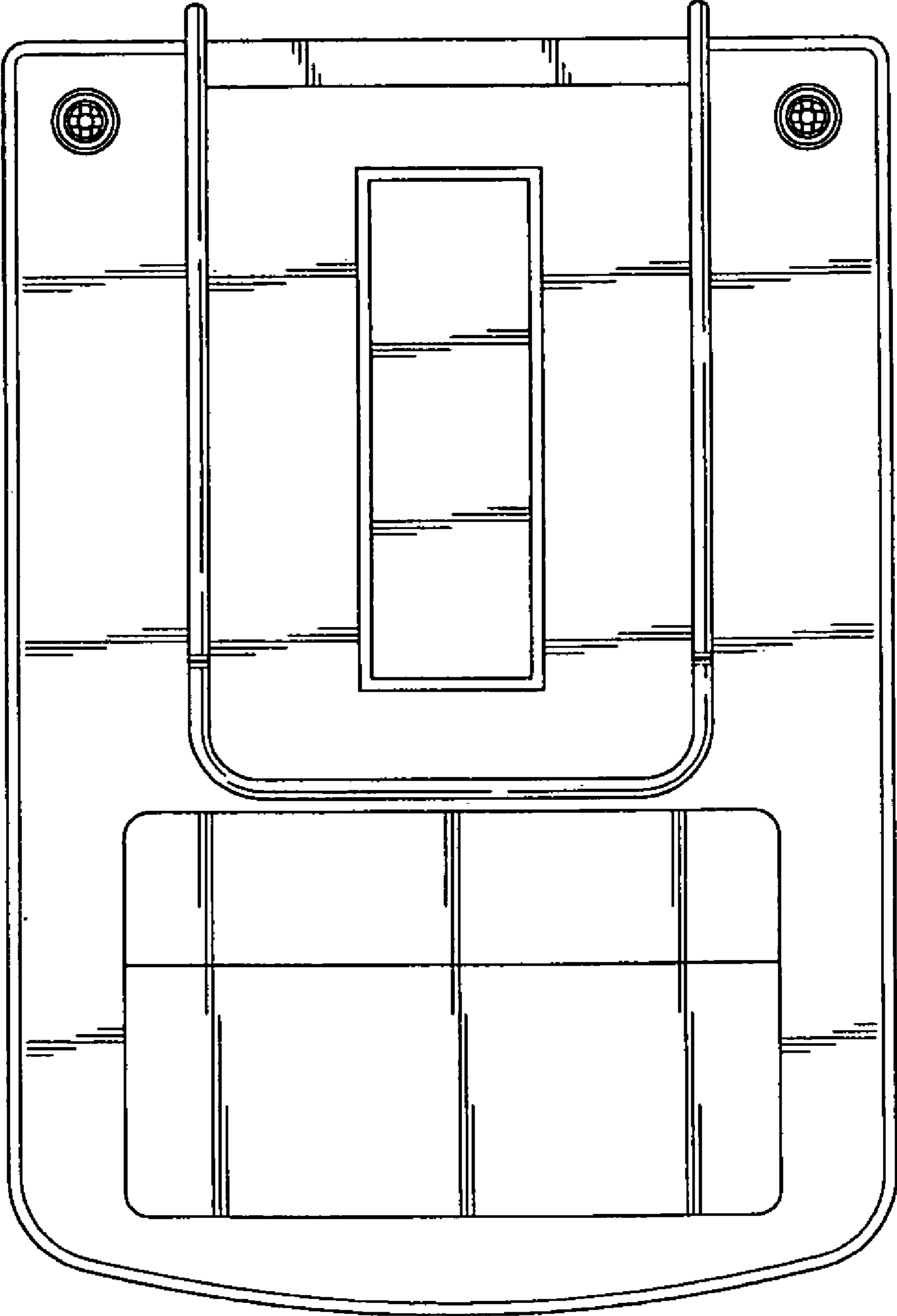

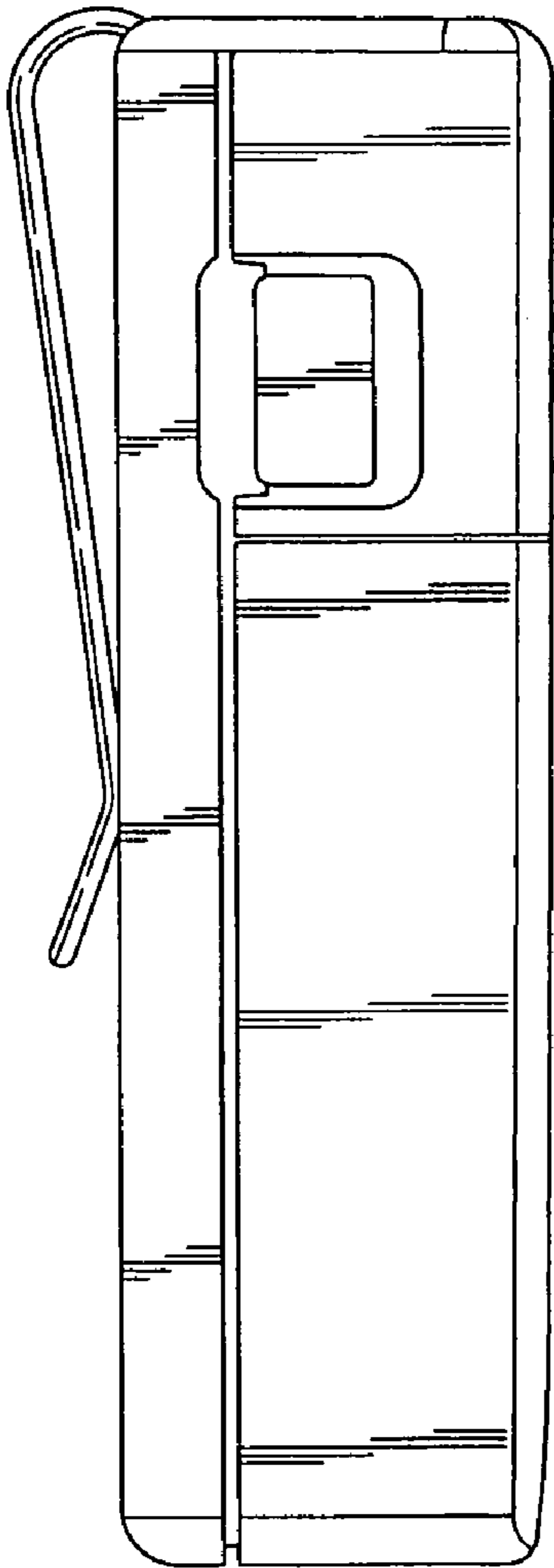

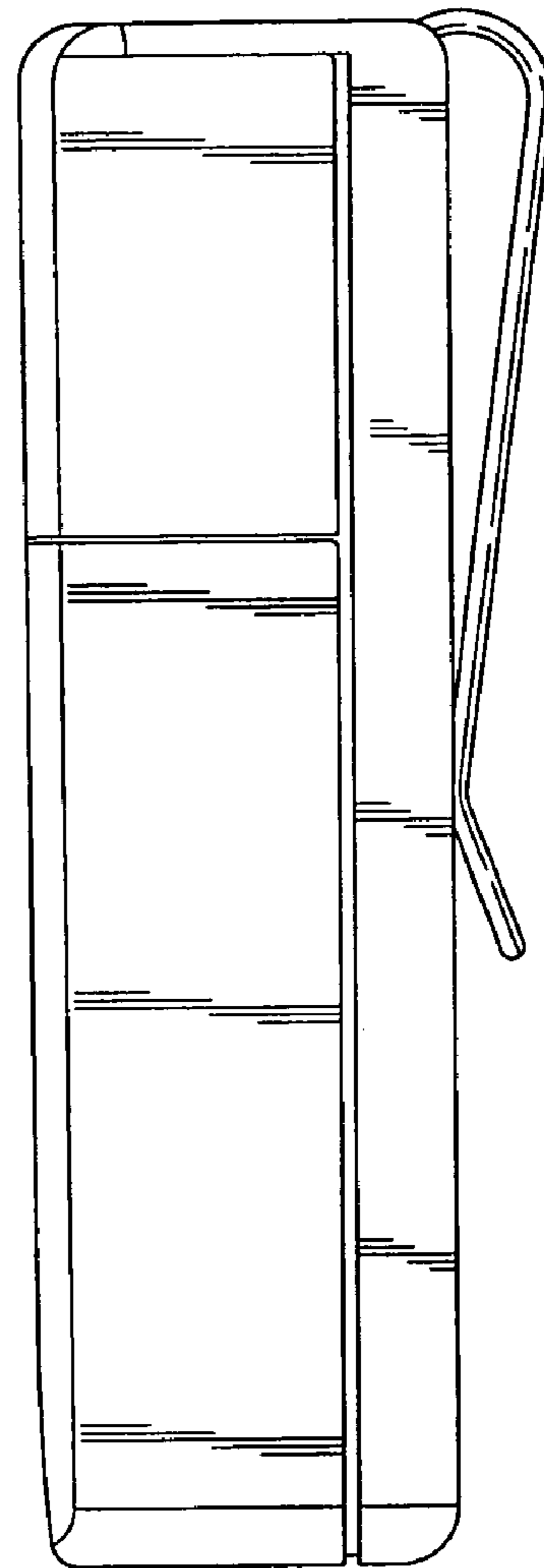

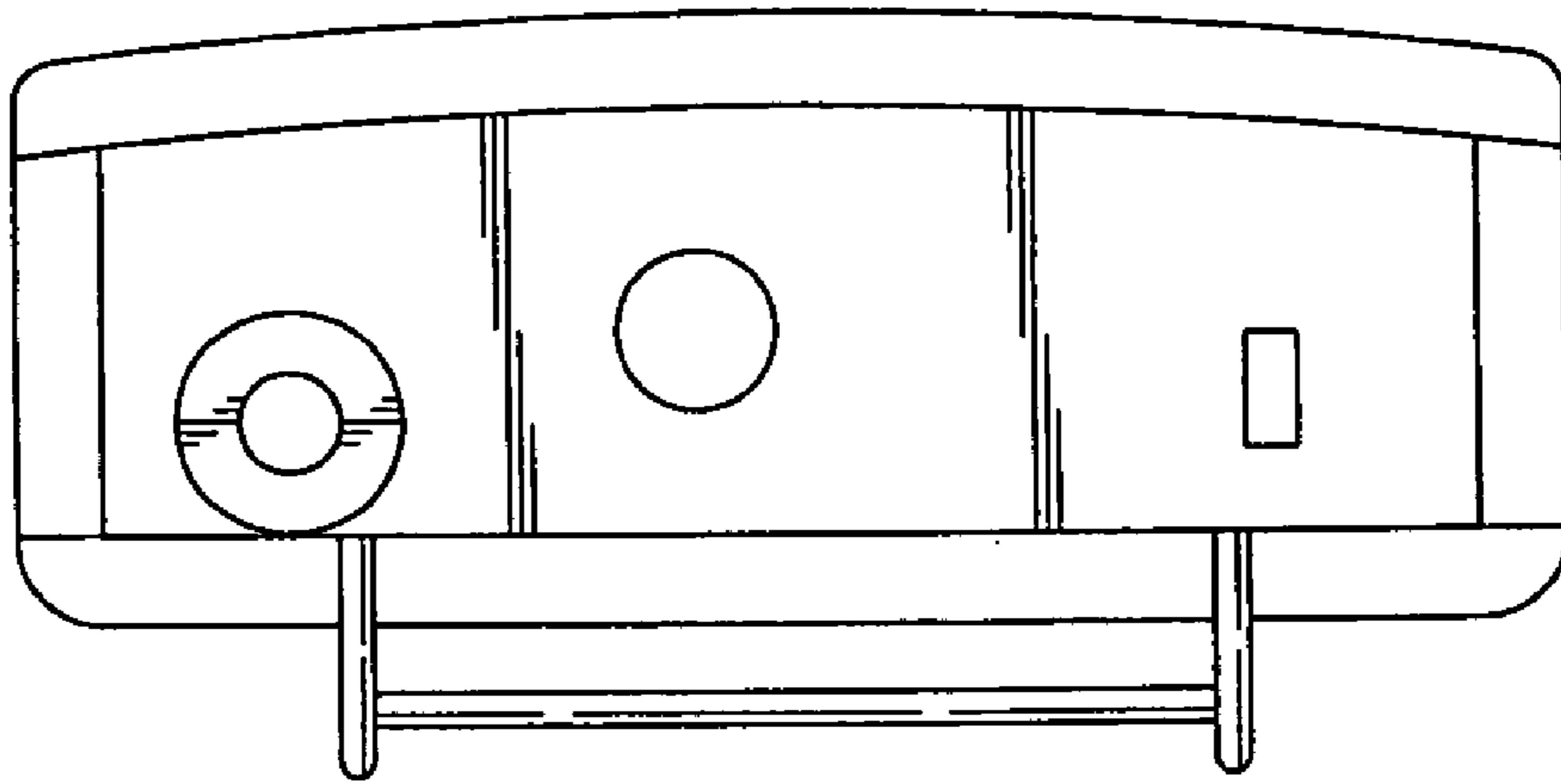

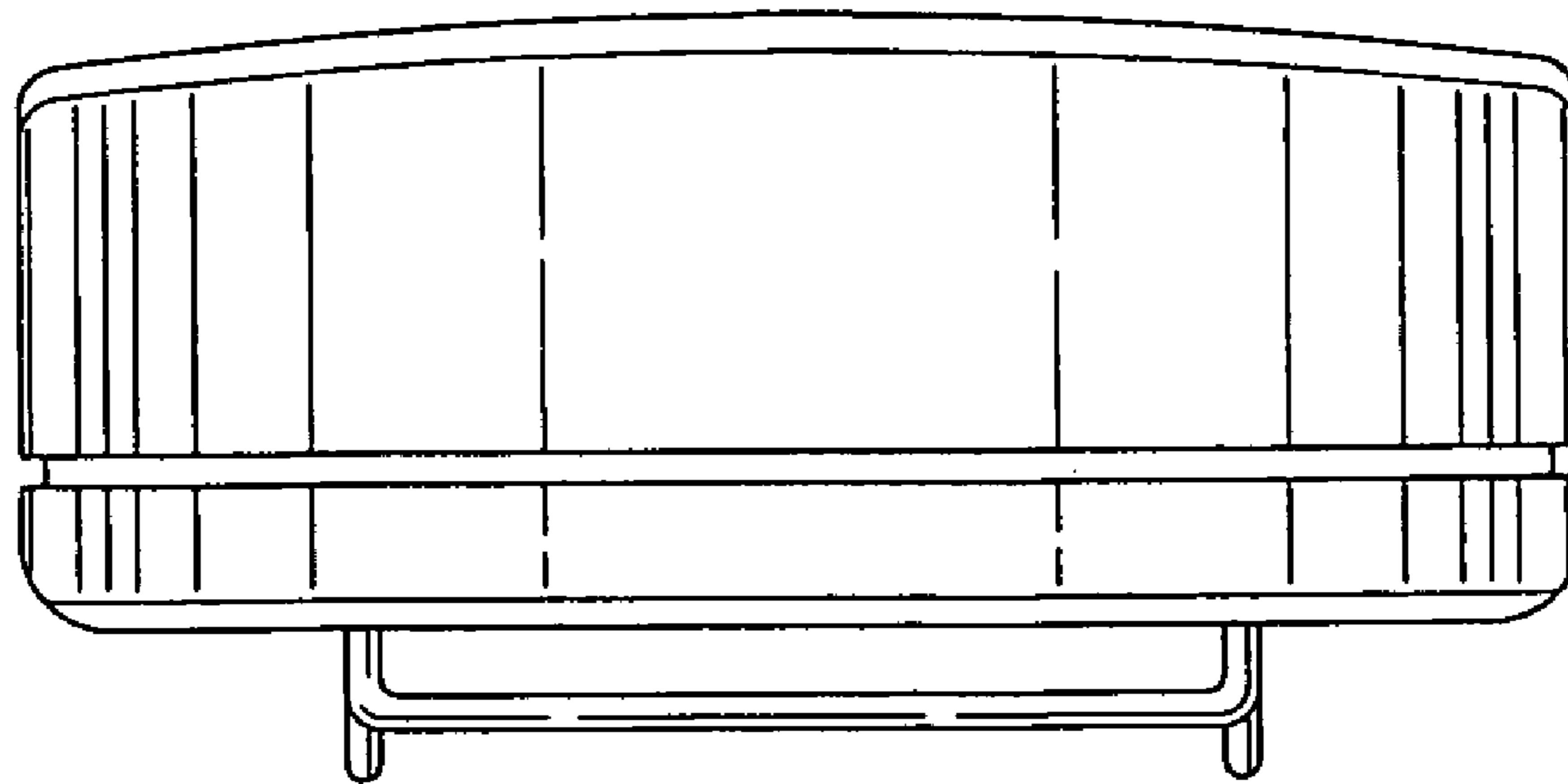
