The ornamental design for a surface mount power outlet, as shown and described.

**DESCRIPTION**

FIG. 20 is a rear elevational view thereof;

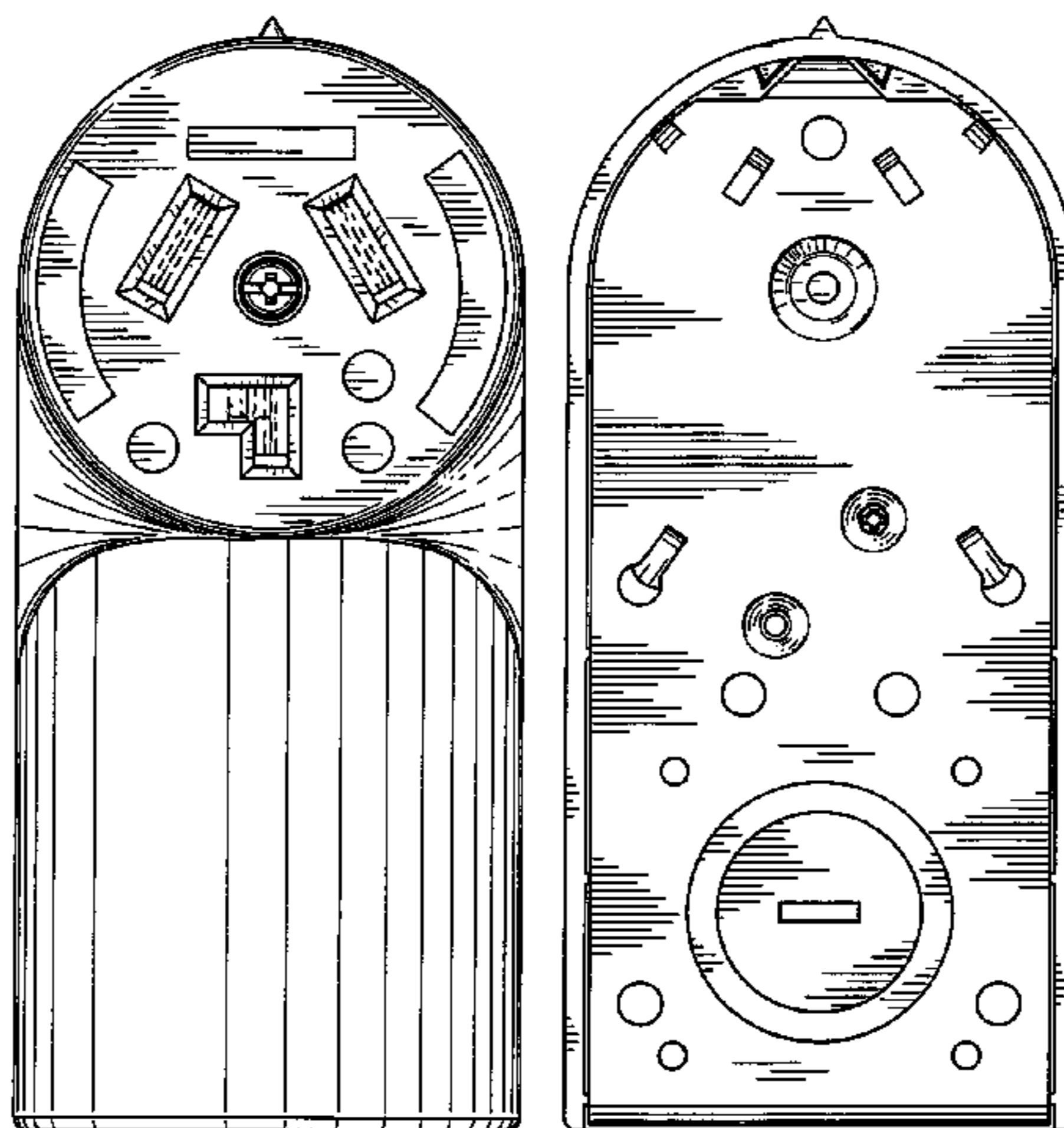
FIG. 21 is a left side elevational view thereof;

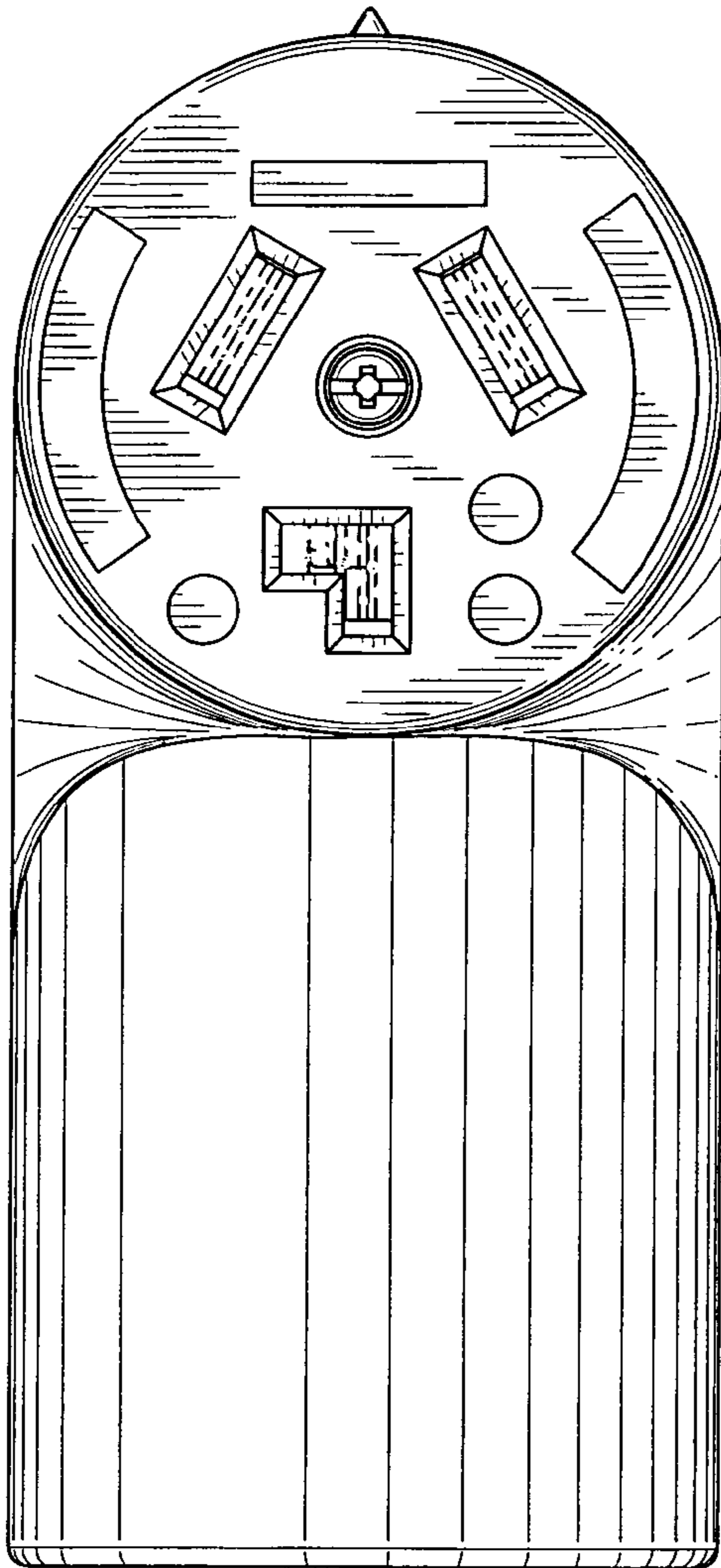

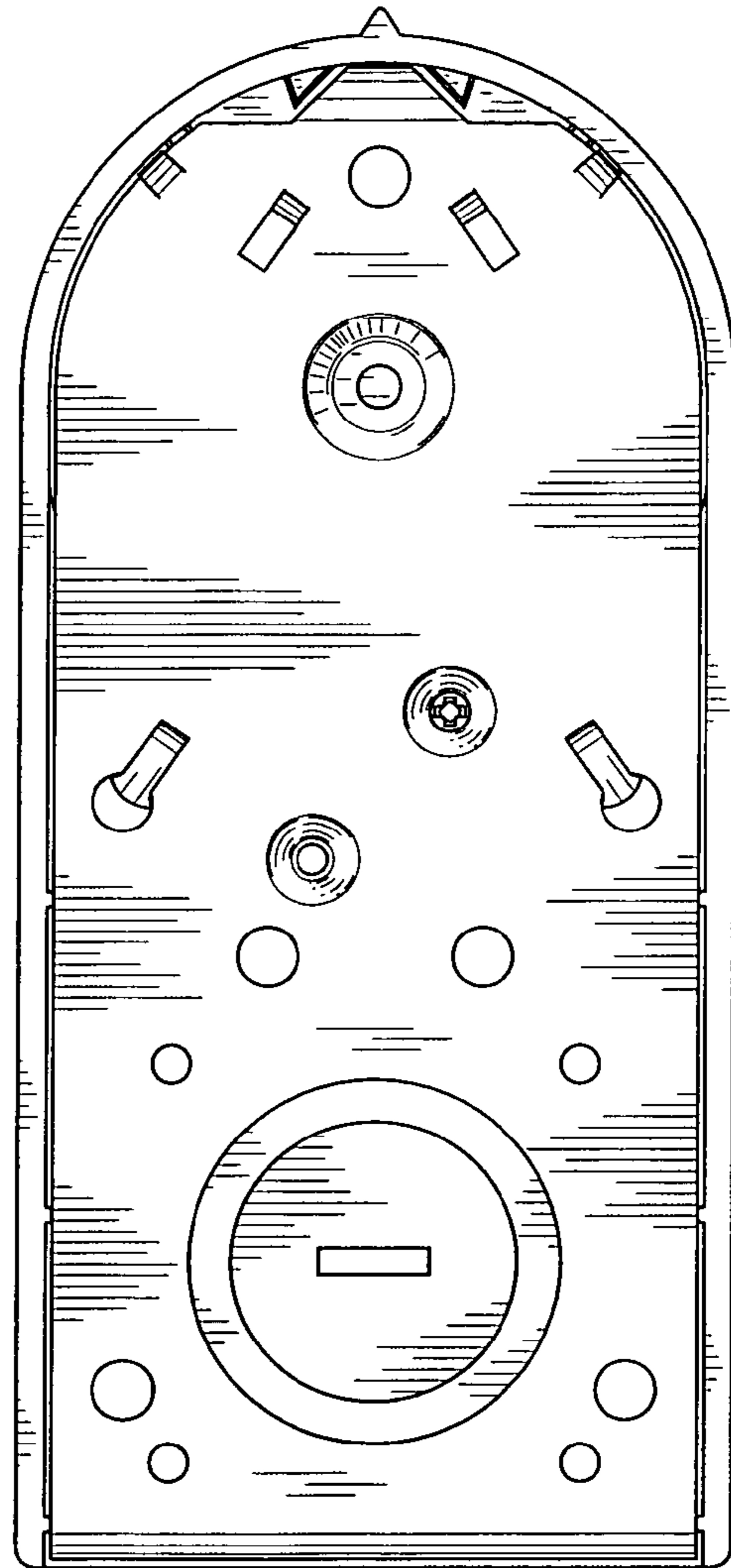

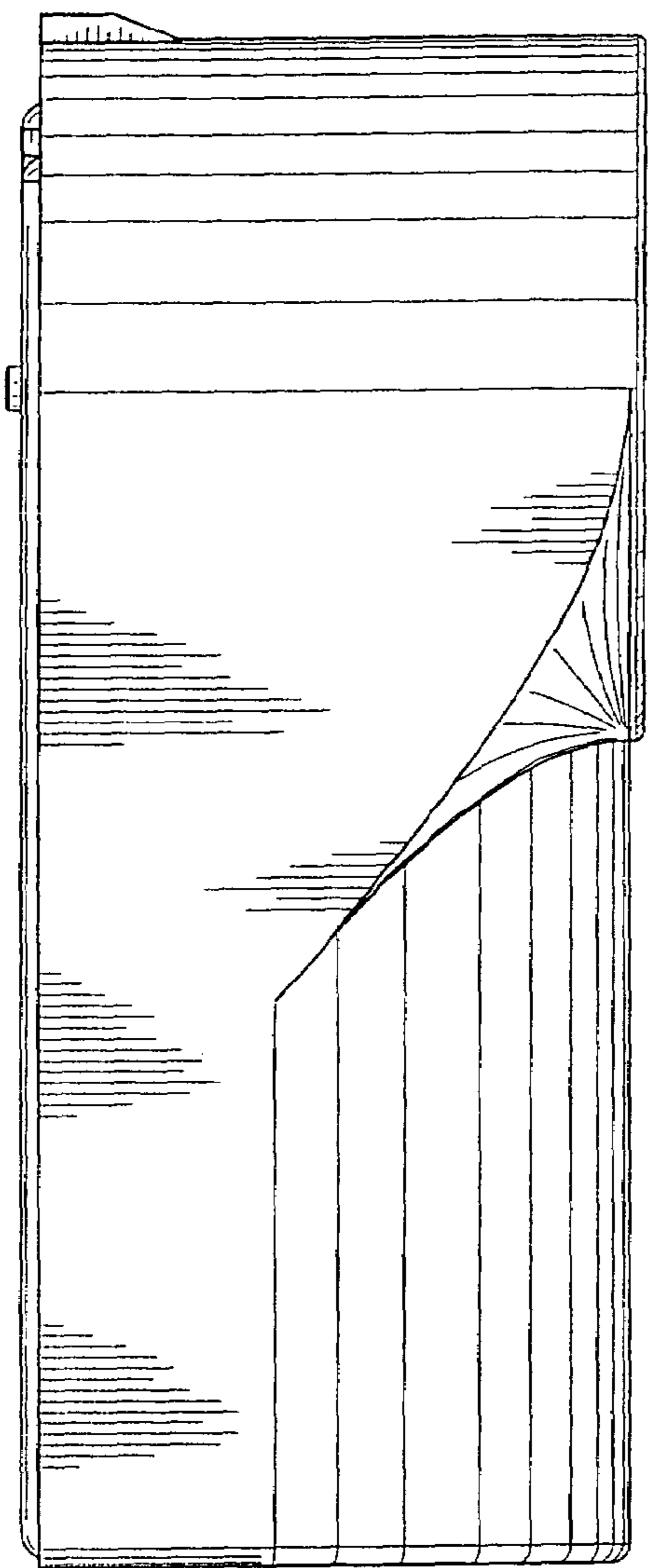

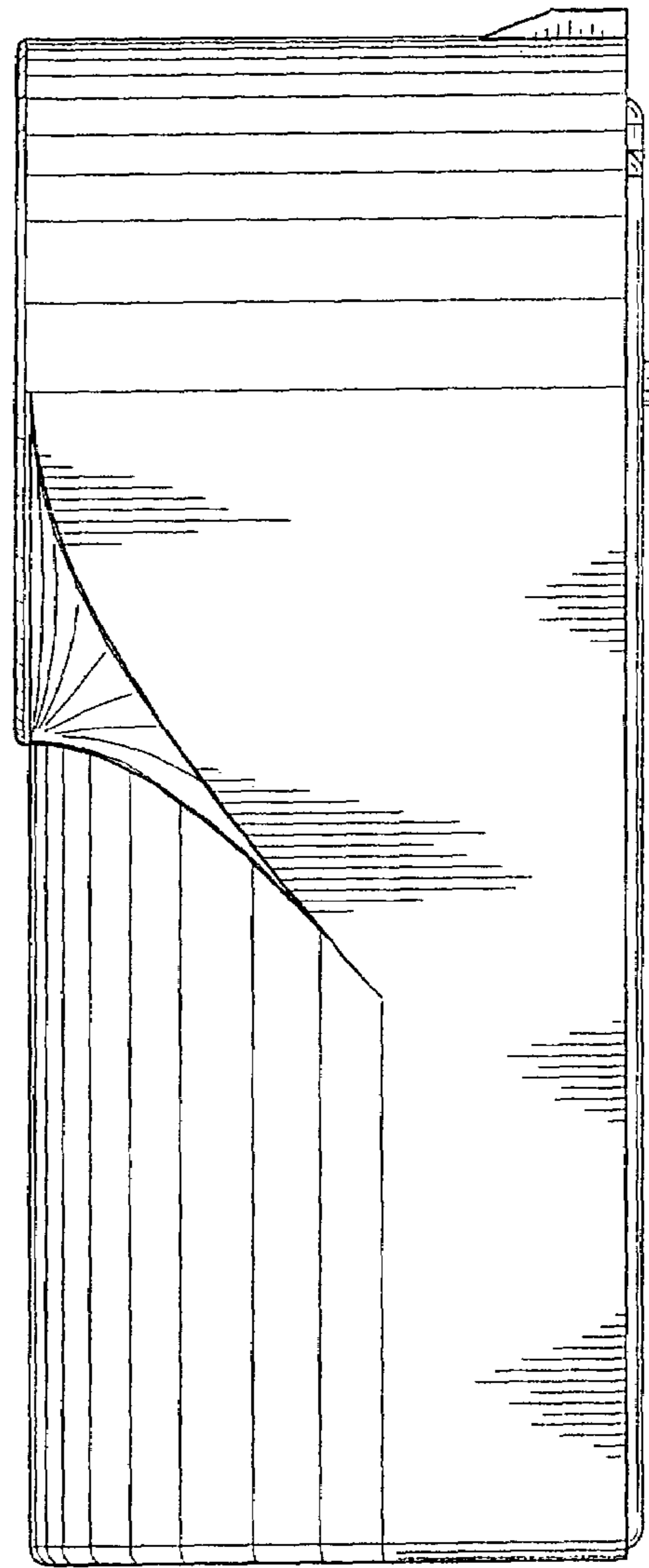

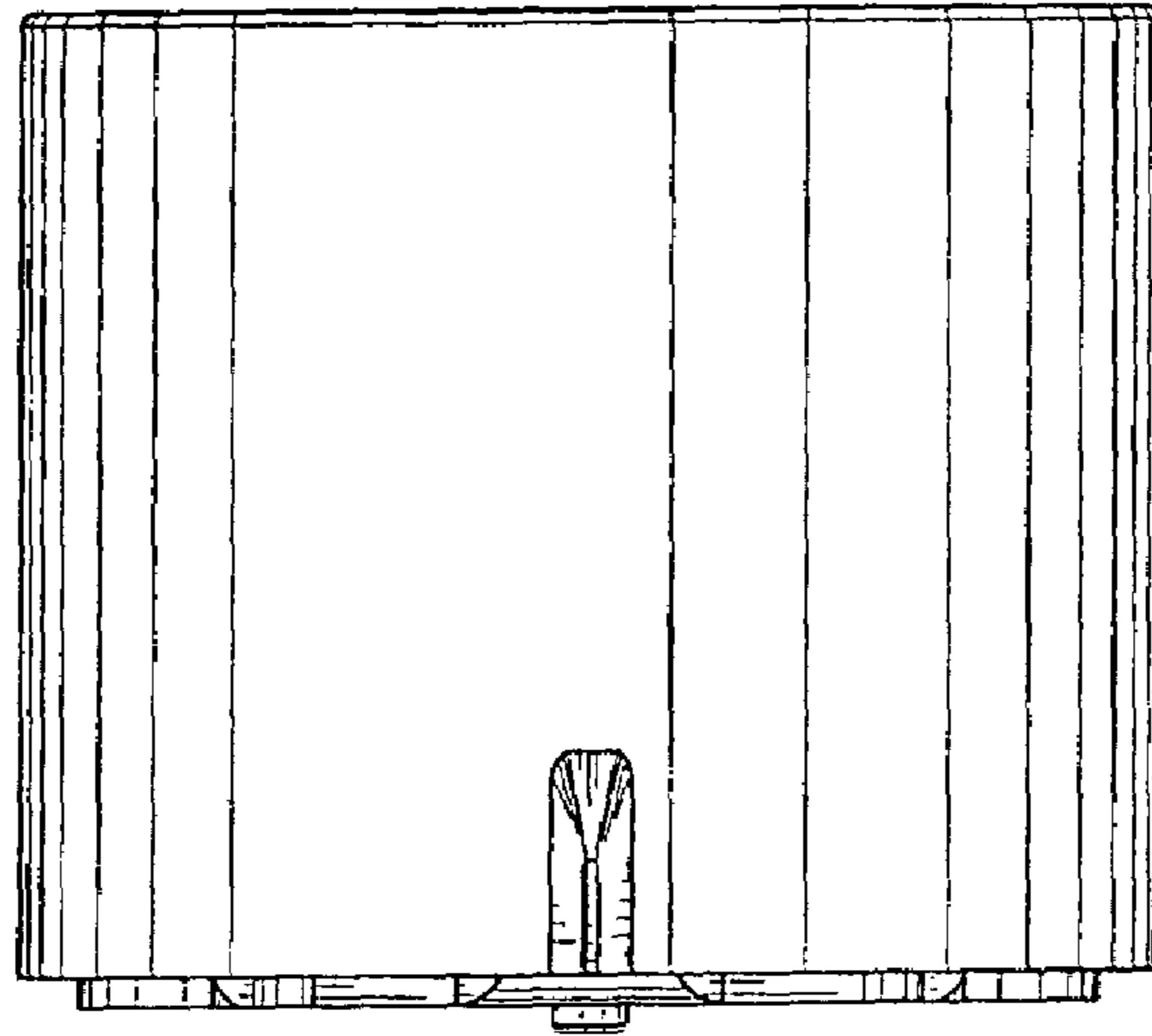

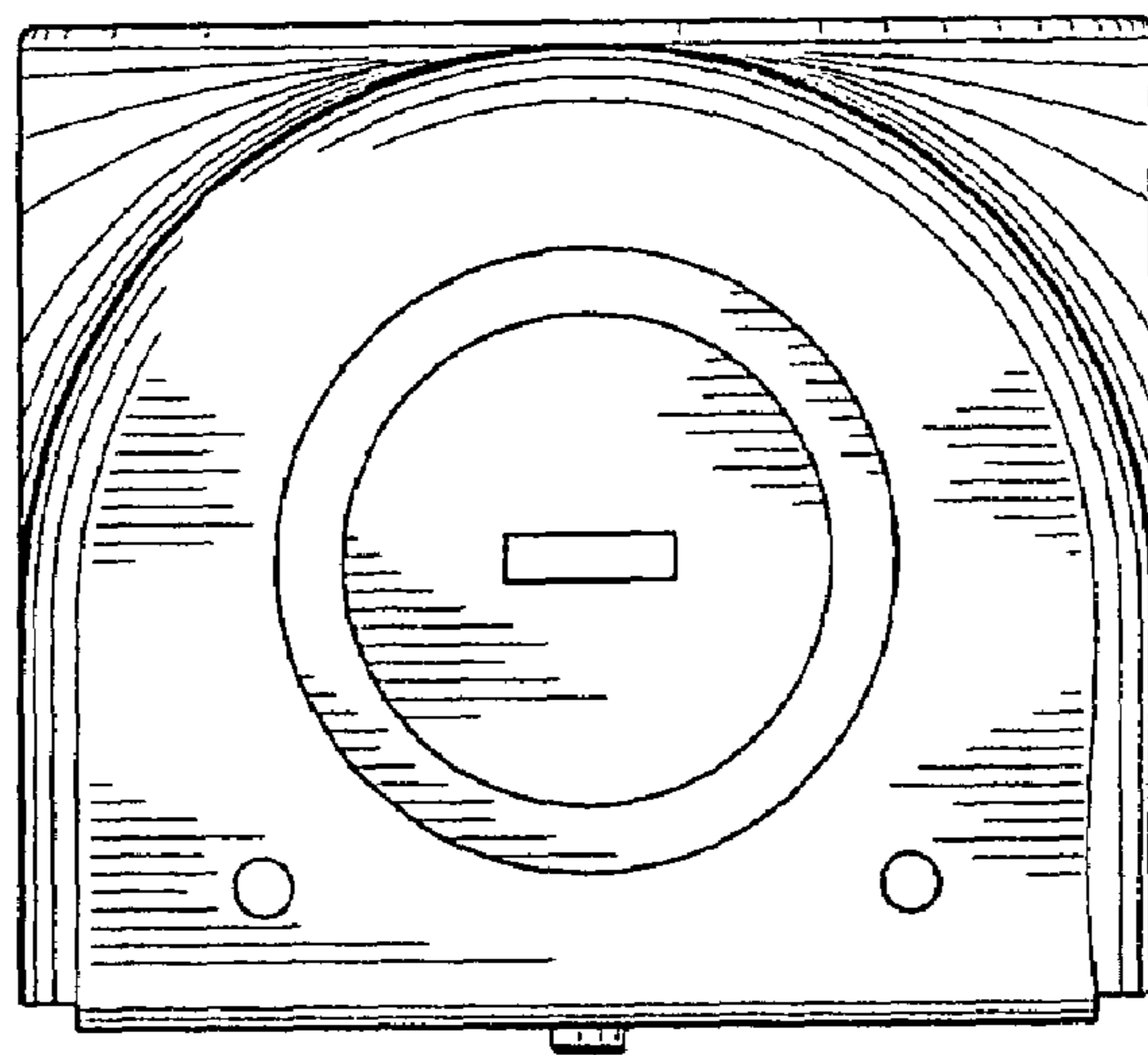

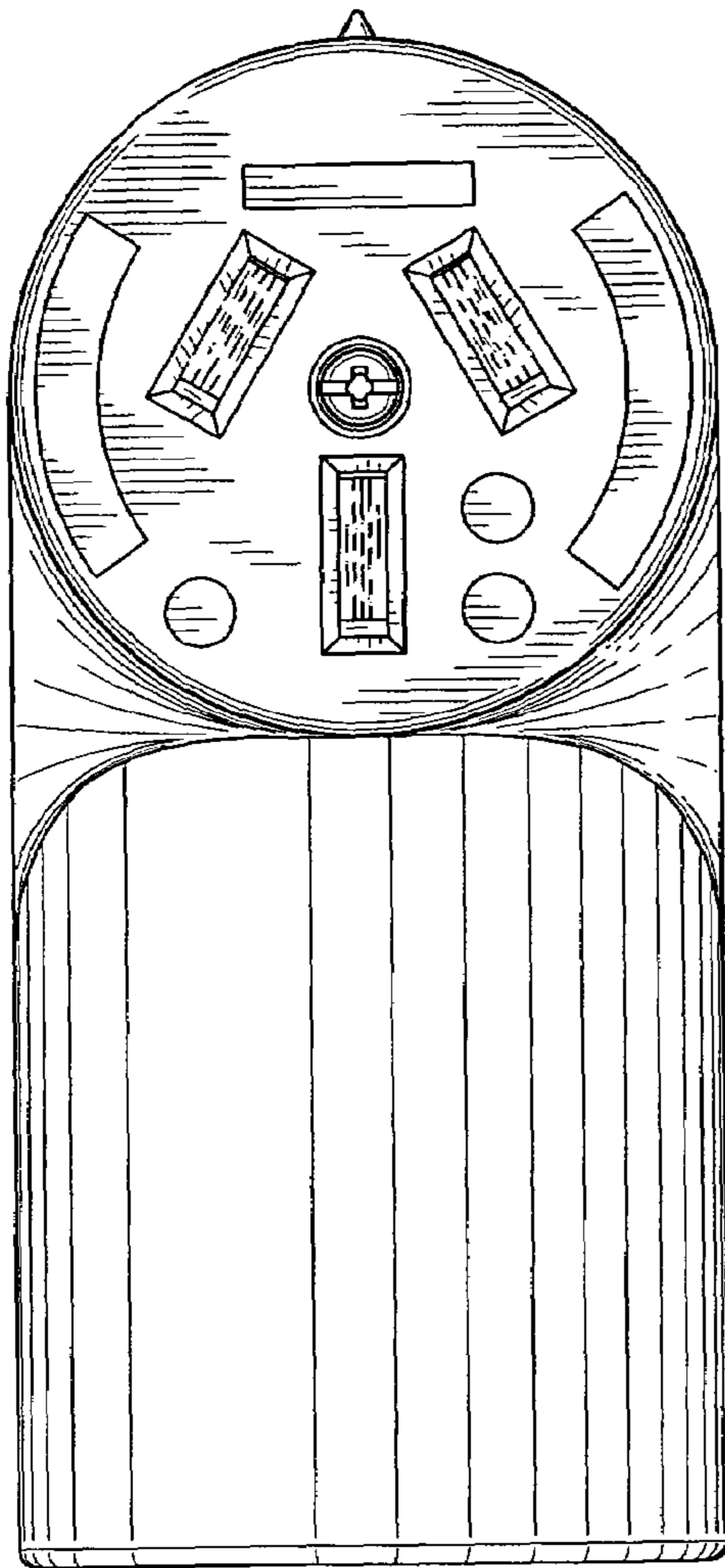

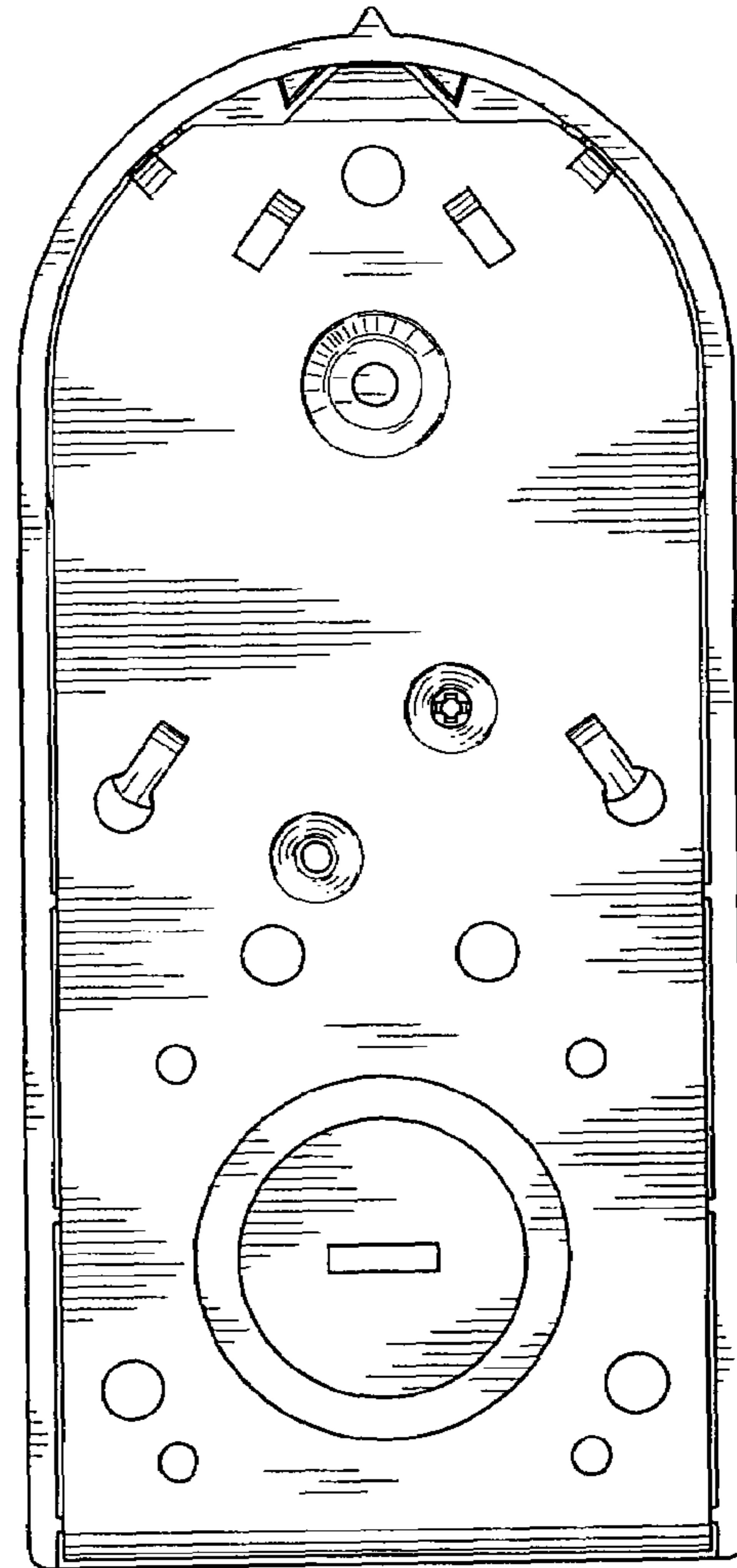

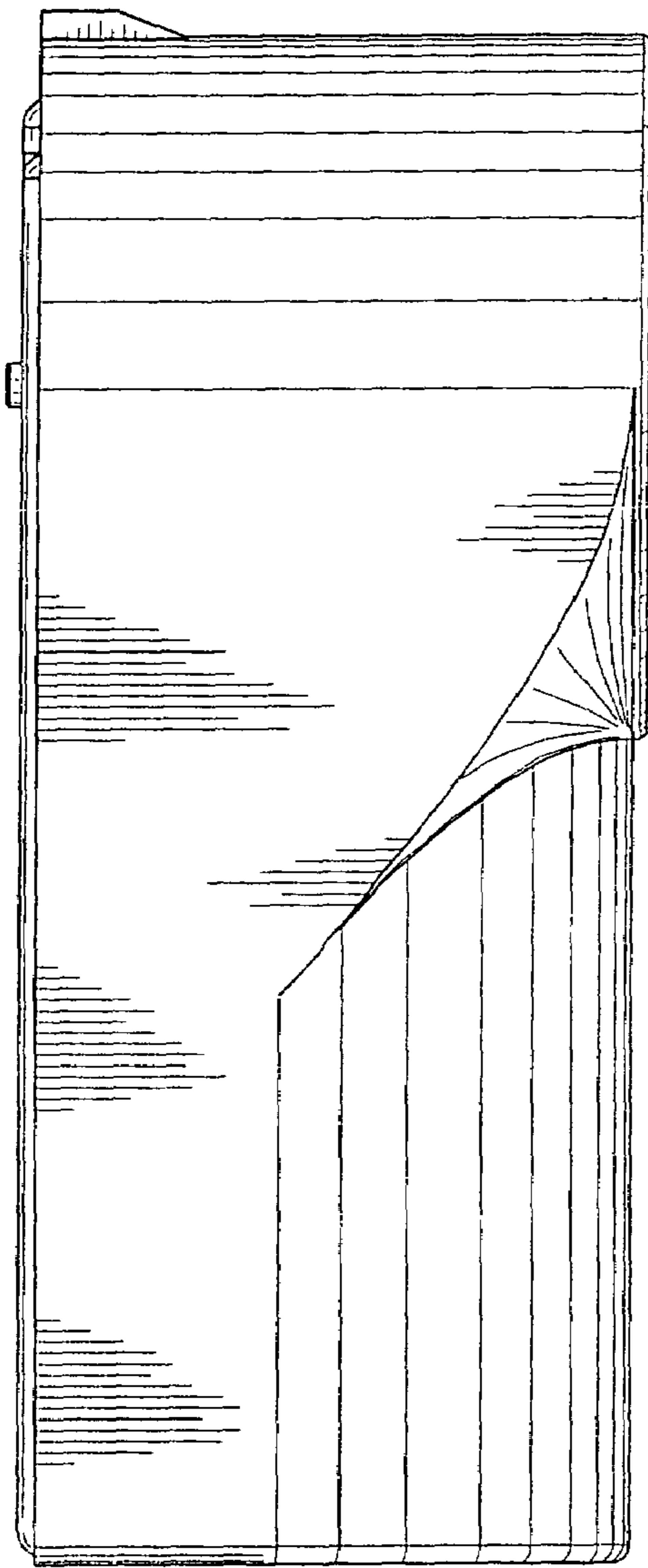

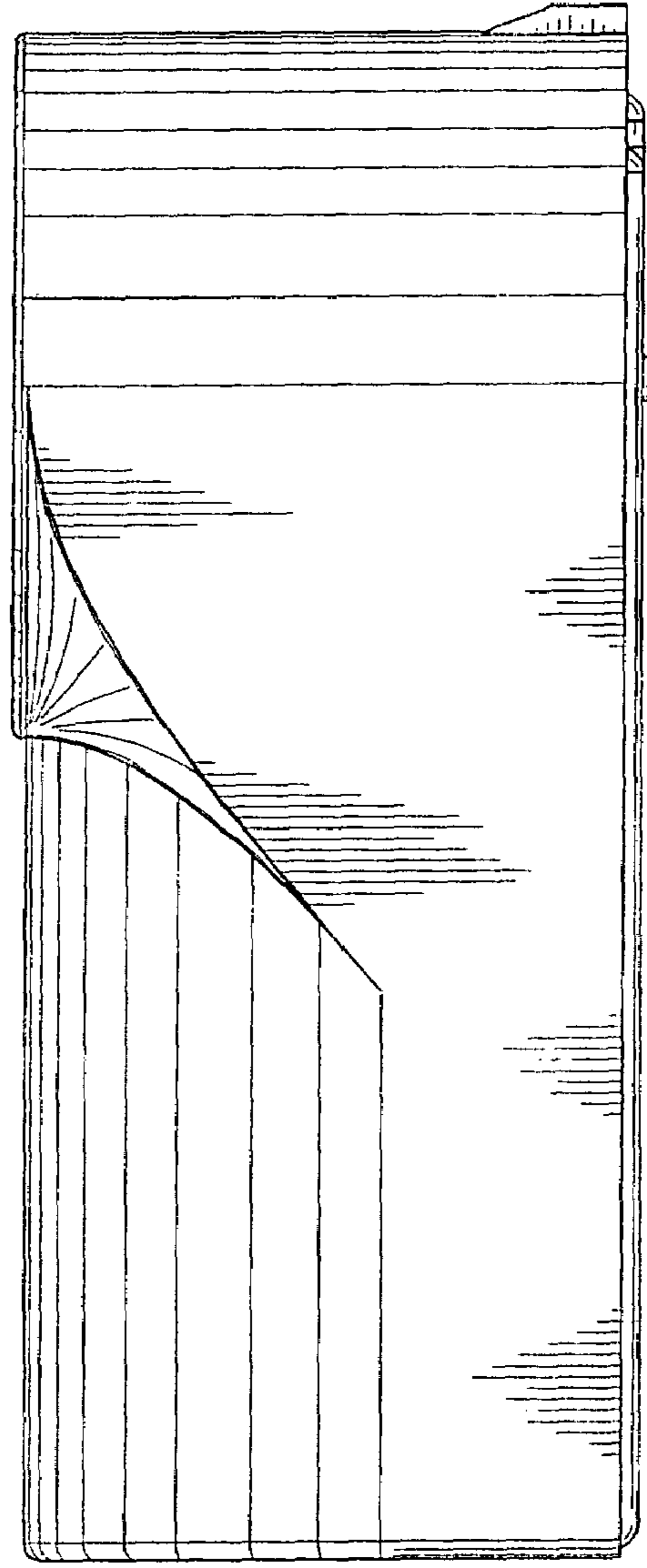

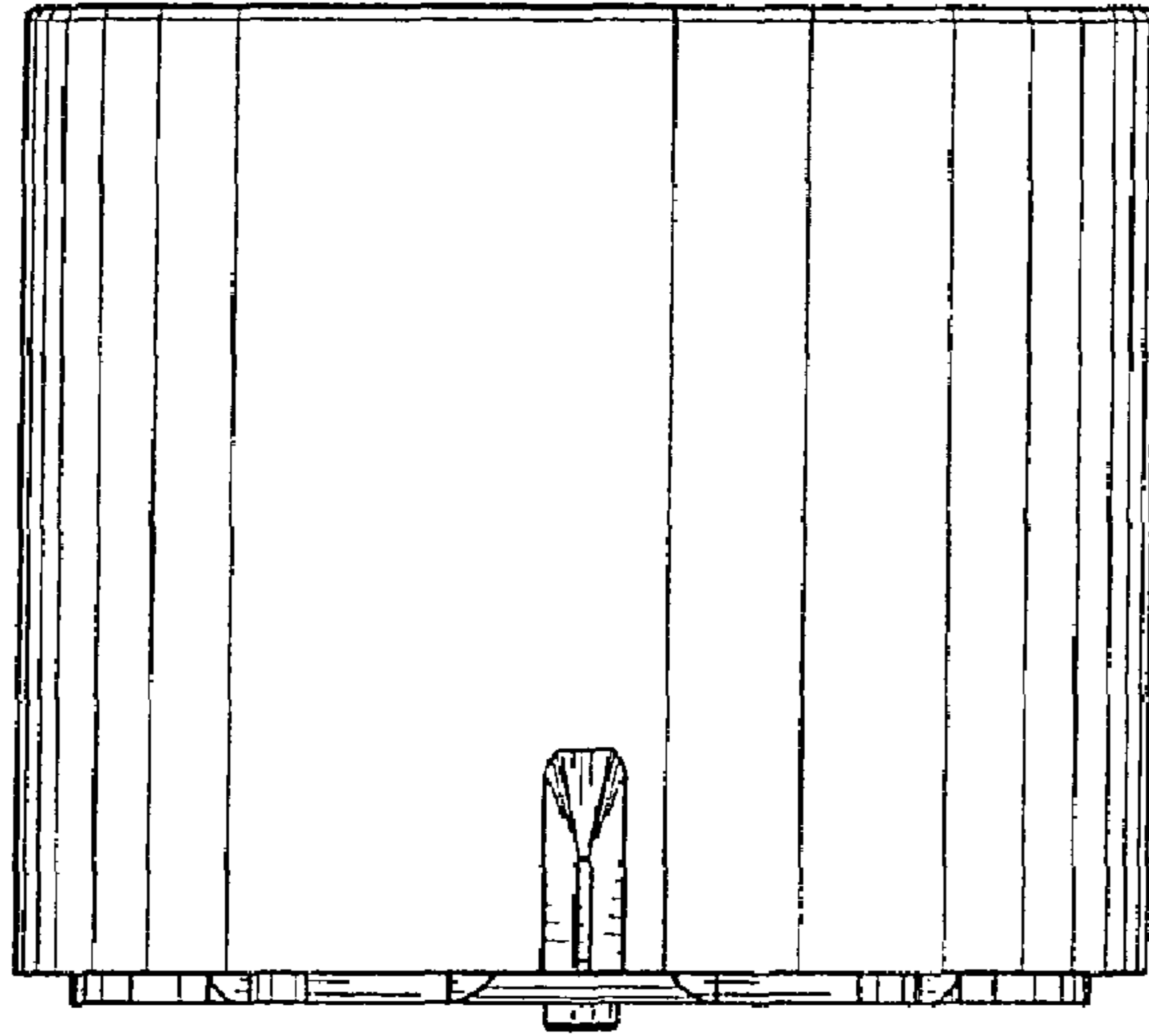

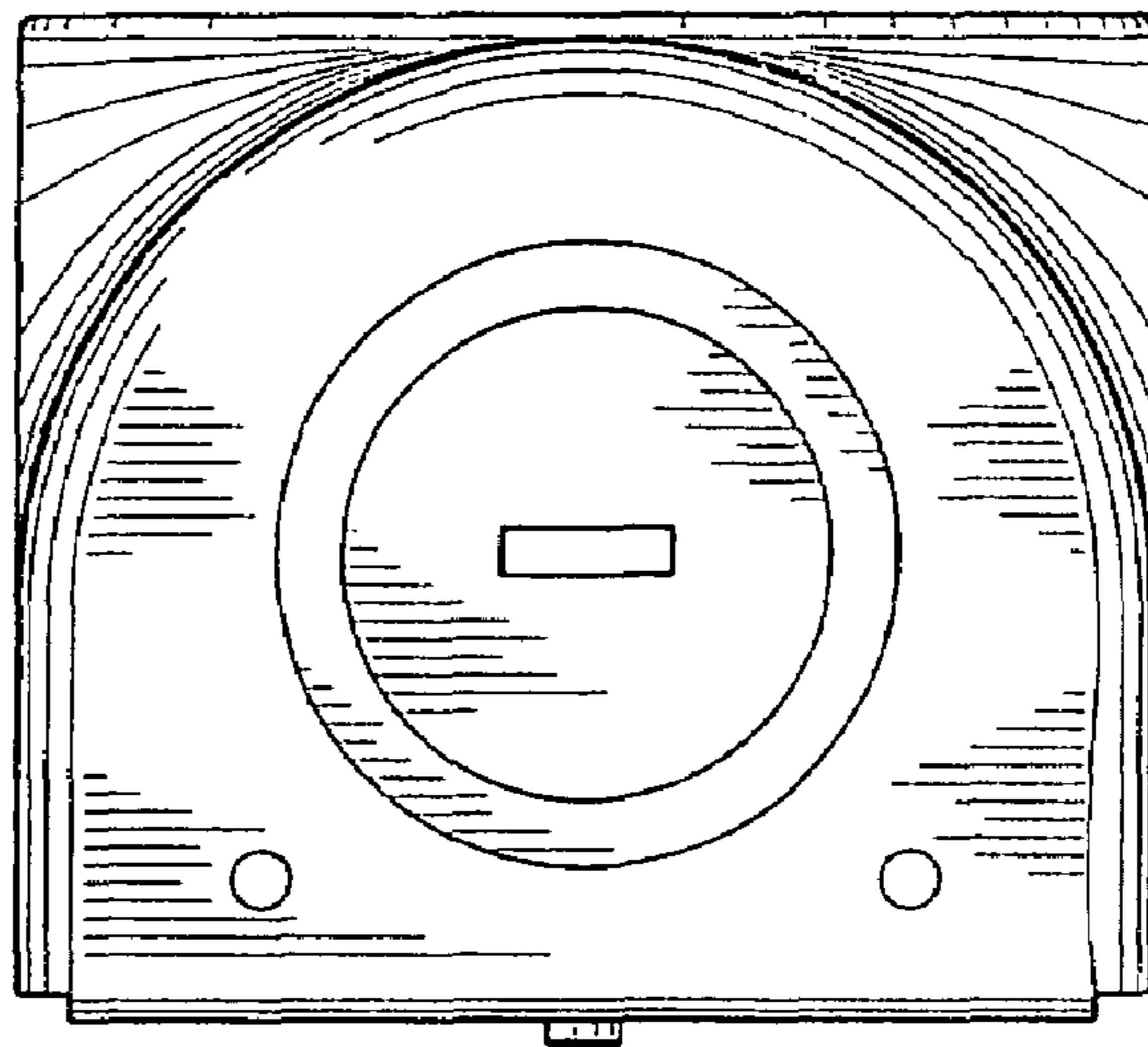

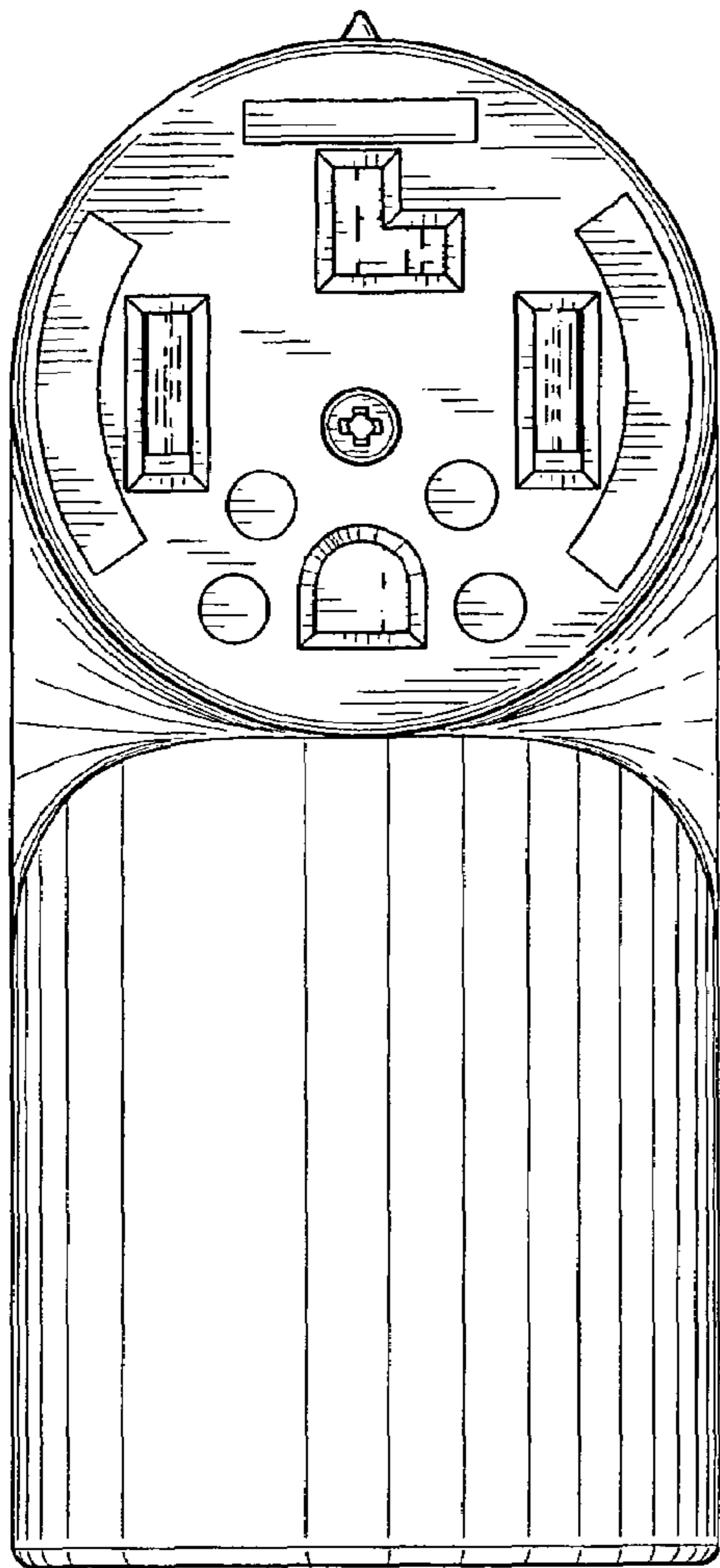

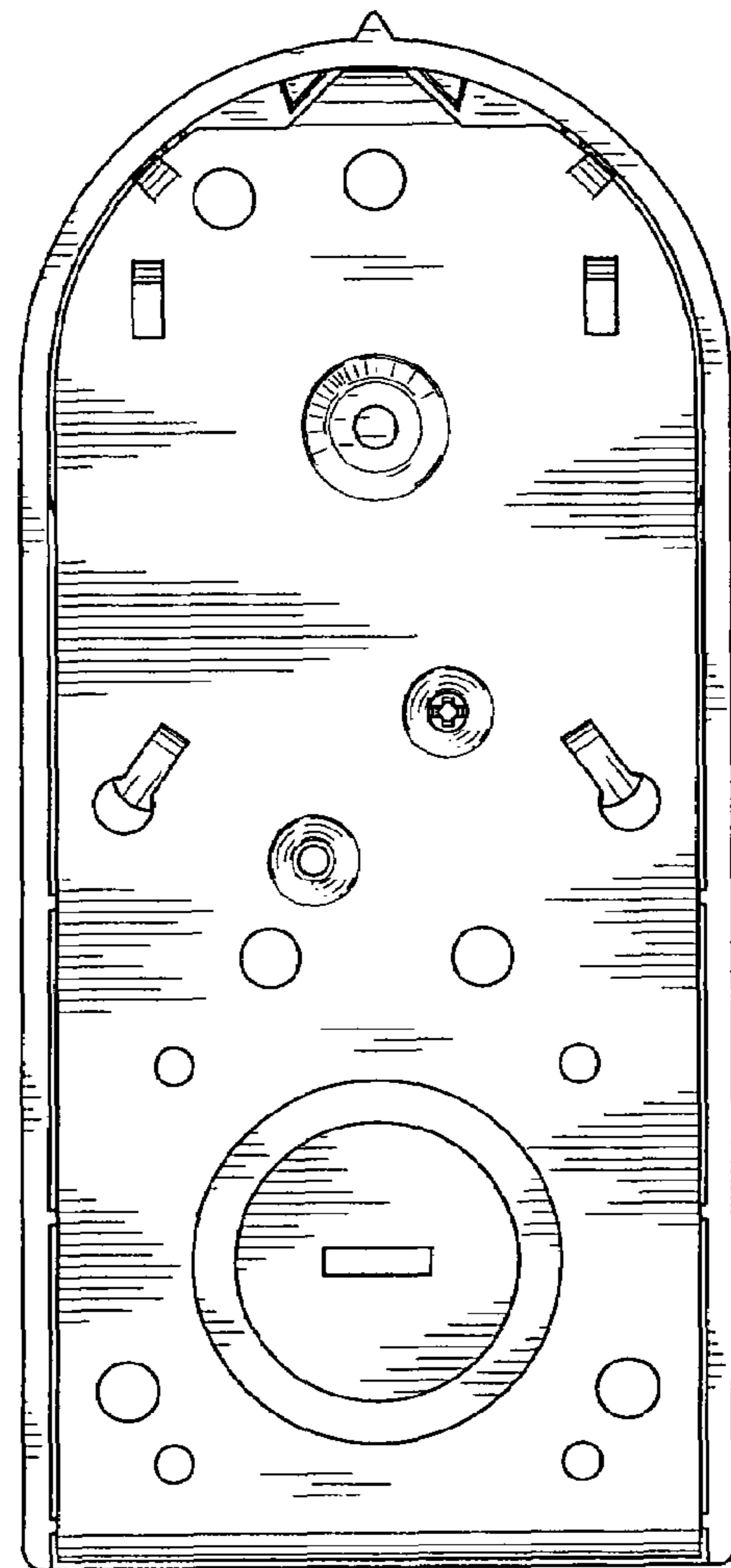

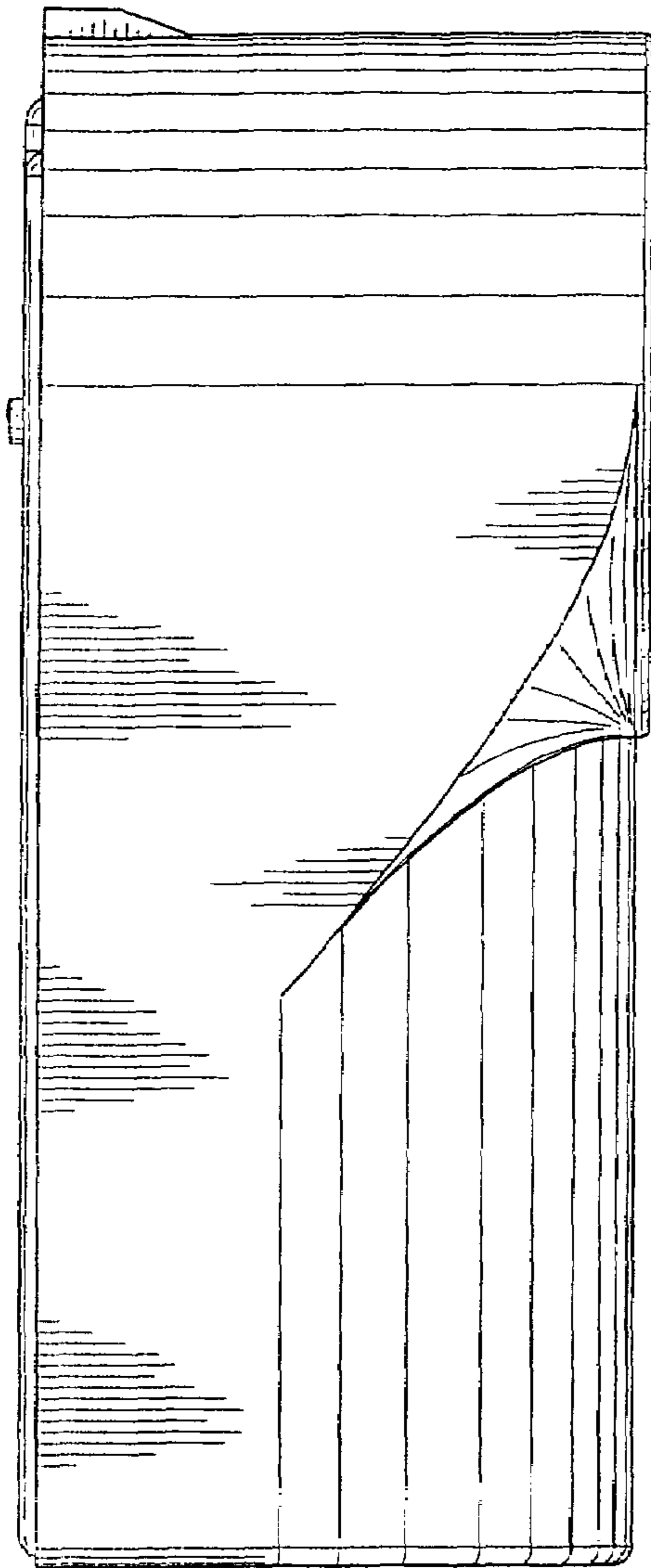

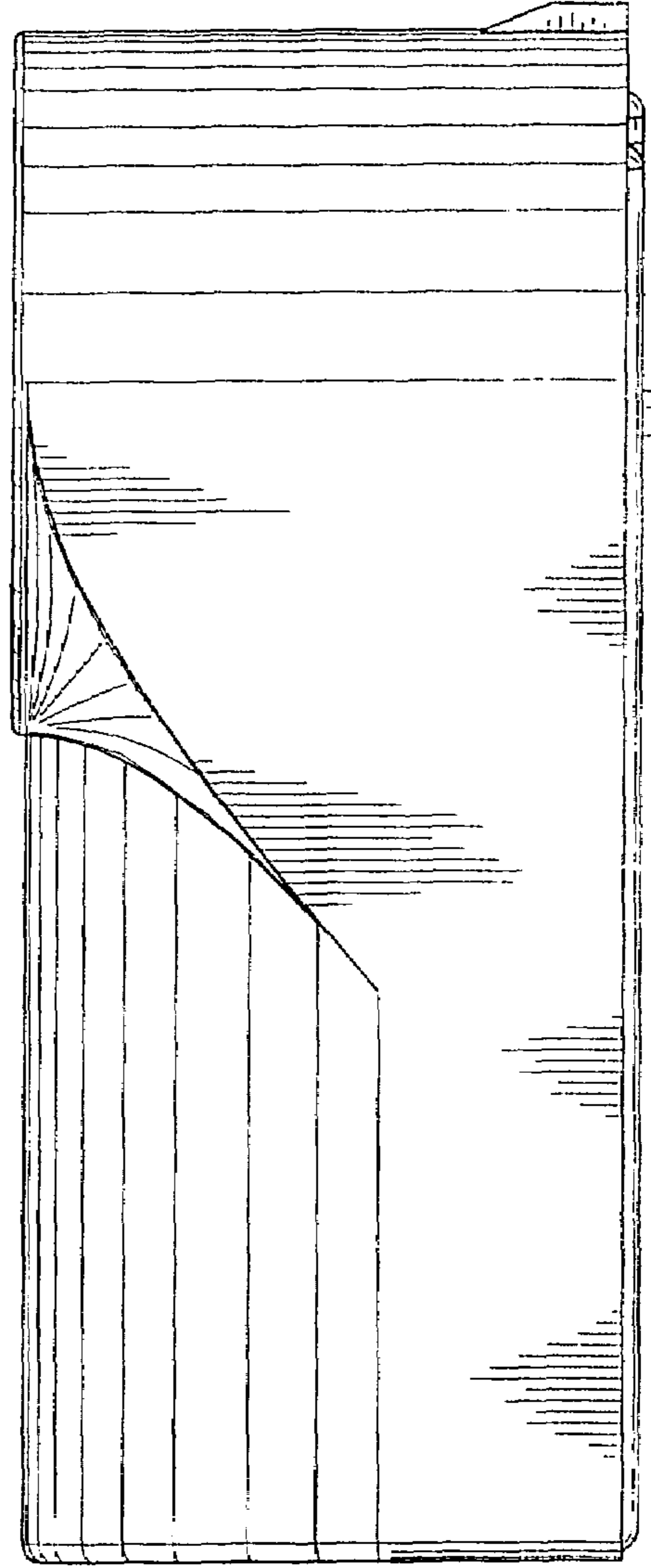

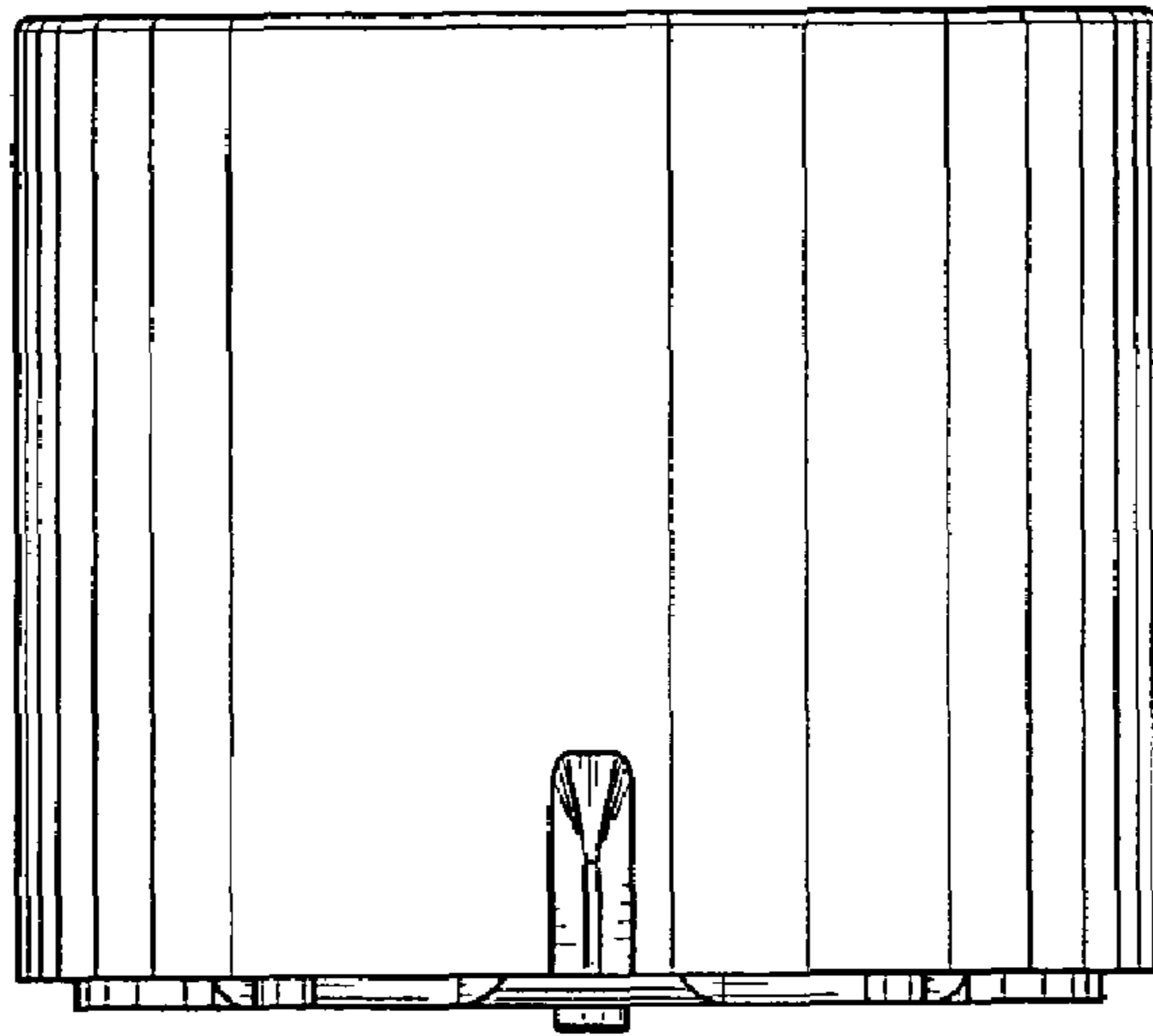

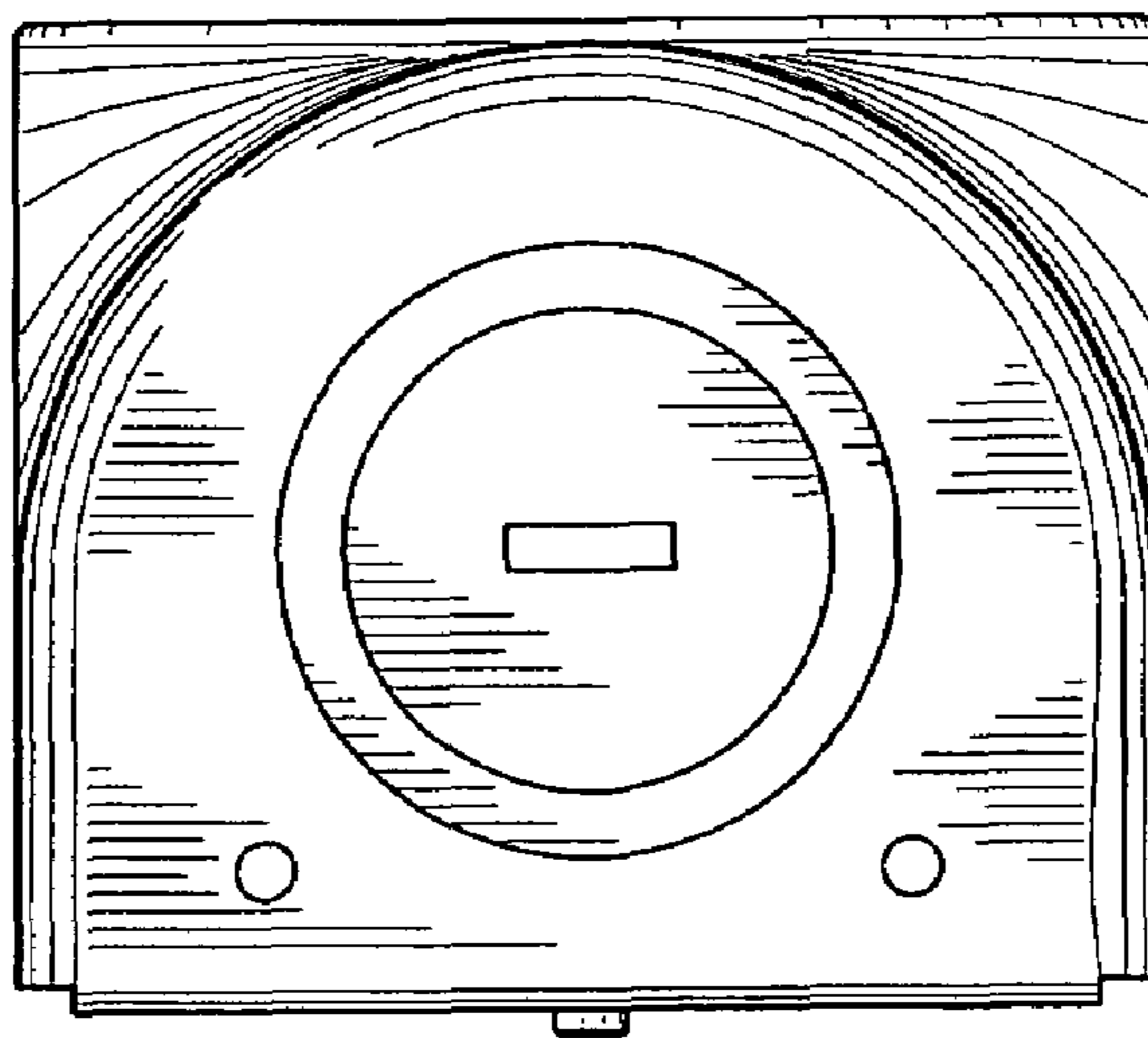

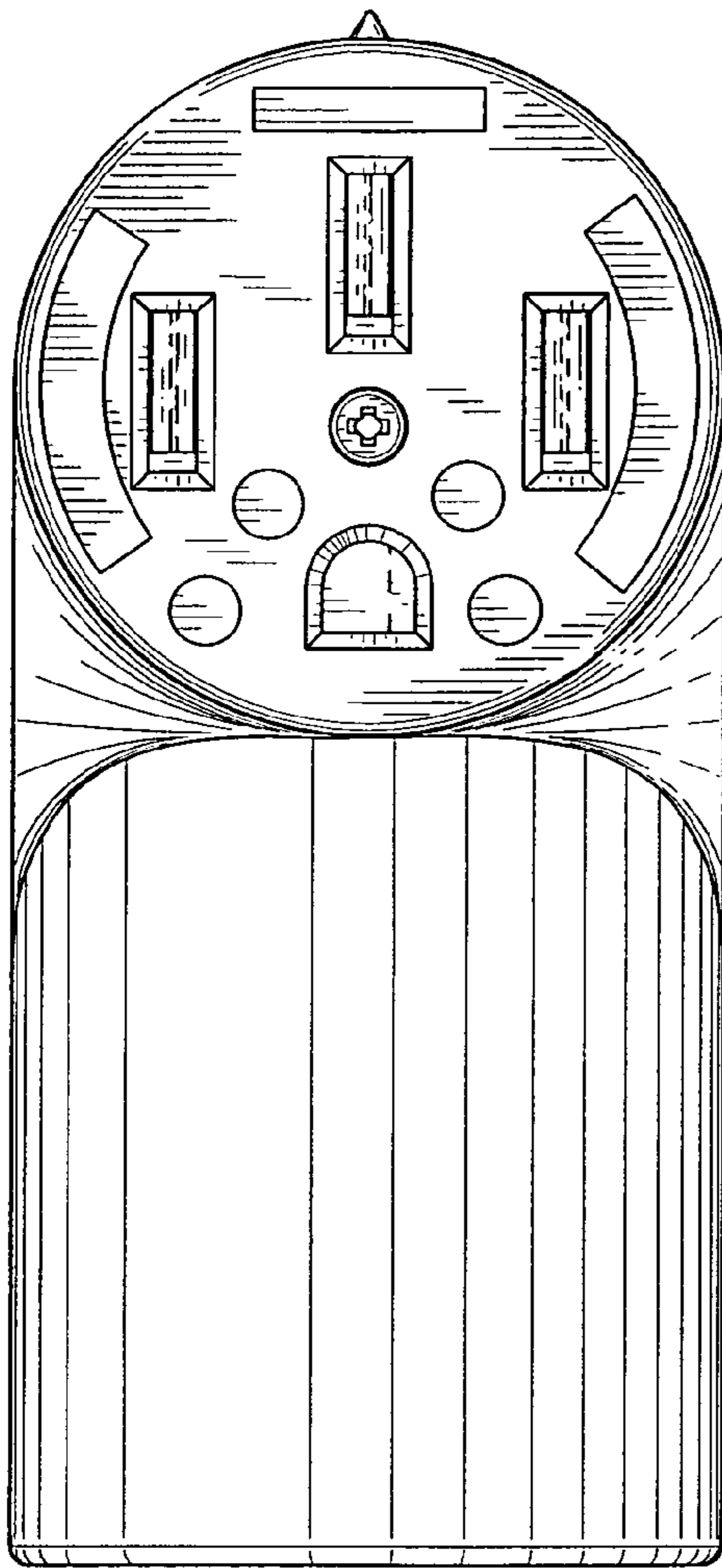

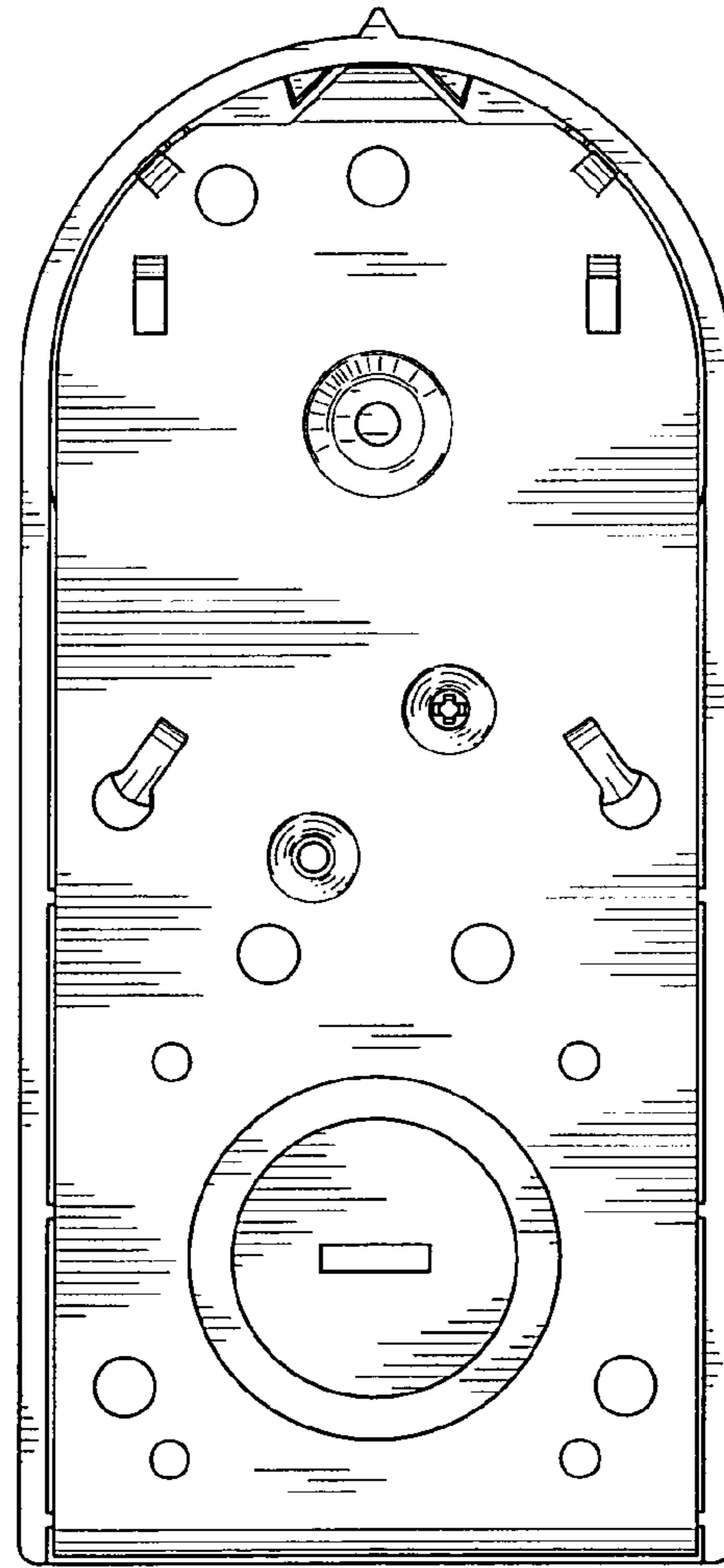

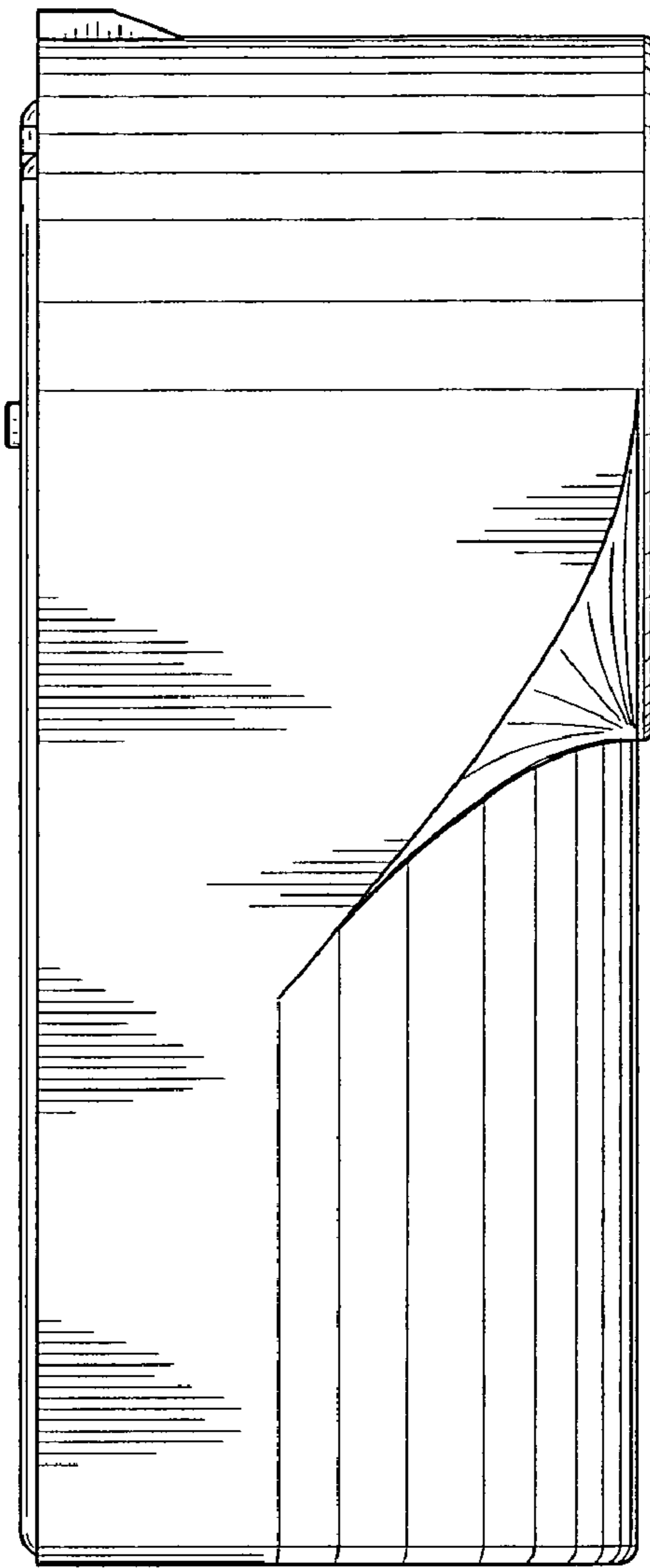

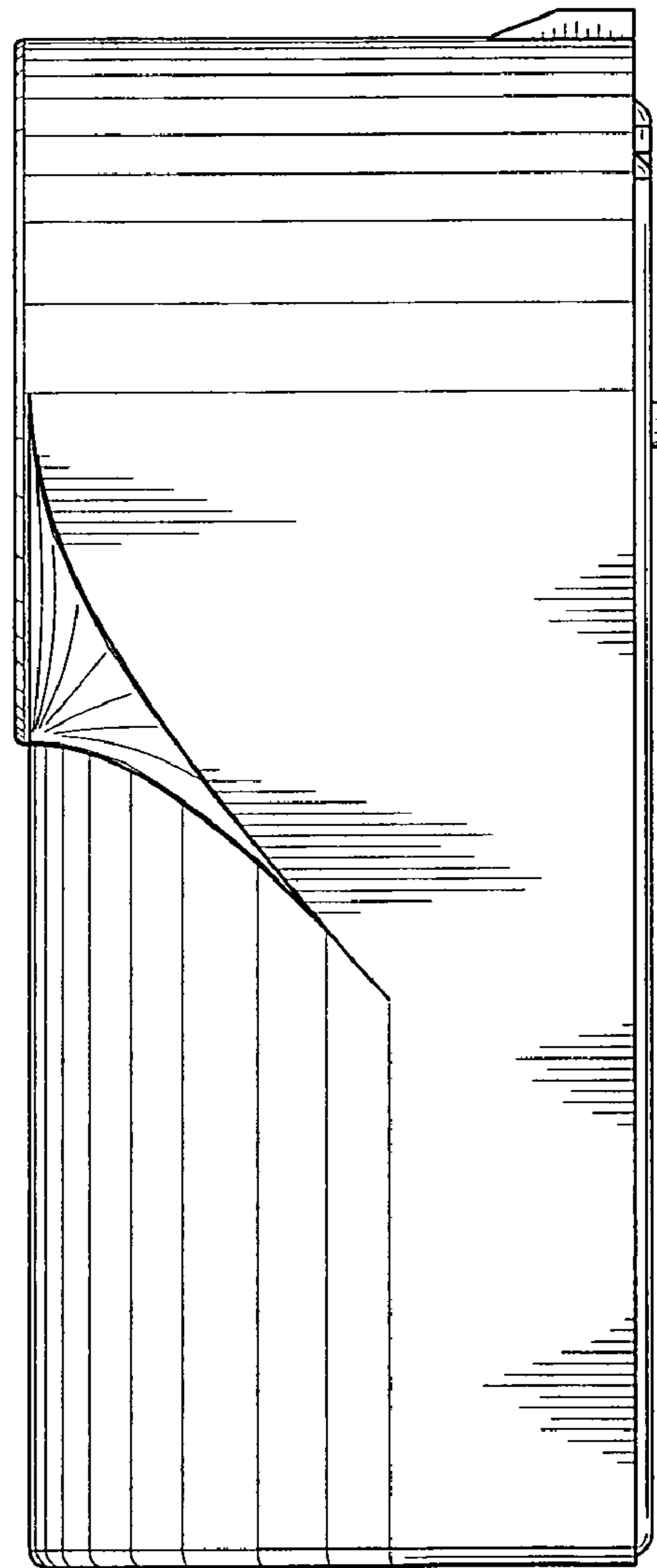

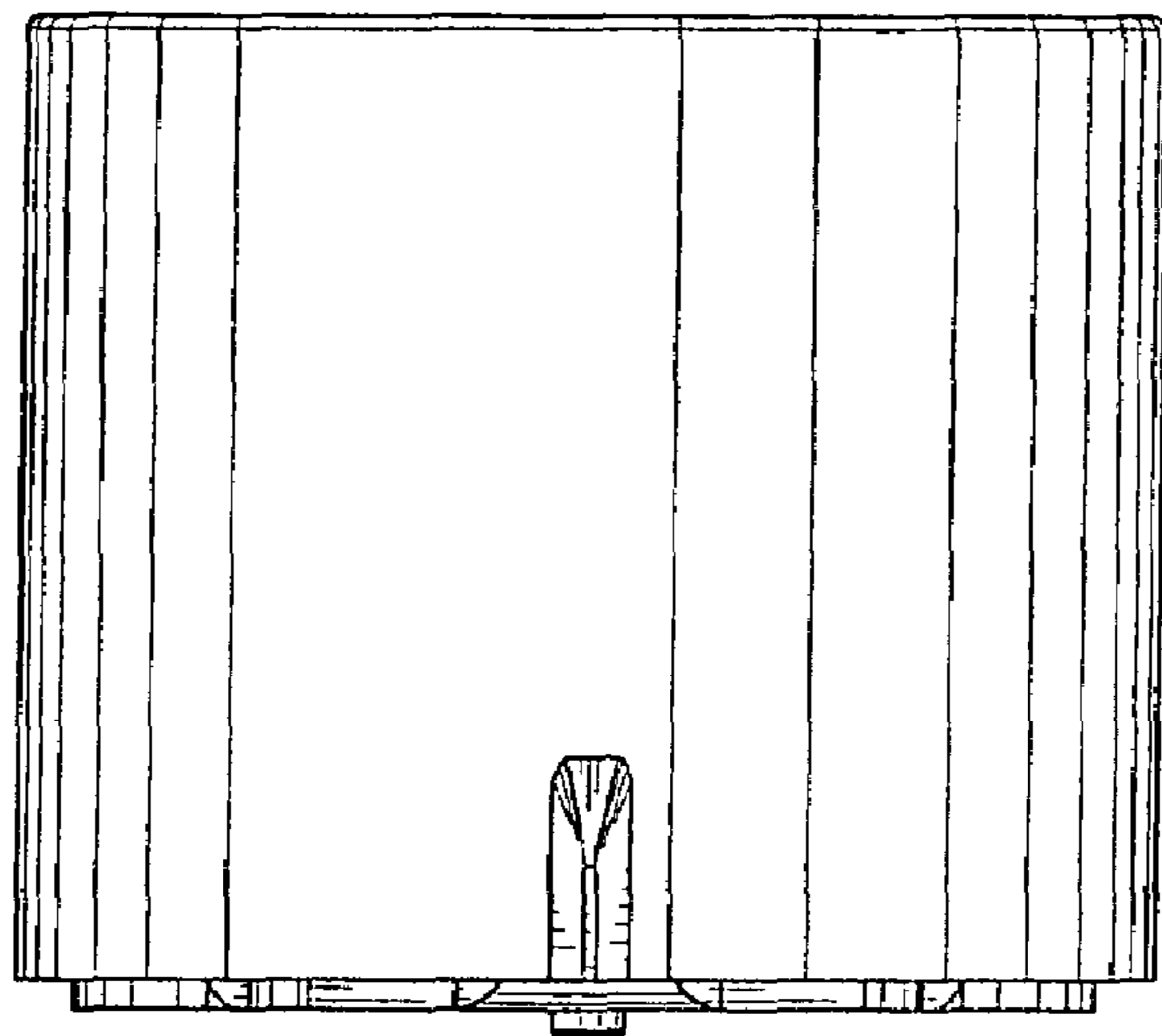

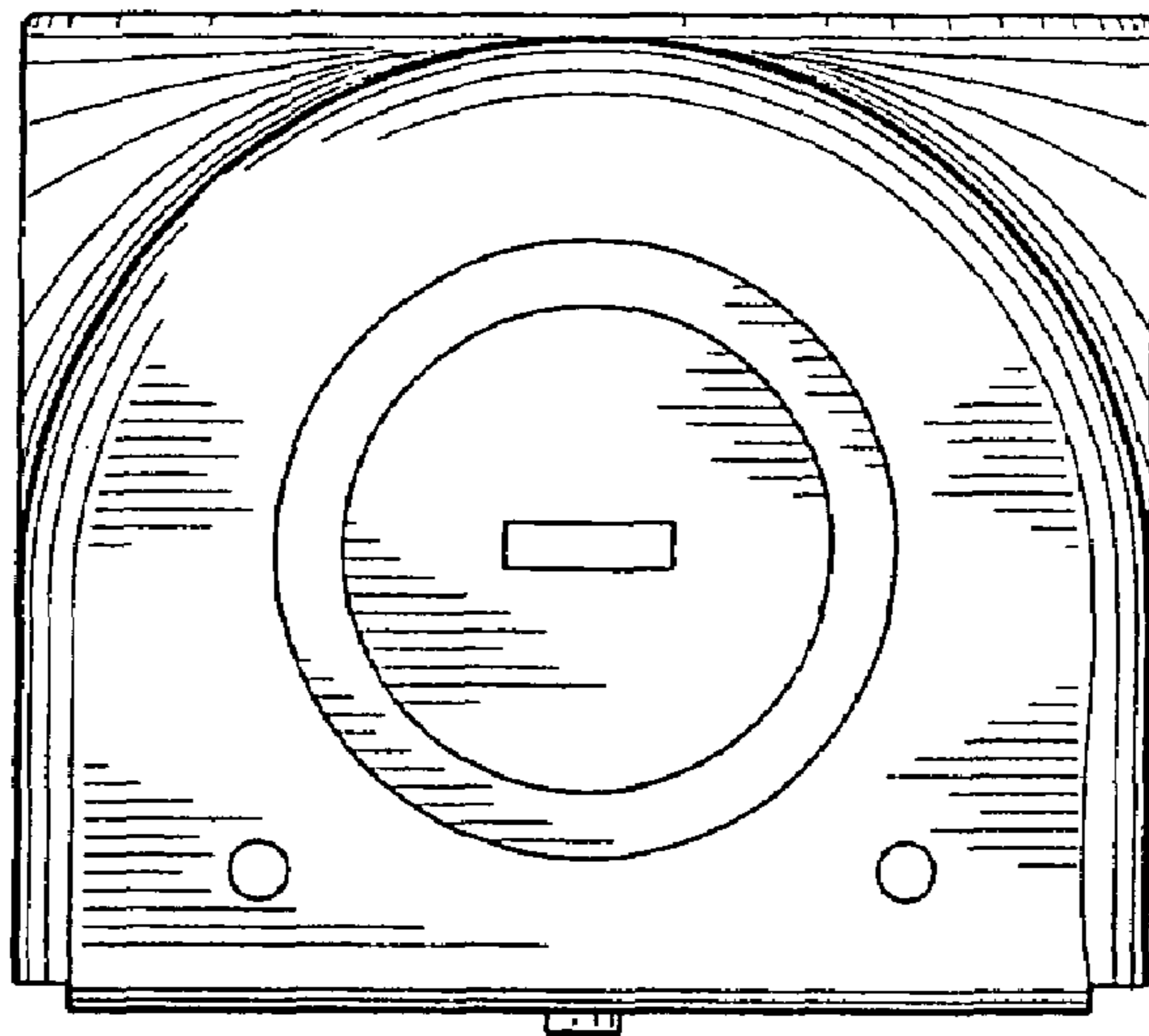
