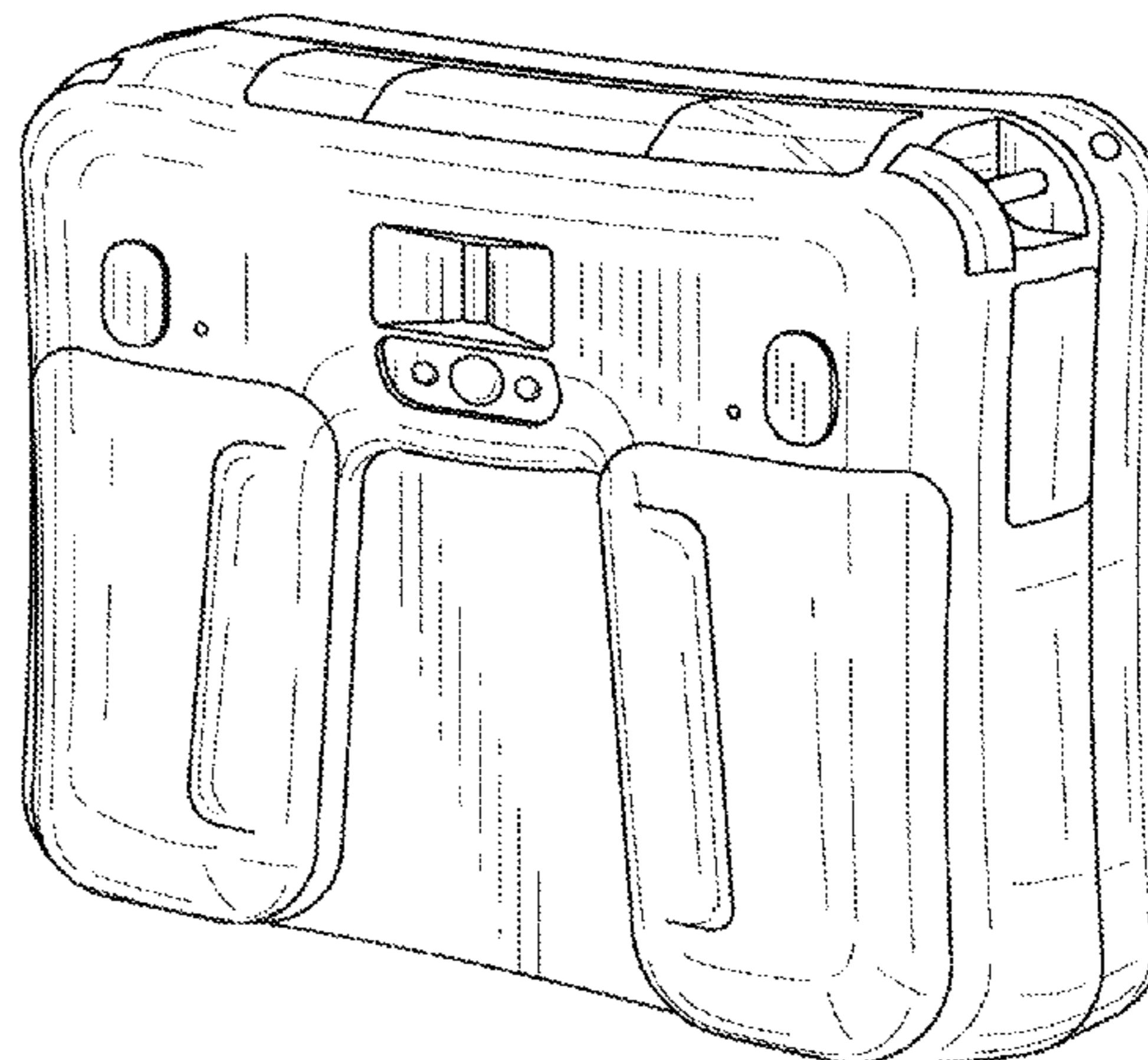
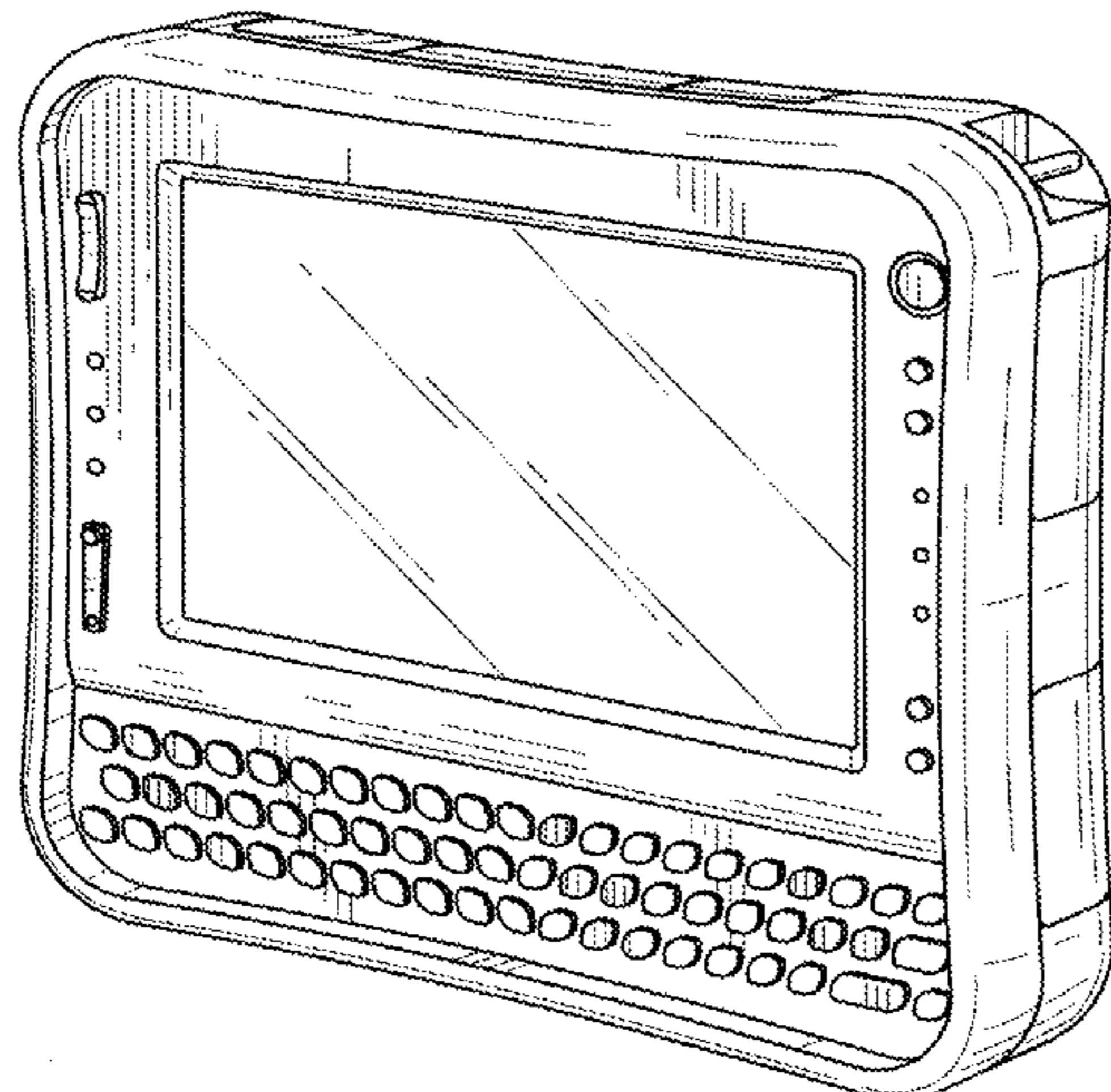
(57) **CLAIM**

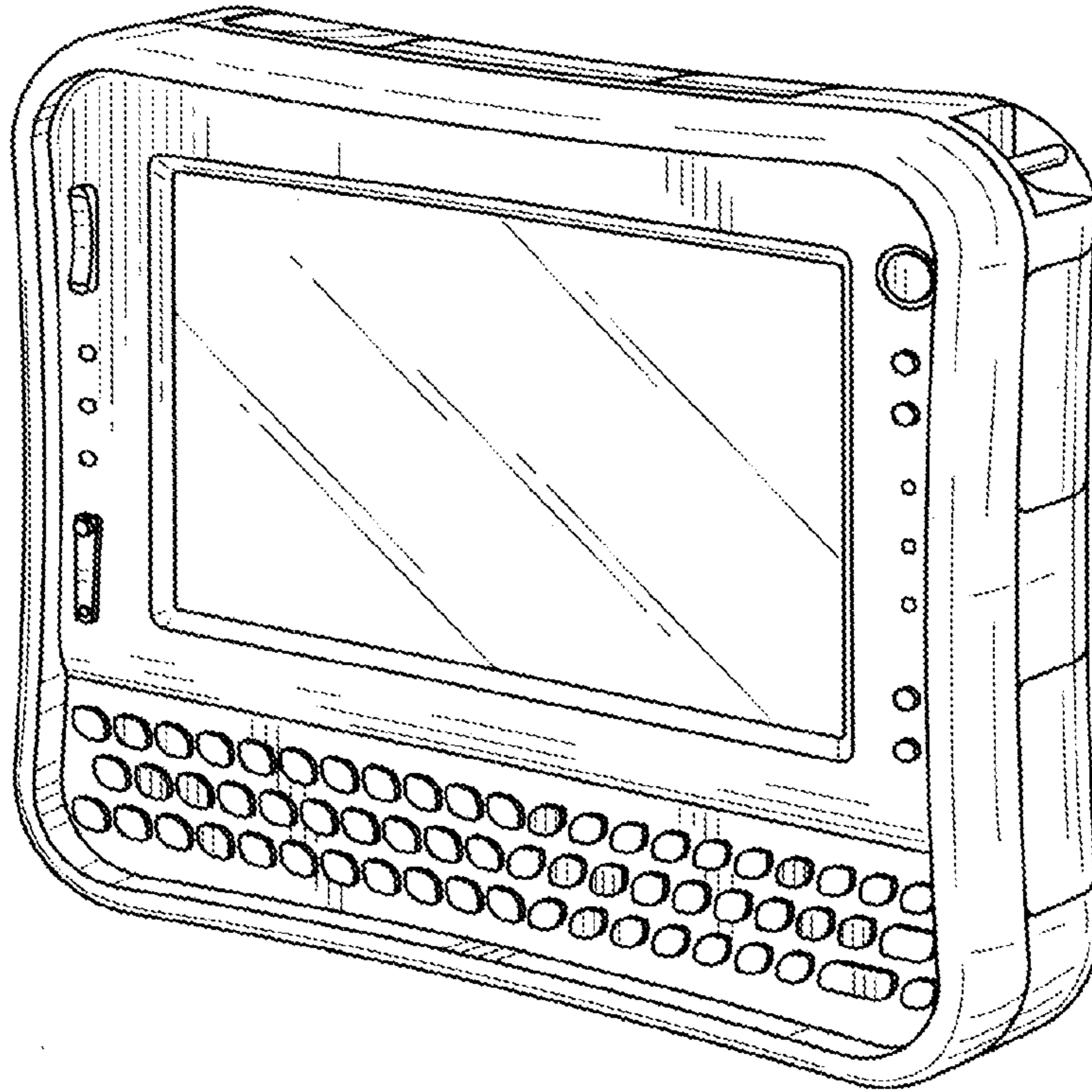

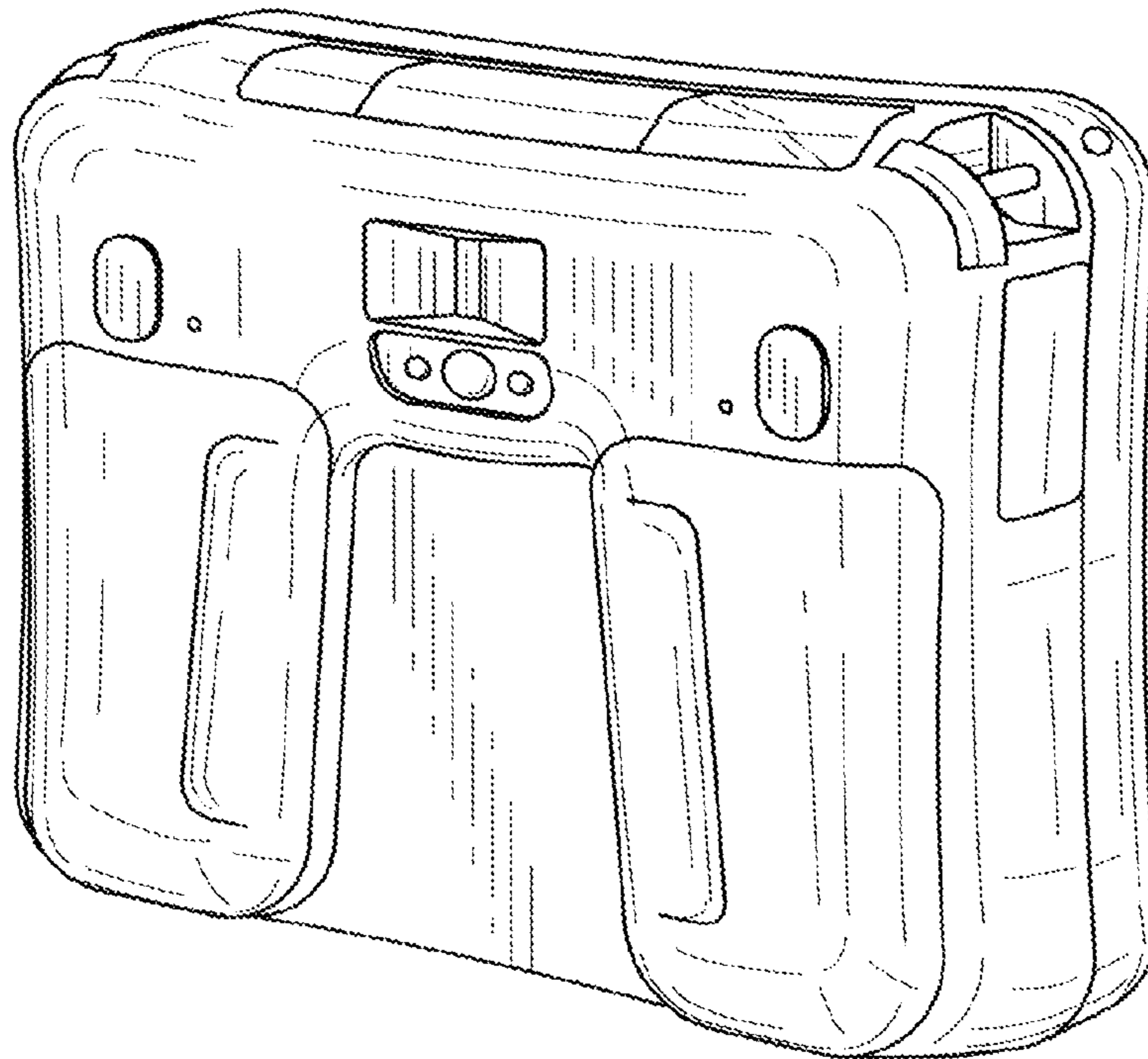

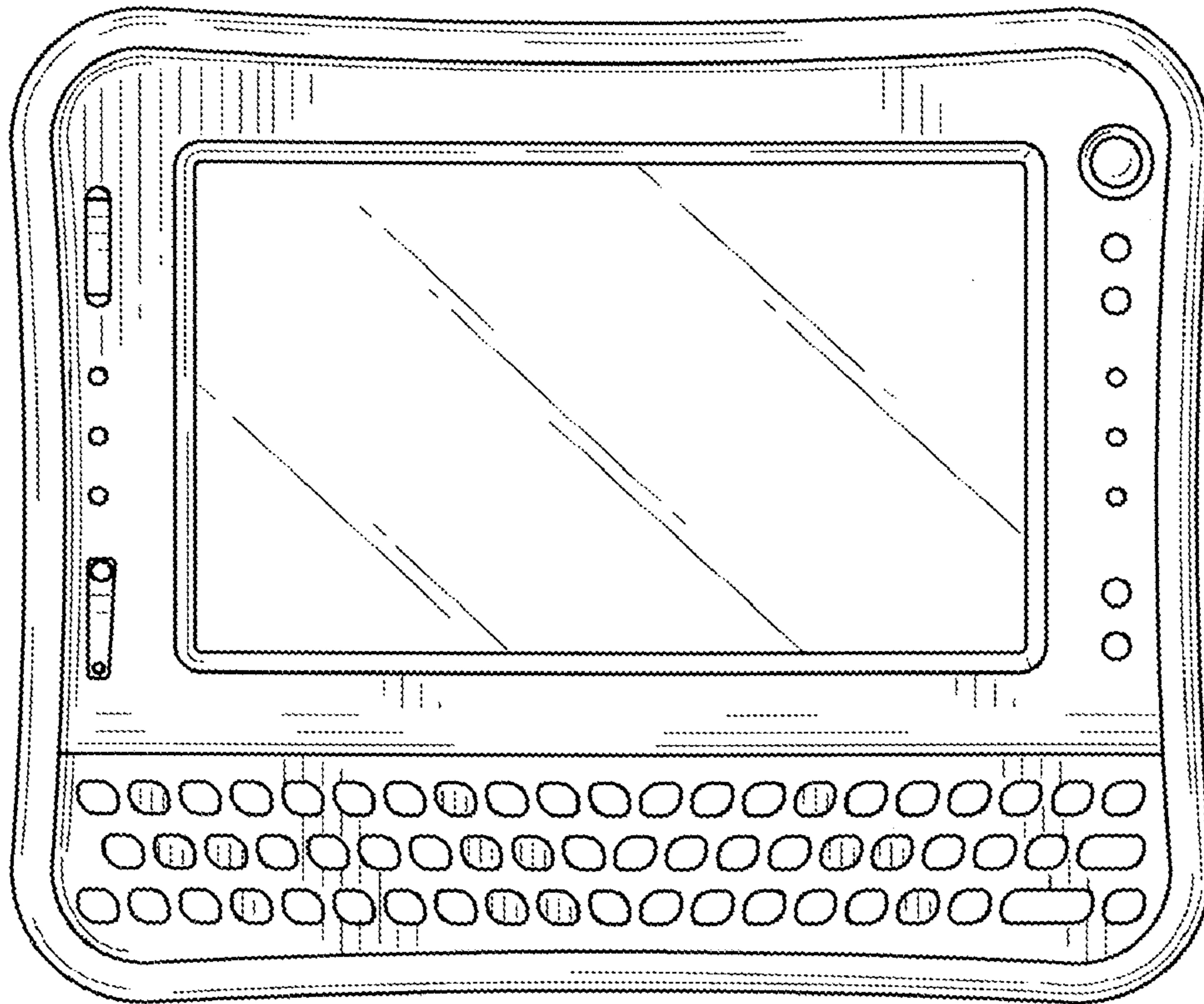

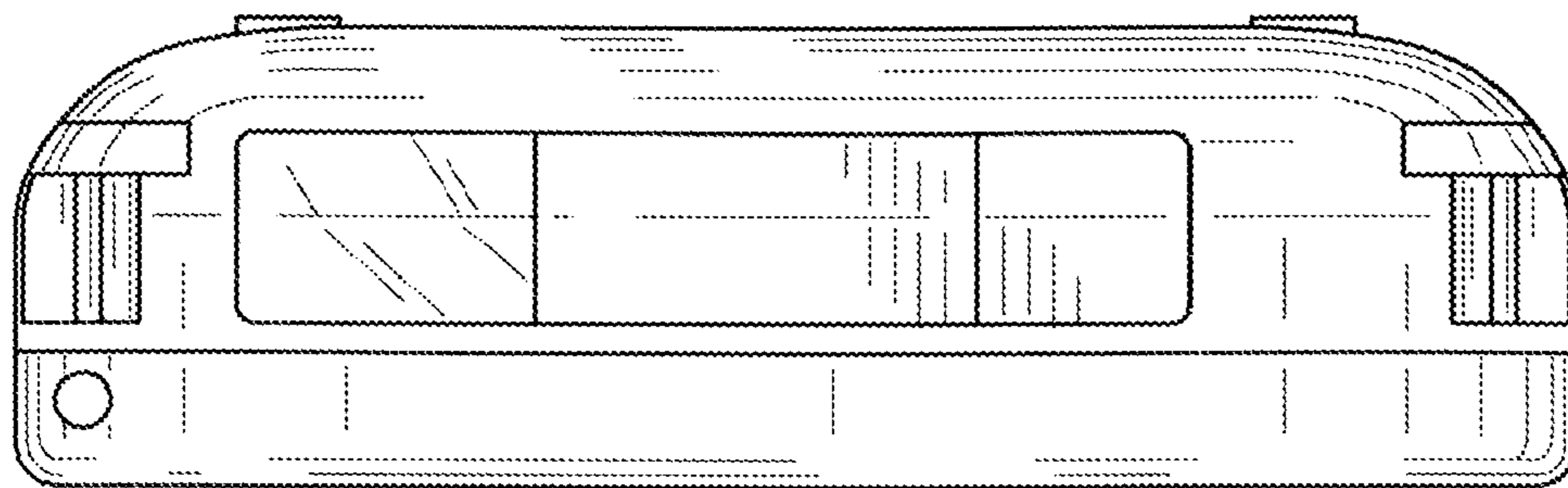

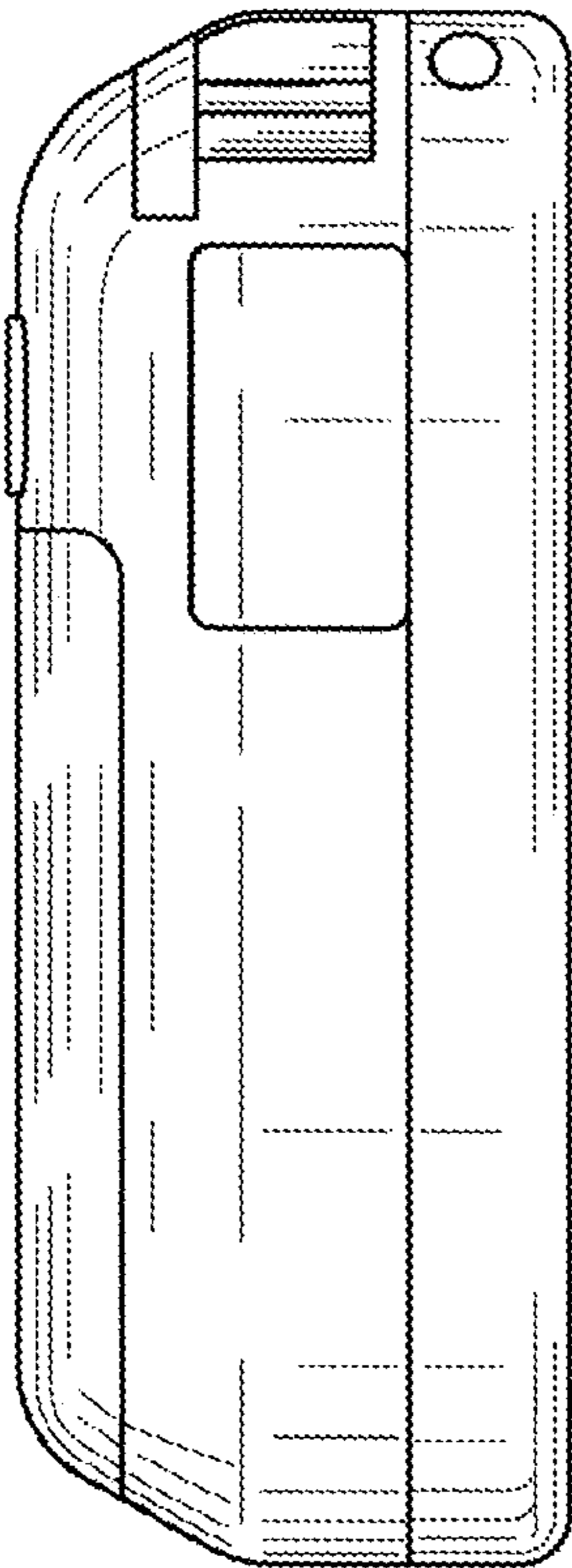

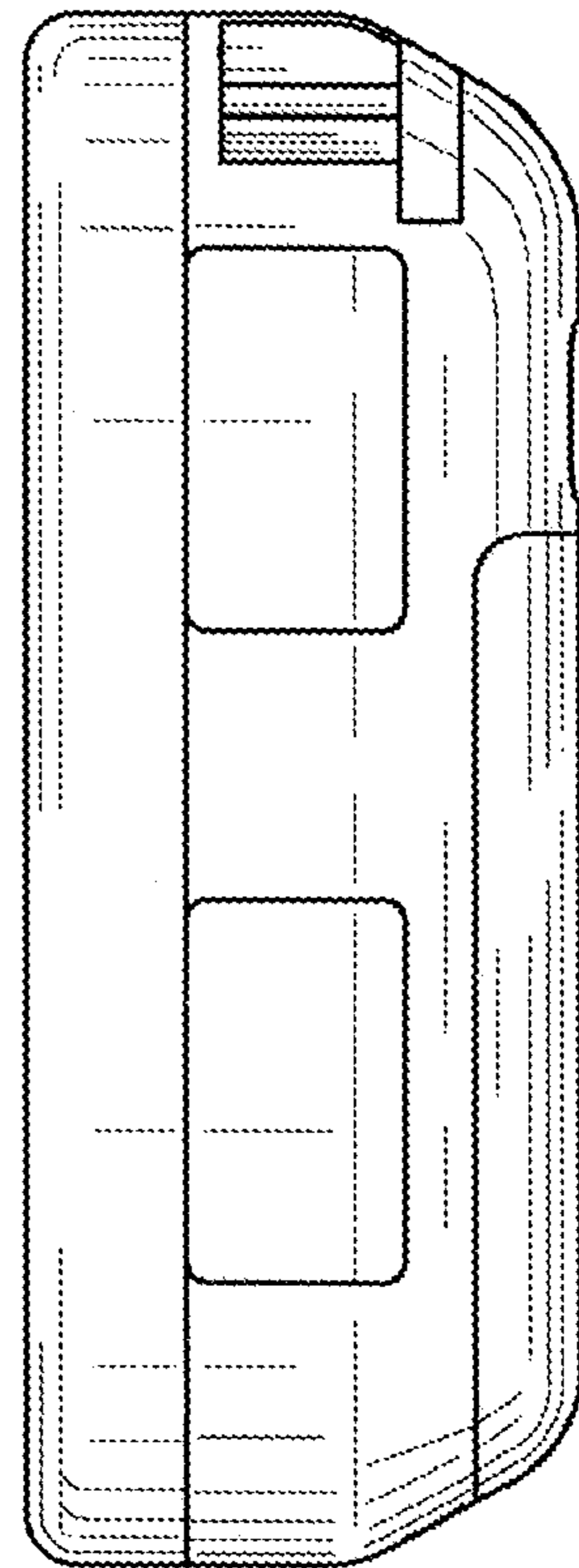

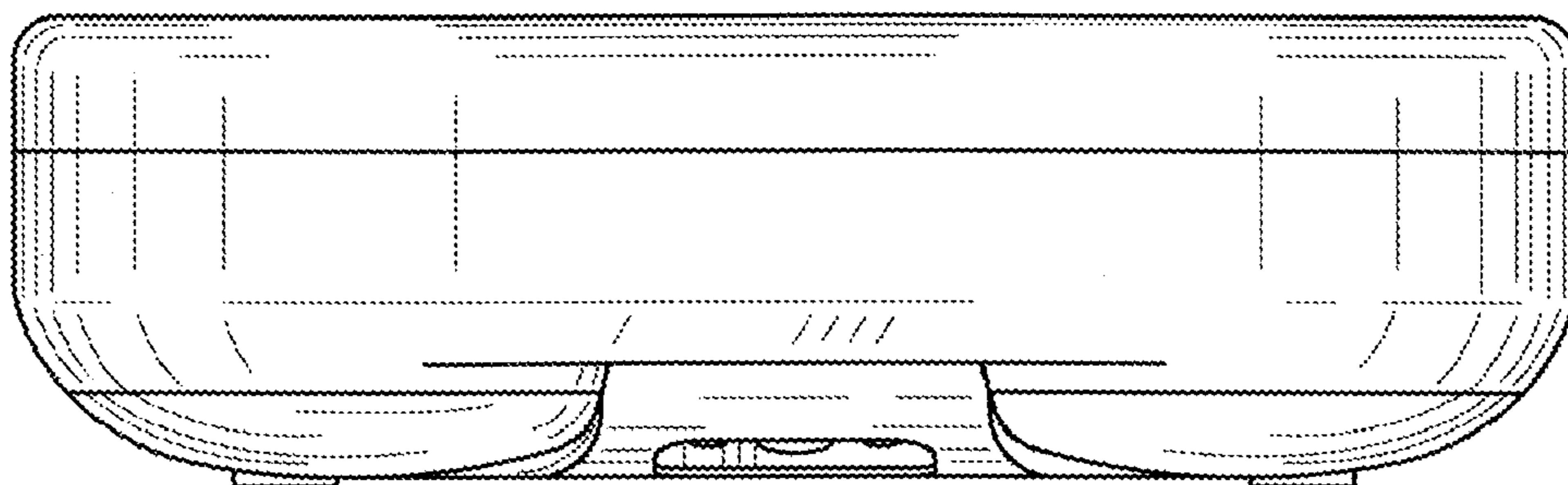

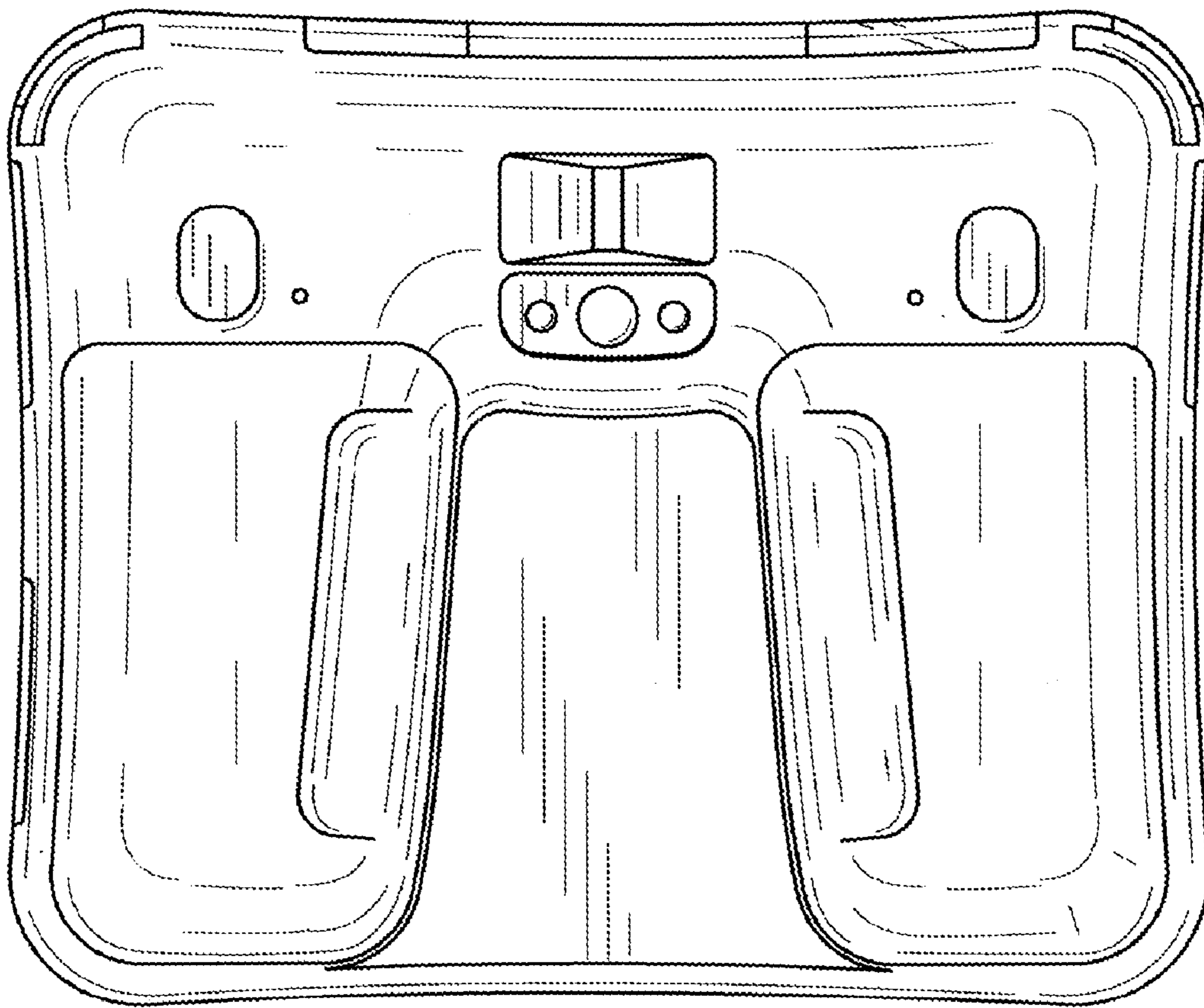
***Fig. 5.***
