(57) **CLAIM**

The ornamental design for a ballpoint pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a ballpoint pen showing my new design, with the writing tip retracted;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a bottom plan view thereof;

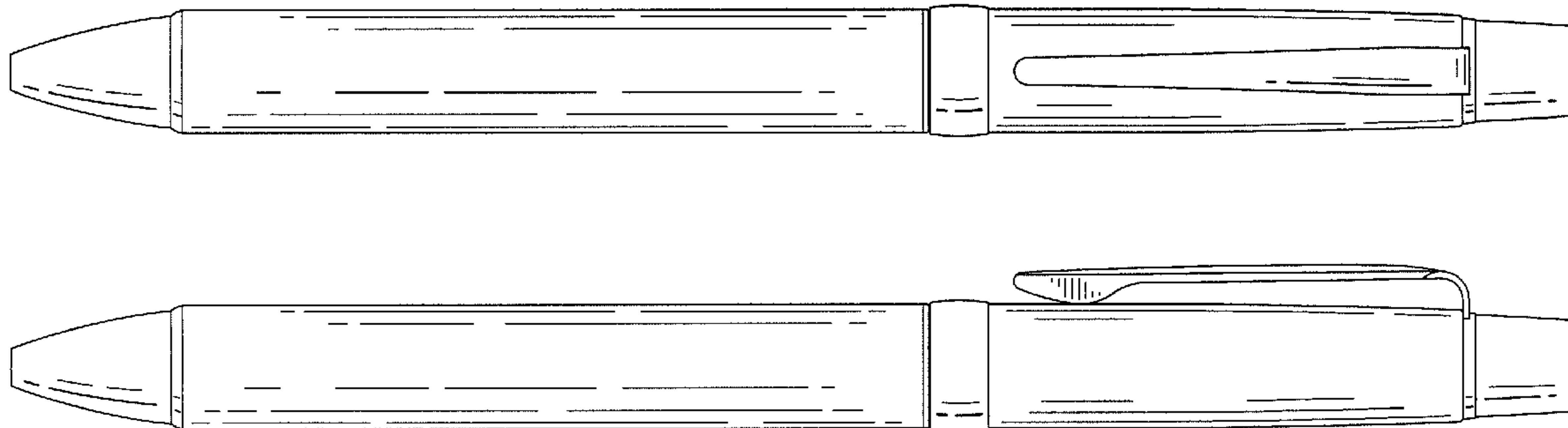
FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof; and,

FIG. 7 is a front elevational view thereof, with the writing tip extended.

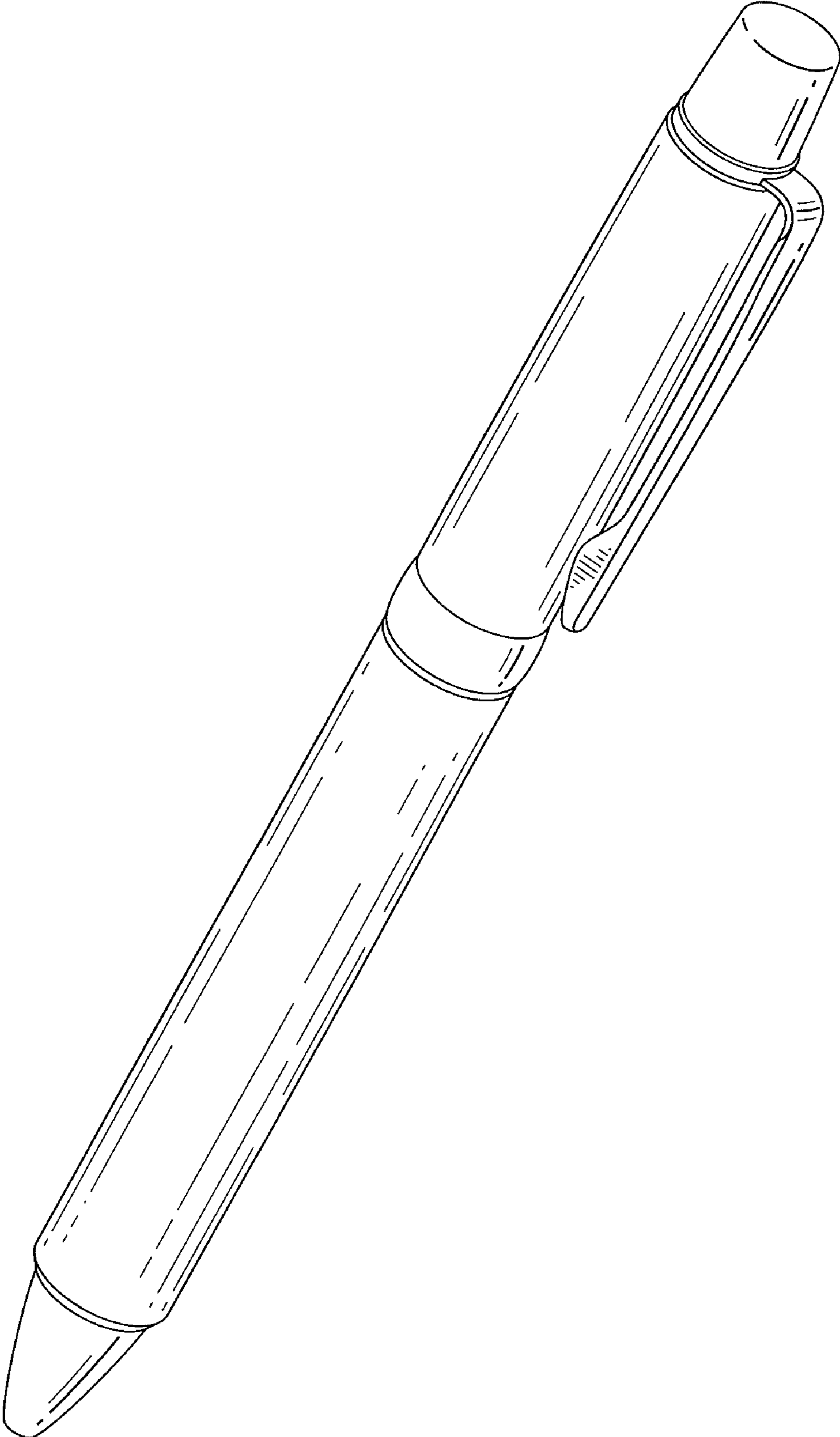

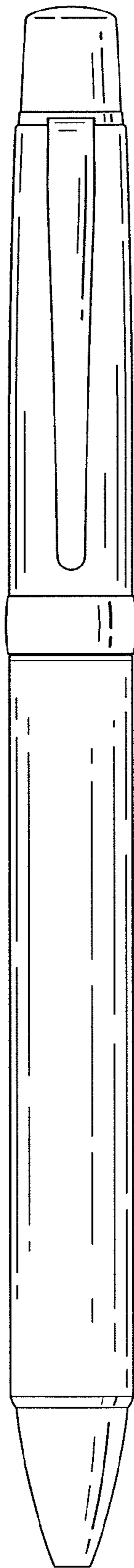

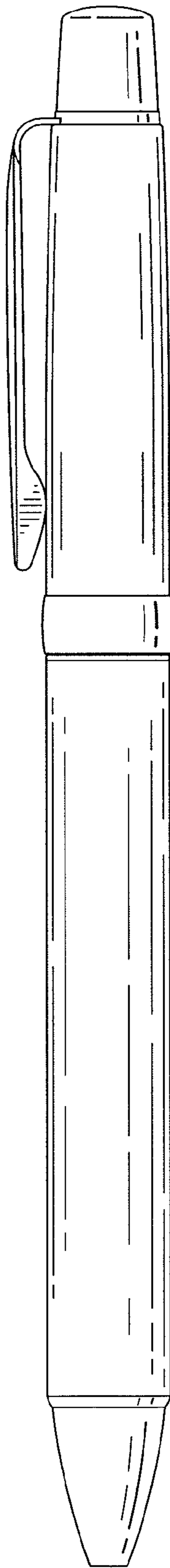

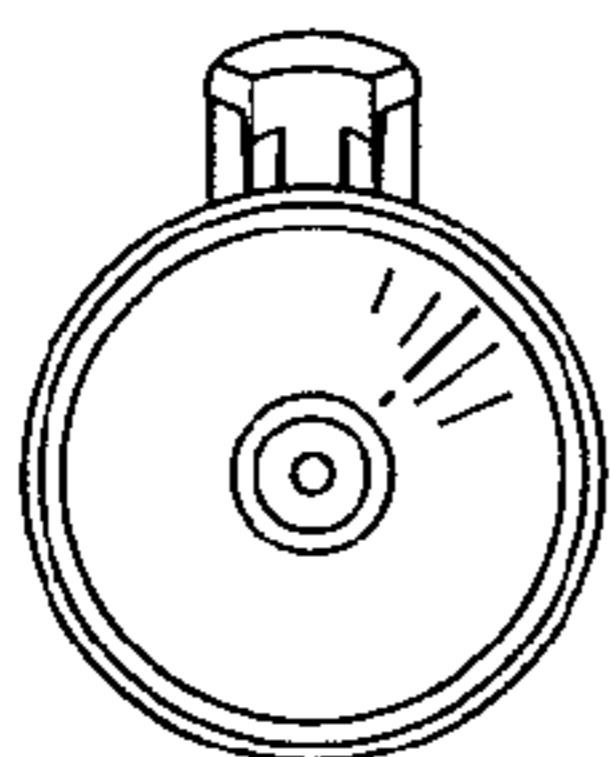

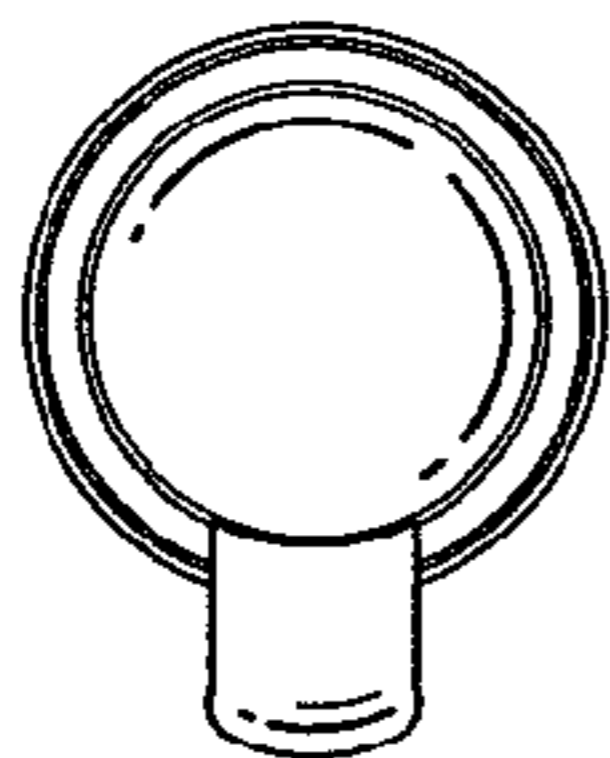

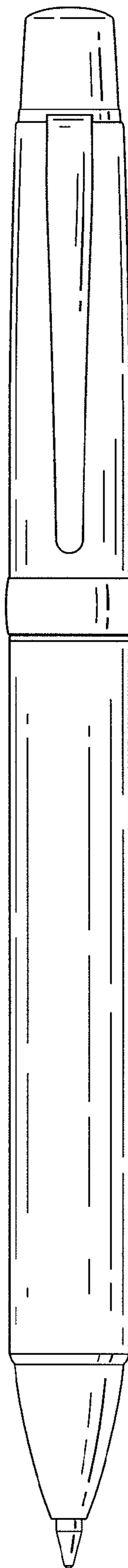
