FIG. 1 is a top perspective view of a rifle receiver trigger gasket showing my new design.

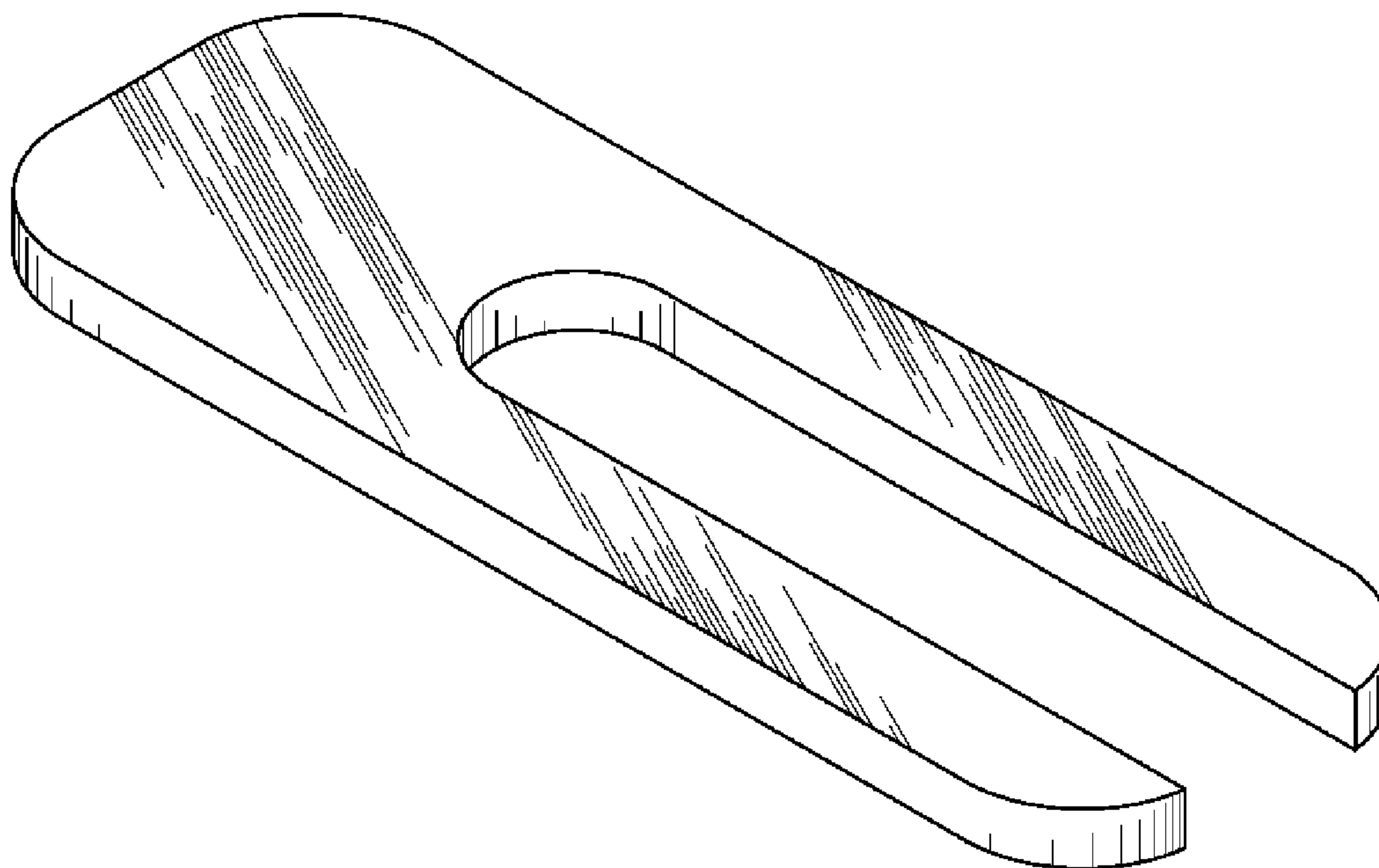
FIG. 2 is a top plan view thereof with the bottom side being a mirror image thereof.

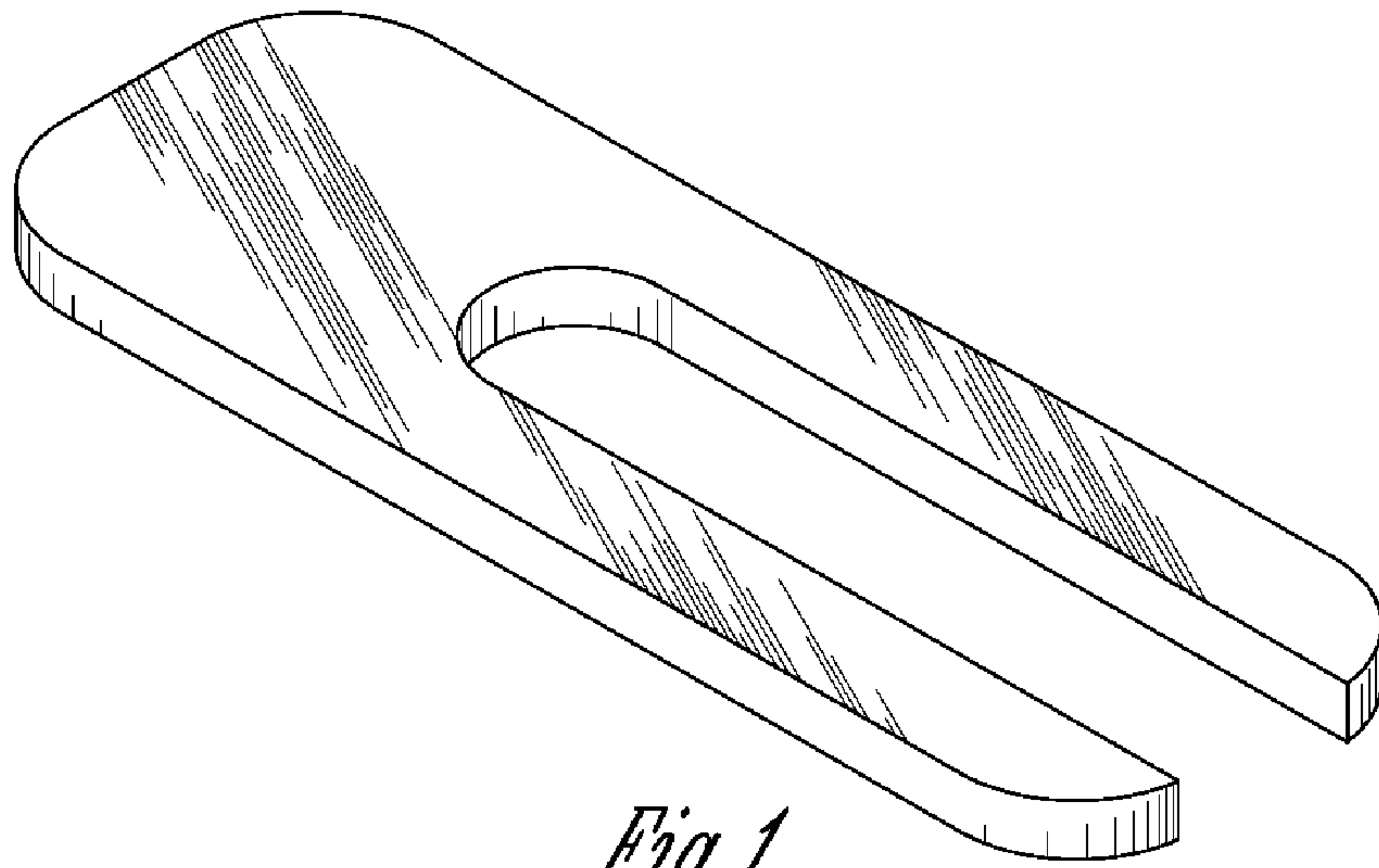
FIG. 3 is a side elevation view thereof with the opposite side being a mirror image thereof.

FIG. 4 is a right side elevation view thereof; and,

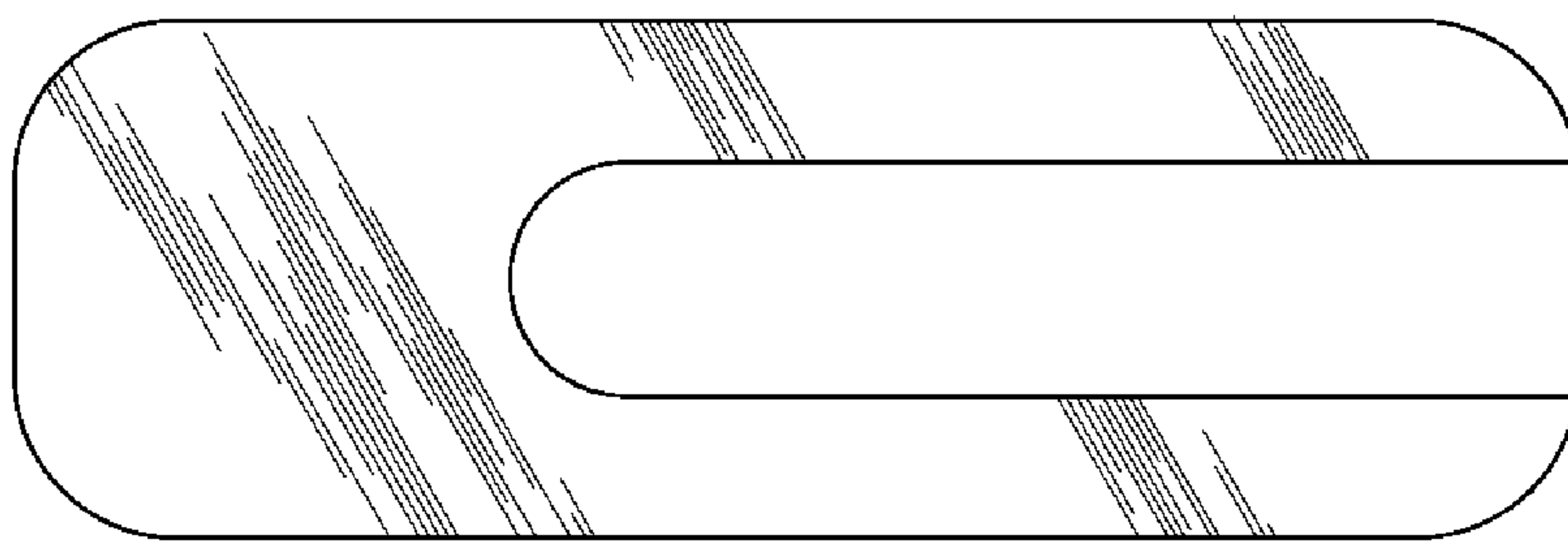
FIG. 5 is a left side elevation view thereof.

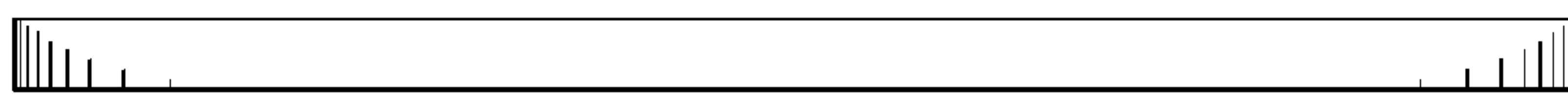




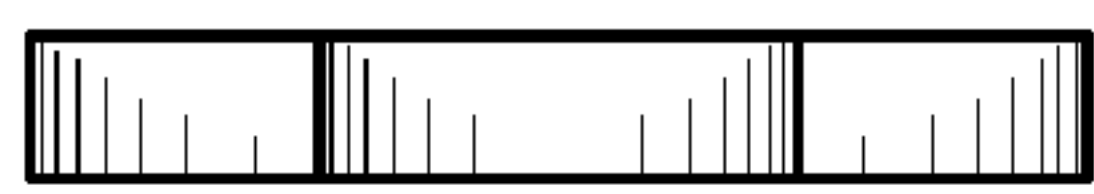

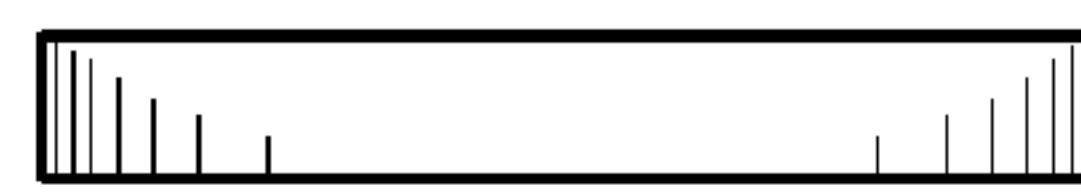
