FIG. 4 is a bottom plan view thereof;

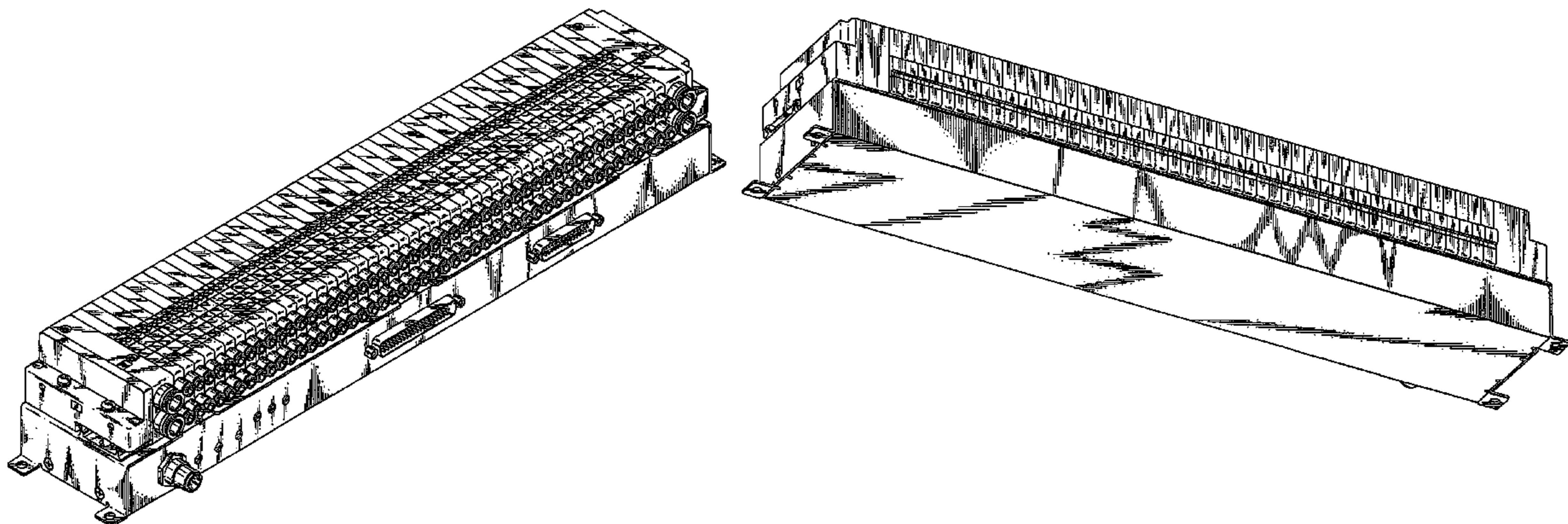
FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

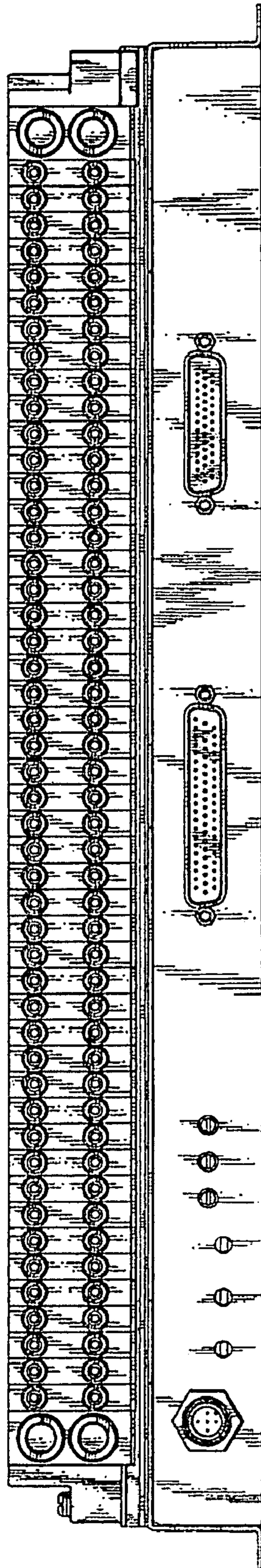
FIG. 7 is a top and left front perspective view thereof; and,

FIG. 8 is a bottom and right rear perspective view thereof.

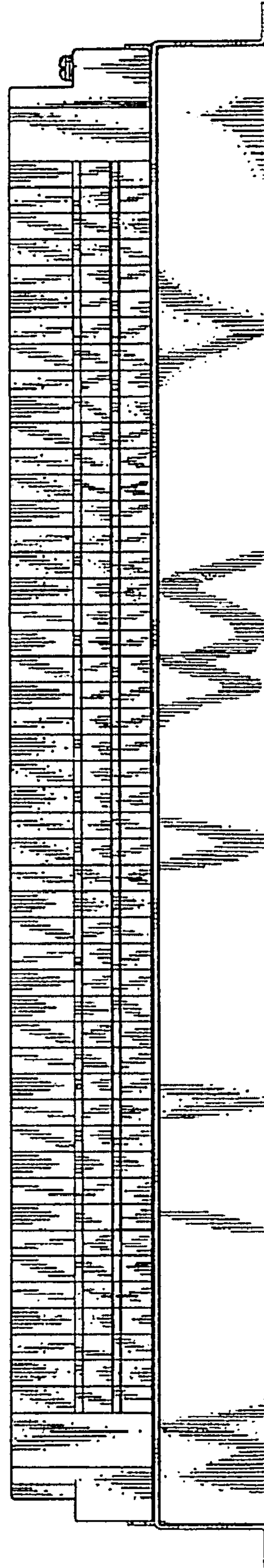

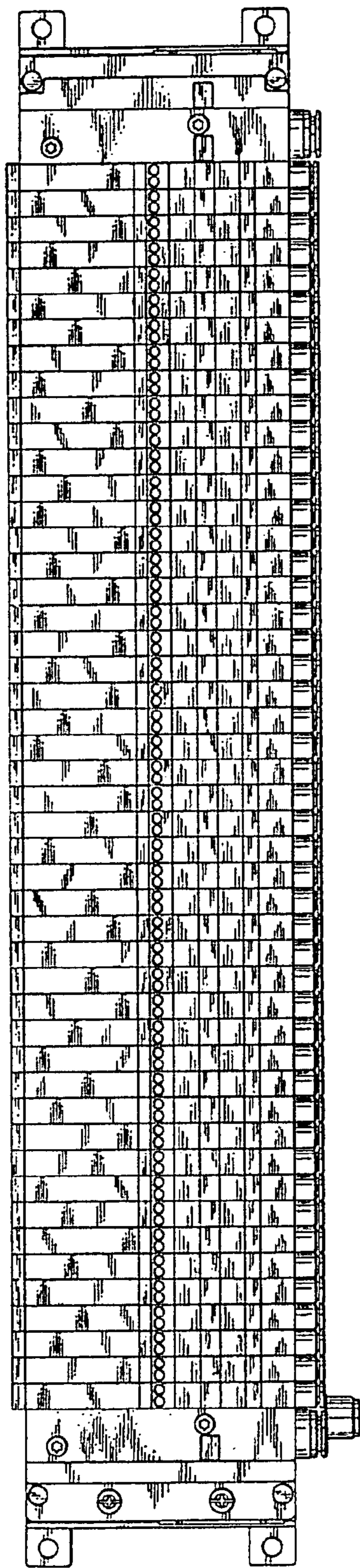

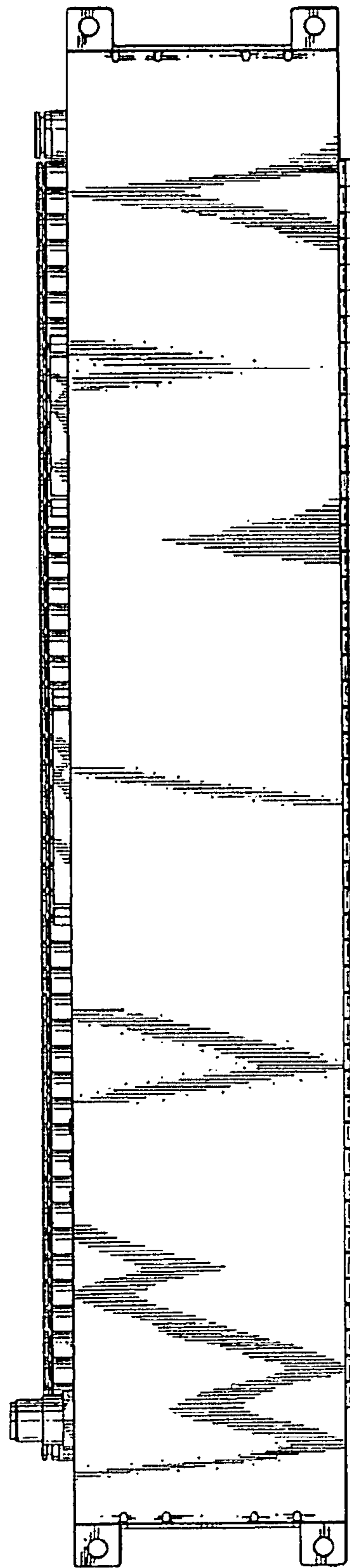

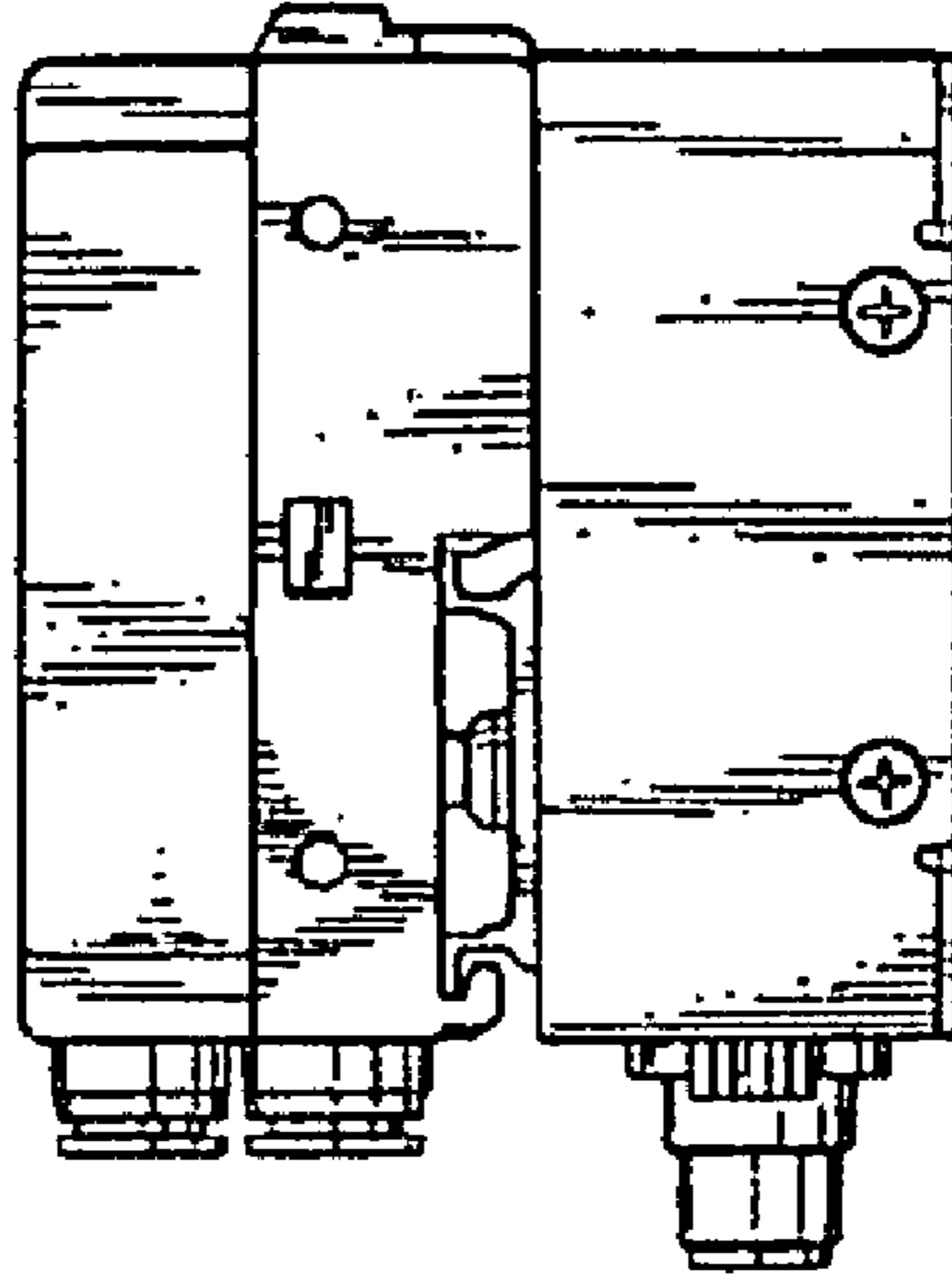

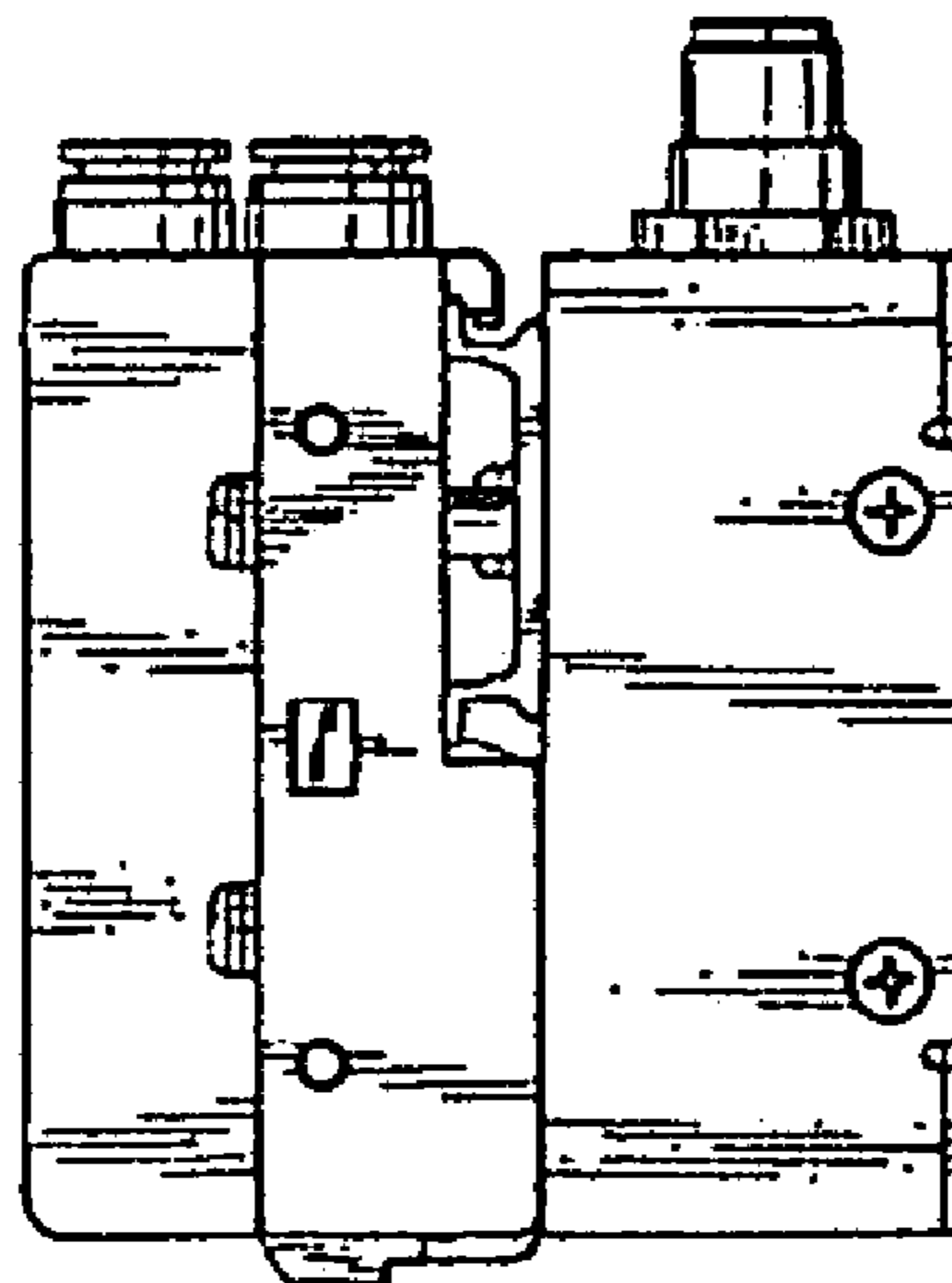

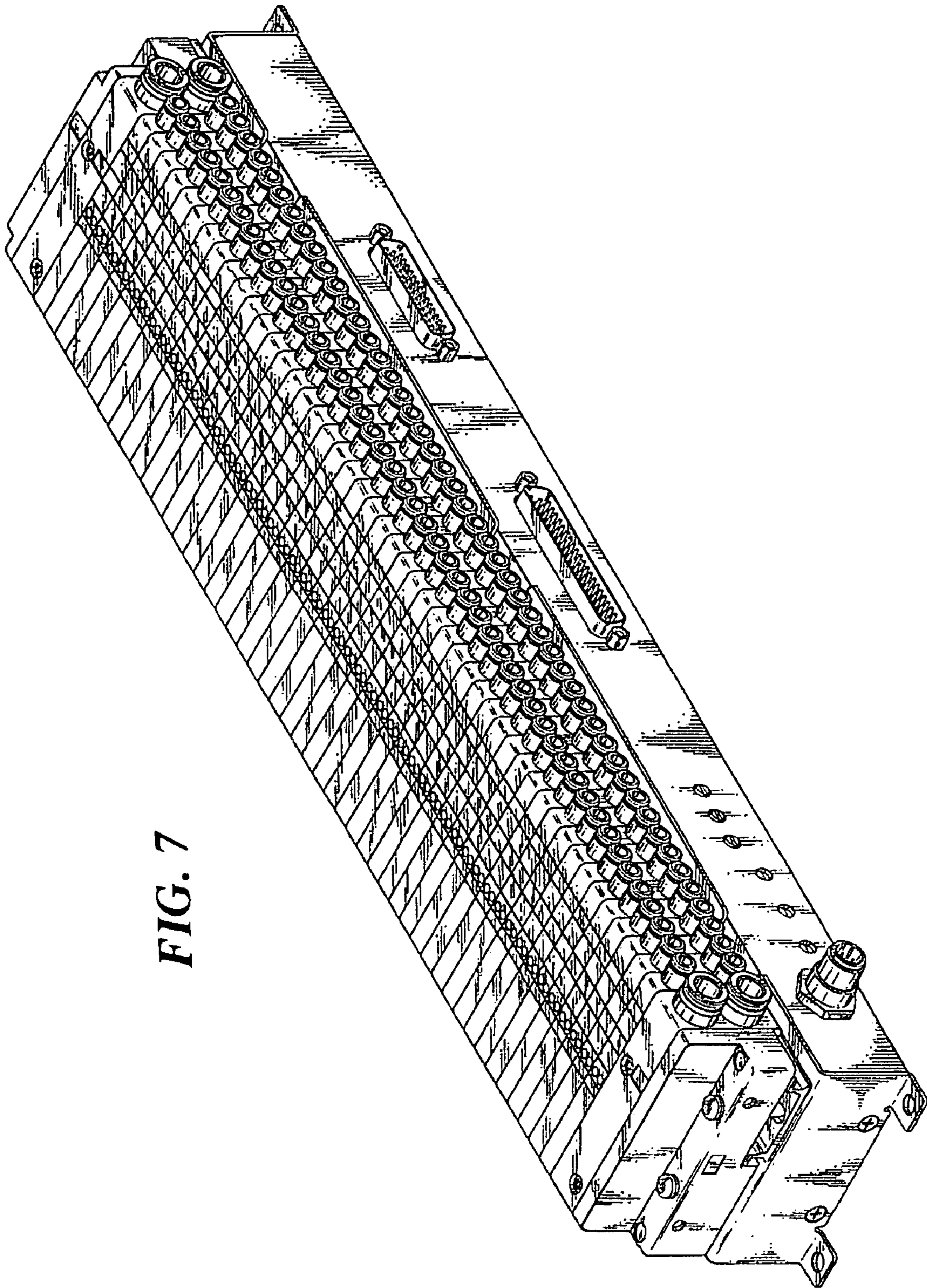
