DESCRIPTION

FIG. 1 is a front elevational view of a garment drying apparatus showing my new design expanded open with poles;

FIG. 2 is a rear elevational view of the garment drying apparatus of FIG. 1;

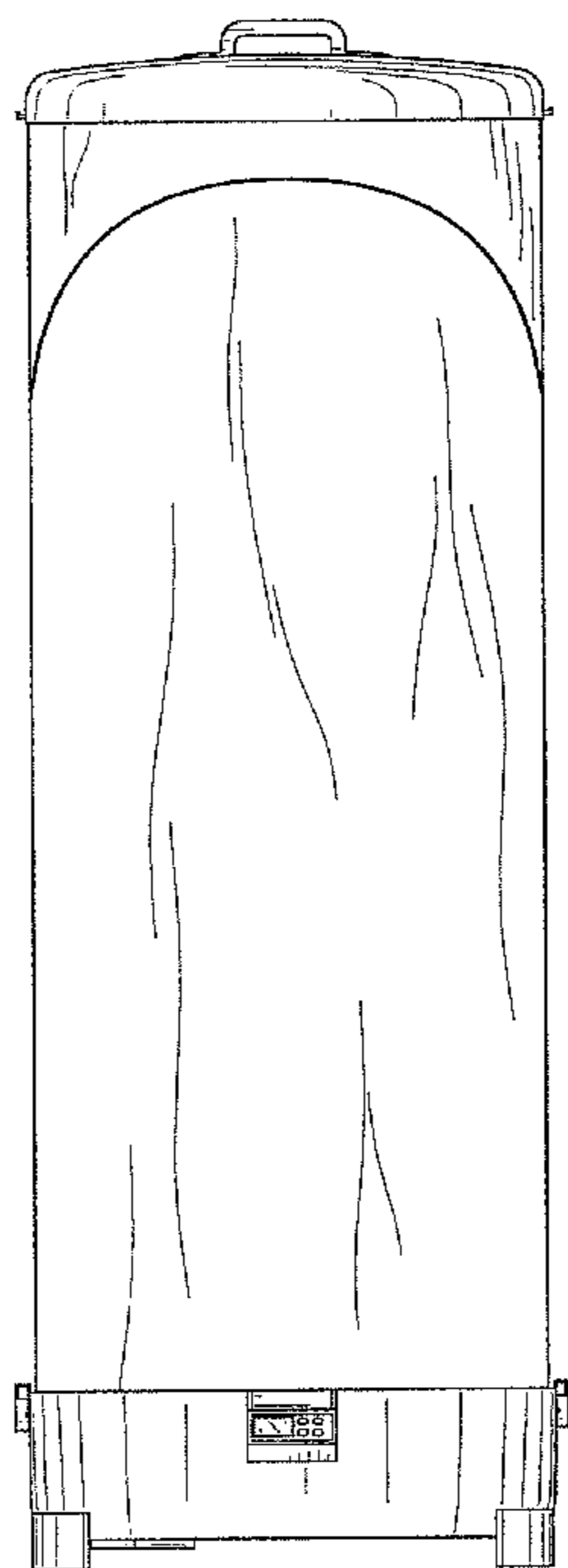
FIG. 3 is a top plan view of the garment drying apparatus of FIG. 1;

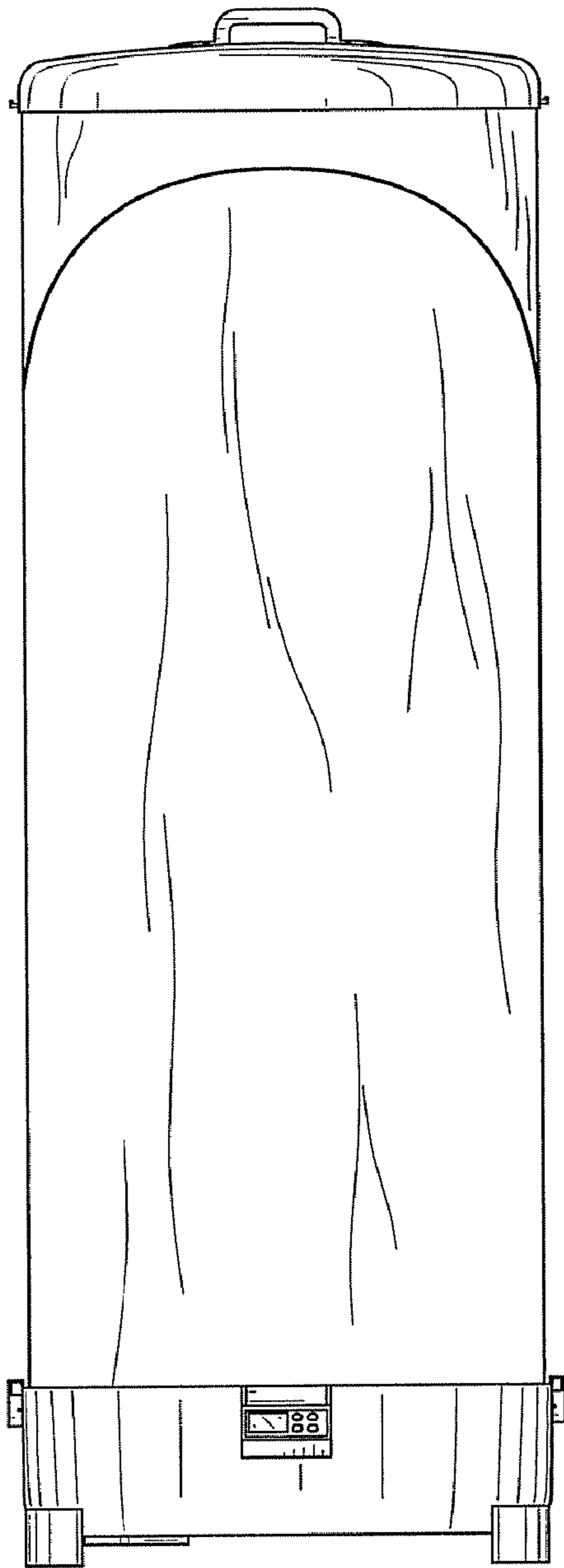

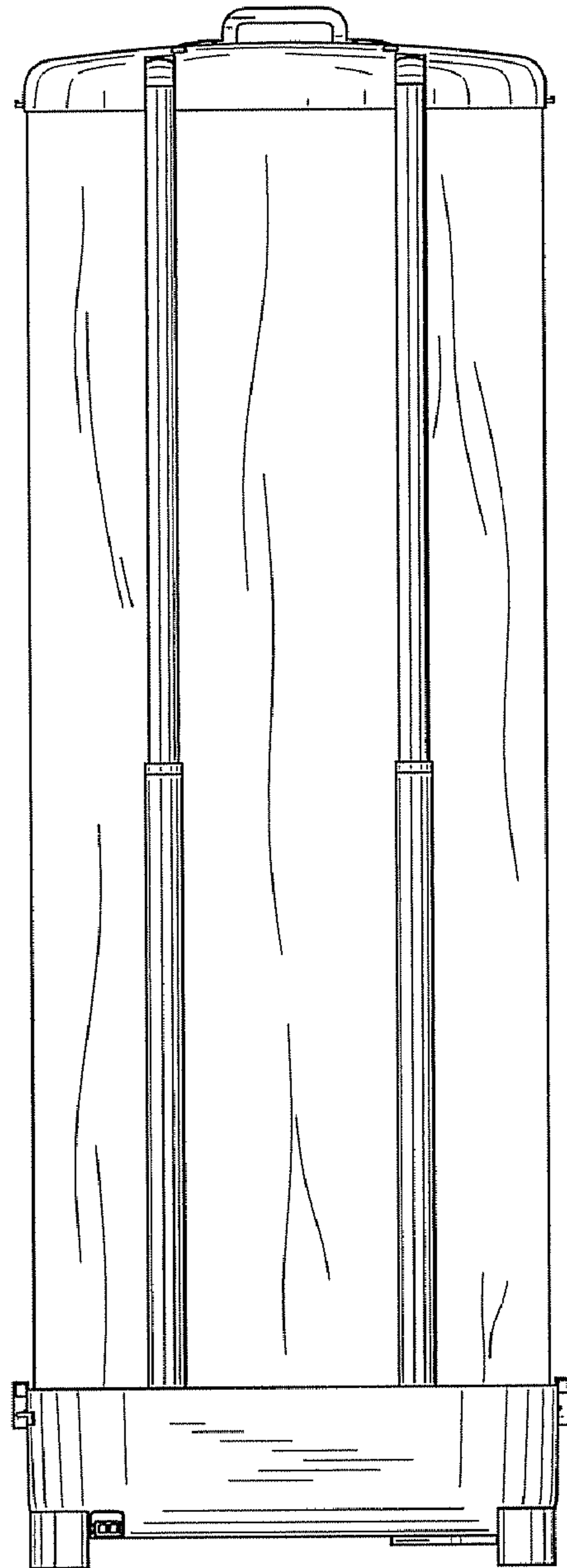

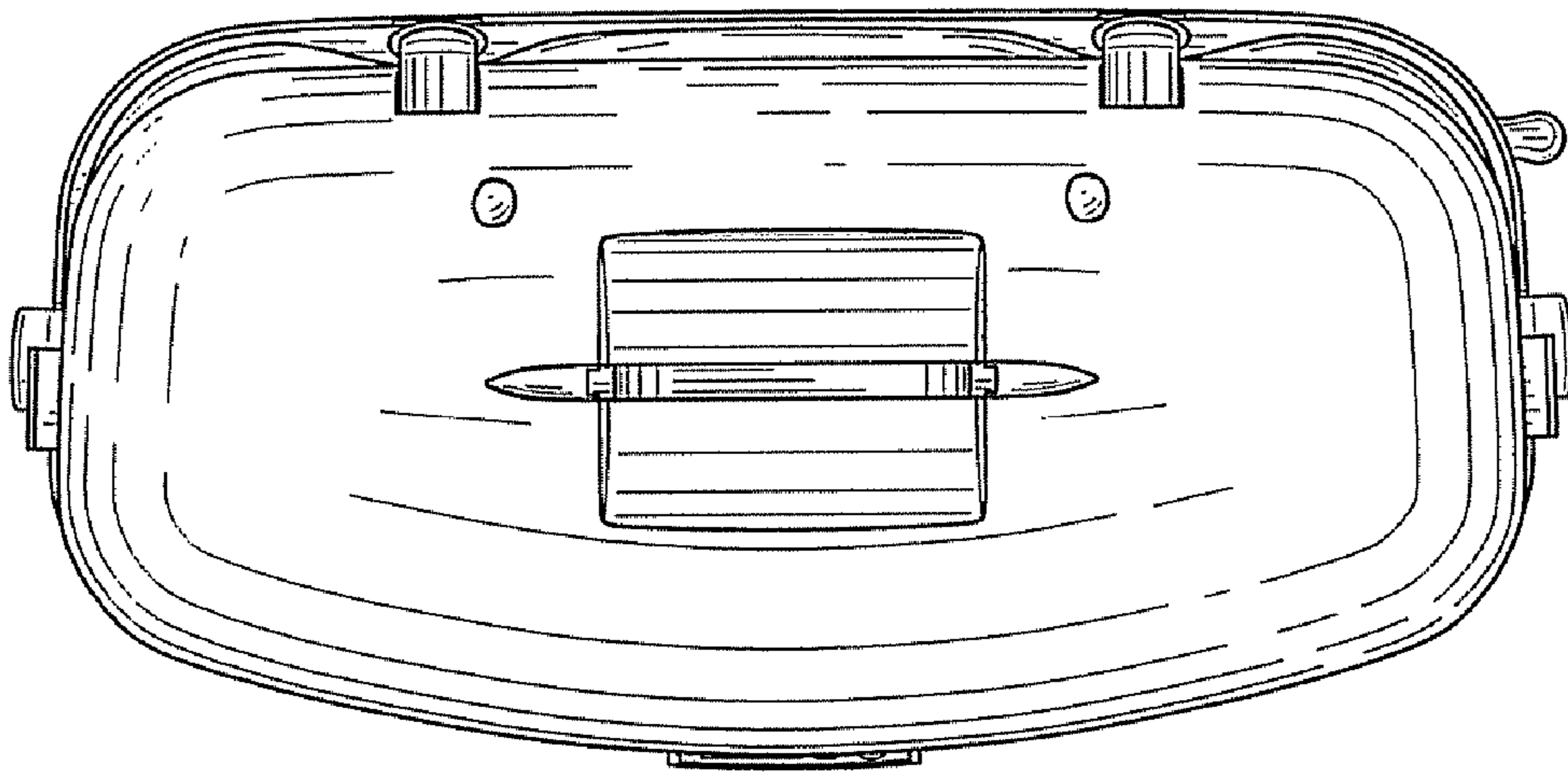

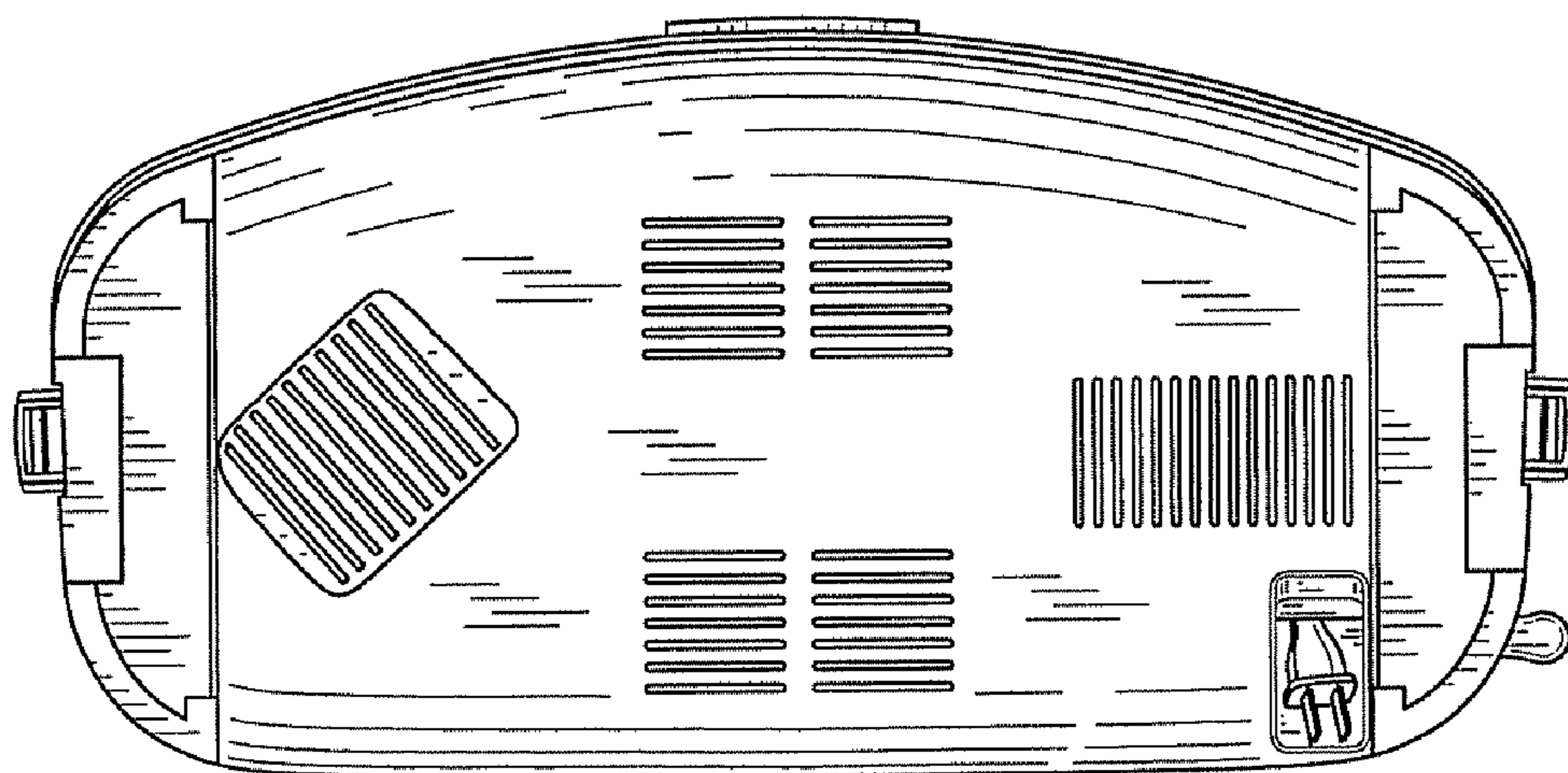

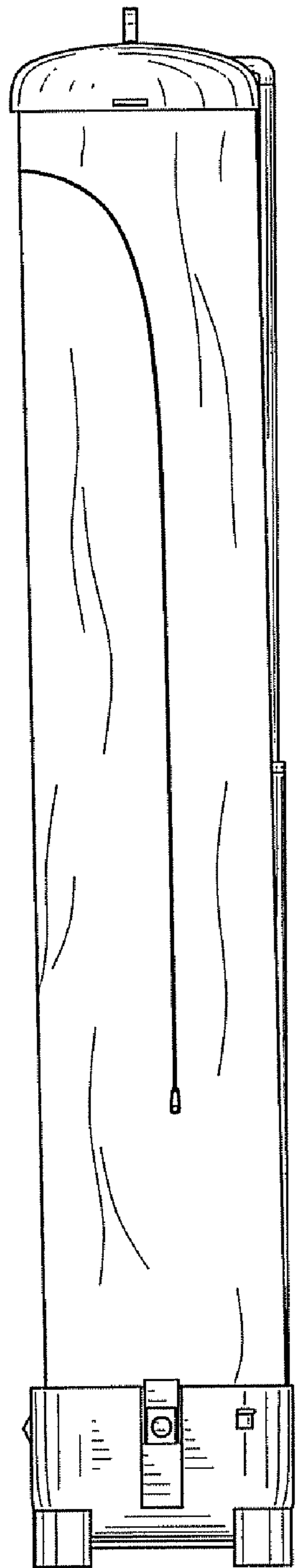

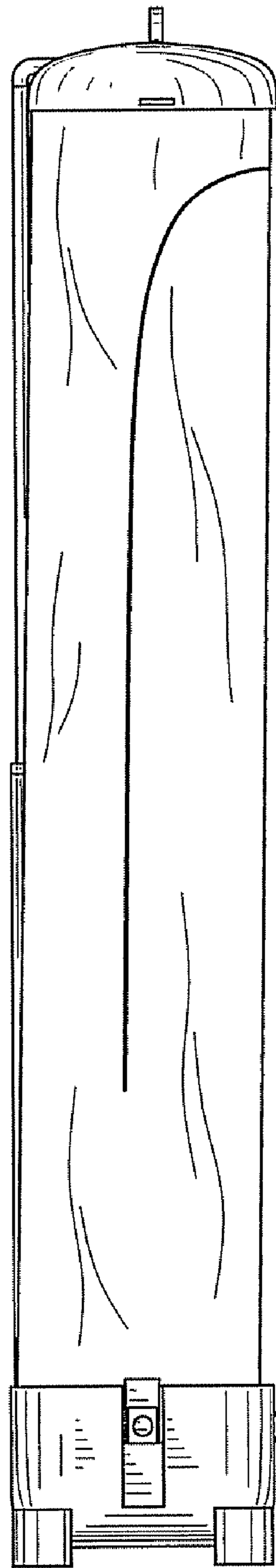
