The ornamental design for a shirt with integrated reflective safety vest, as shown and described.

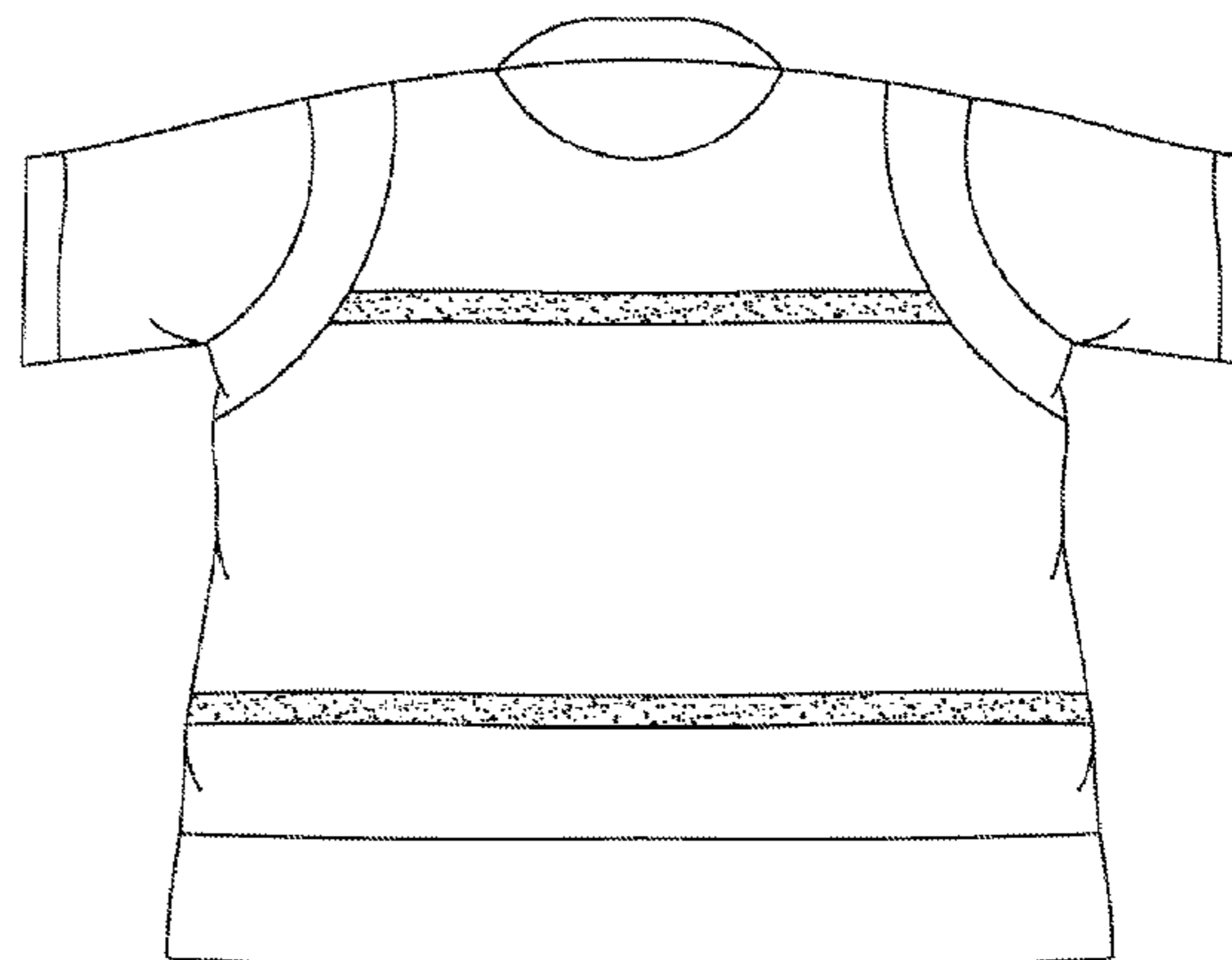
DESCRIPTION

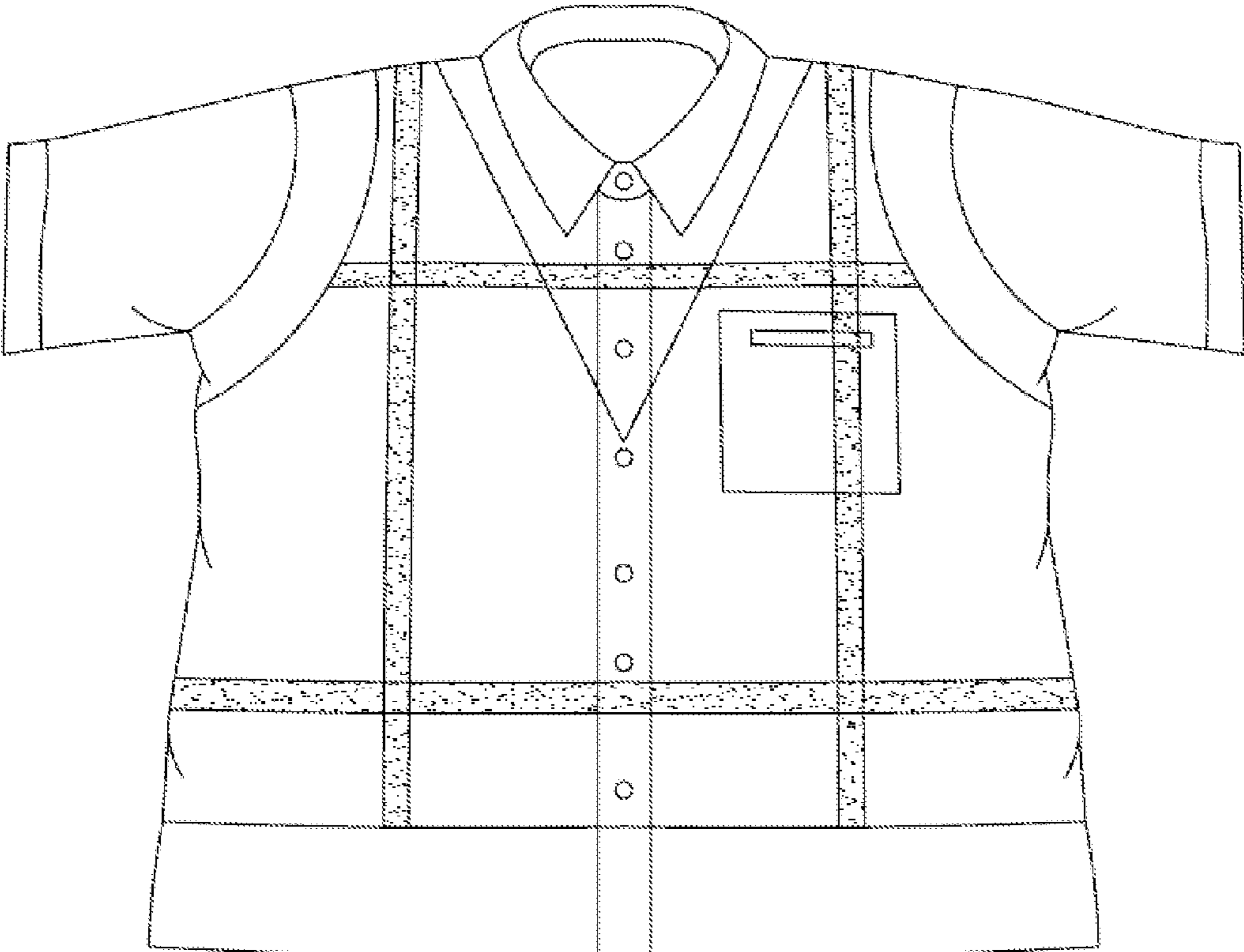

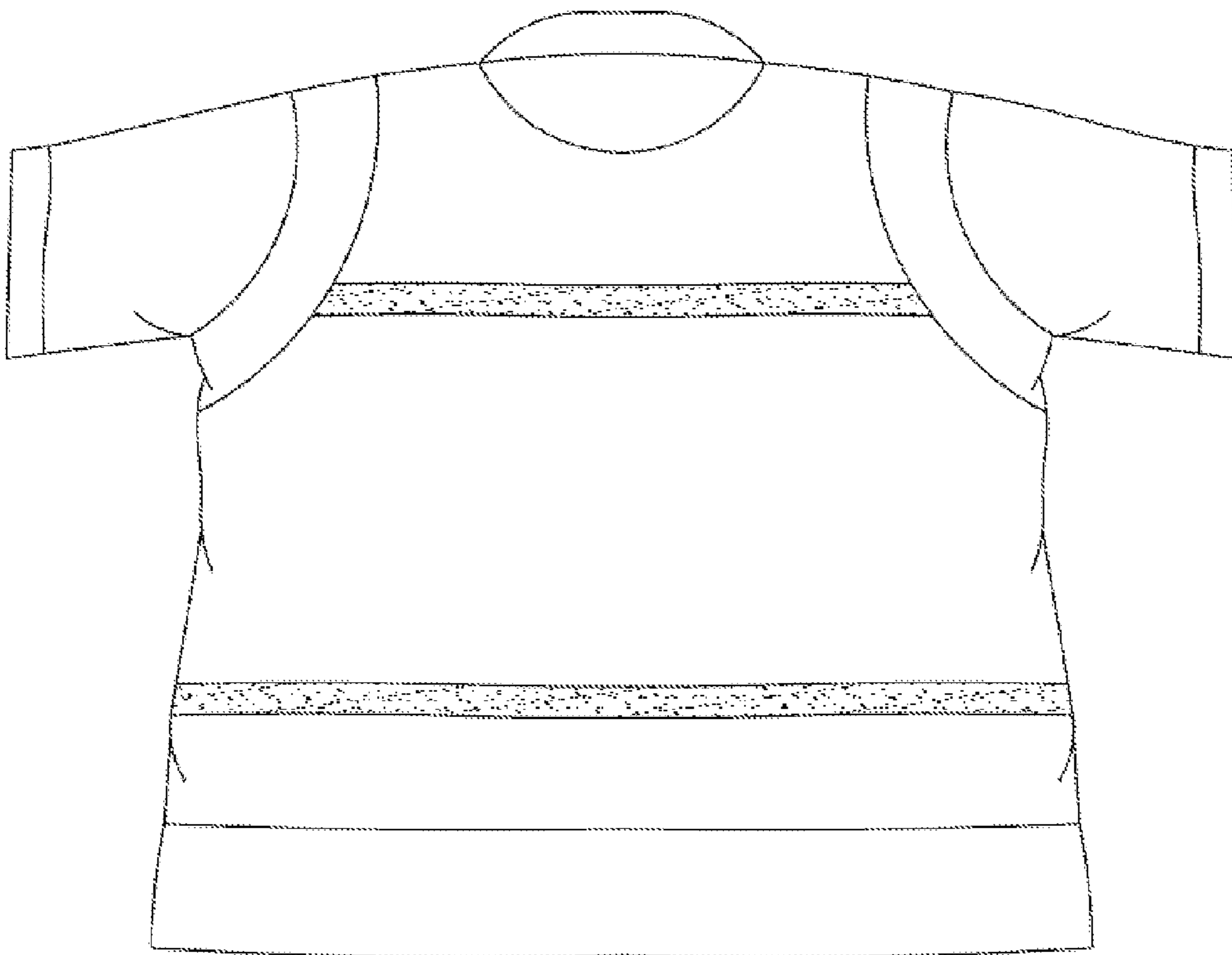
