We claim the ornamental design for footwear with antenna, as shown.

DESCRIPTION

FIG. 1 is a perspective view of footwear with antenna, according to the present invention;

FIG. 2 is a top view of the footwear with antenna of FIG. 1;

FIG. 3 is a side view of the footwear with antenna of FIG. 1;

FIG. 4 is an opposite side view of the footwear with antenna of FIG. 1;

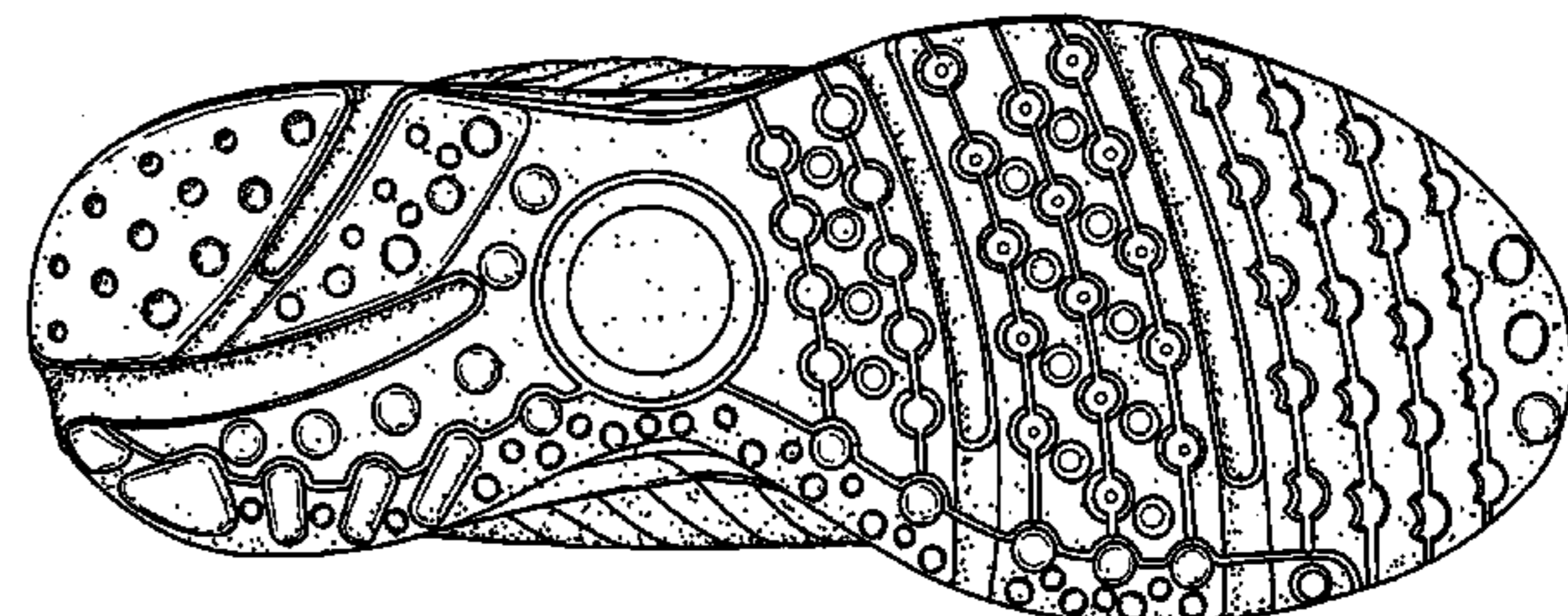
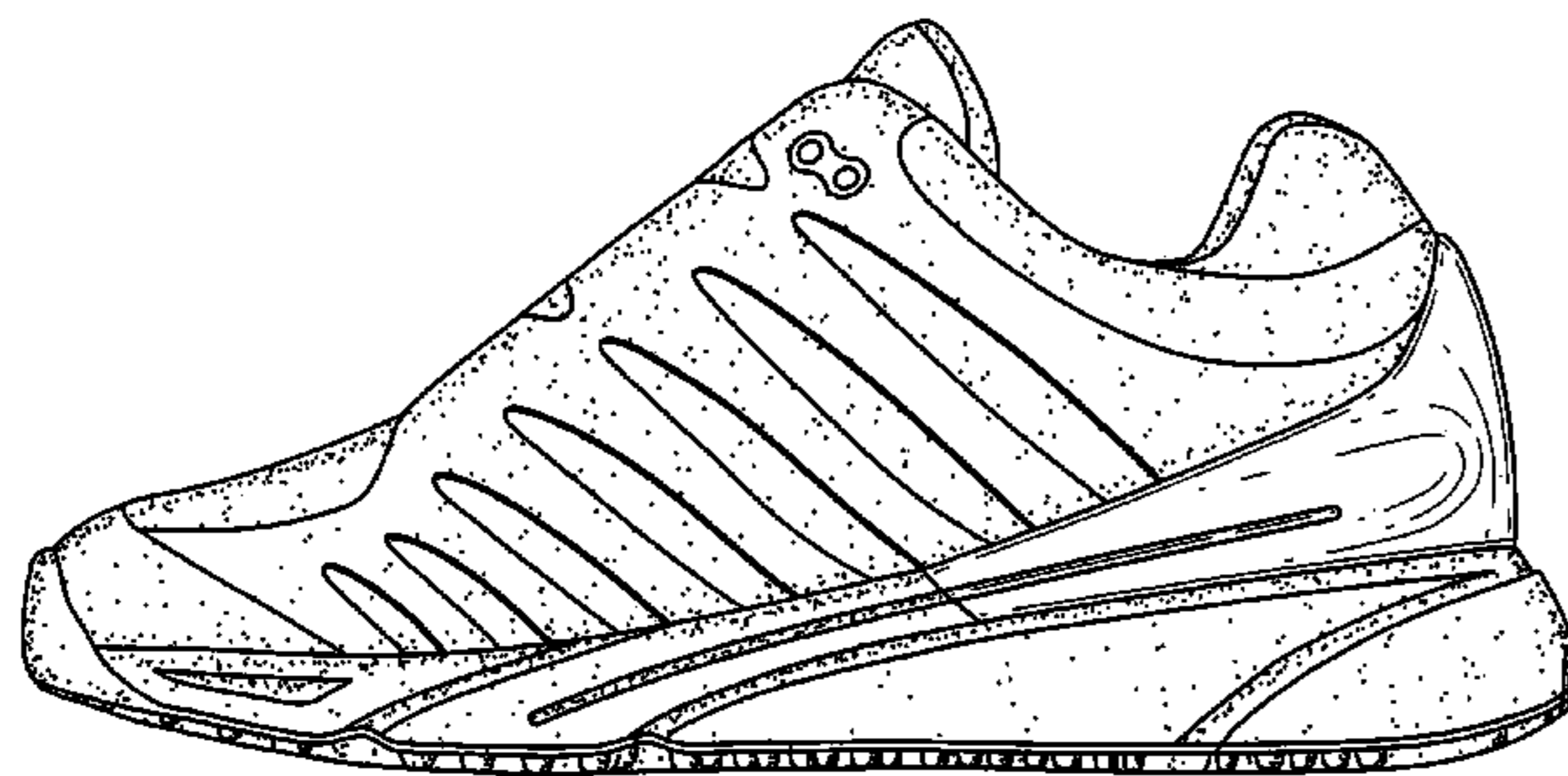

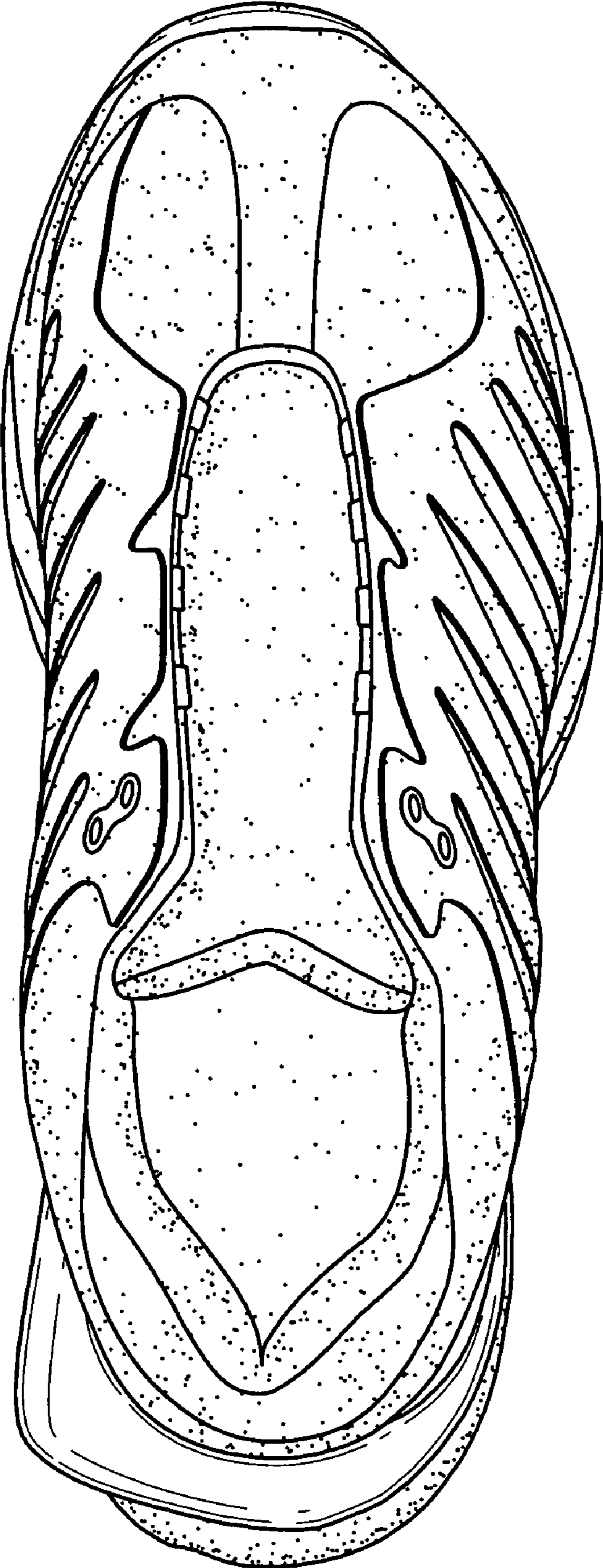
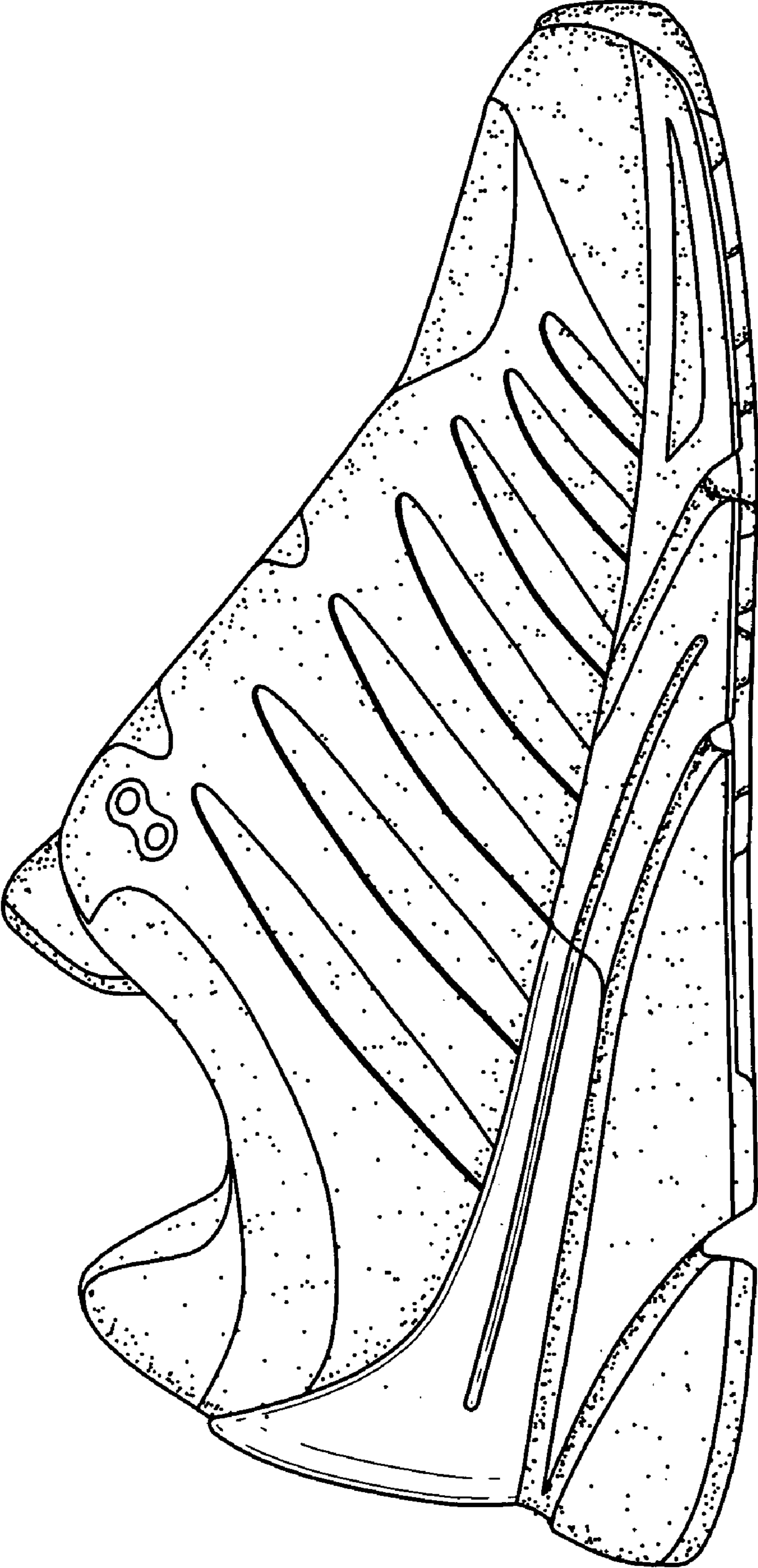

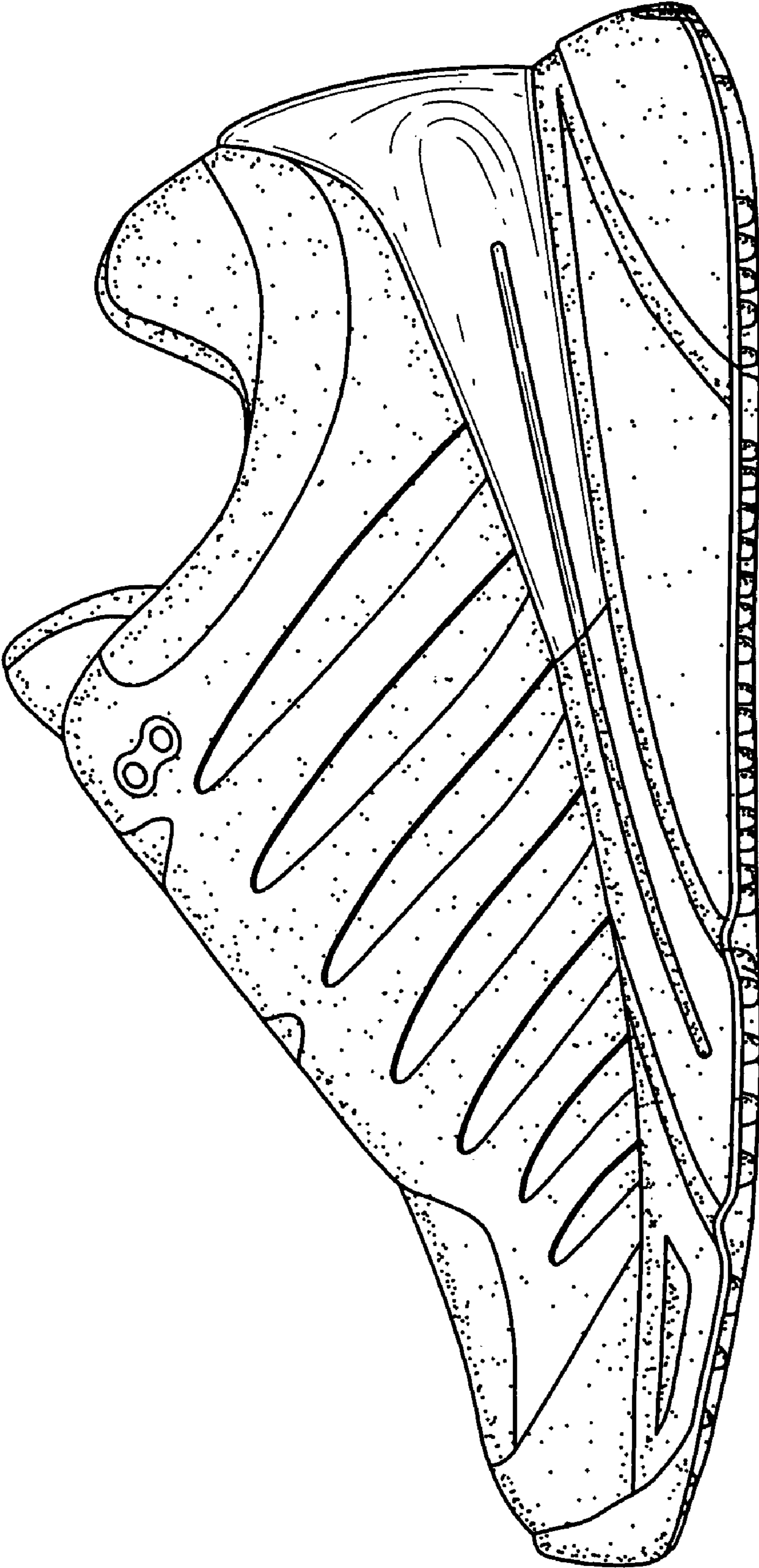

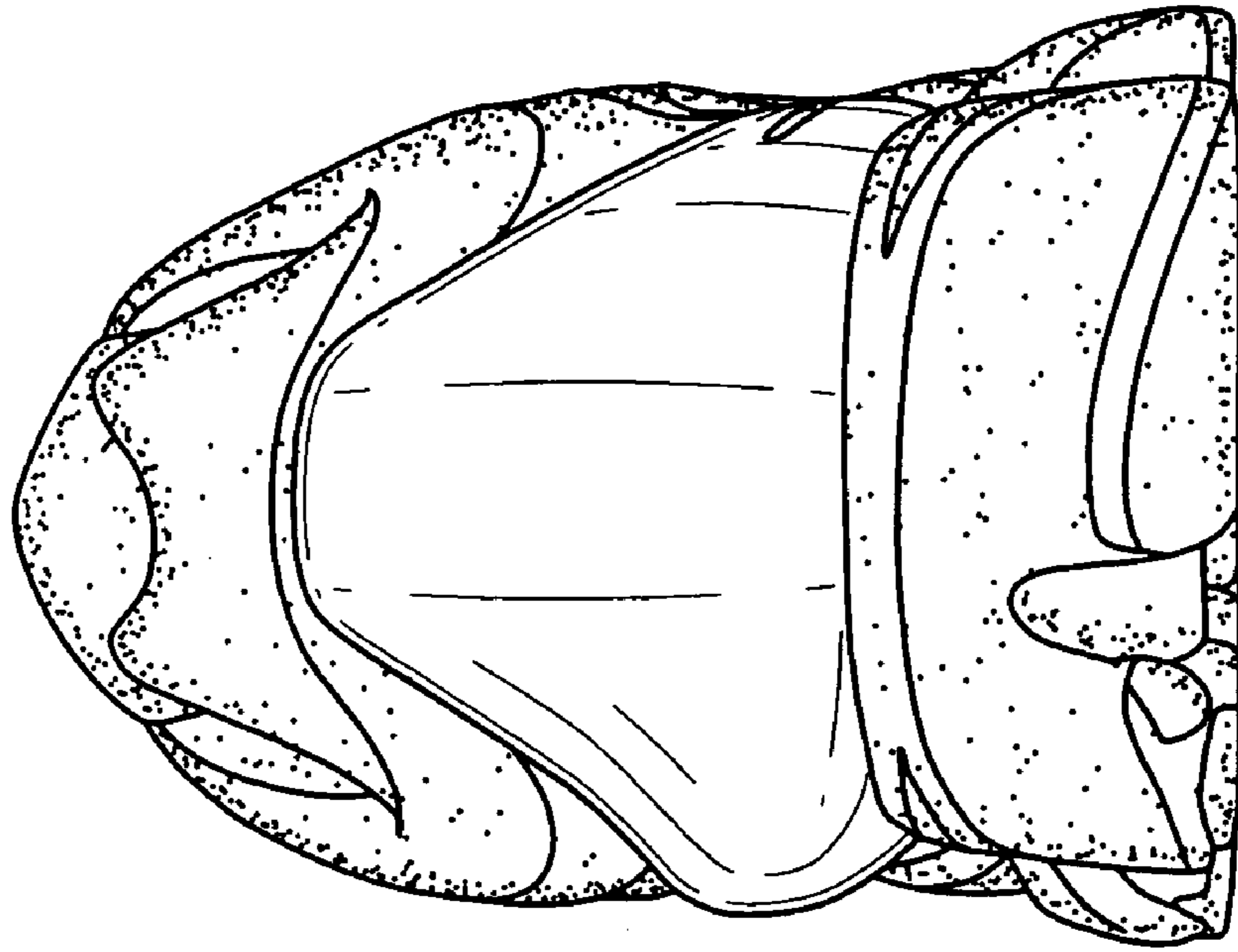
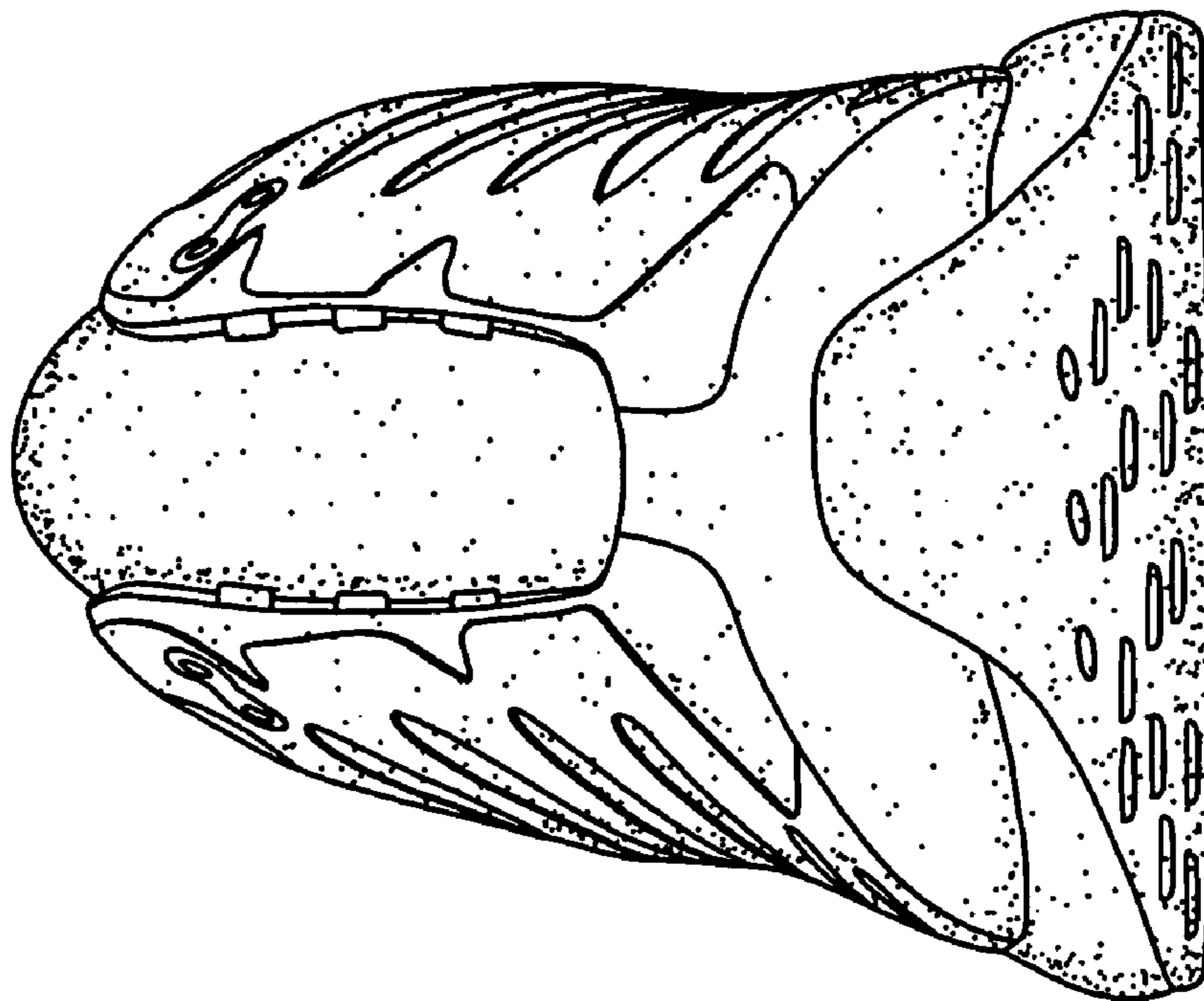

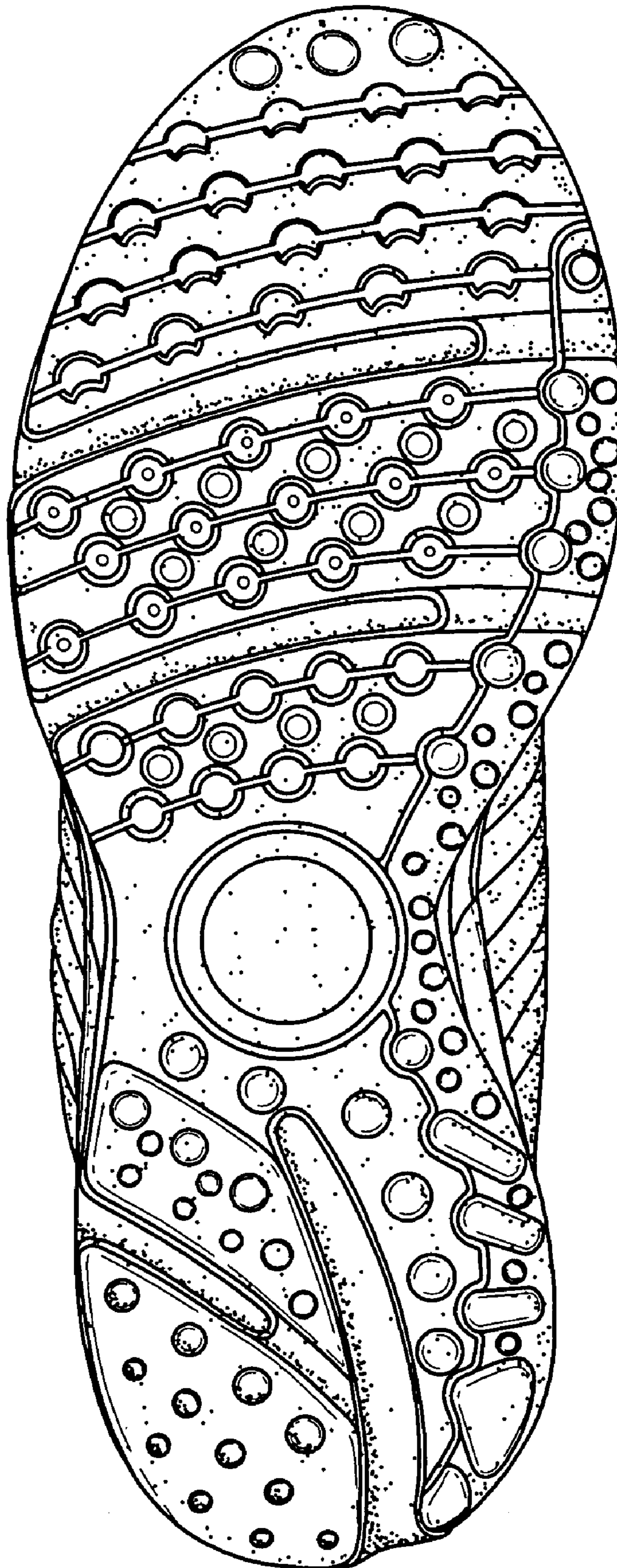
