(57) **CLAIM**

The ornamental design for luggage, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the luggage, embodying our new design.

FIG. 2 is front view of the luggage of FIG. 1.

FIG. 3 is a rear view of the luggage of FIG. 1.

FIG. 4 is left side view of the luggage of FIG. 1.

FIG. 5 is right side view of the luggage of FIG. 1.

FIG. 6 is a top view of the luggage of FIG. 1; and,

FIG. 7 is a bottom view of the luggage of FIG. 1.

The broken lines shown on the straps and front trim of the luggage depict stitching and form part of the claimed design. All other broken lines in the figures are illustrative of environment and form no part of the claimed design.

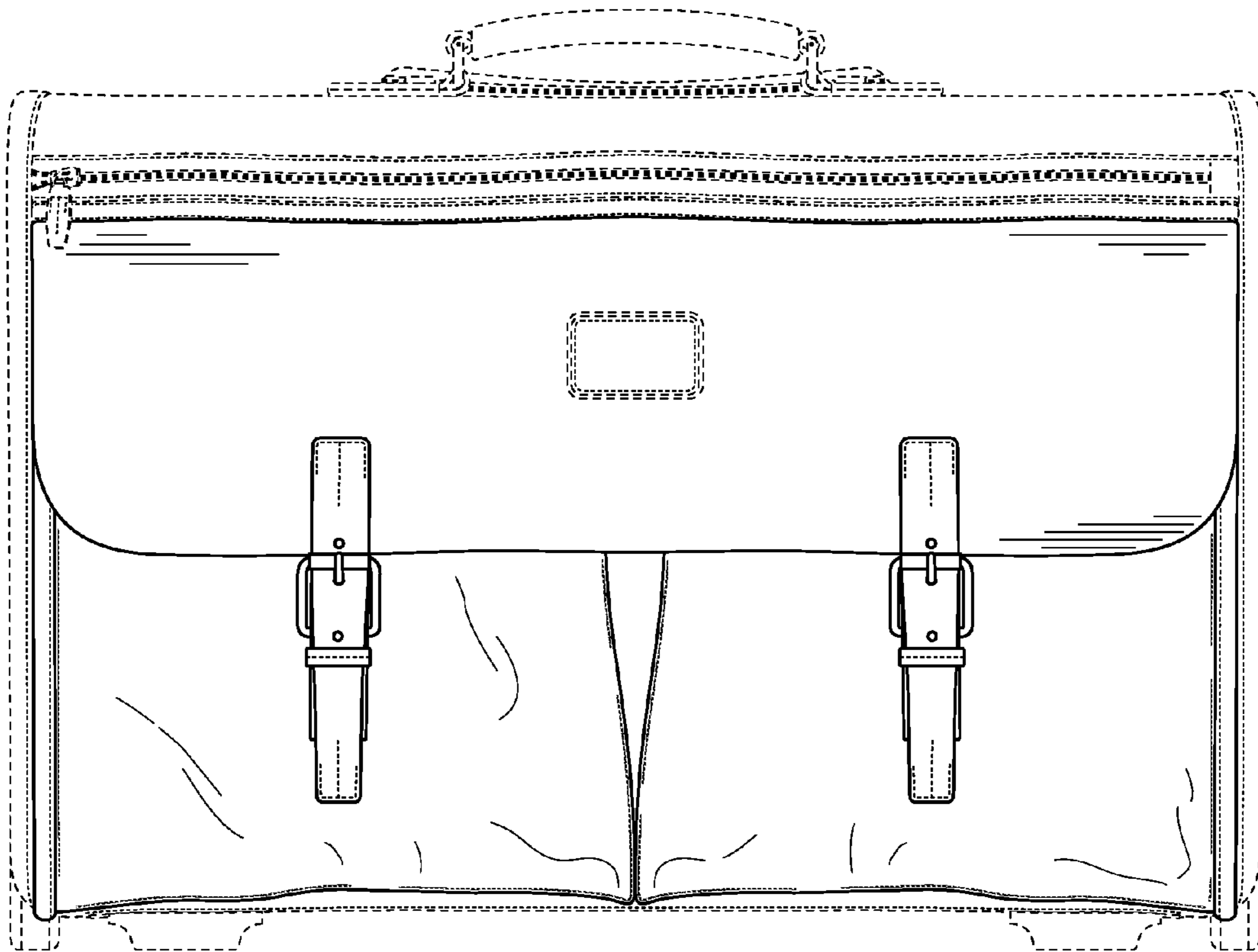

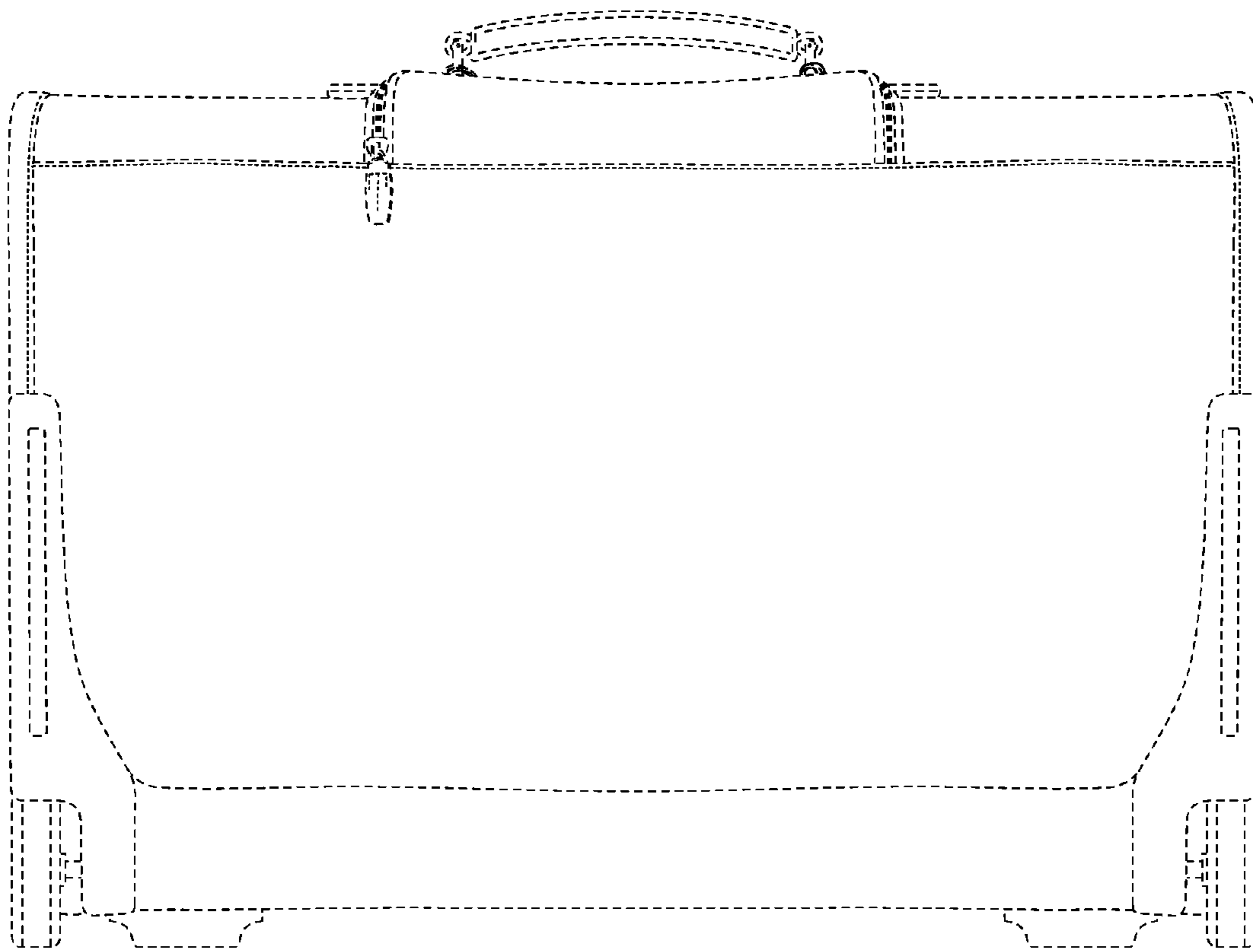

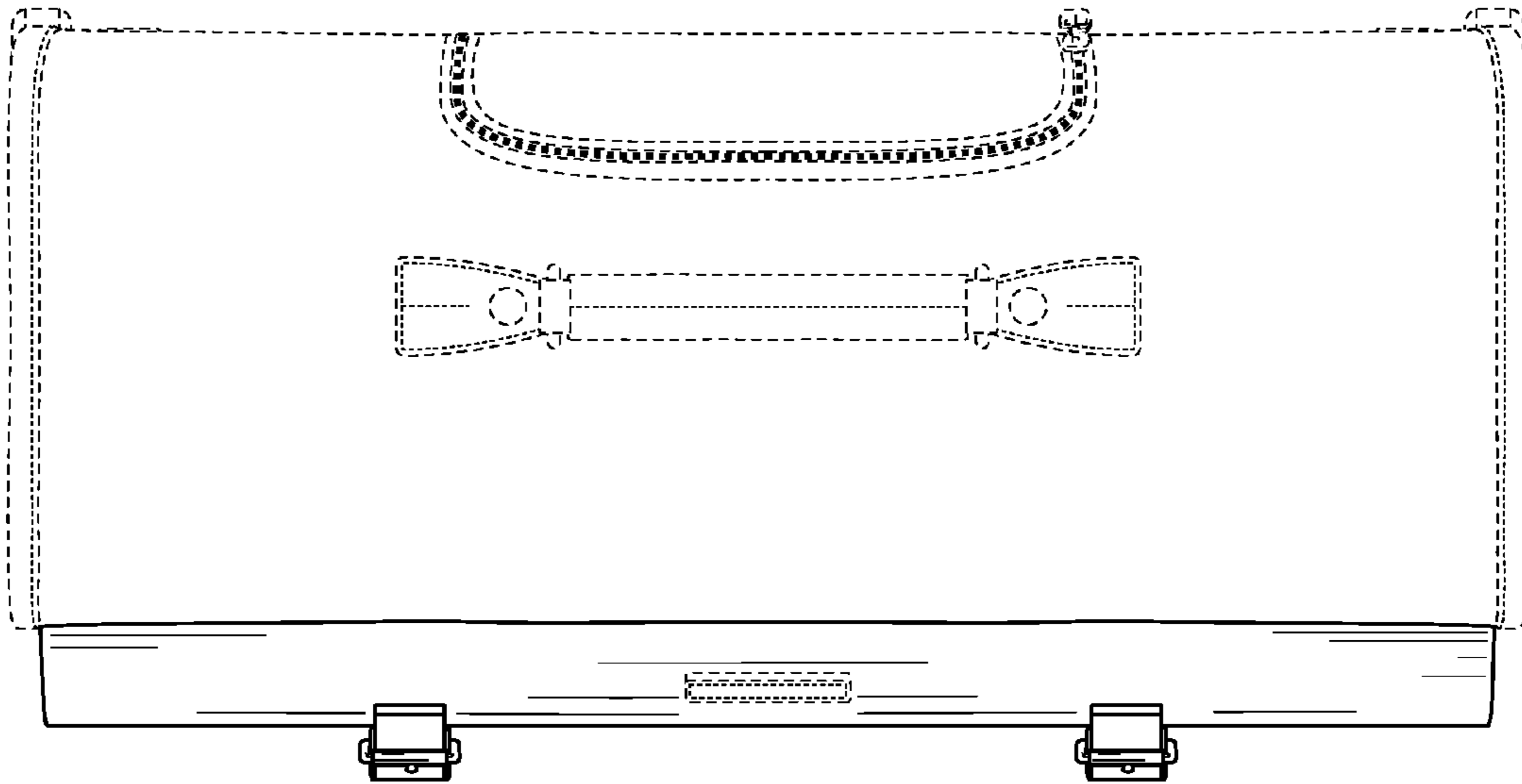

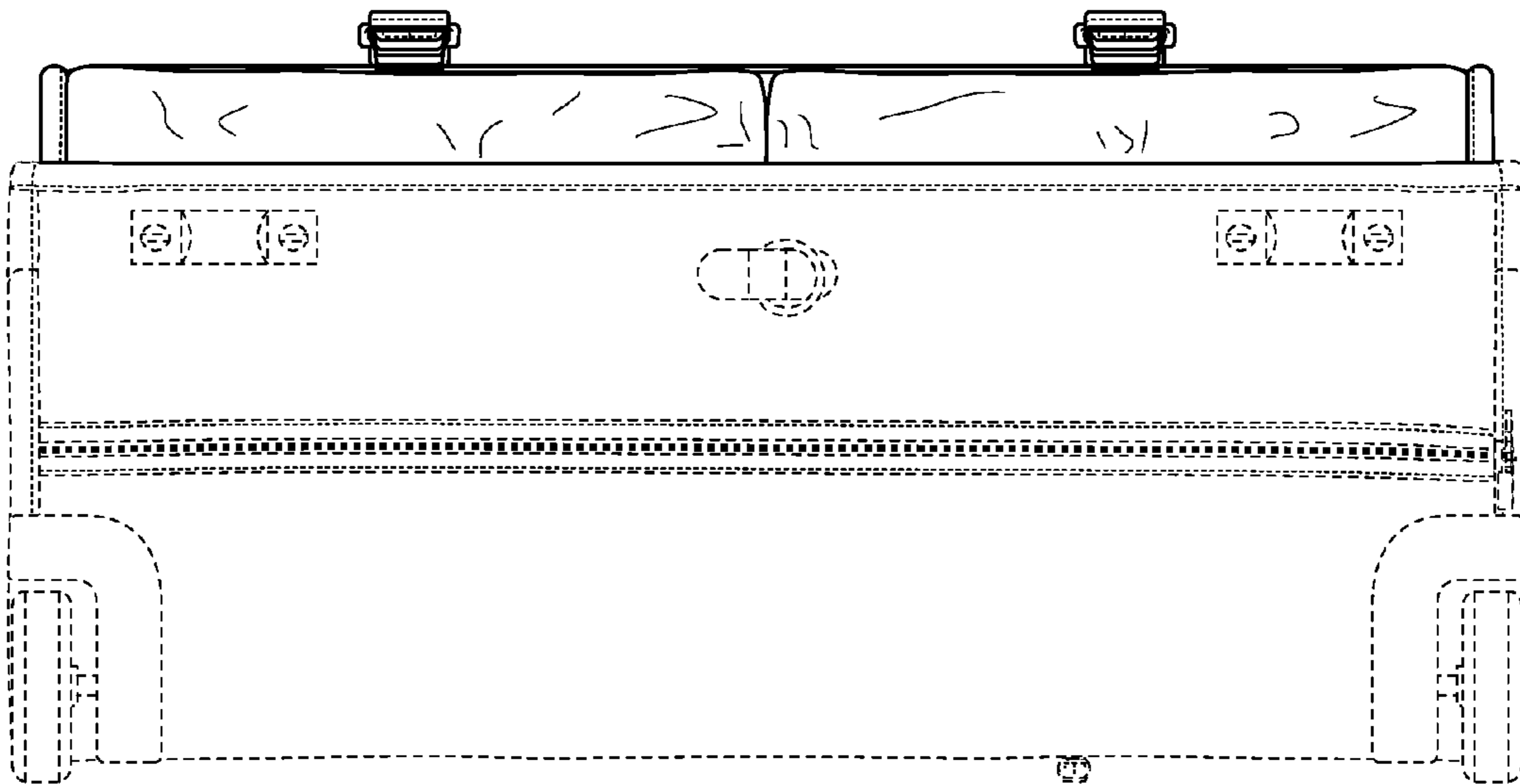
