(57) **CLAIM**

The ornamental design for a pillow with cross straps, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective top view of a pillow with cross straps according to the invention.

FIG. 2 is a top view of a pillow with cross straps according to the invention.

FIG. 3 is a front view of a pillow with cross straps according to the invention.

FIG. 4 is a left side view with reference to FIG. 3 of a pillow with cross straps according to the invention.

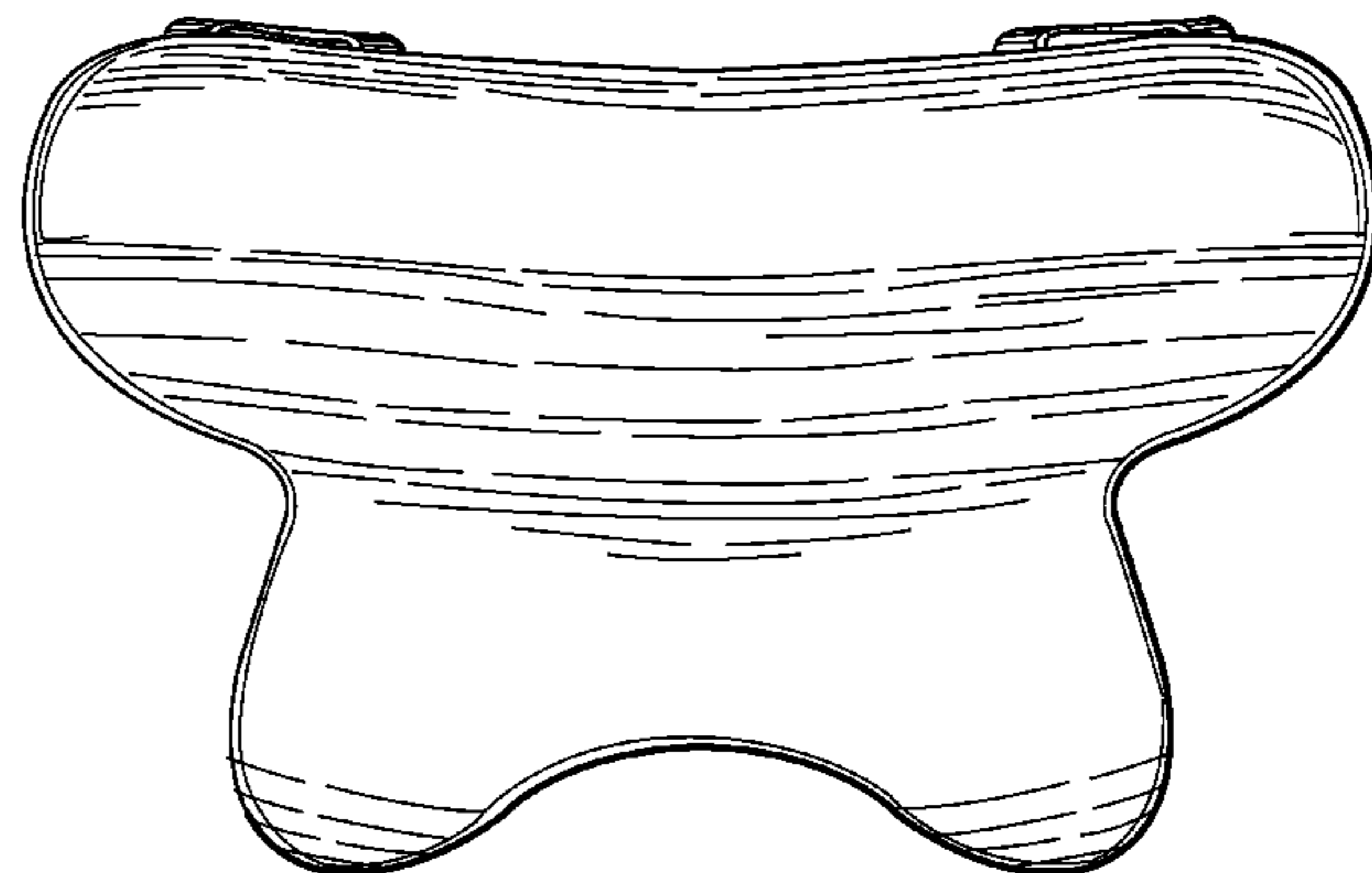
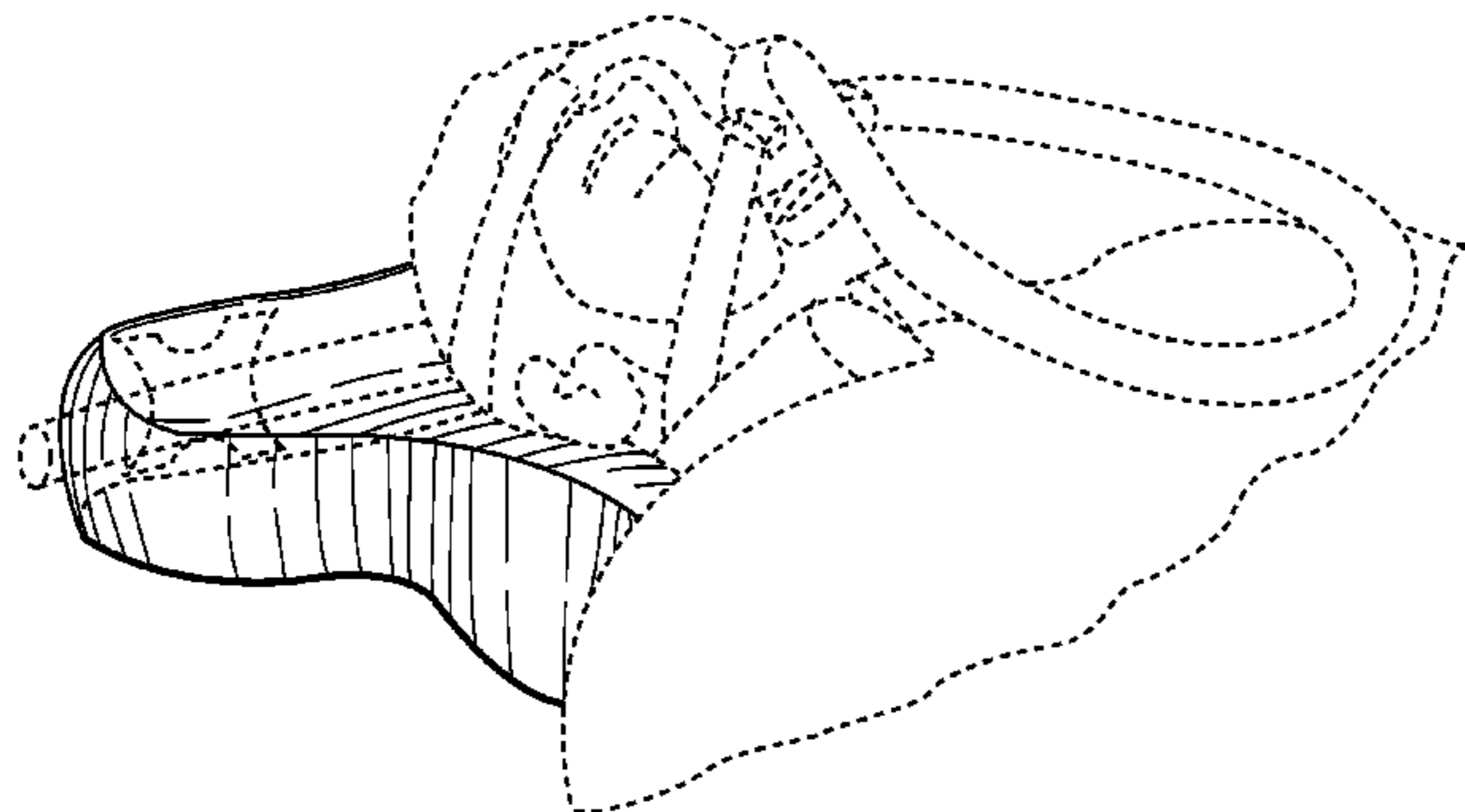
FIG. 5 is a rear view of a pillow with cross straps according to the invention.

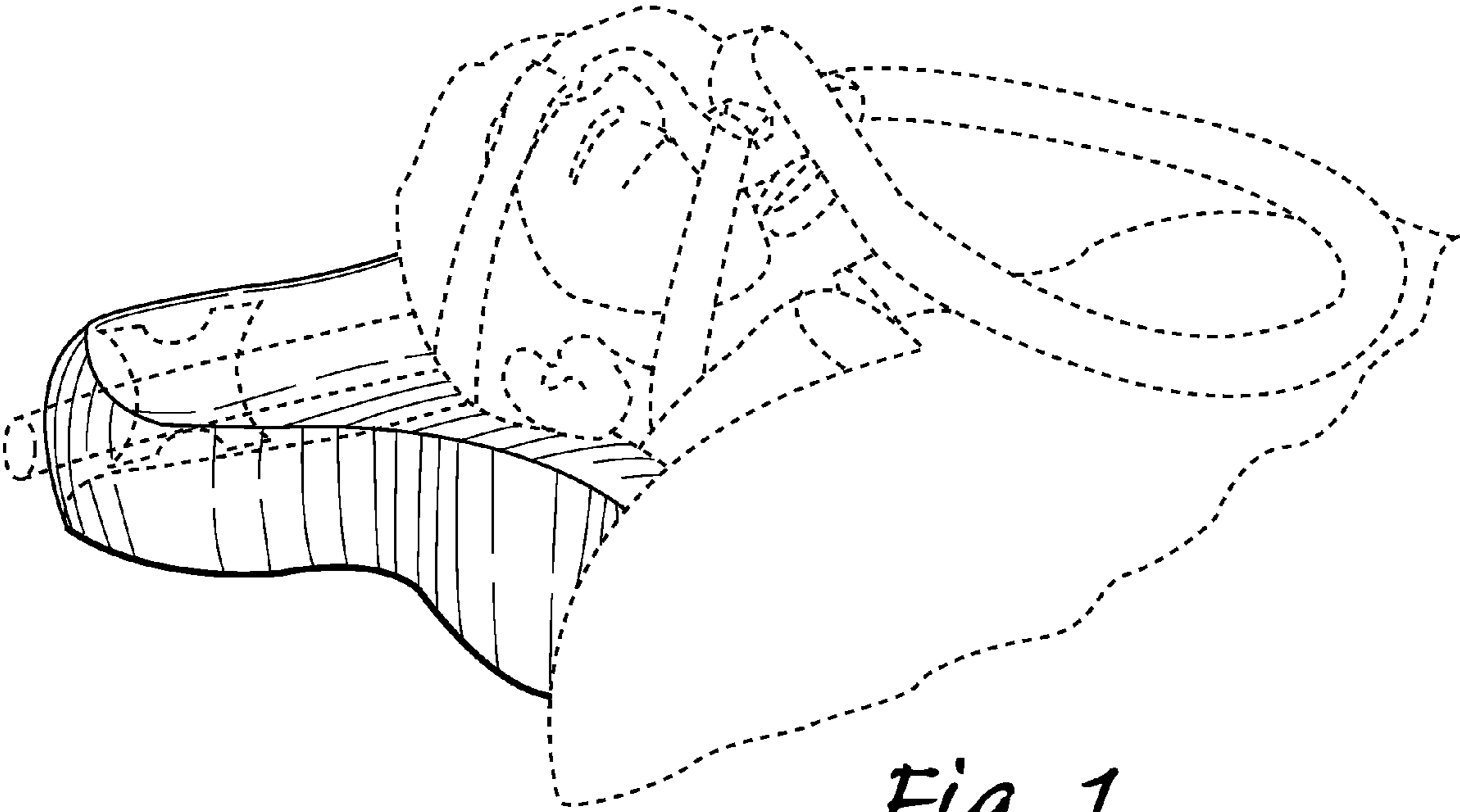
FIG. 6 is a right side view with reference to FIG. 3 of a pillow with cross straps according to the invention; and,

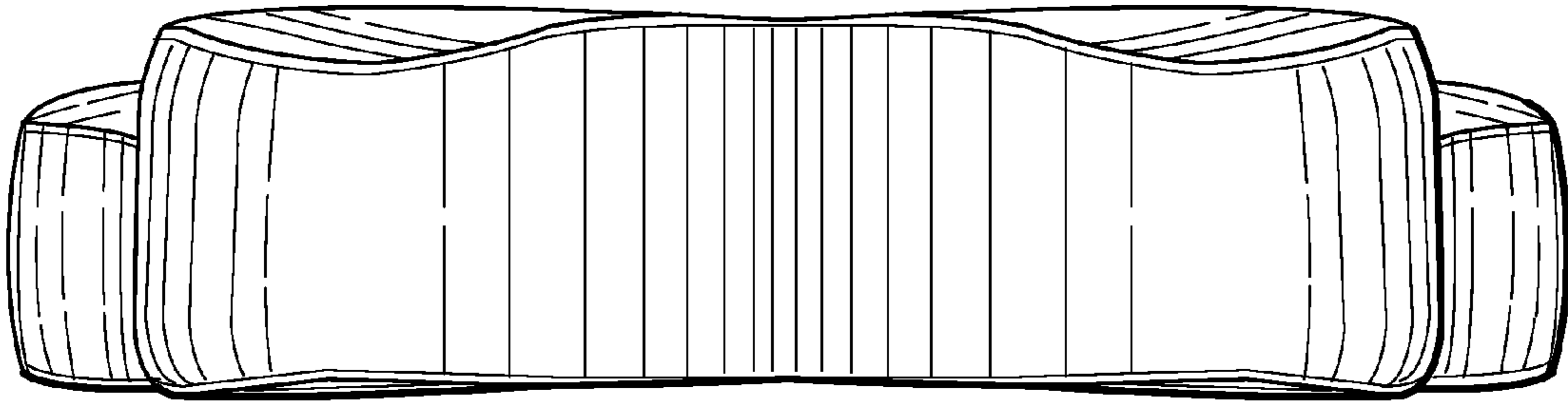




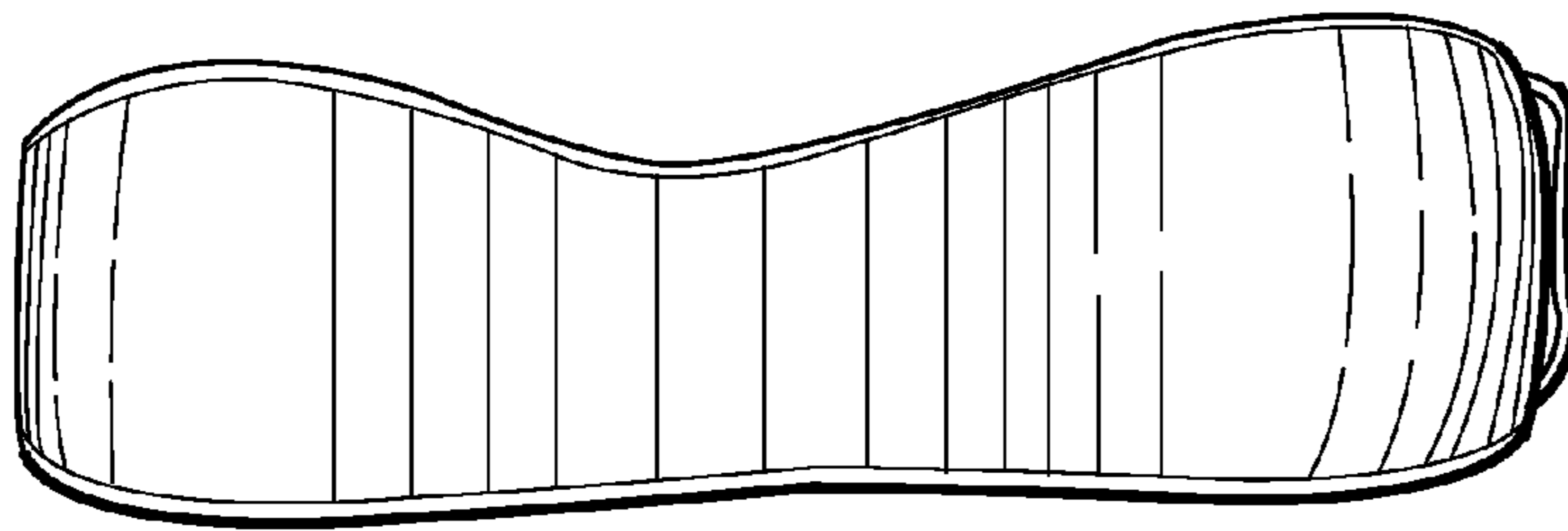

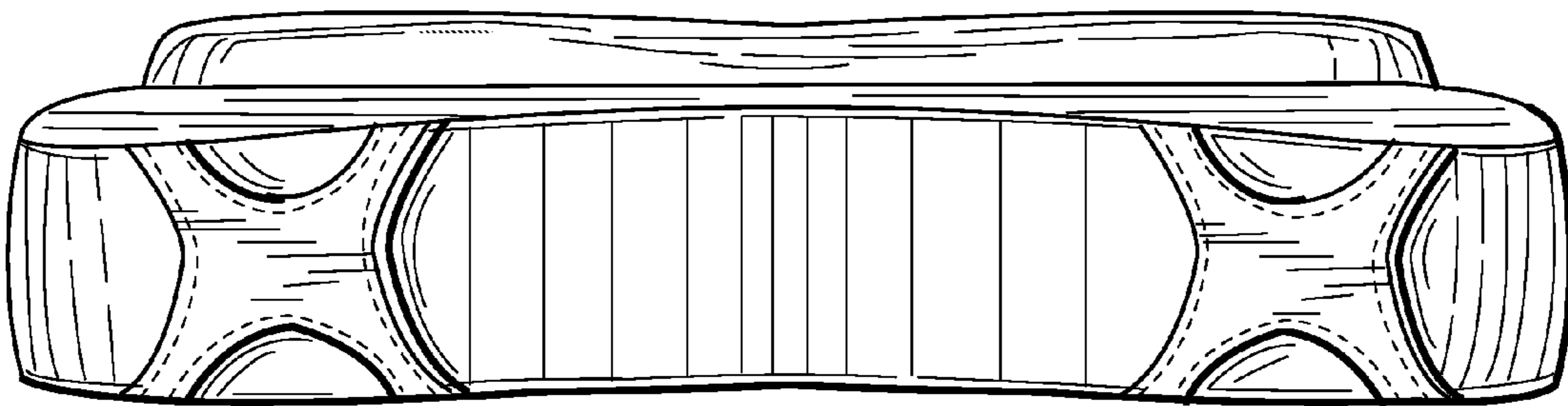

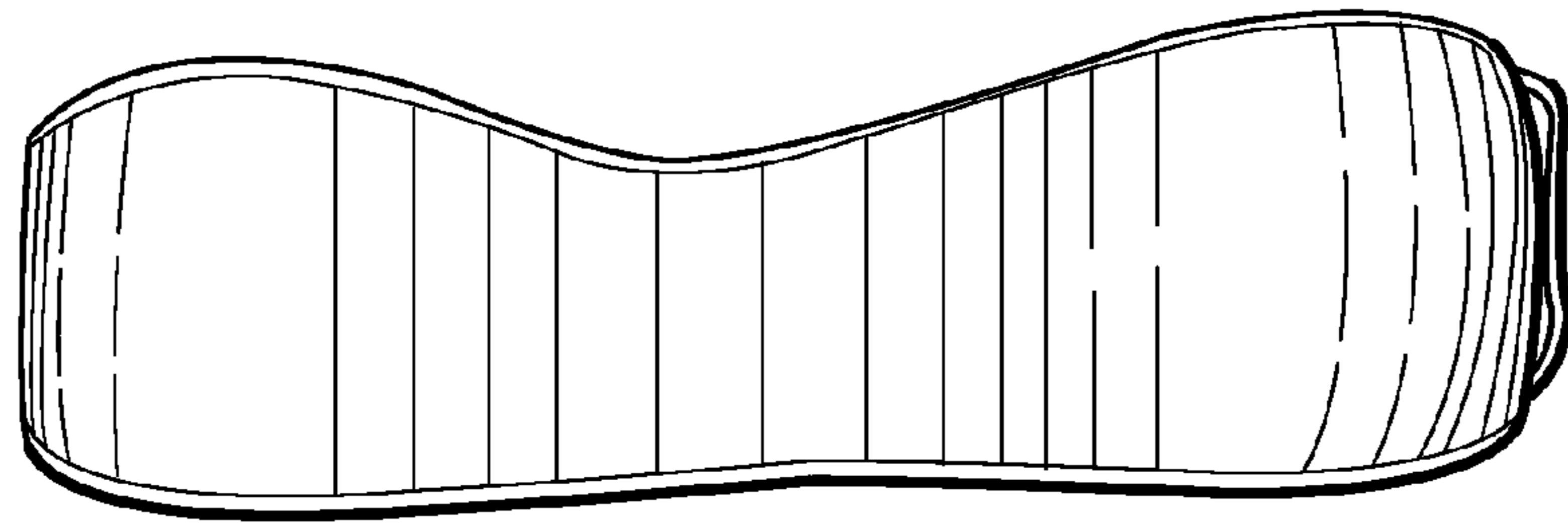

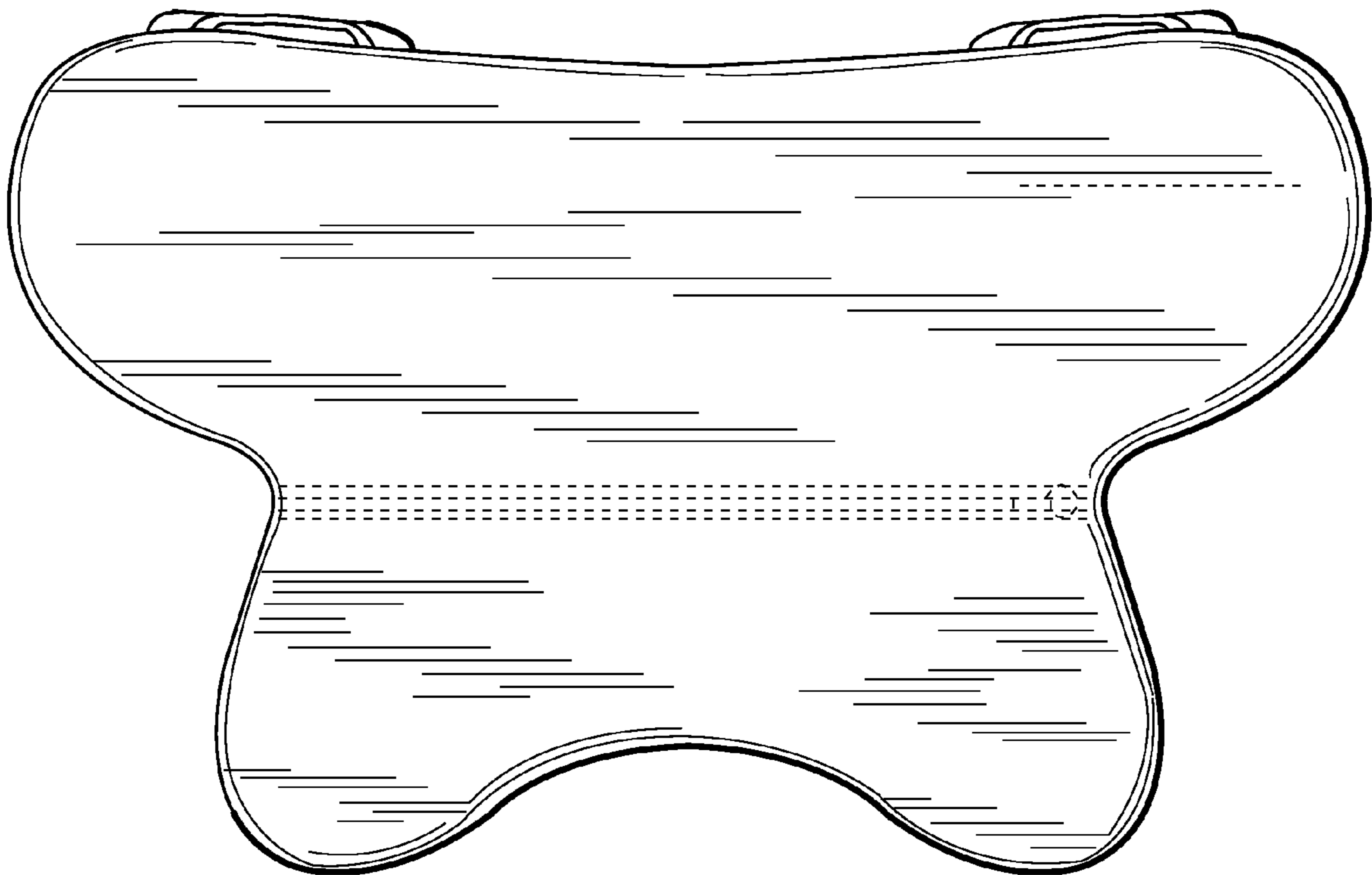
