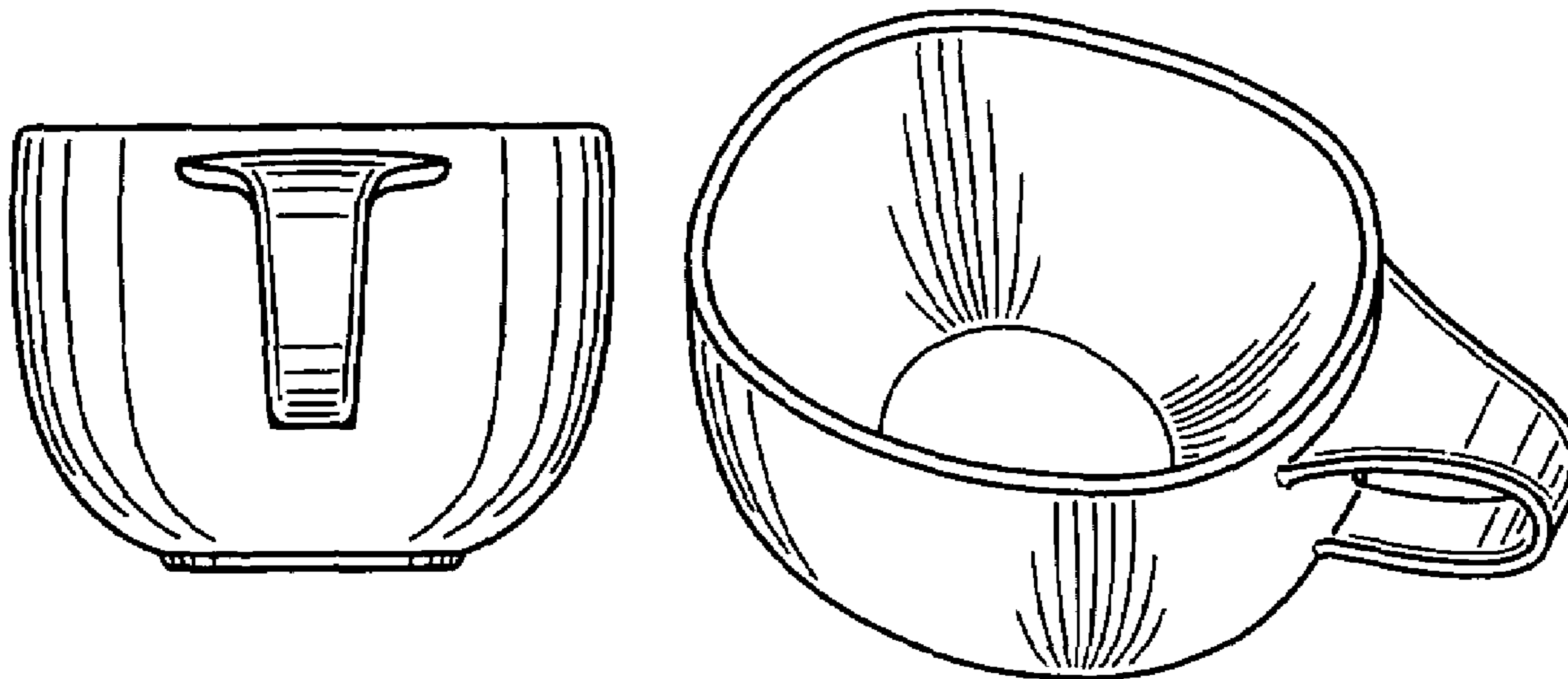
The ornamental design for a cup, as shown and described.

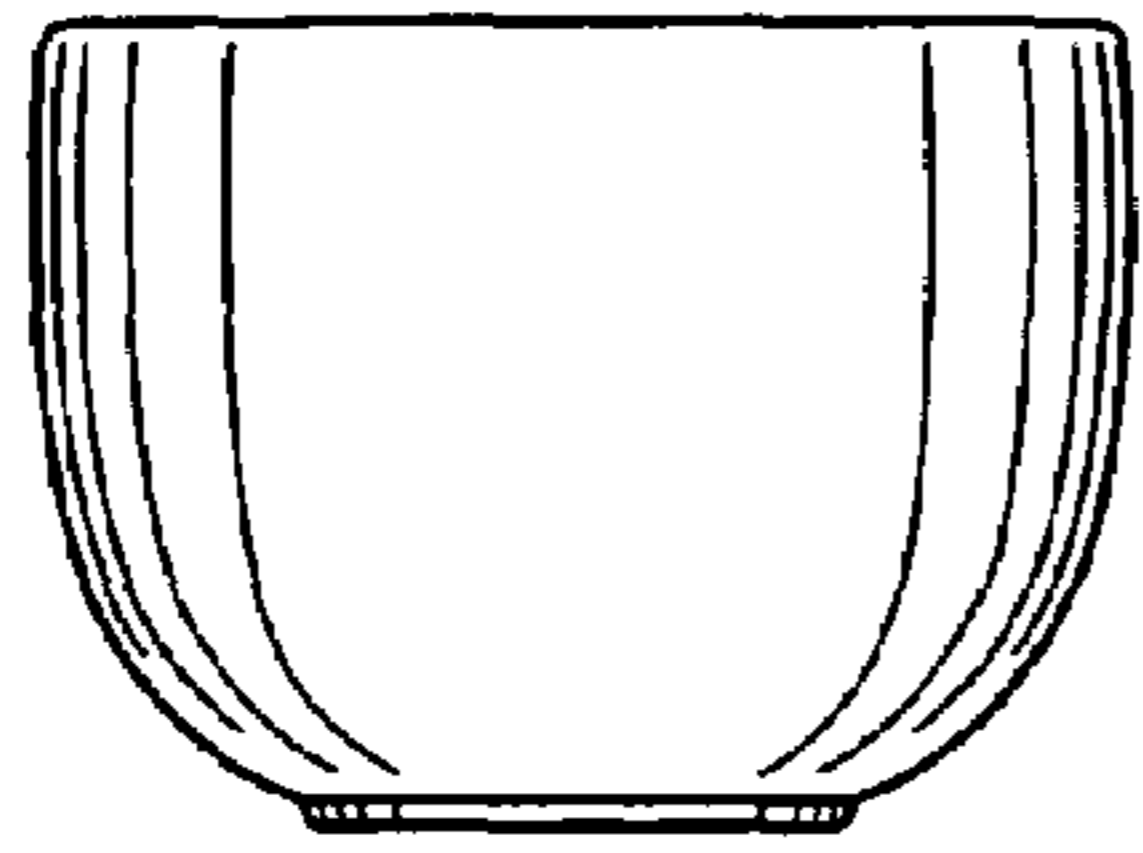
**DESCRIPTION**

FIG. 7 is a top view thereof.

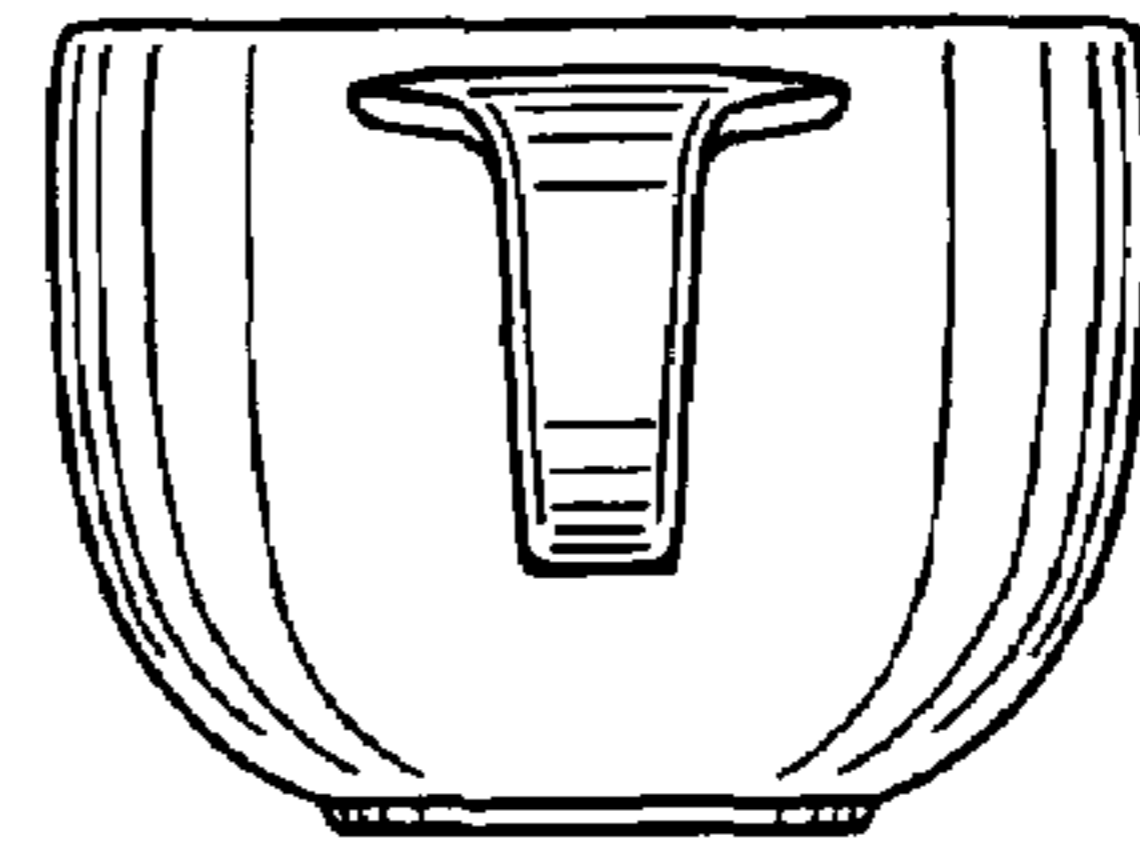

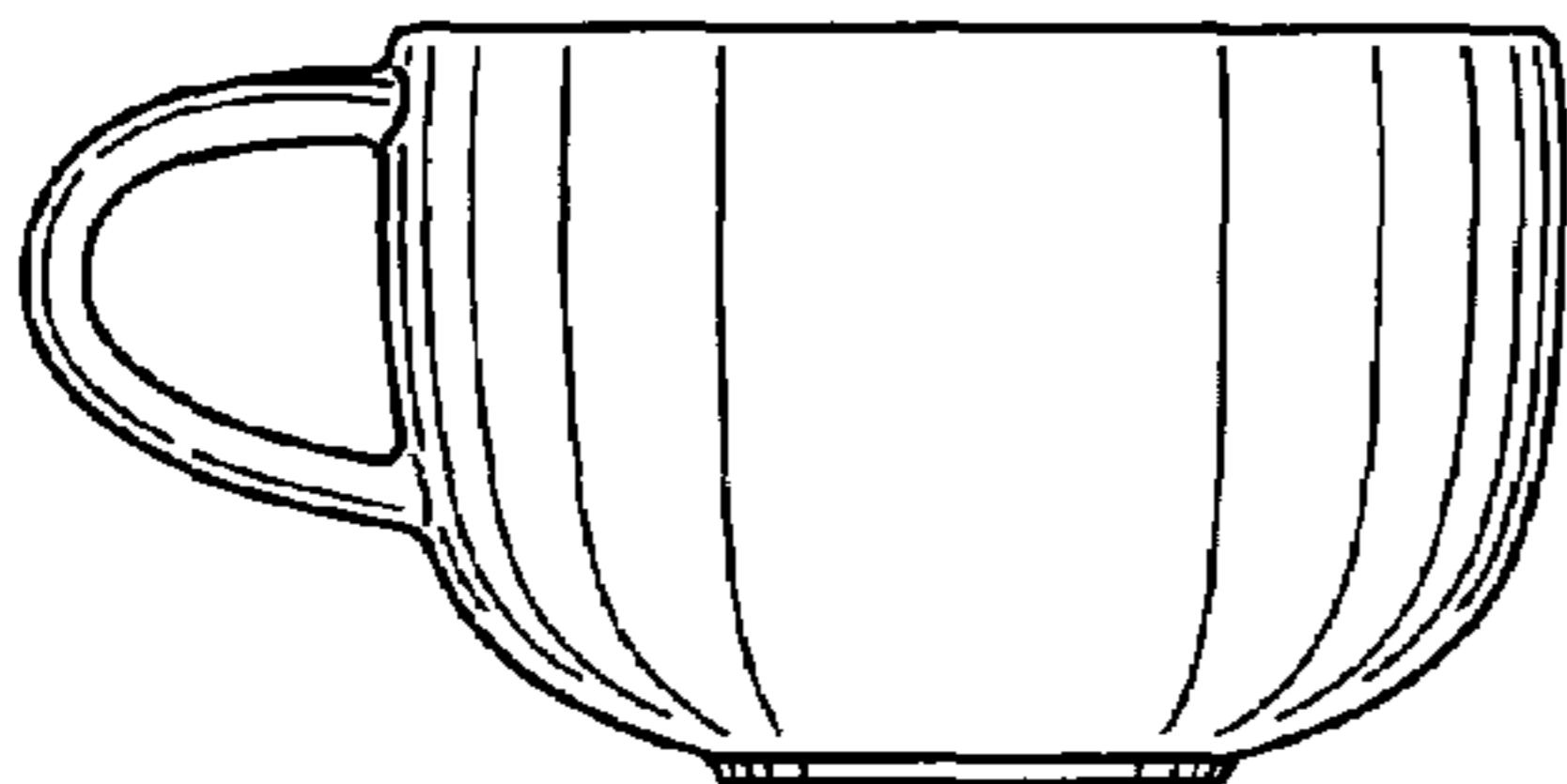




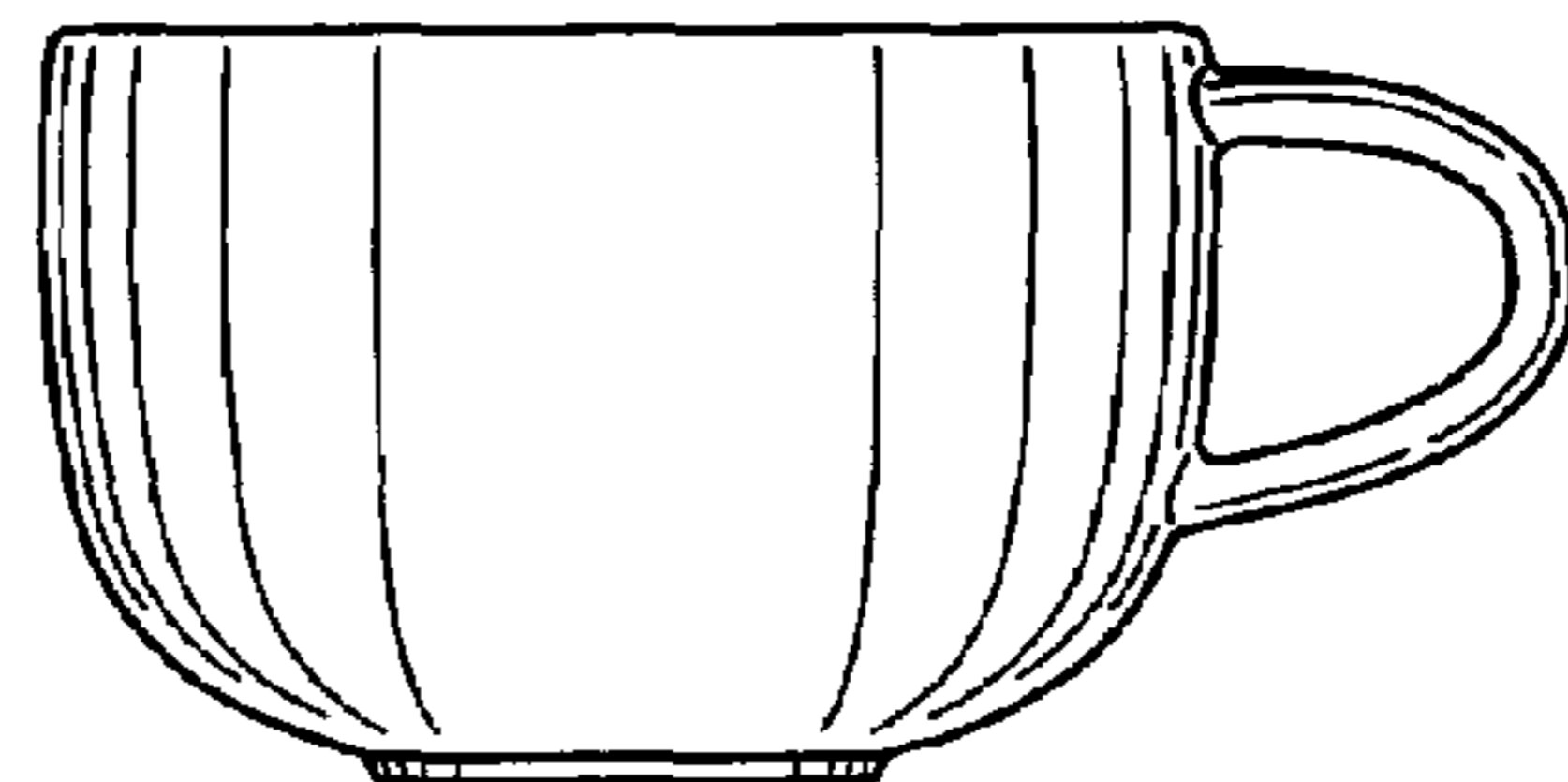

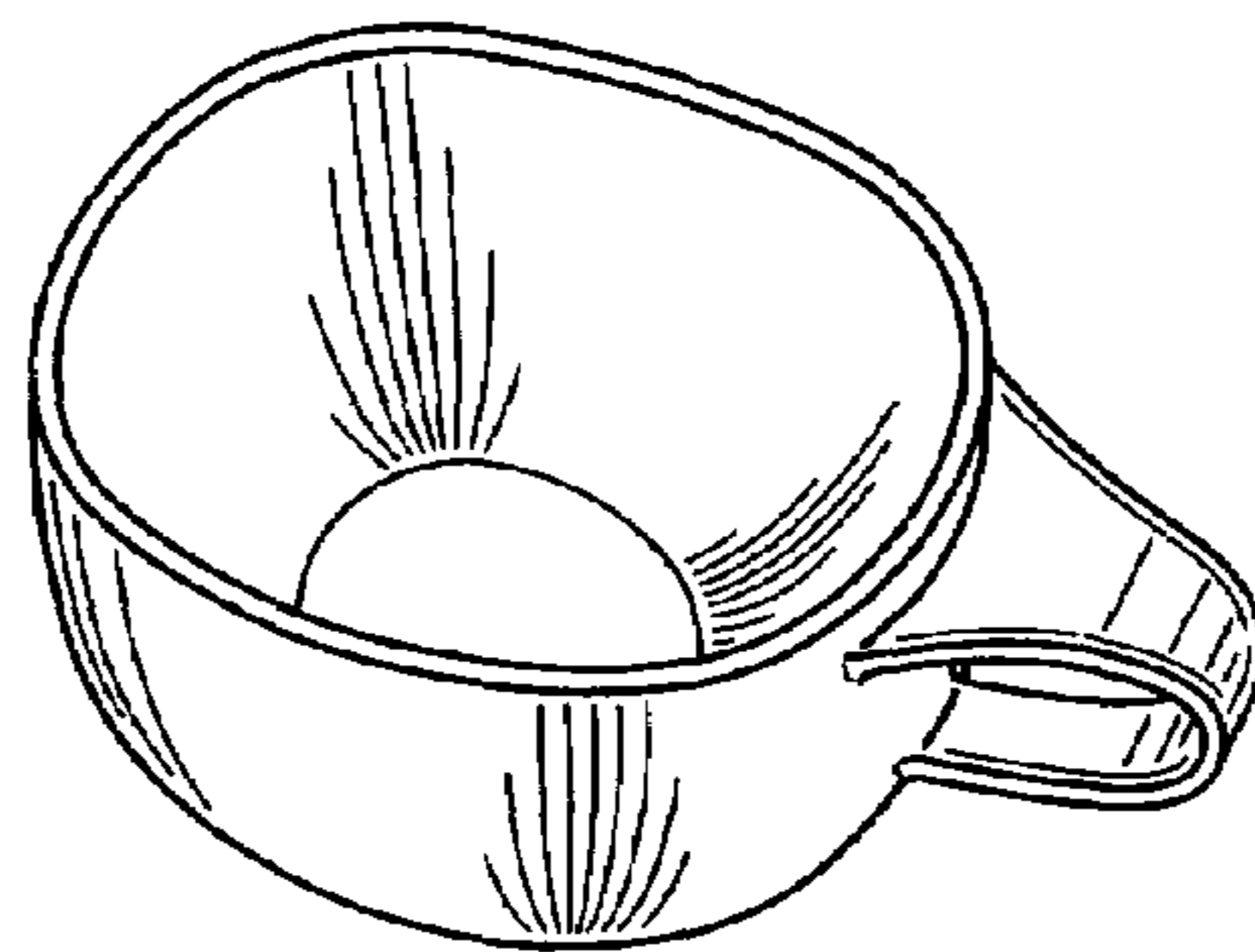

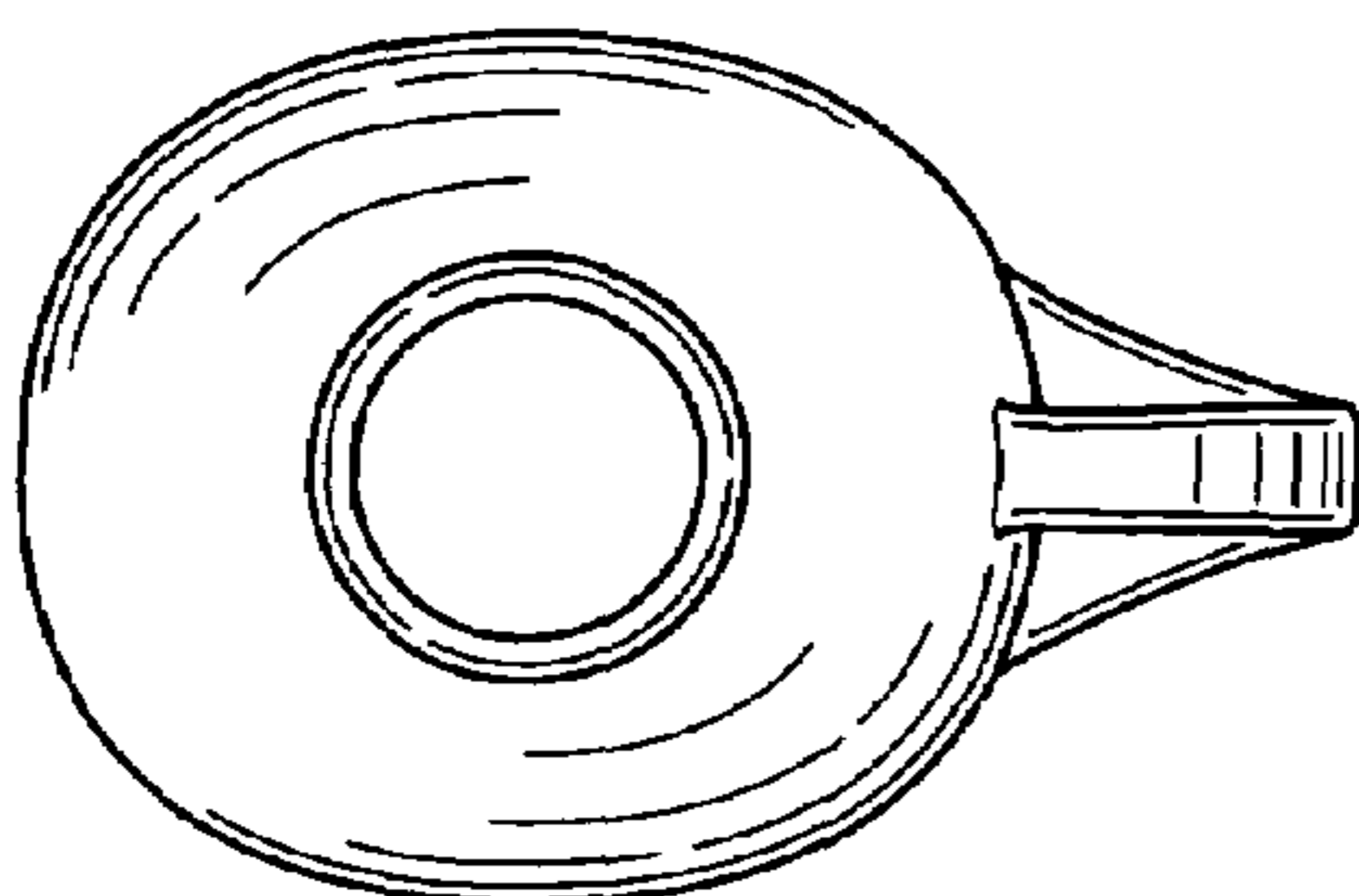

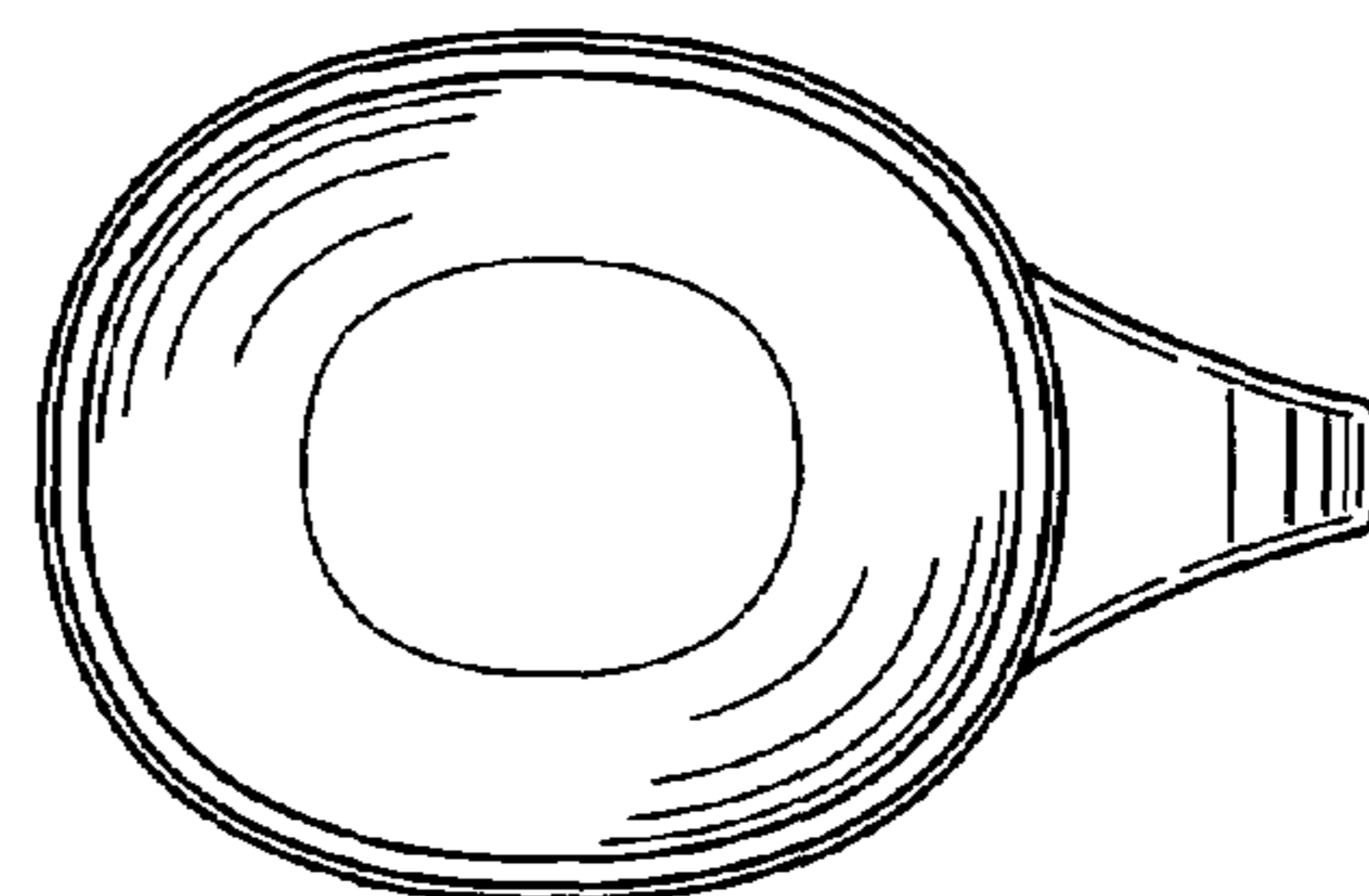
