**DESCRIPTION**

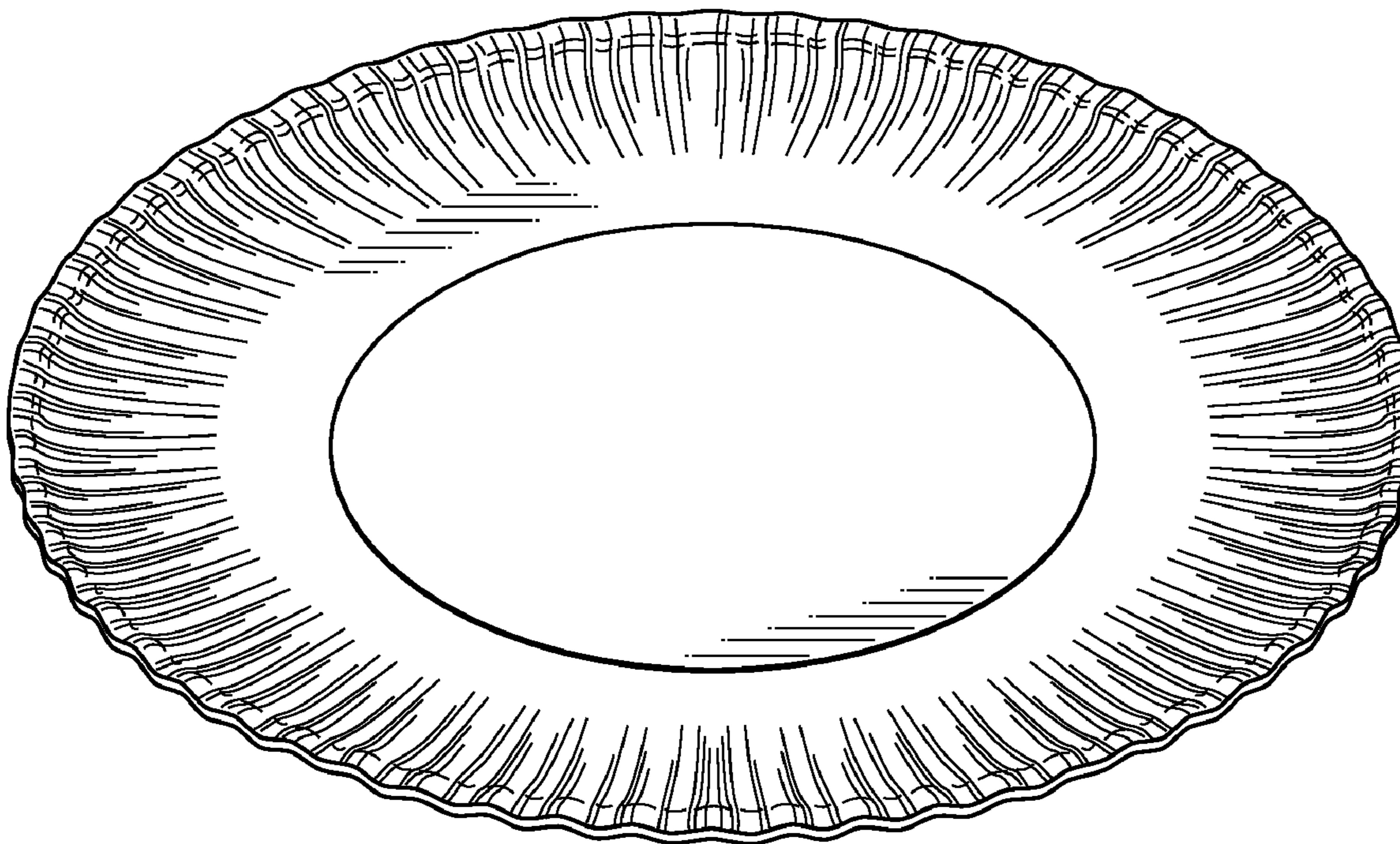
FIG. 1 is a perspective of the re-usable rigid dinner plate of my new design;

FIG. 2 is a top plan view thereof;

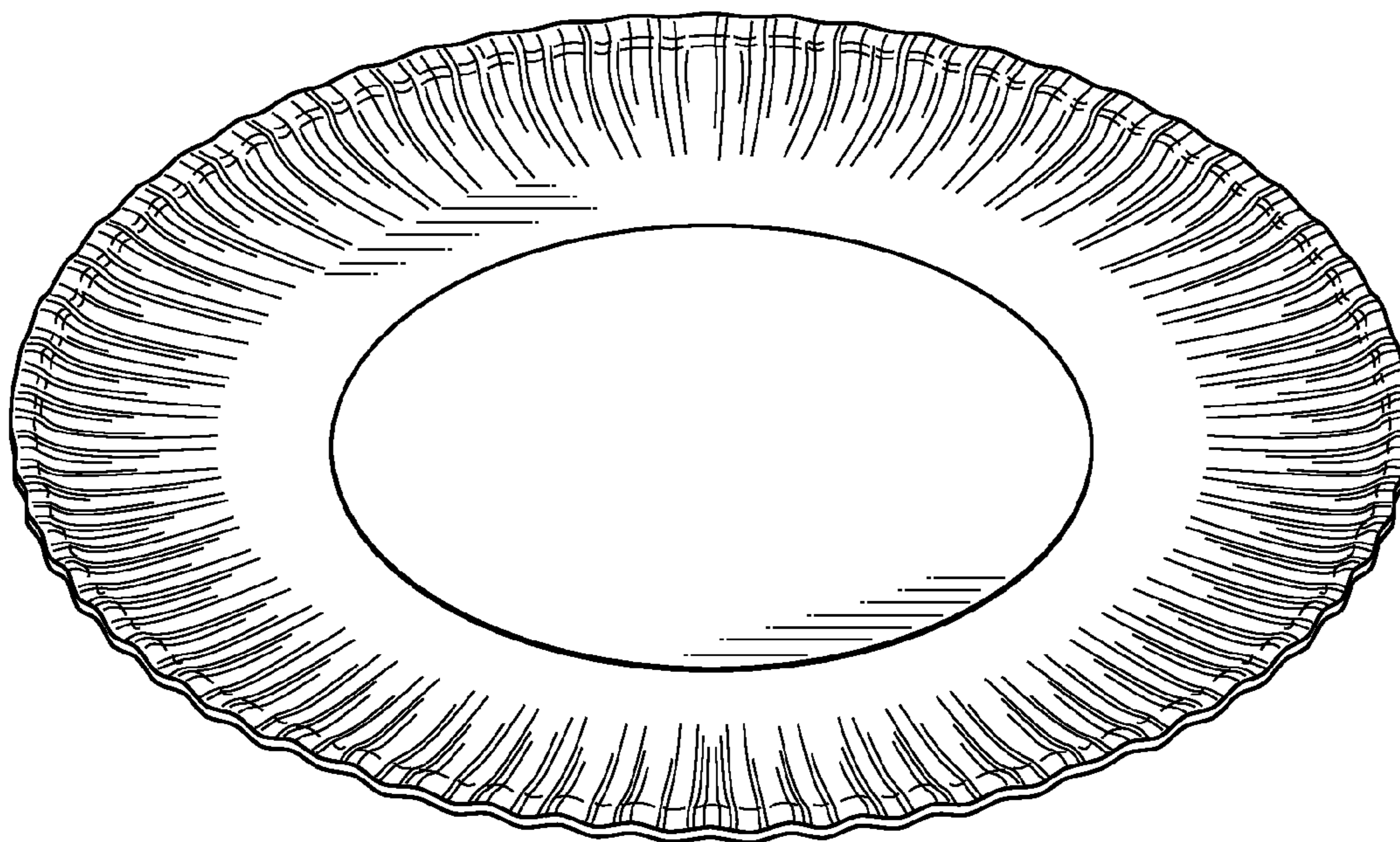
FIG. 3 is a bottom plan view thereof; and,

FIG. 4 is a front view thereof, with rear, left-side, and right-side views being identical.

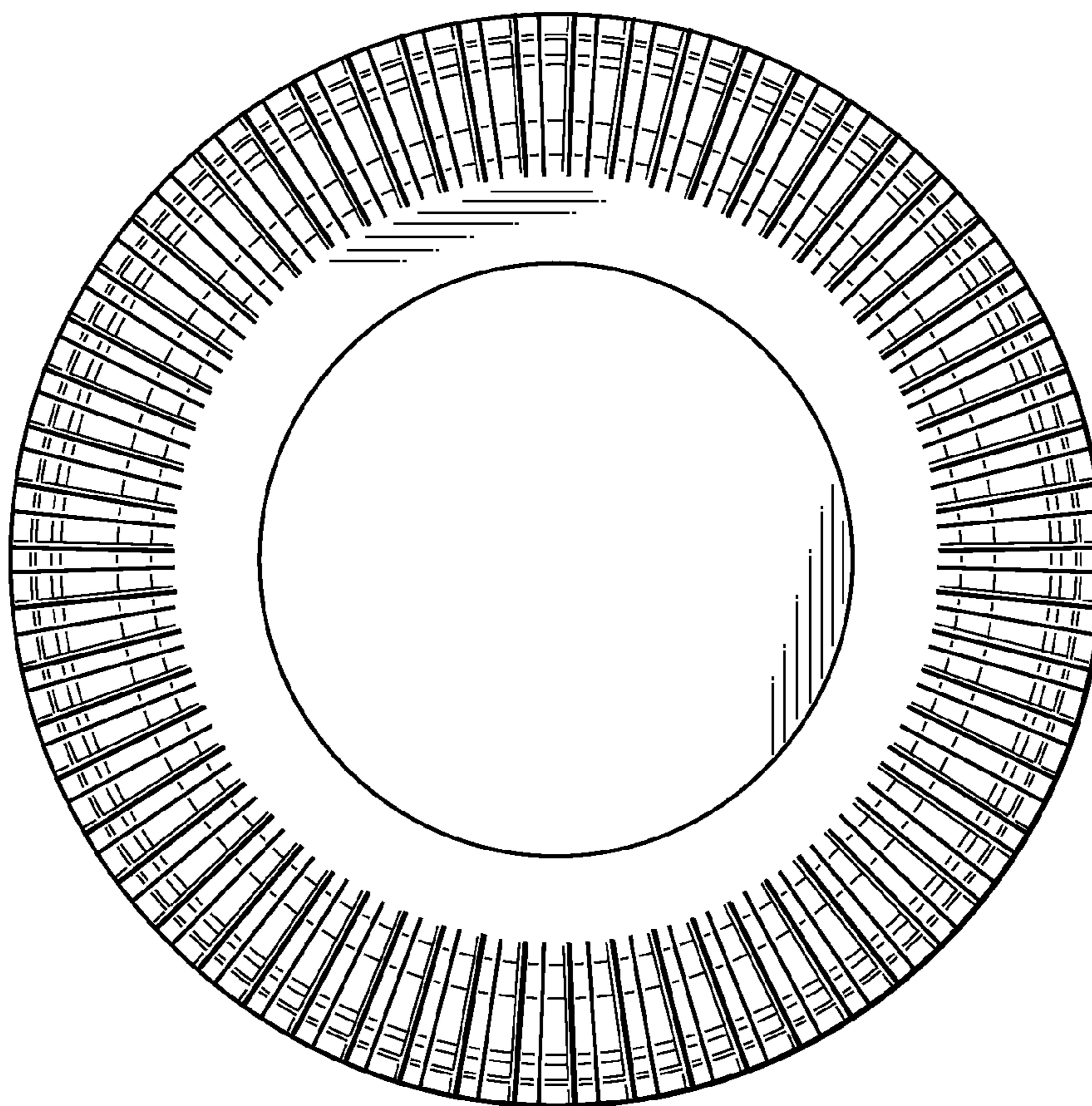

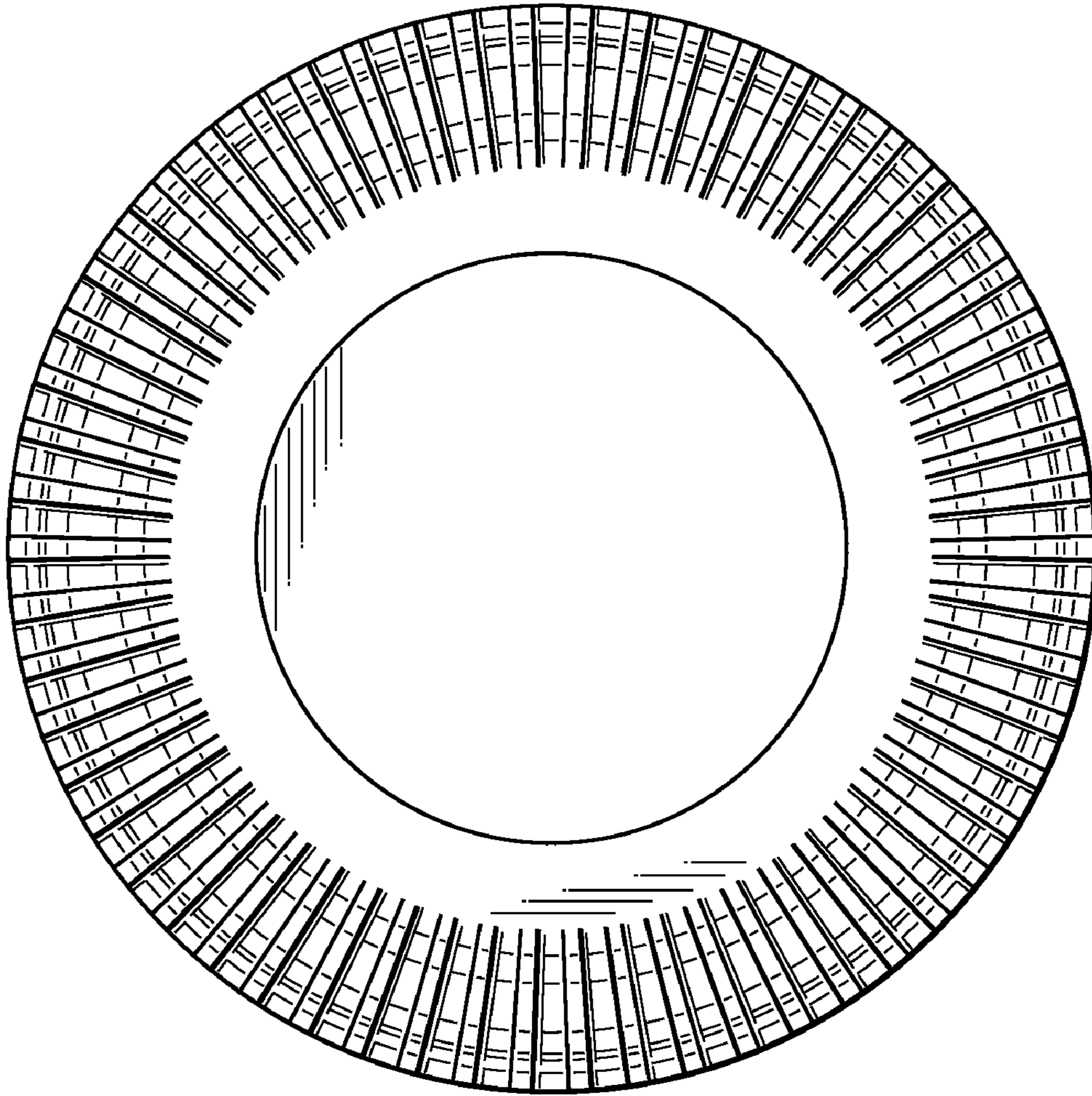
