FIG. 12 is a perspective view (IV) of the spanner in a position of use.

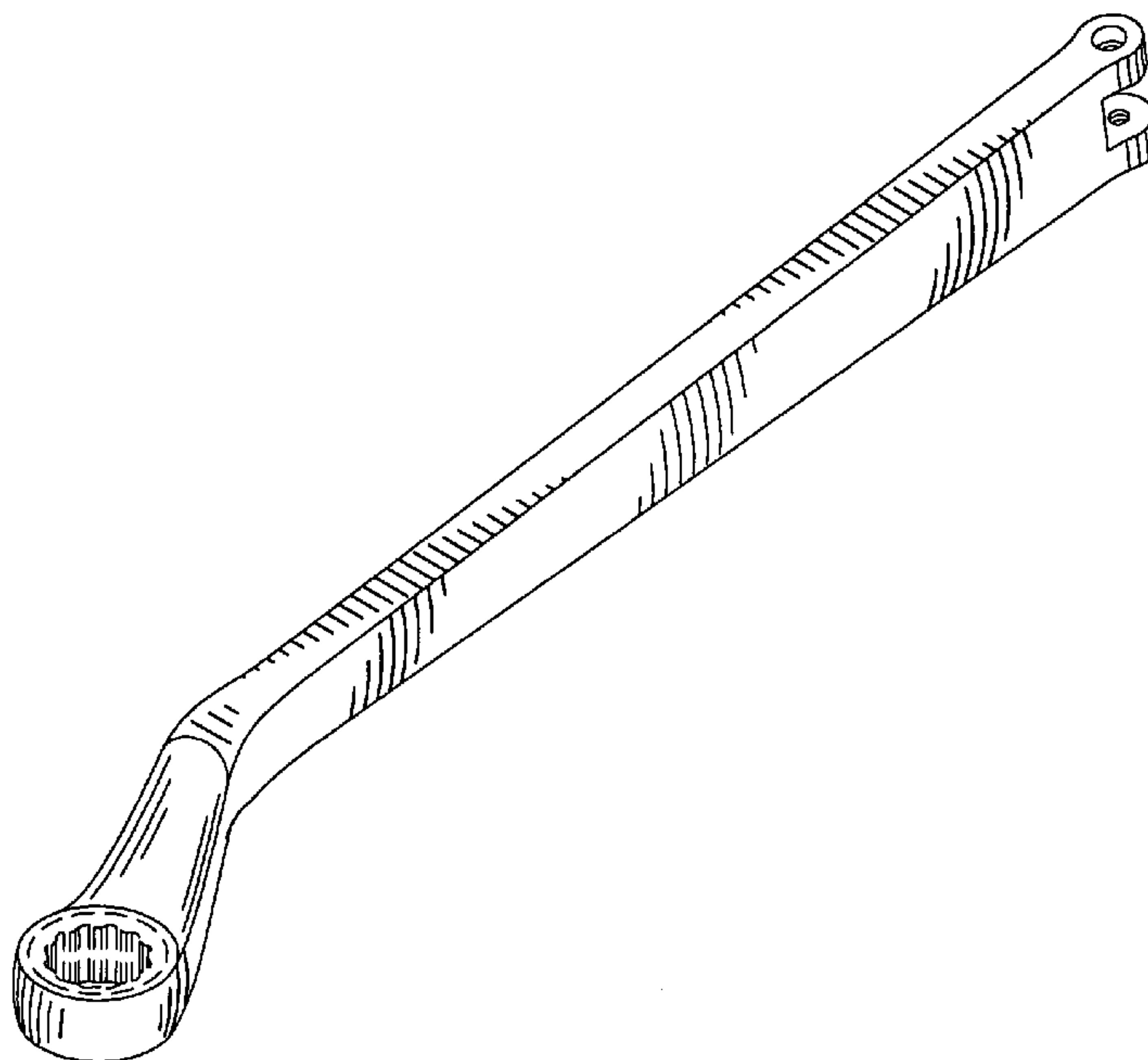
FIG. 13 is a front elevational view of FIG. 12.

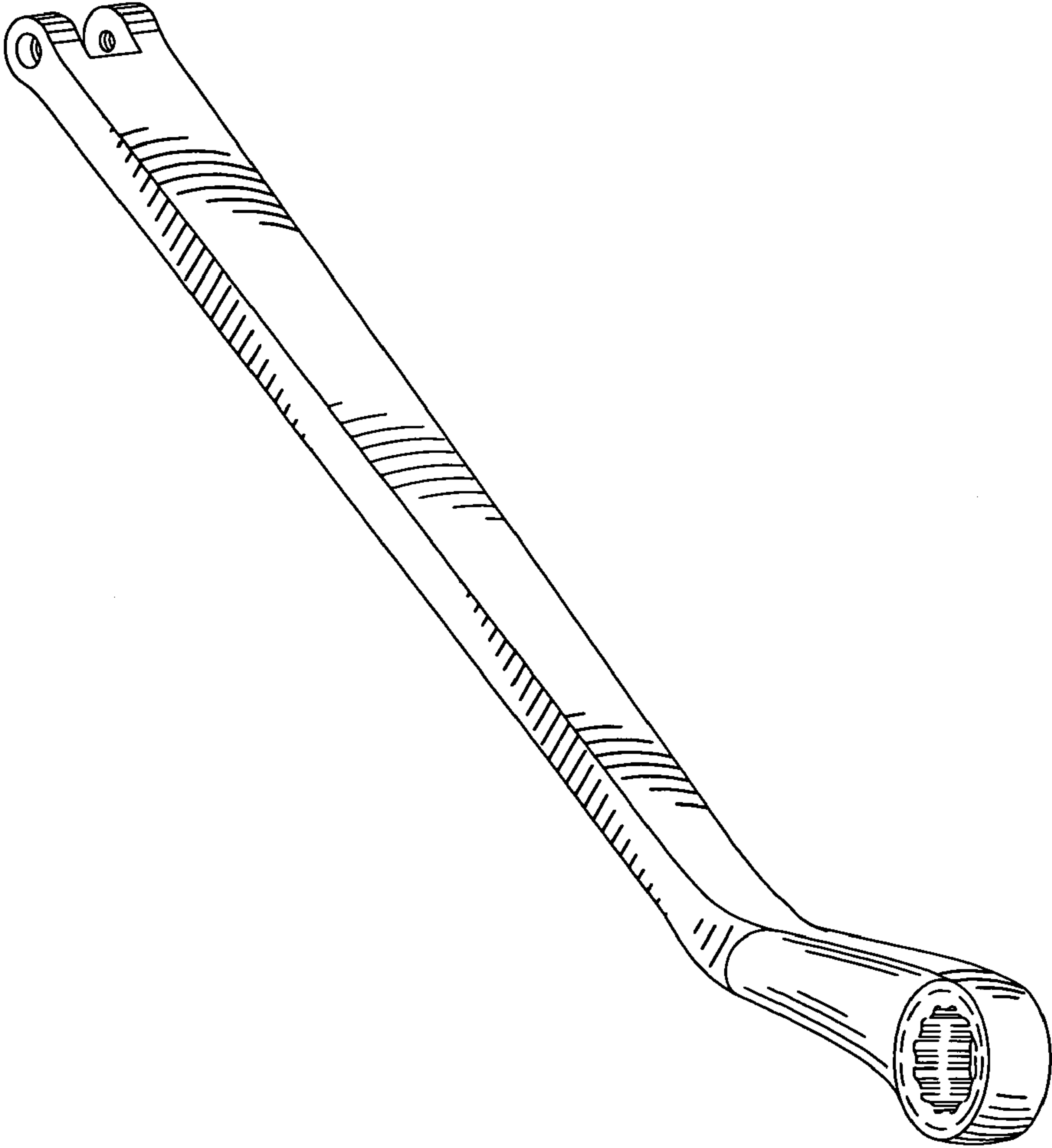

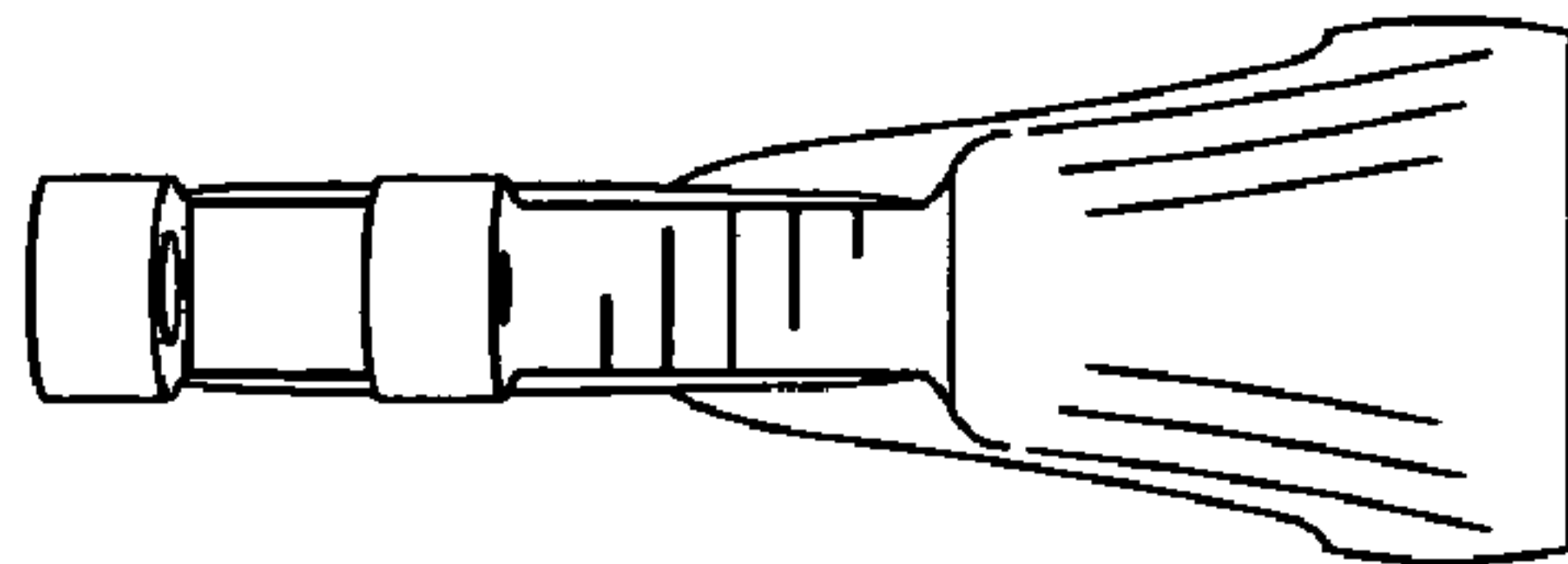

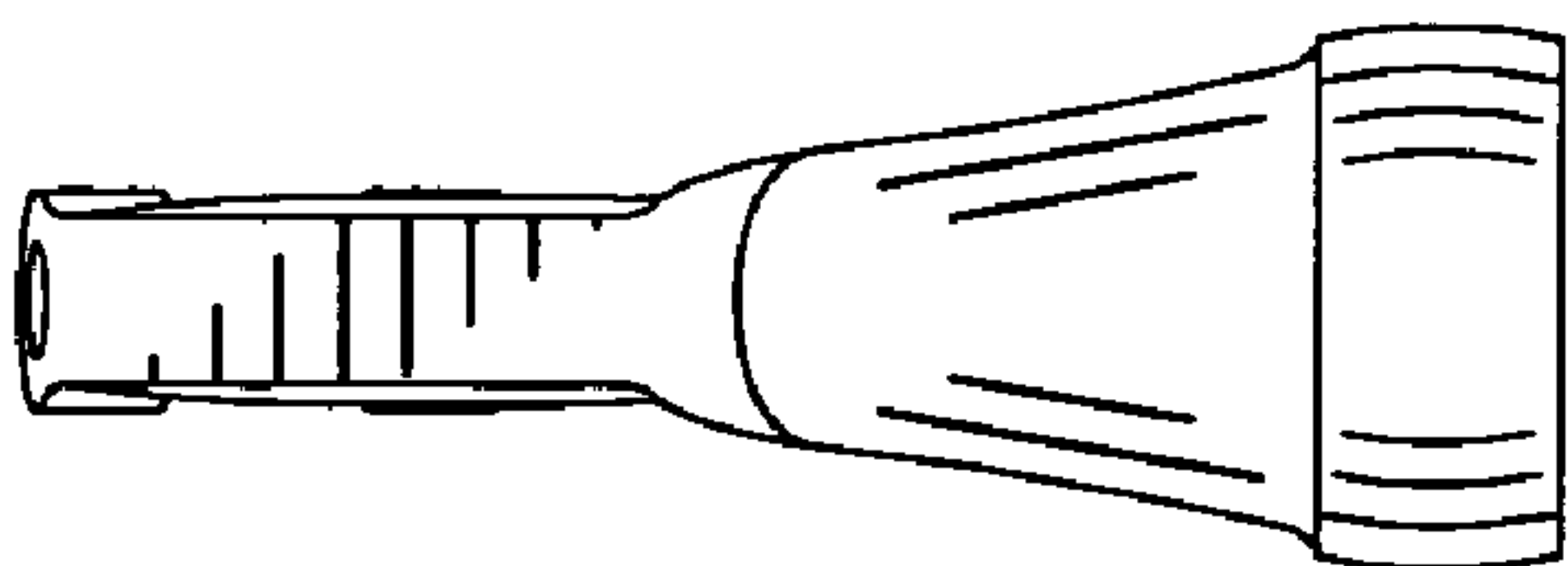

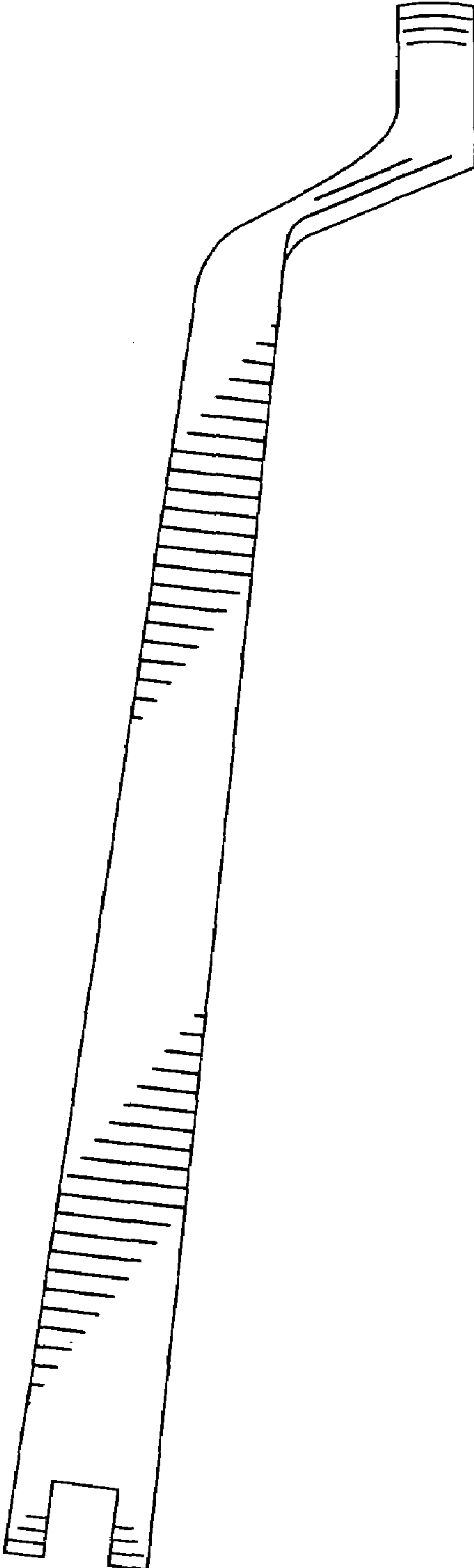

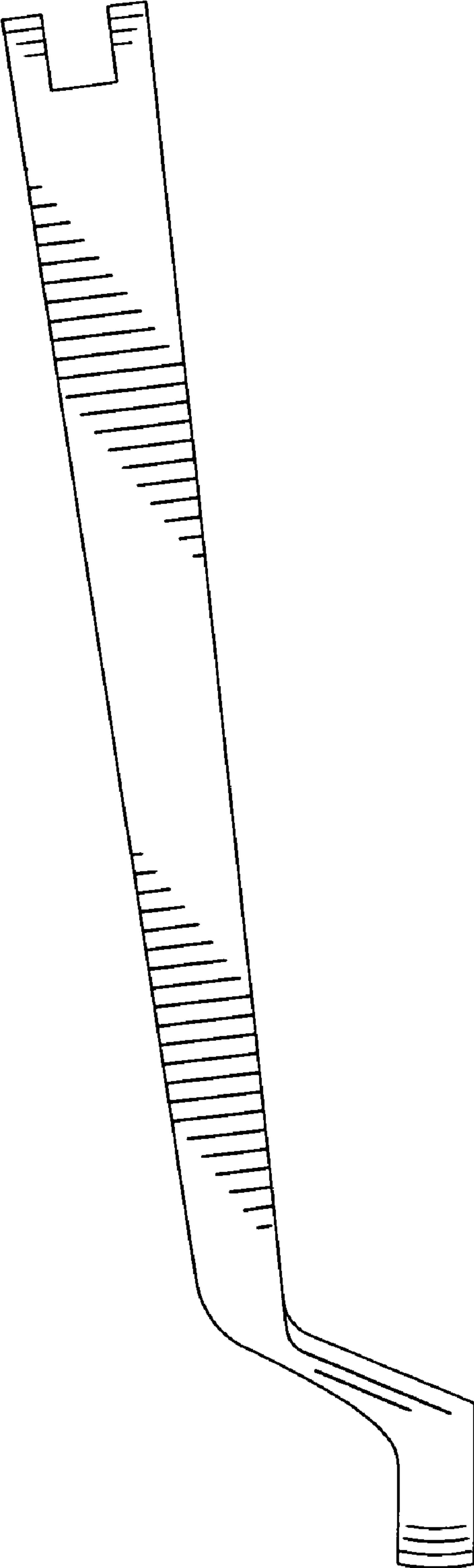

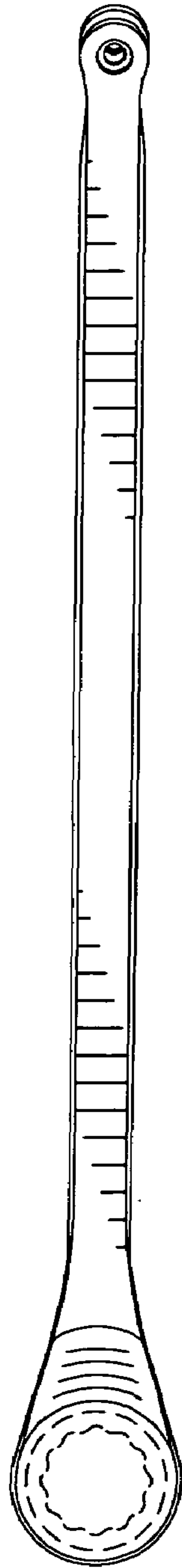

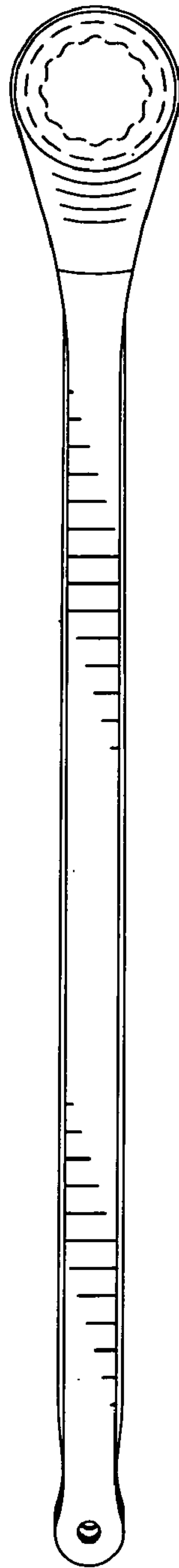

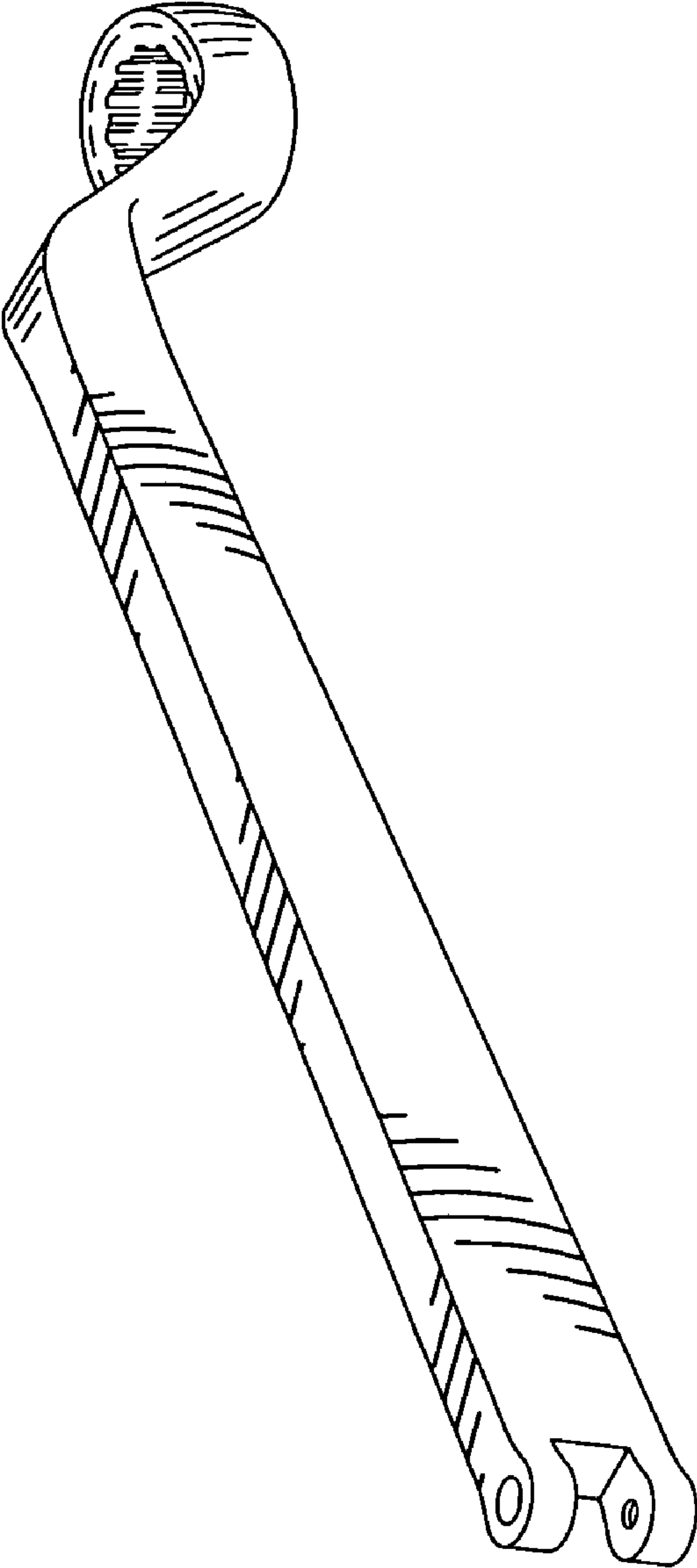

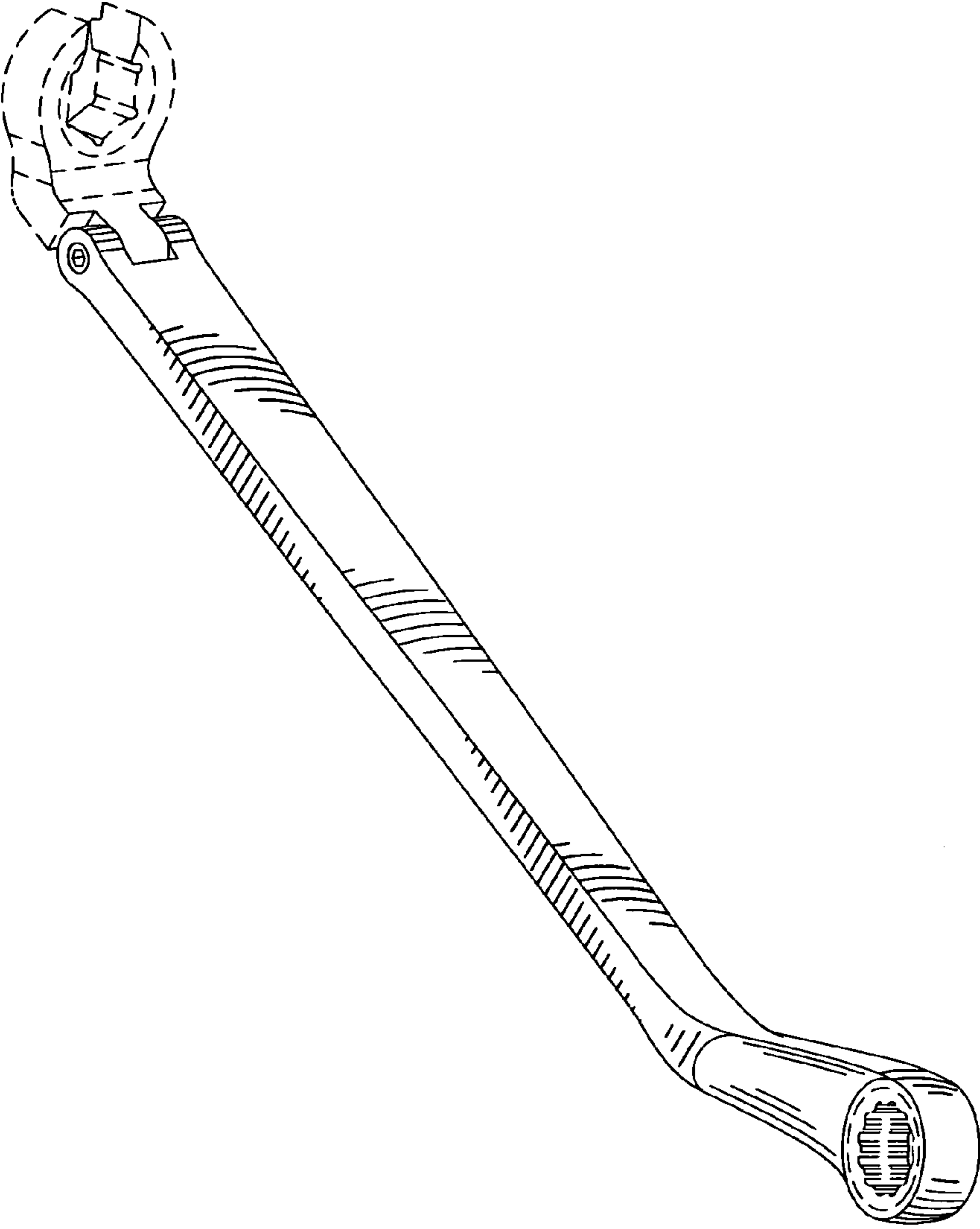

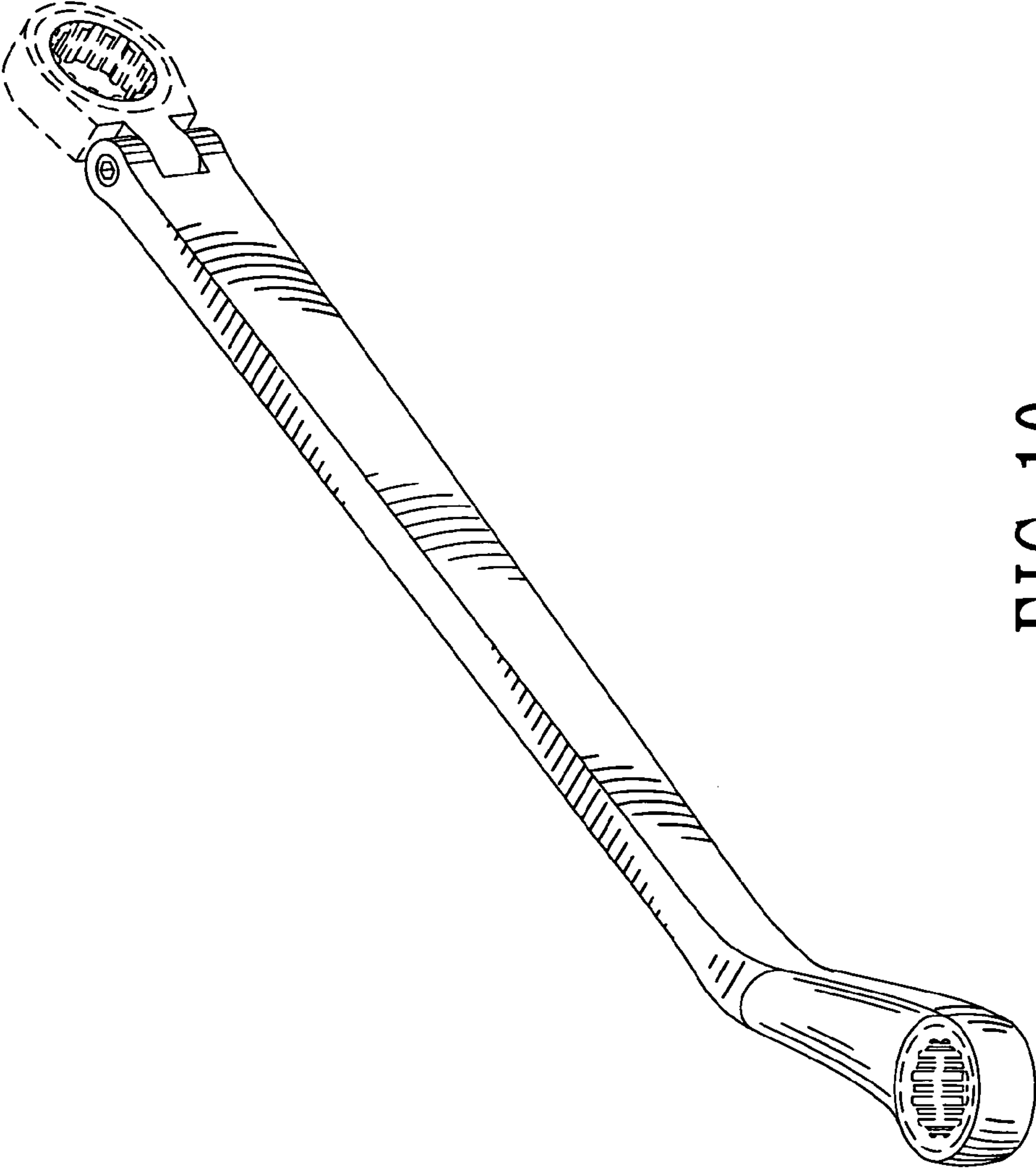

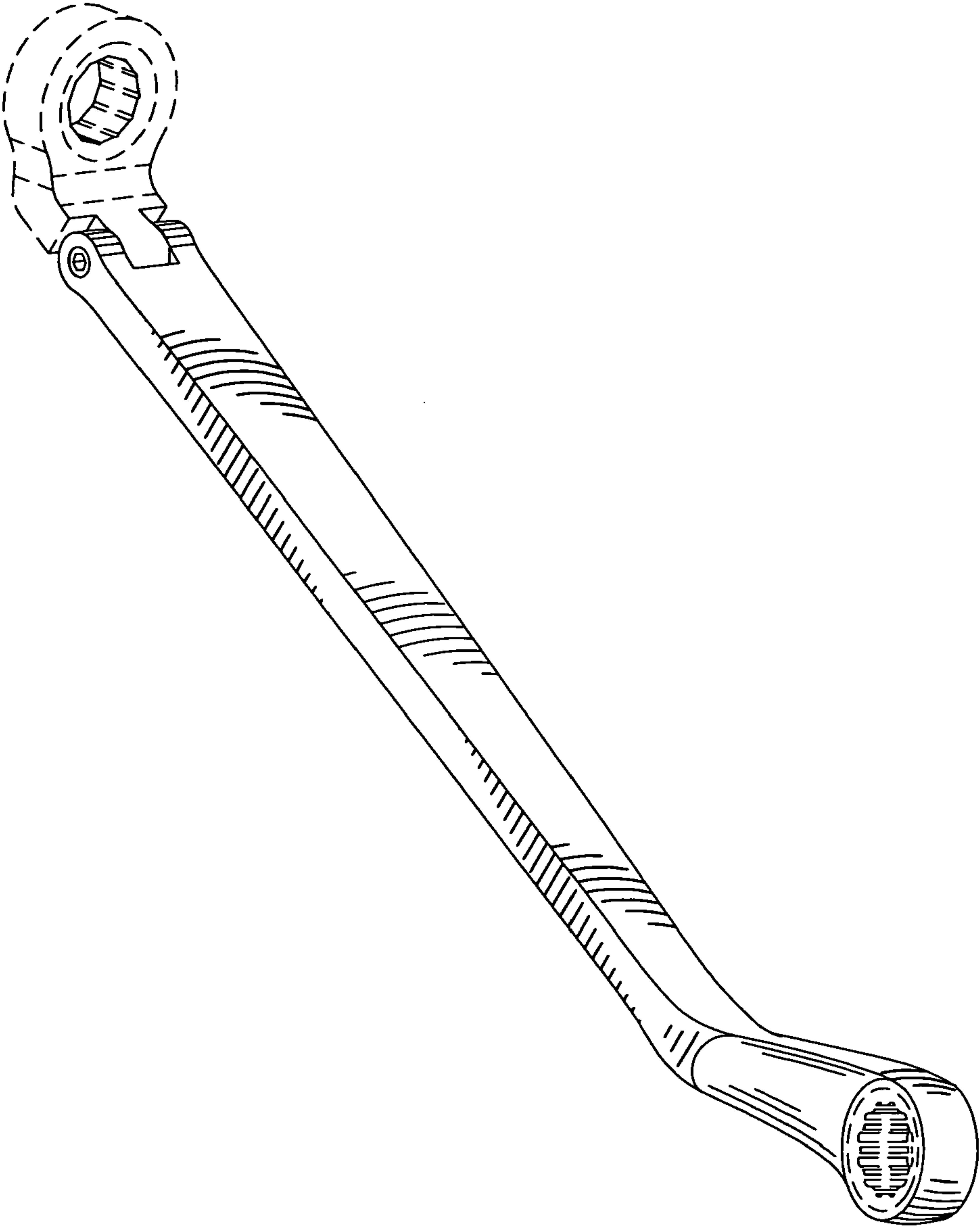

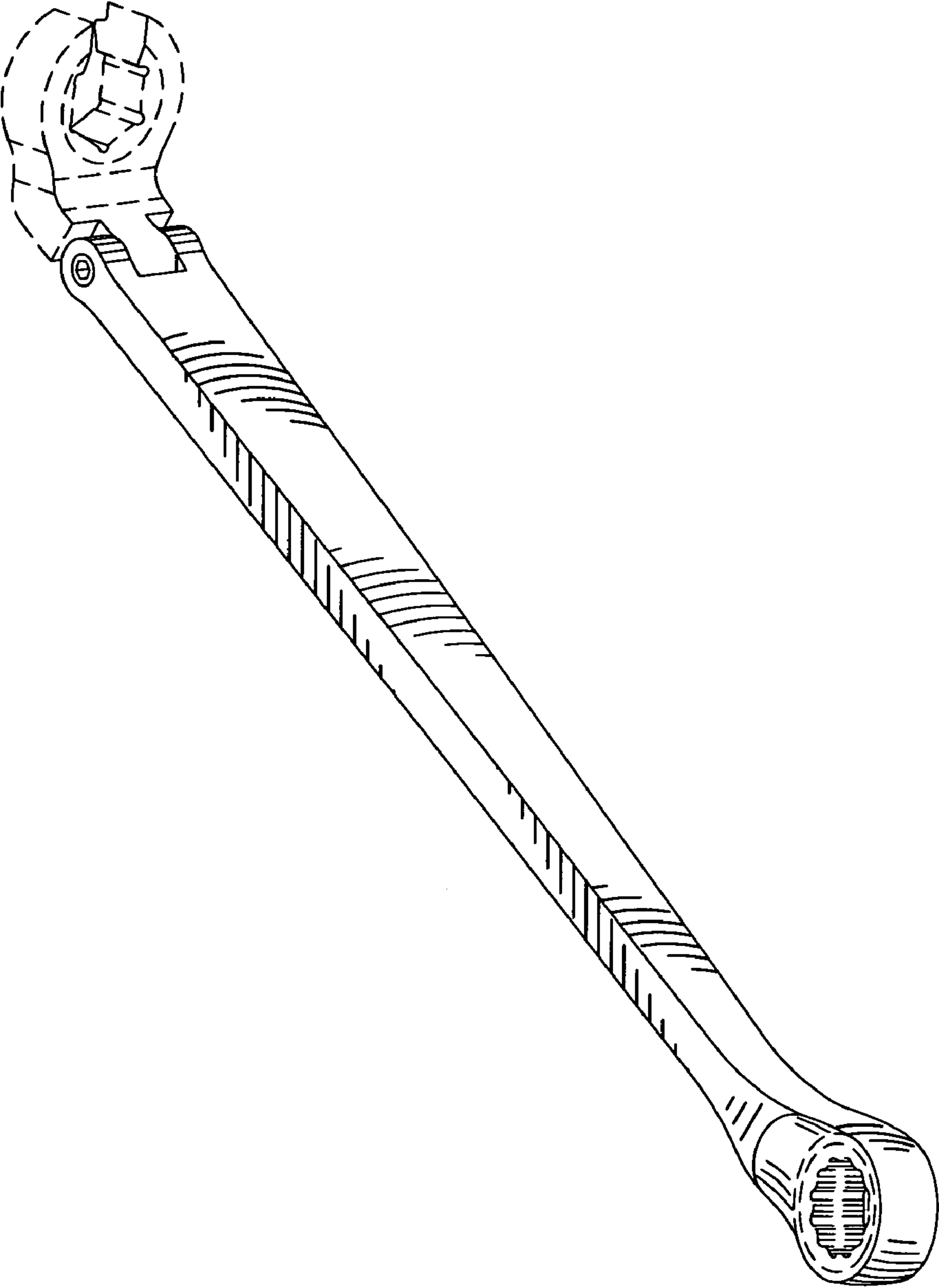

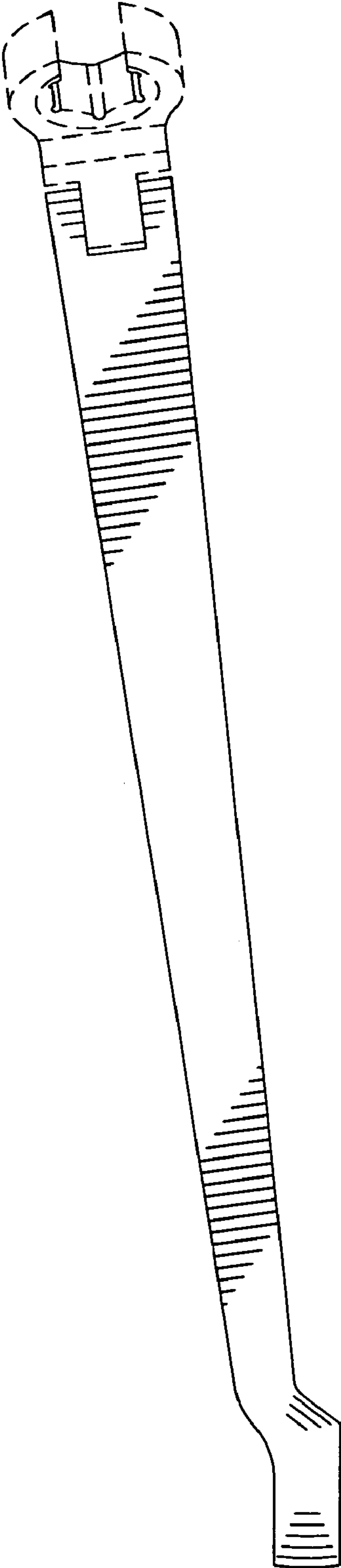

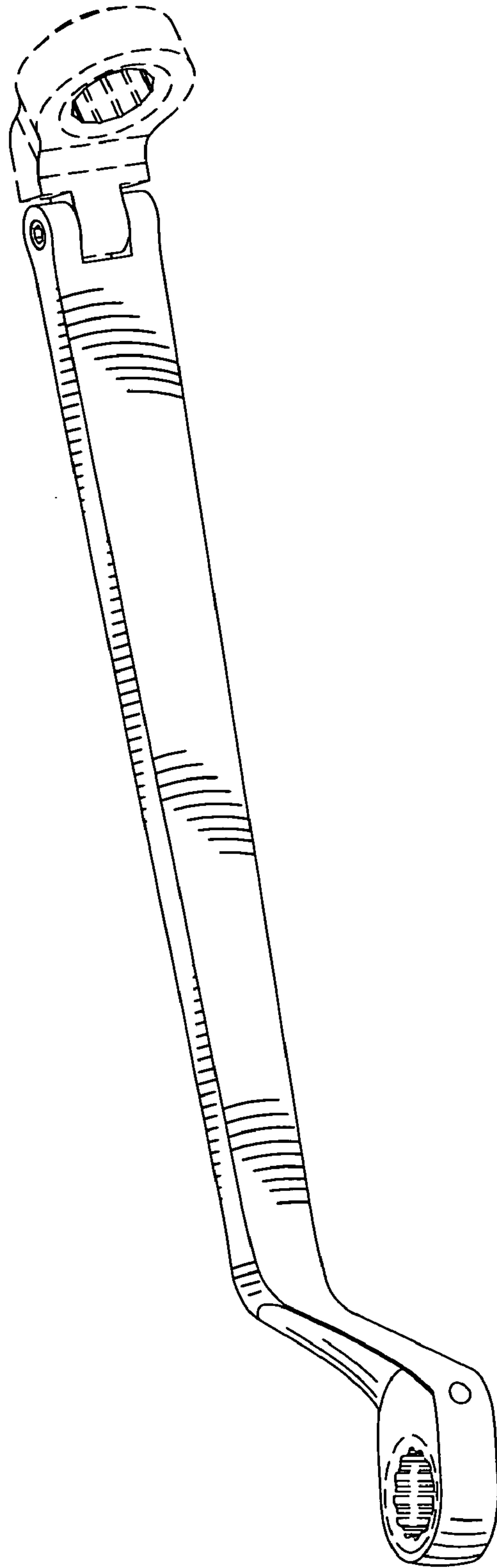

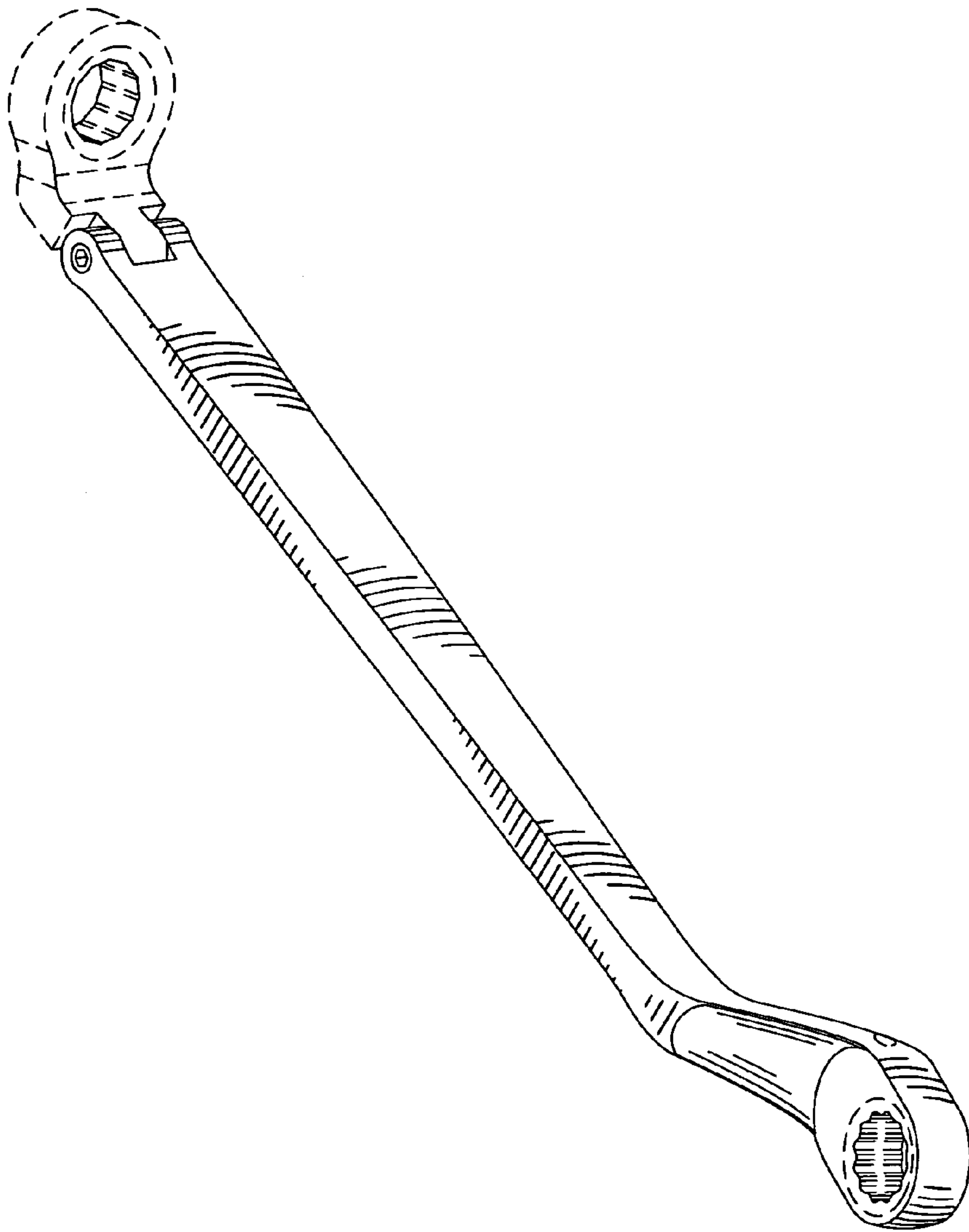

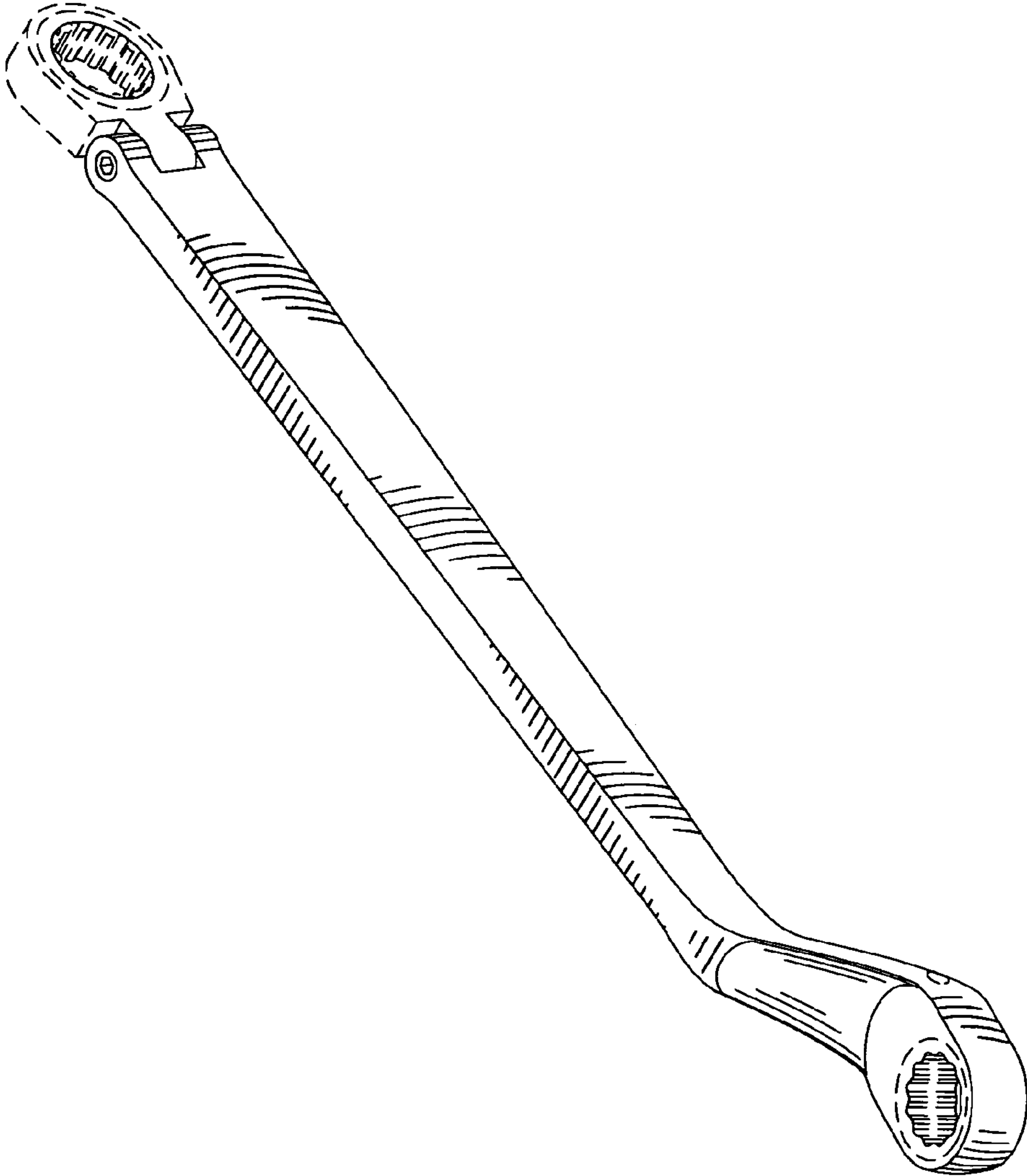
