DESCRIPTION

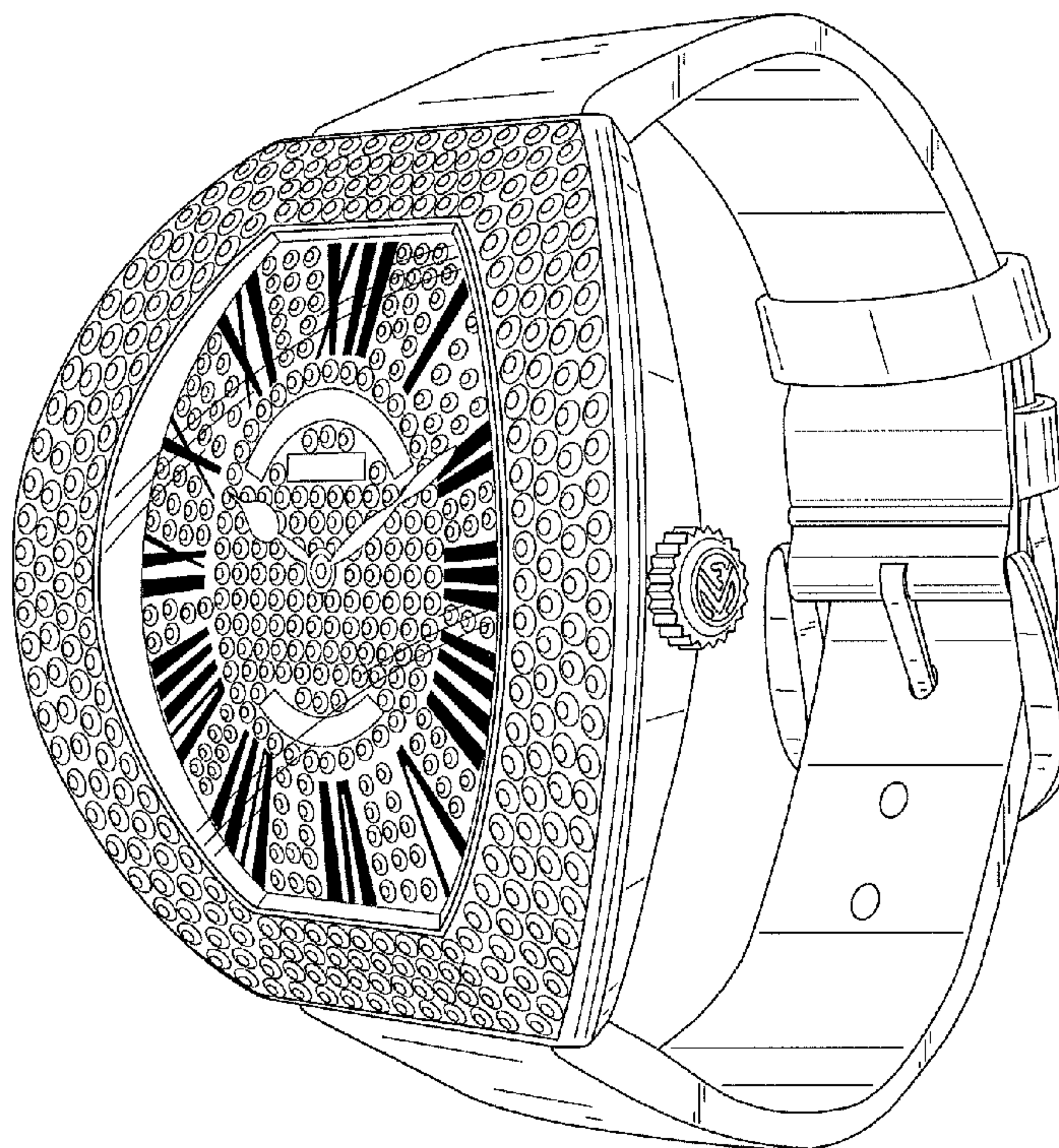
FIG. 1 is a front elevational view of a wristwatch showing my new design;

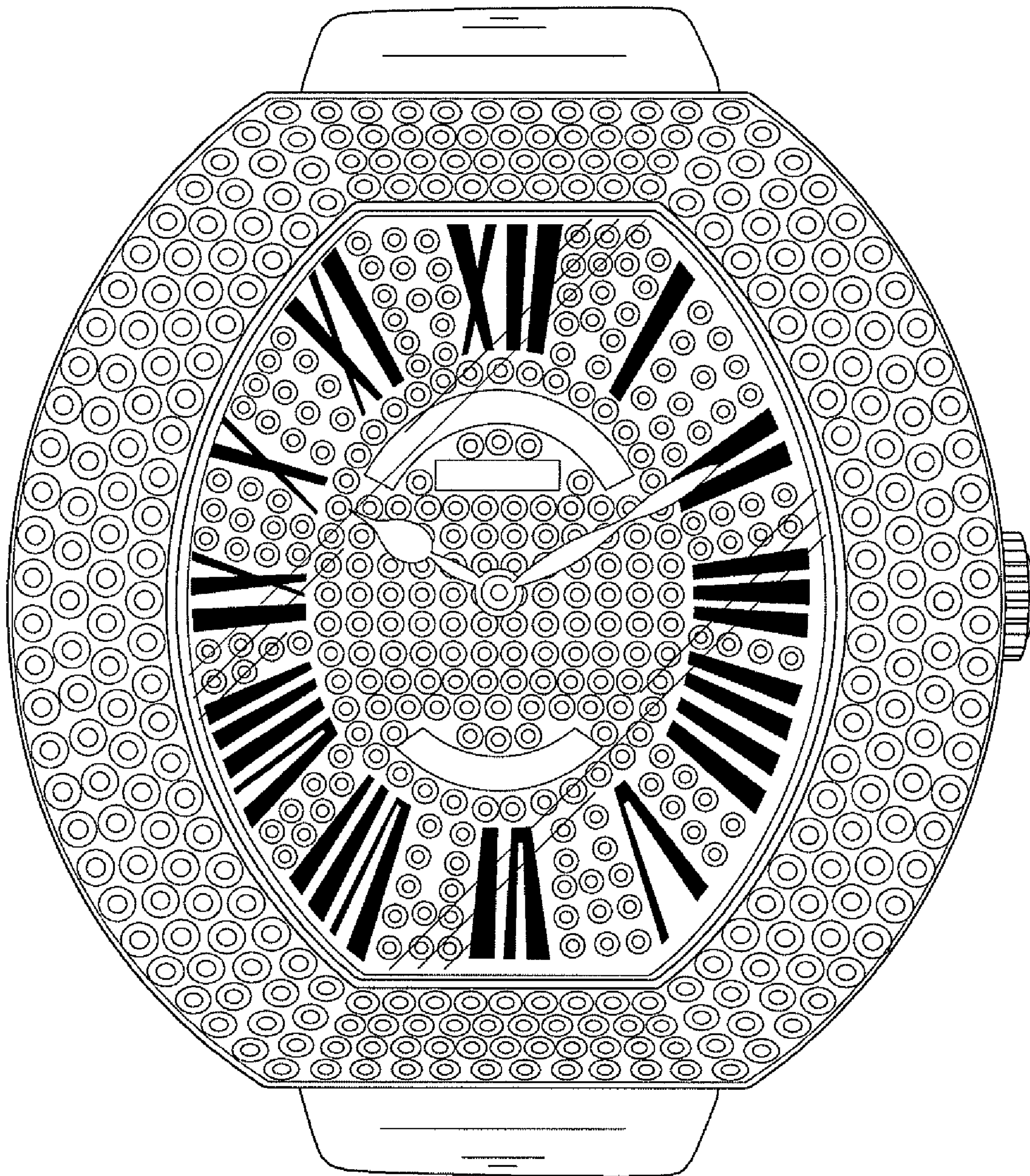

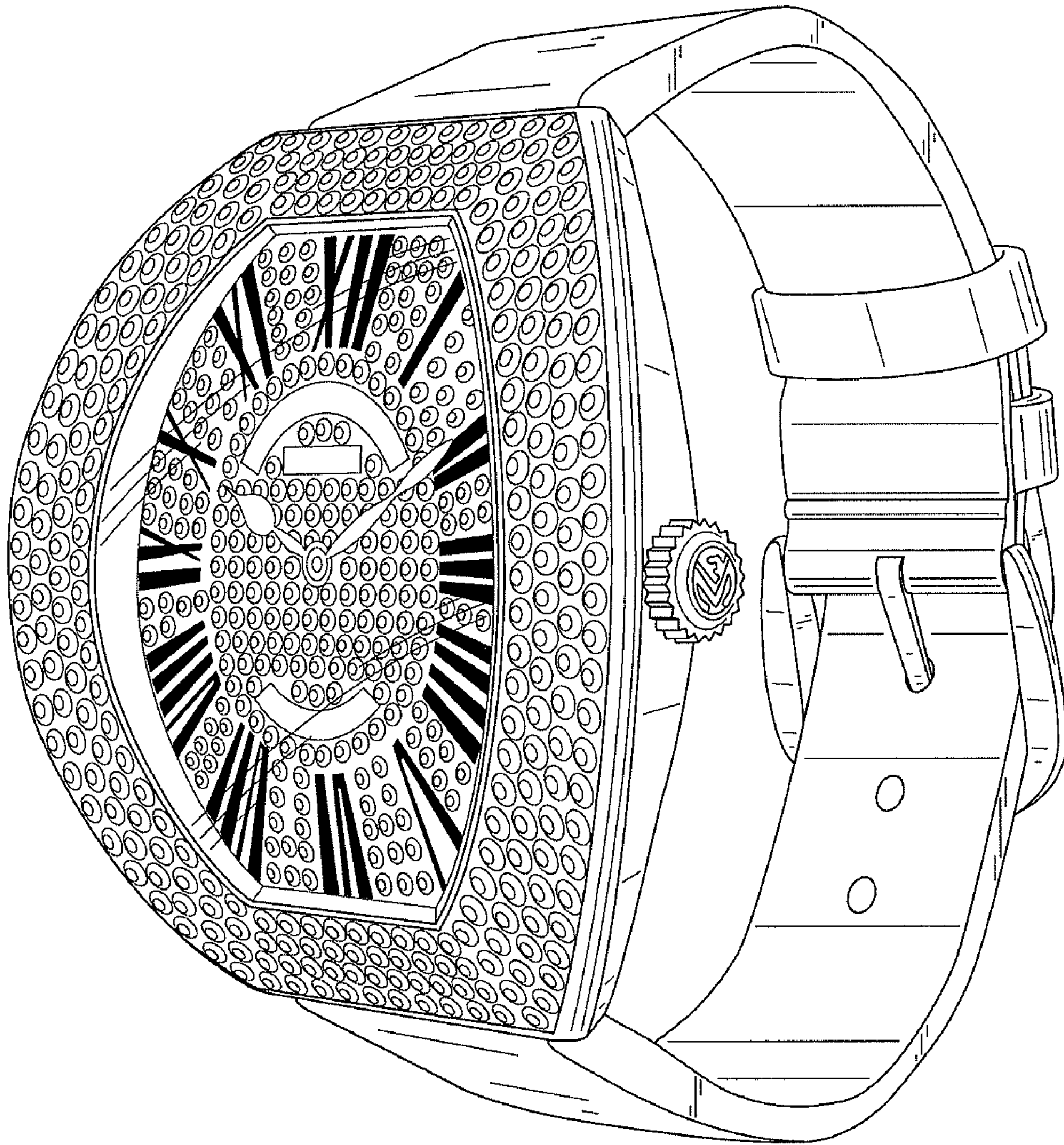

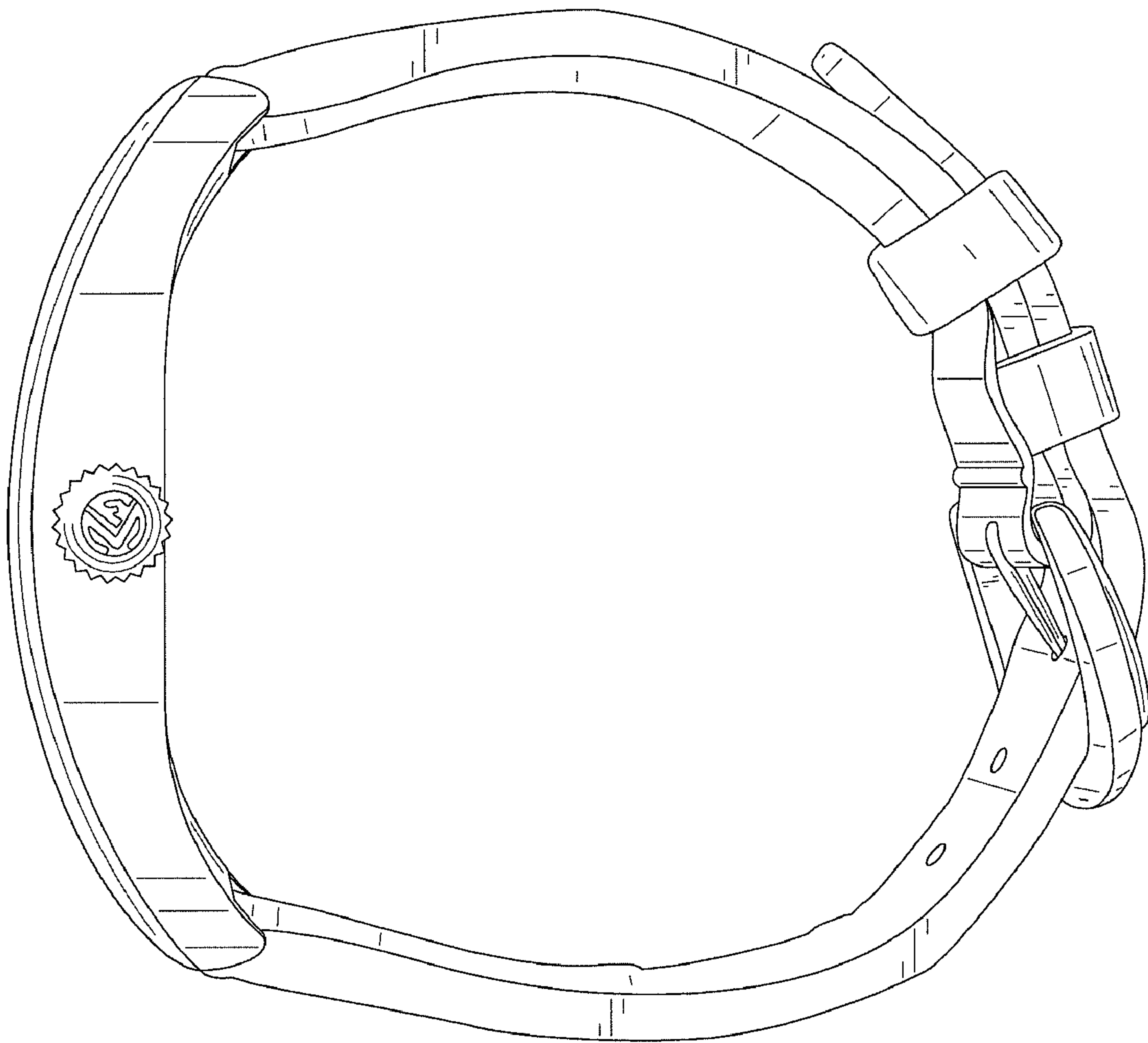

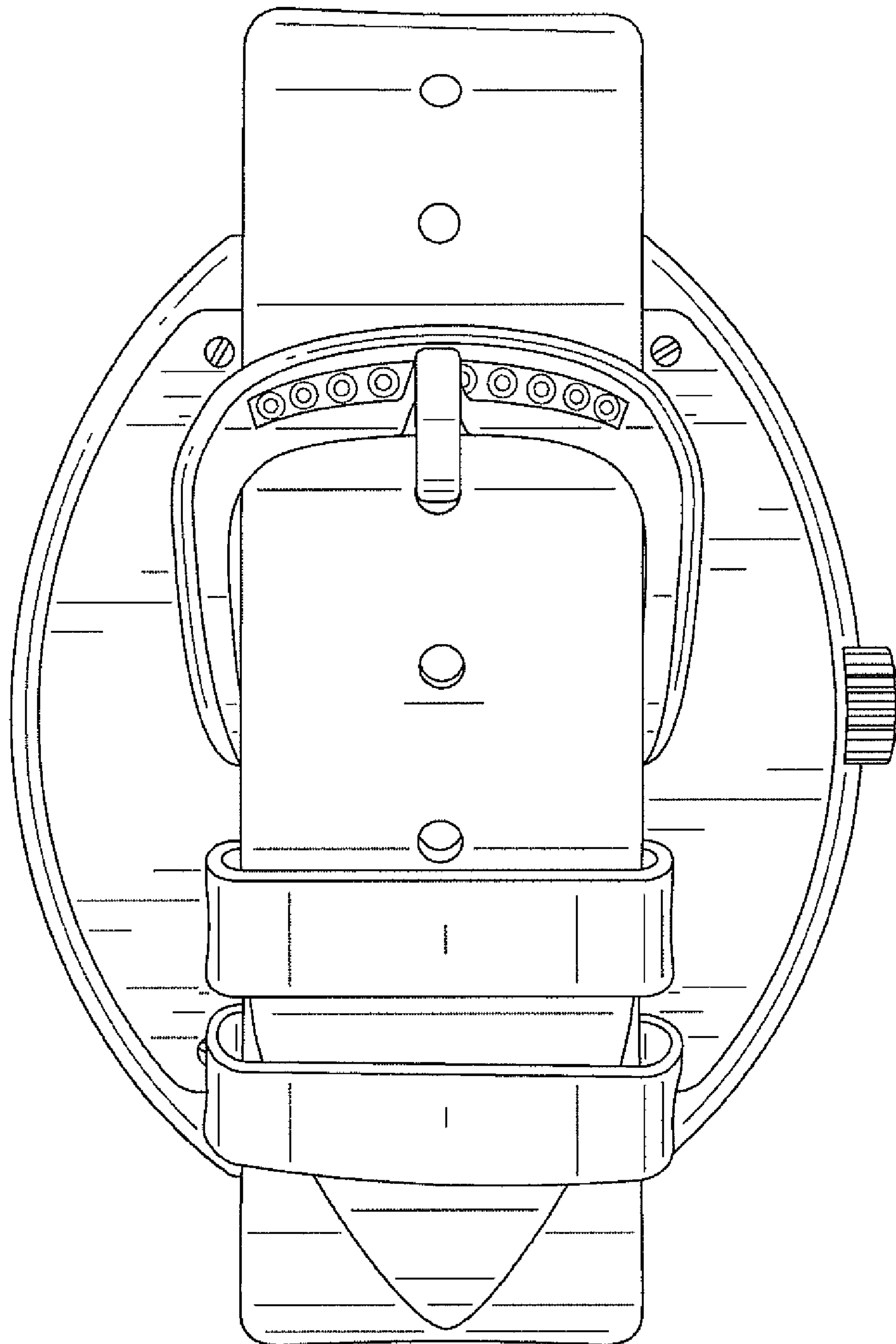
