FIG. 6 is a bottom view thereof.

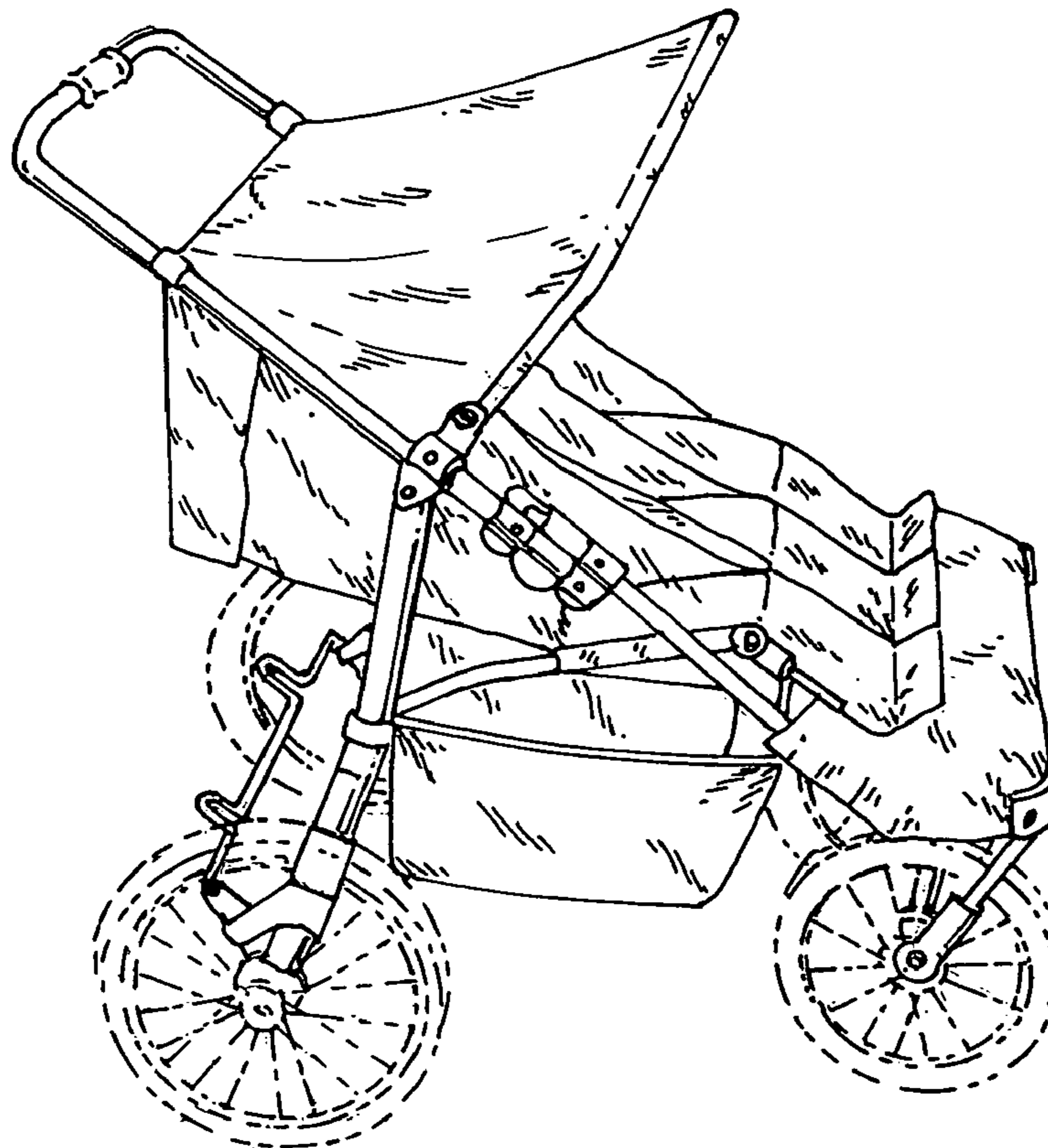
The broken line showing of the wheels and front step in the figure drawings is included for the purpose of illustrating environment and forms no part of the claimed design.

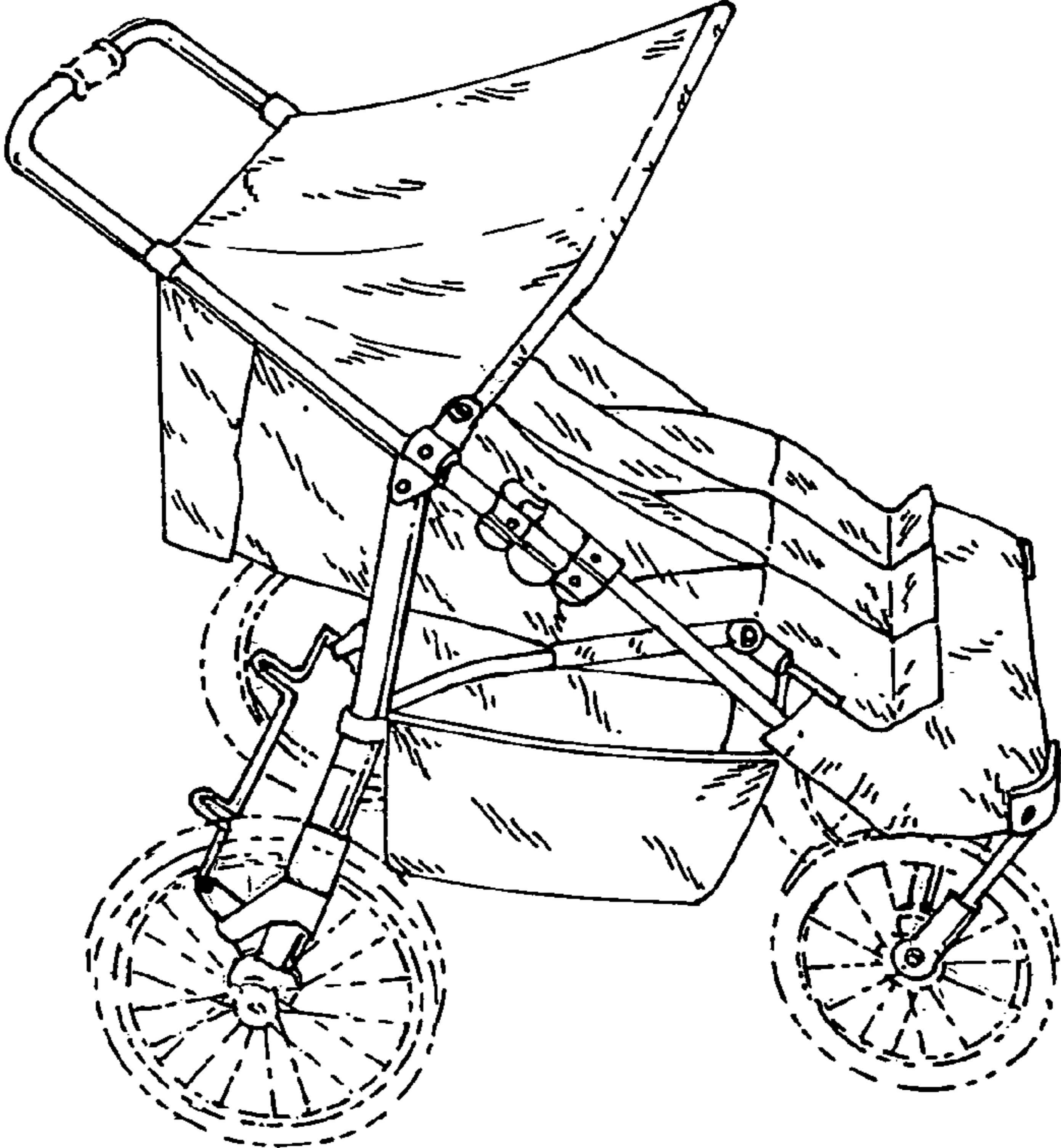

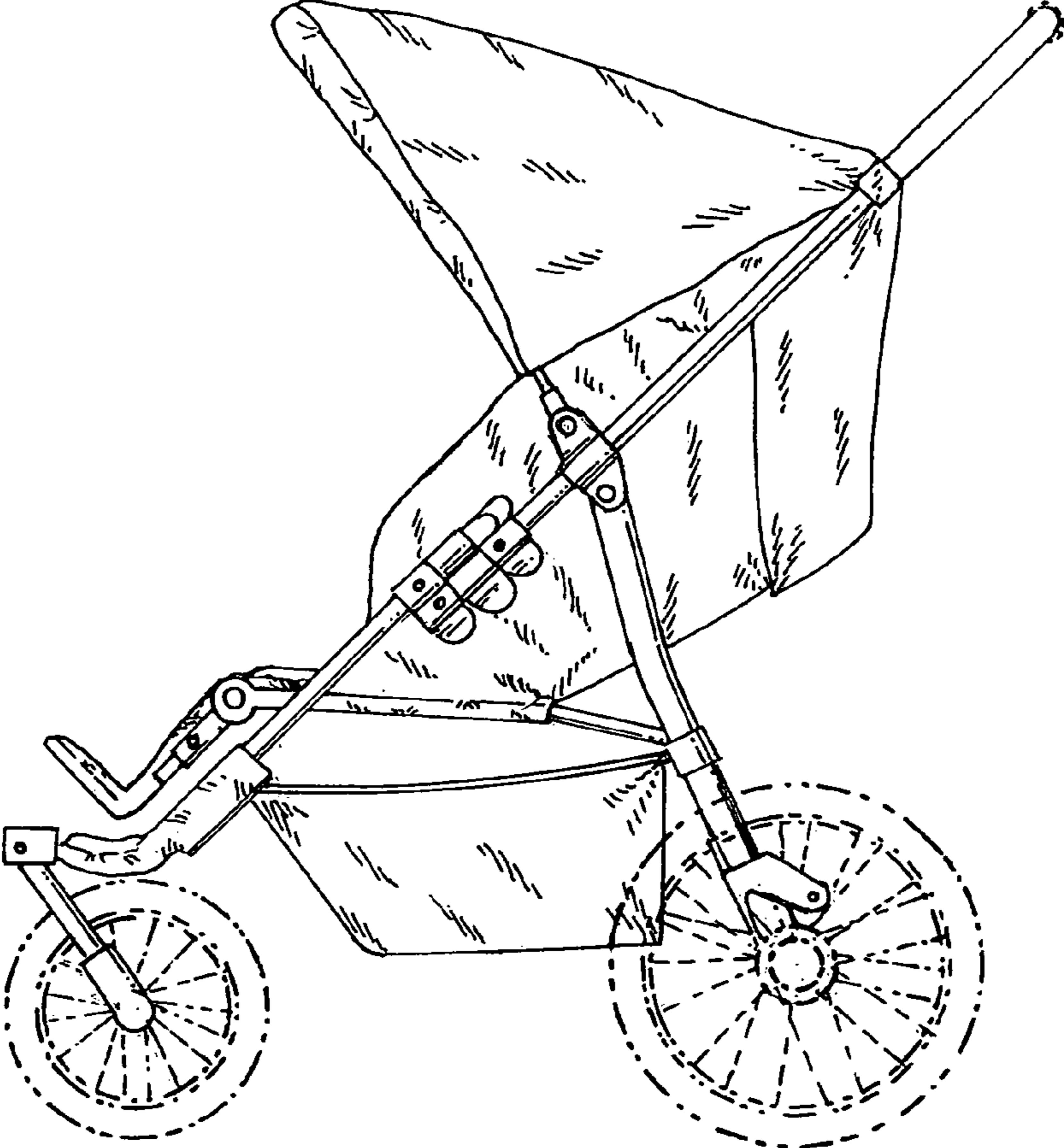

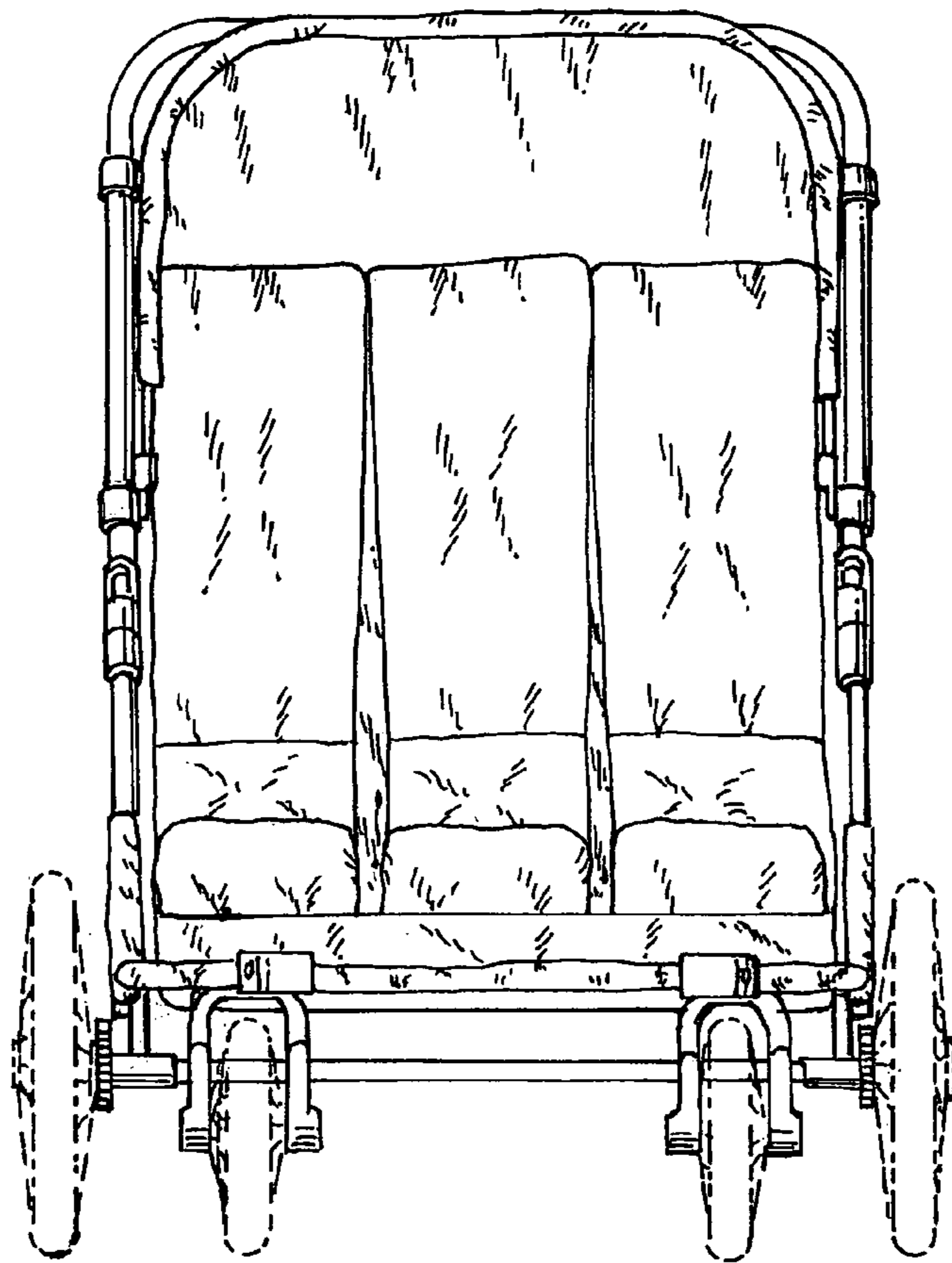

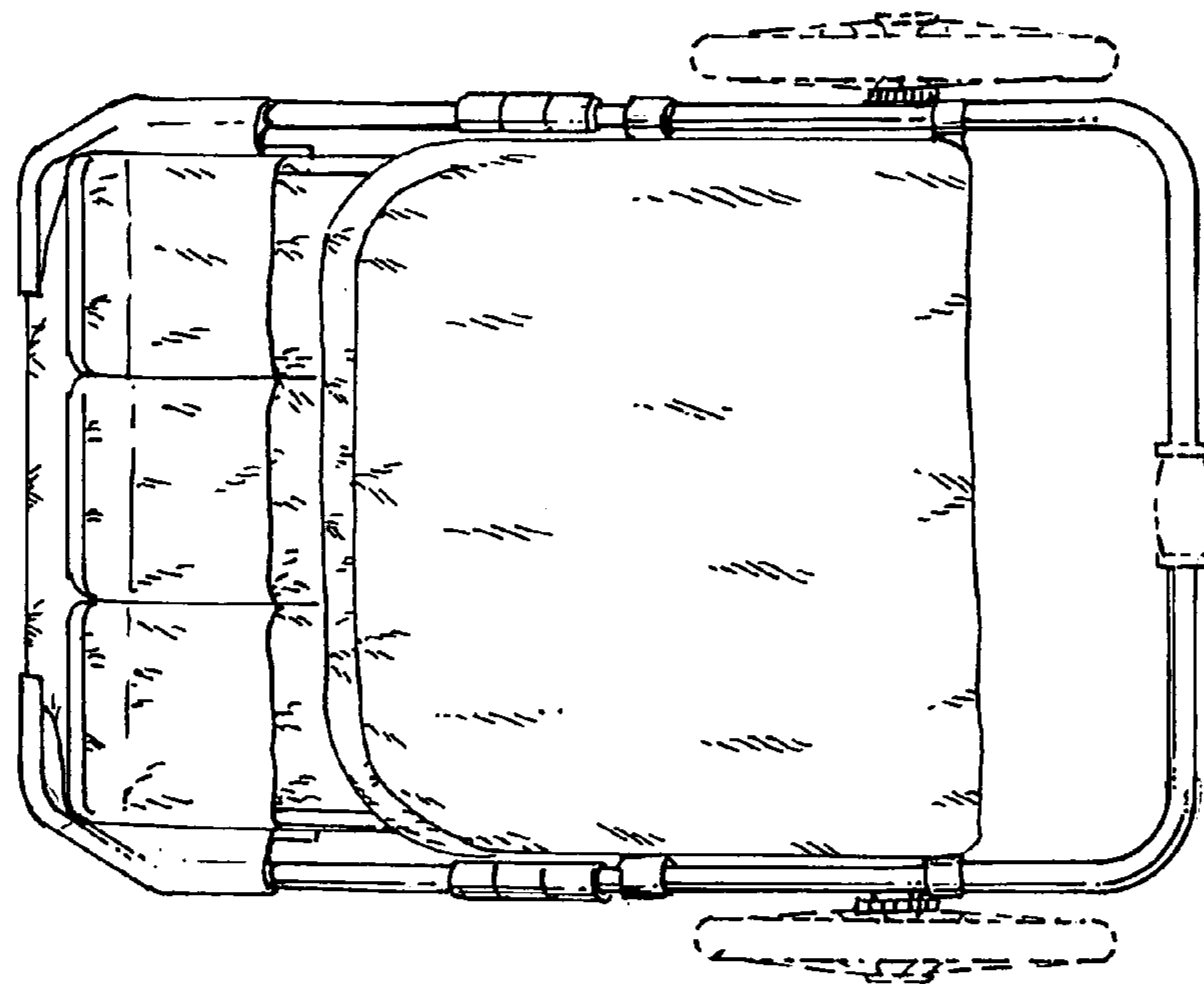

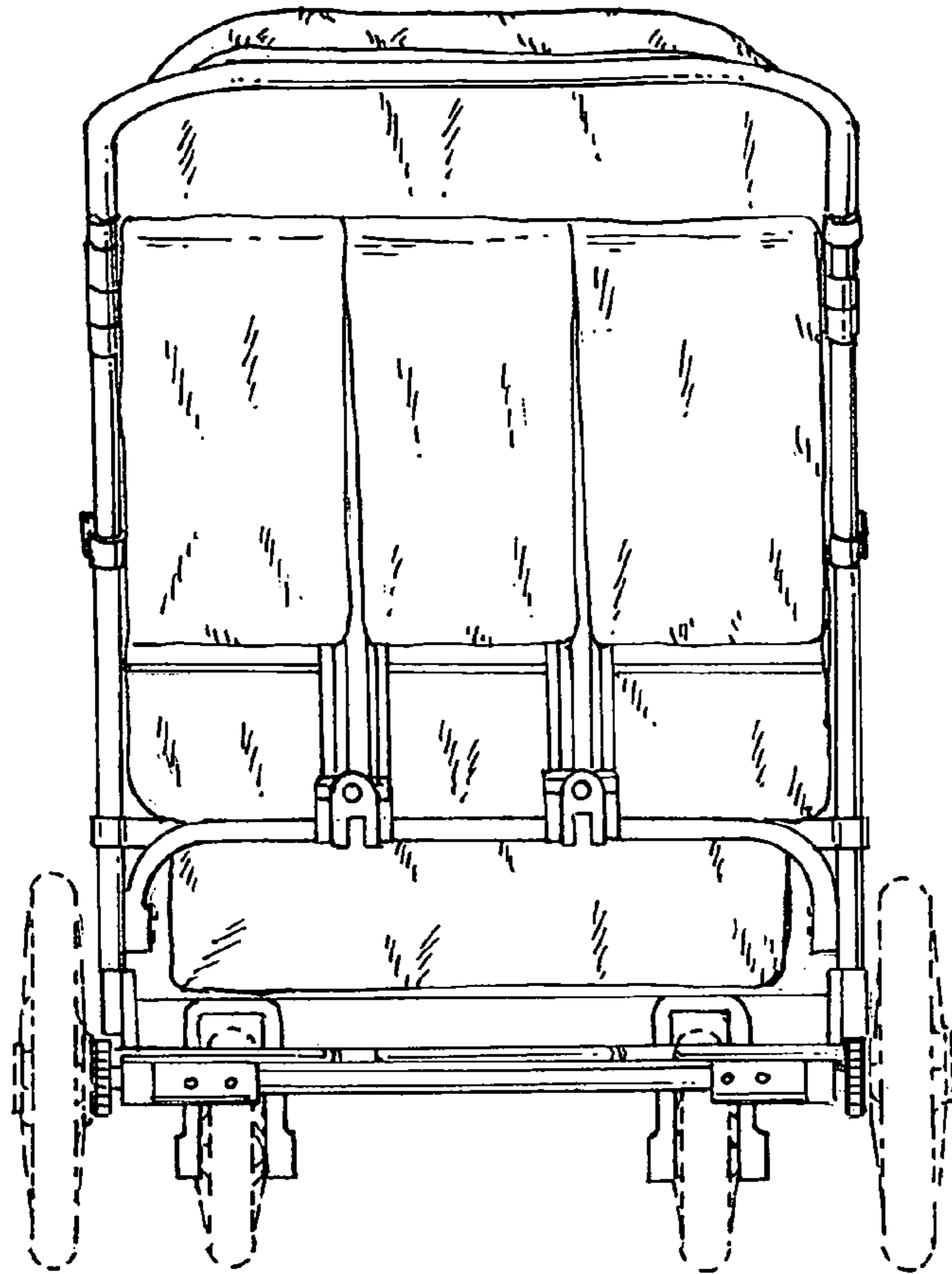

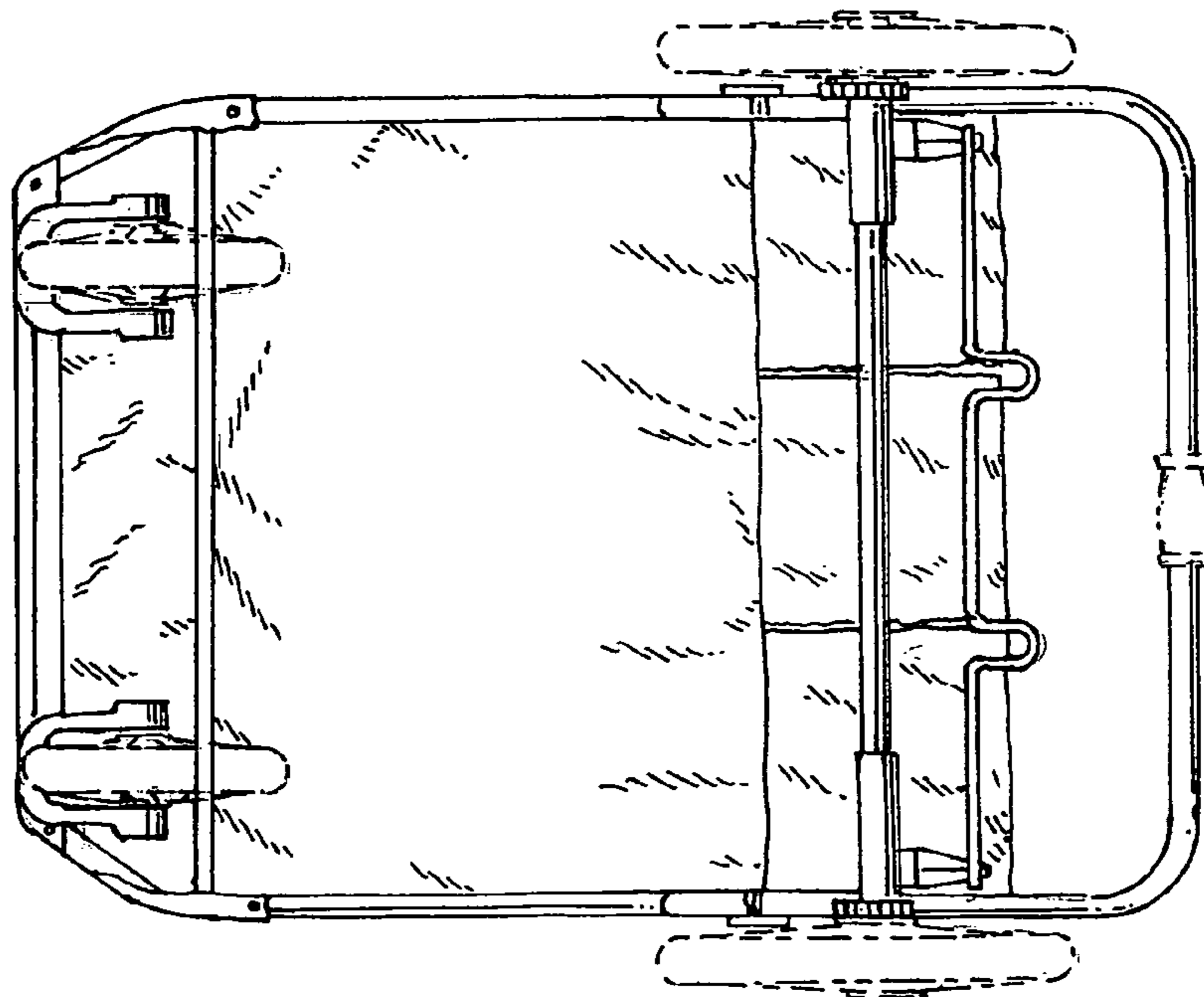
