invention.

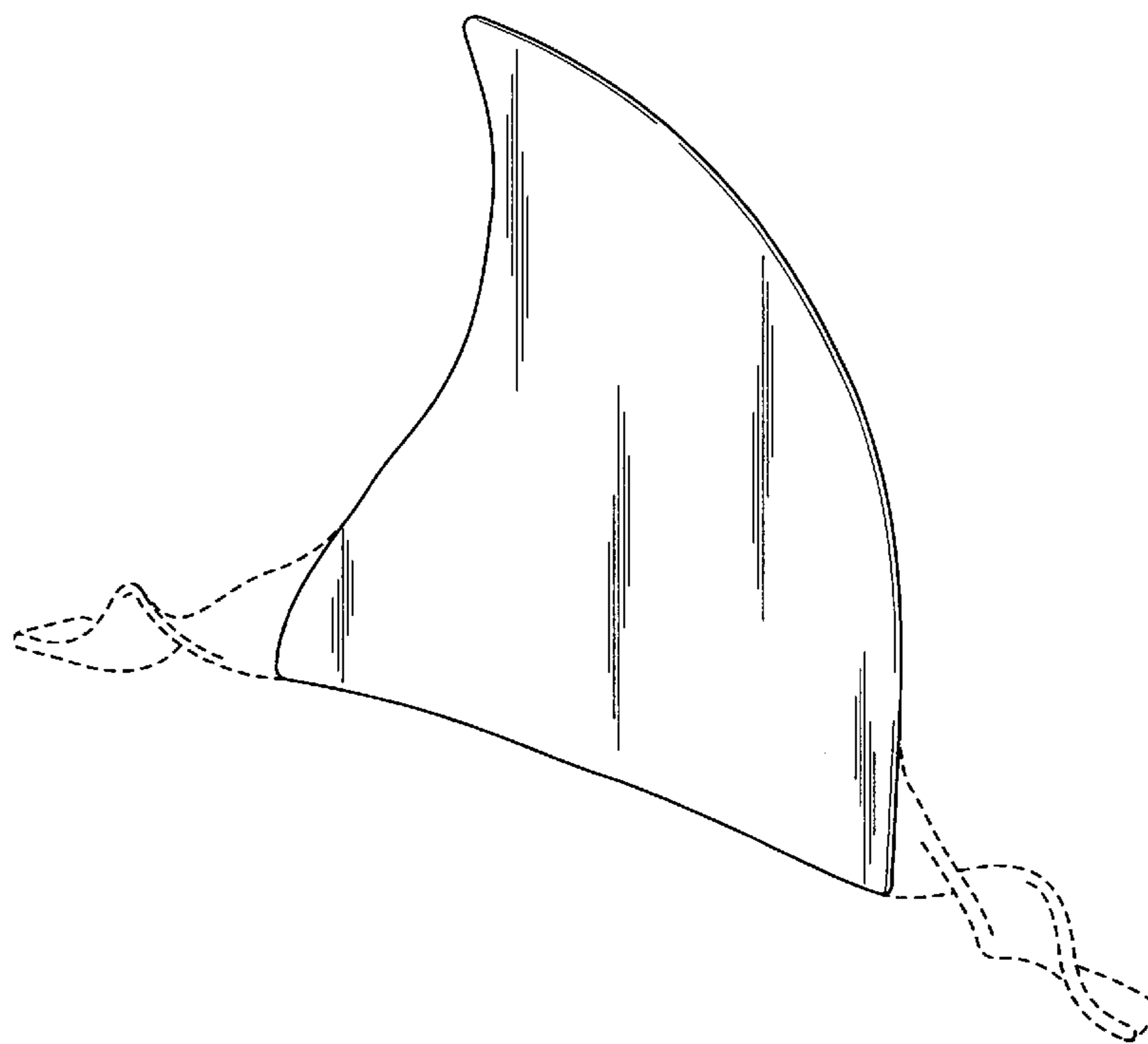

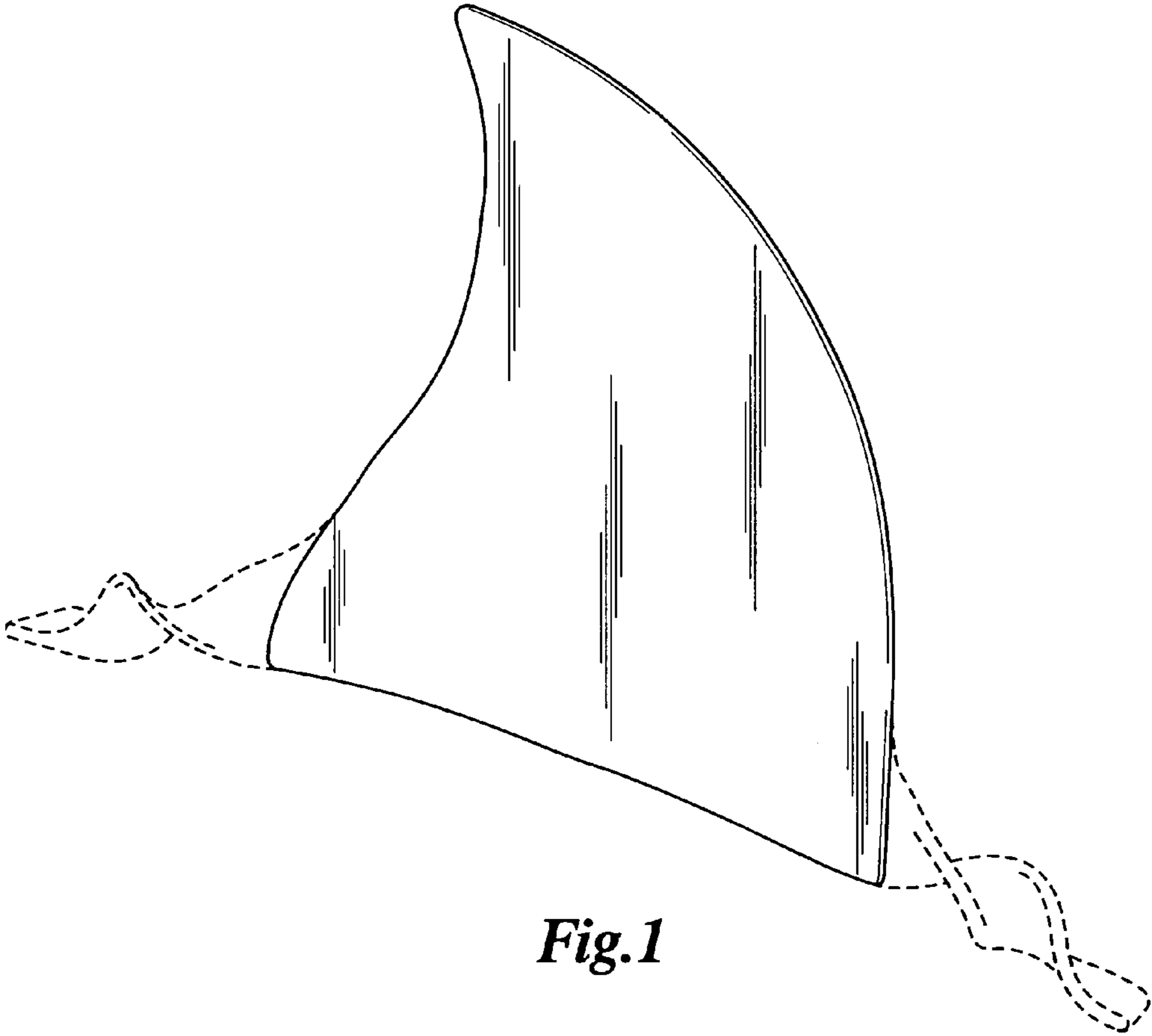

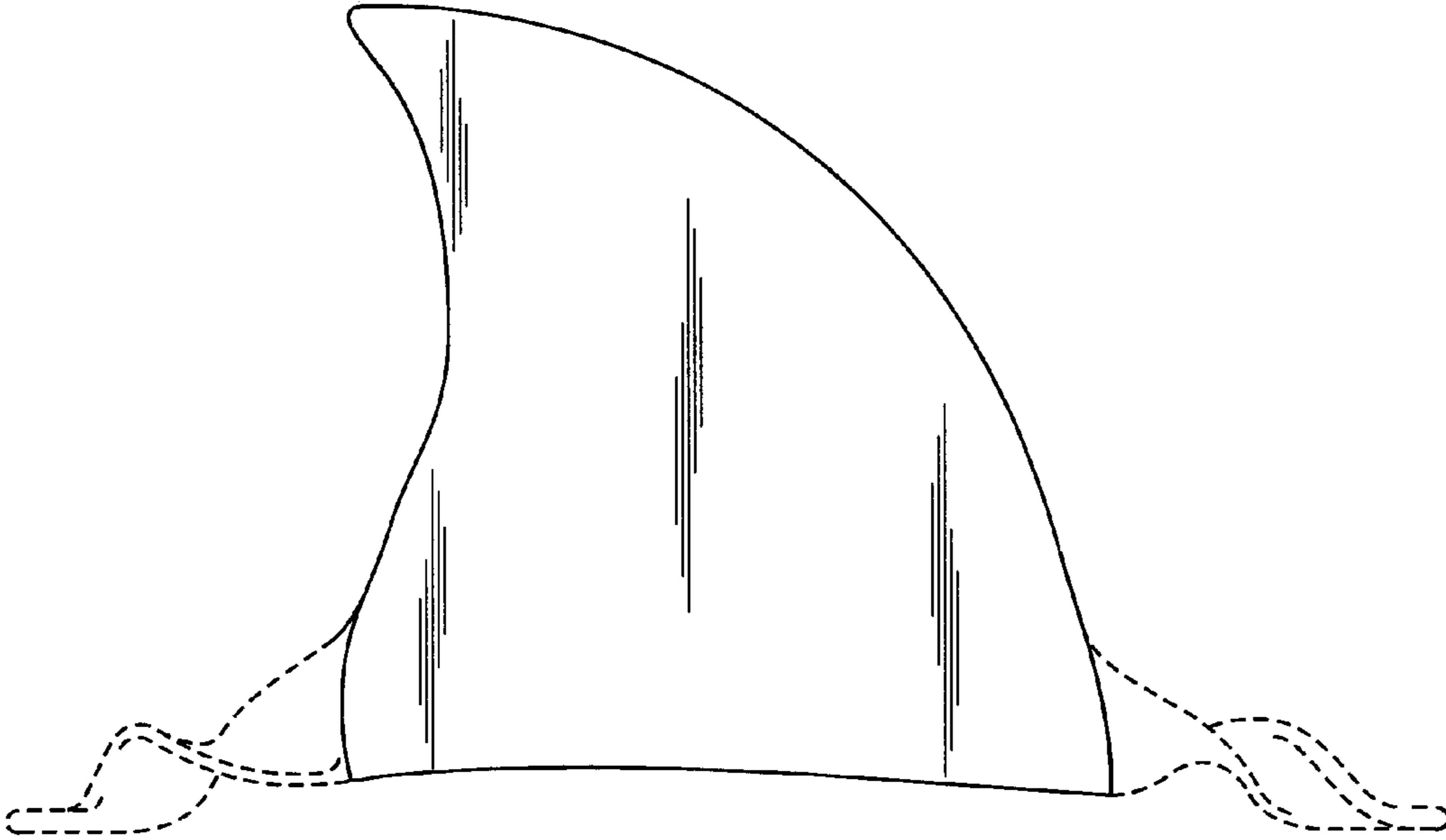

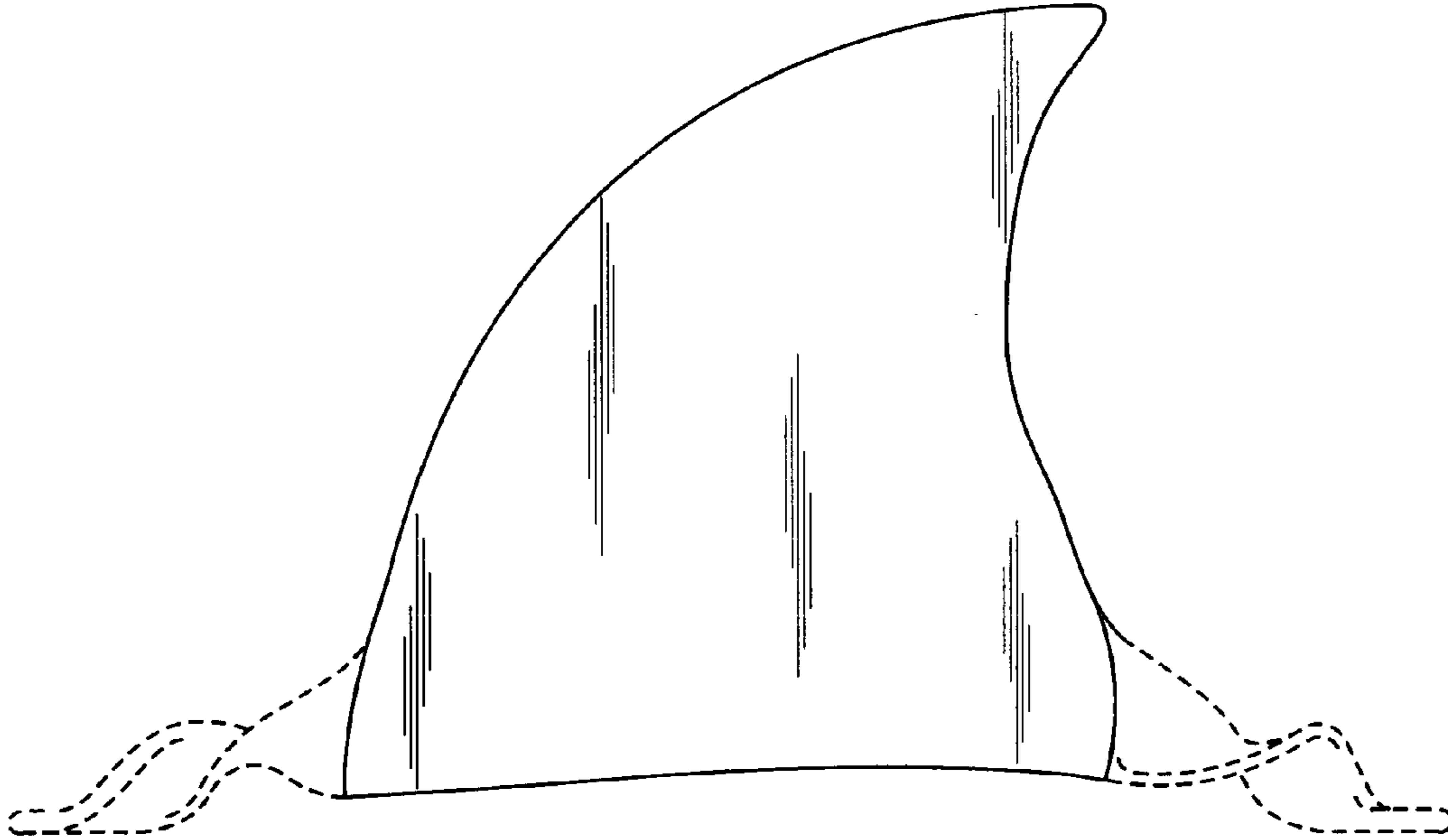

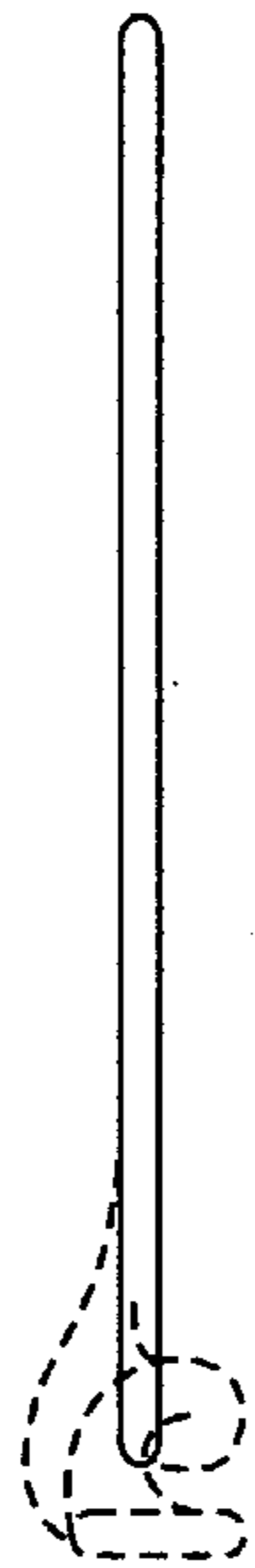

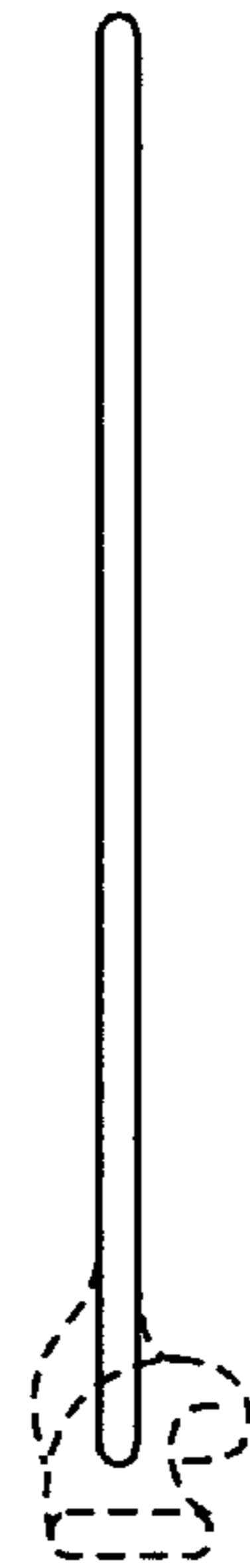

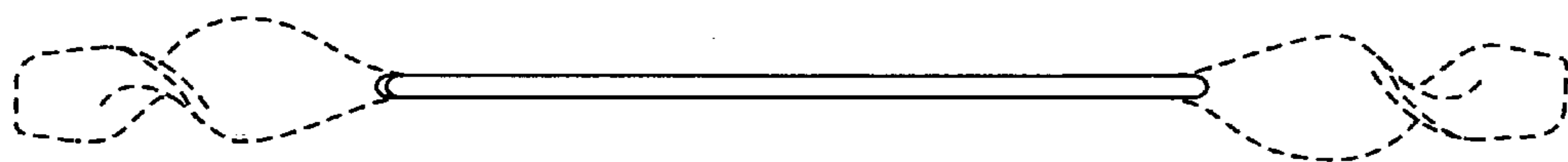

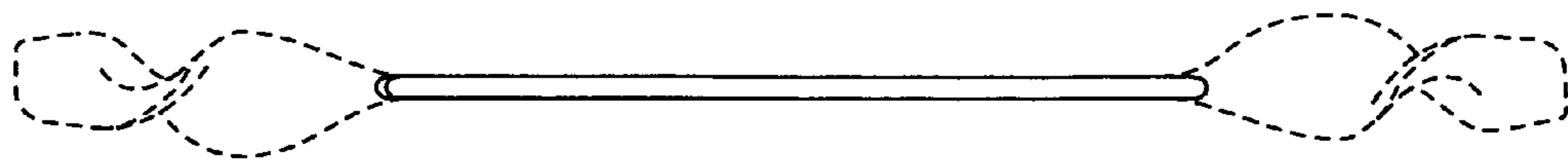
