(57) **CLAIM**

We claim the ornamental design for mobile phone, as shown.

DESCRIPTION

FIG. 1 is a front/left-side/top perspective view of a mobile phone showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a right-side elevational view thereof;

FIG. 6 is a top elevational view thereof;

FIG. 7 is a bottom elevational view thereof;

FIG. 8 is a front/left-side/top perspective view of a mobile phone showing that the front panel has been slid upward; and,

FIG. 9 is a rear view of a mobile phone when the front panel is sliding upward.

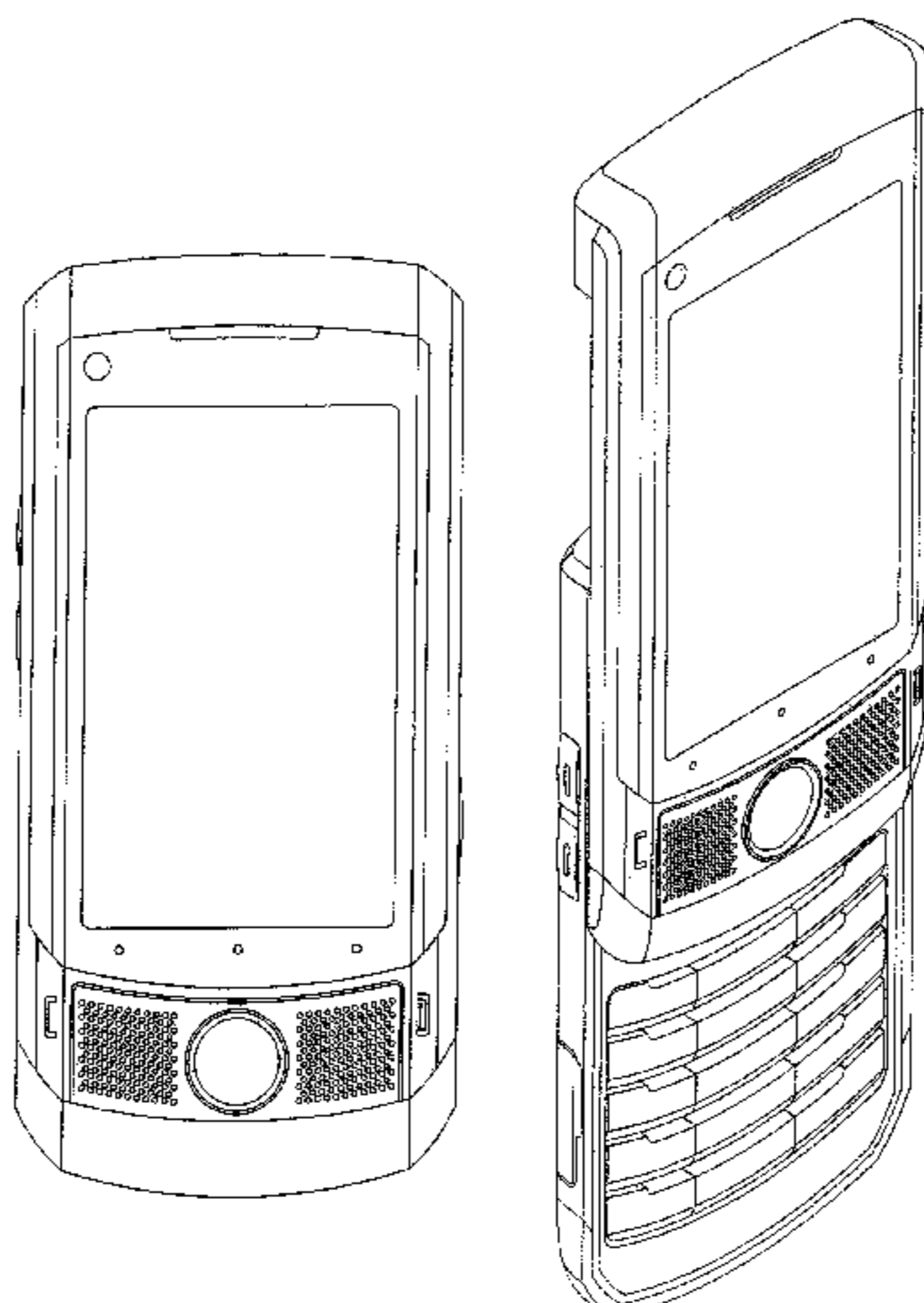

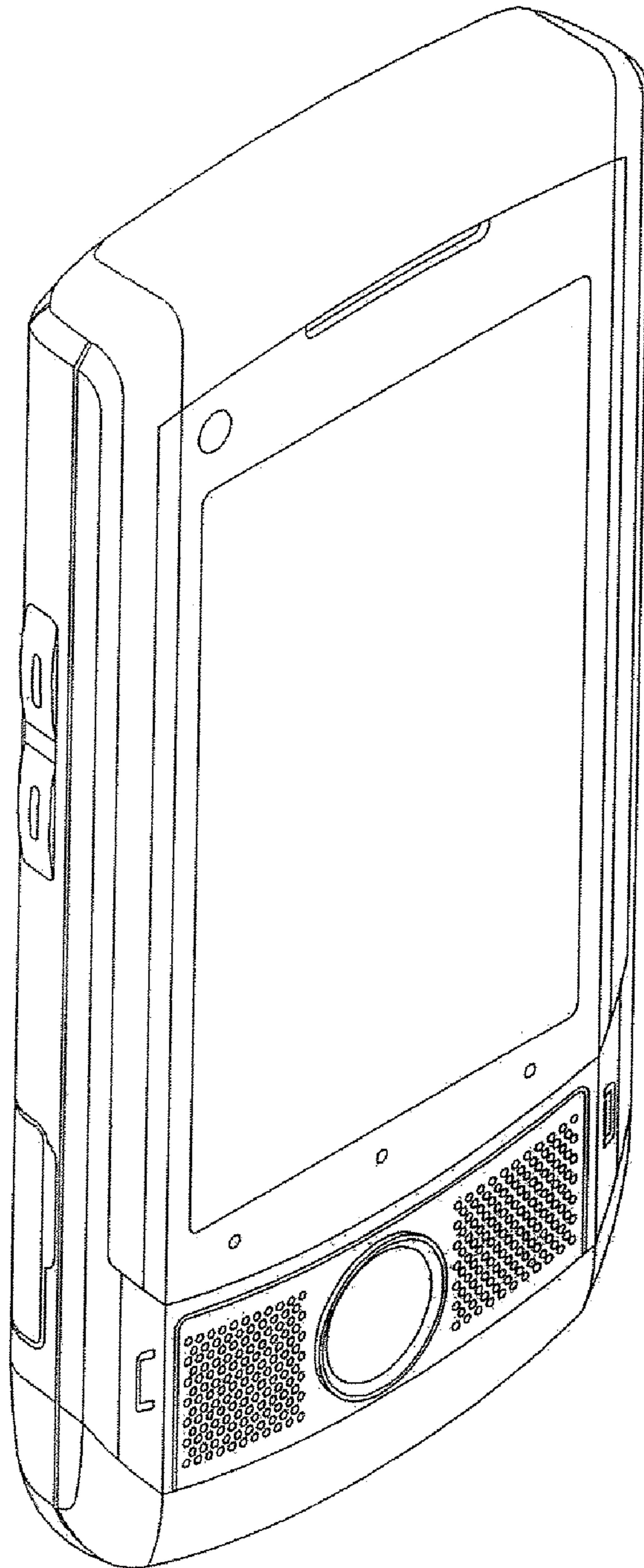

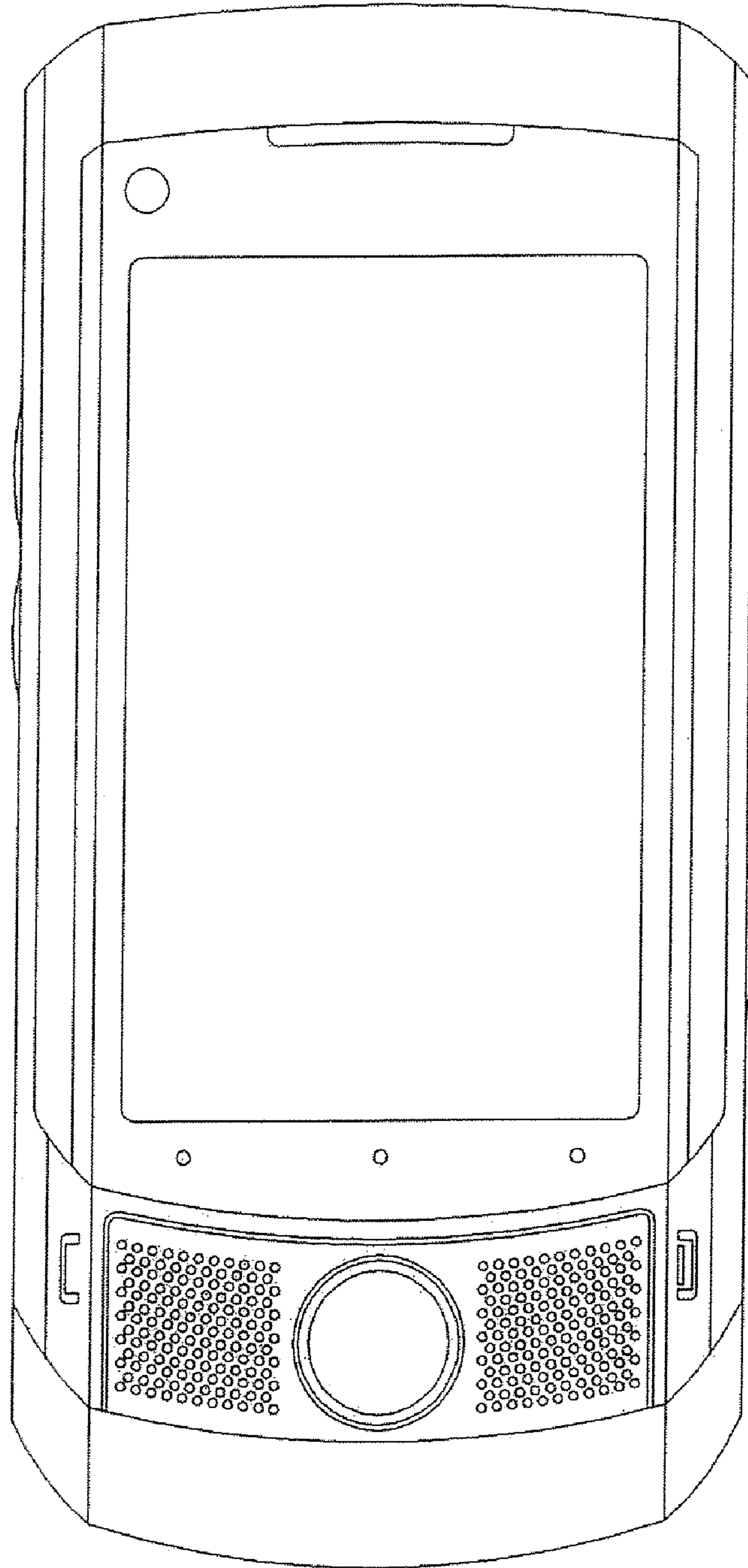

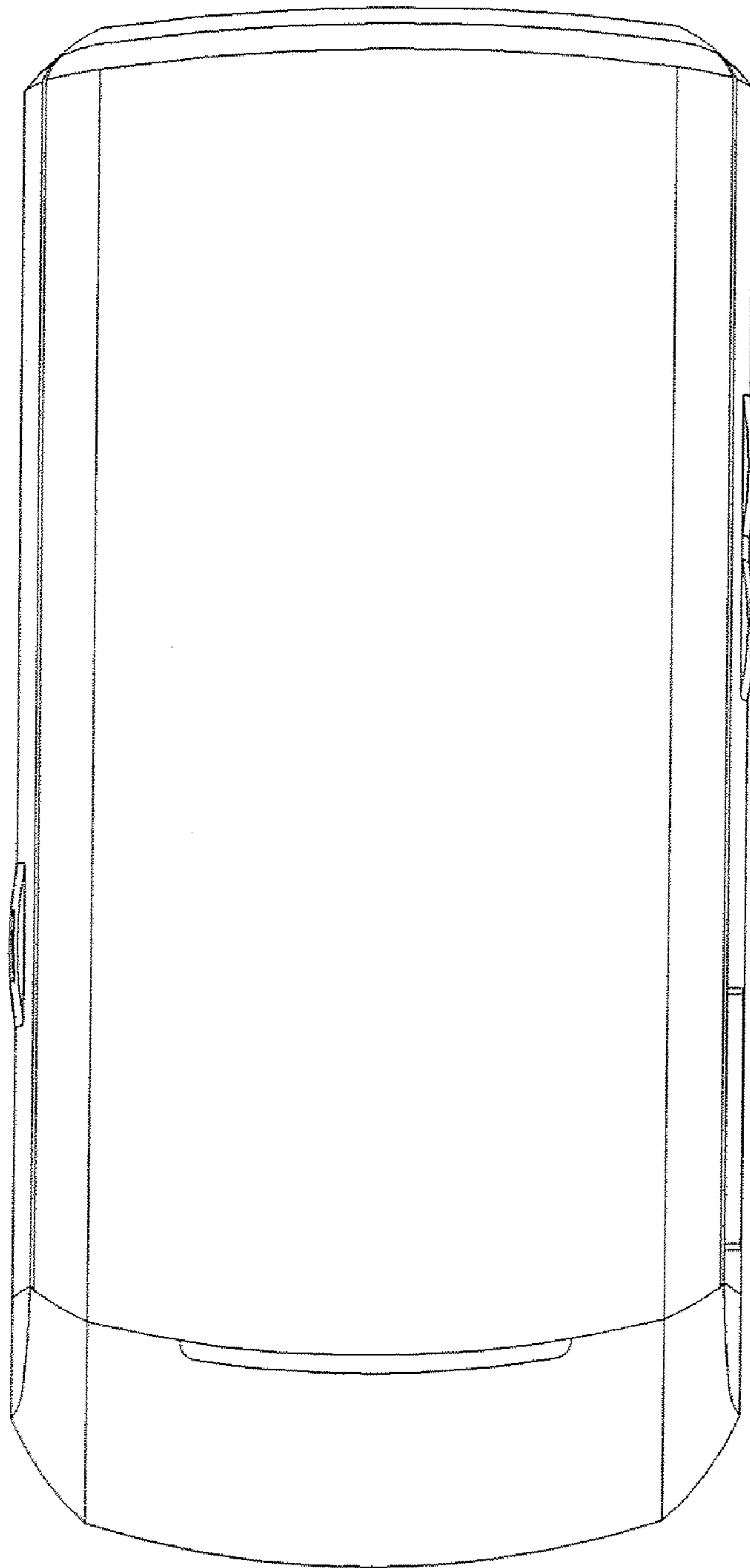

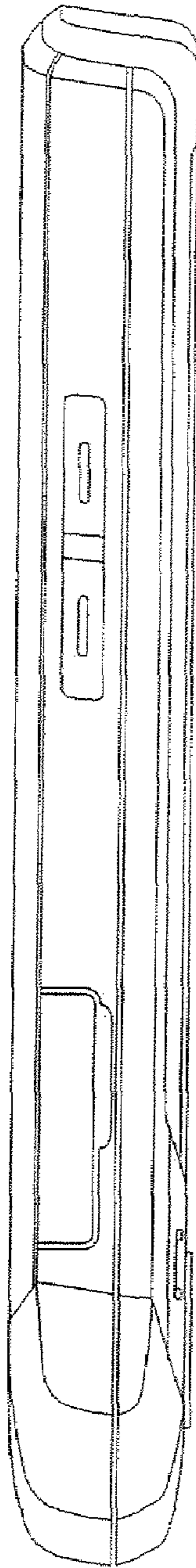

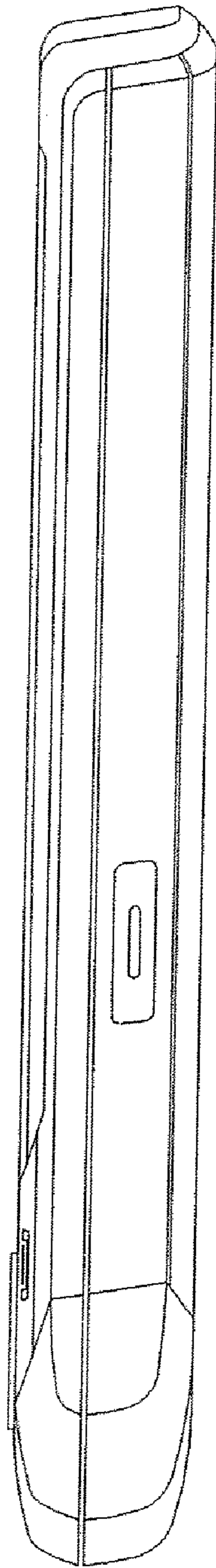

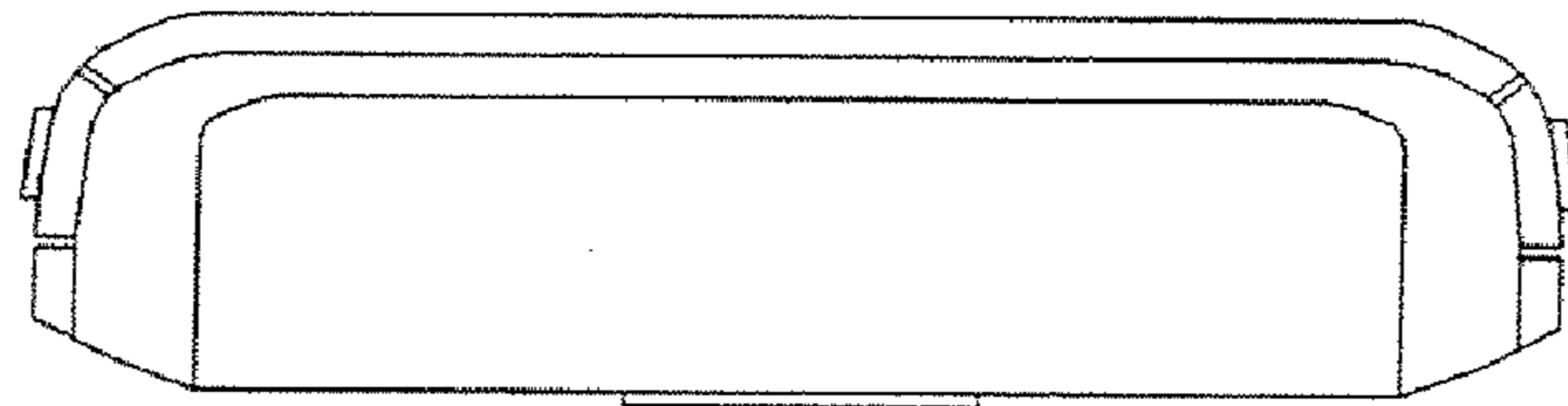

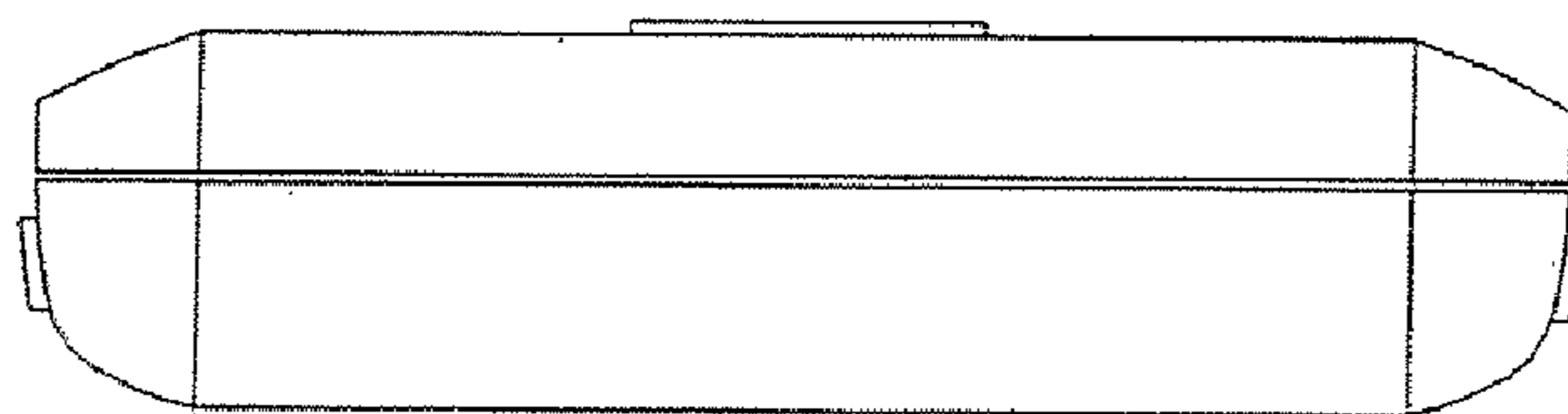

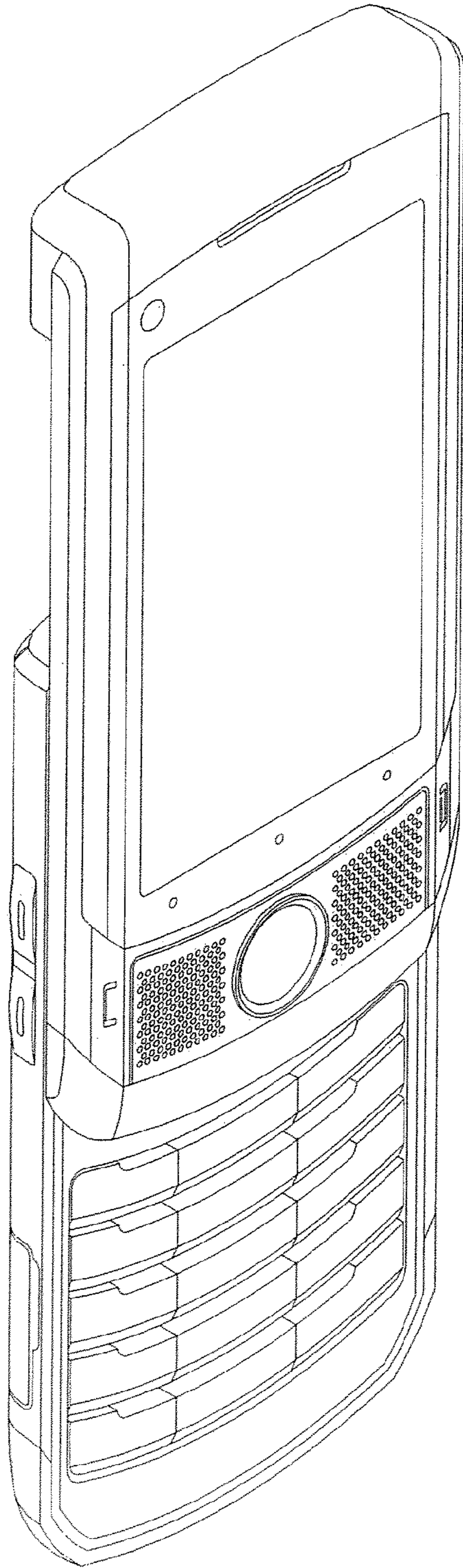
