FIG. 4 shows a right side elevation view thereof;

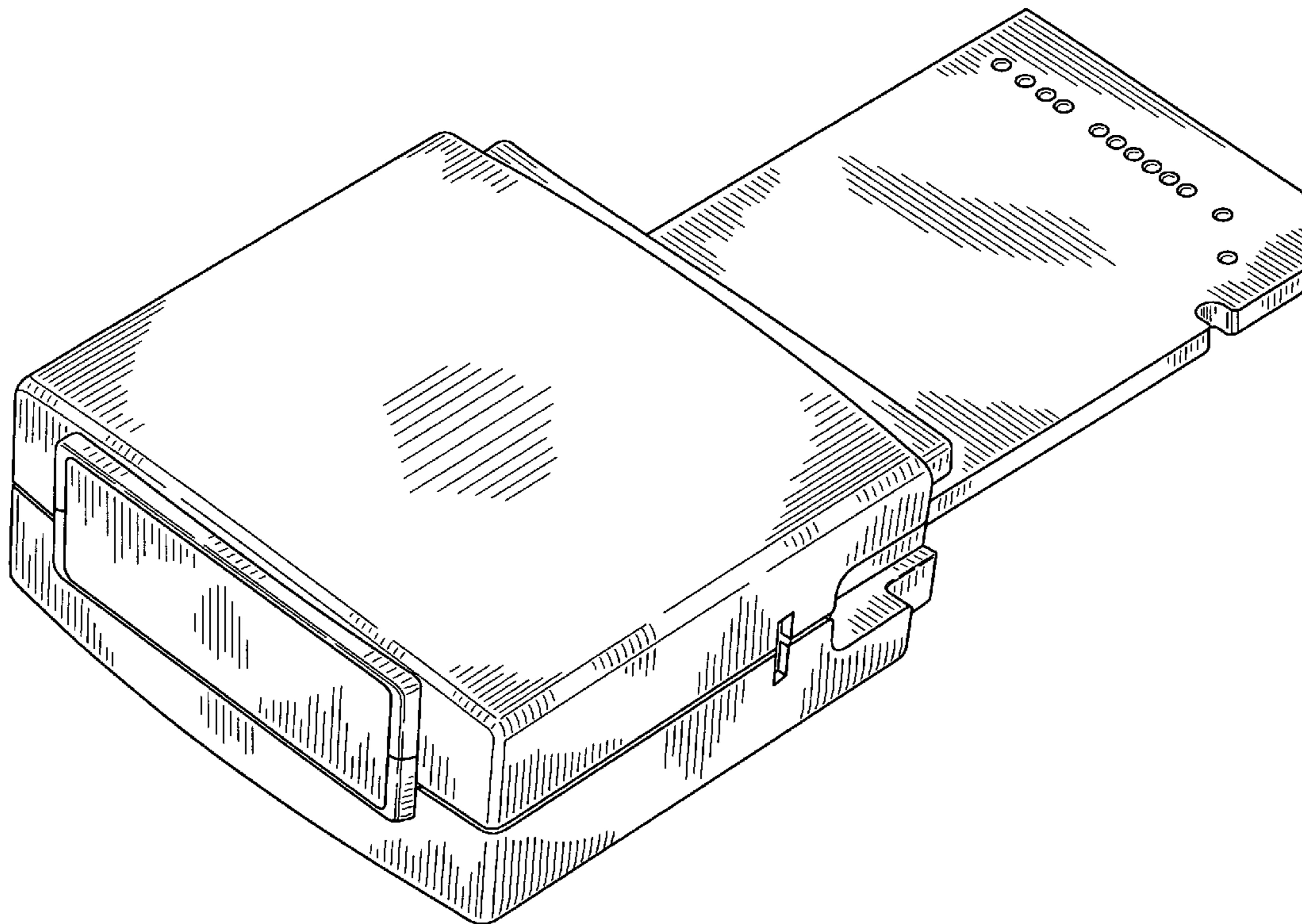
FIG. 5 shows a left side elevation view thereof;

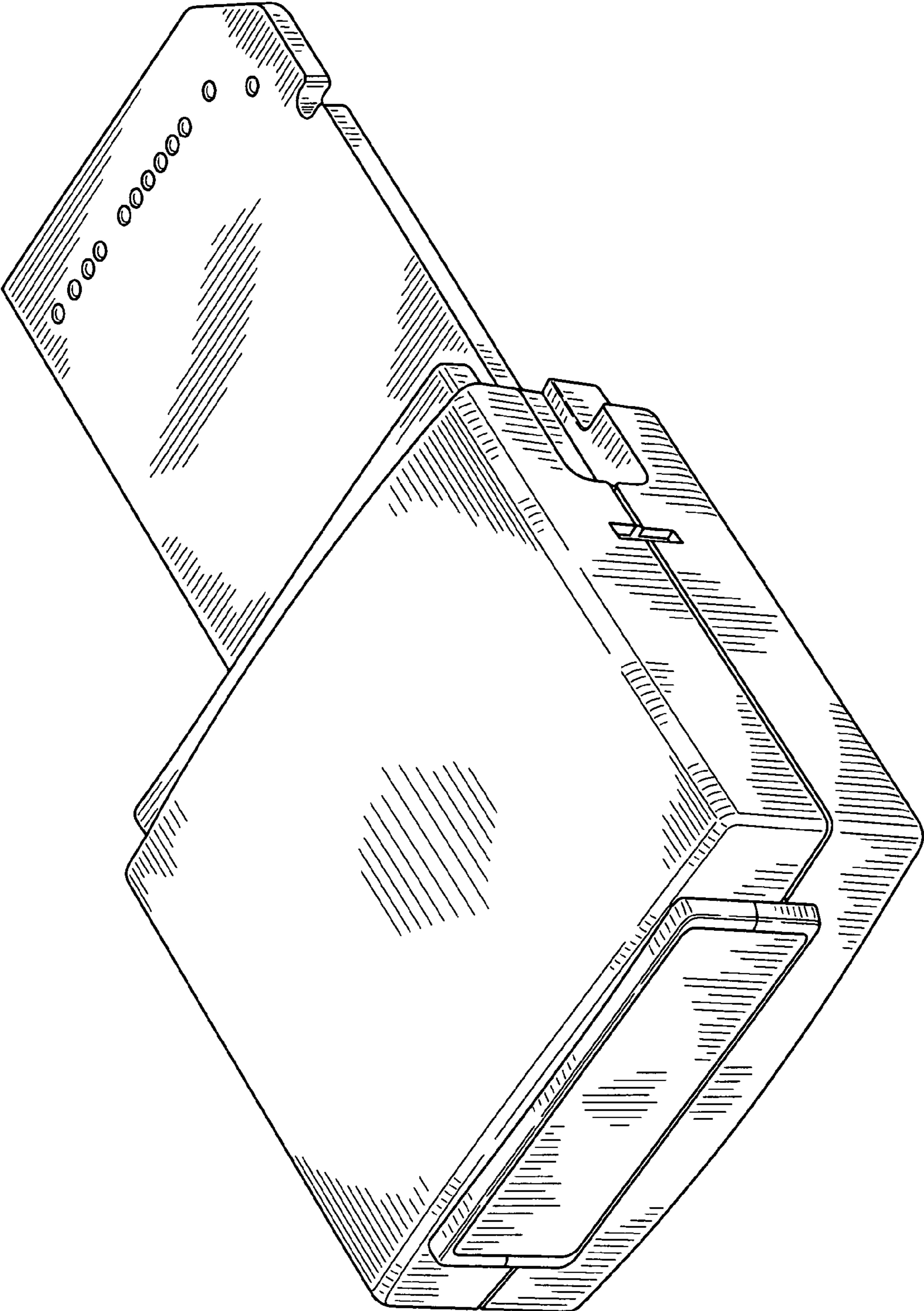

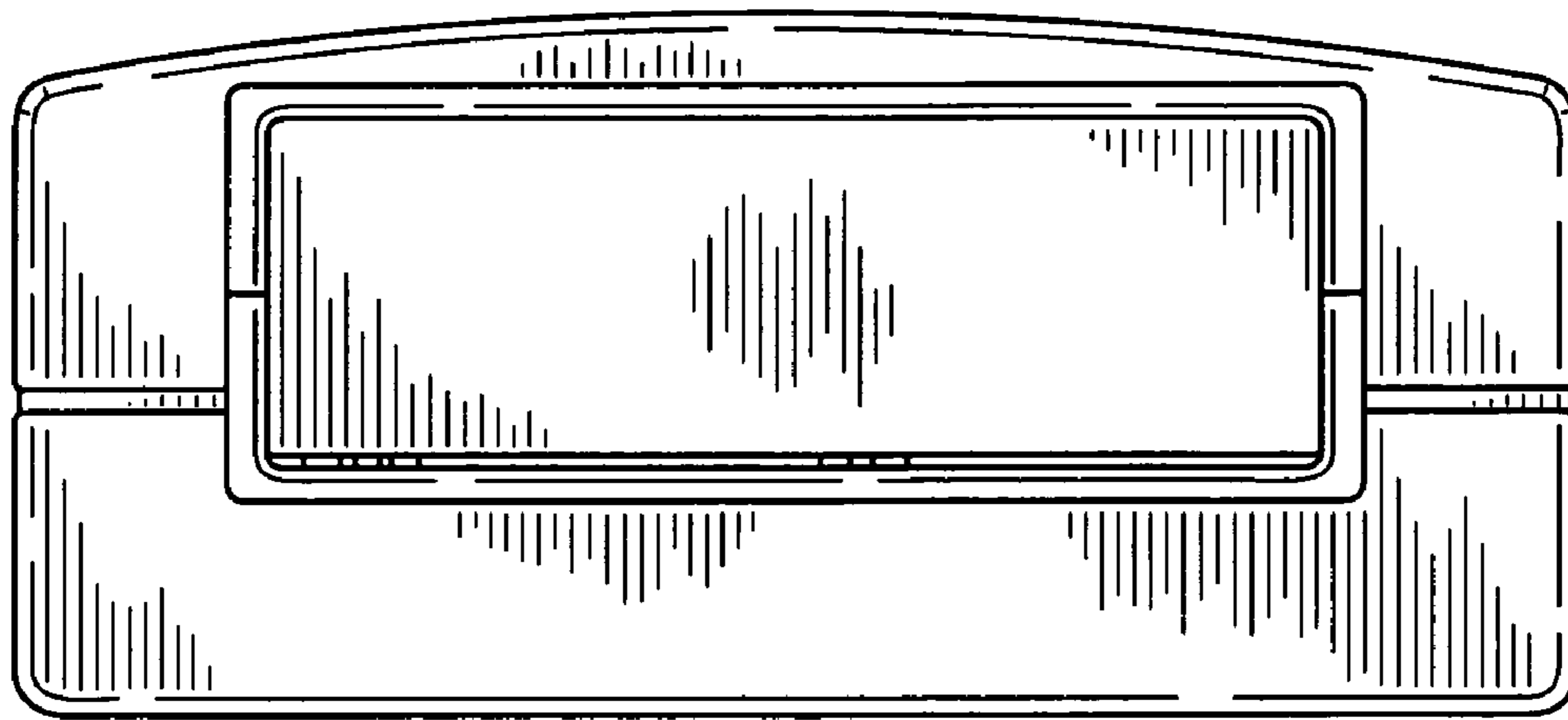

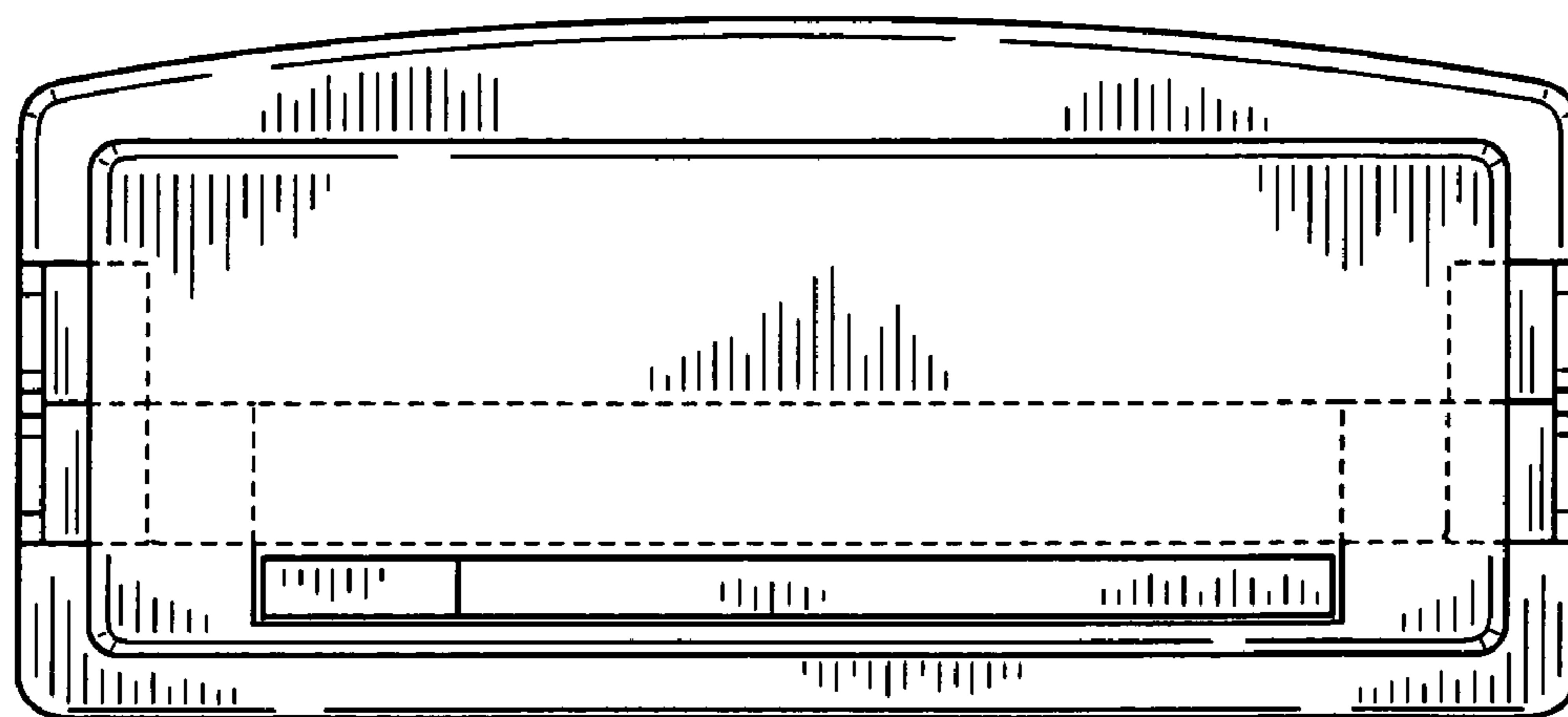

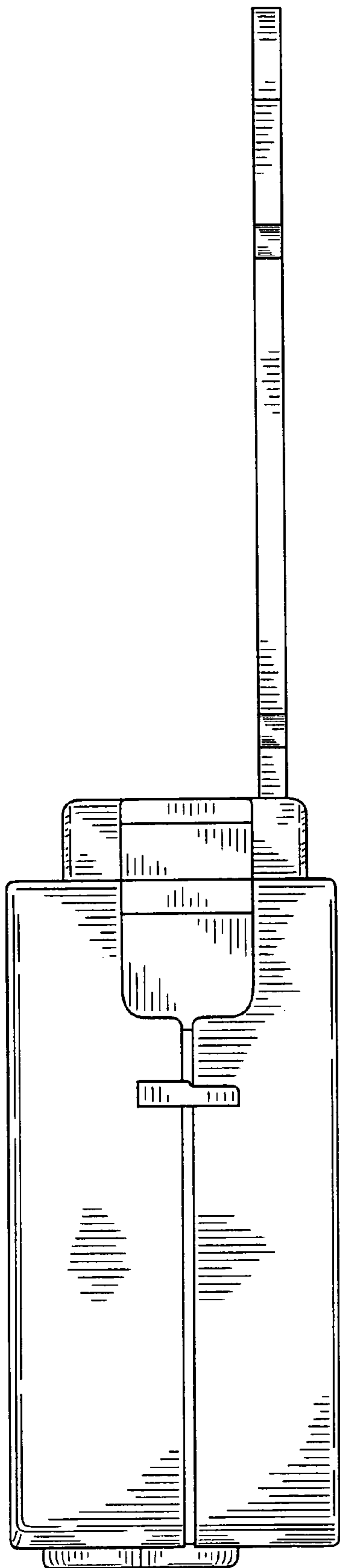

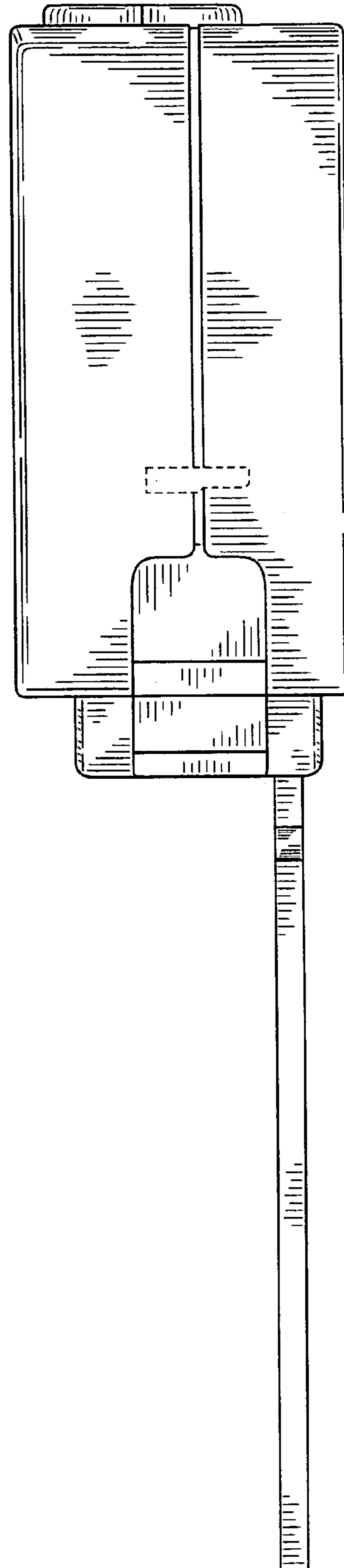

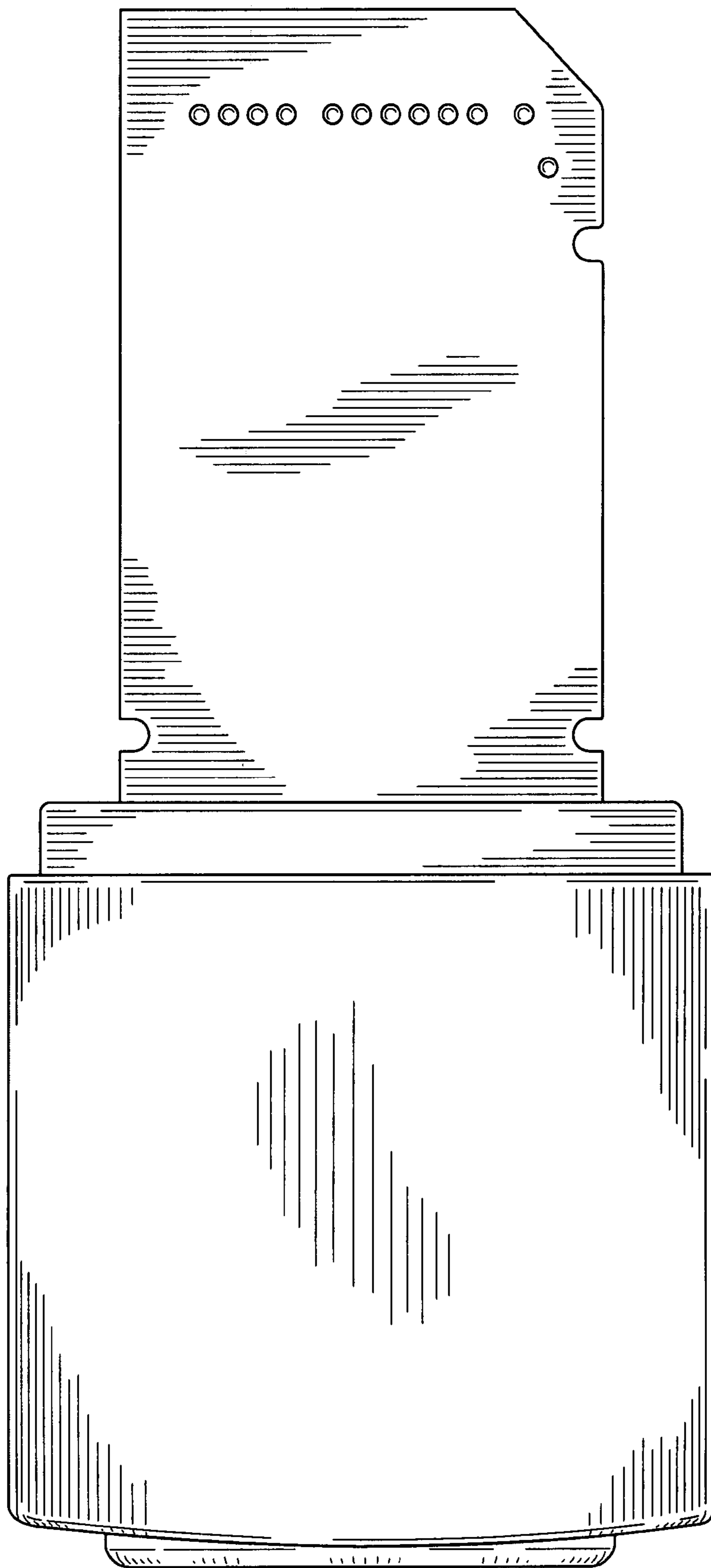

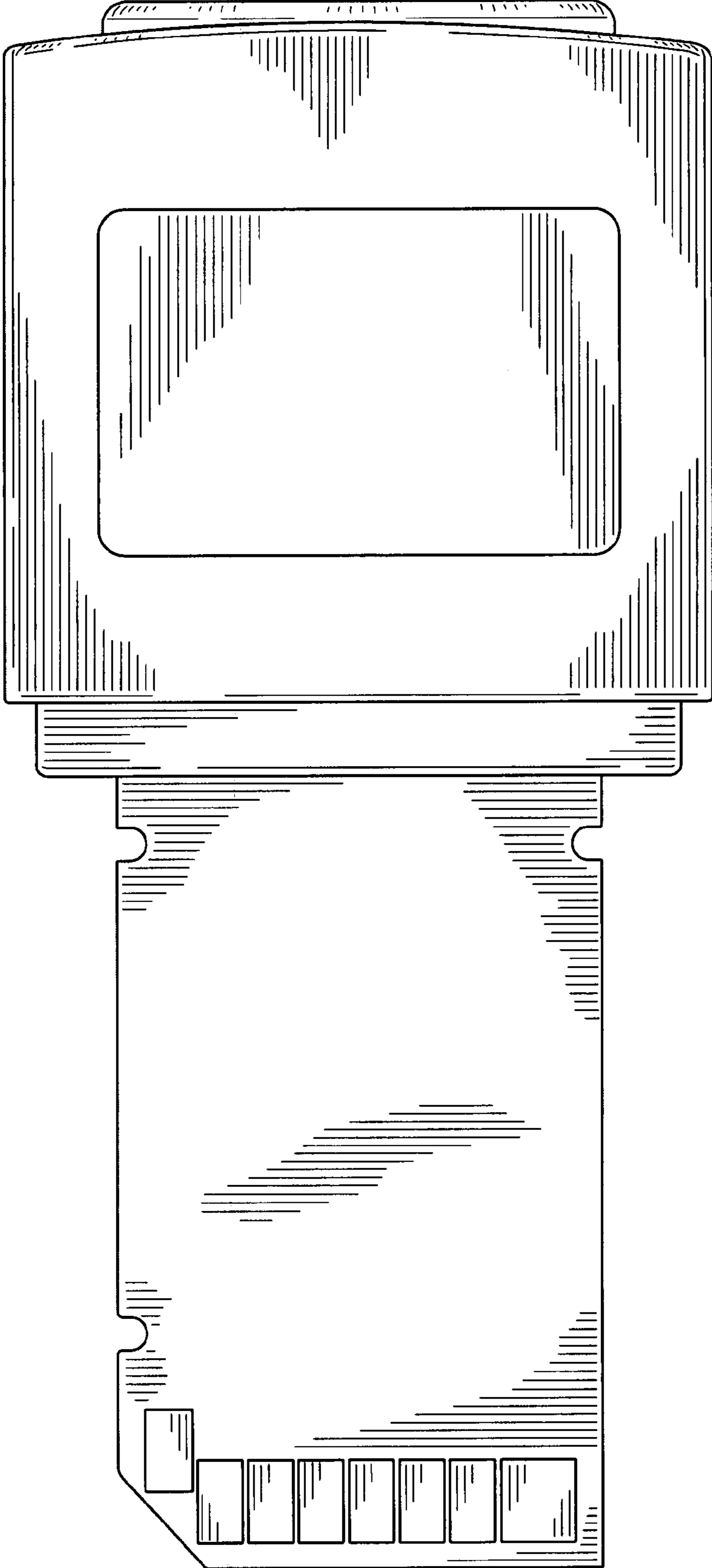
