DESCRIPTION

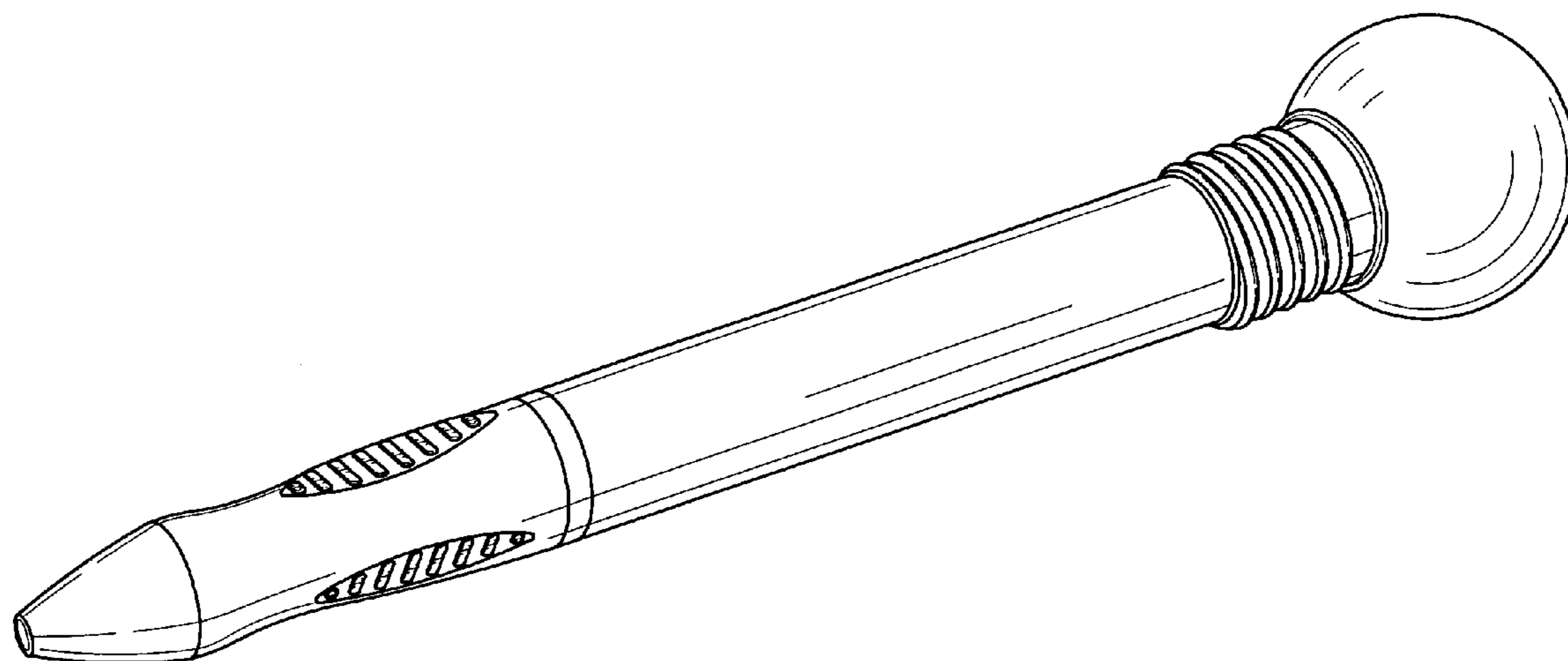
FIG. 1 is a perspective view showing the top, front and left side of the ball pen showing my new design.

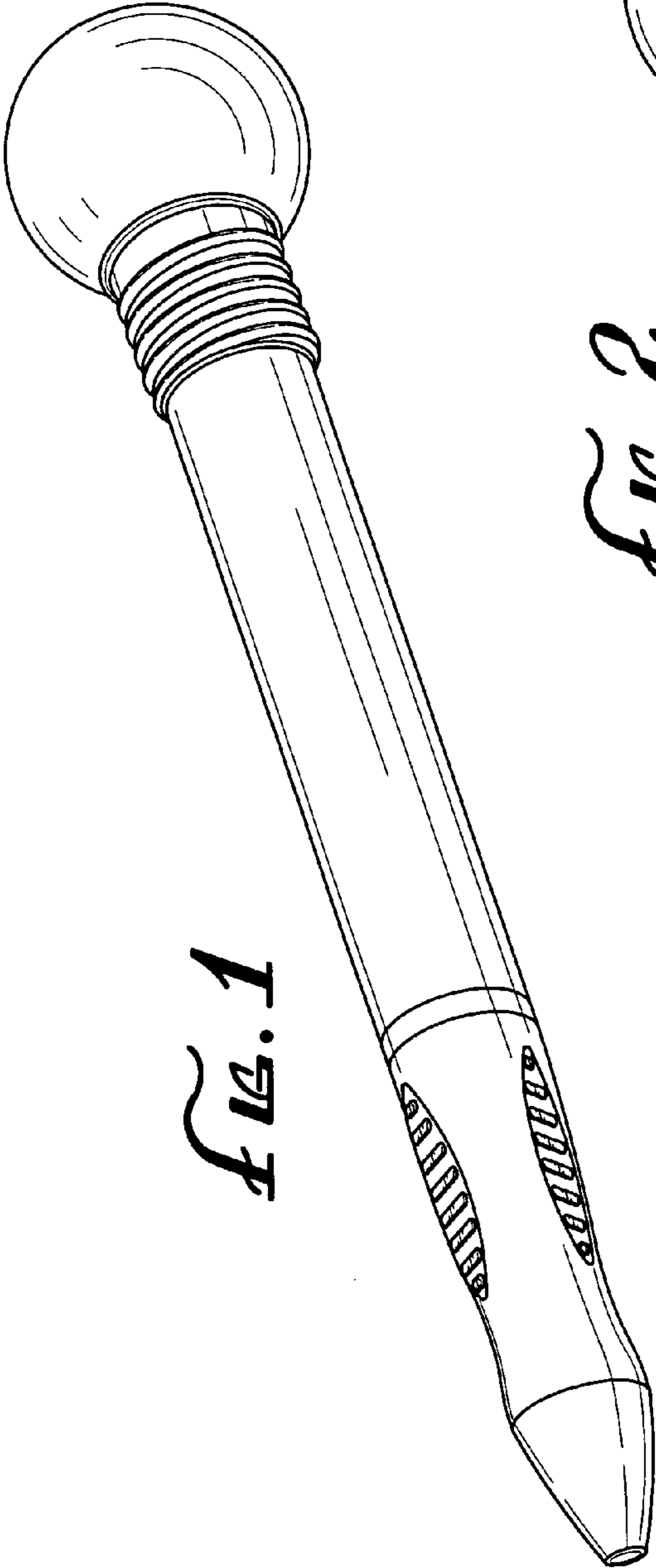

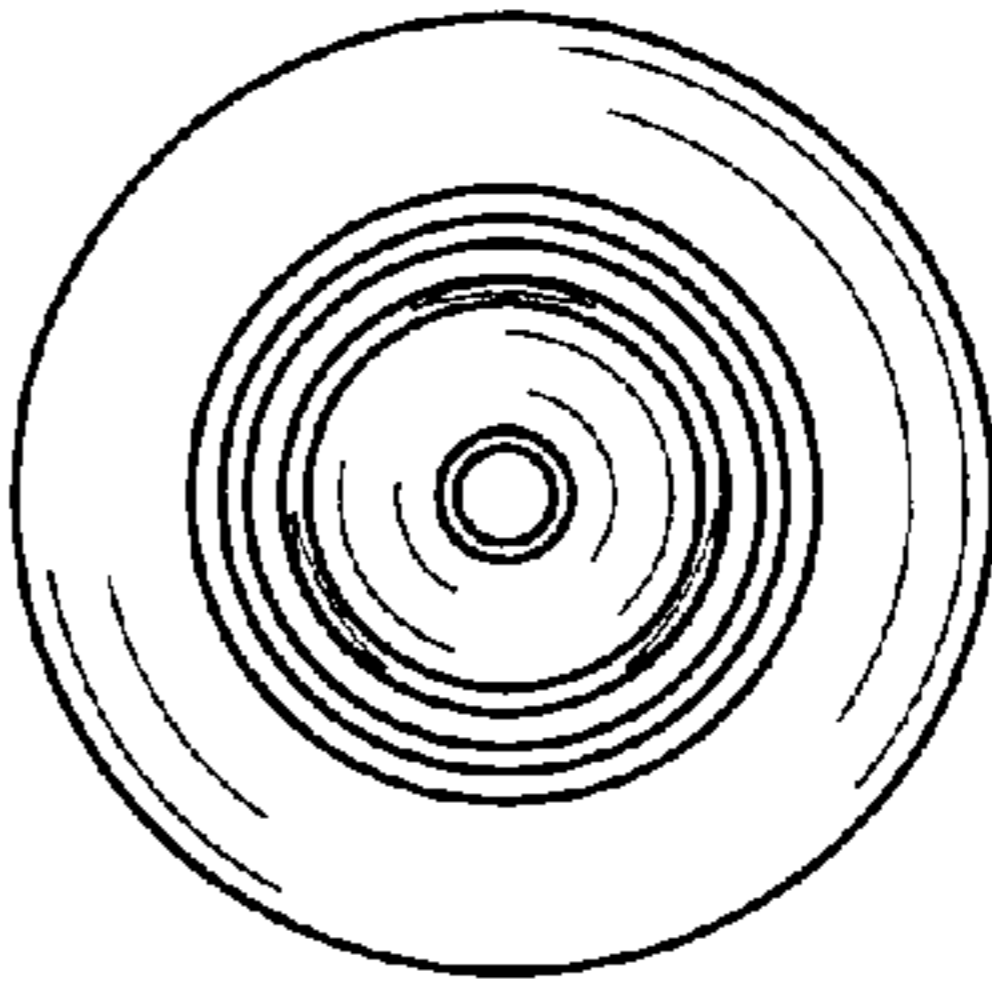
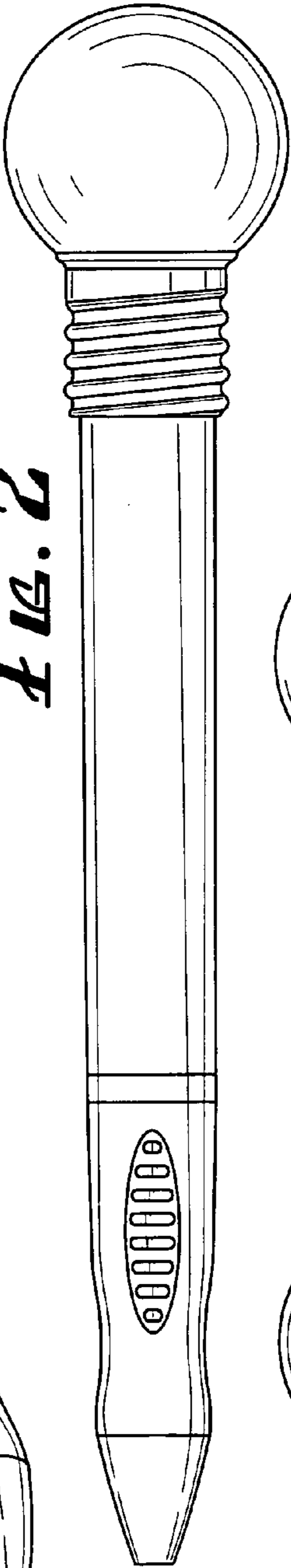

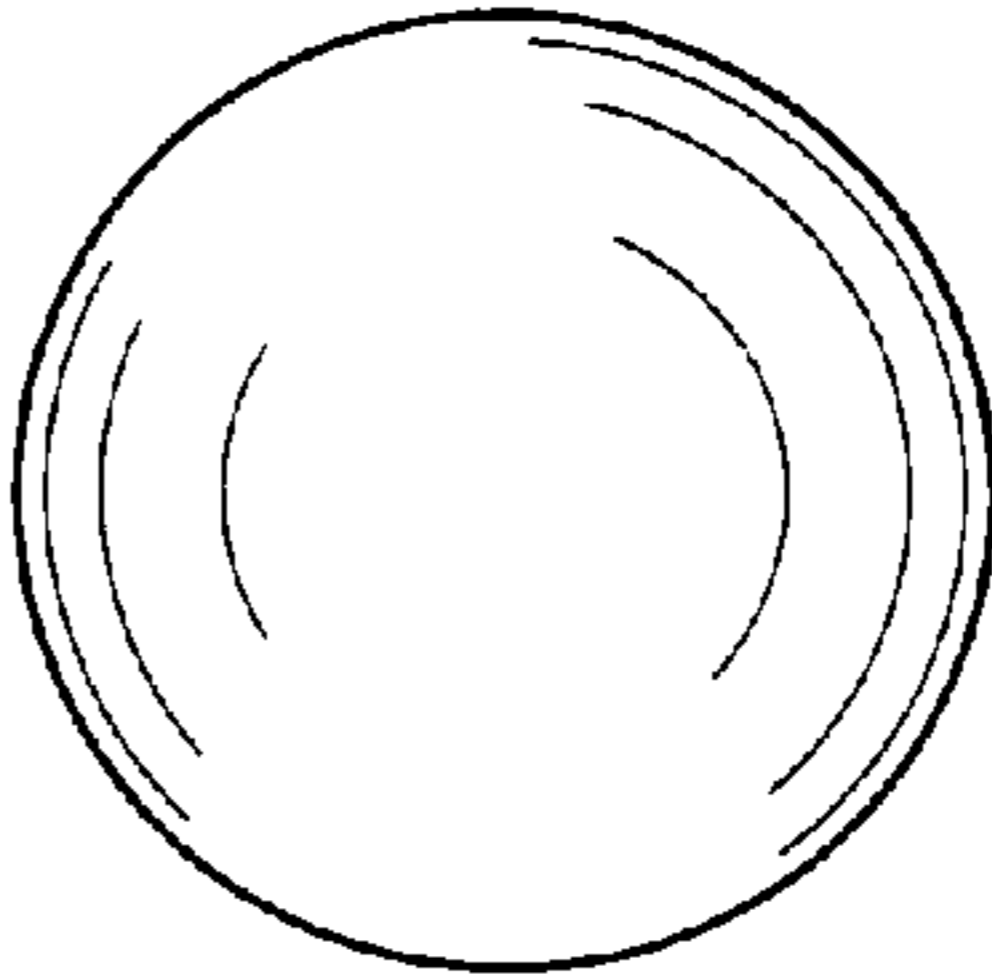
