FIG. 4 shows an enlarged side view thereof;

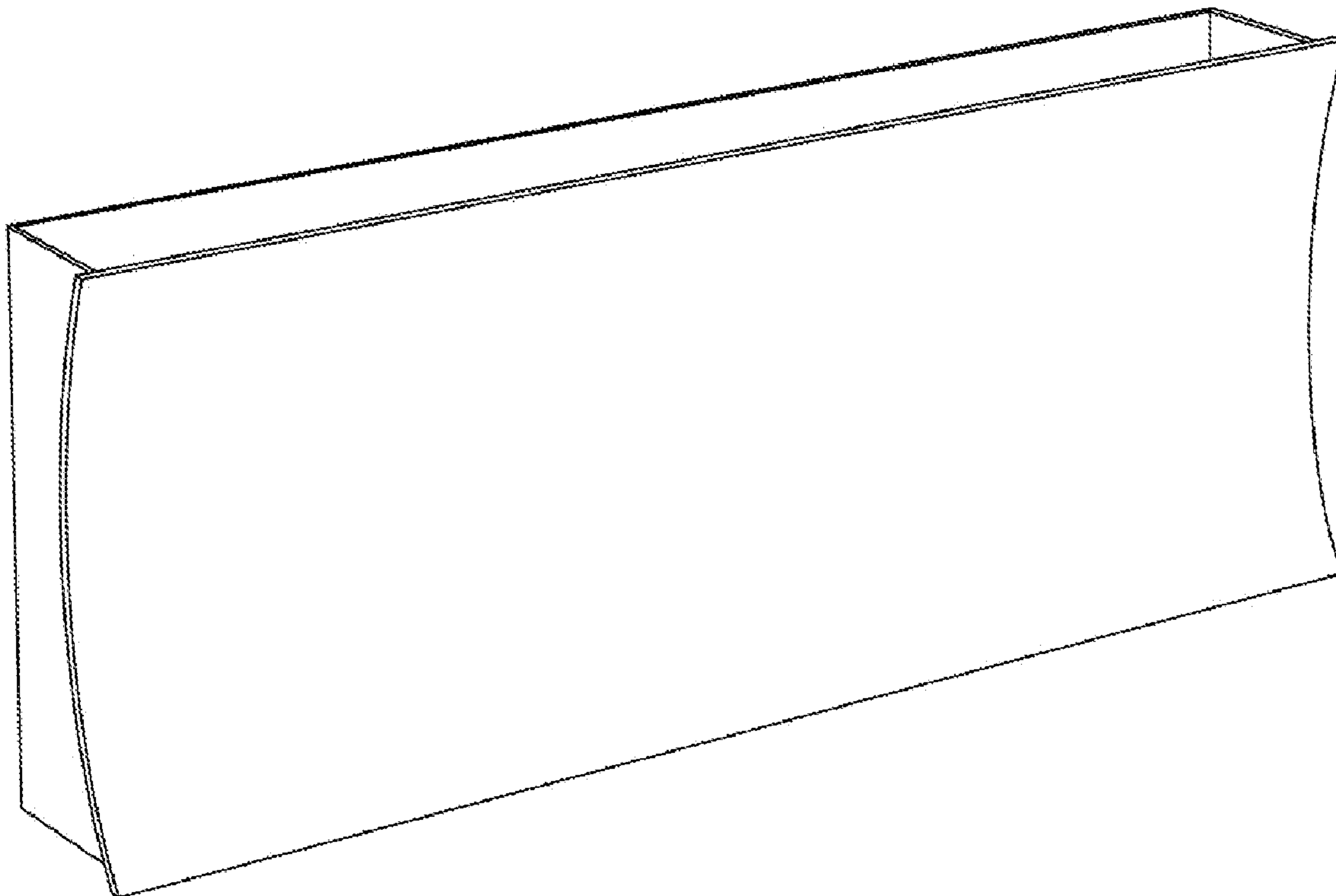
FIG. 5 shows an enlarged opposite side view of the design as shown in FIG. 4, and

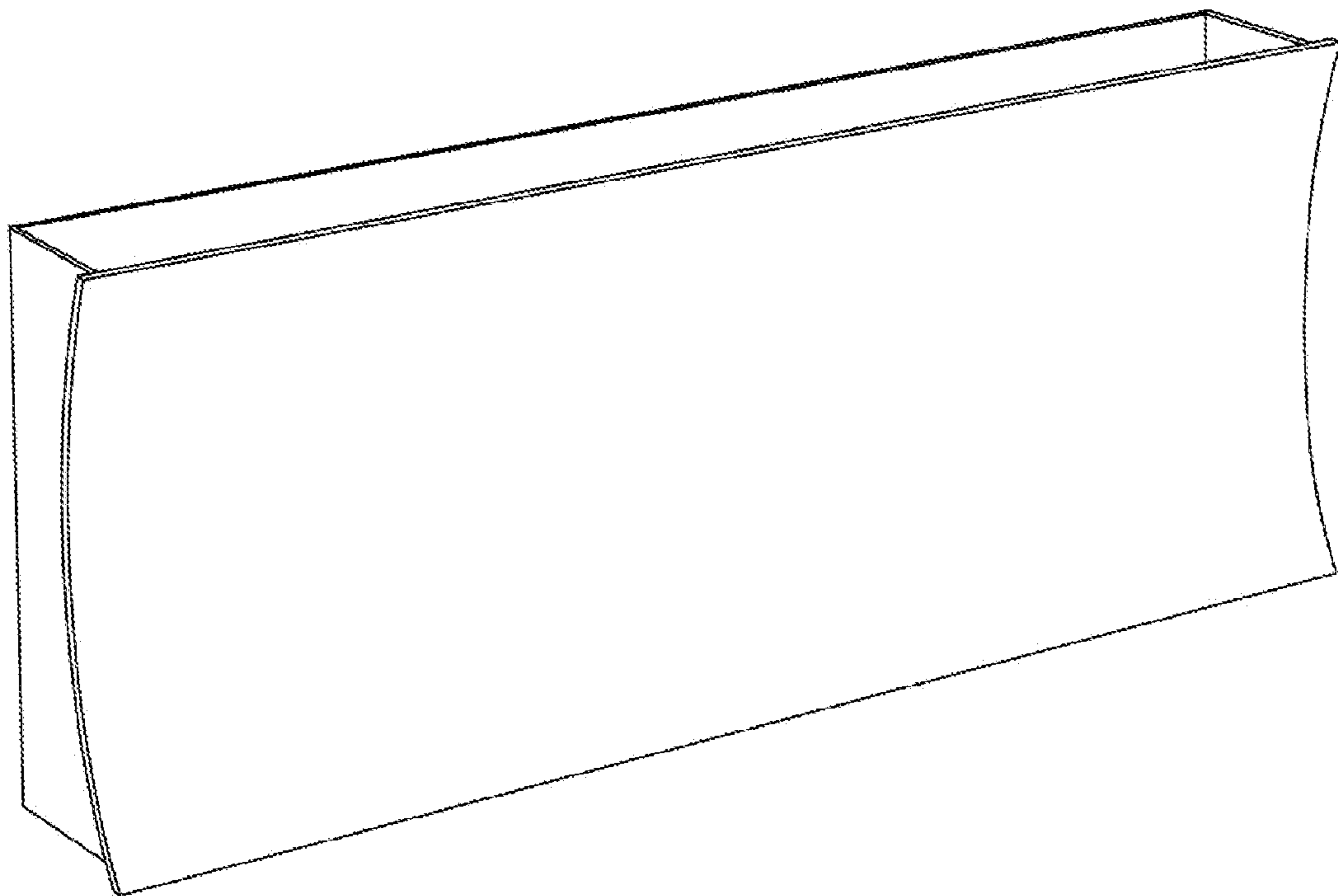

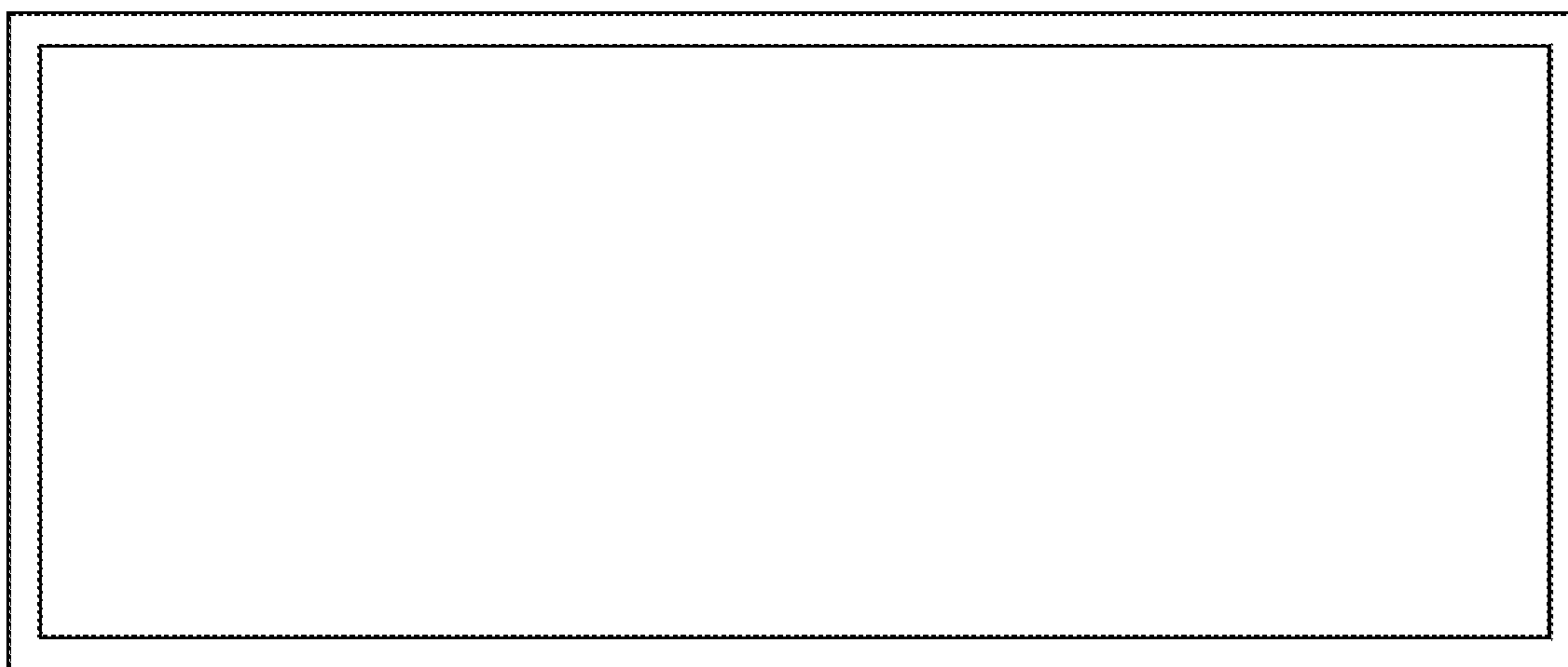

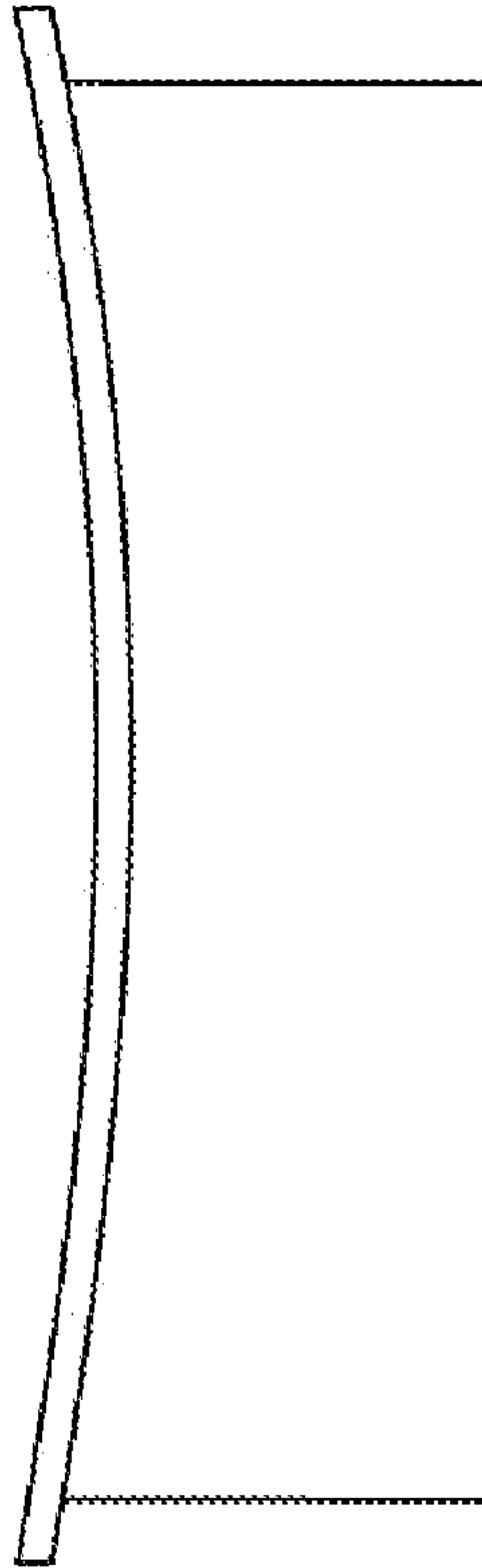

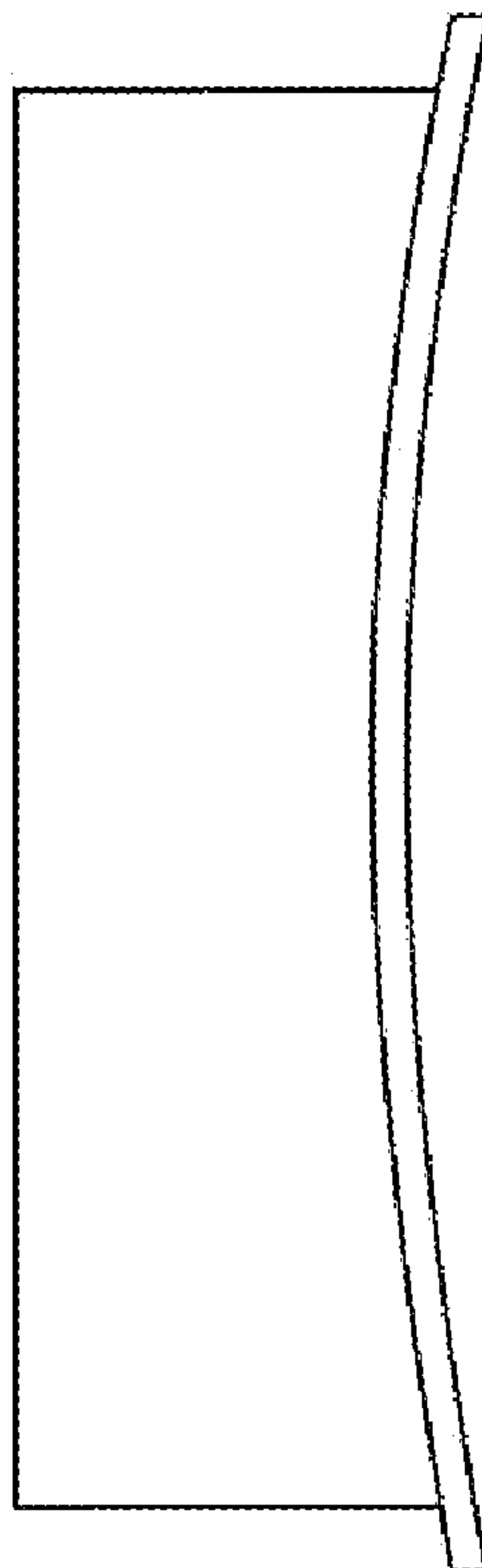

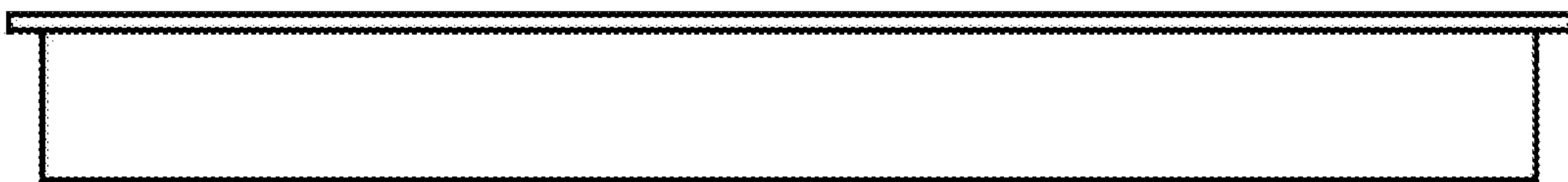
