FIG. 6 is a side perspective view; and,

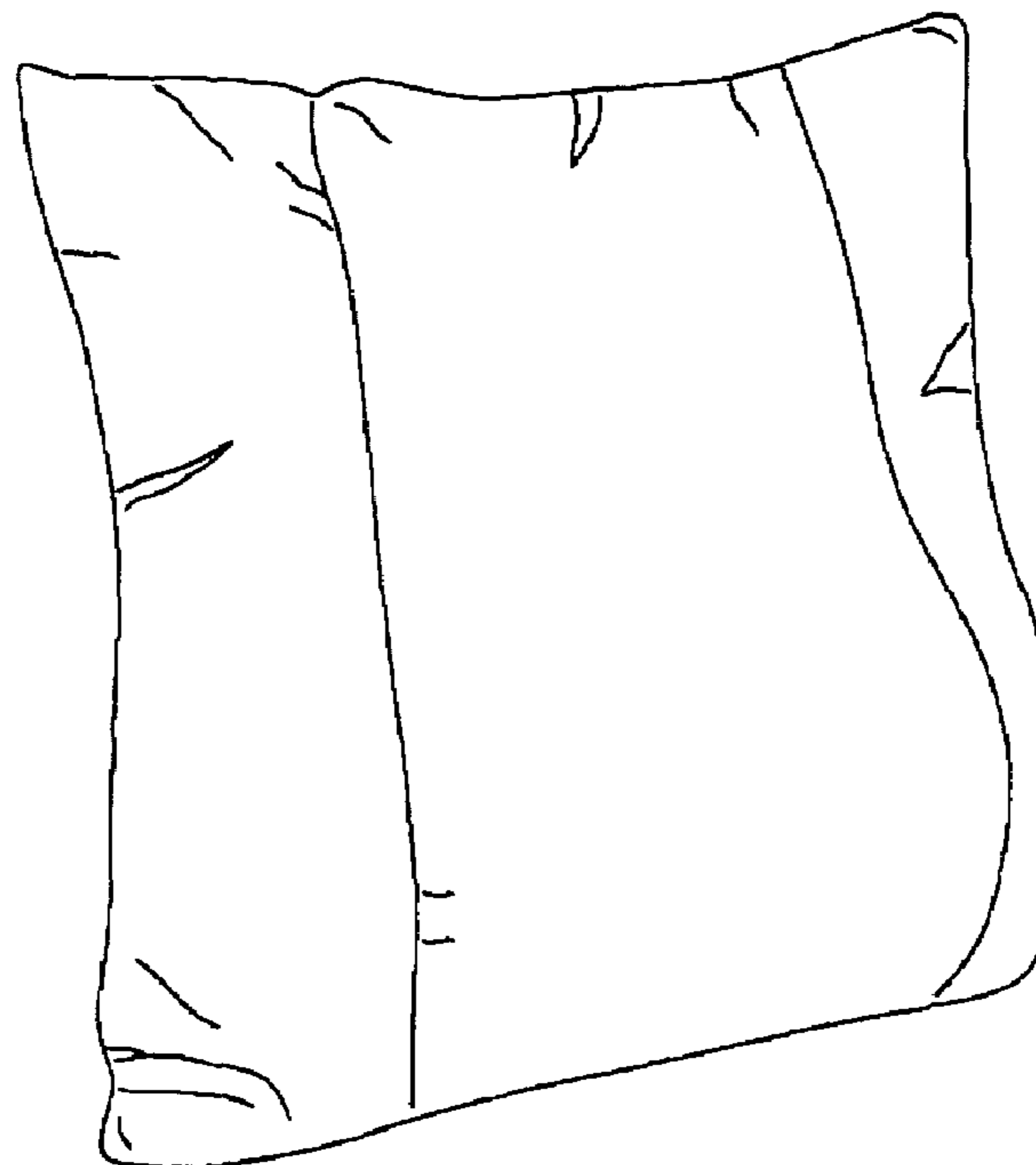
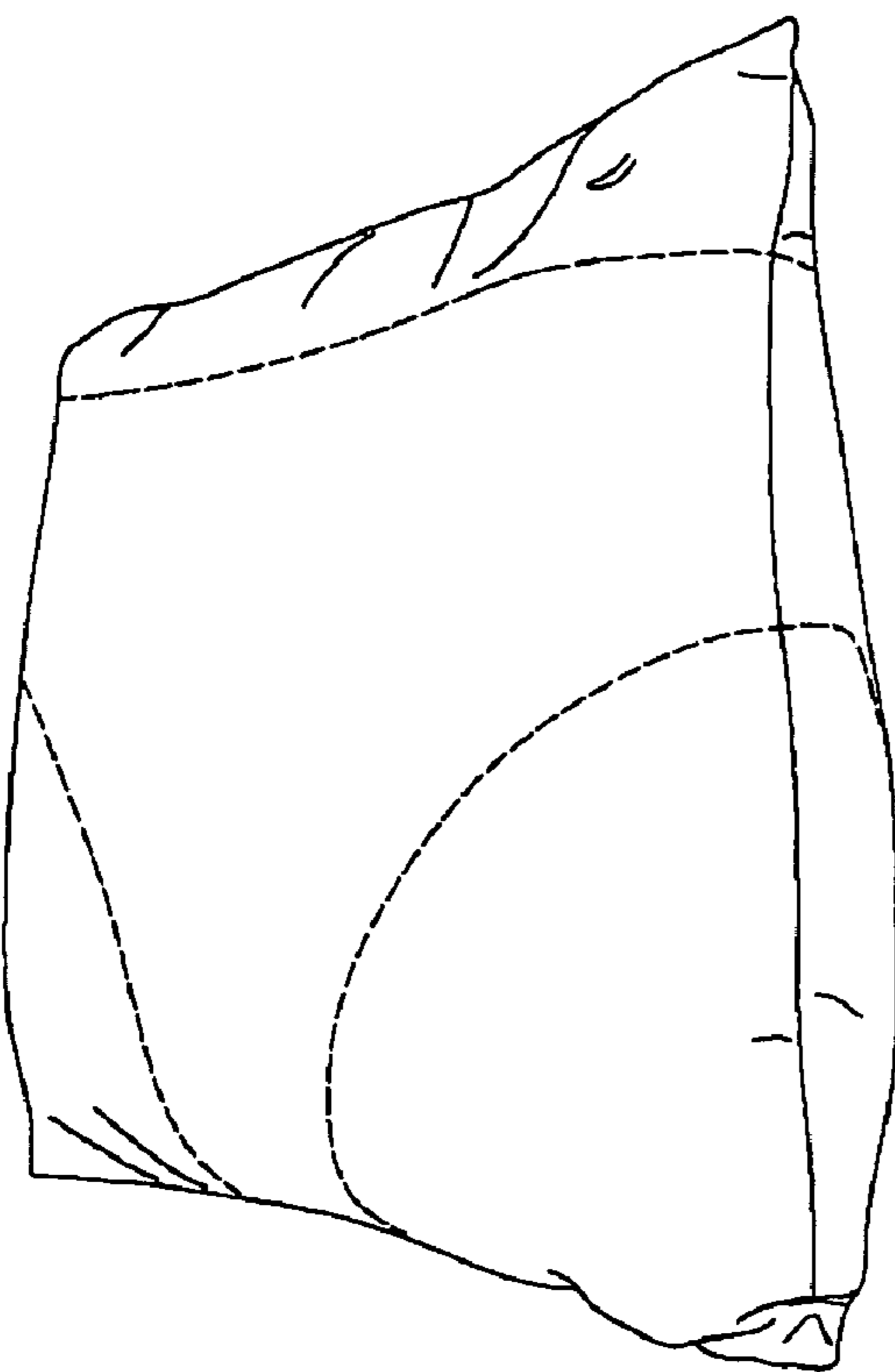
FIG. 7 is a side elevational view.

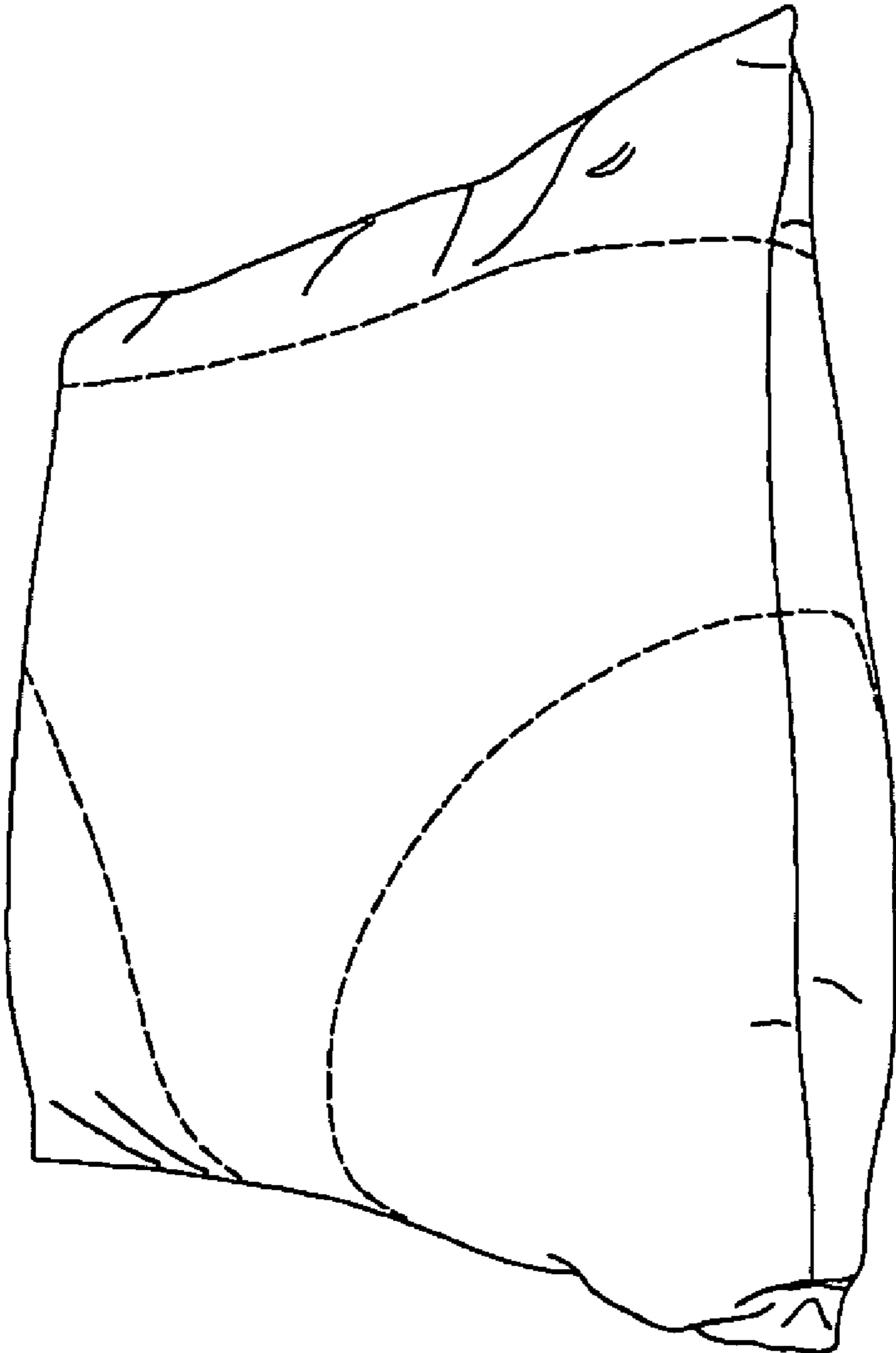

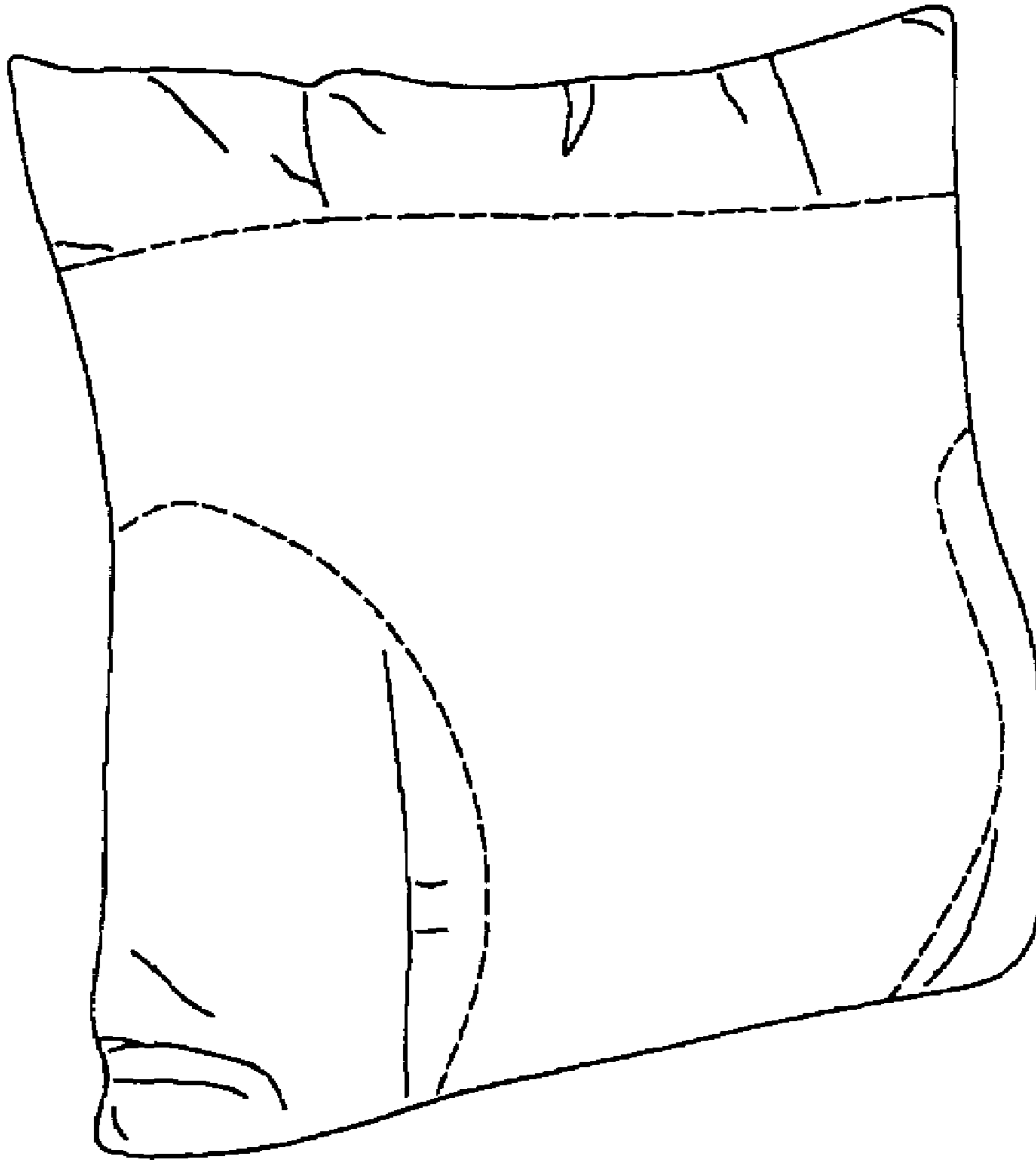

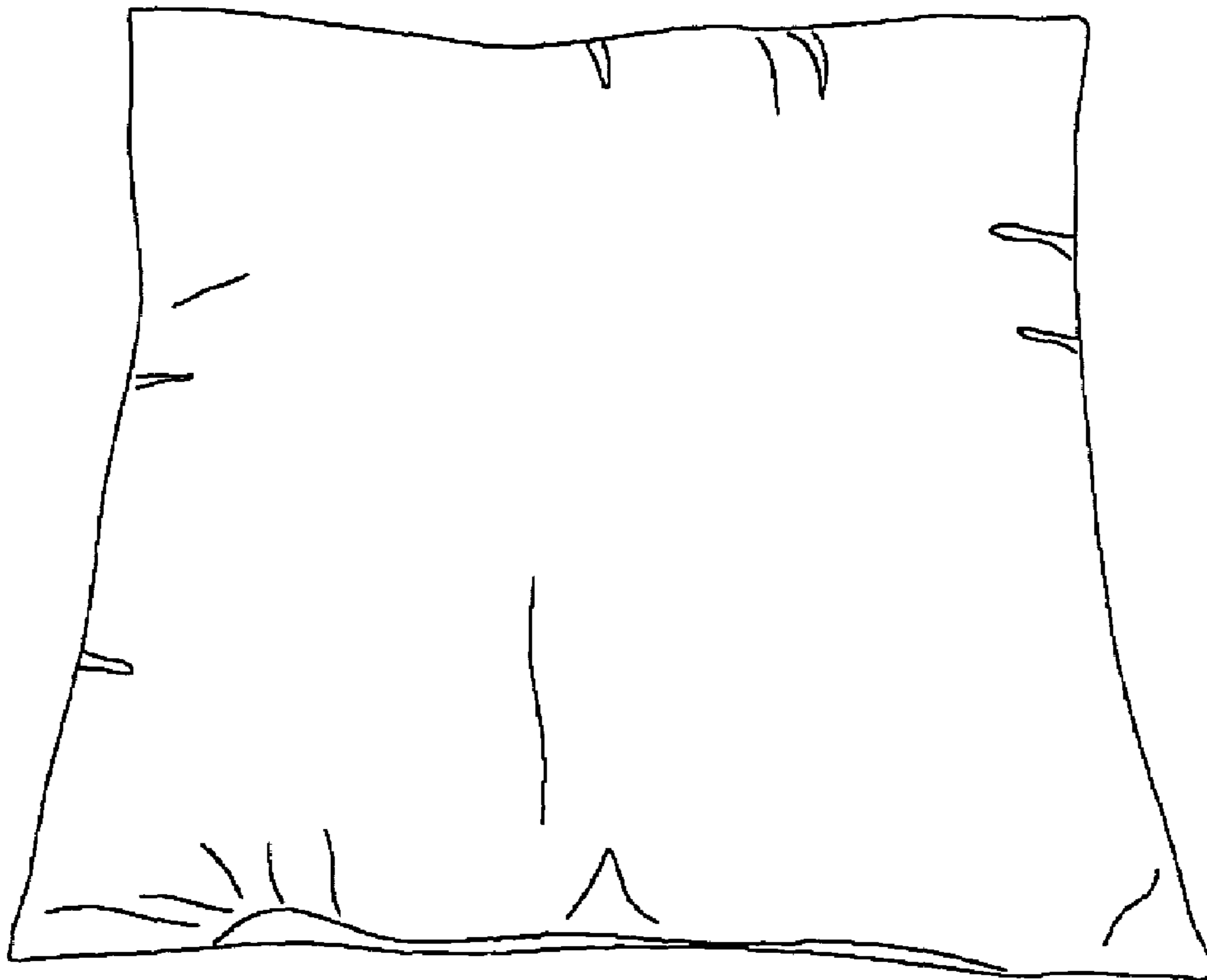

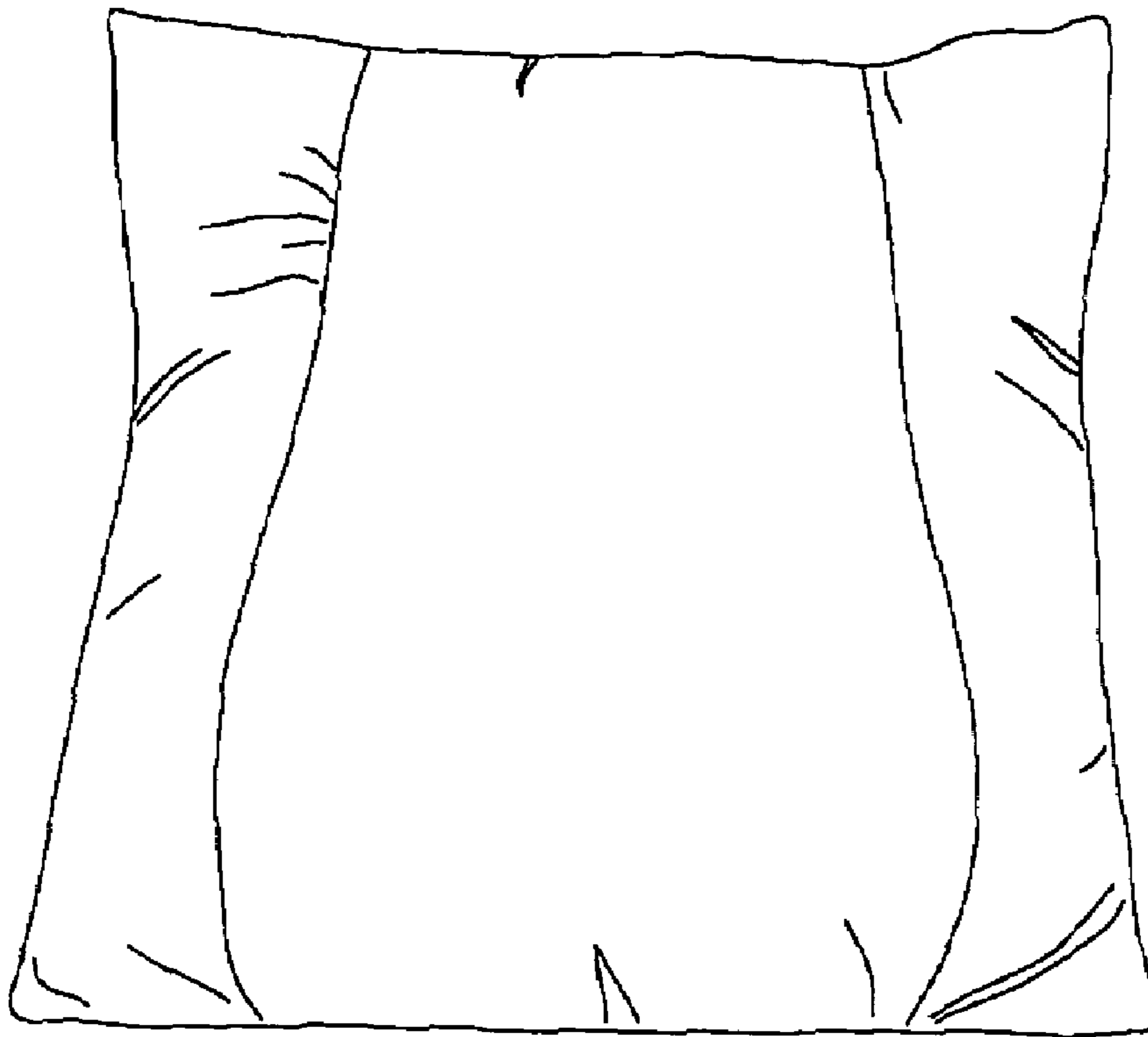

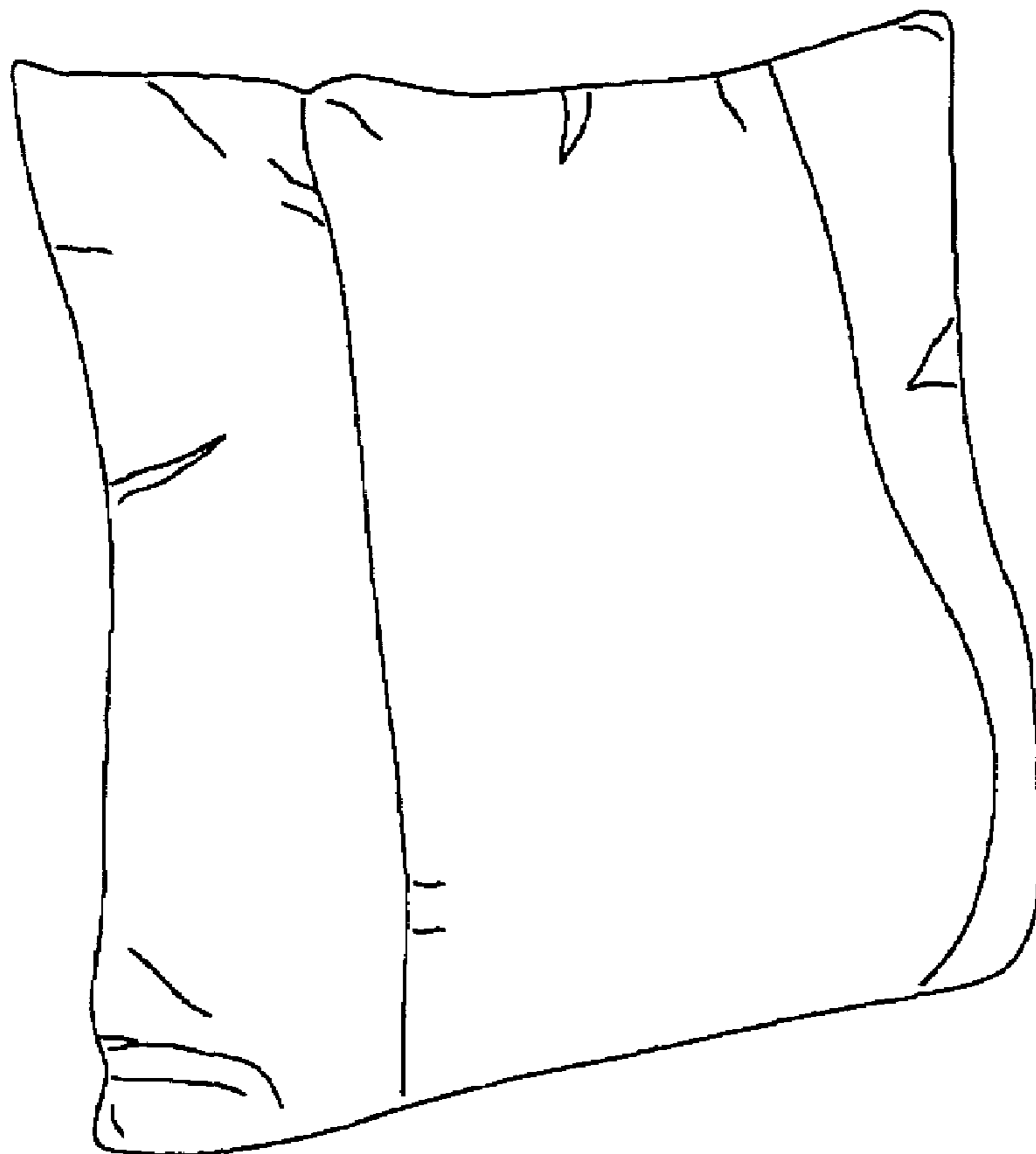

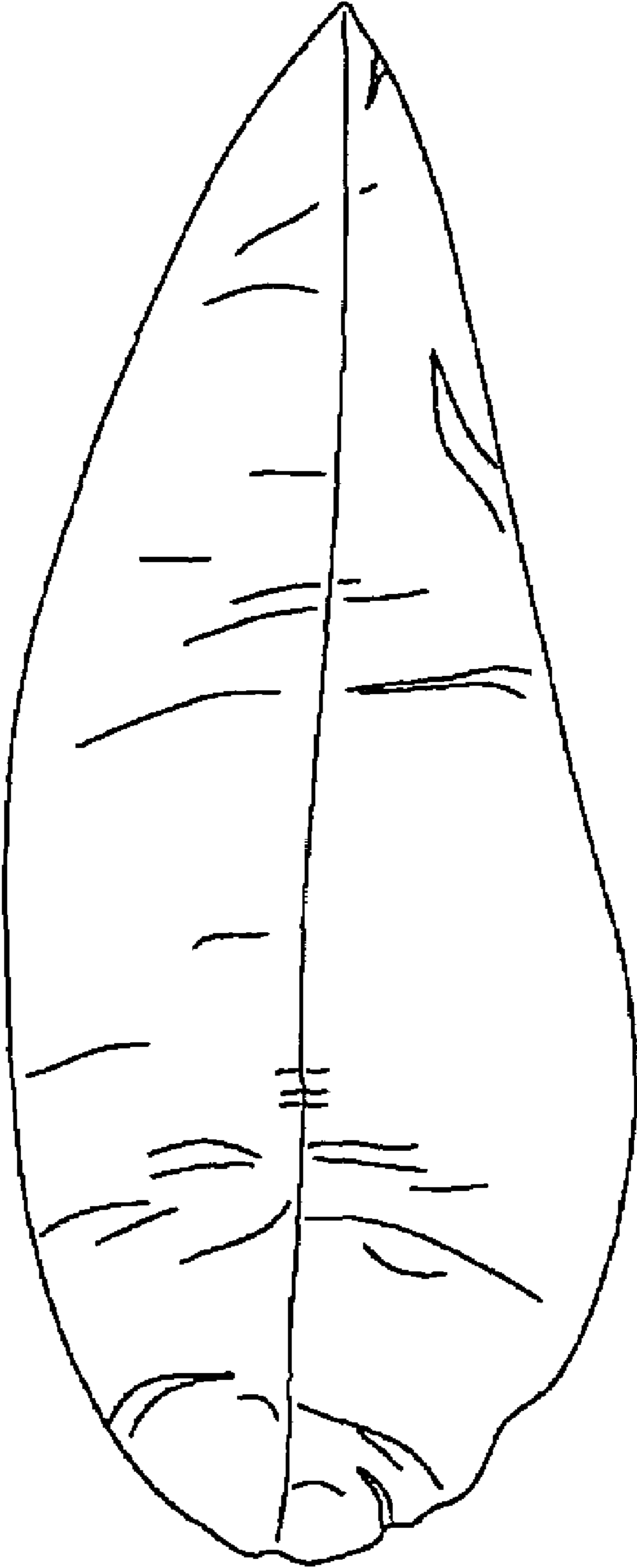
