FIG. 1 is a top view of the novelty soccer ball showing my new design;

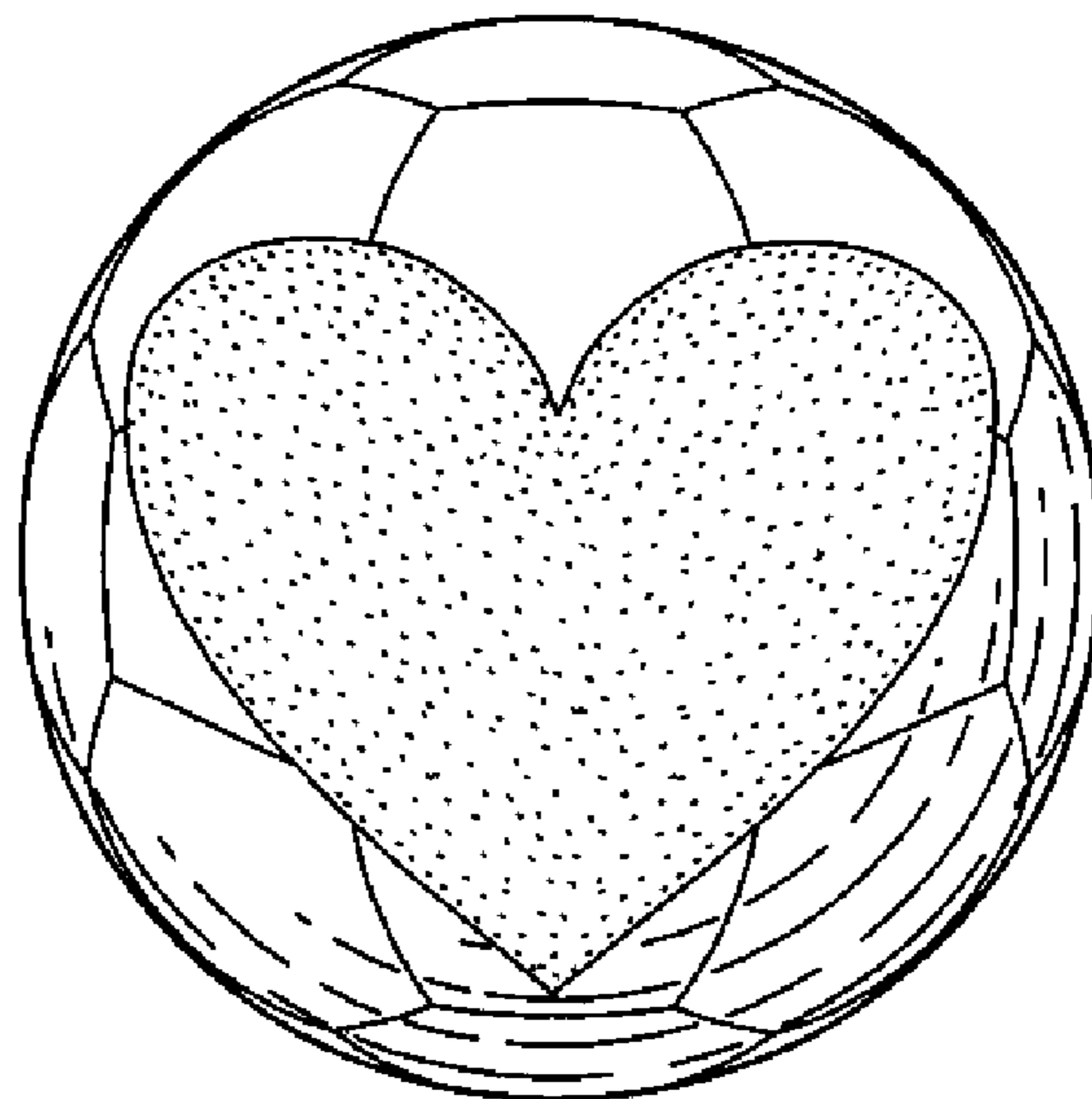
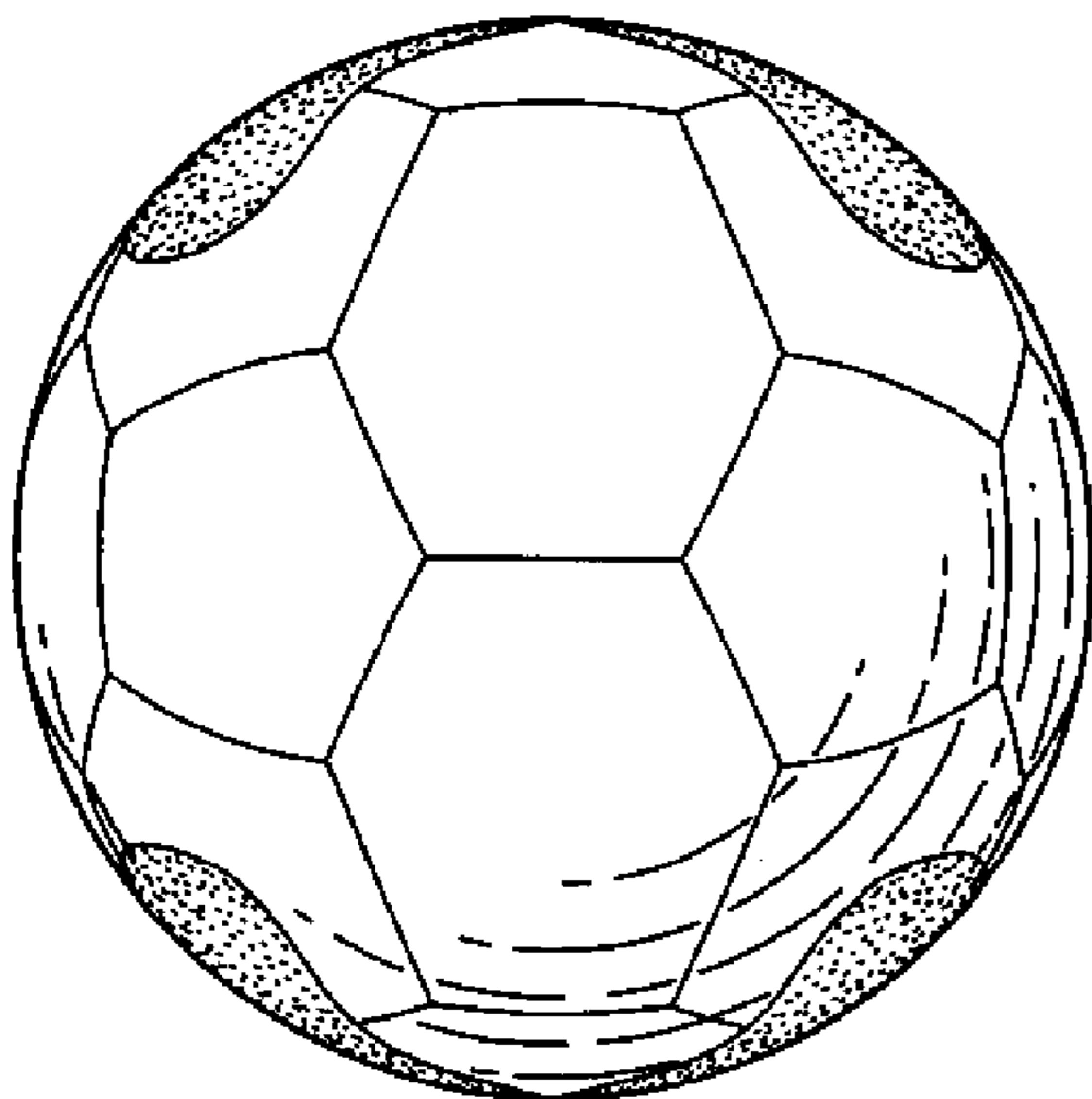
FIG. 2 is a front view thereof;

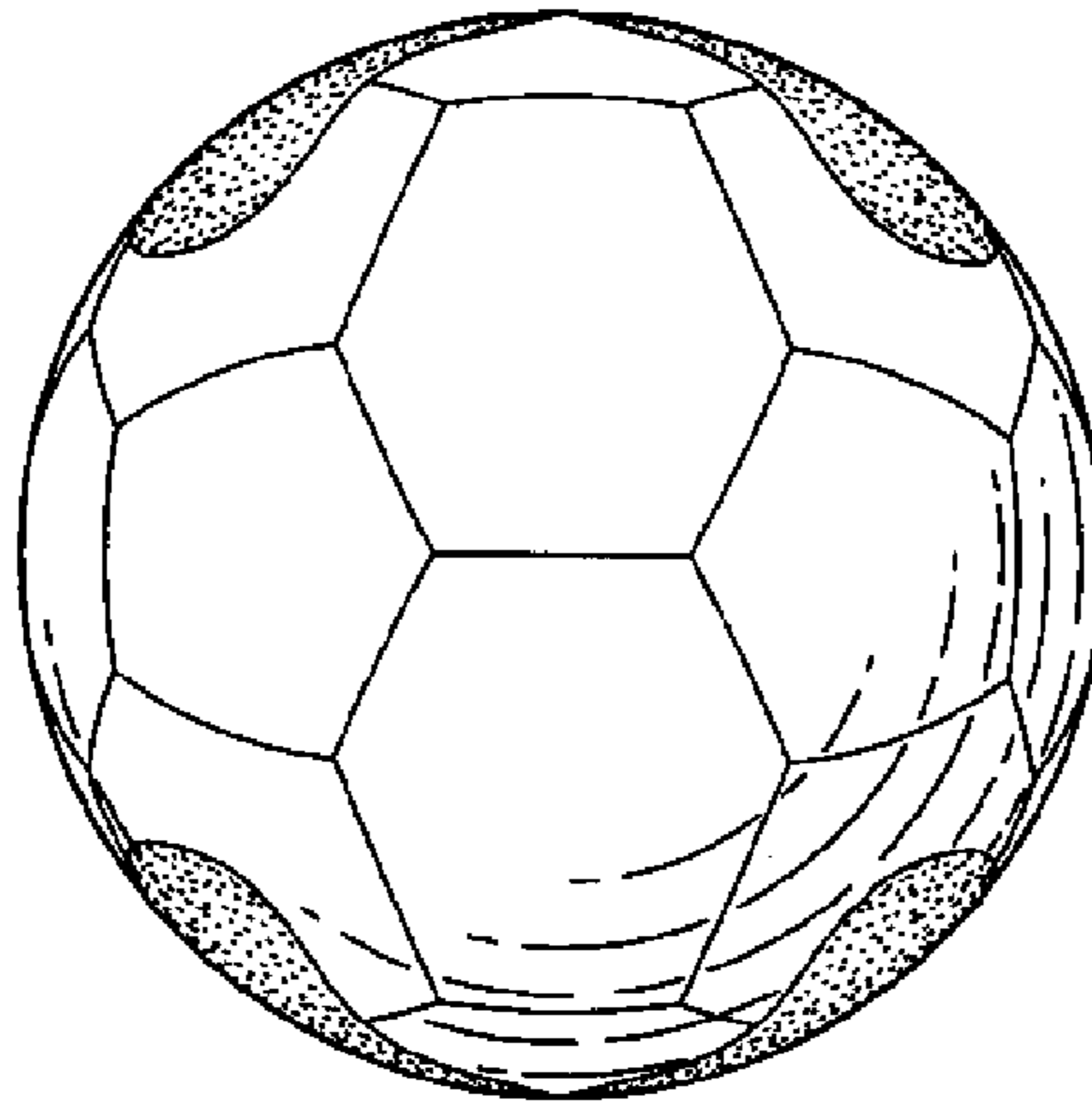
FIG. 3 is a side view thereof, the opposite side being a mirror image thereof;

FIG. 4 is a bottom view thereof; and,

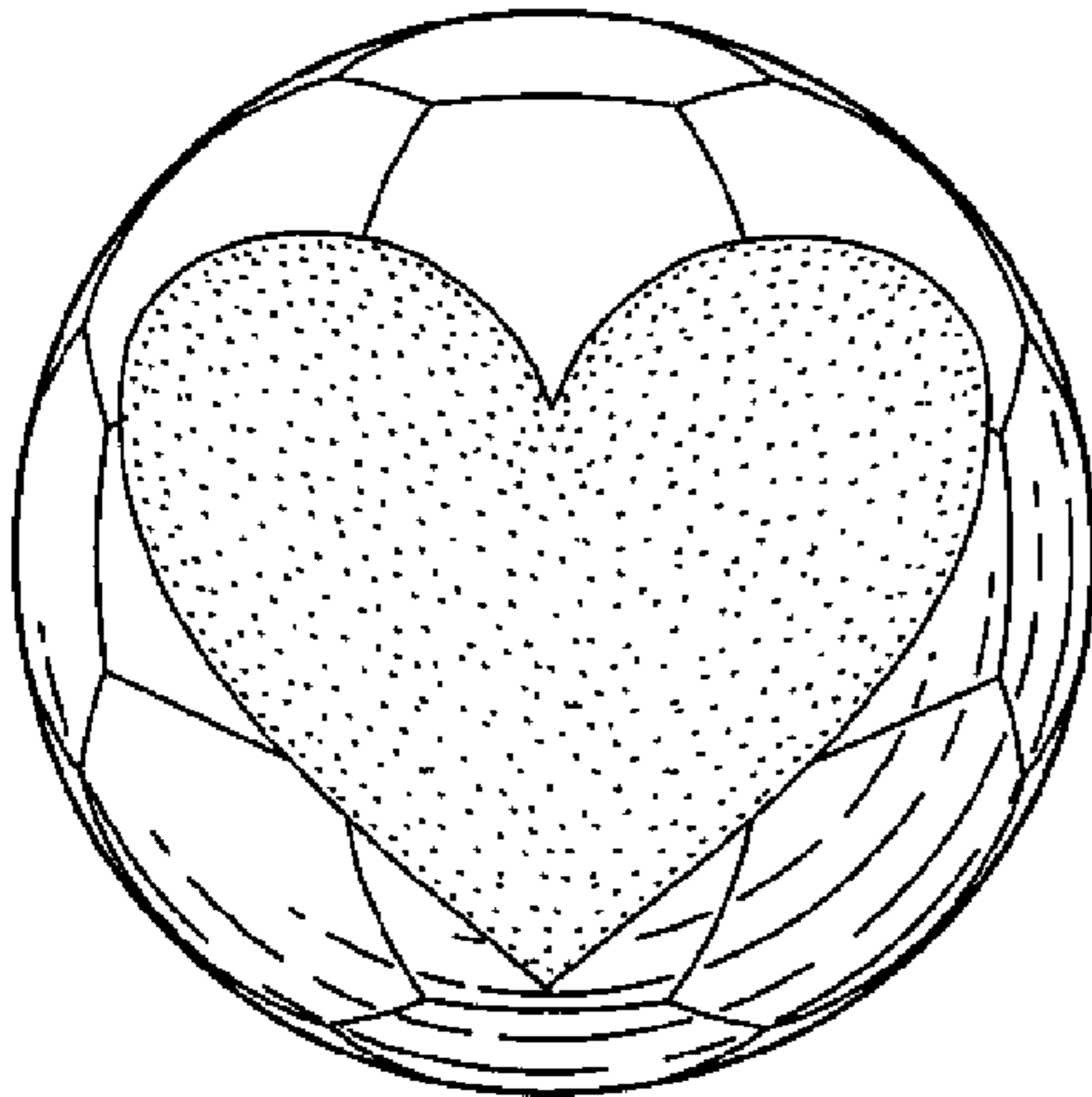
FIG. 5 is a rear view thereof.

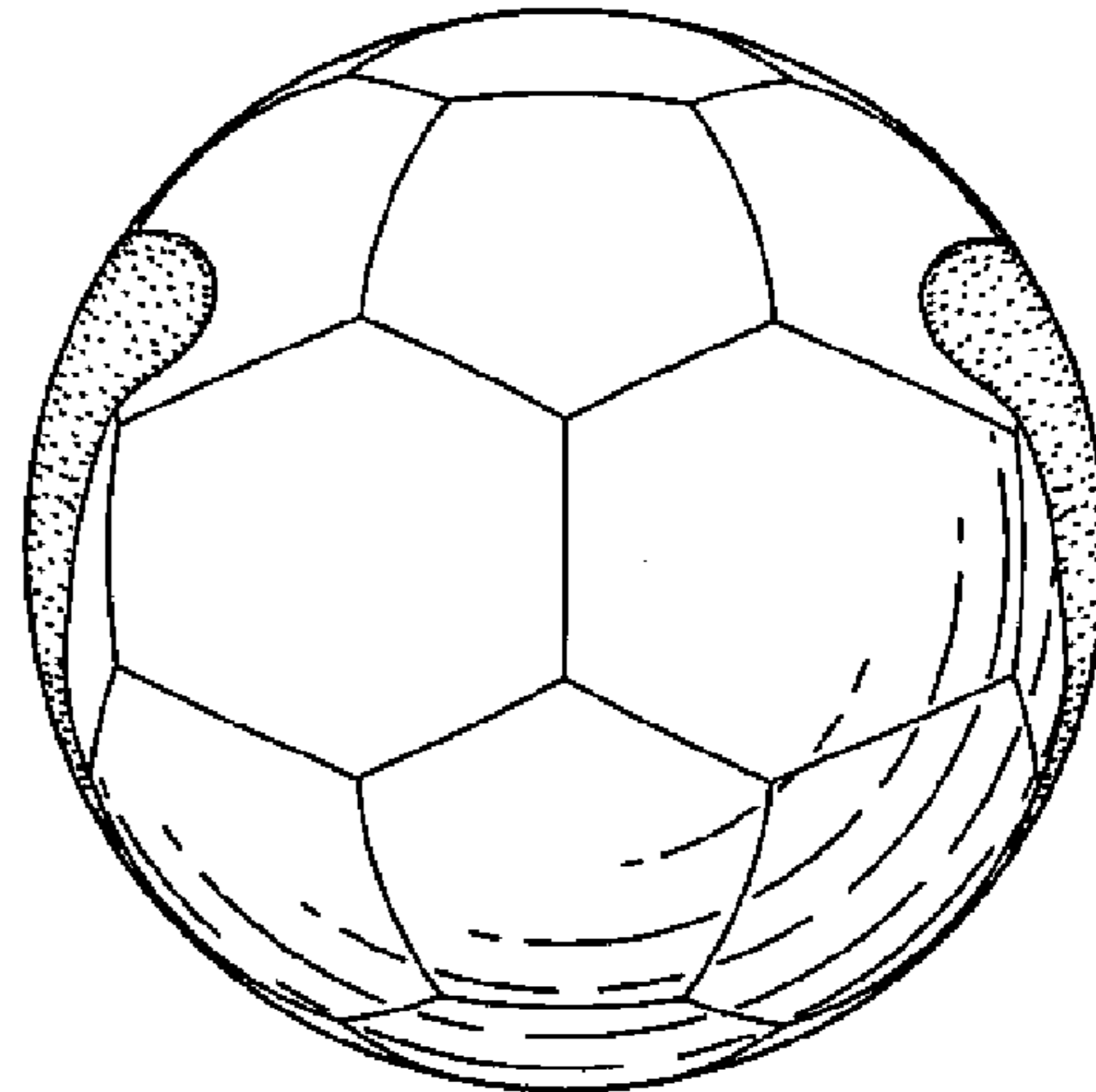




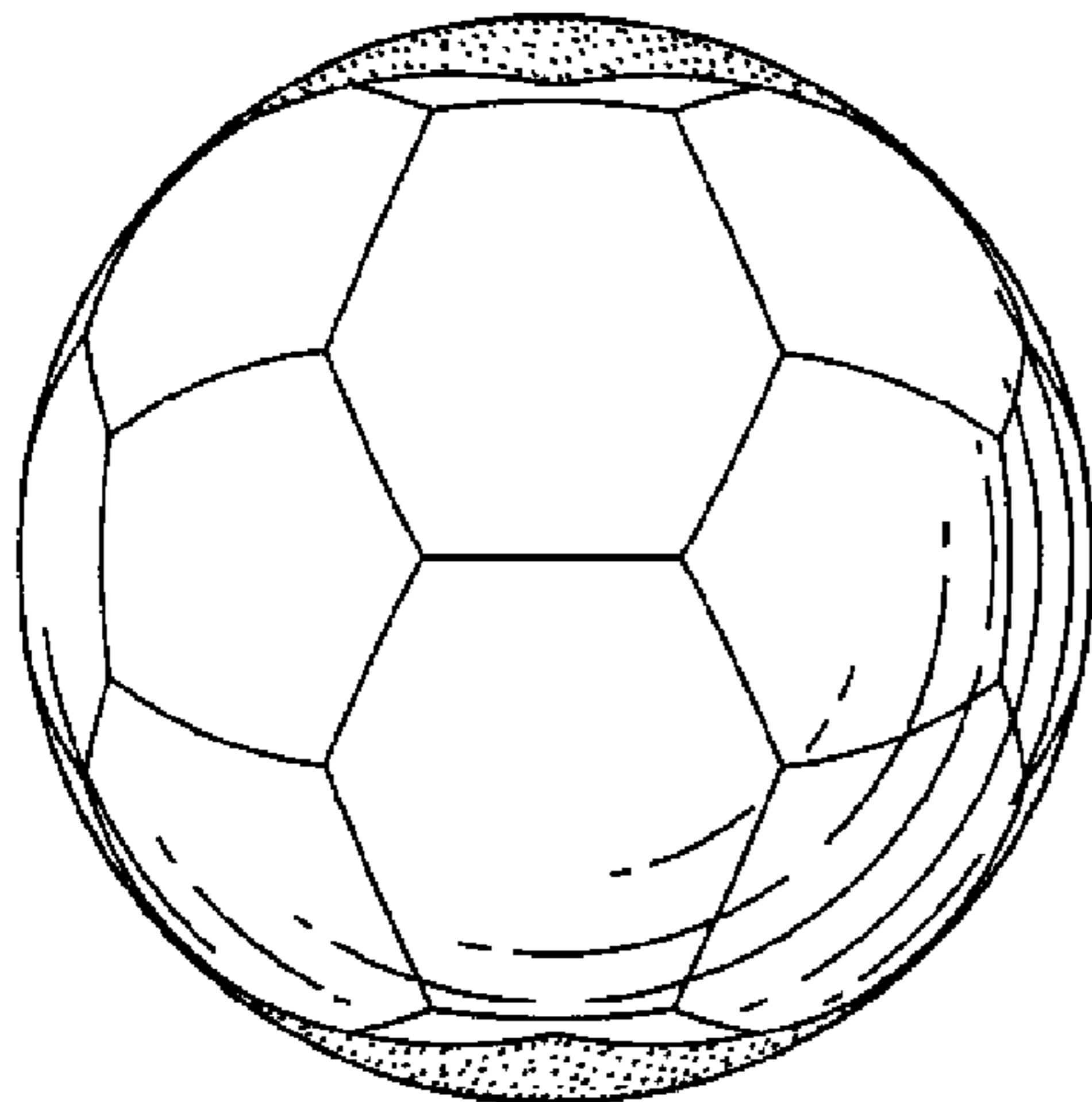

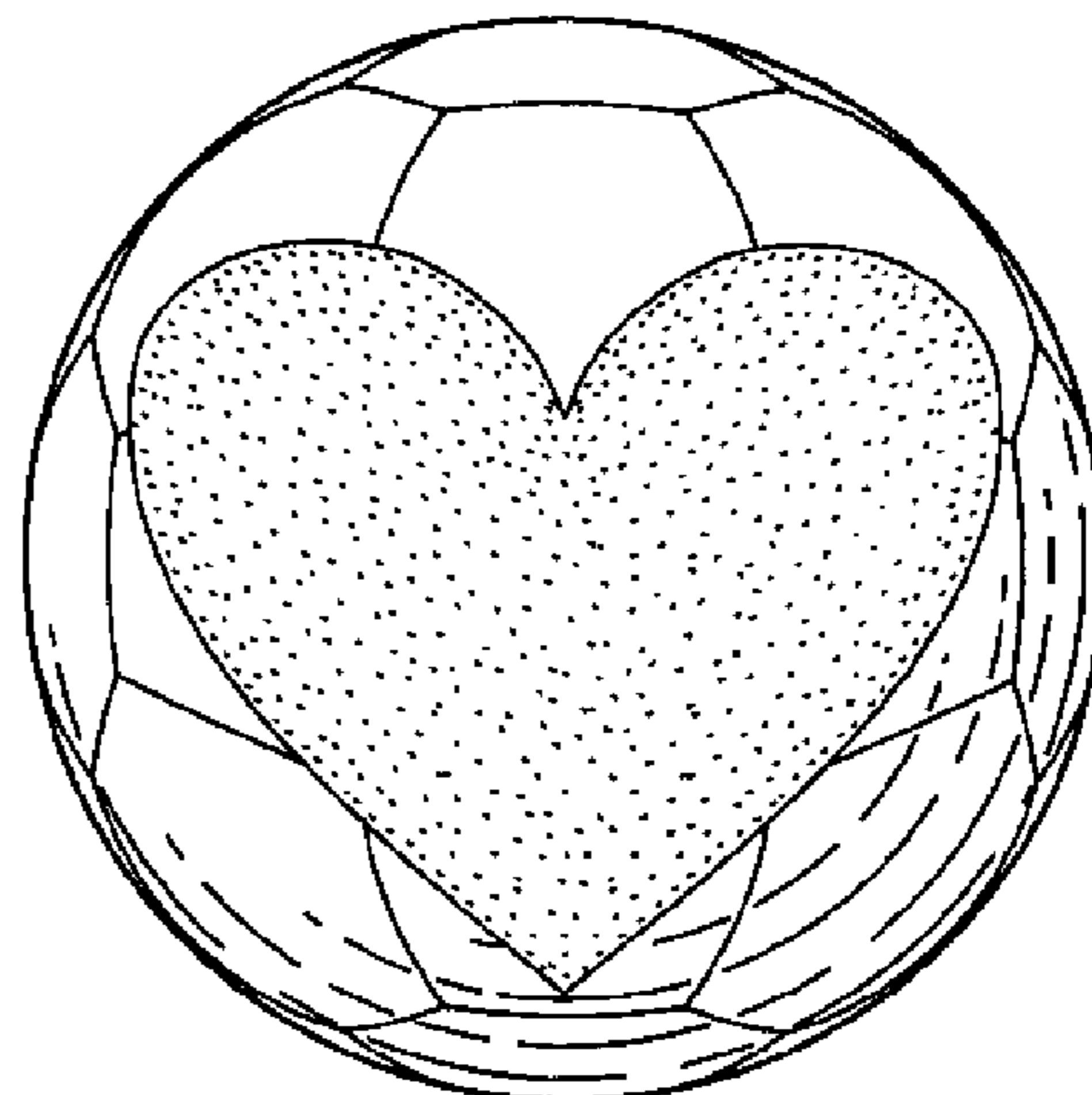
