(57) **CLAIM**

The ornamental design for a plumbing fixture, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a plumbing fixture in the form of a bathing tub or portion thereof.

FIG. 1 is a left, top, front perspective view of a plumbing fixture embodying our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a right, top, front perspective view of a plumbing fixture according to another embodiment of our new design, the top plan, front elevational, rear elevational, left side elevational, right side elevational and bottom plan views thereof being mirror images of the views shown in respective FIGS. 2-7;

FIG. 9 is a left, top, front perspective view of a plumbing fixture according to another embodiment of our new design;

FIG. 10 is a top plan view thereof;

FIG. 11 is a front elevational view thereof;

FIG. 12 is a rear elevational view thereof;

FIG. 13 is a left side elevational view thereof;

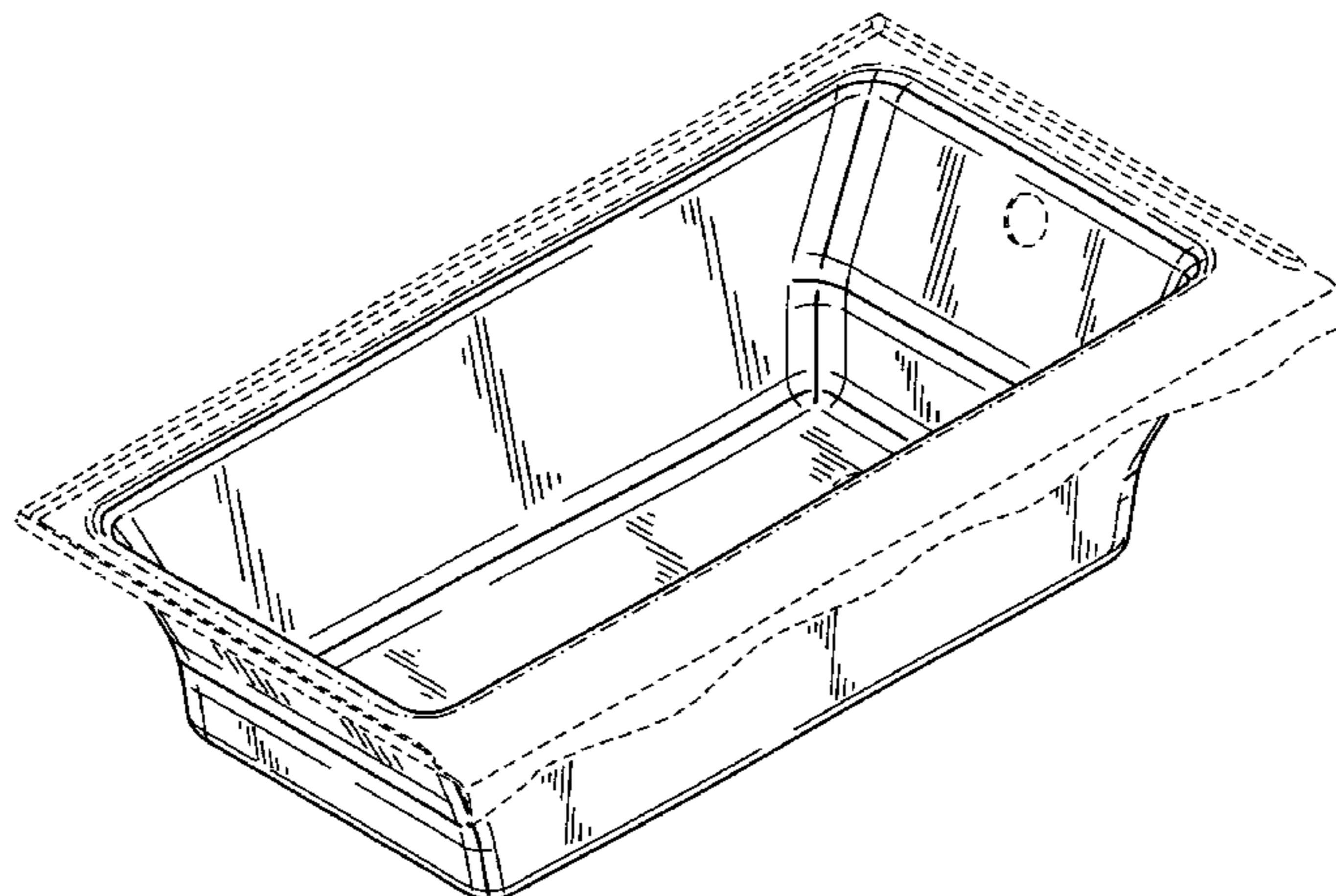
FIG. 14 is a right side elevational view thereof;

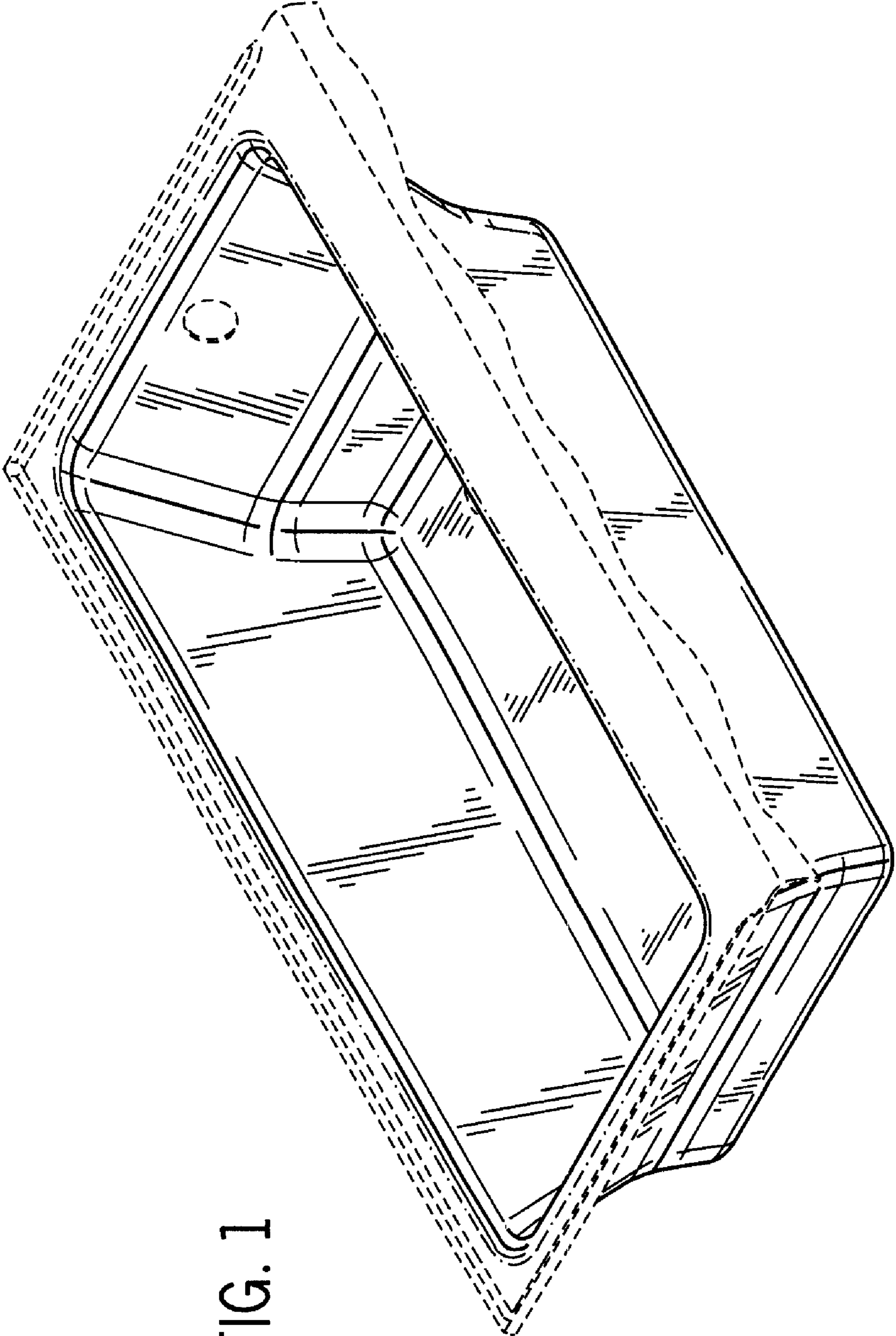

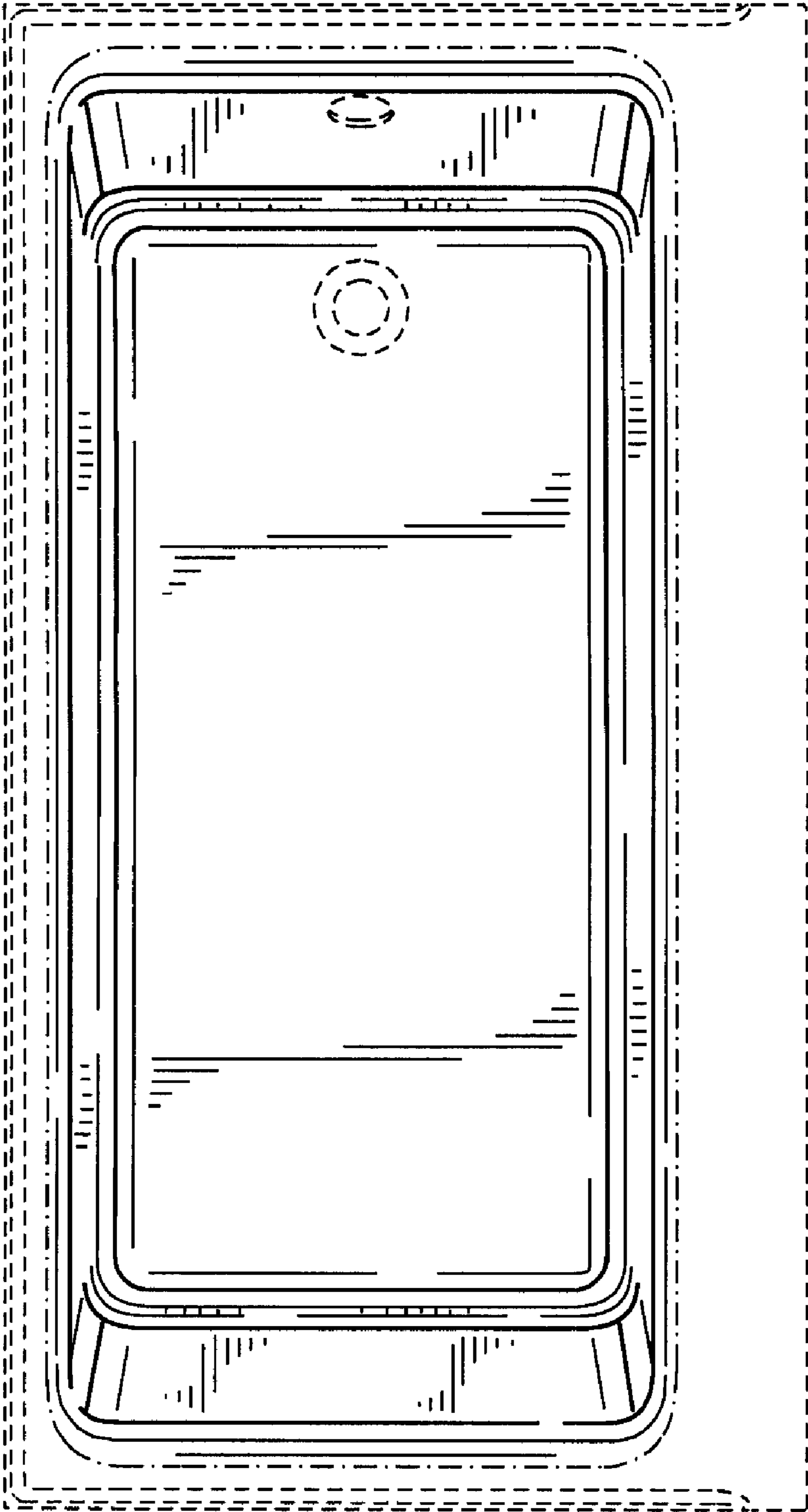

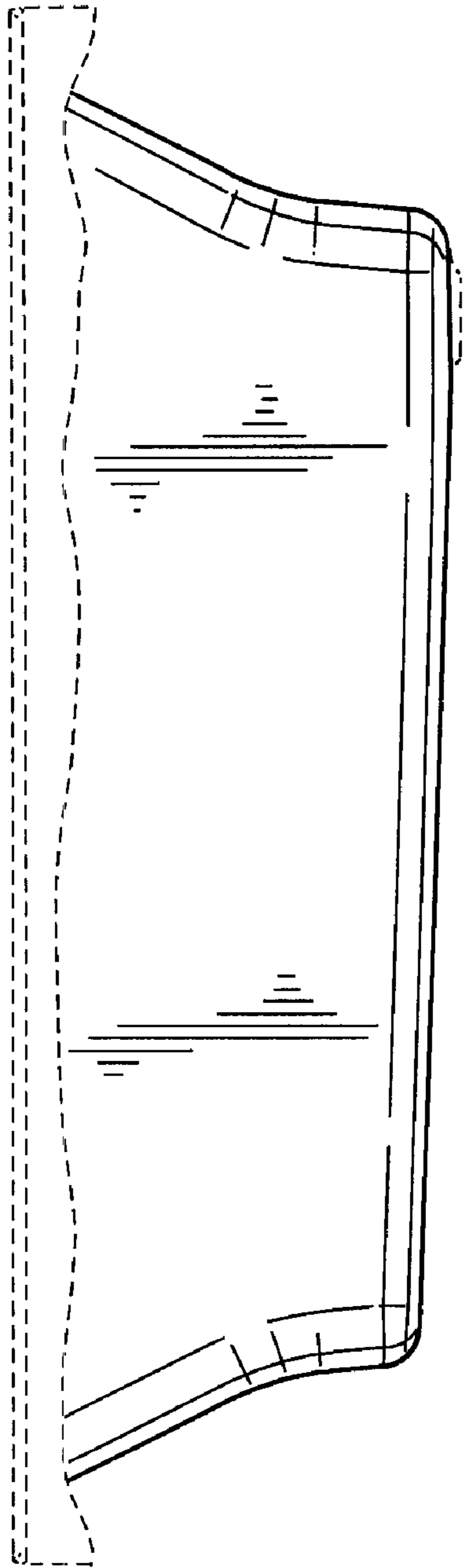

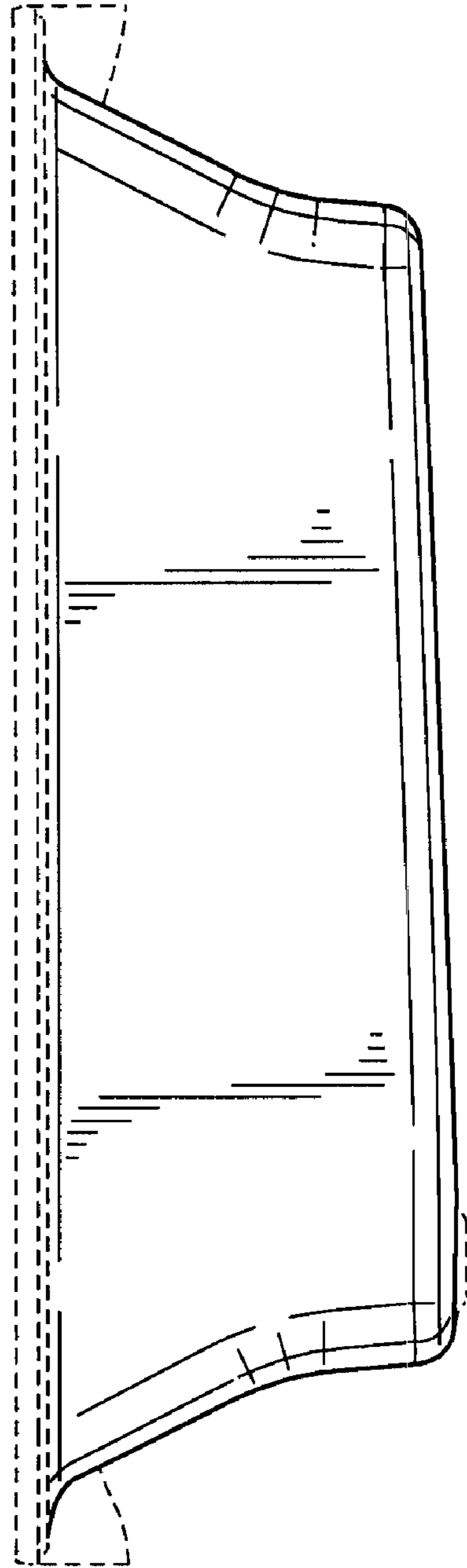

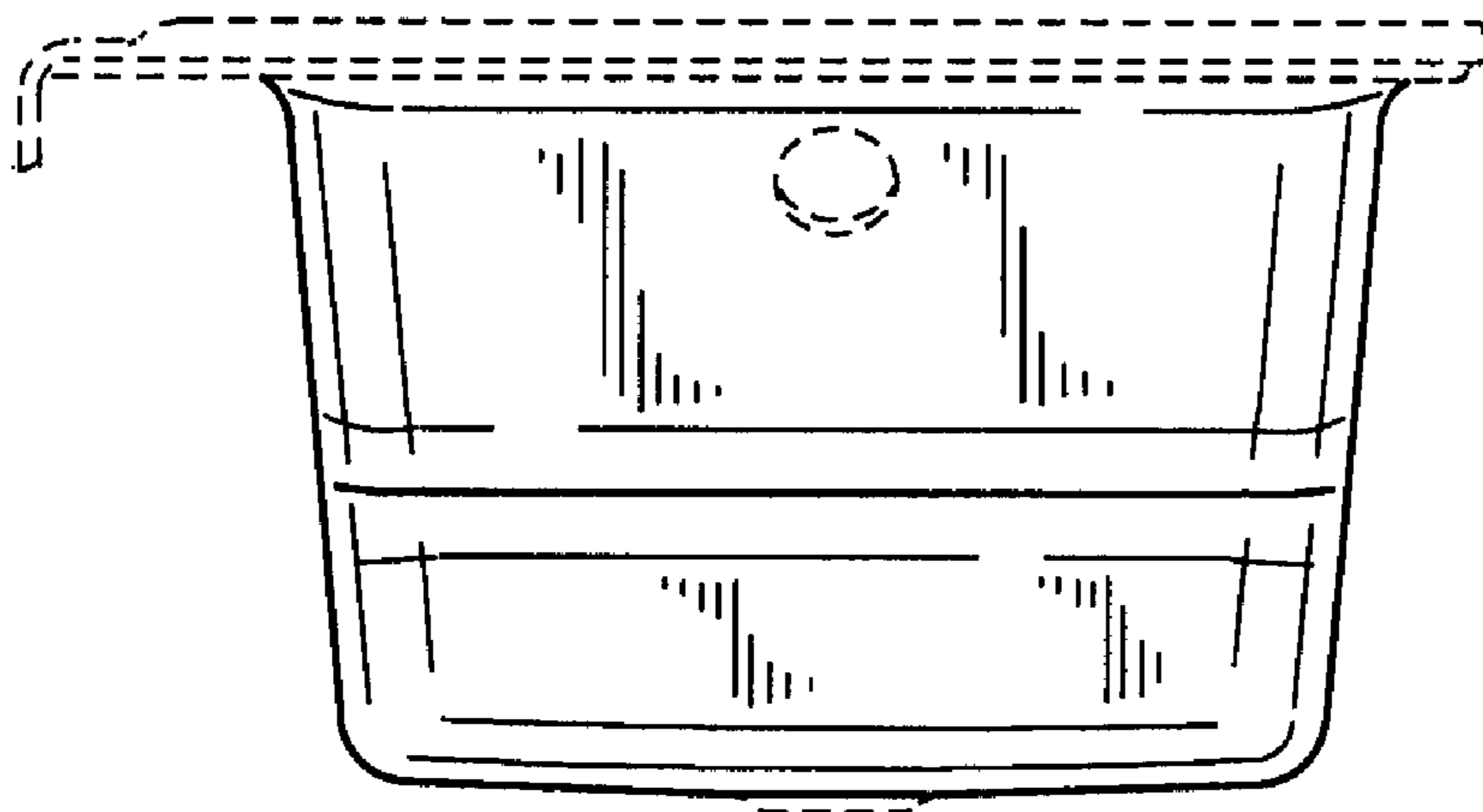

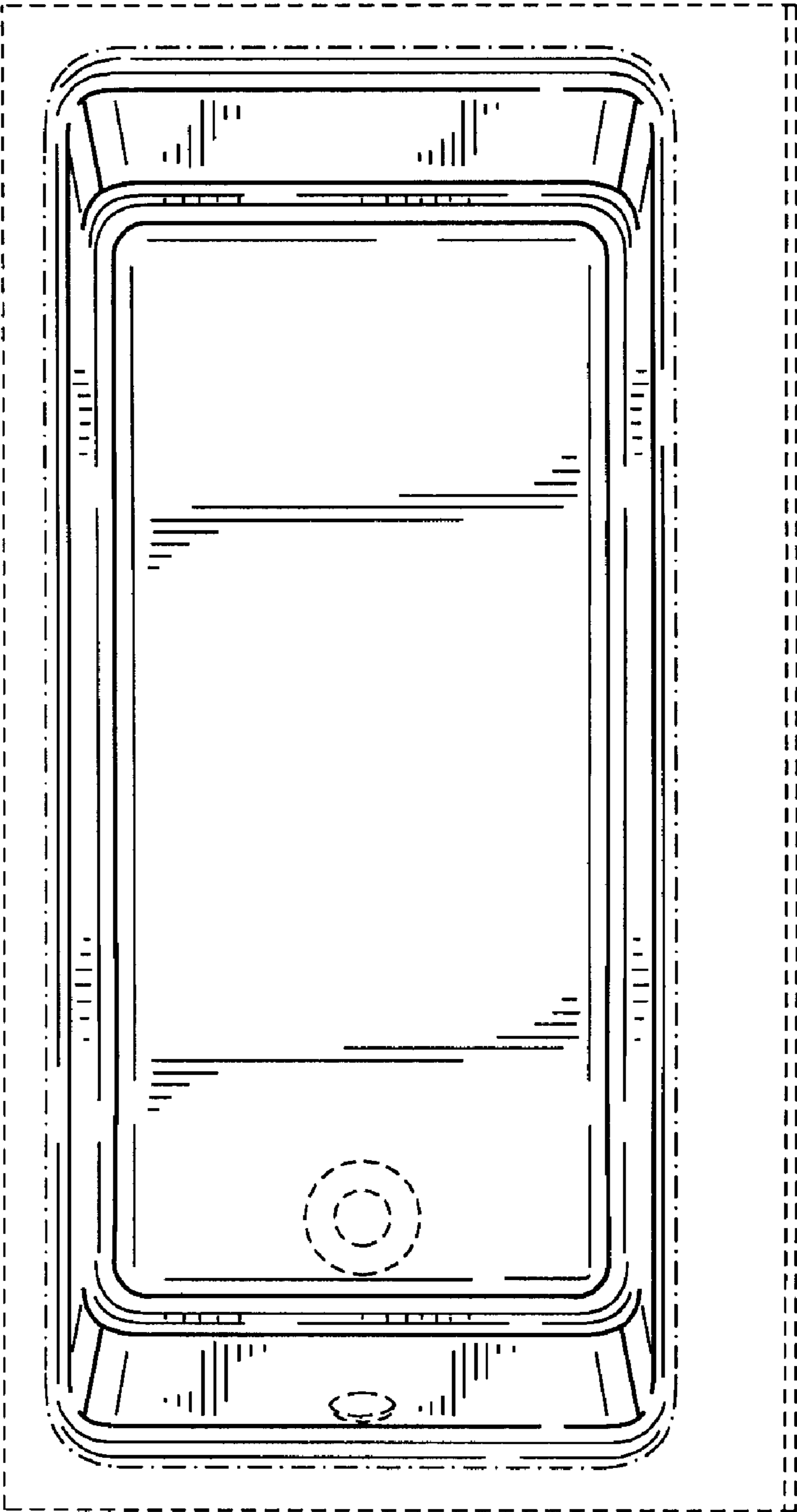

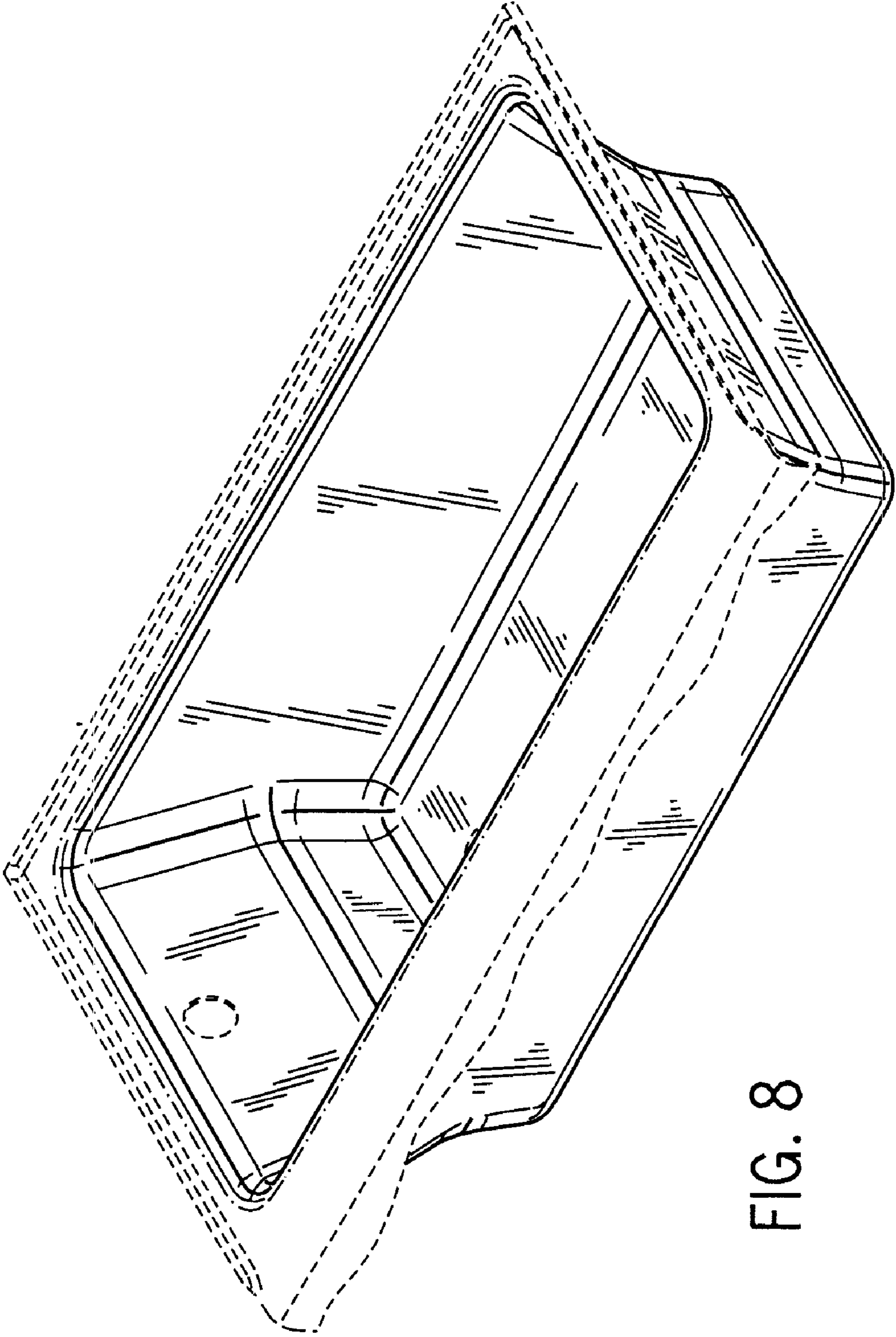

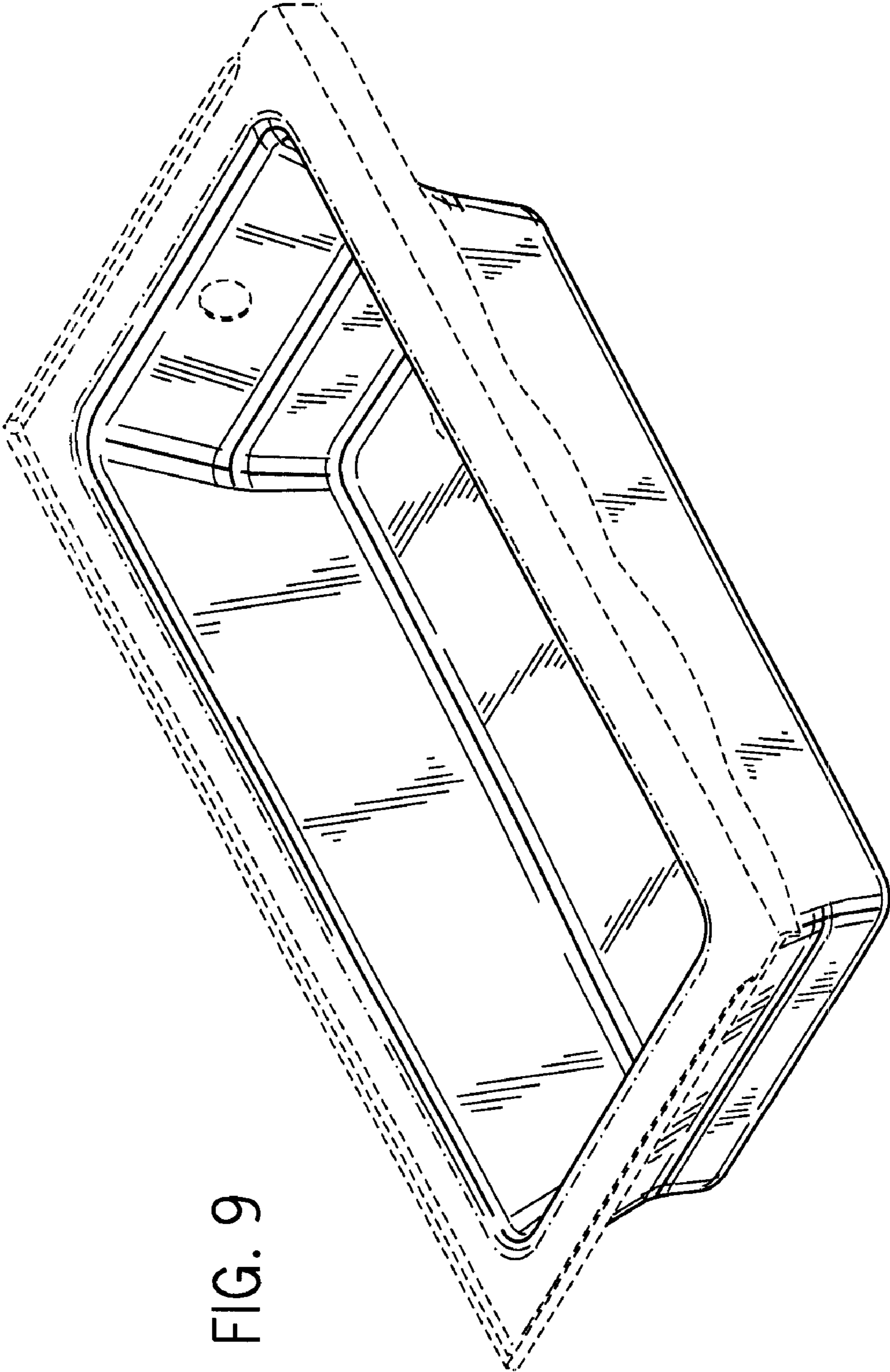

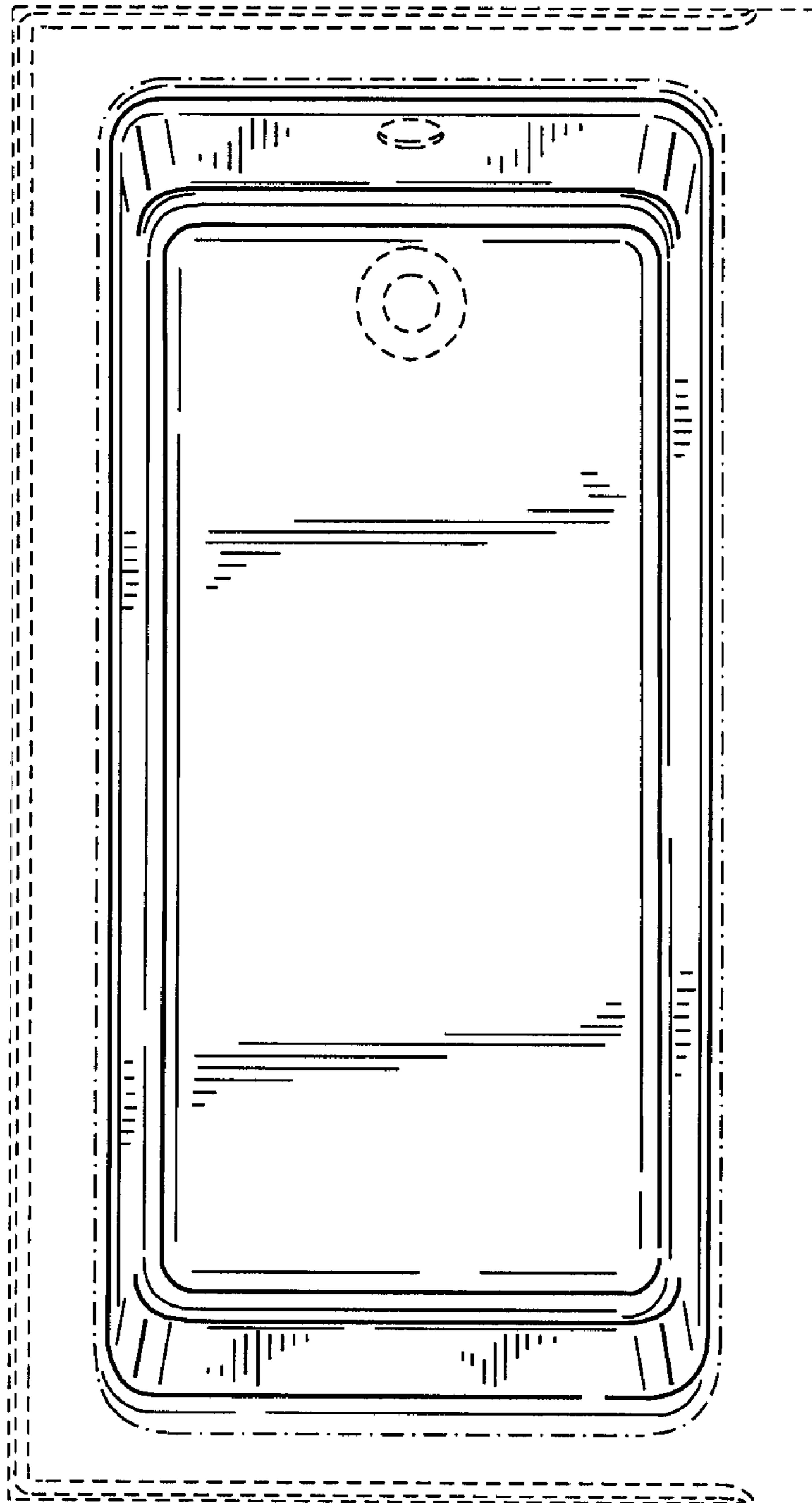

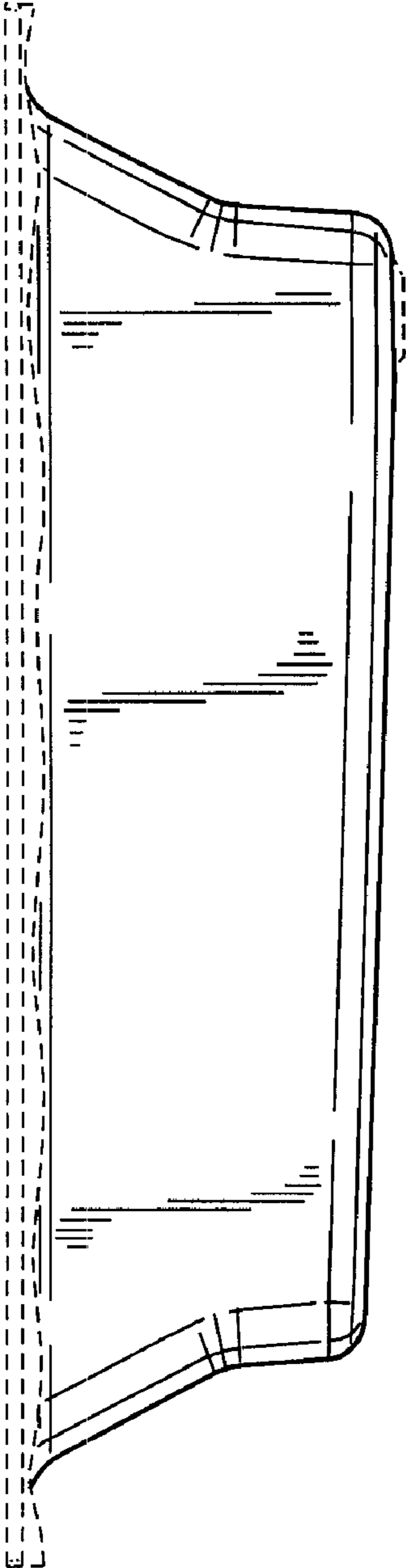

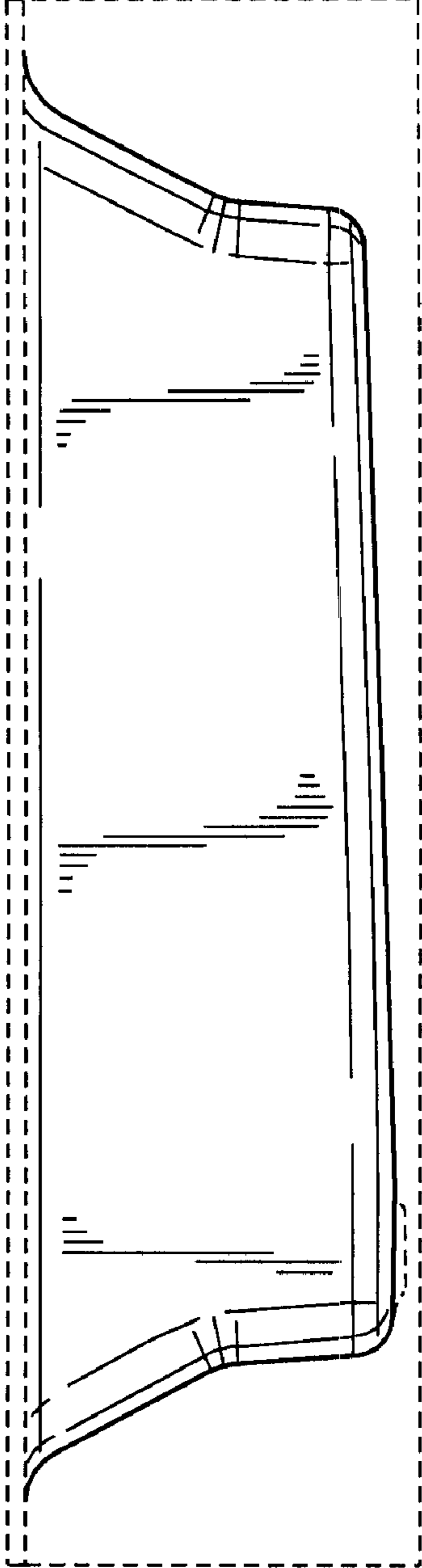

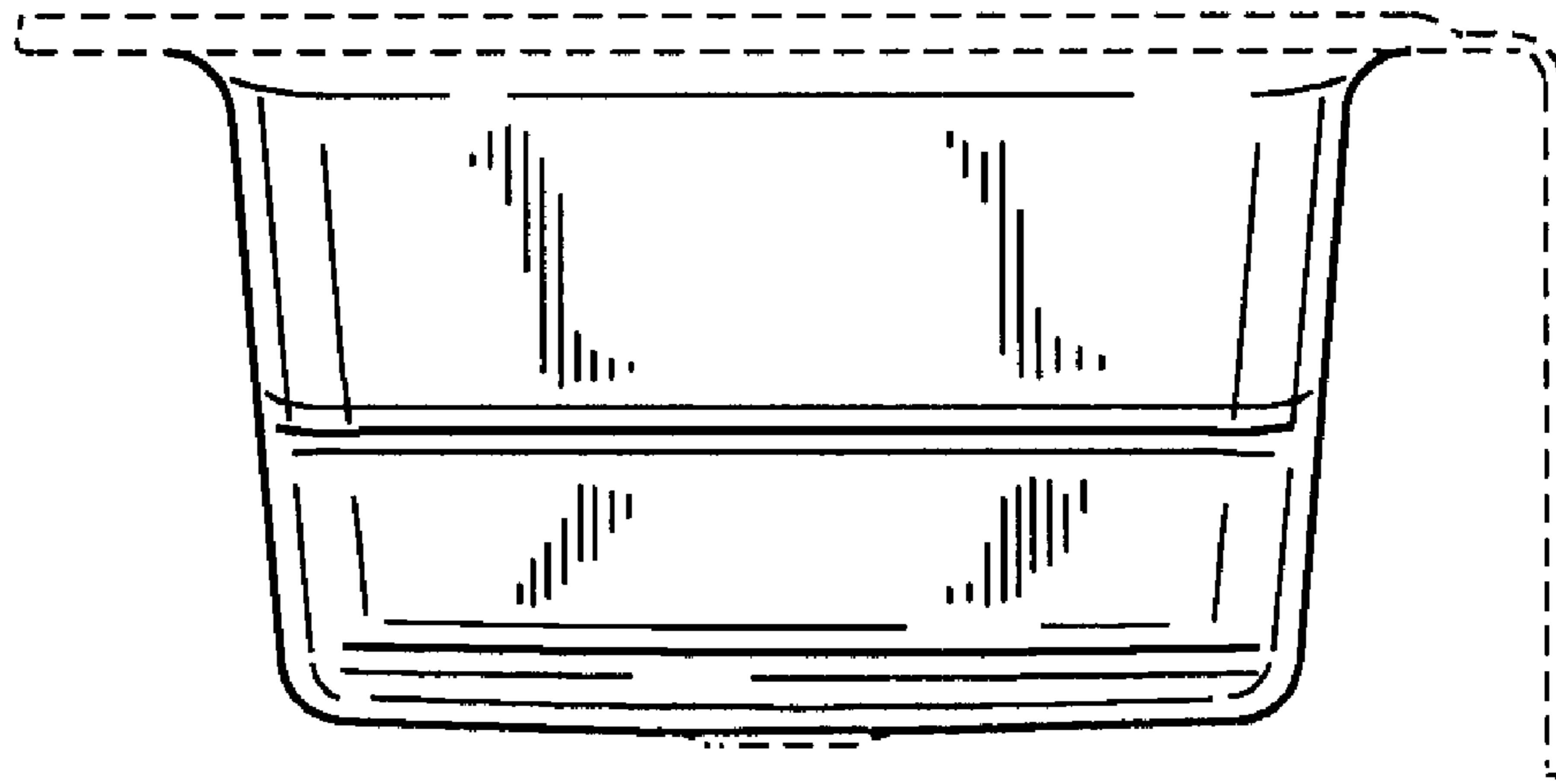

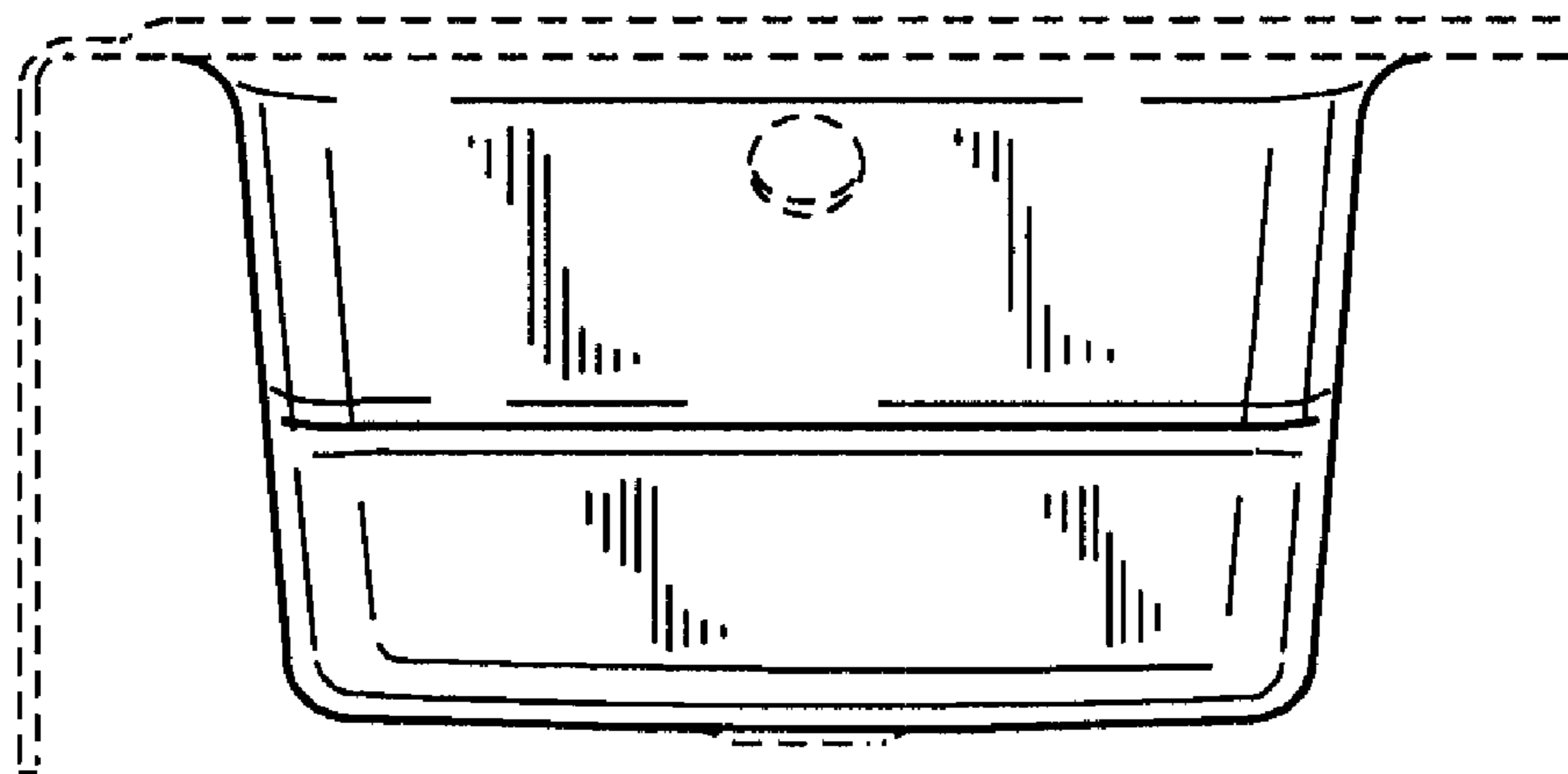

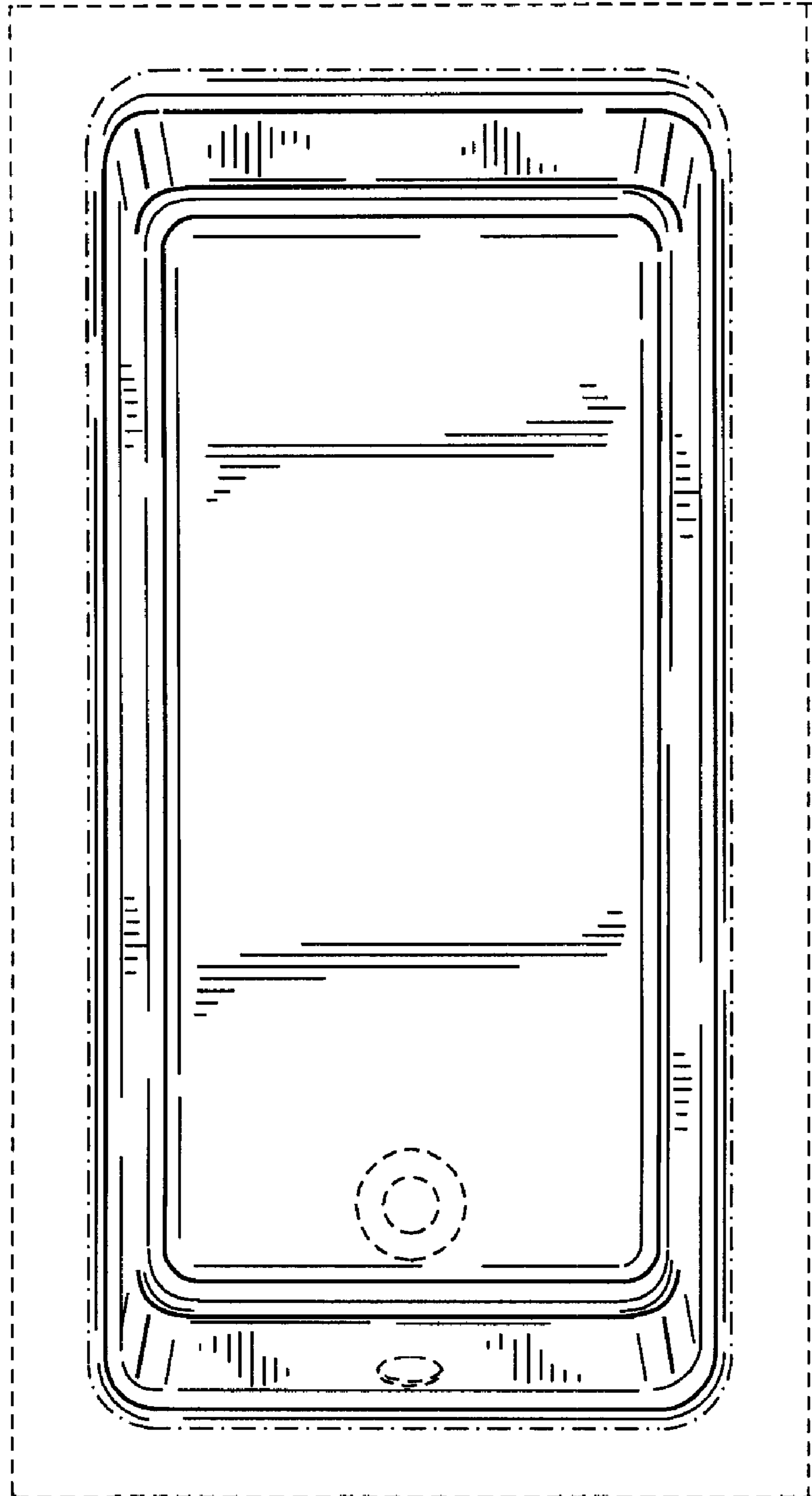

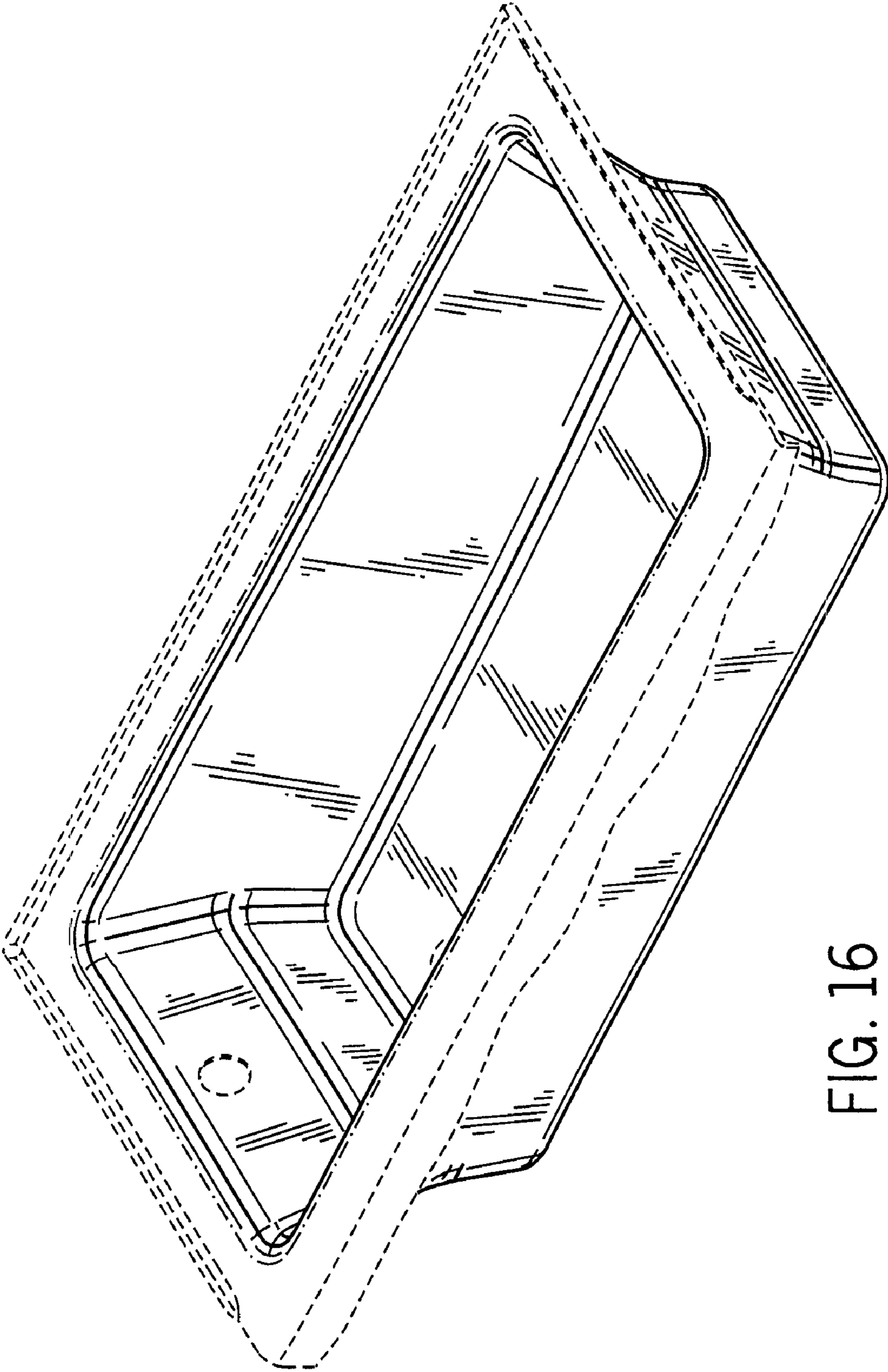
