**DESCRIPTION**

FIG. 1 is a perspective view of an air purifier showing our new design;

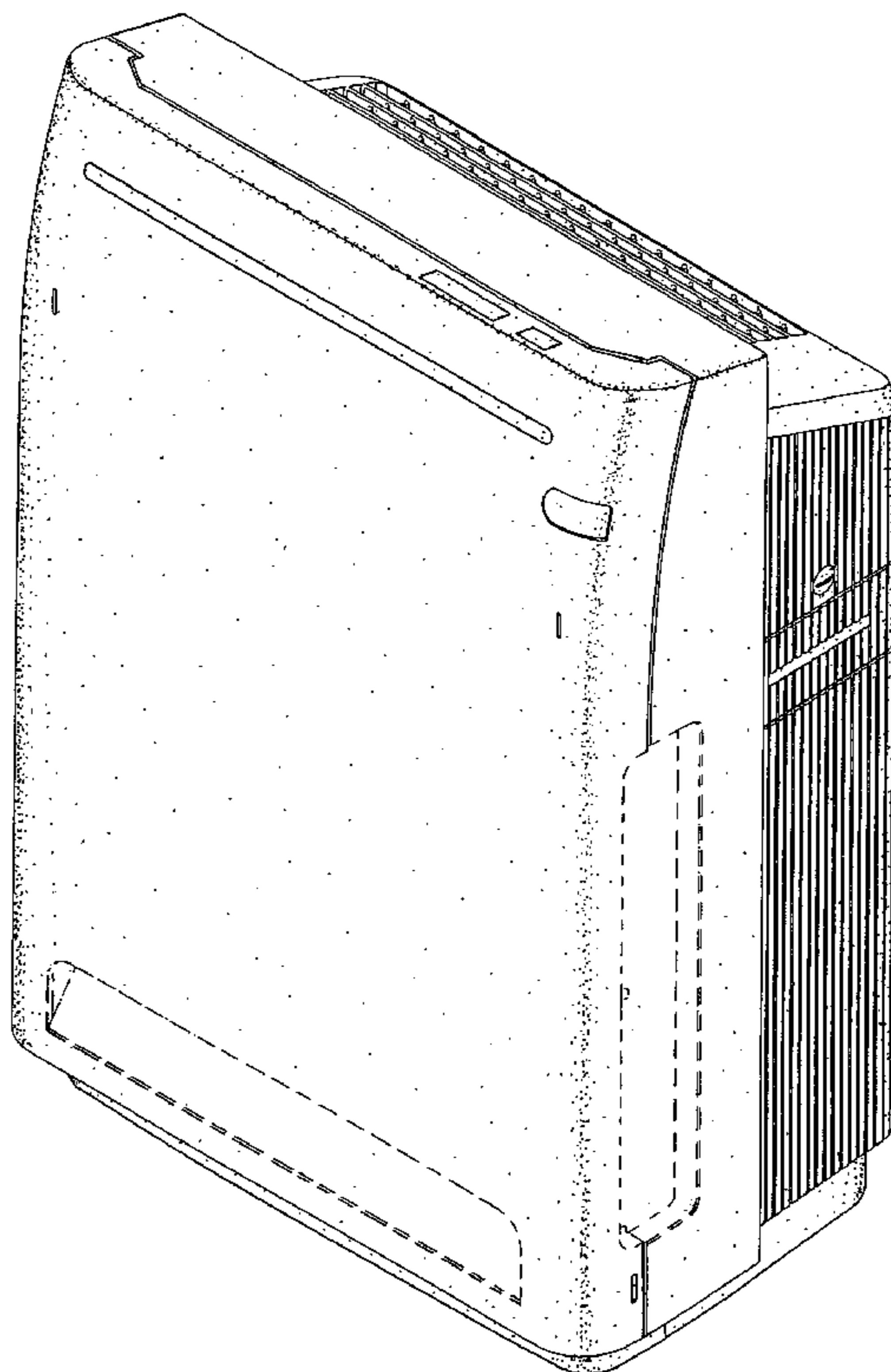

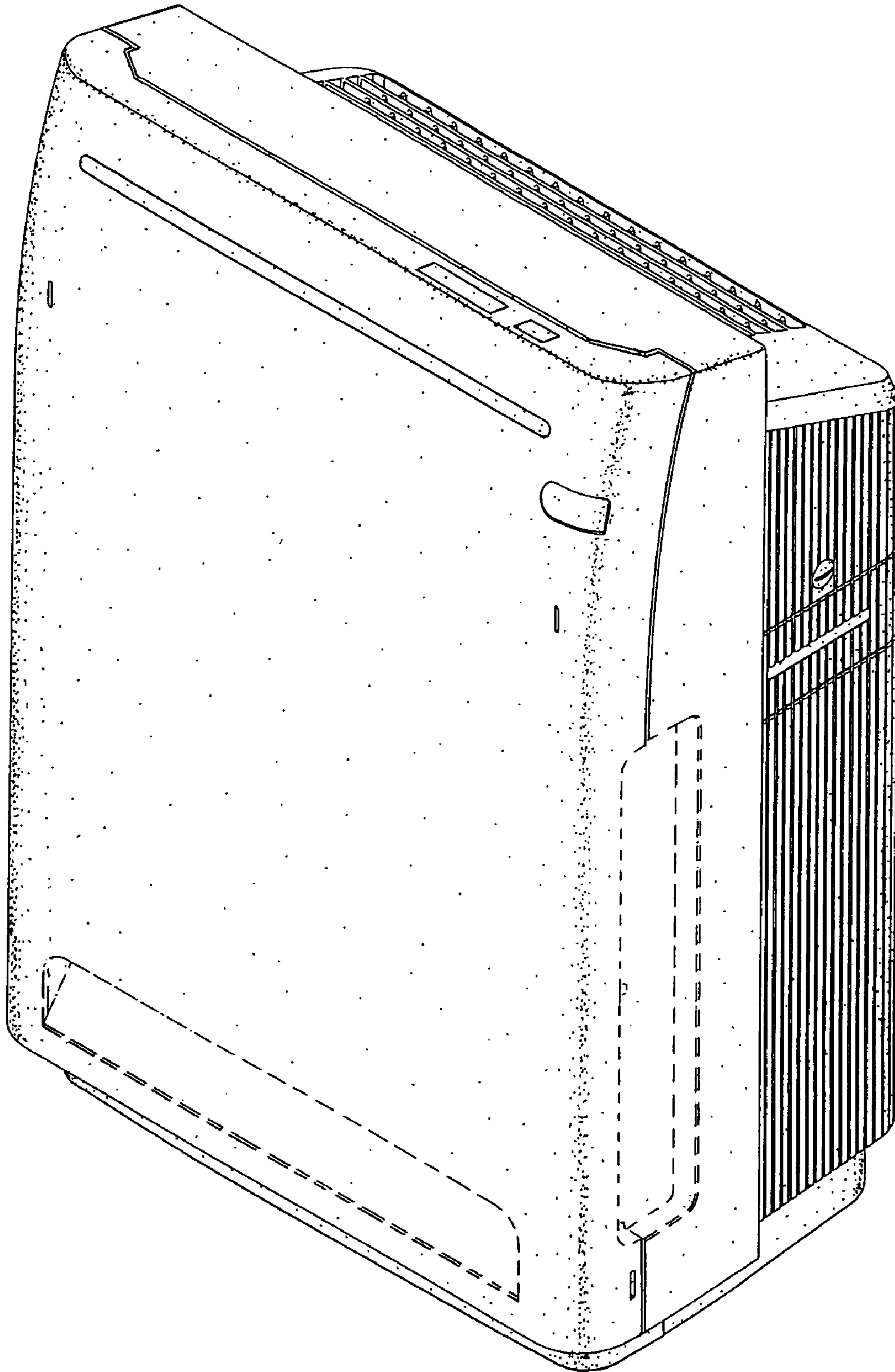

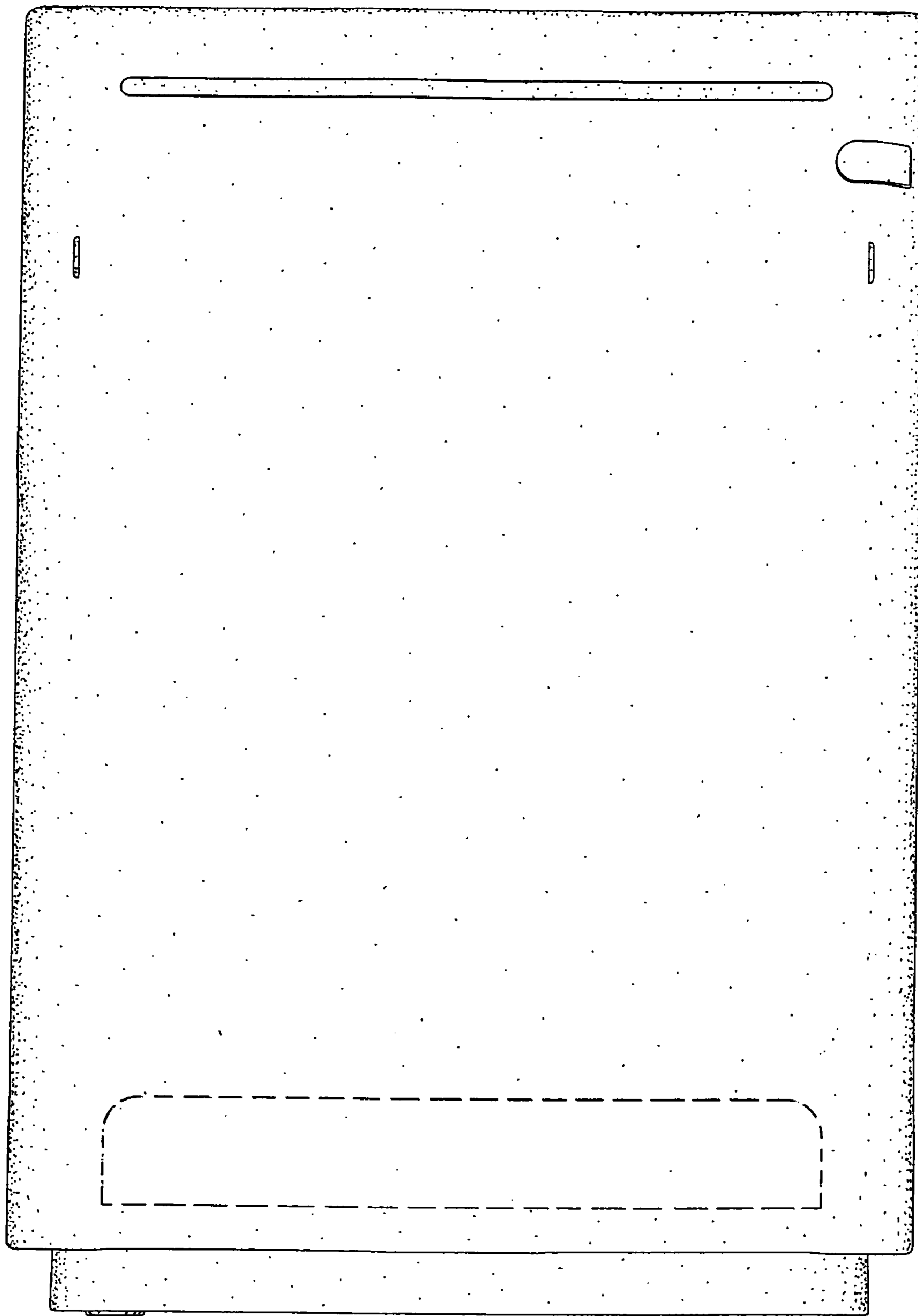

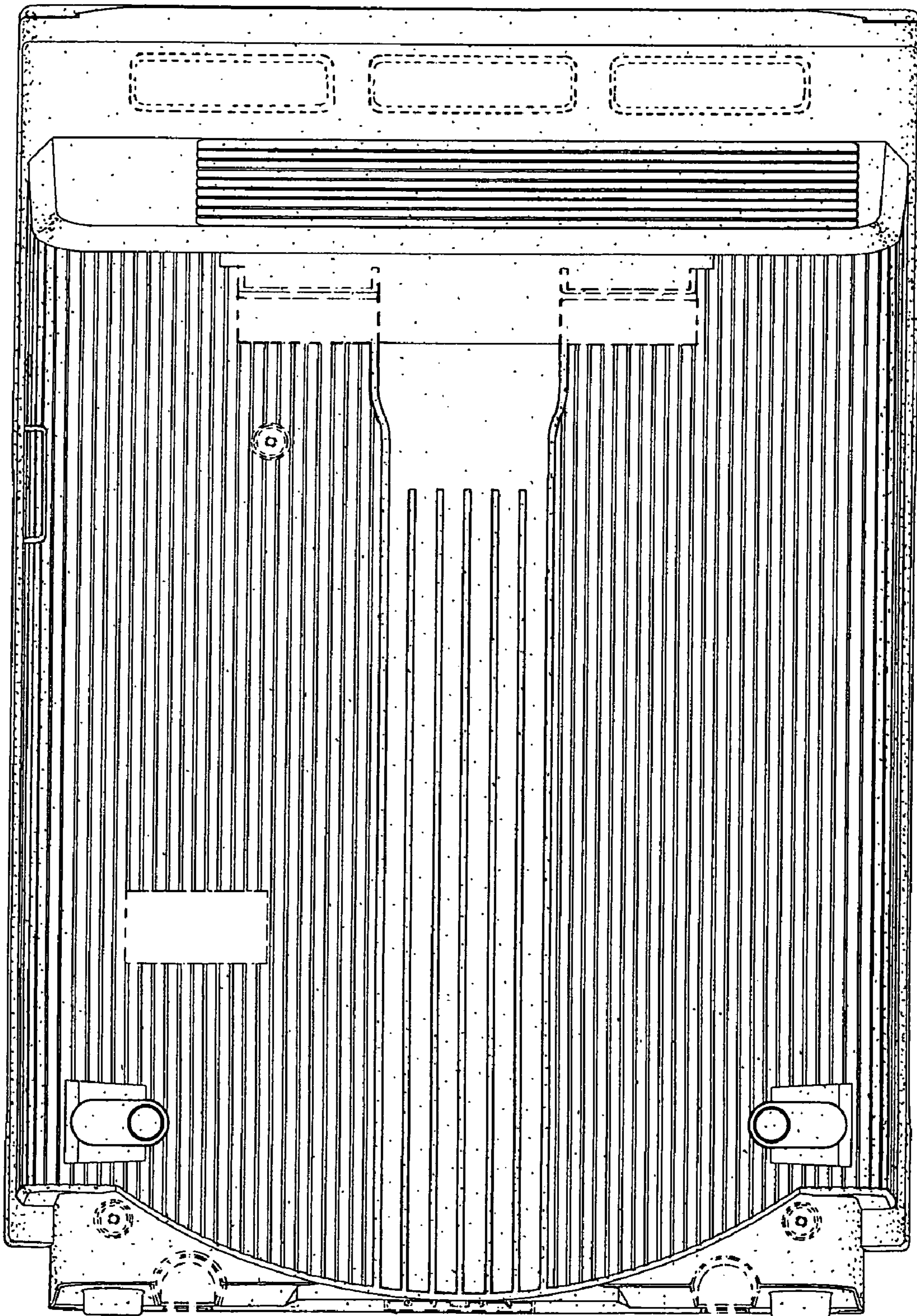

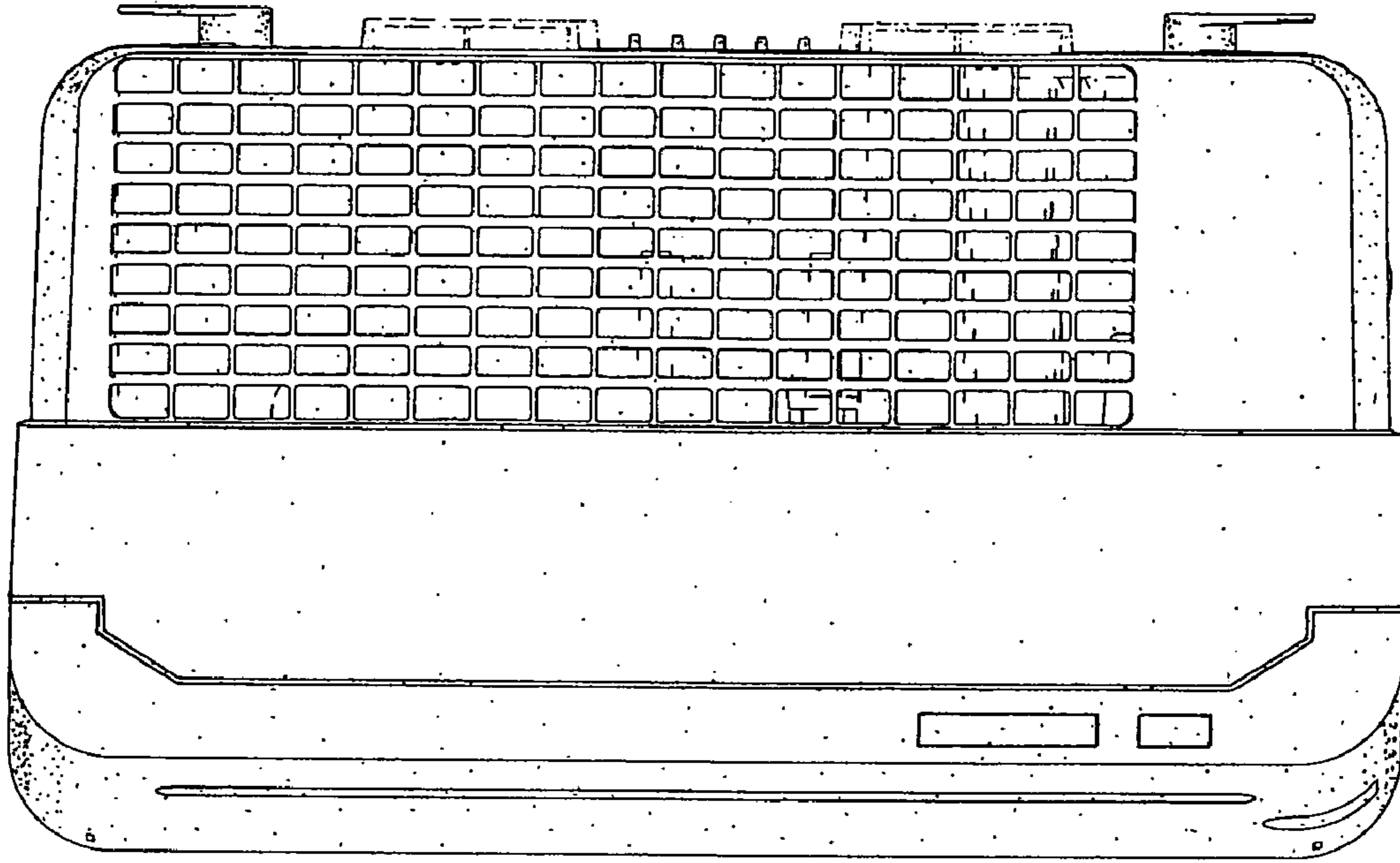

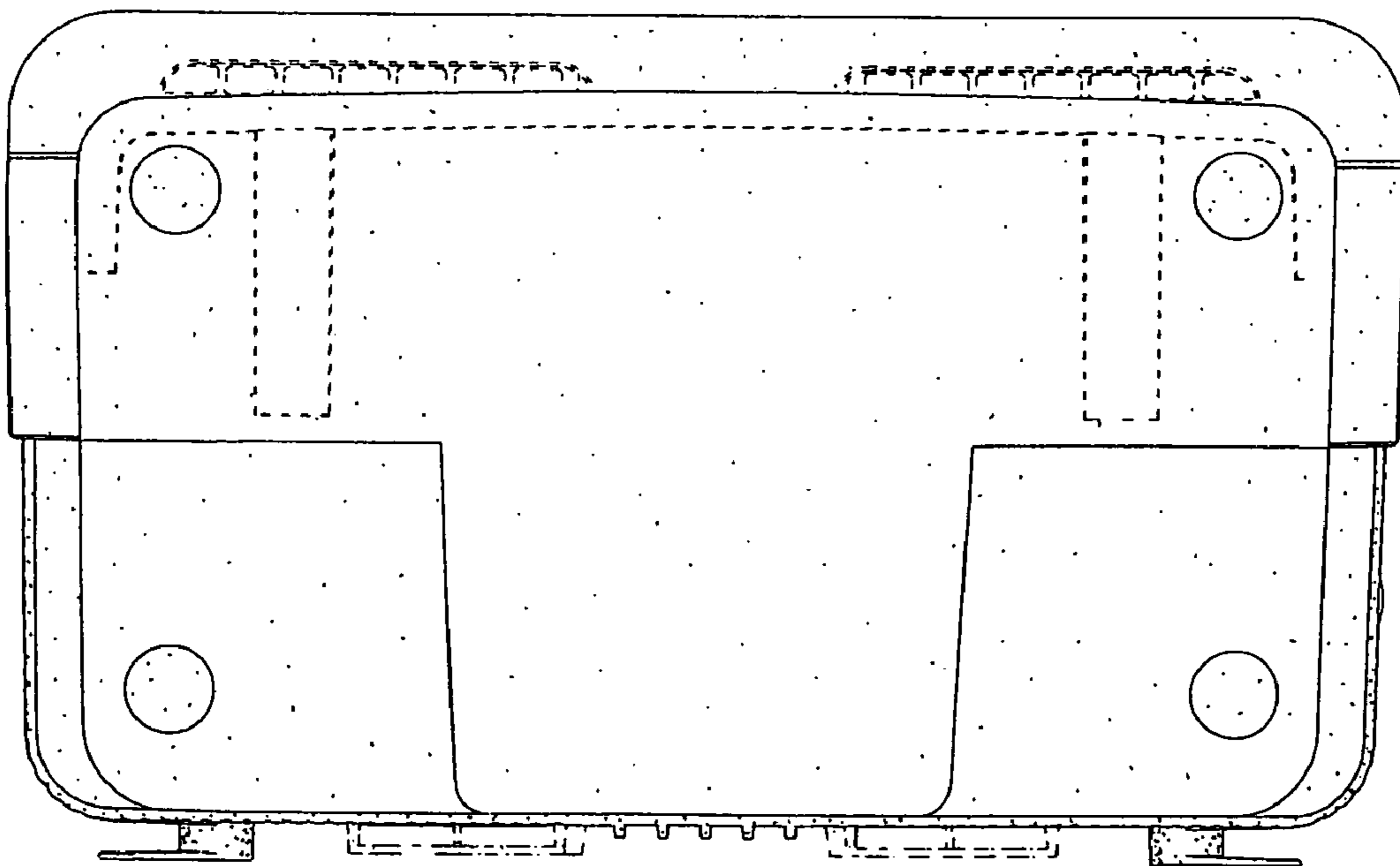

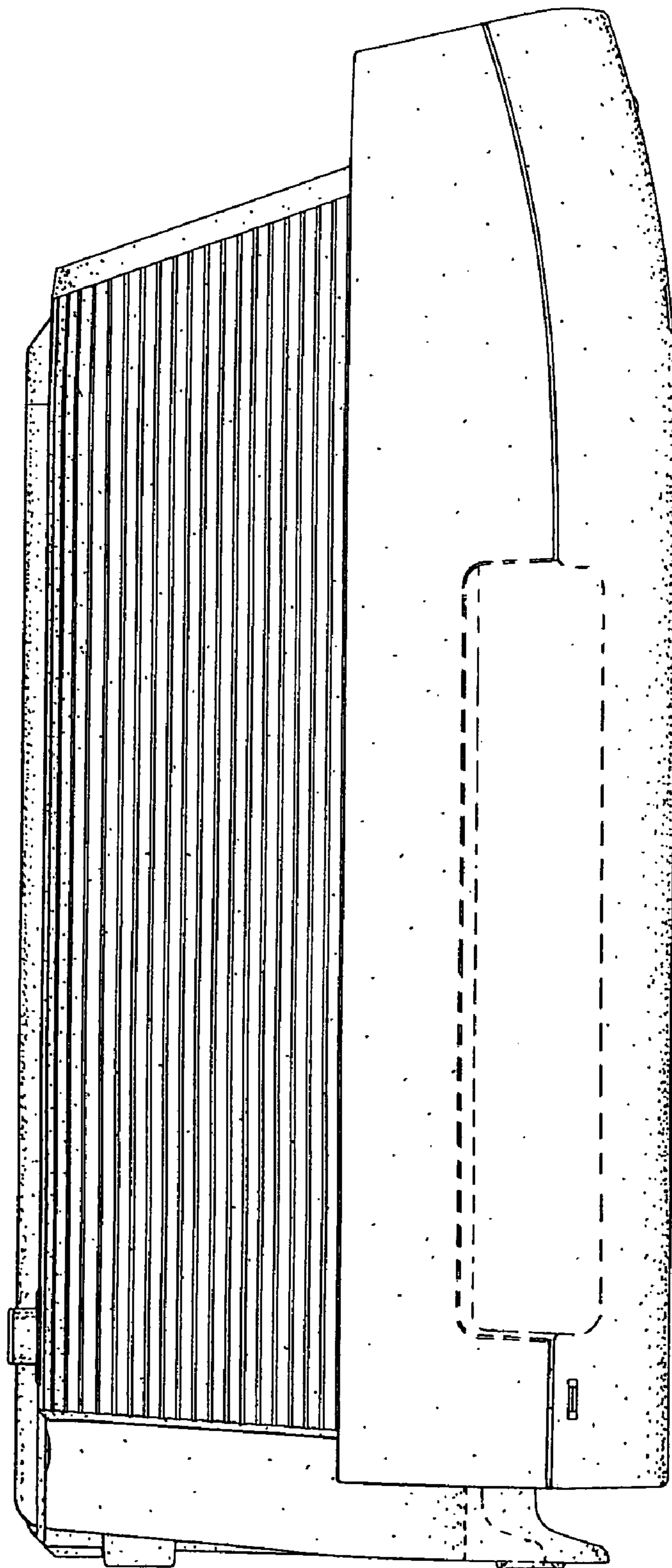
