The ornamental design for an upper limb prosthesis, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an upper limb prosthesis showing our new design;

FIG. 2 is another front perspective view thereof;

FIG. 3 is a top perspective view thereof shown on a slightly reduced scale;

FIG. 4 is a side perspective view thereof;

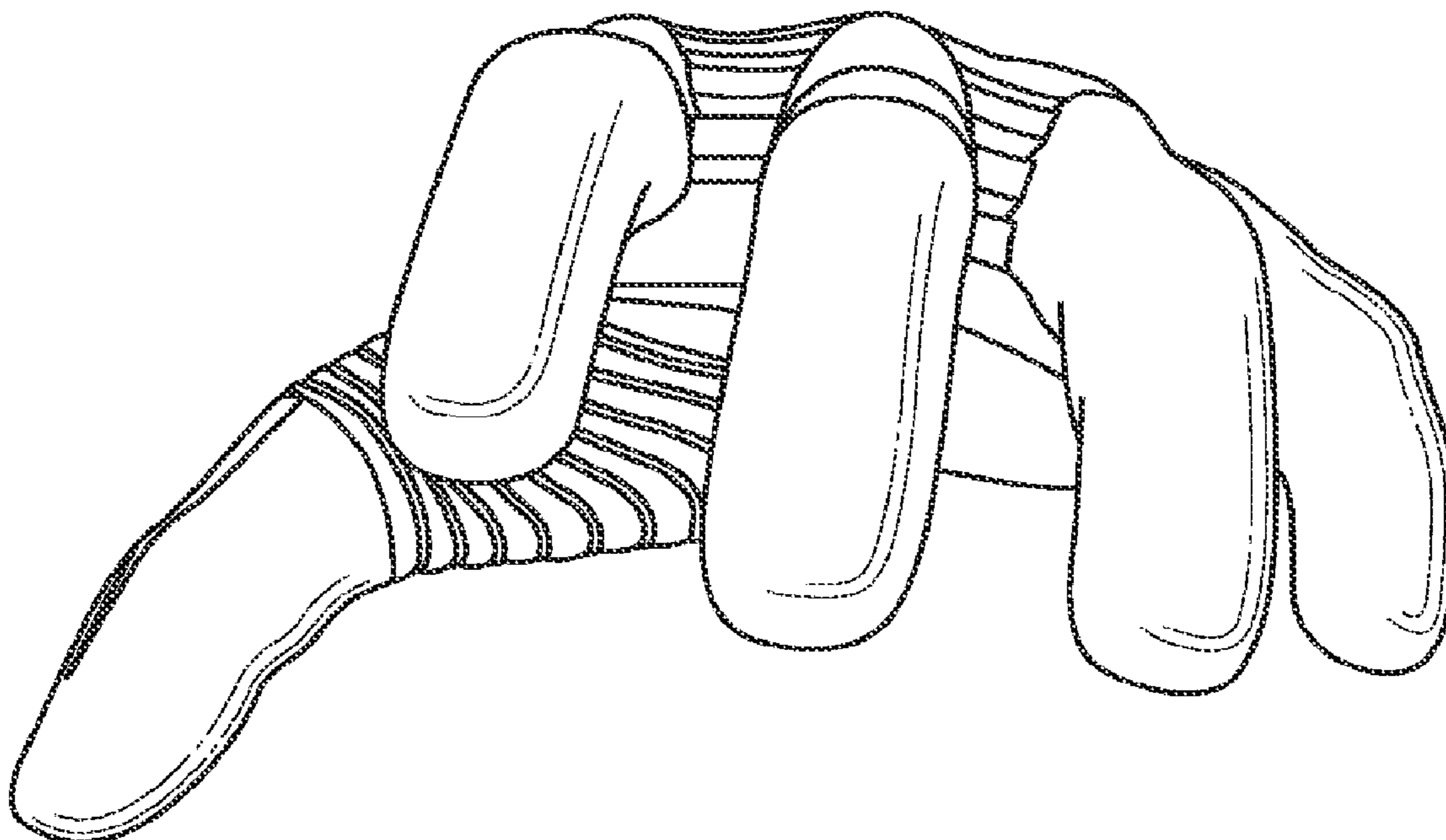
FIG. 5 is a bottom perspective view thereof;

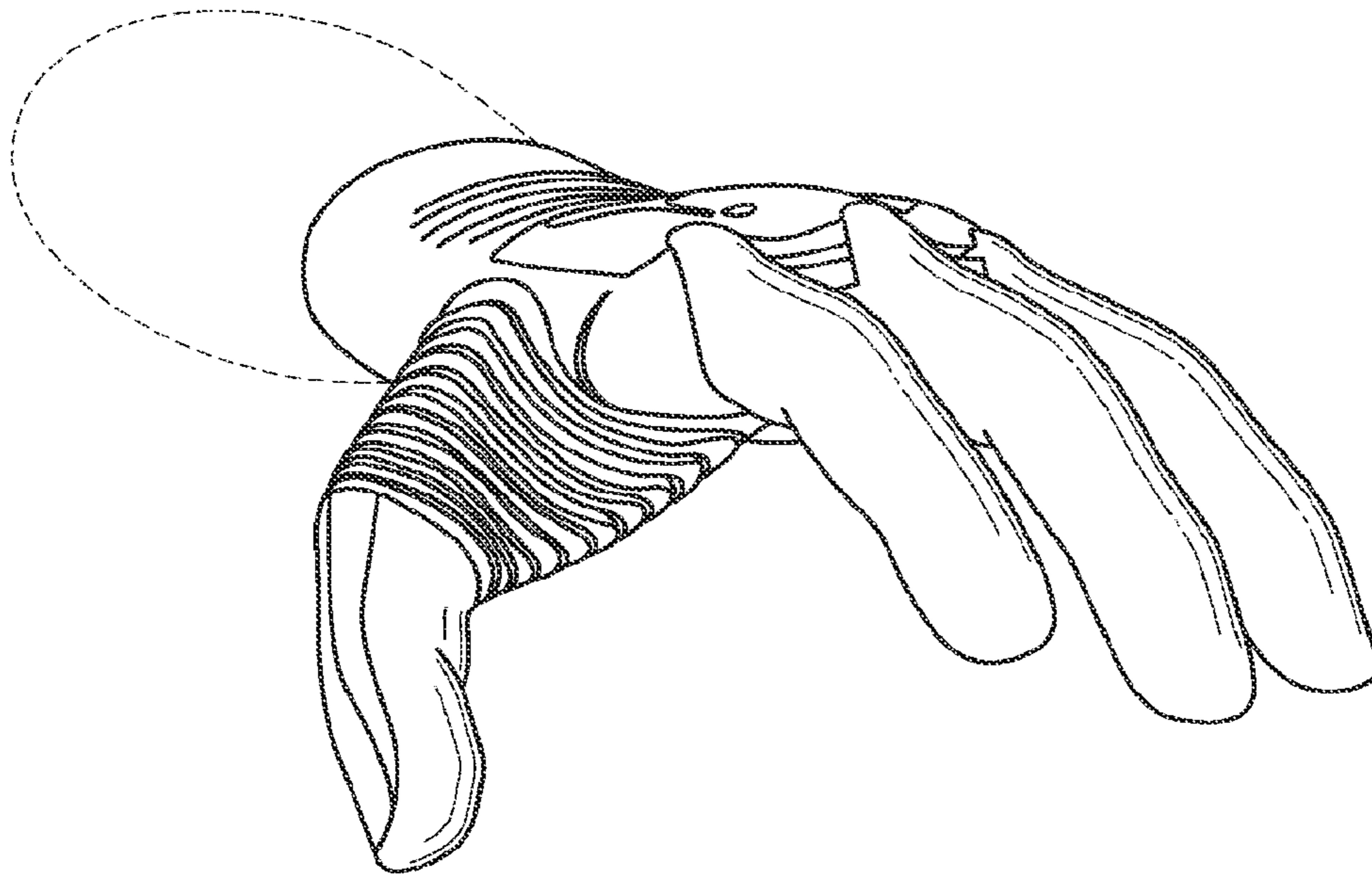

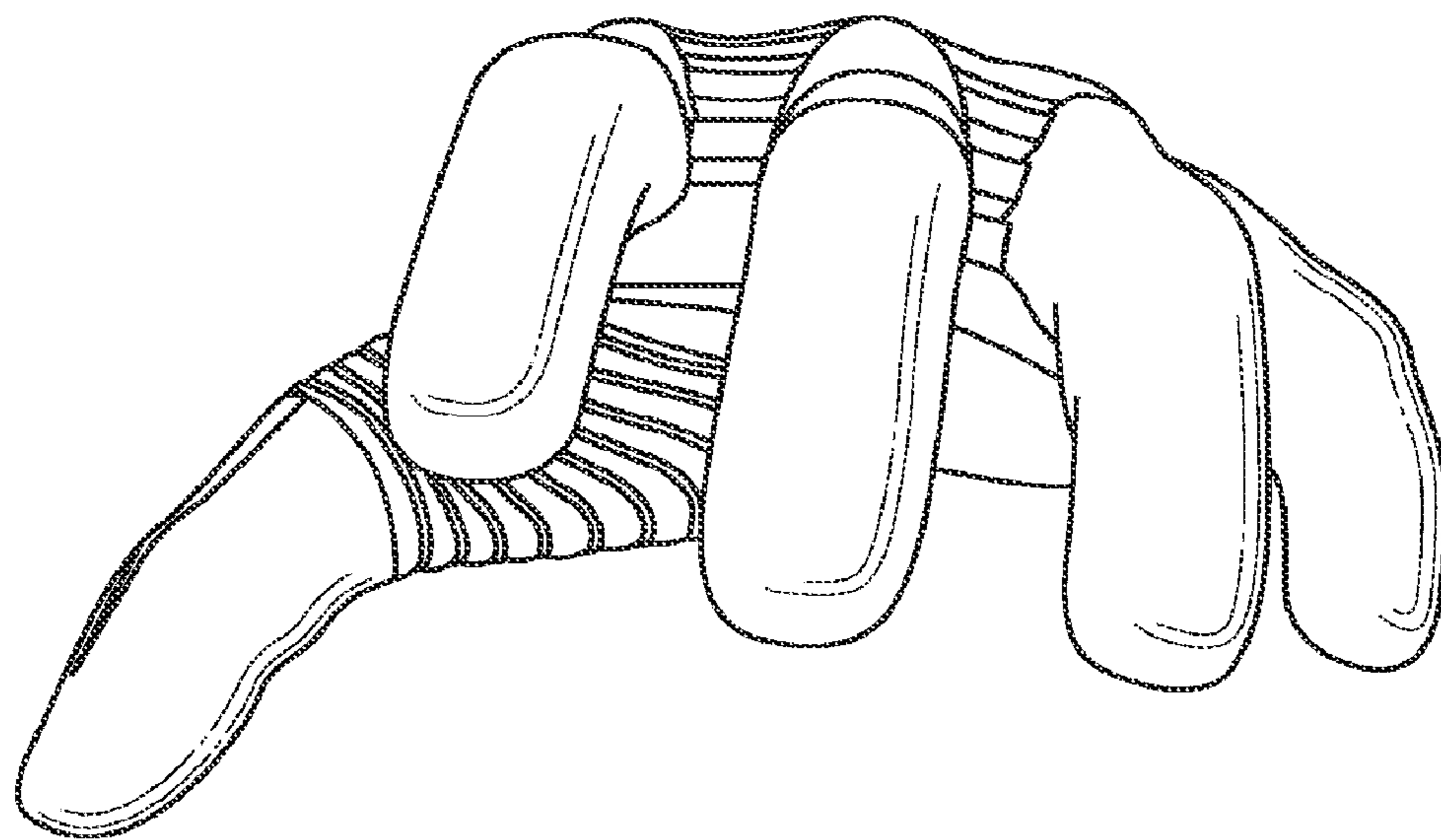

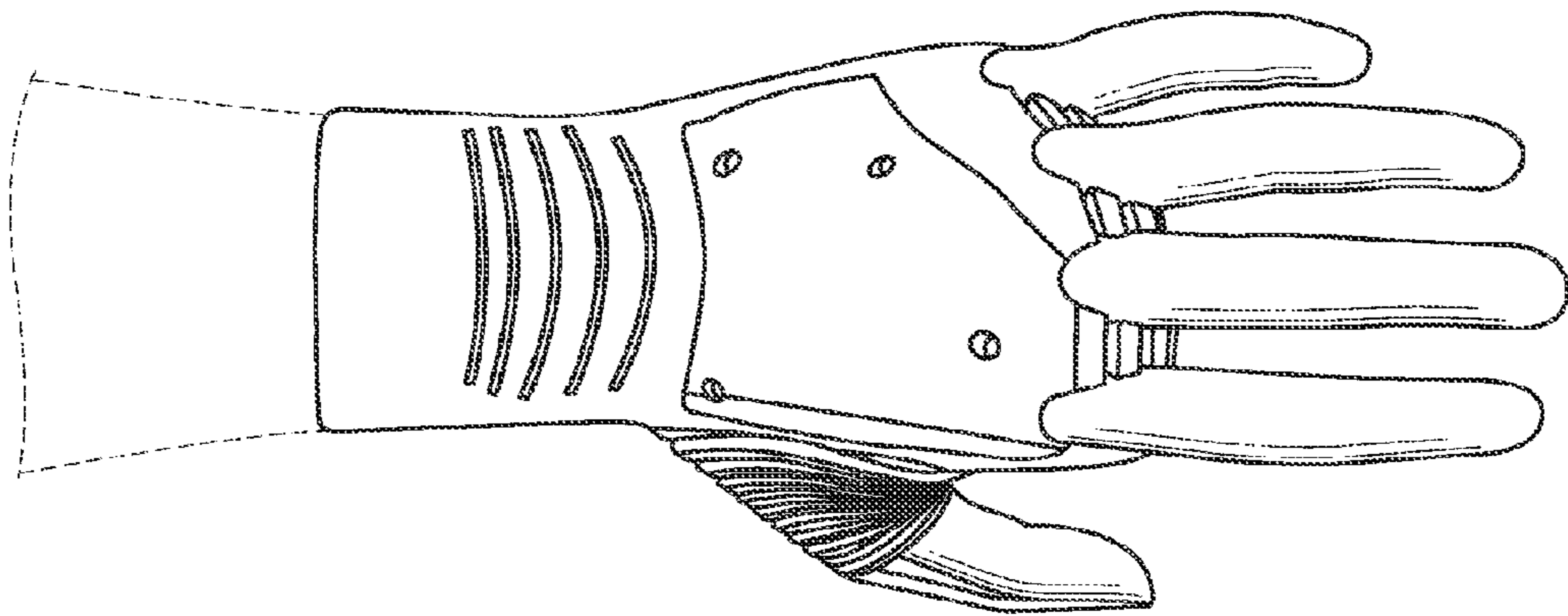

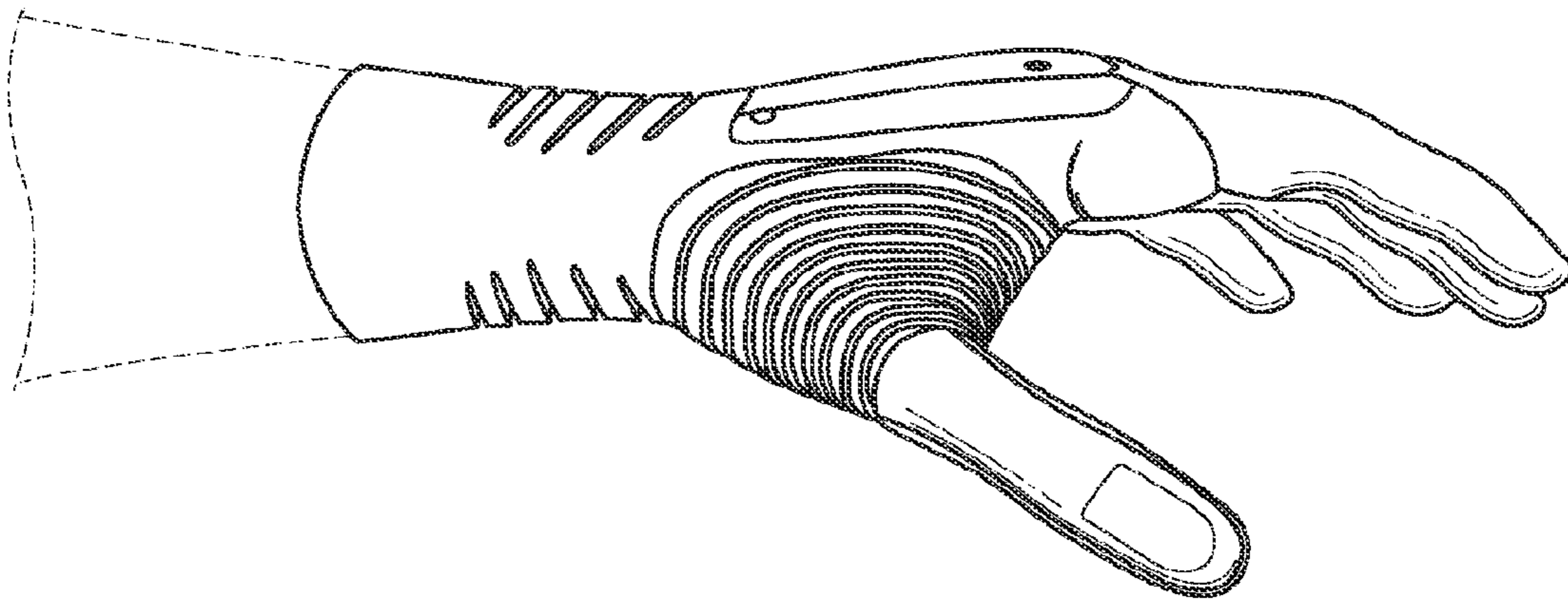

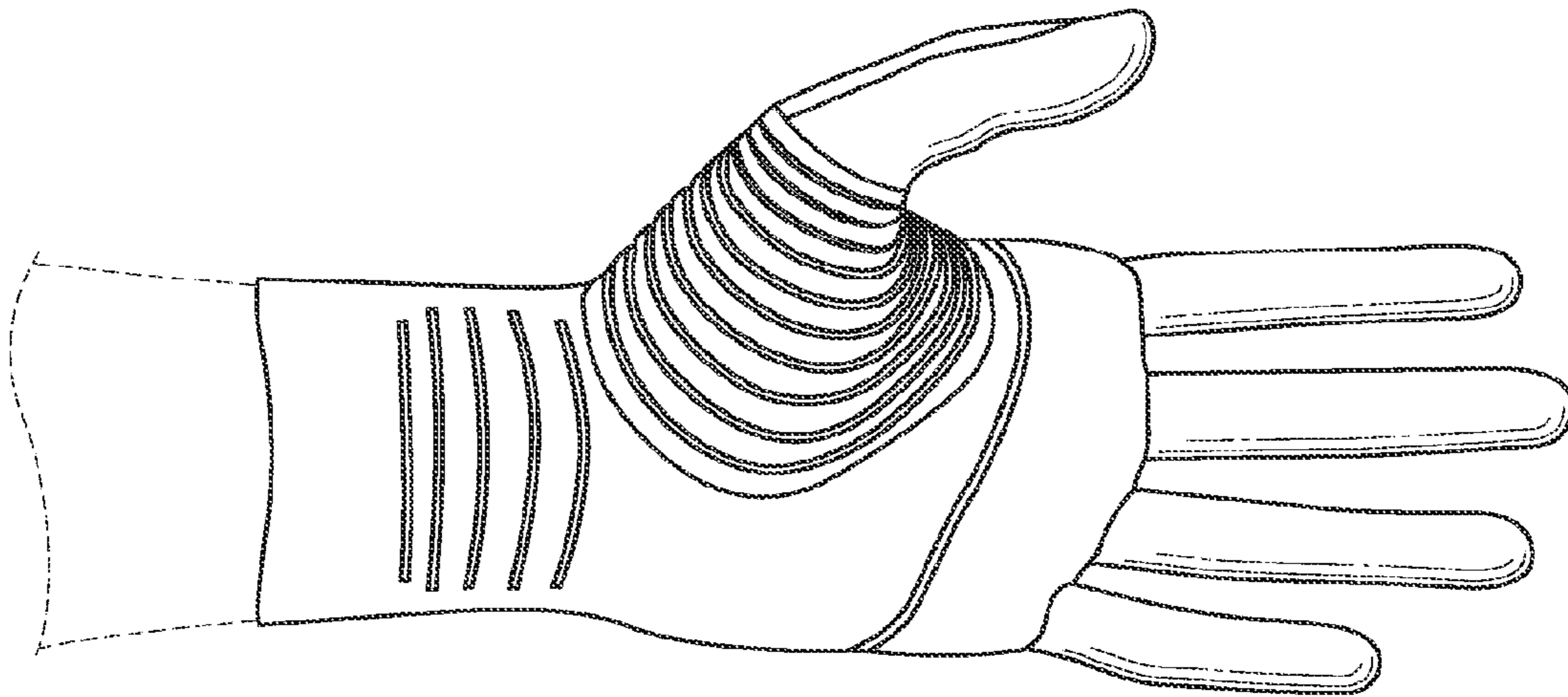

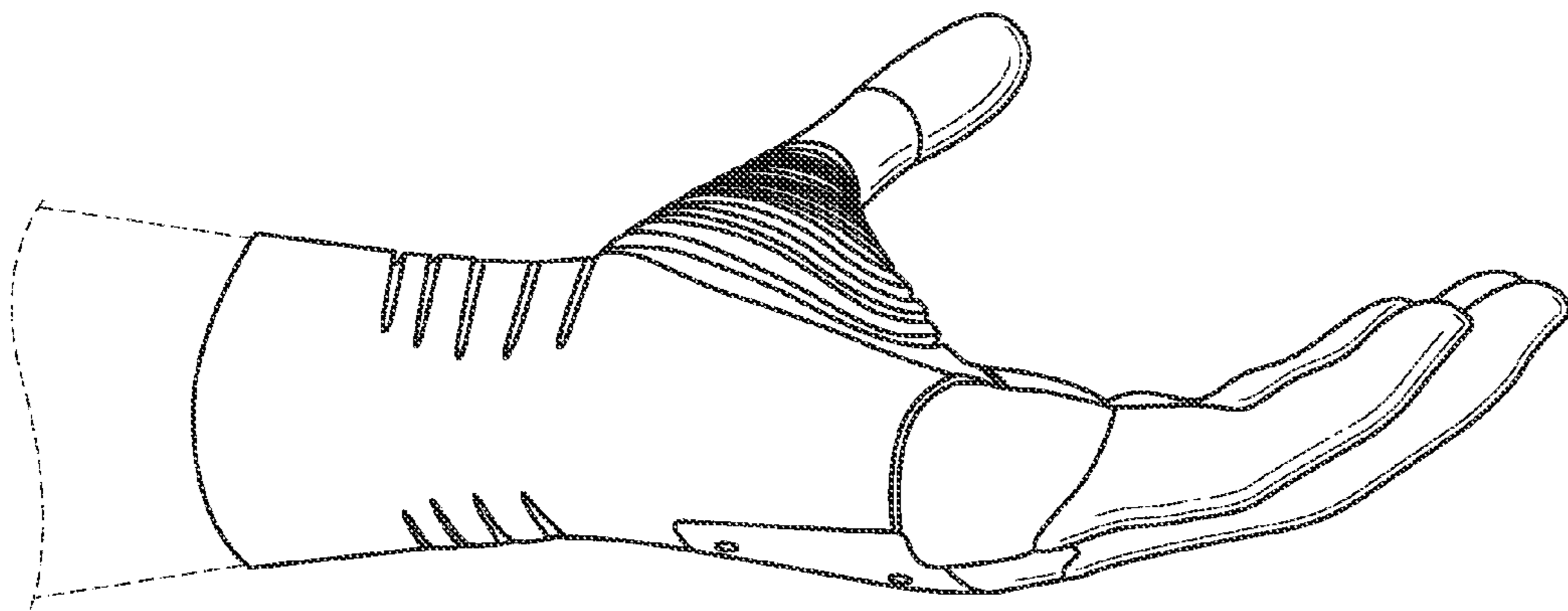

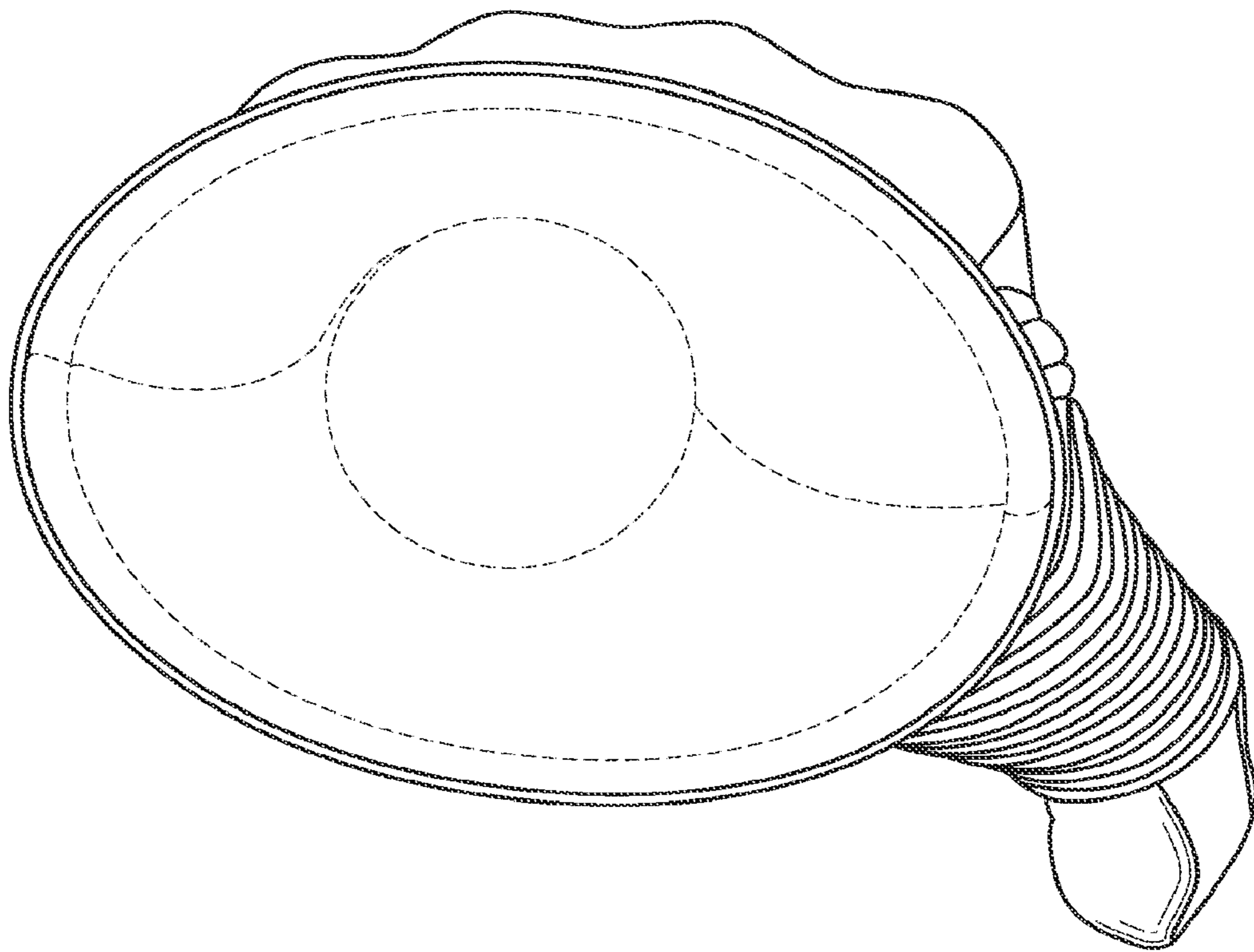
