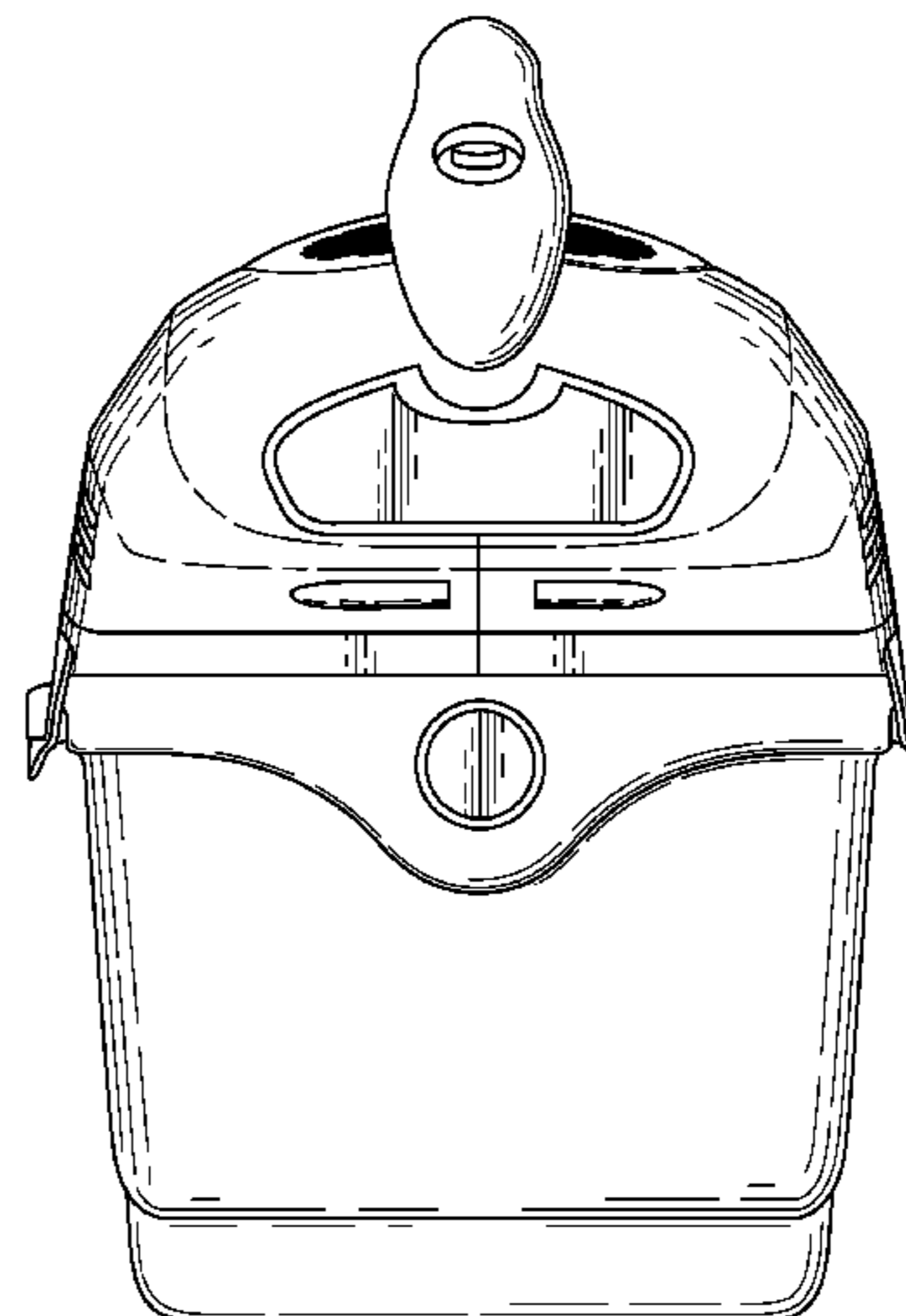
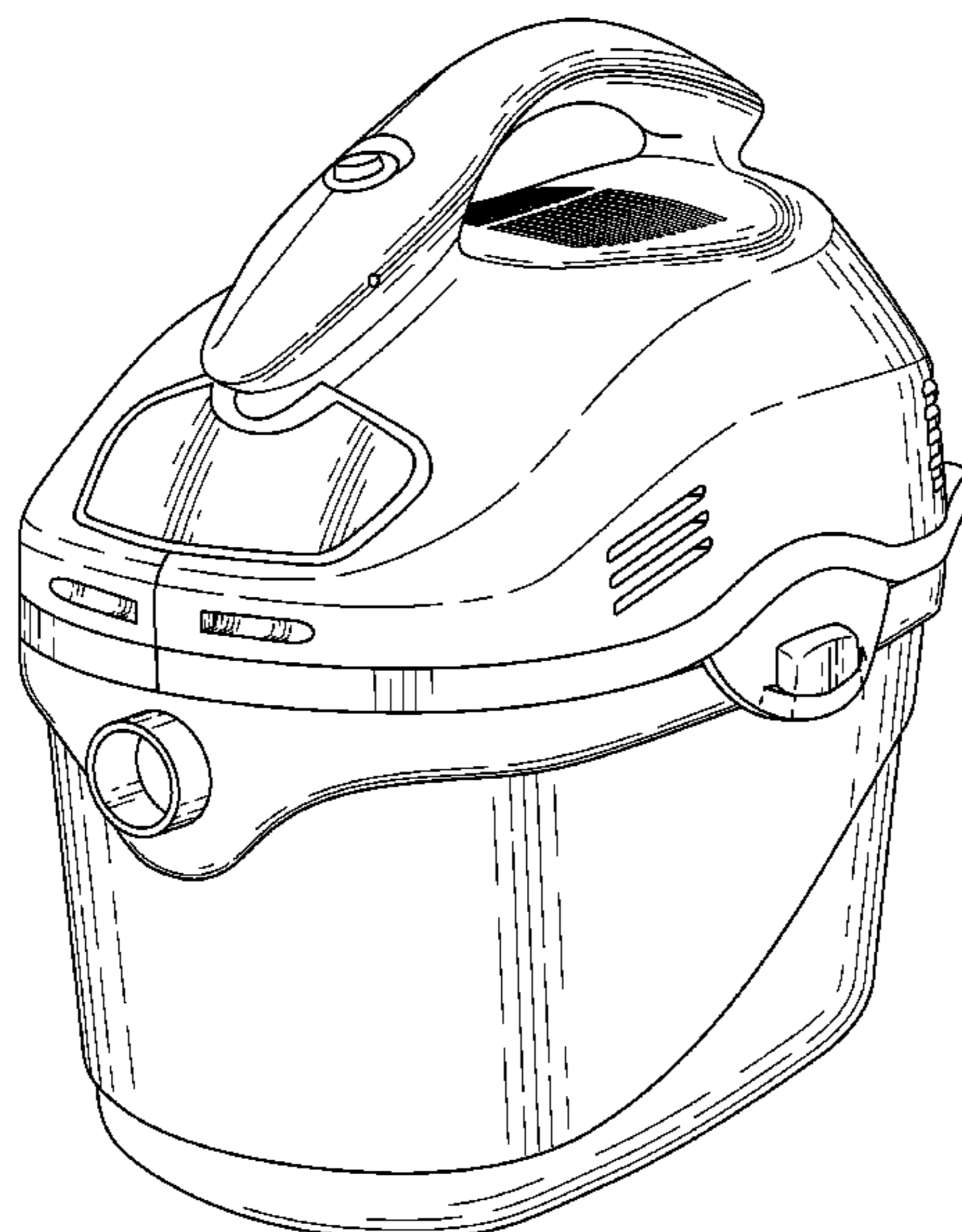
(57) **CLAIM**

The ornamental design for a portable wet/dry vacuum appliance, as shown and described.

DESCRIPTION

FIG. 1 is a isometric front perspective view of a portable wet/dry vacuum appliance showing our design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is a side view showing the side opposite that shown in FIG. 4; and,
FIG. 6 is a top plan view thereof.

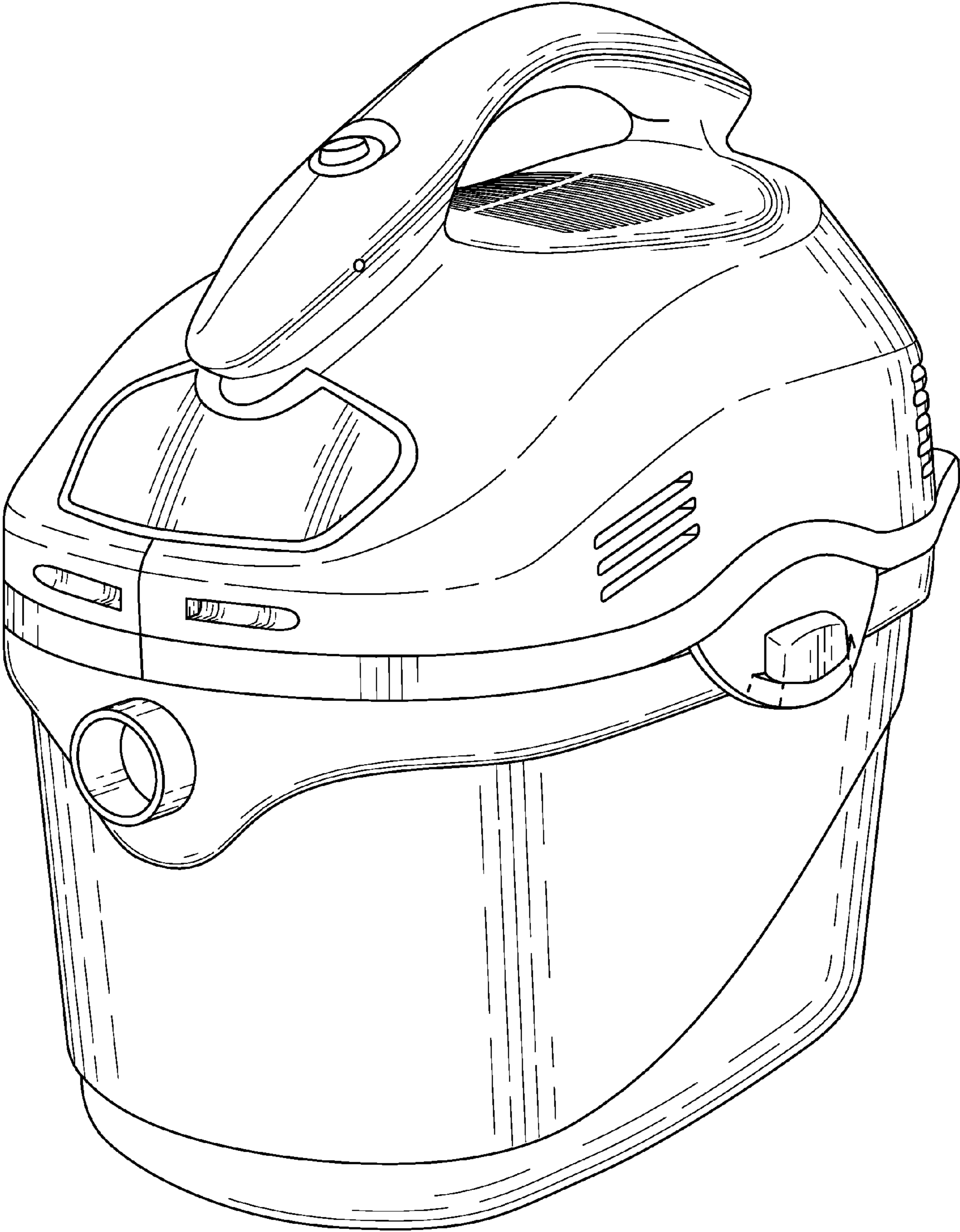

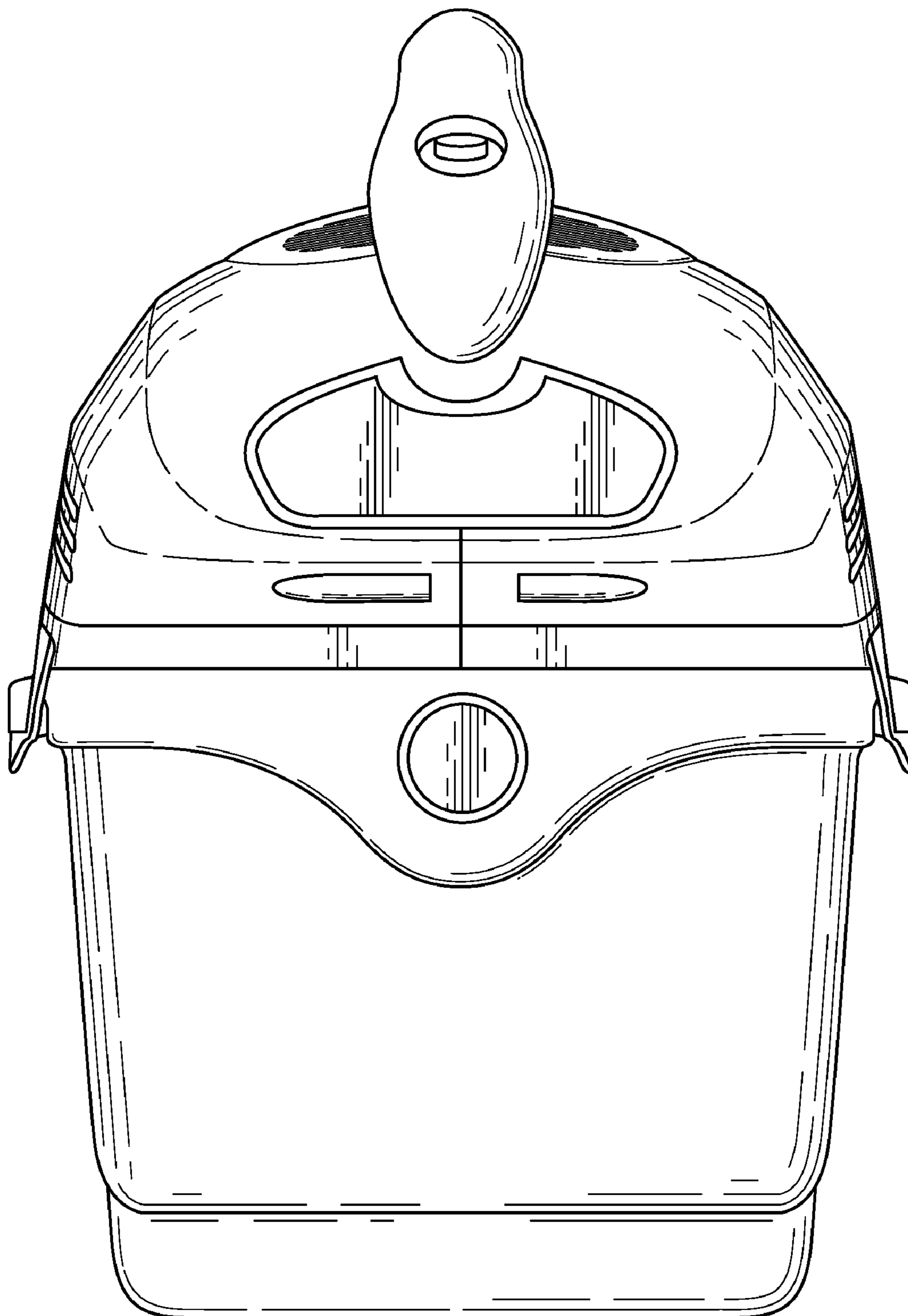

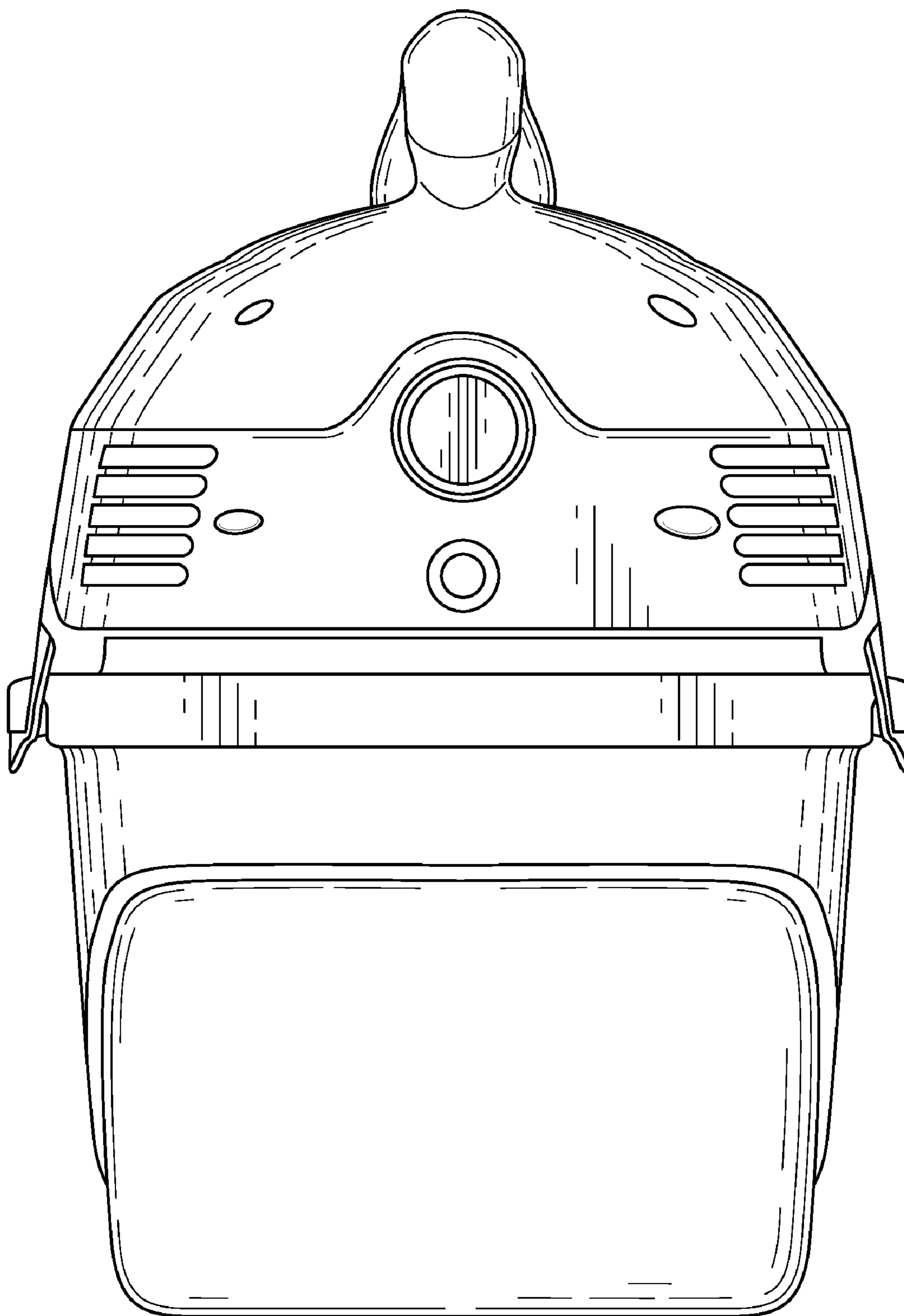

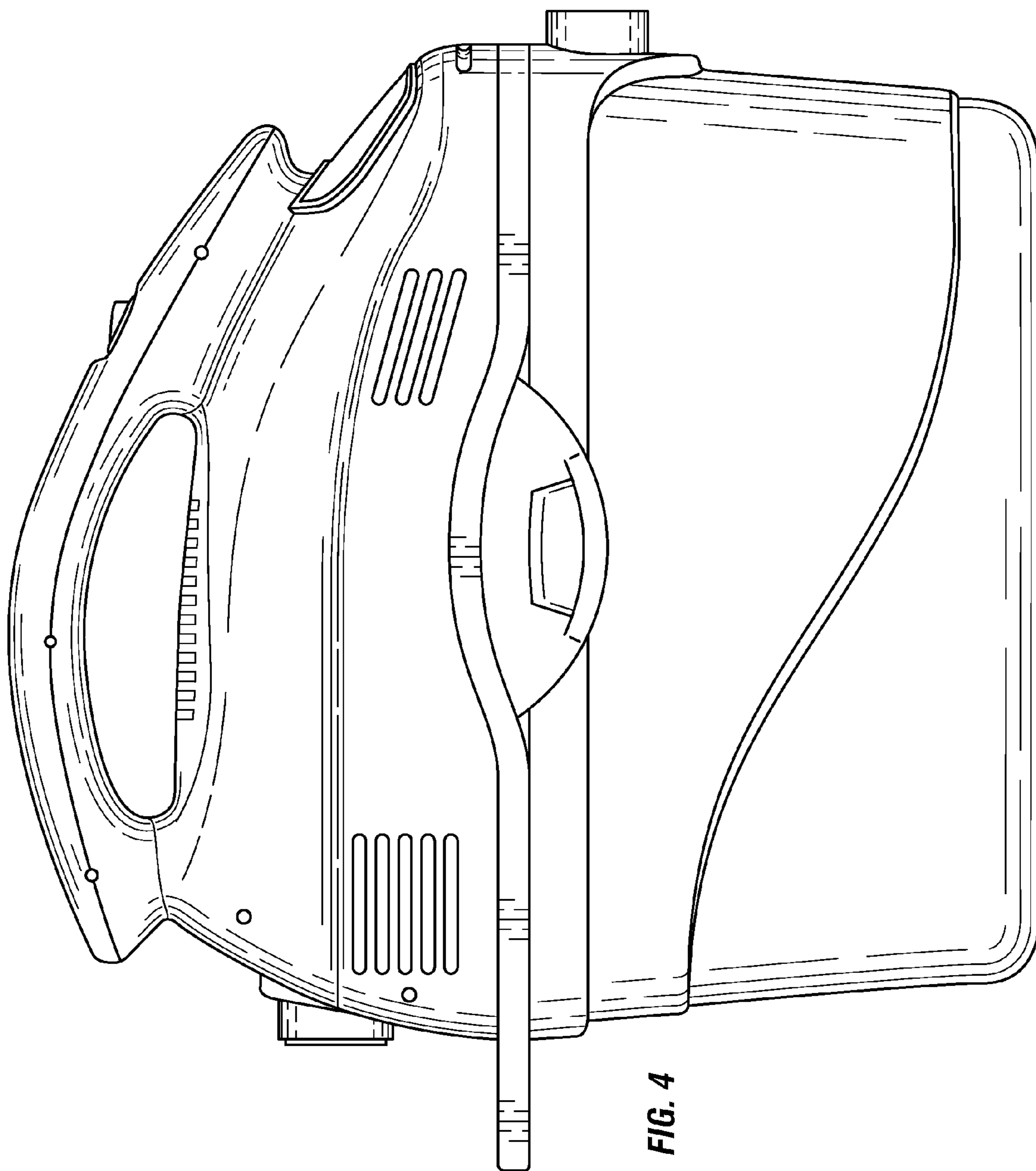

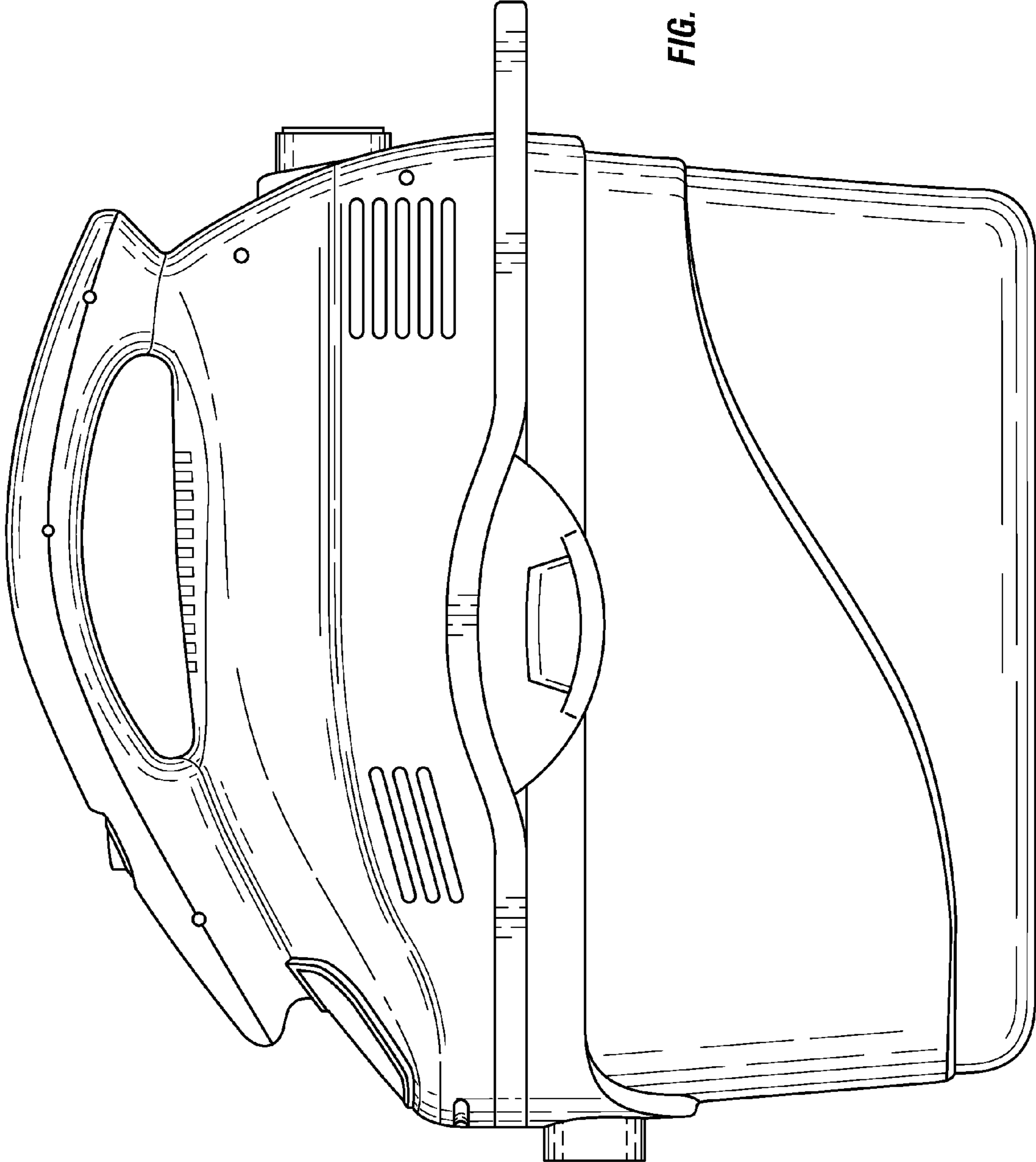

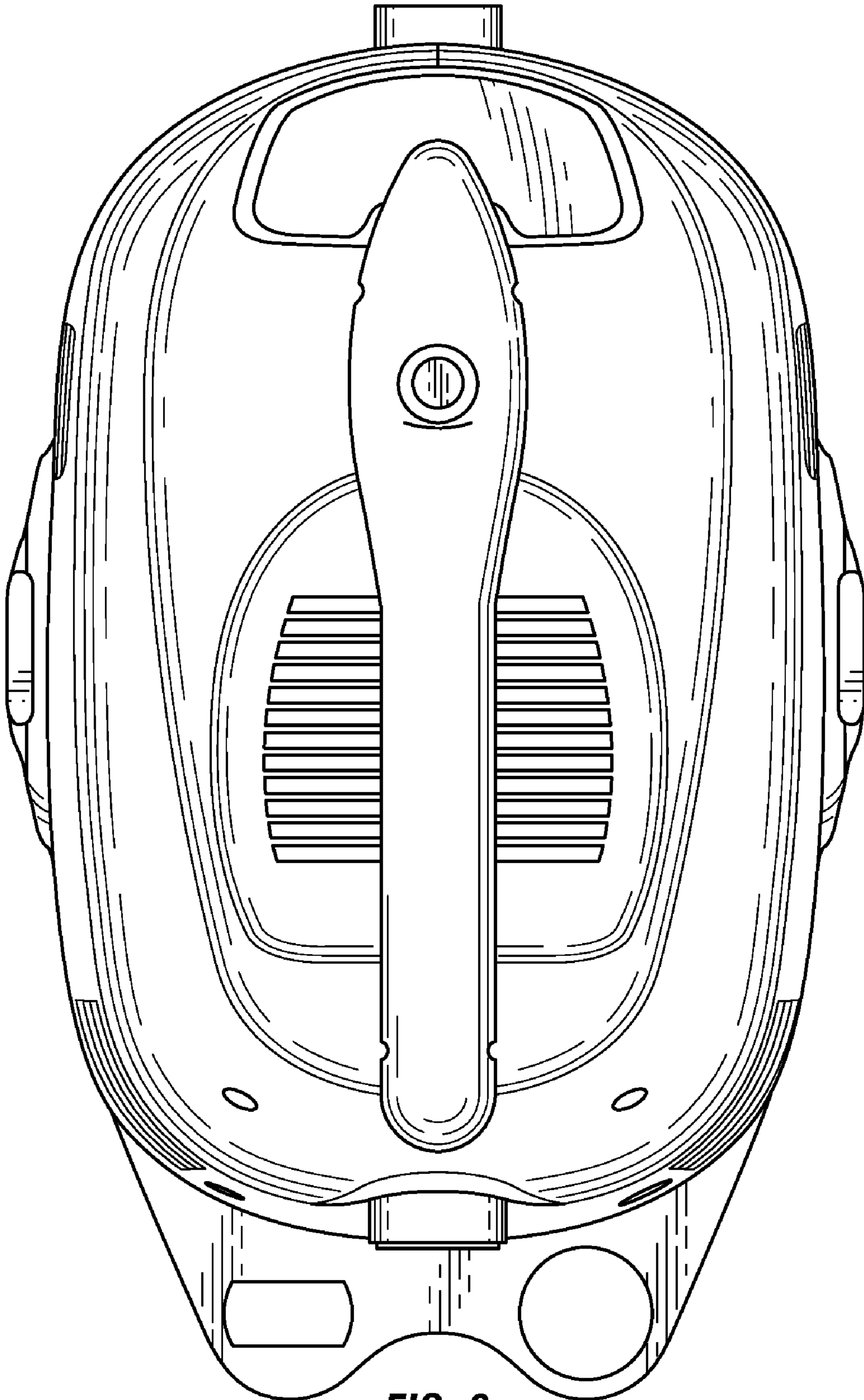
