(57) **CLAIM**

The ornamental design for a coin holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a coin holder, showing my design.

FIG. 2 is a front elevational view;

FIG. 3 is a rear elevational view;

FIG. 4 is a side elevational view when viewed from the right side;

FIG. 5 is a side elevational view when viewed from the left side;

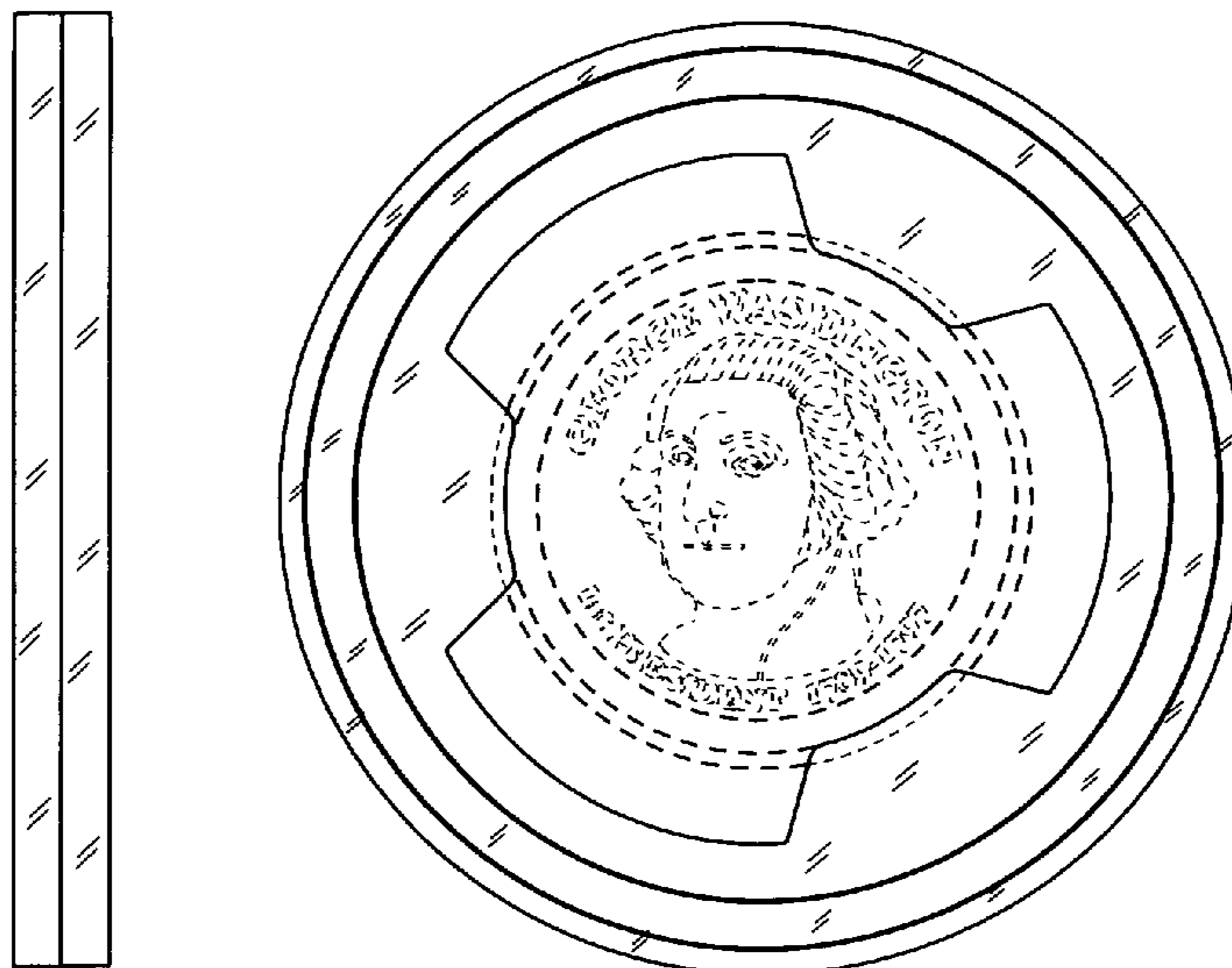
FIG. 6 is a top plan view;

FIG. 7 is a bottom plan view; and,

FIG. 8 is a front elevational view with the coin holder retaining a coin therein.

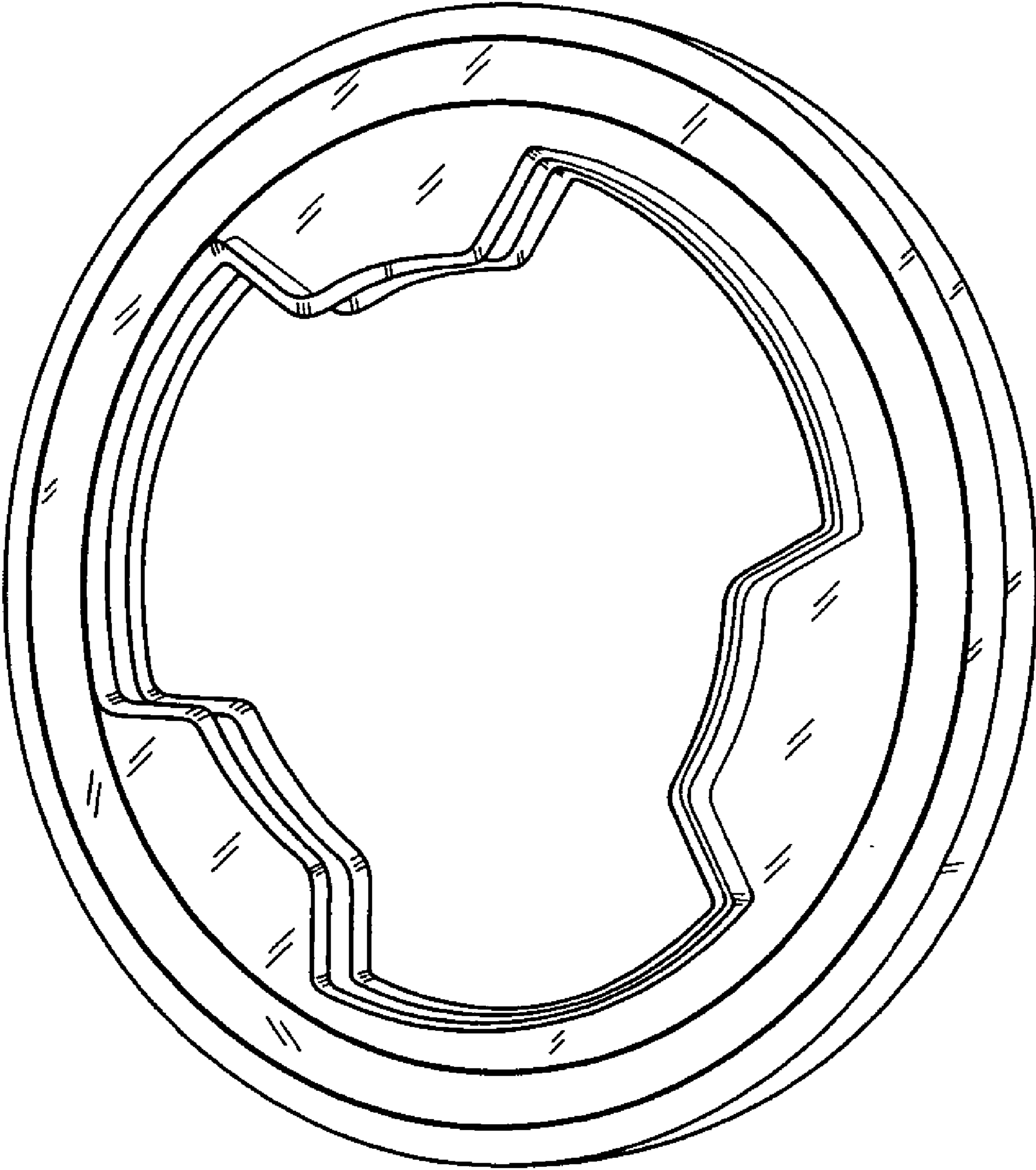

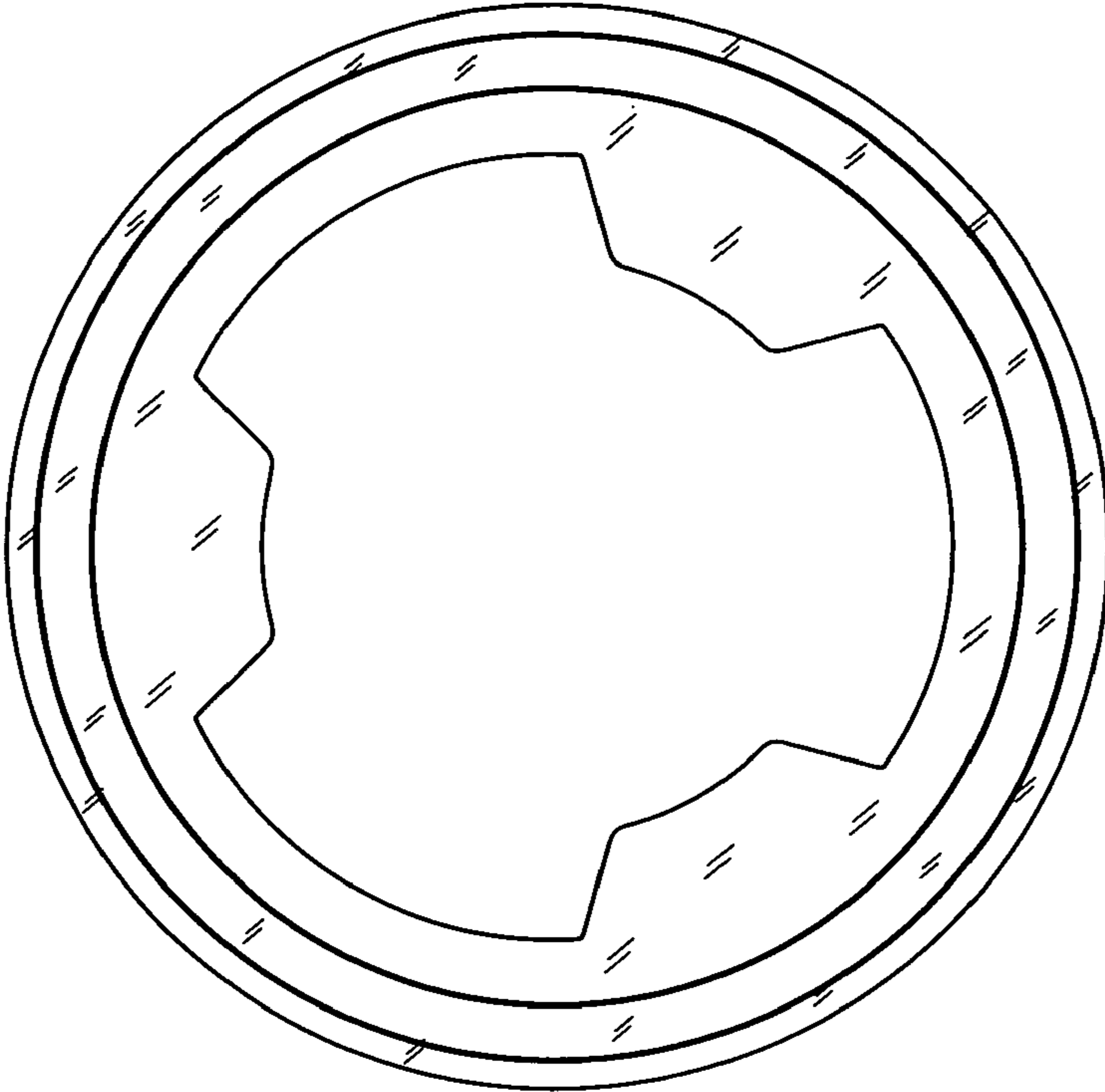

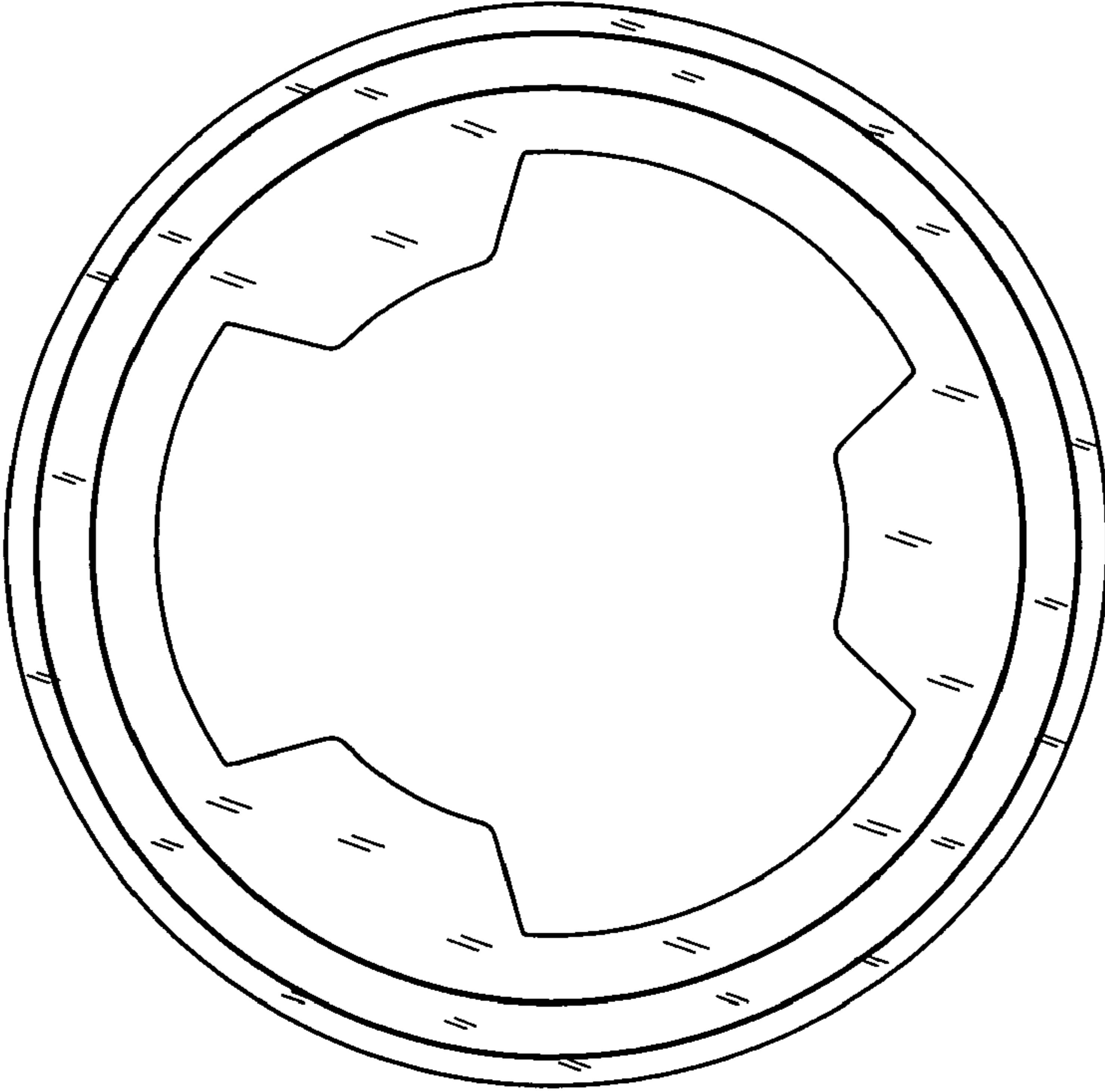

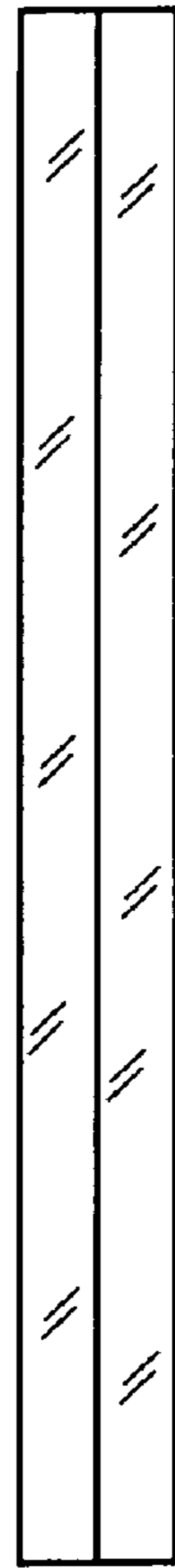

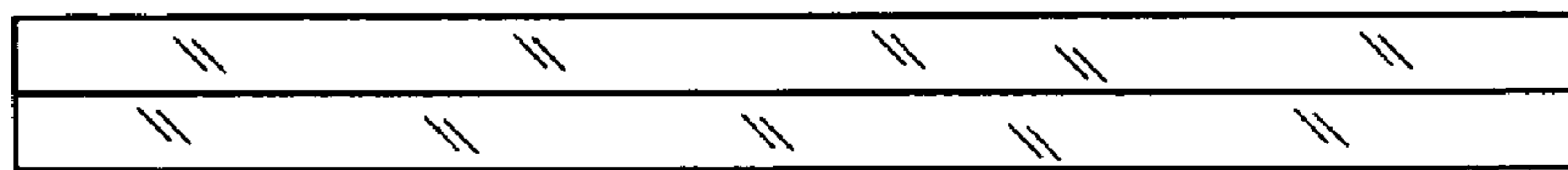

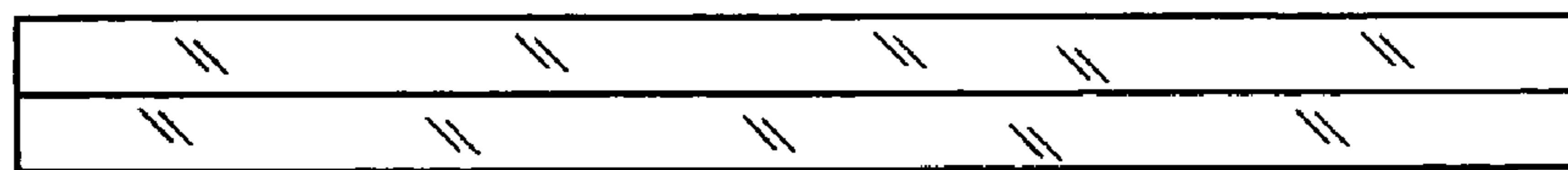

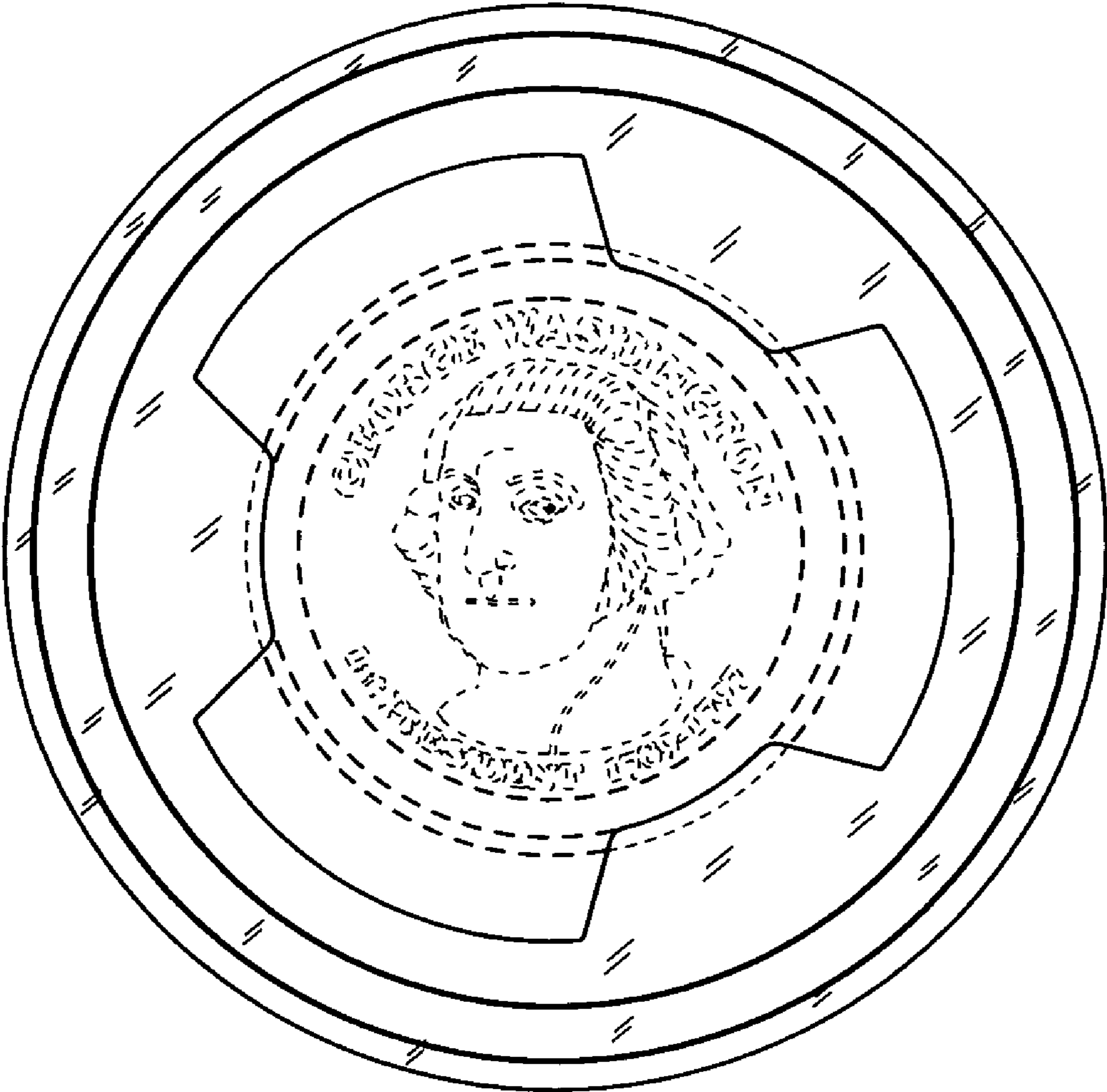
