as shown and described.

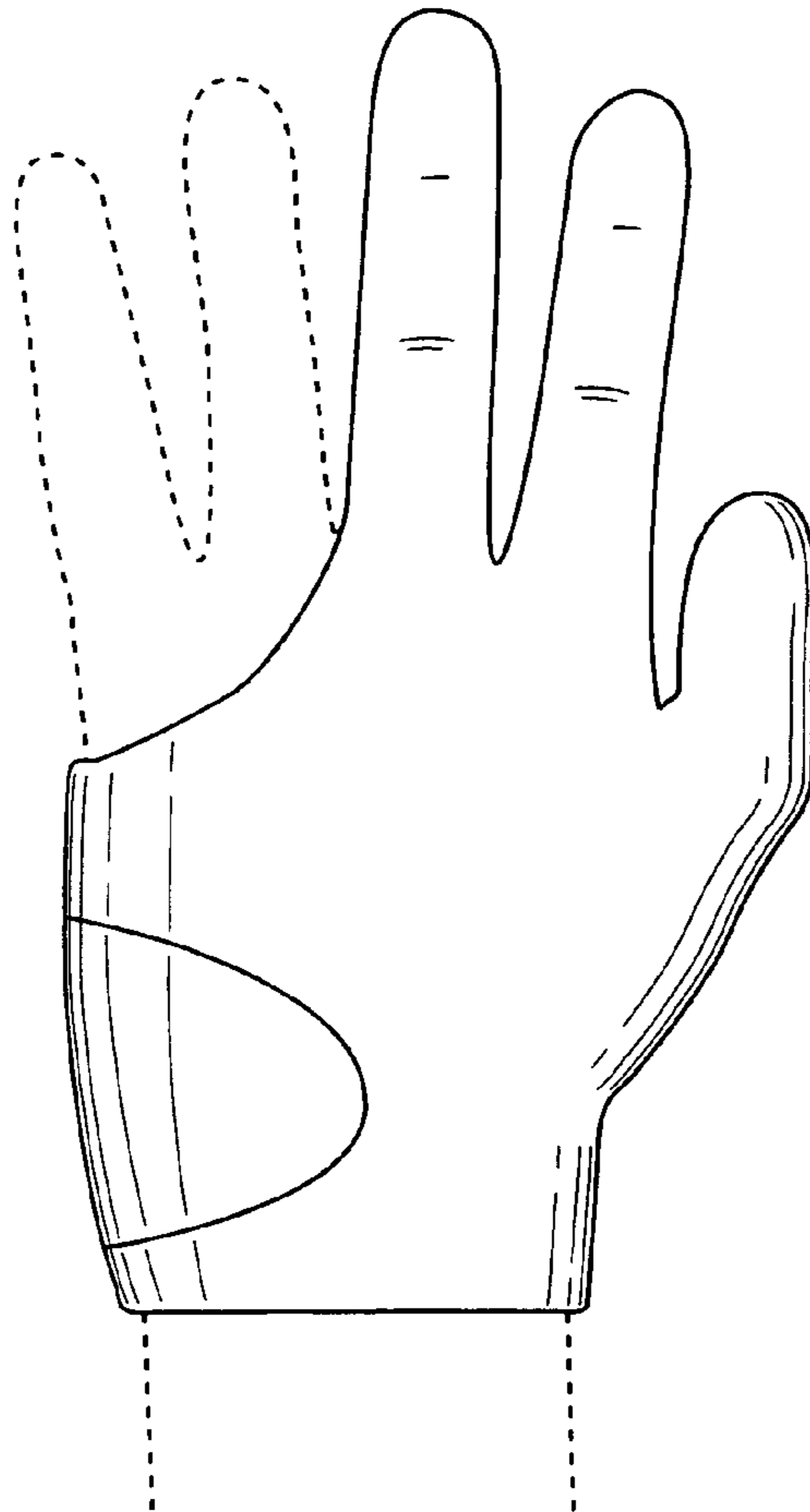
**DESCRIPTION**

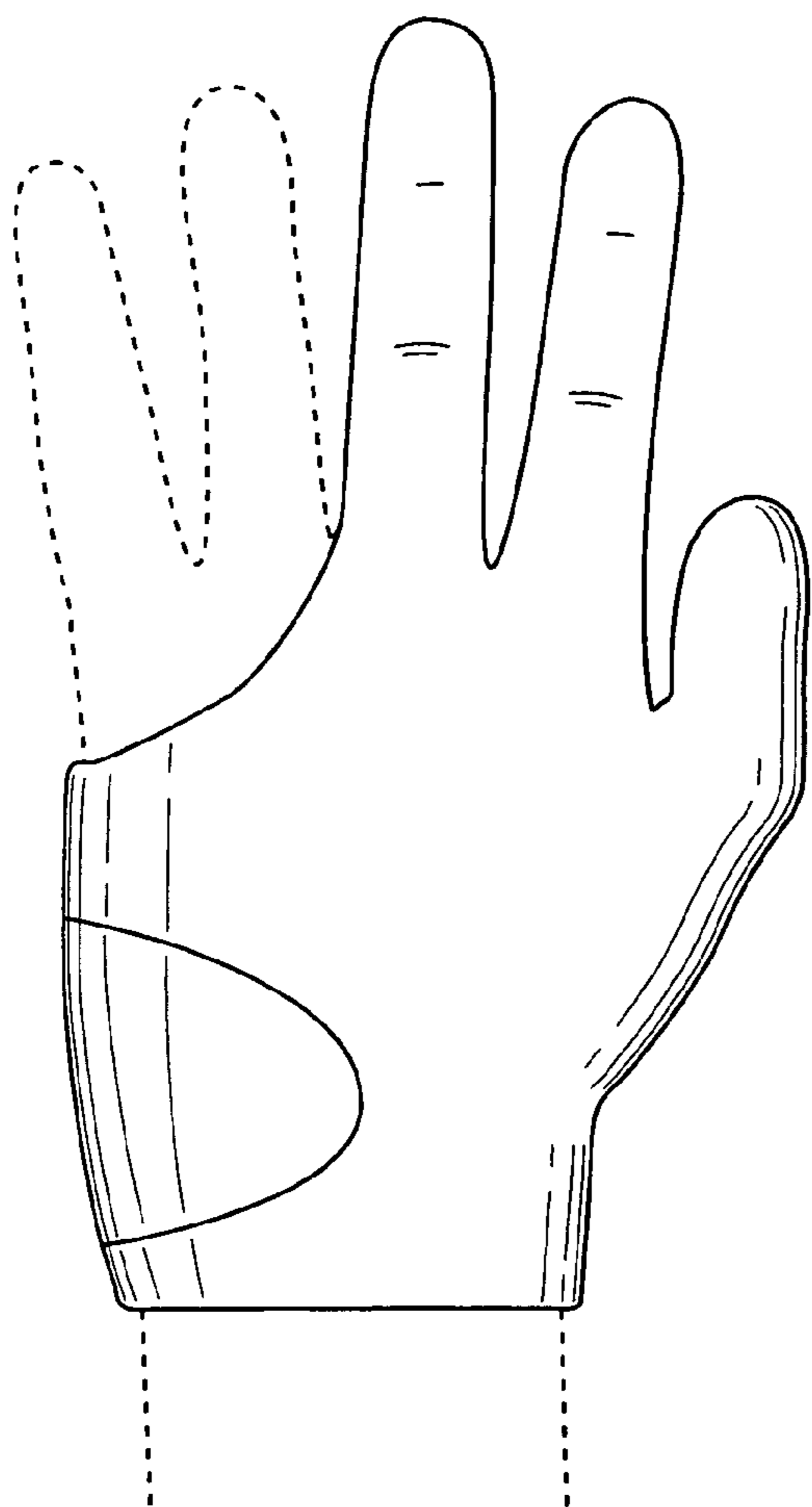
FIG. 1 is a top plan view of my design for an electronic game

FIG. 2 is a bottom (palm) plan view thereof.

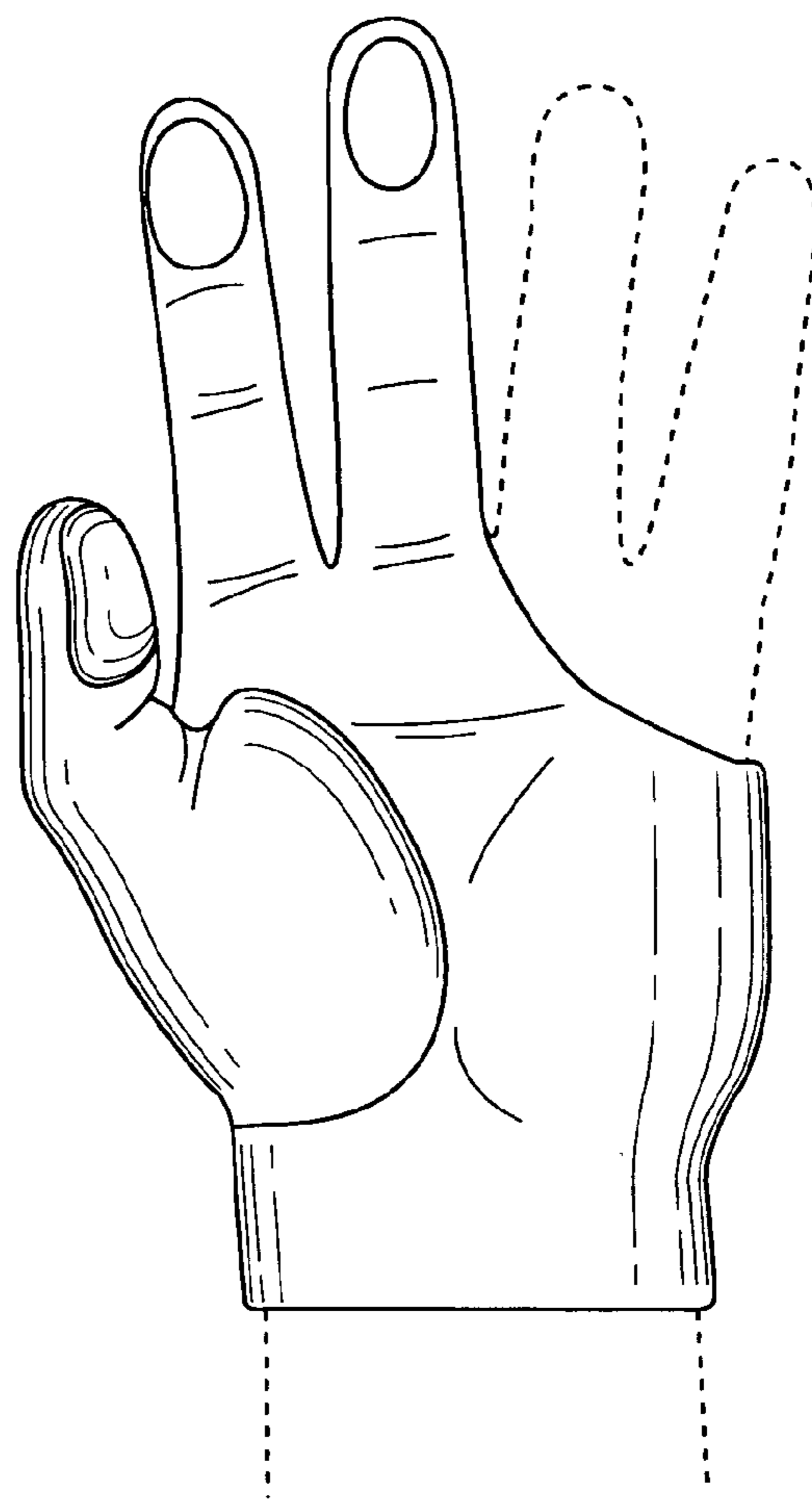
The broken line showing of a hand is included for the purpose
