FIG. 5 is a side view of the new design;

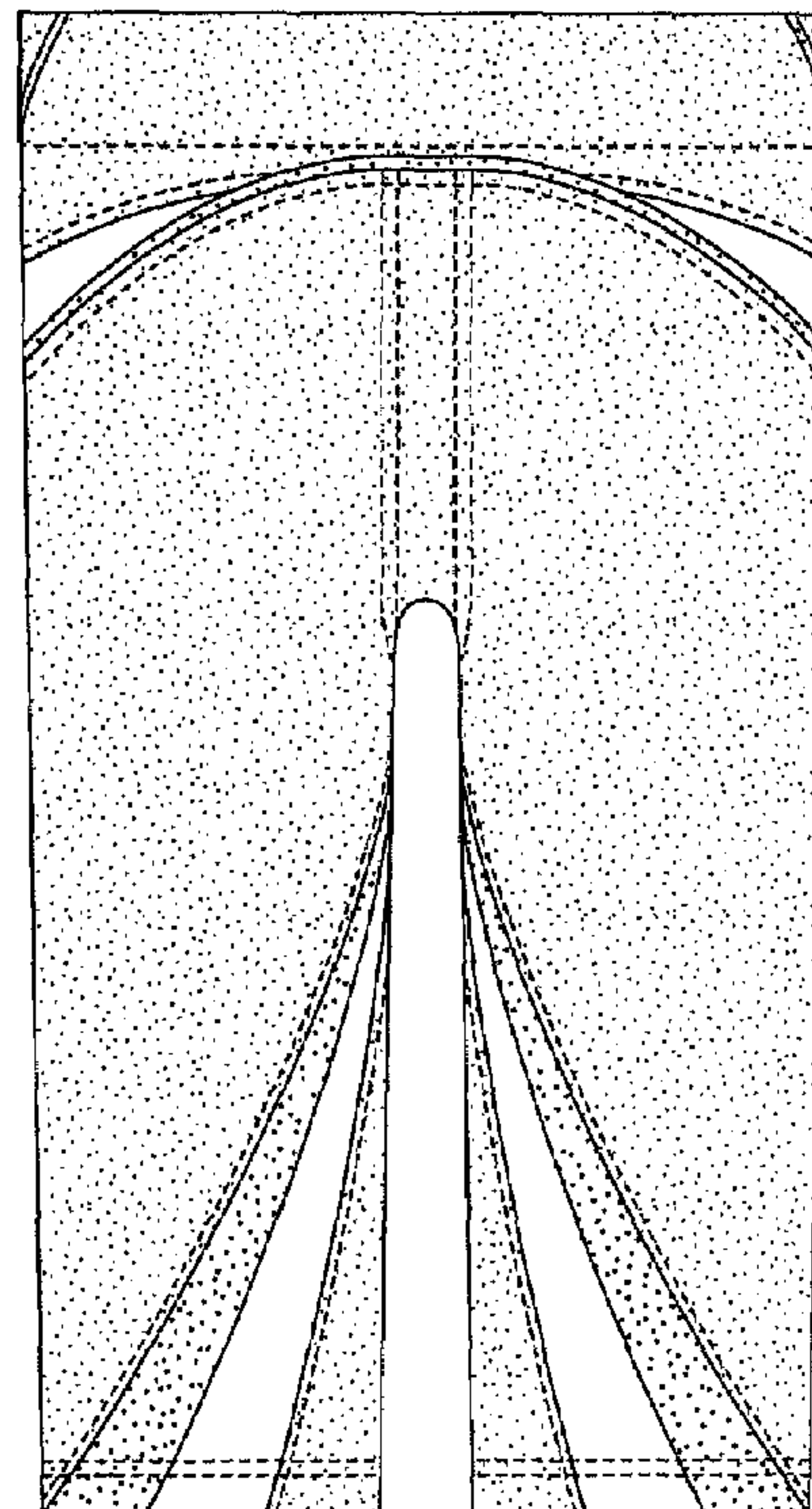
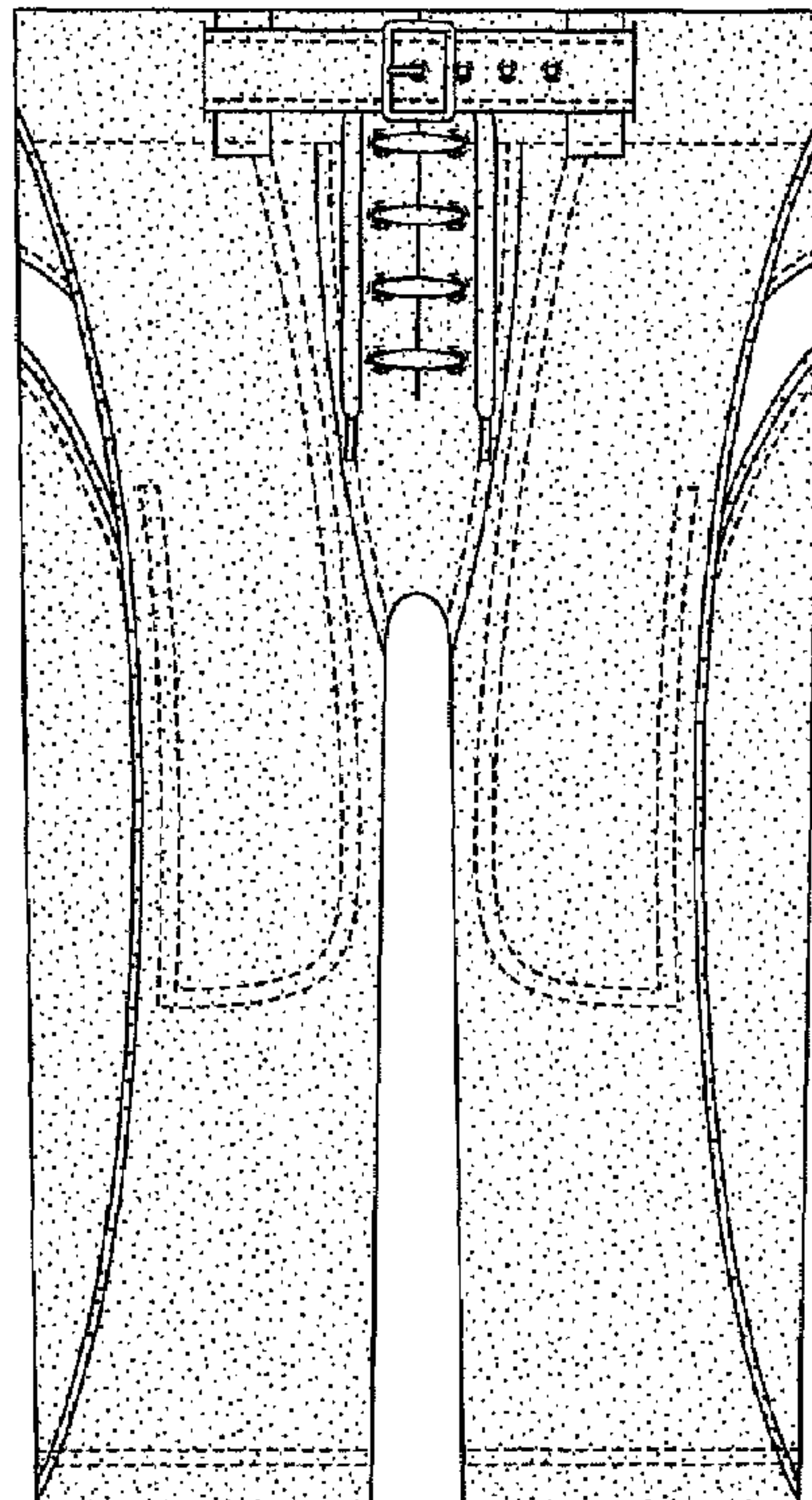
FIG. 6 is a top view of the pant design;

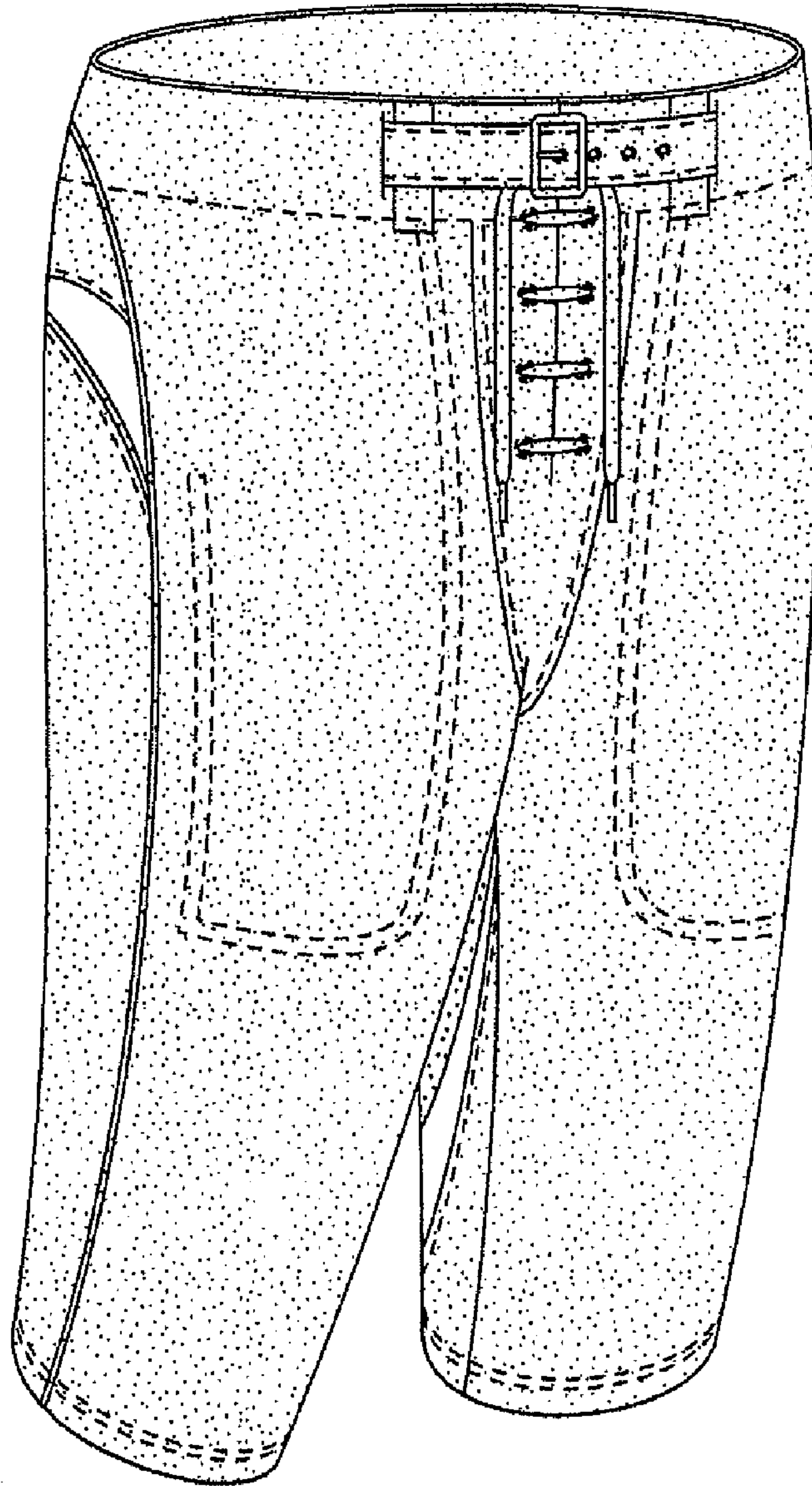

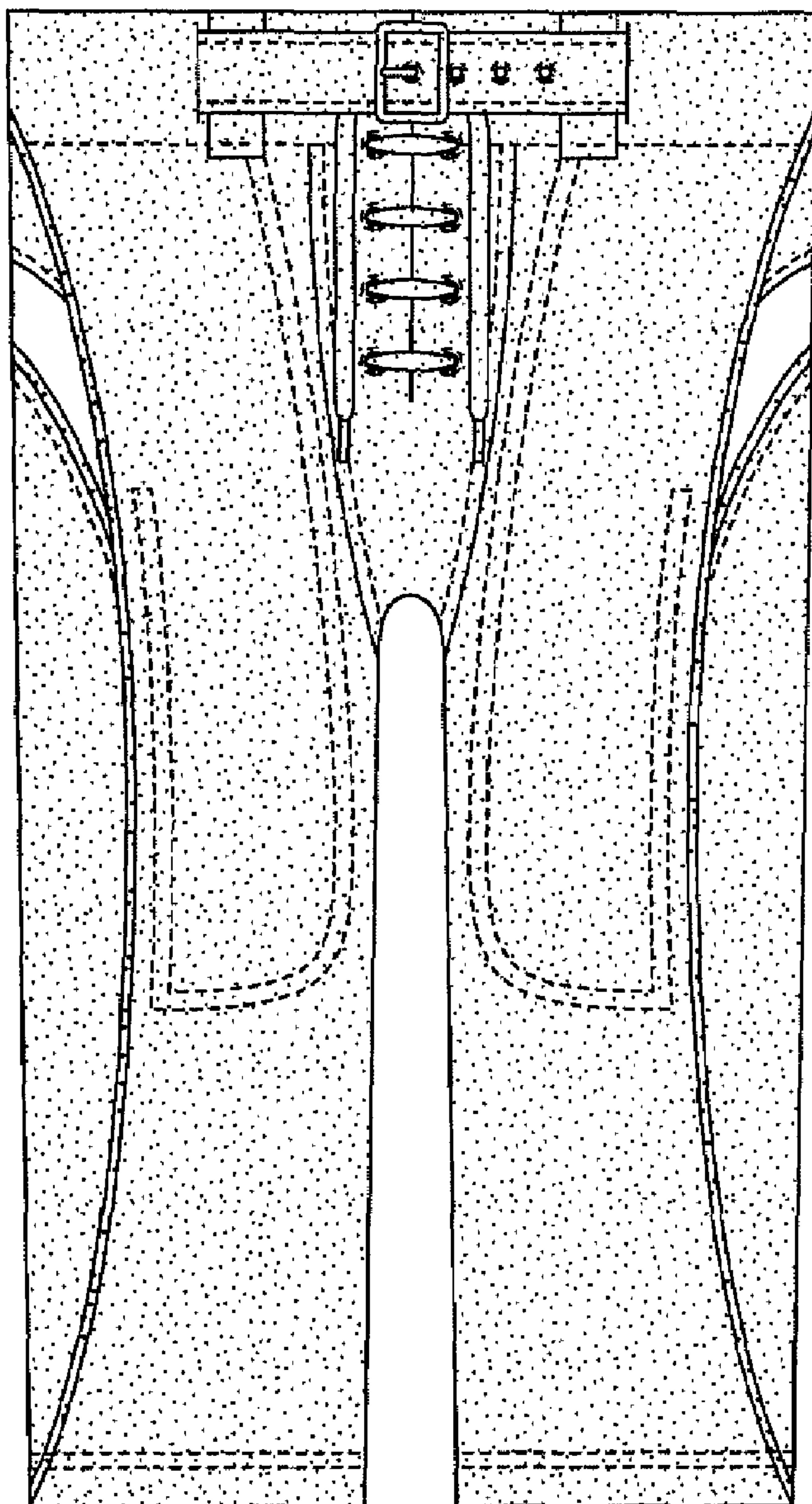

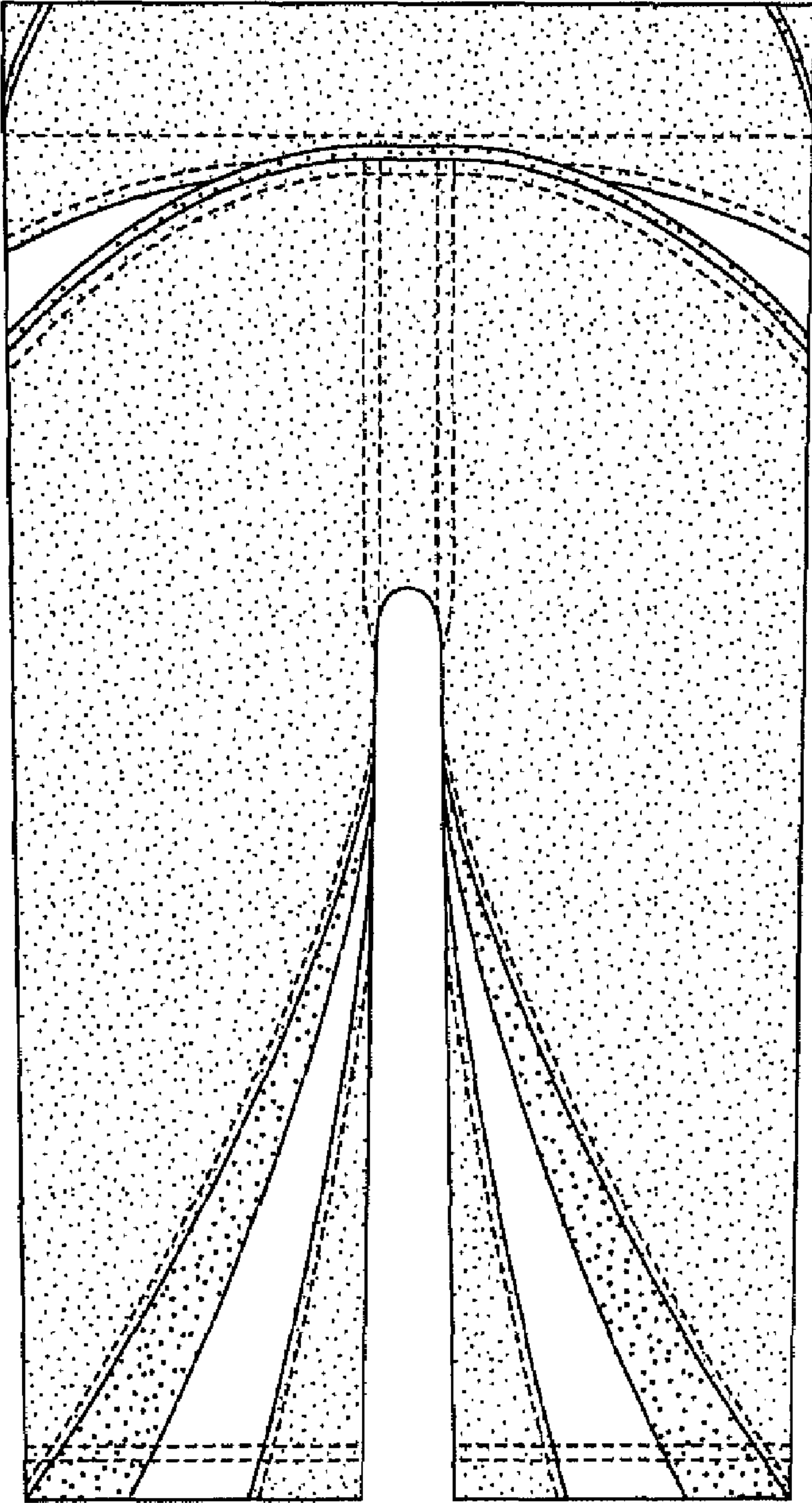

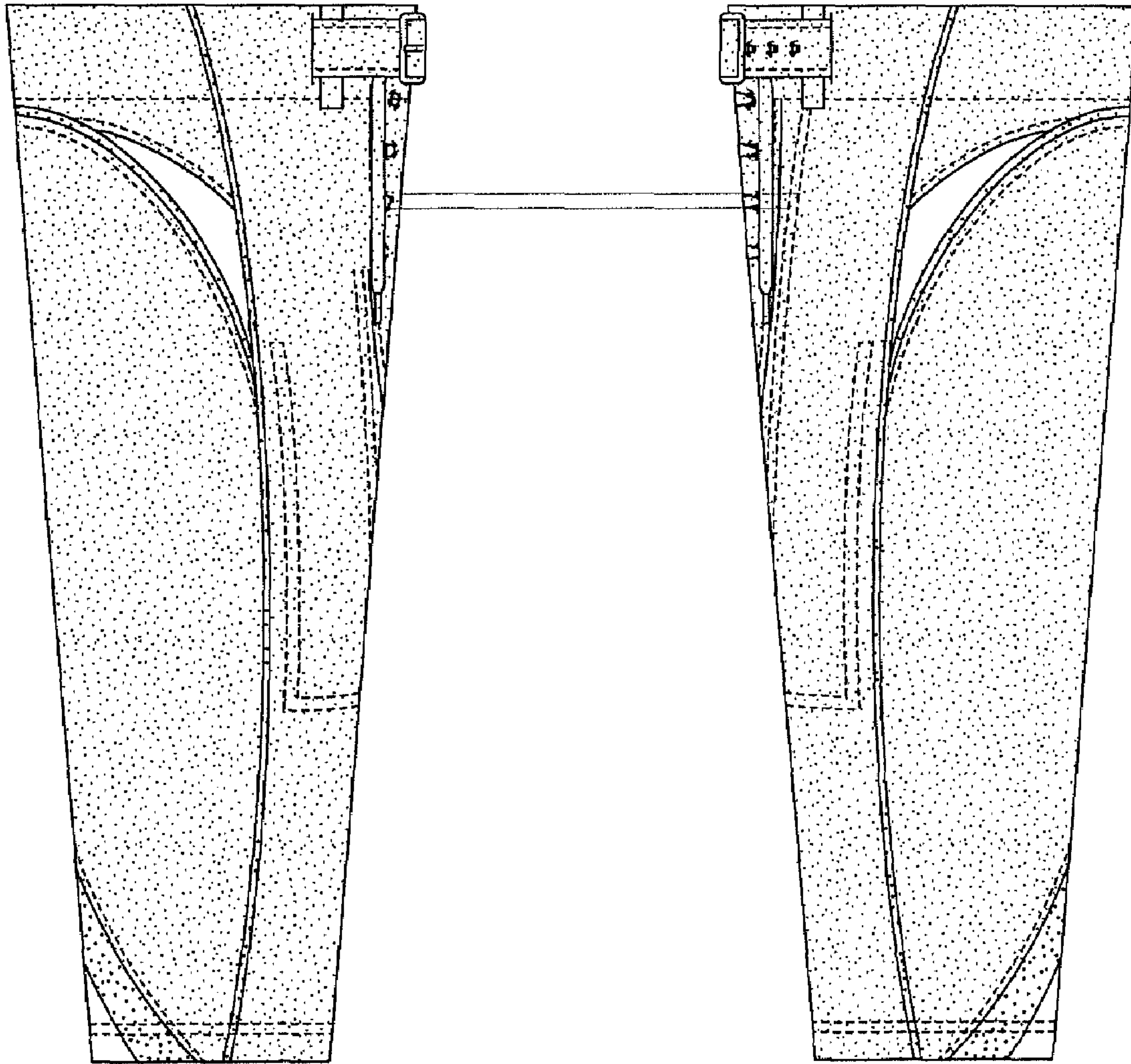

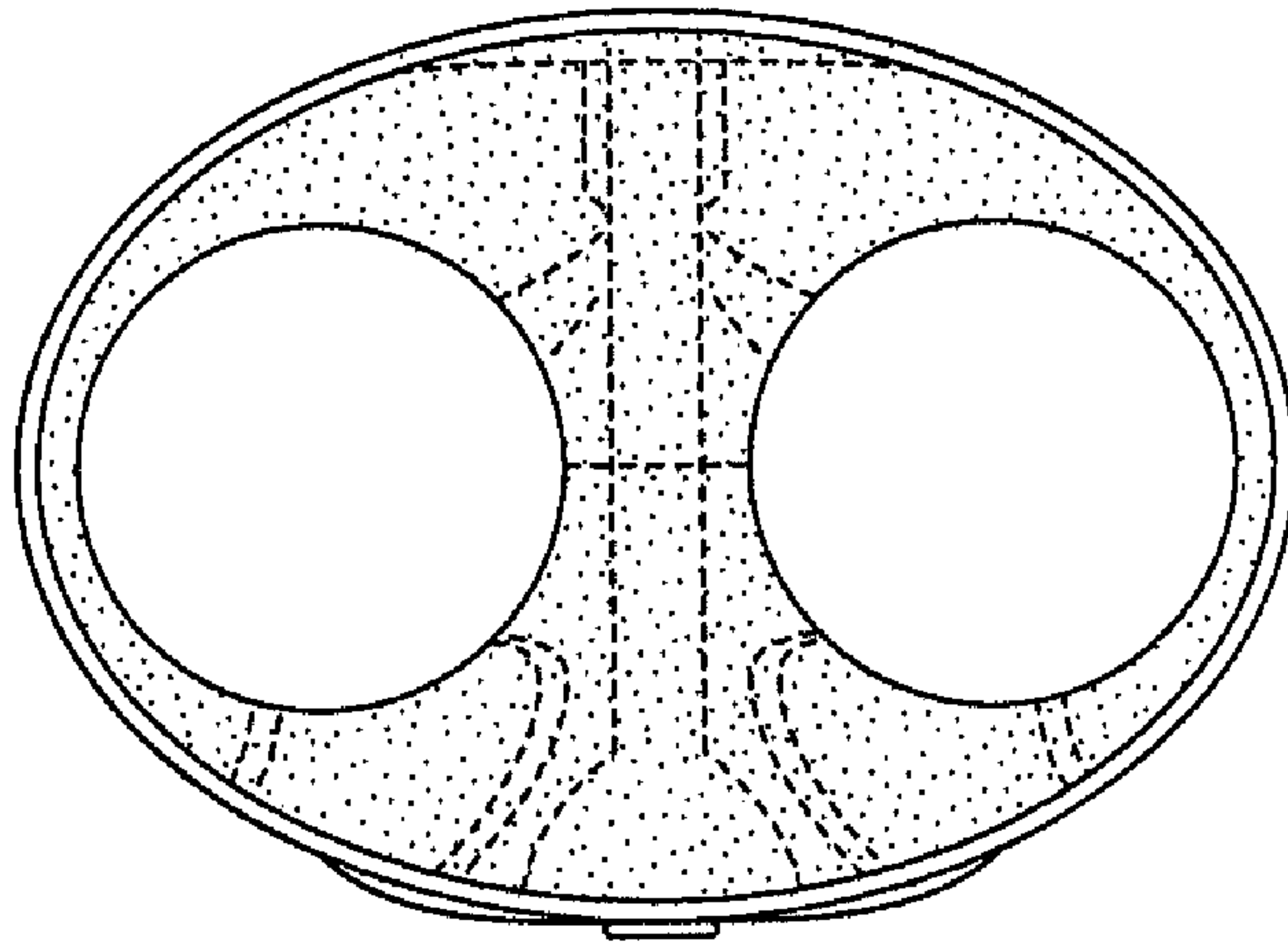

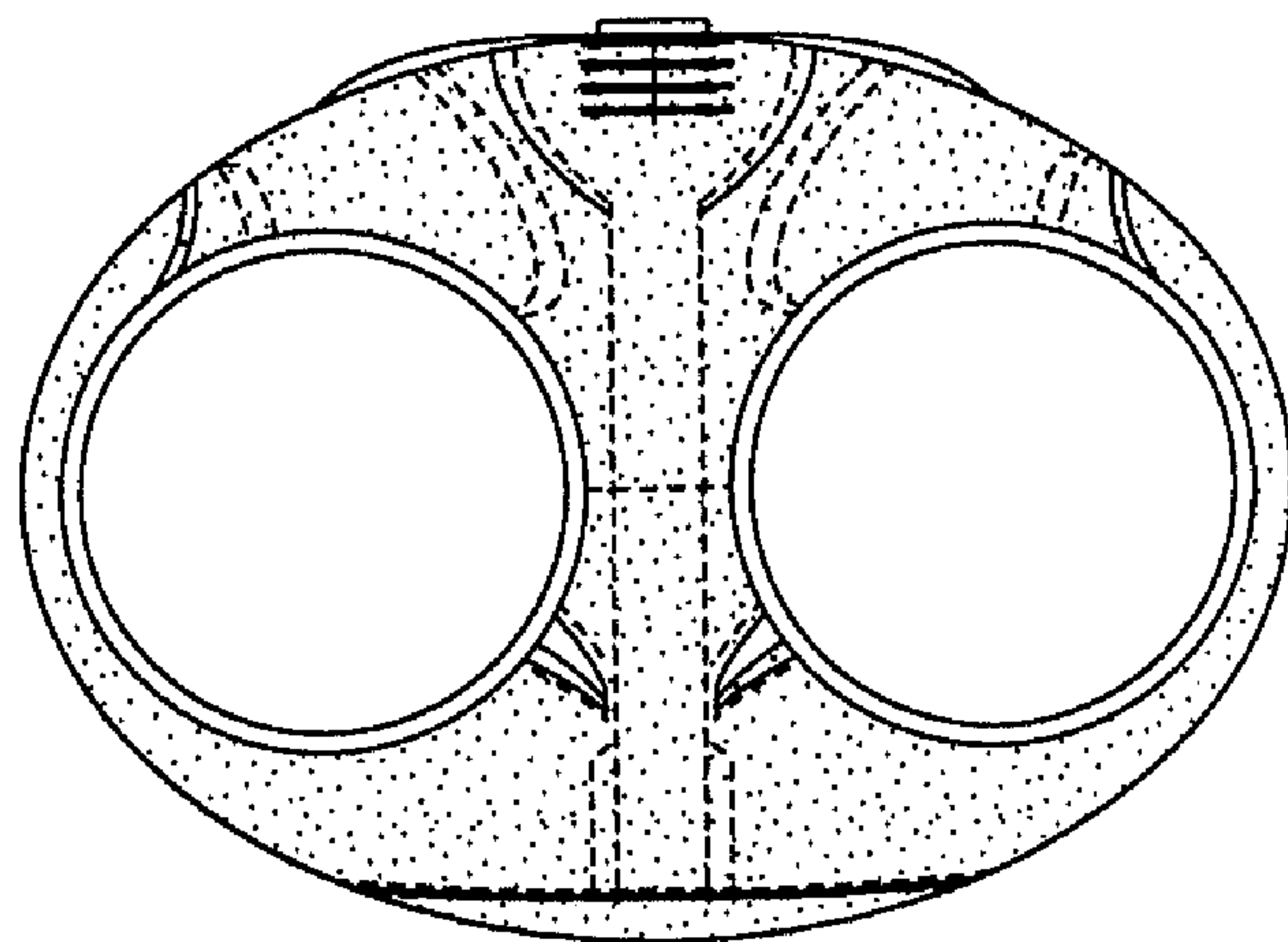

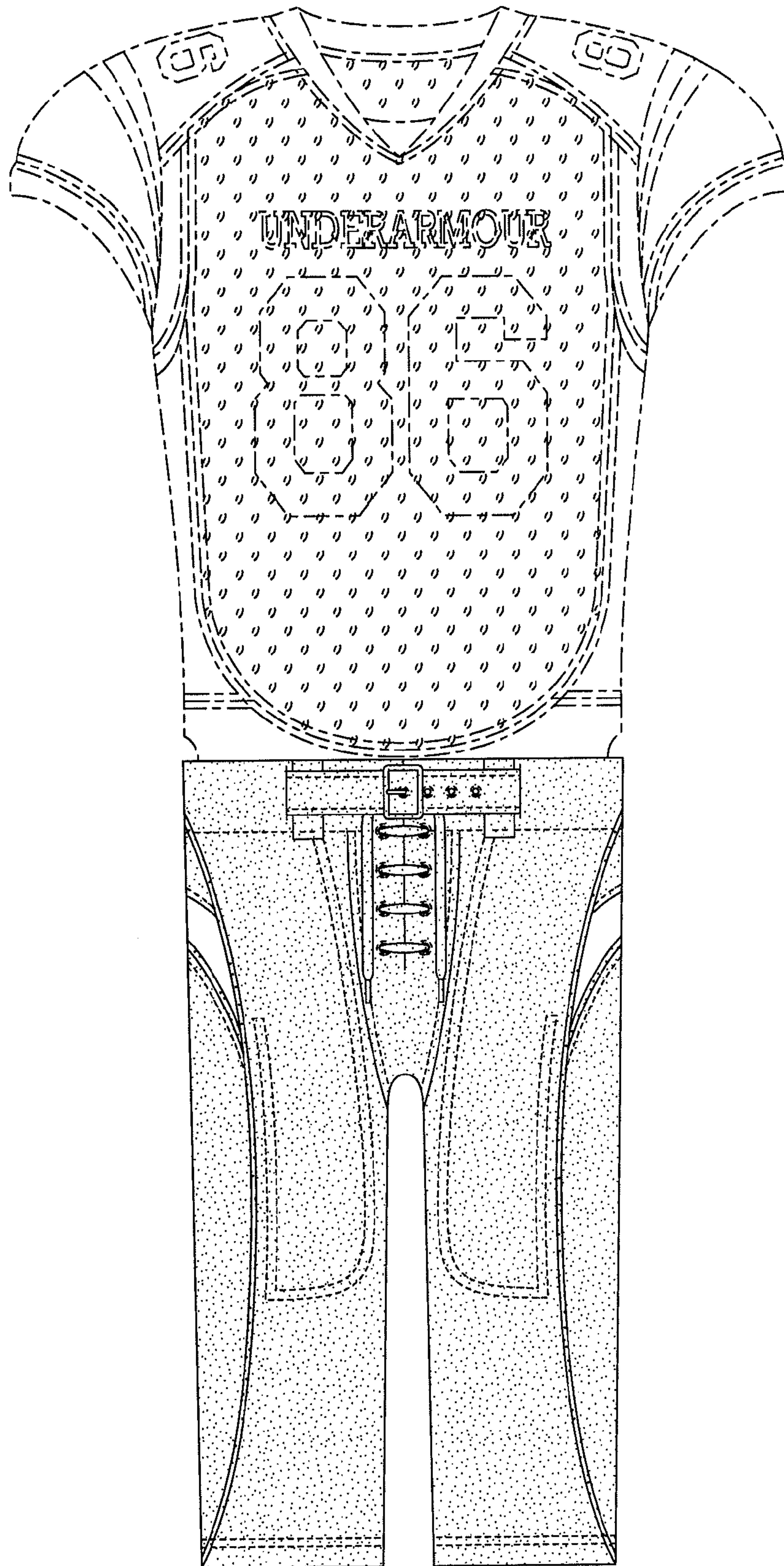
