(57) **CLAIM**

The ornamental design for a skirt with straps, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a skirt with straps showing a dashed line indicating a seam along the outside edge of each strap;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

The broken lines are for illustrative purposes only and form no part of the claimed design.

The broken lines in FIGS. 1-7, on the surface of the straps, represent seams.

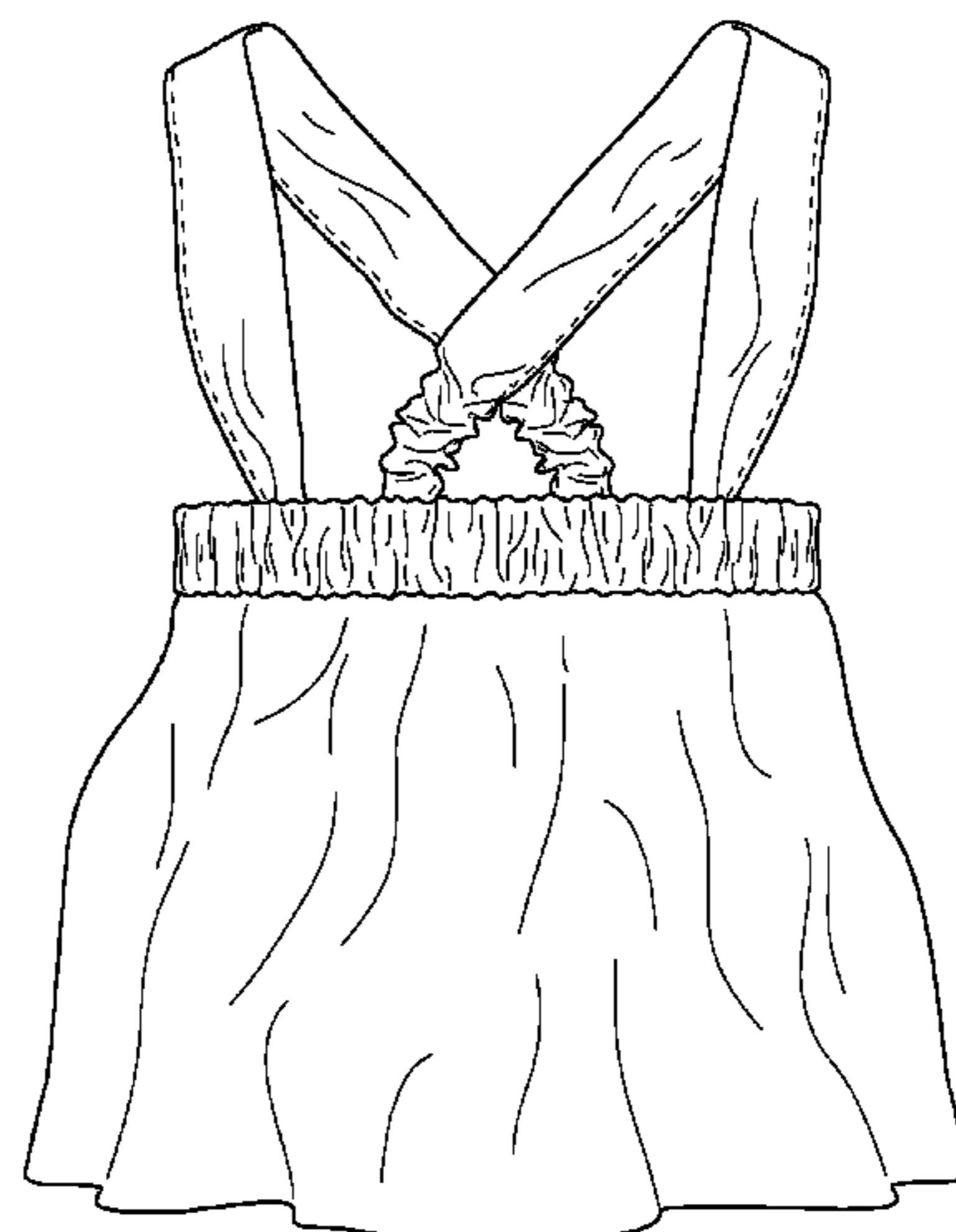

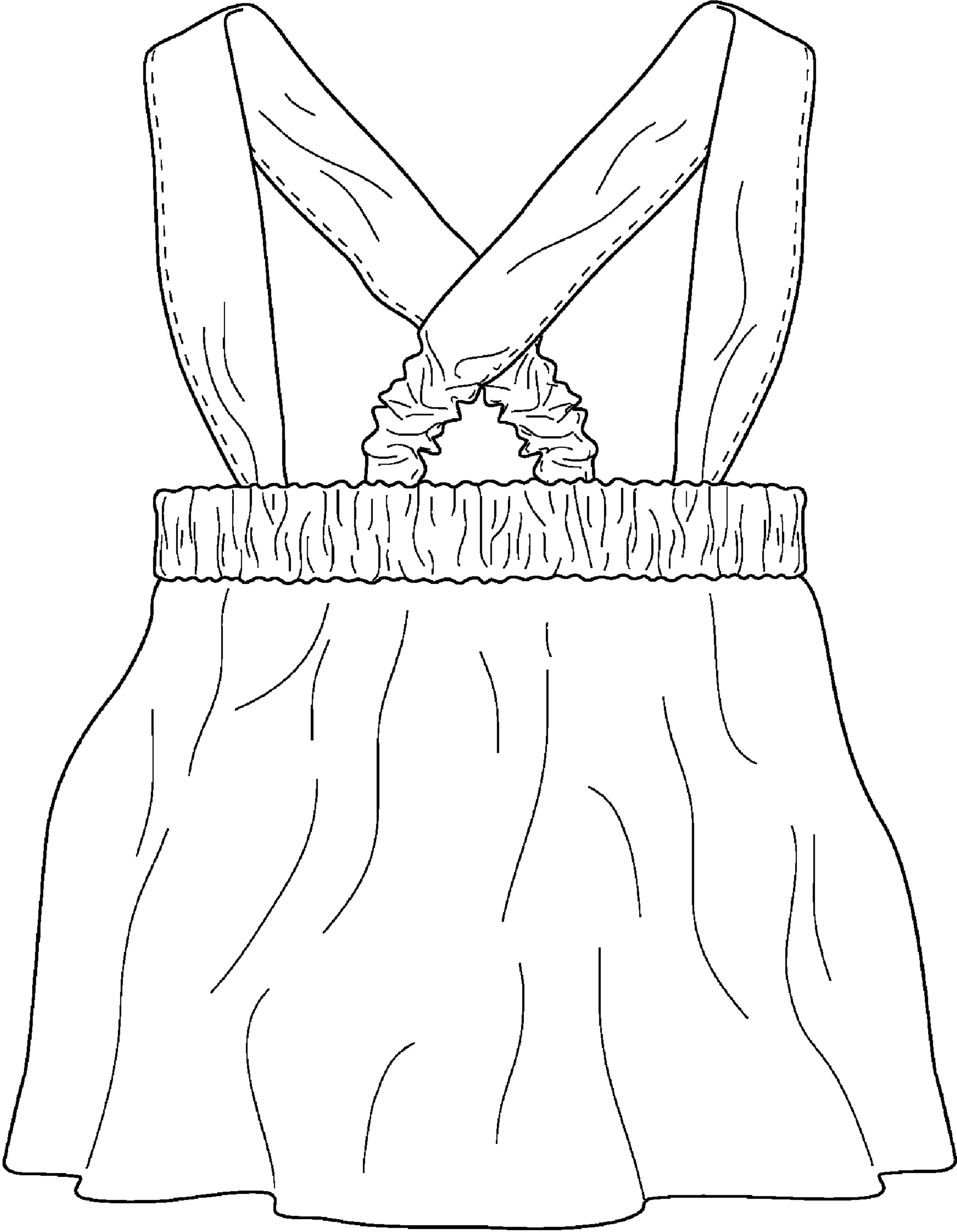

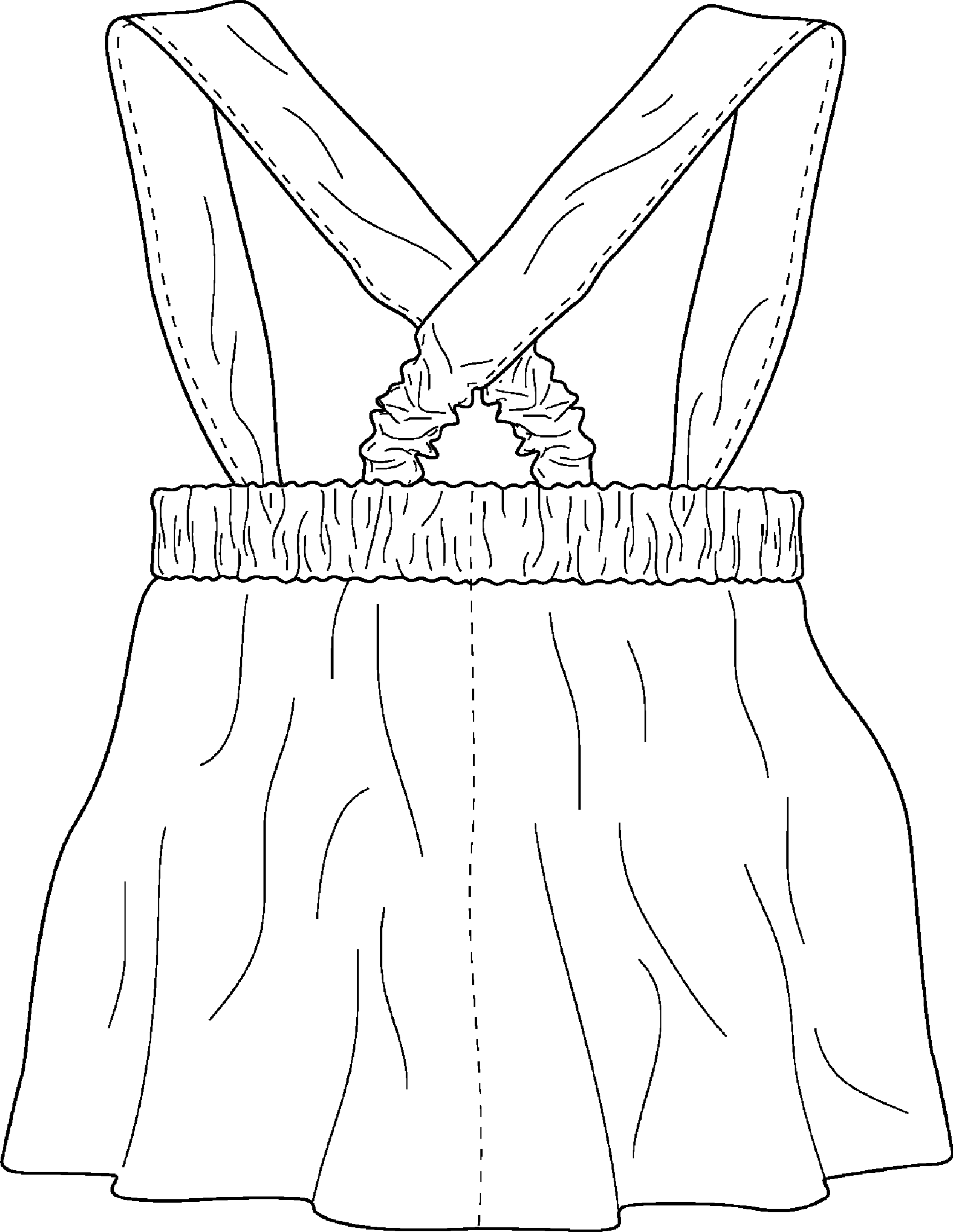

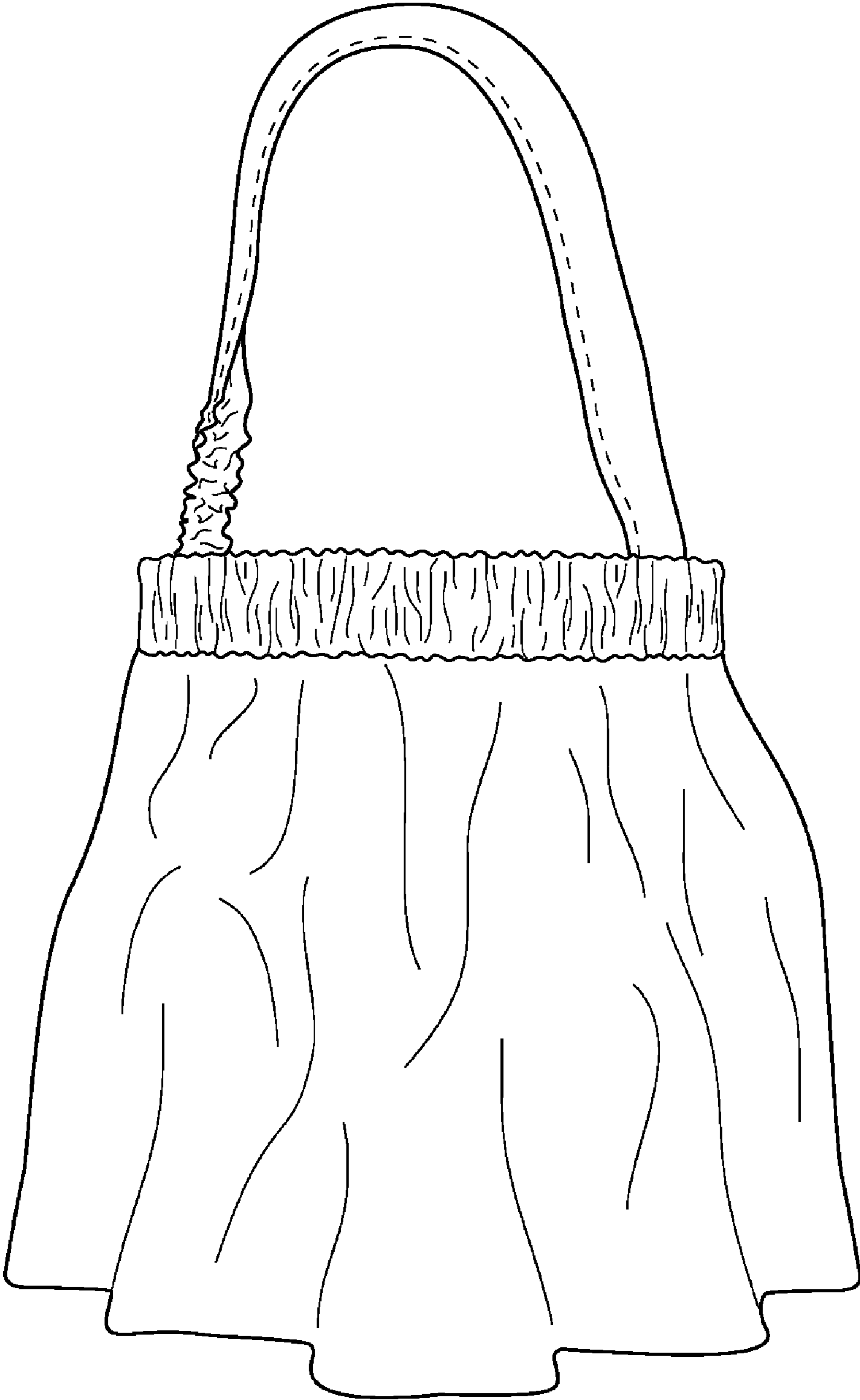

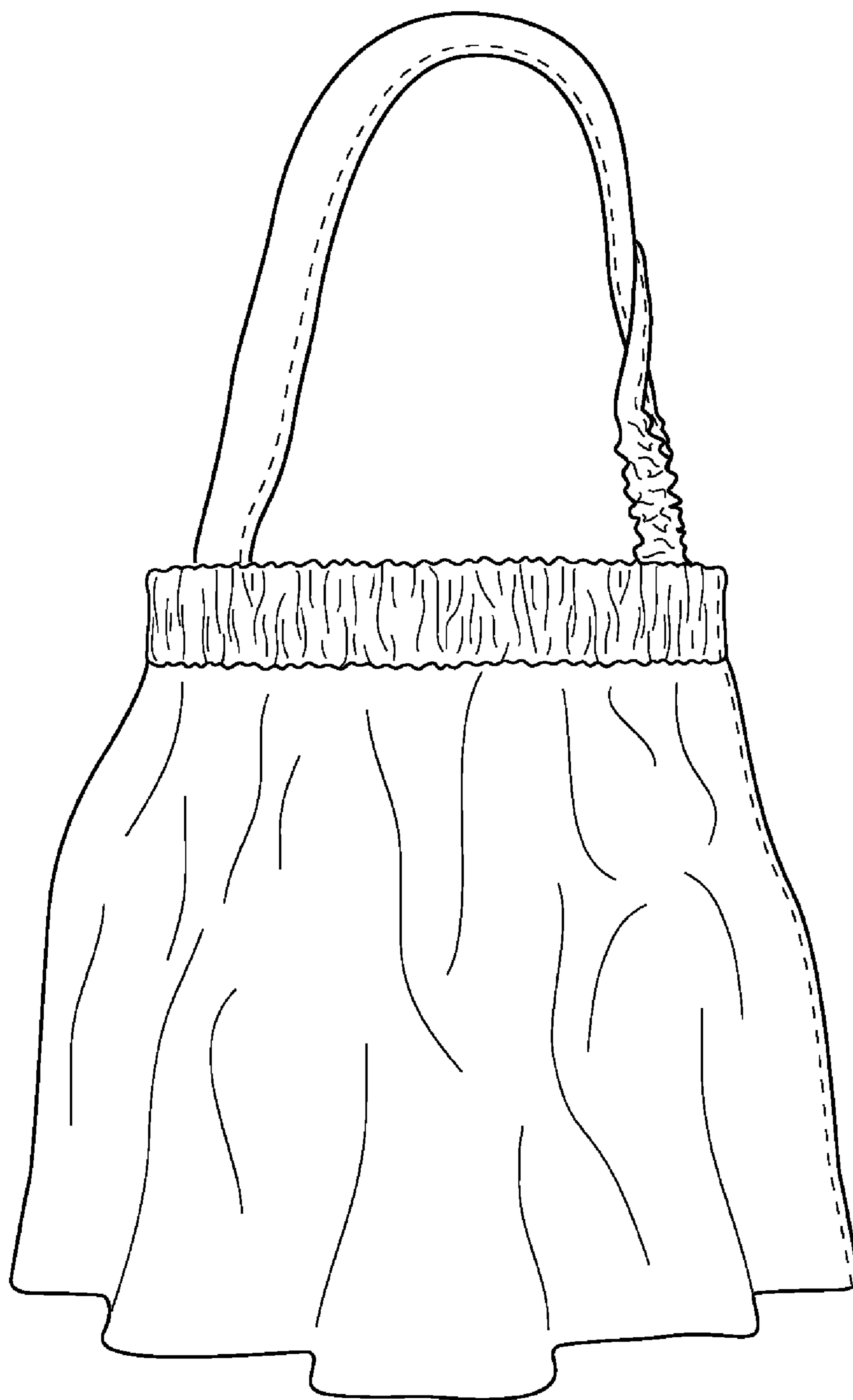

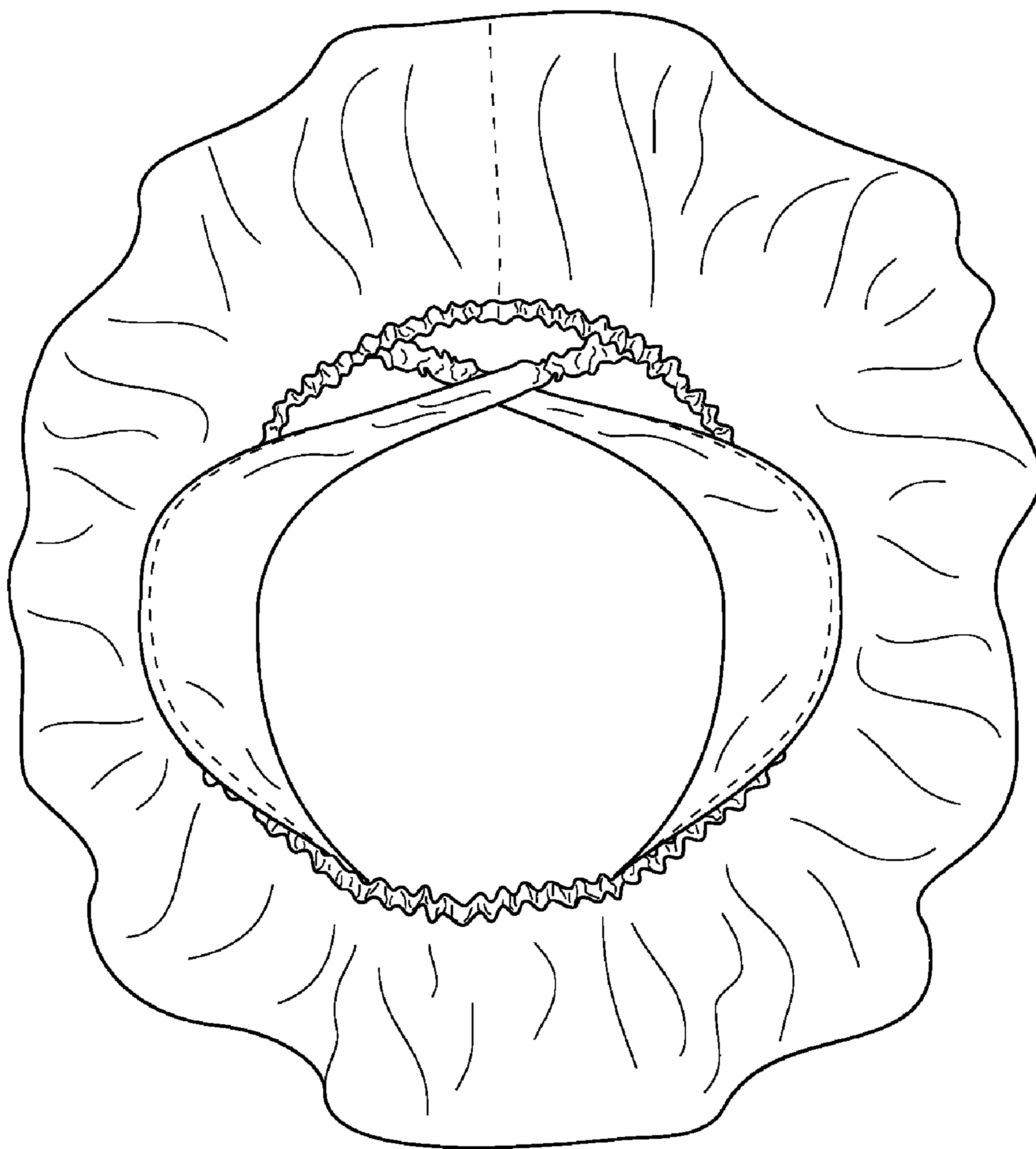

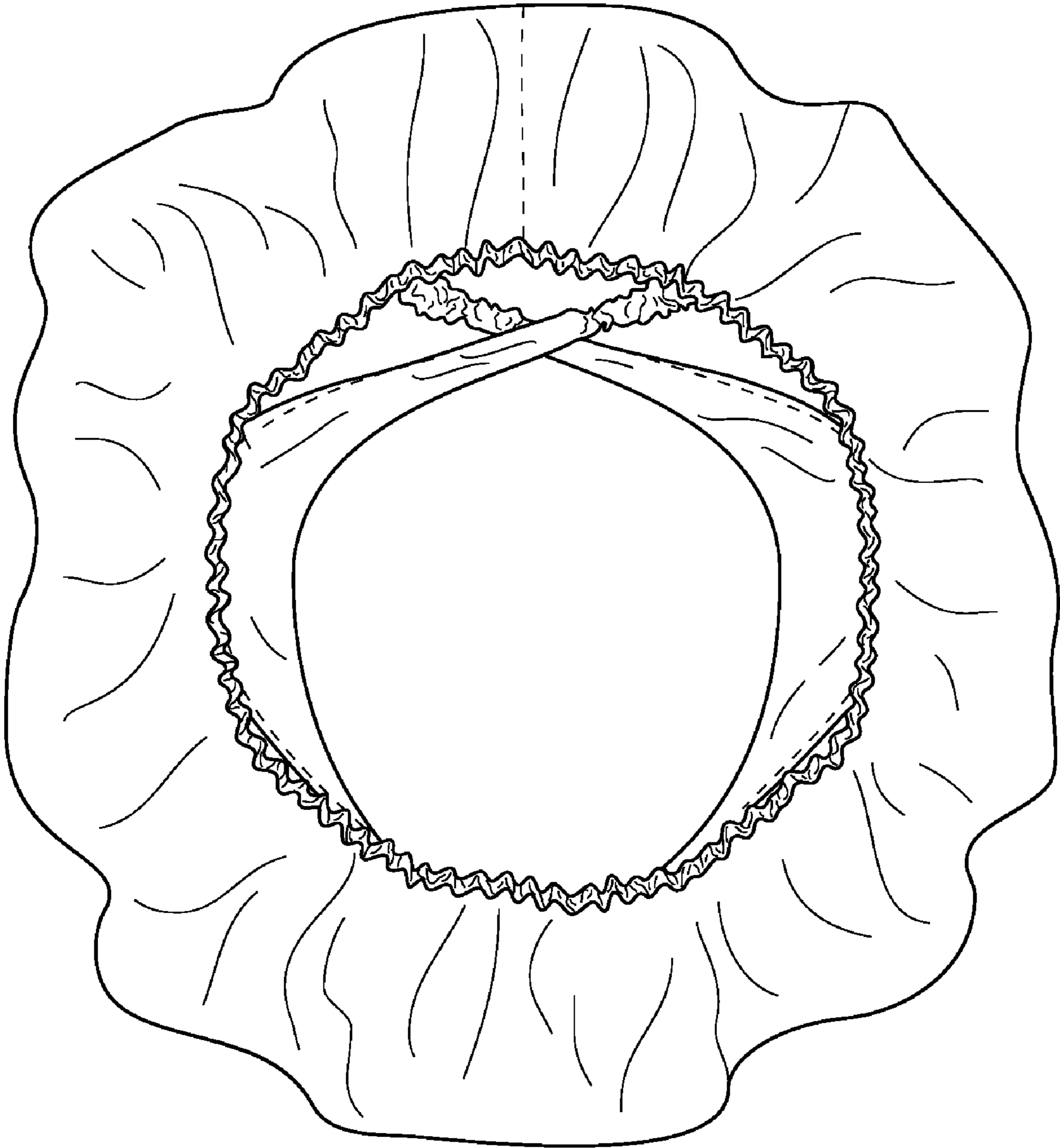
