(57) **CLAIM**

The ornamental design for a deer track clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view illustrating a deer track clip;

FIG. 2 is a bottom plan view illustrating the deer track clip of FIG. 1;

FIG. 3 is a front elevational view illustrating the deer track clip of FIG. 1;

FIG. 4 is a right side elevational view illustrating the deer track clip of FIG. 1;

FIG. 5 is rear elevational view illustrating the deer track clip of FIG. 1; and,

FIG. 6 is a left side elevational view illustrating the deer track clip of FIG. 1.

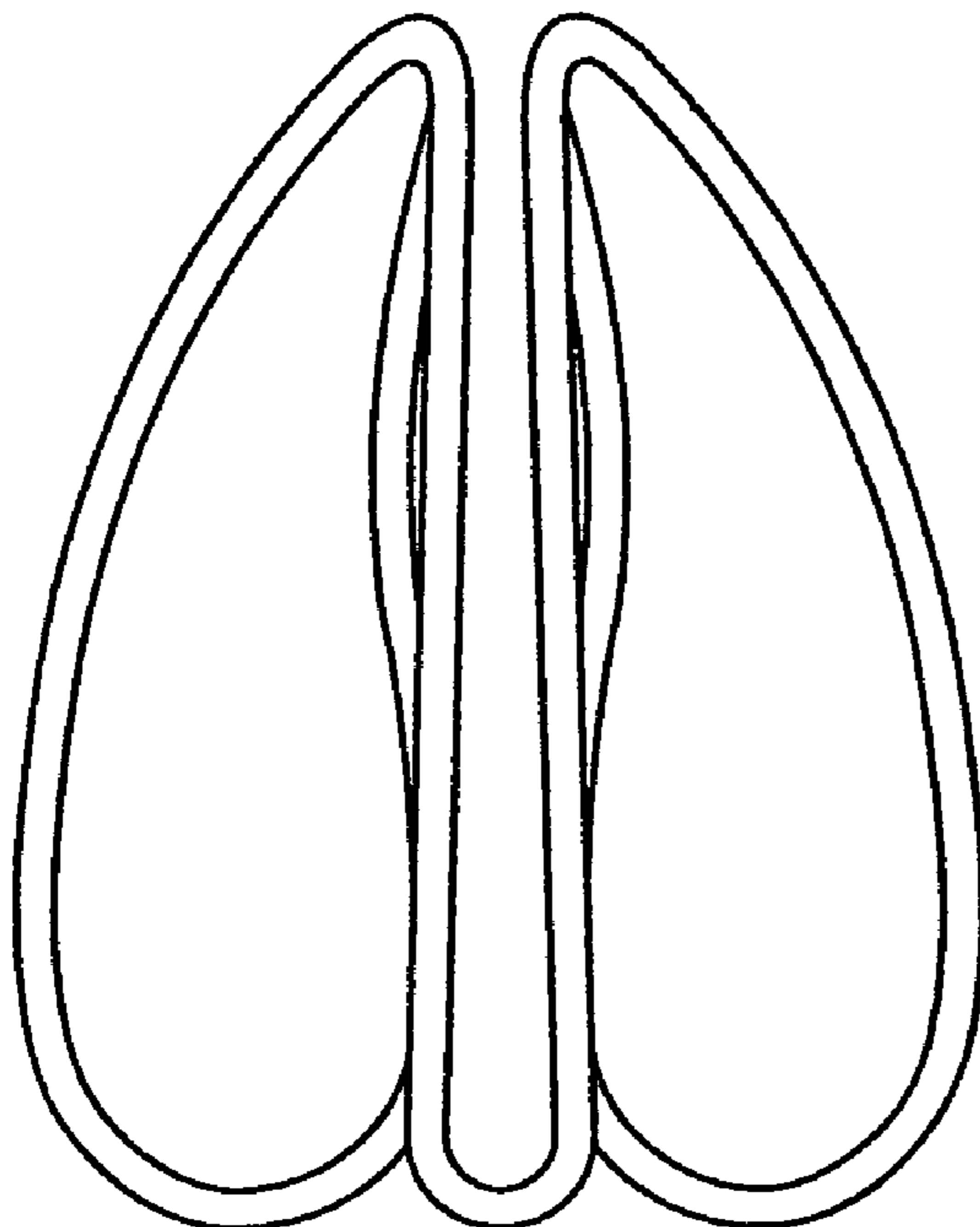

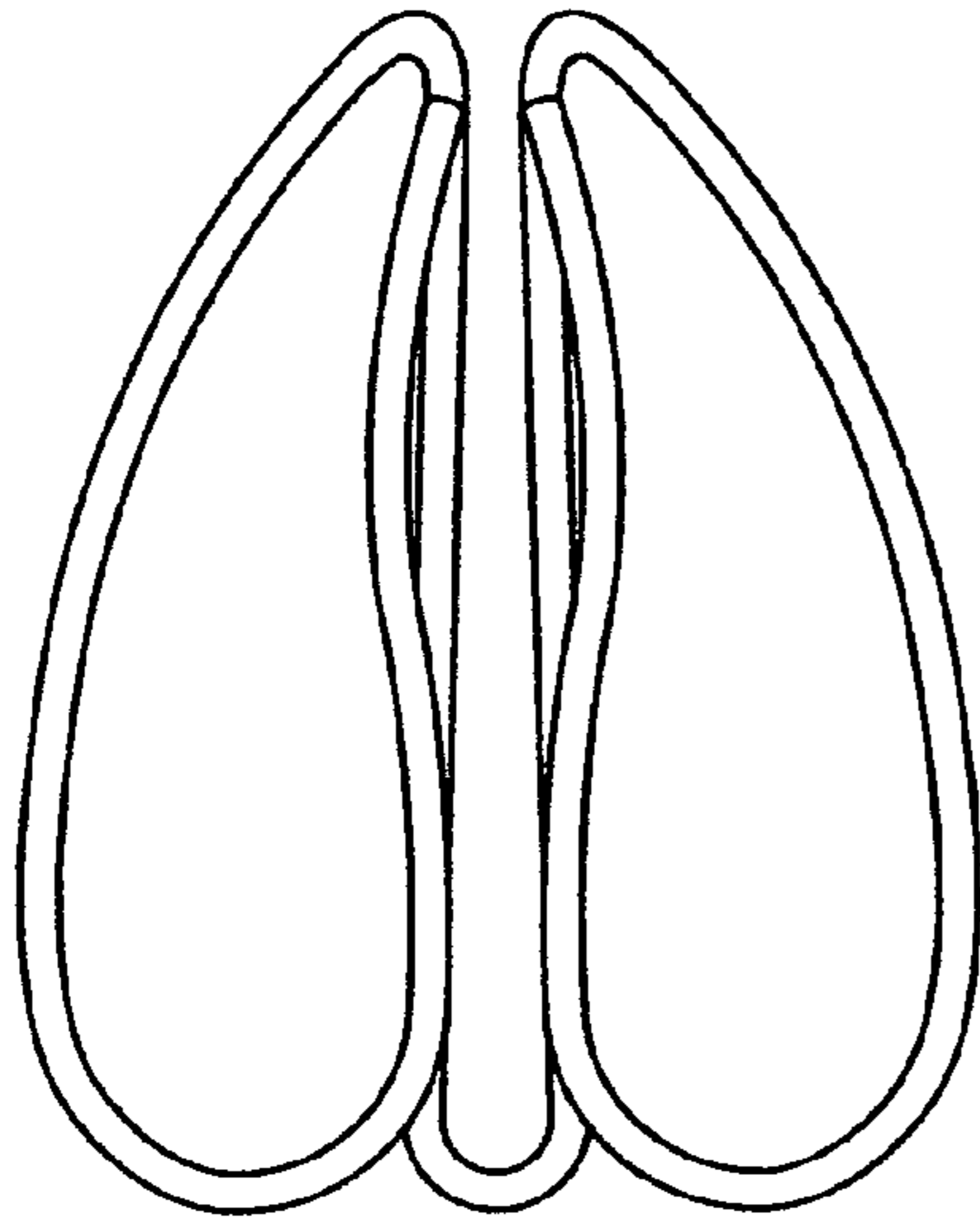

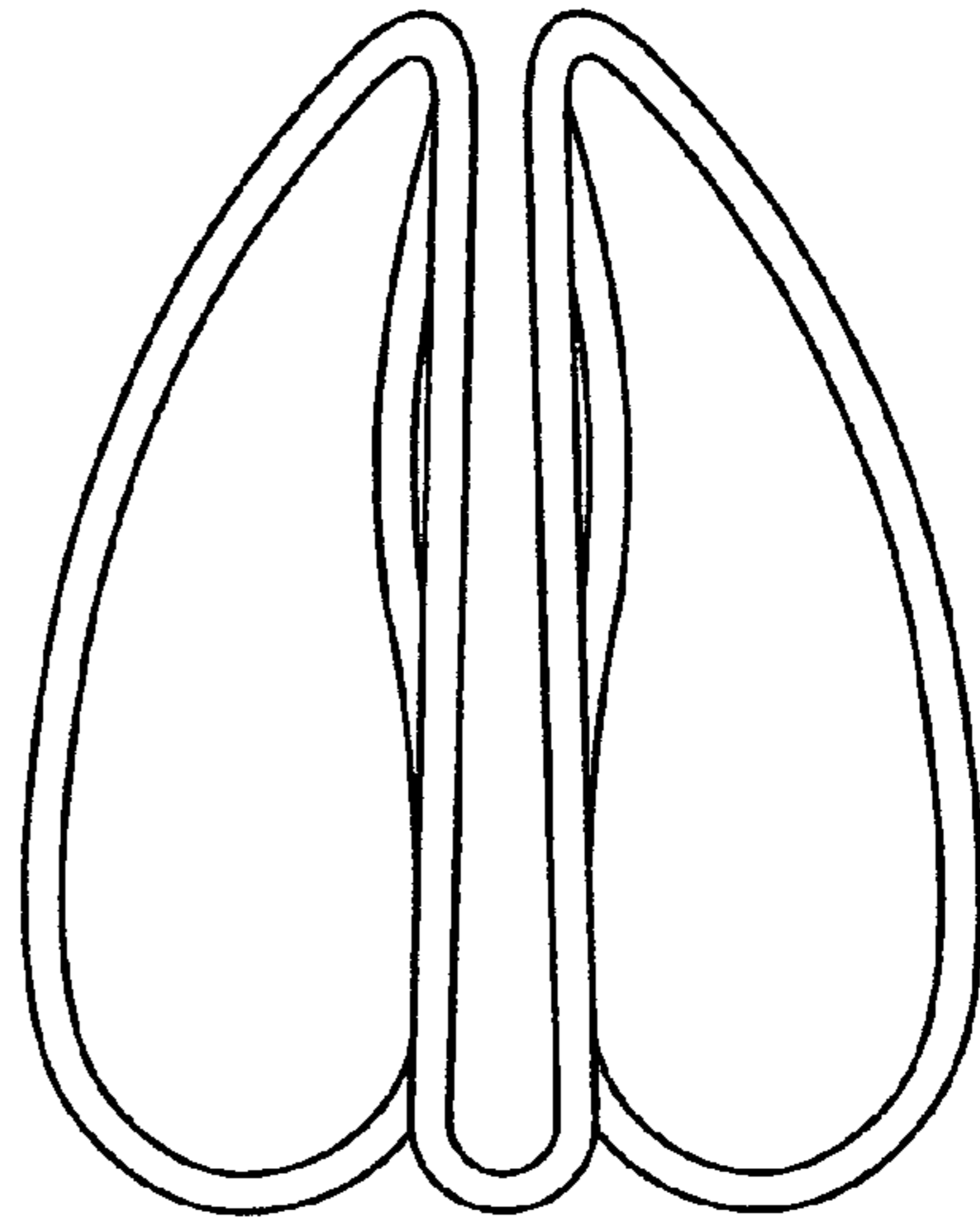

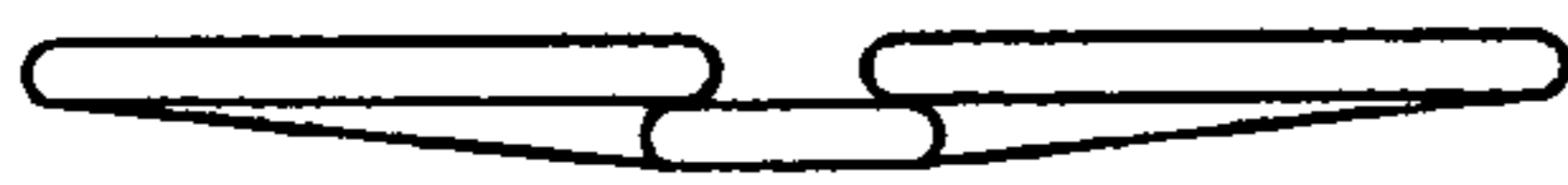

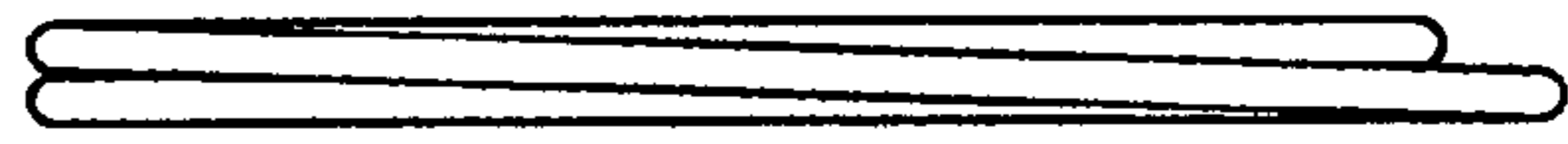
