DESCRIPTION

FIG. 1 is a front perspective view of a portable easel showing my new design;

FIG. 2 is an top, plan view of a portable easel of my invention based on FIG. 1;

FIG. 3 is a bottom, plan view of a portable easel of my invention and a reverse view of FIG. 2;

FIG. 4 is a front plan view of a portable easel of my invention based on FIG. 1;

FIG. 5 is a rear, plan view of a portable easel of my invention and a reverse view of FIG. 4;

FIG. 6 is a side view of a portable easel of my invention;

FIG. 7 is a side view of a portable easel of my invention and a reverse view of FIG. 6; and,

FIG. 8 is a flat blank capable of being assembled into a portable easel of my invention.

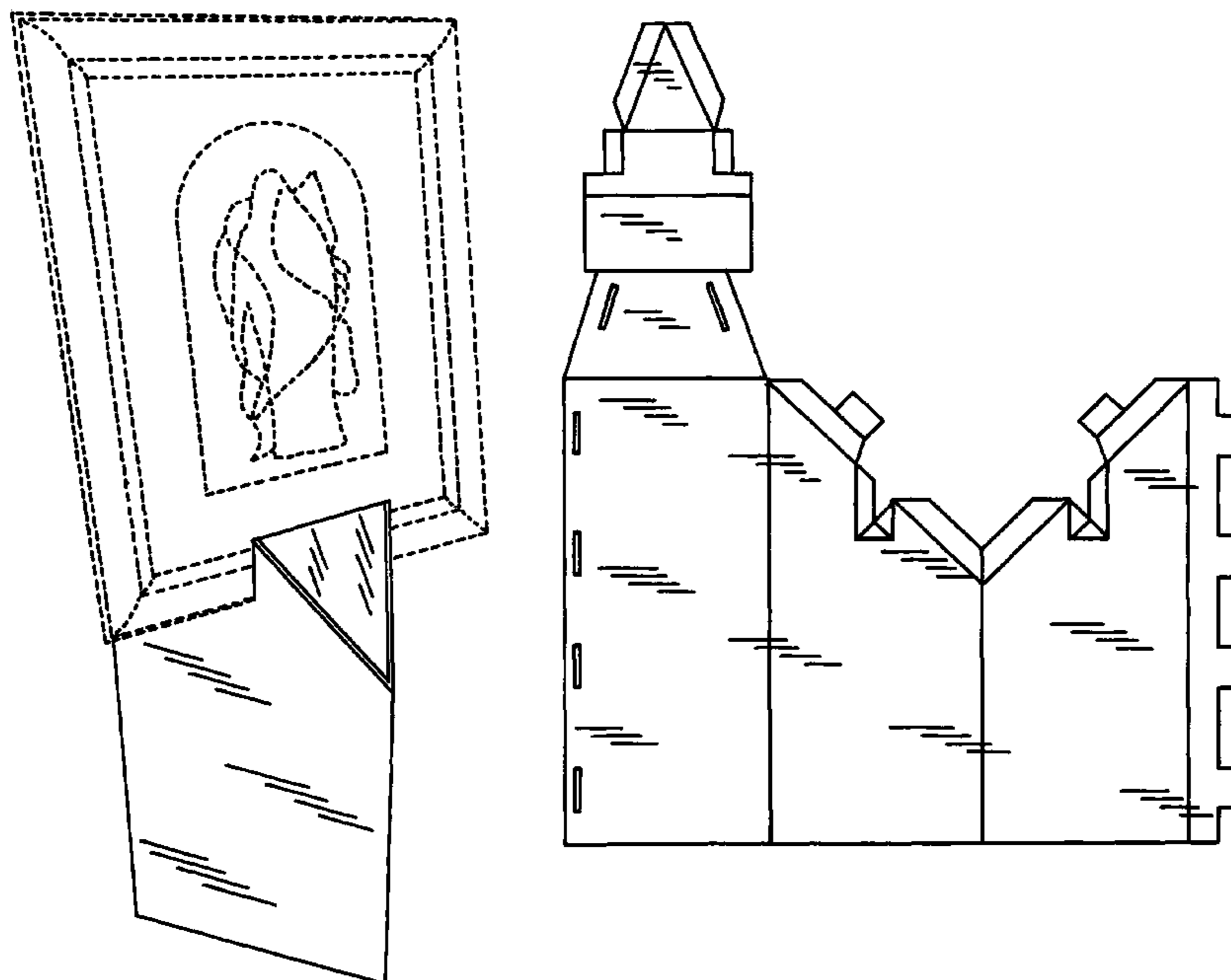

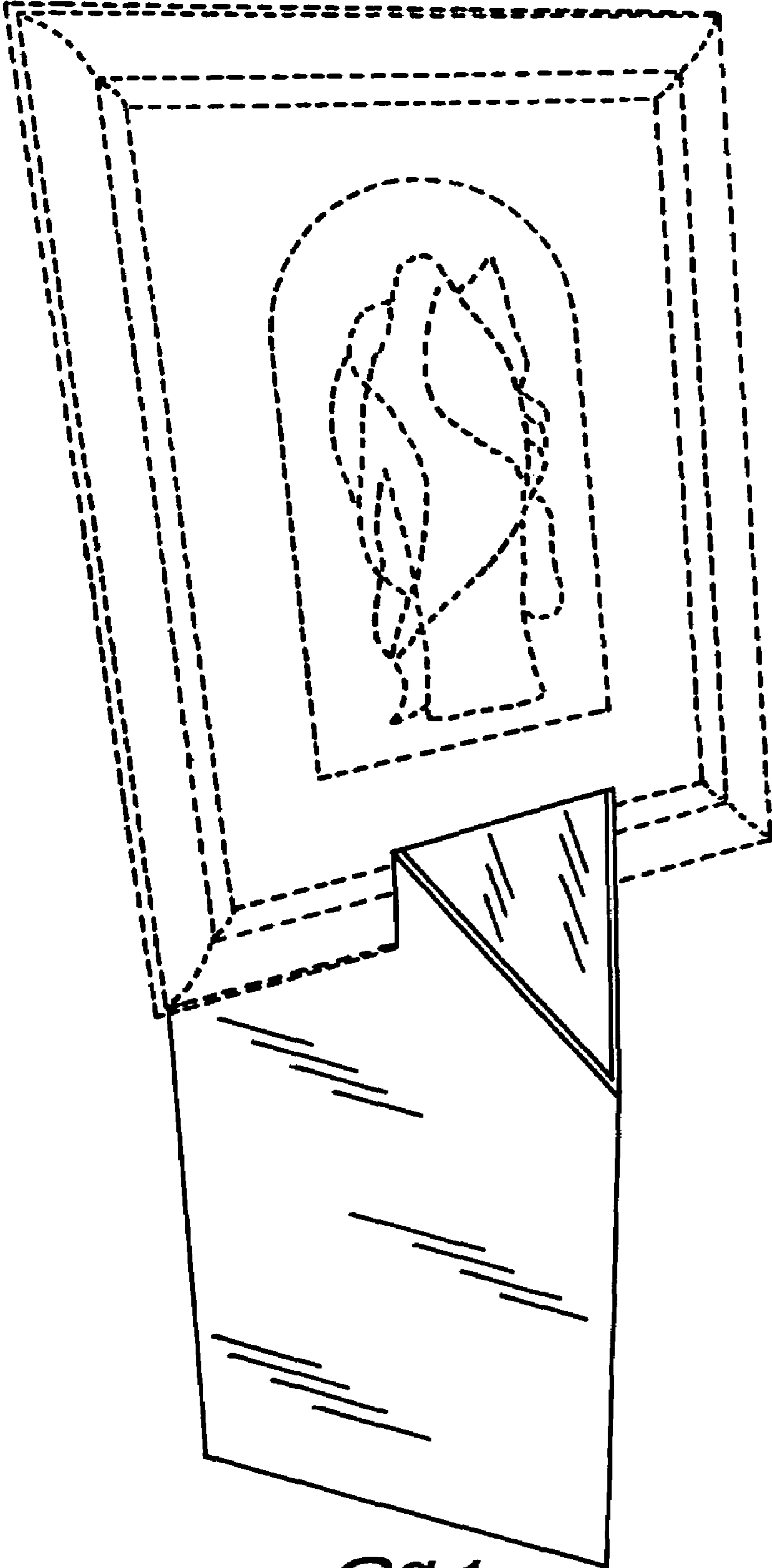

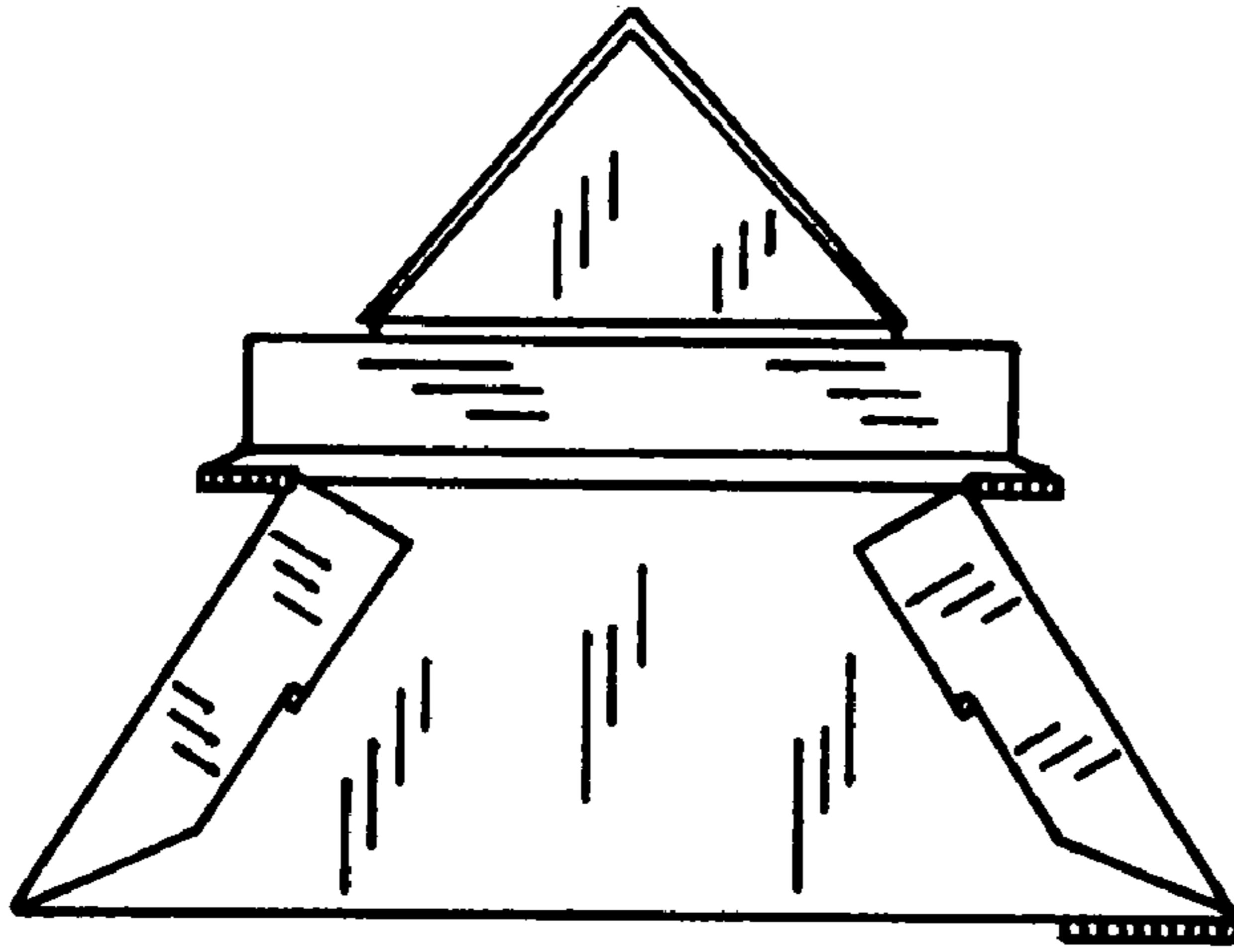

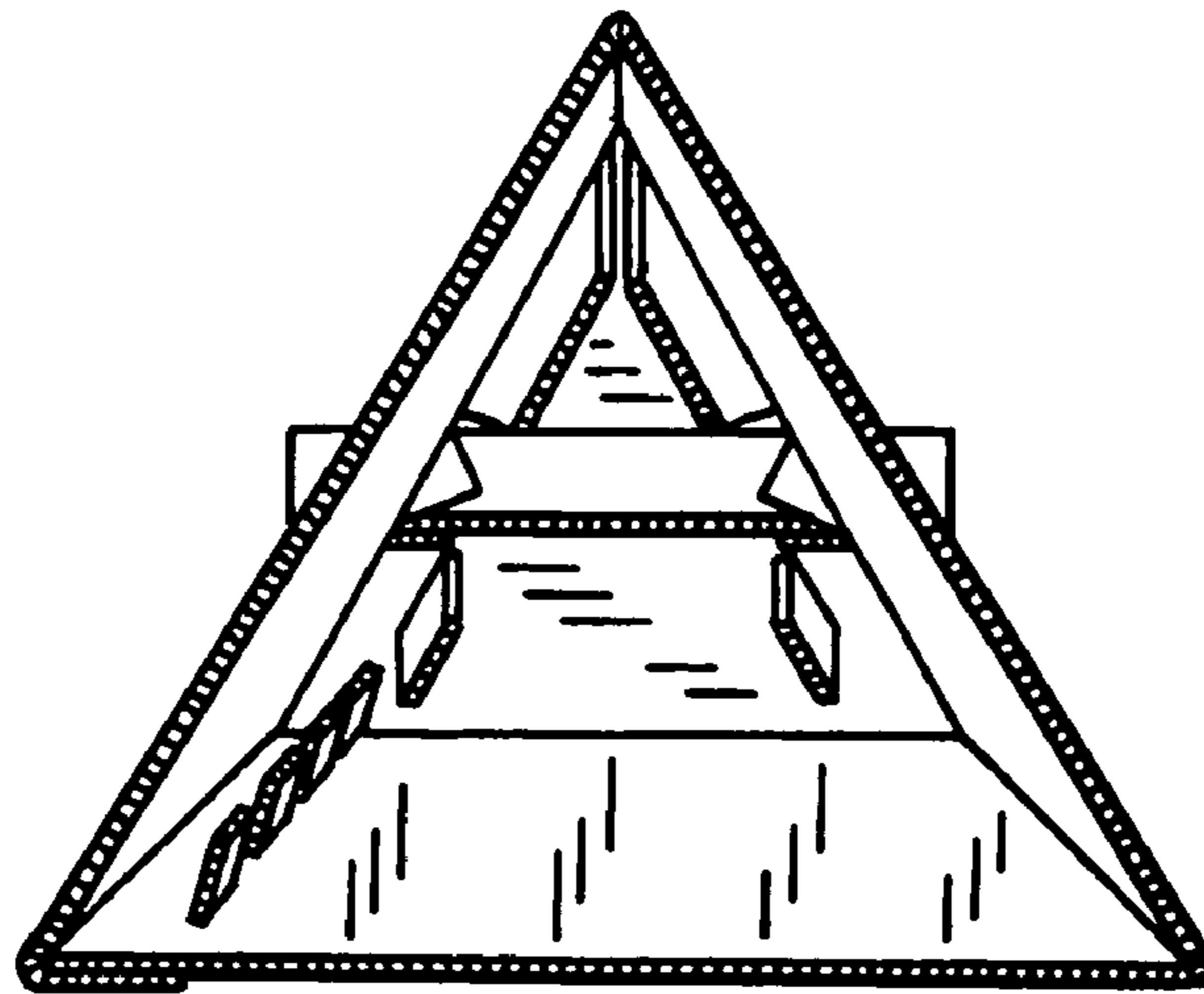

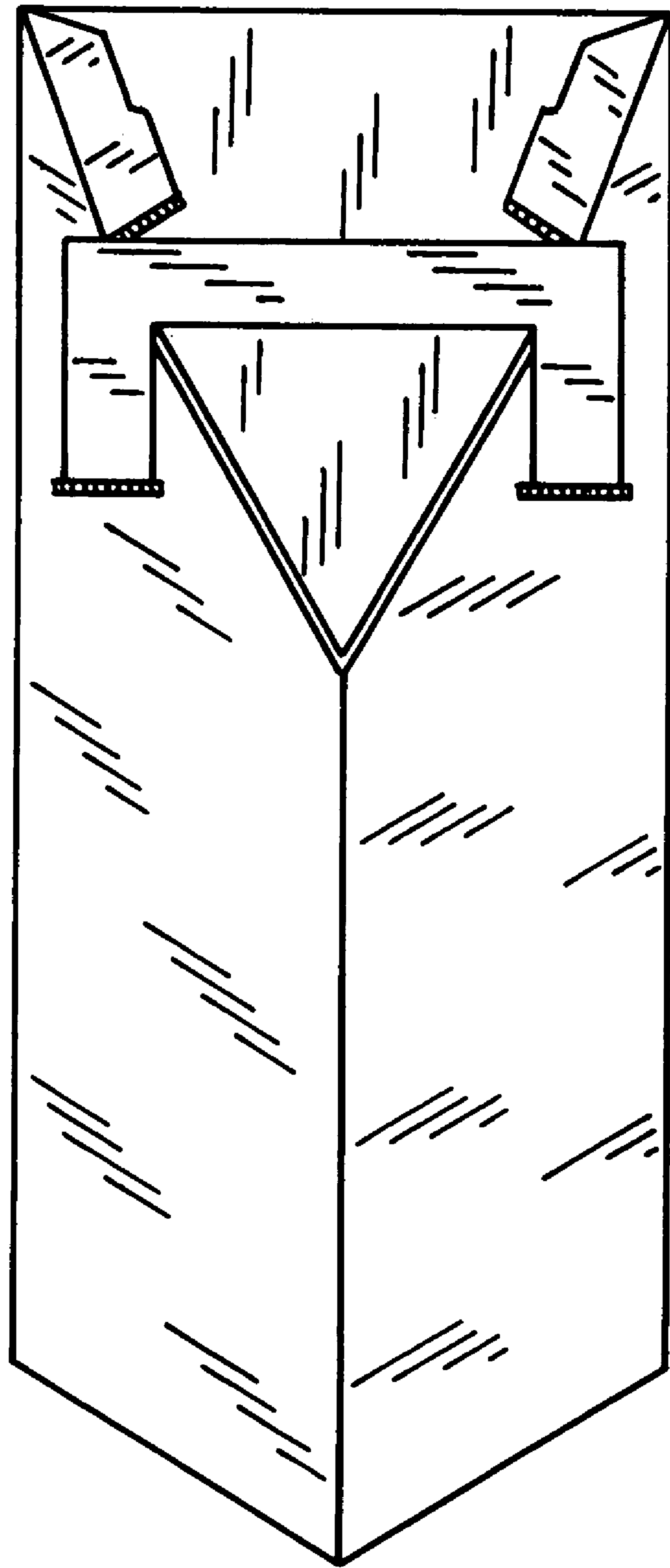

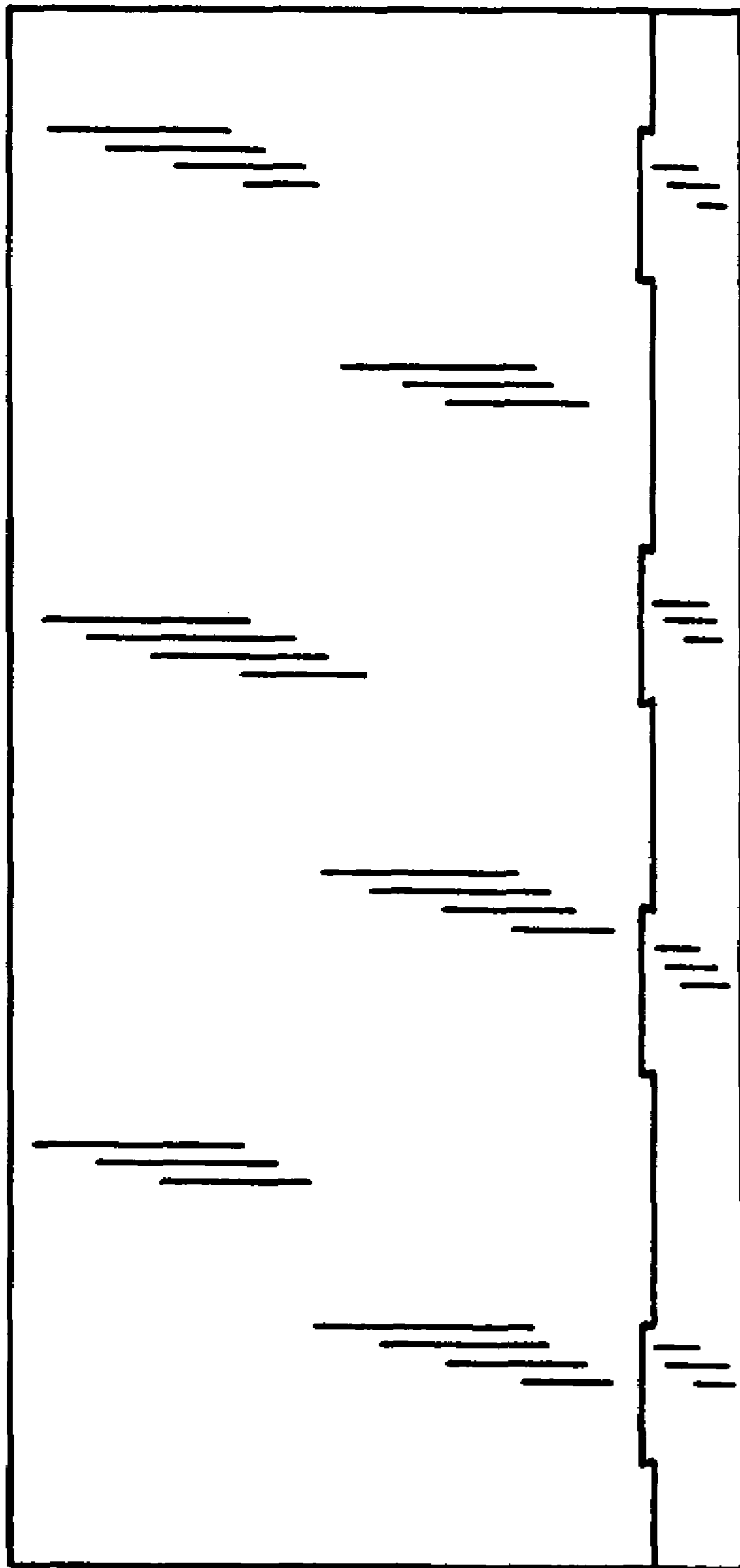

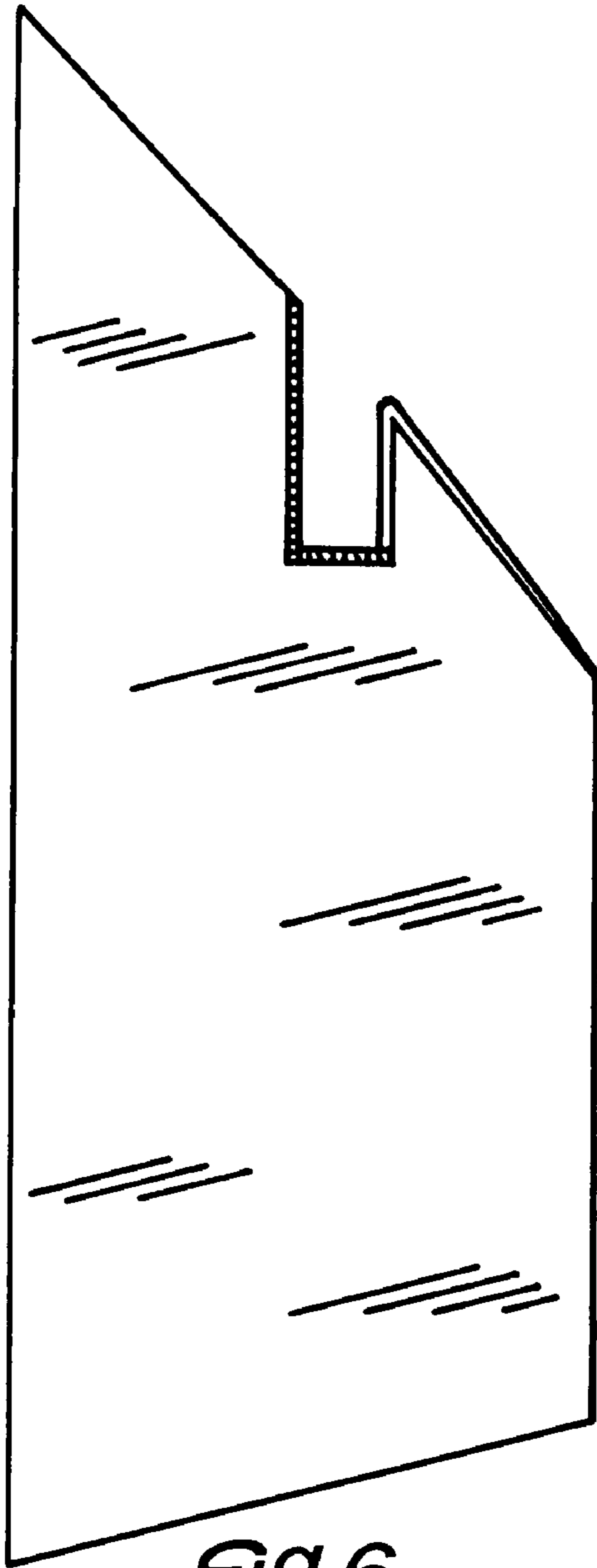

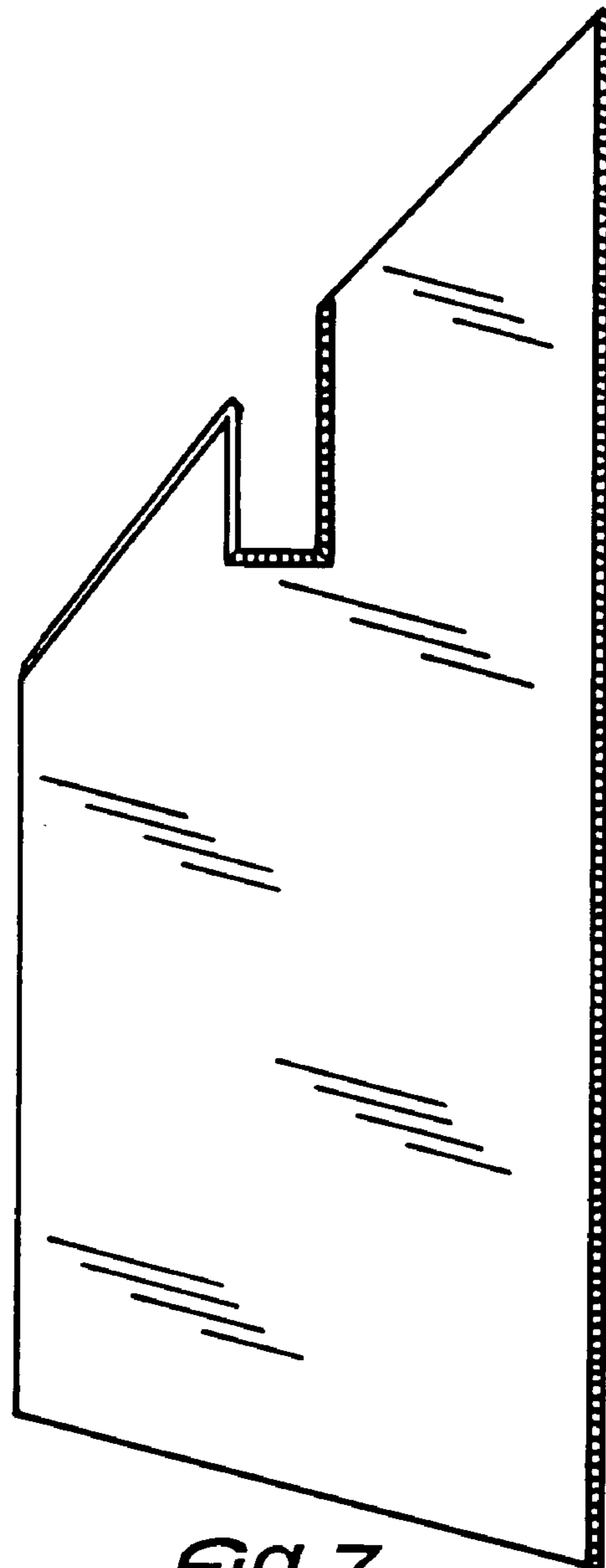

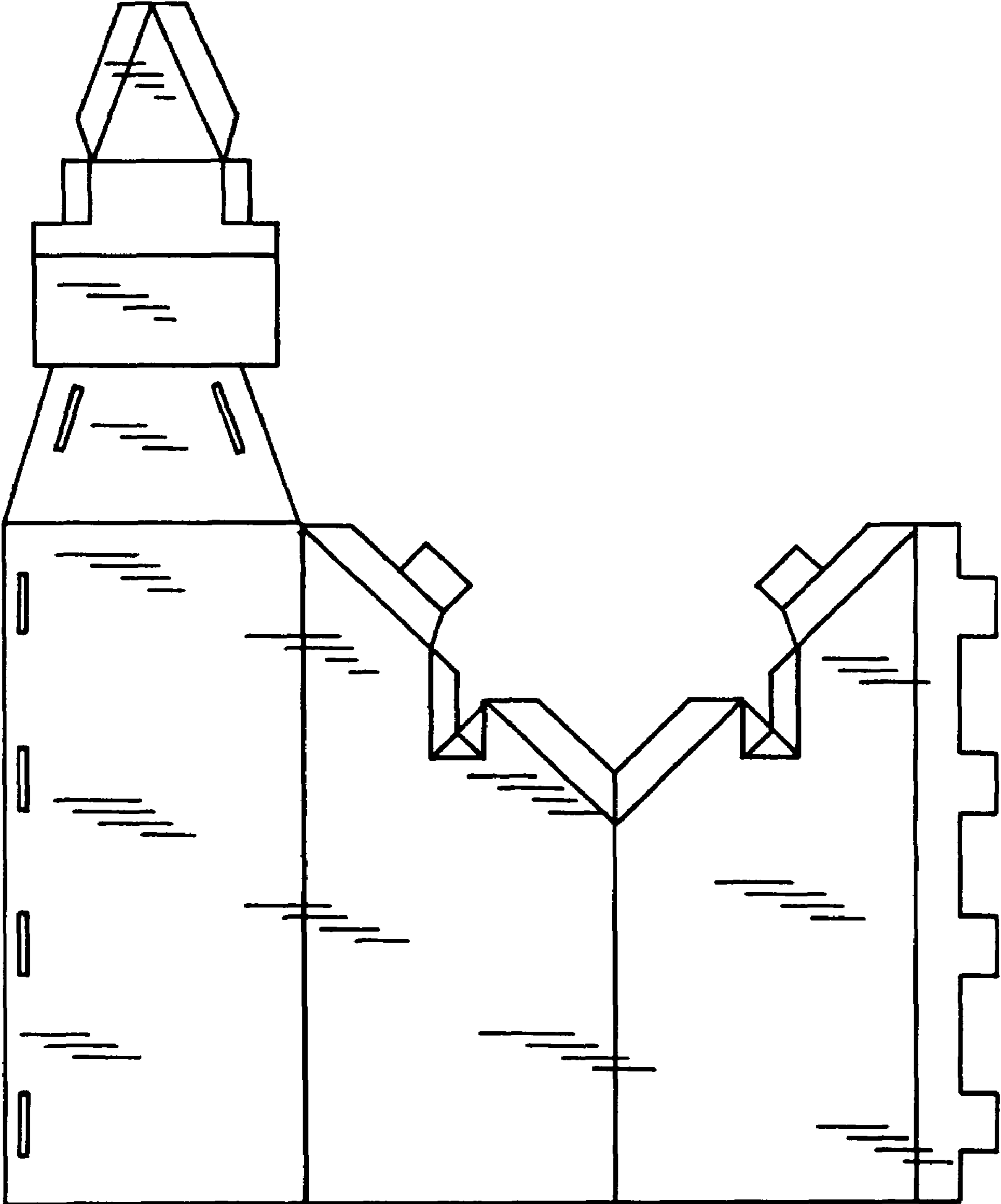
