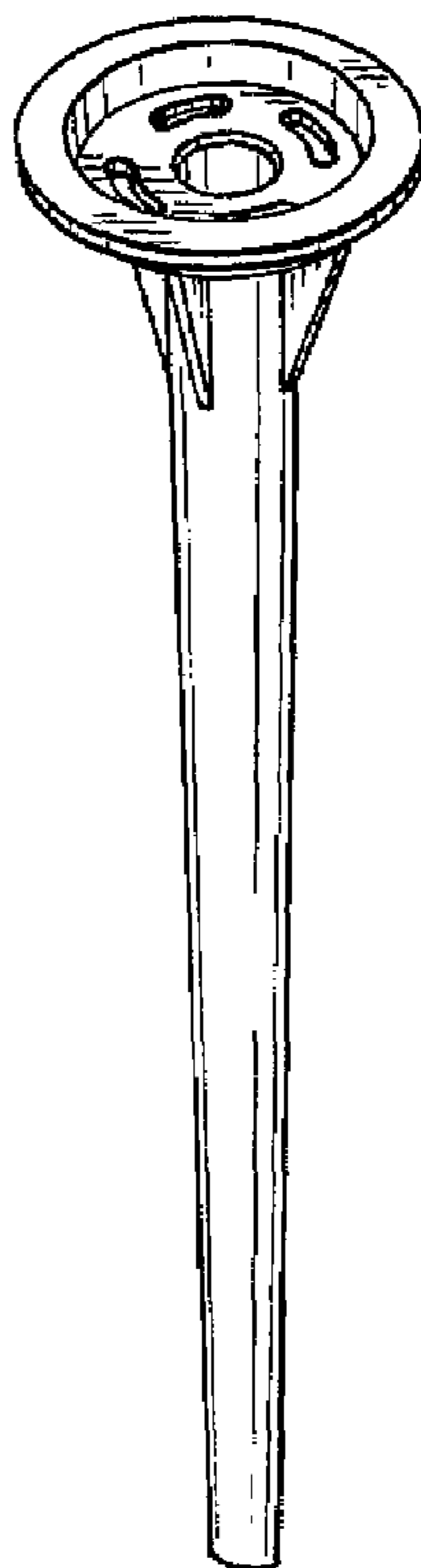

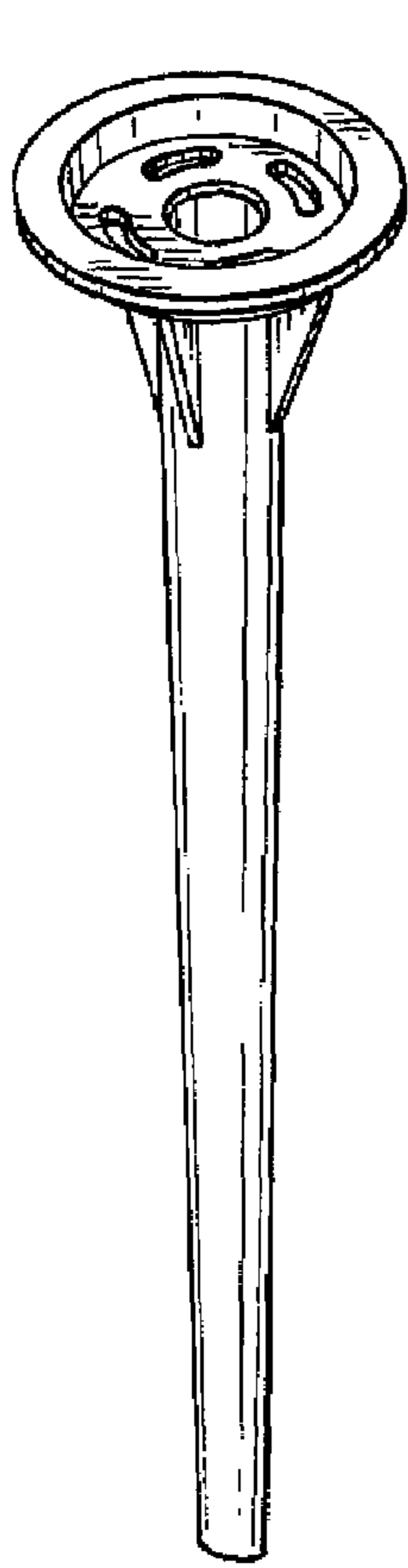
The ornamental design for a sipper tube, as shown and described.

**DESCRIPTION**

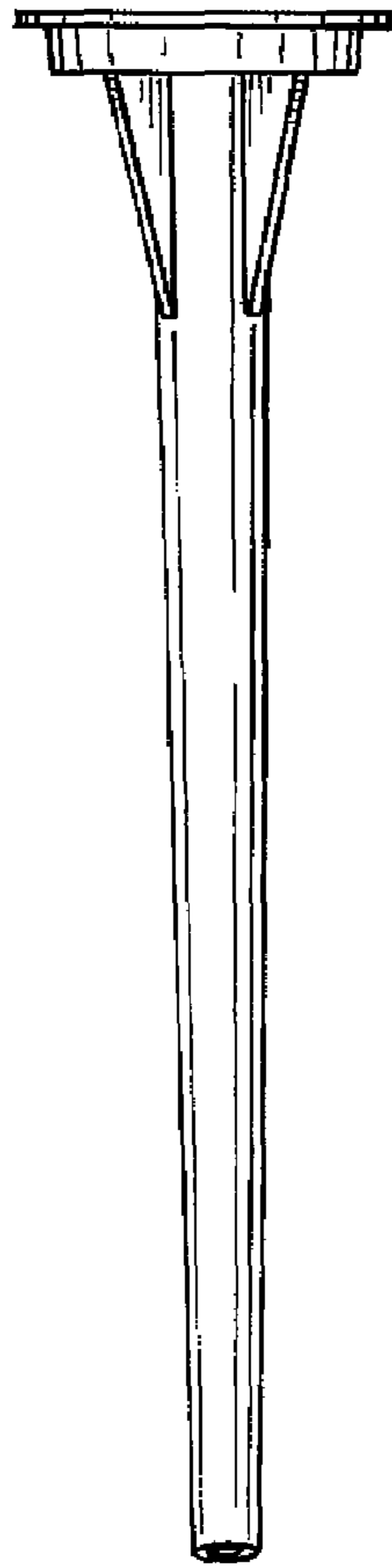
FIG. 1 is a perspective view of the sipper tube;

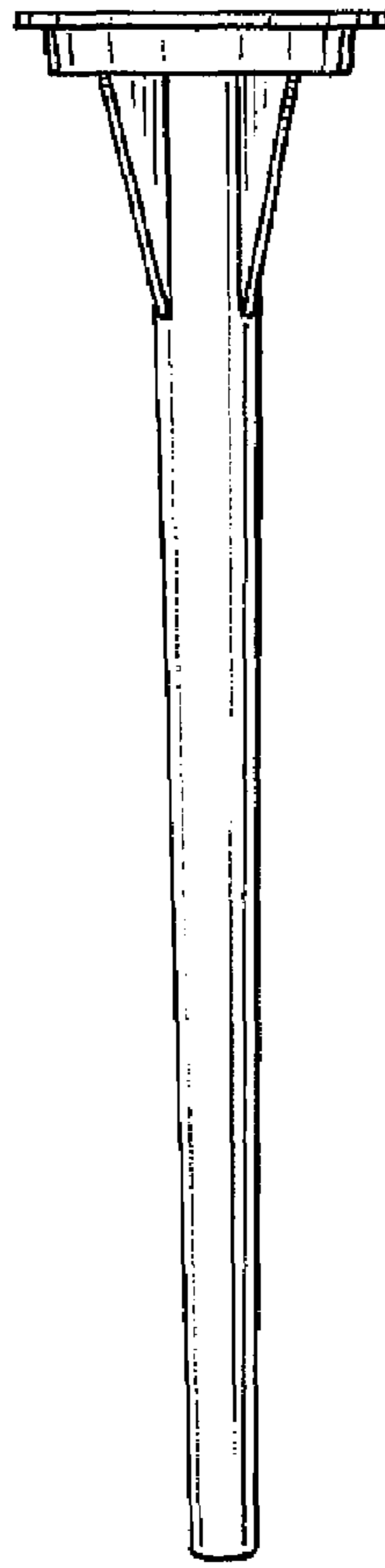




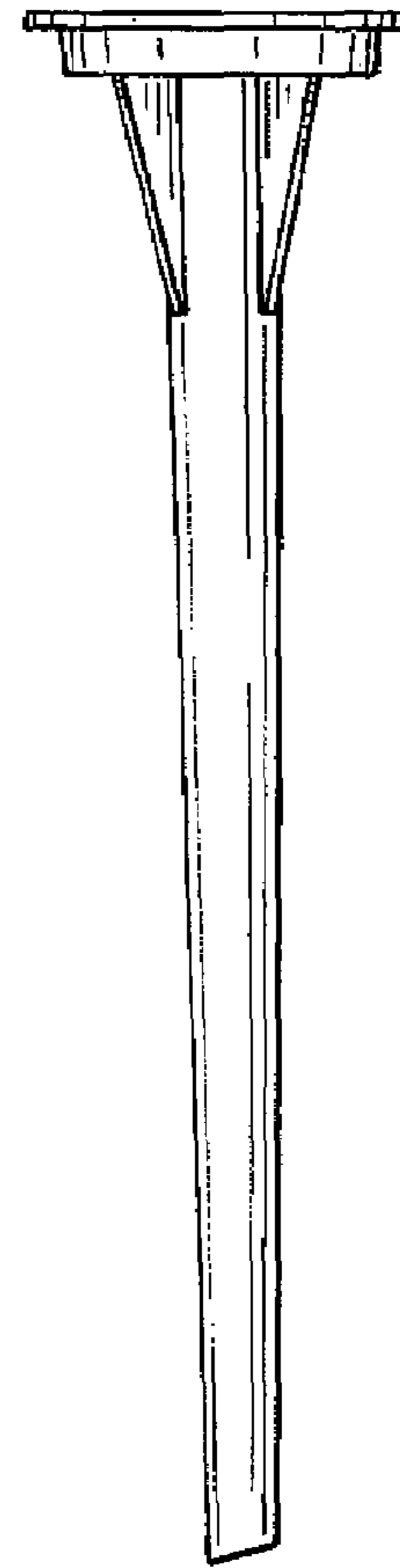

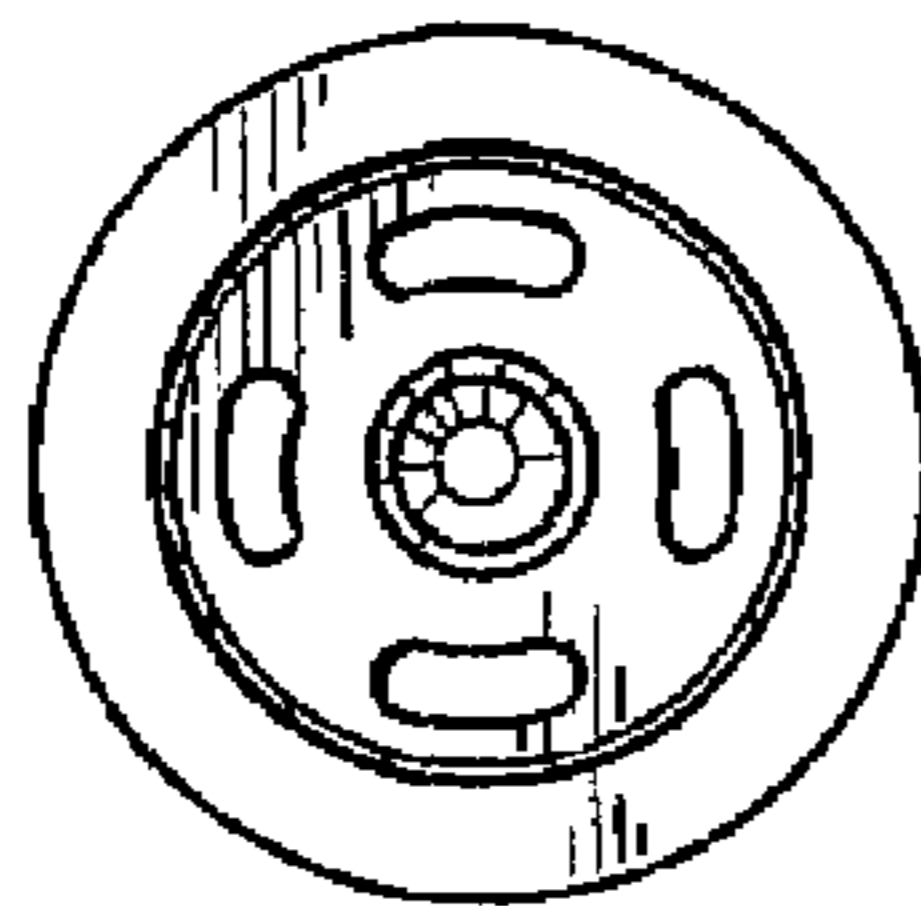

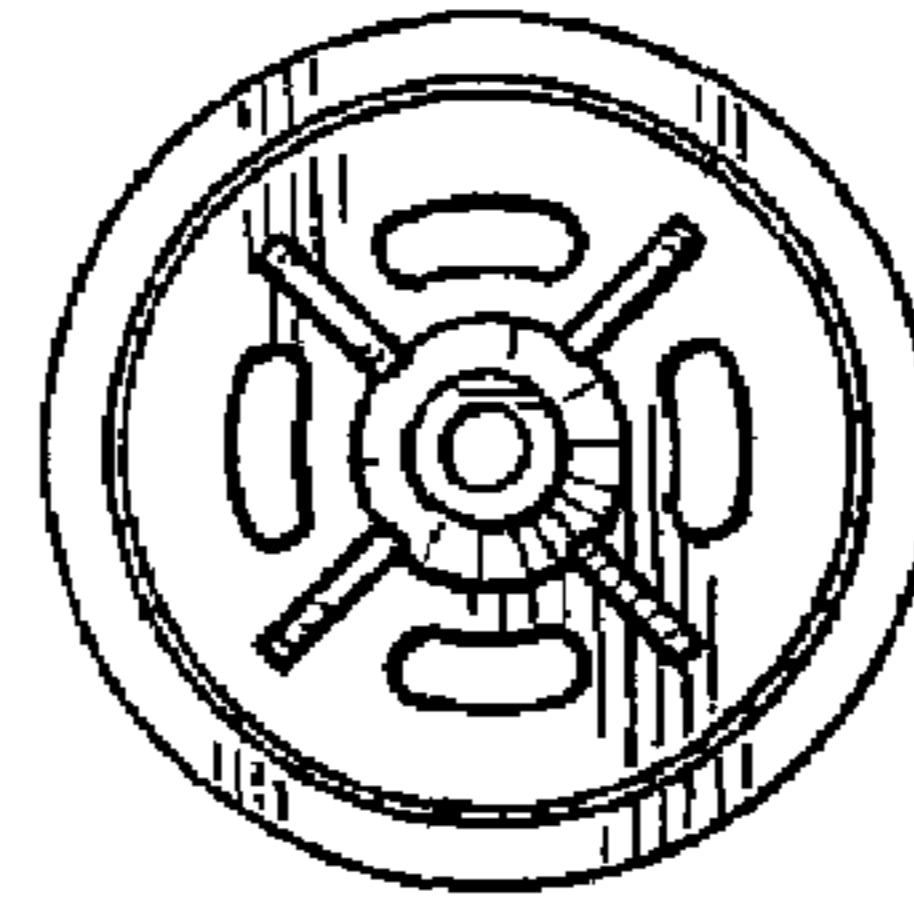
