FIG. 3 is a rear elevational view thereof;

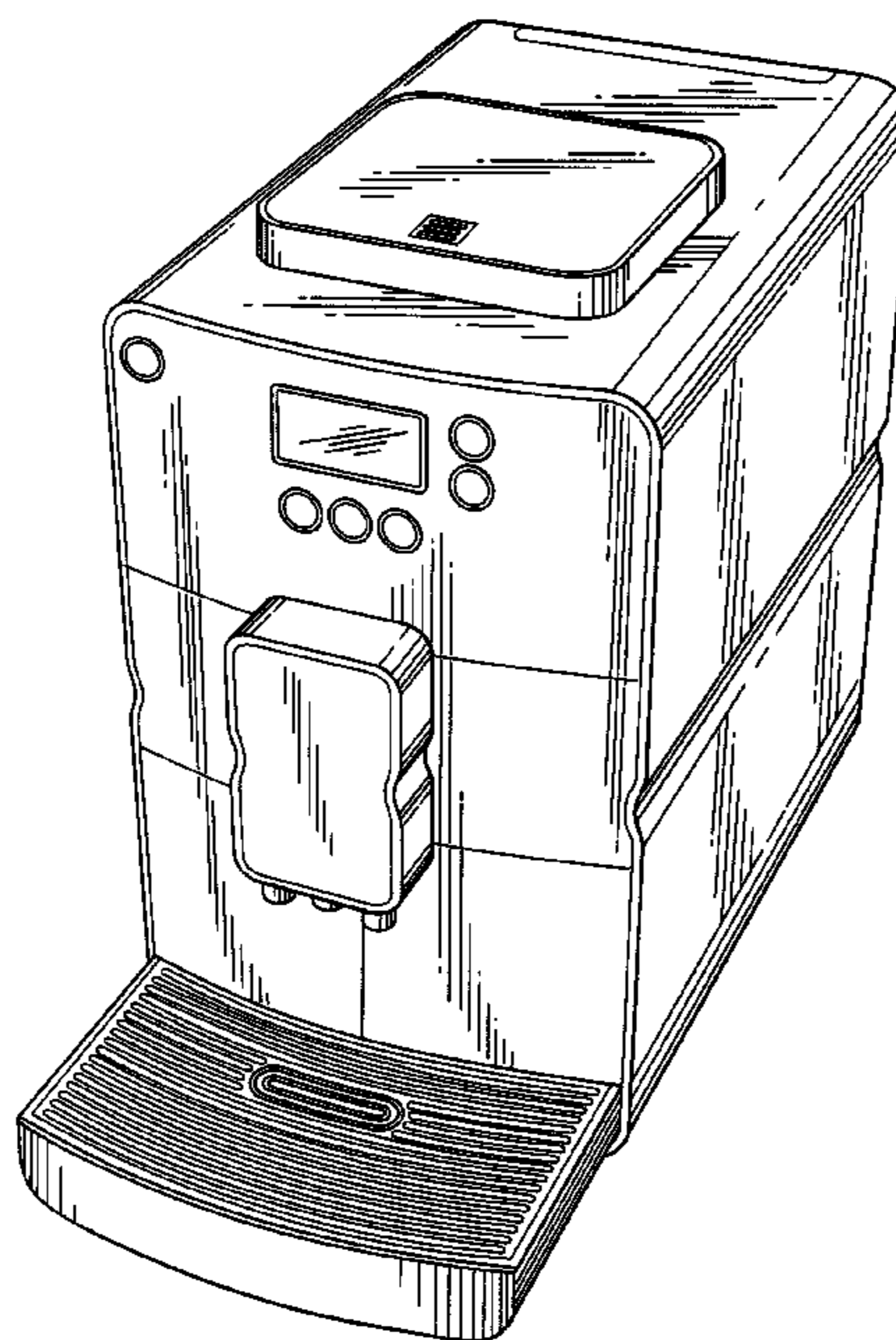
FIG. 4 is a right side elevation view of FIG. 1.

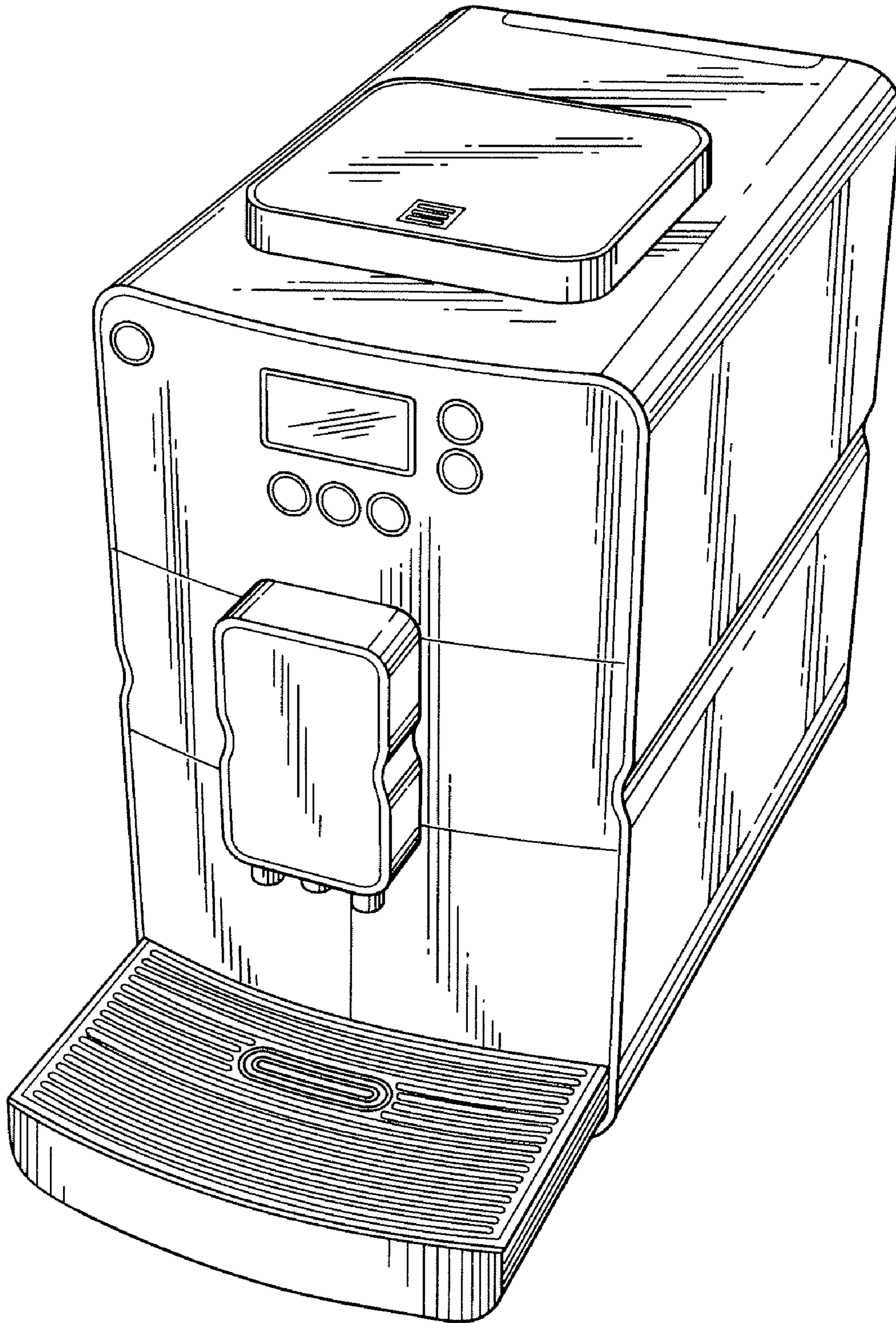

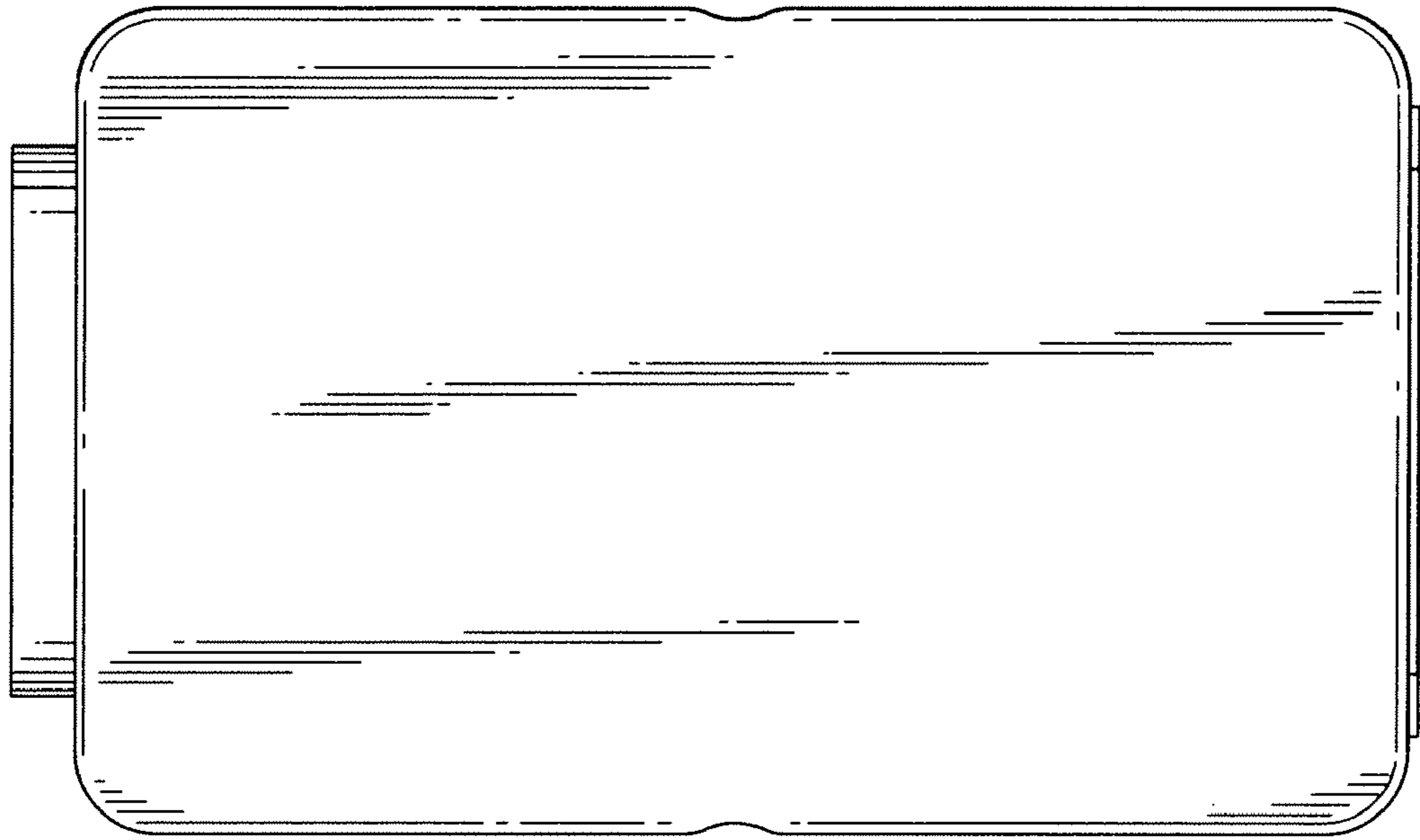

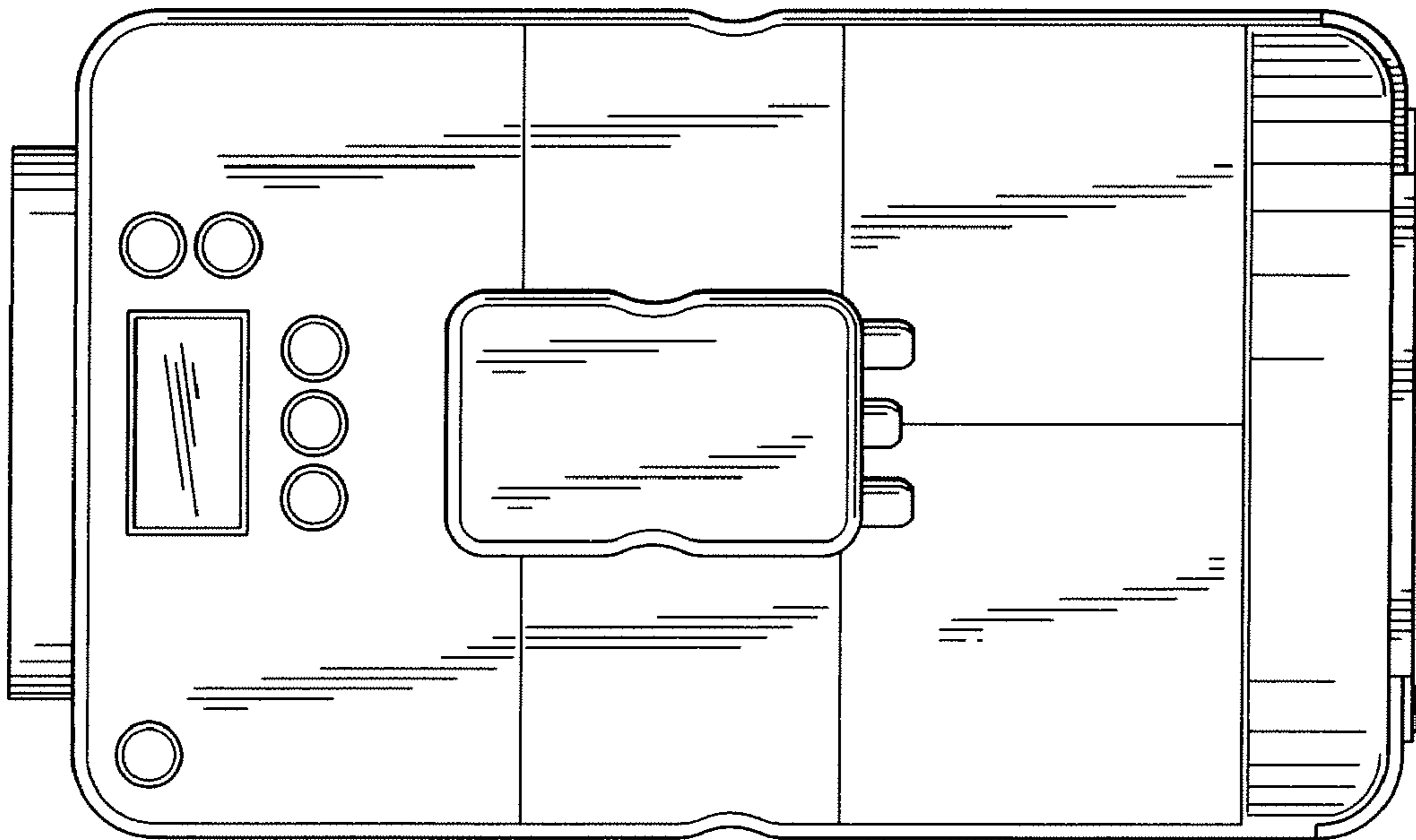

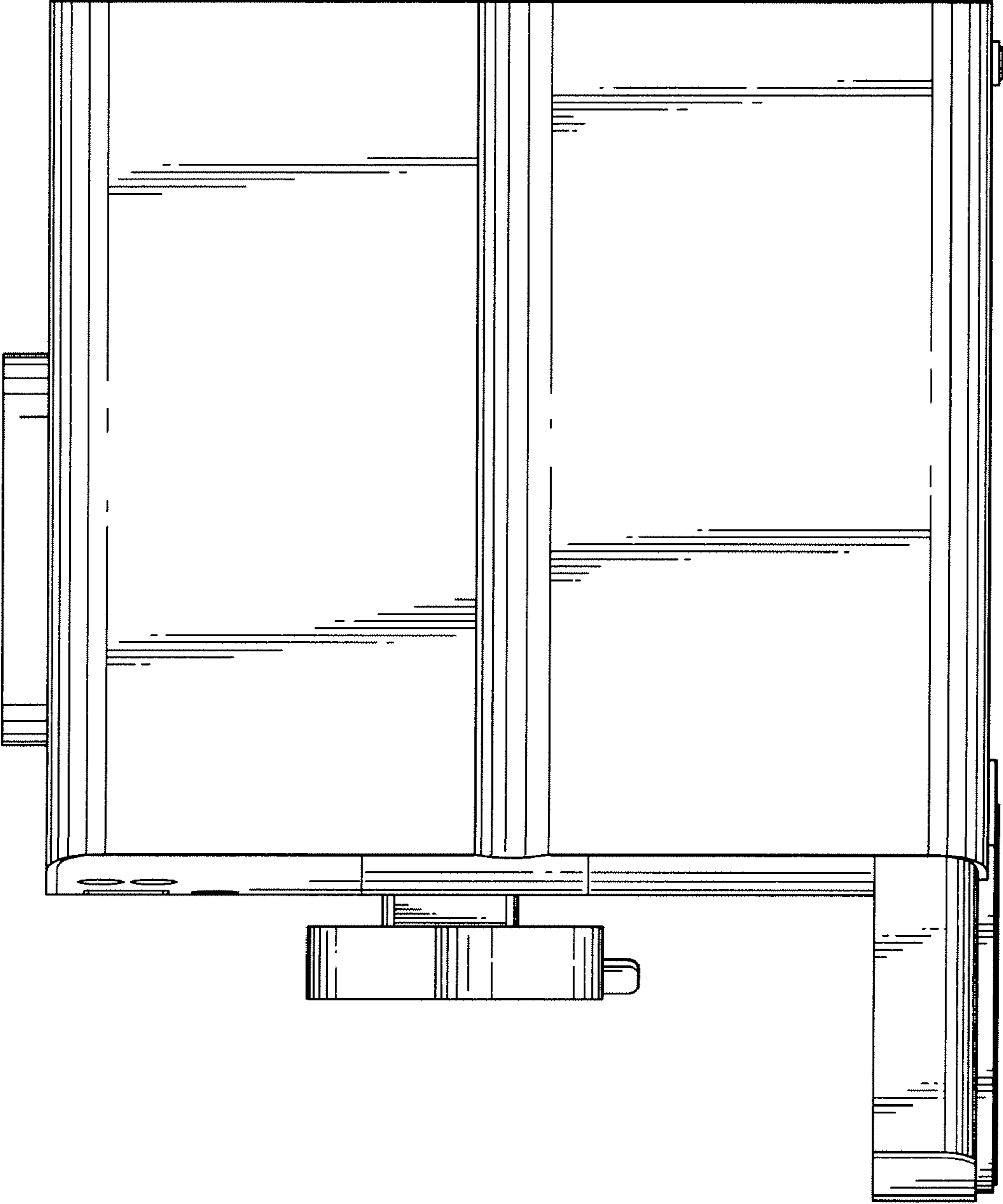

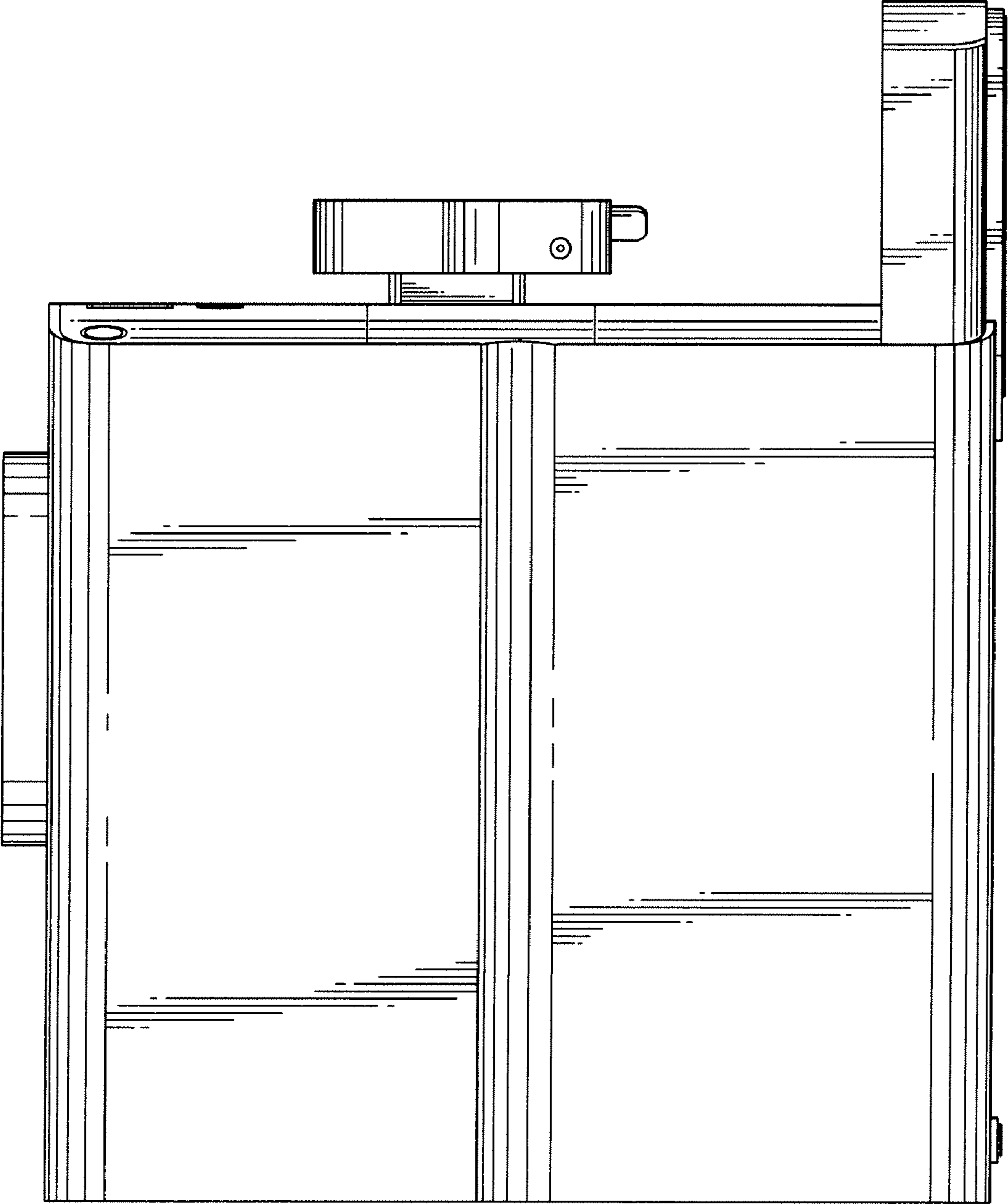

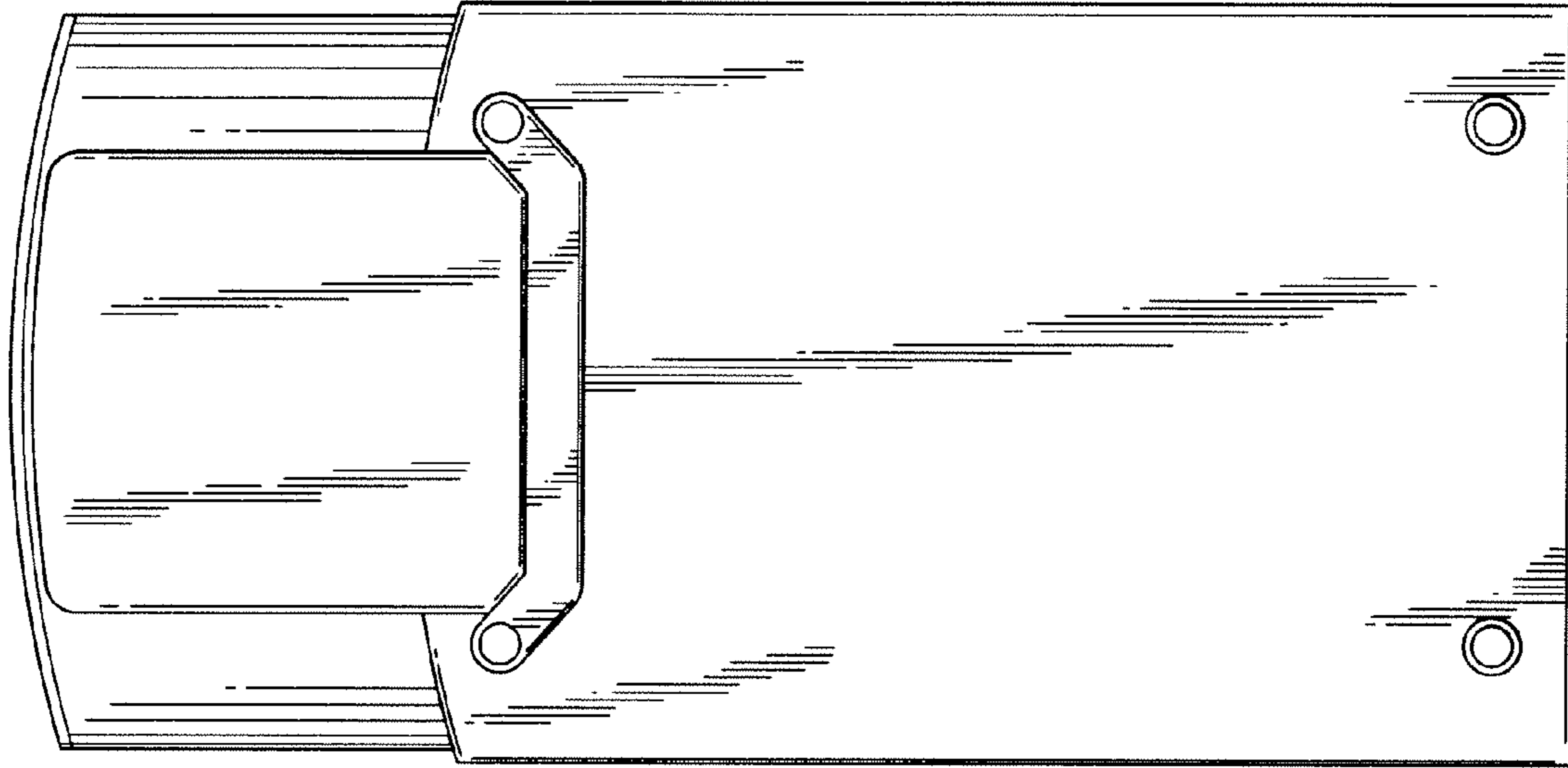

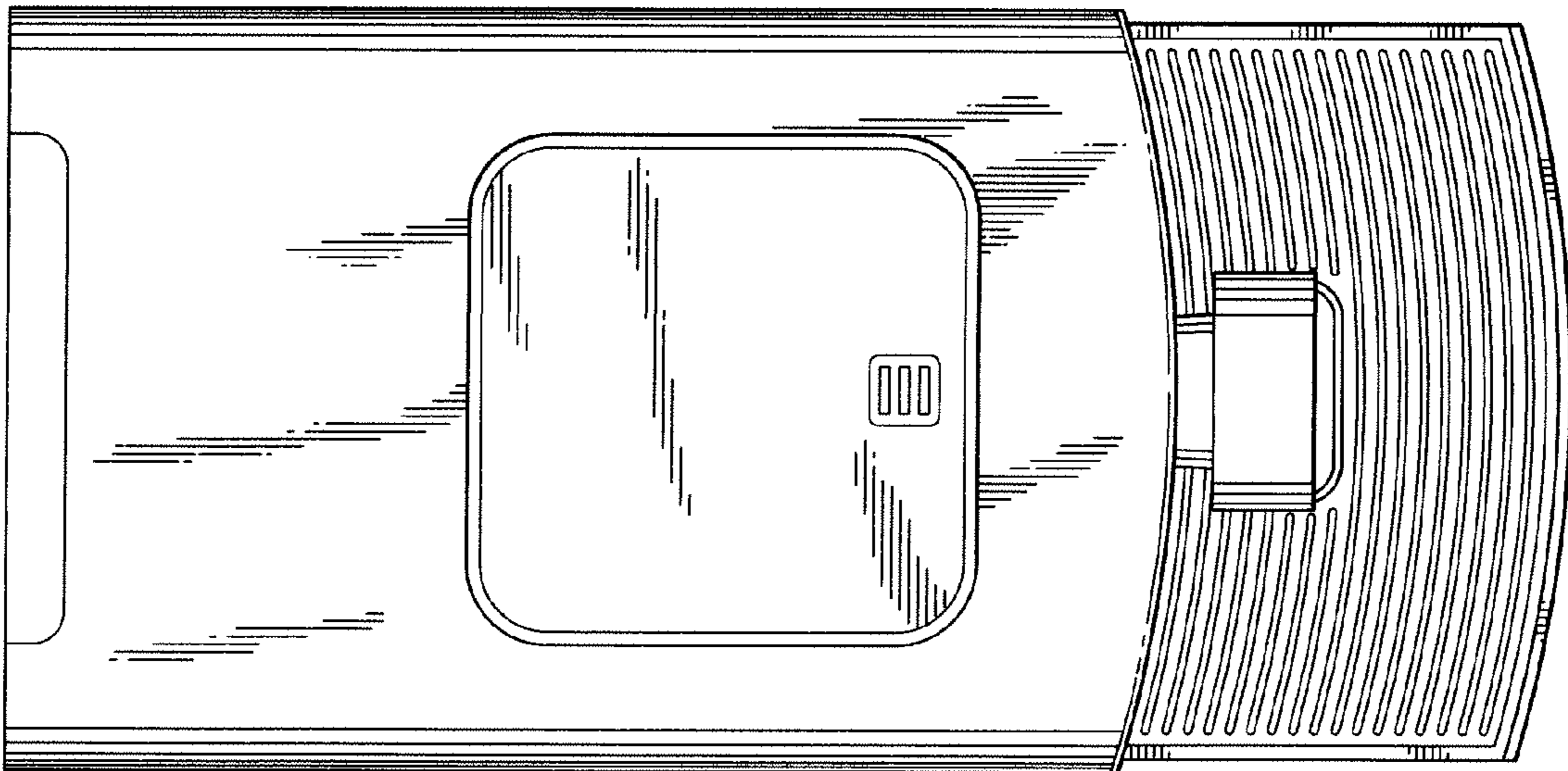
