We claim the ornamental design for a rotary cutter, as shown and described.

**DESCRIPTION**

FIG. 4 is a top view thereof;

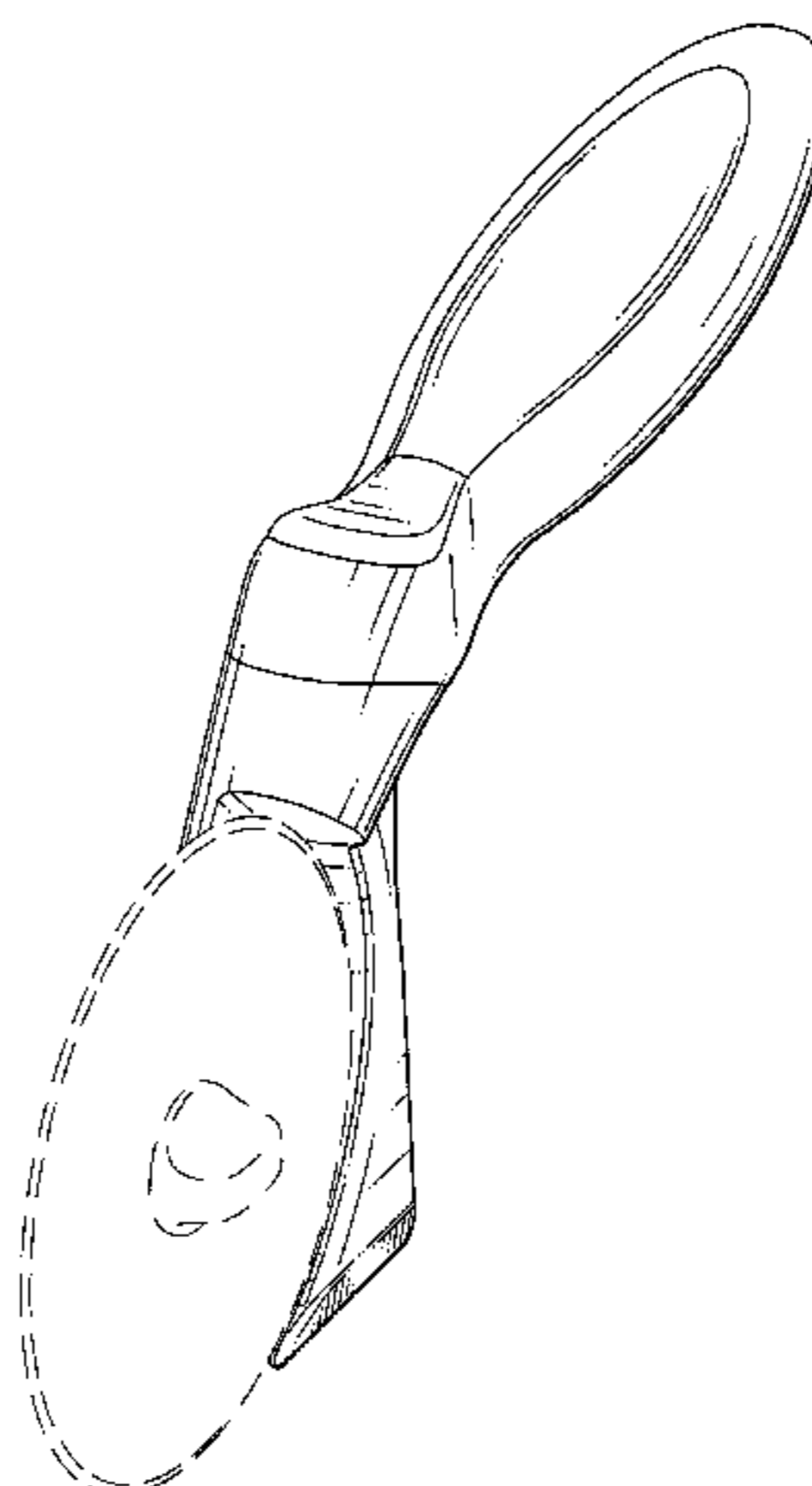
FIG. 5 is a bottom view thereof;

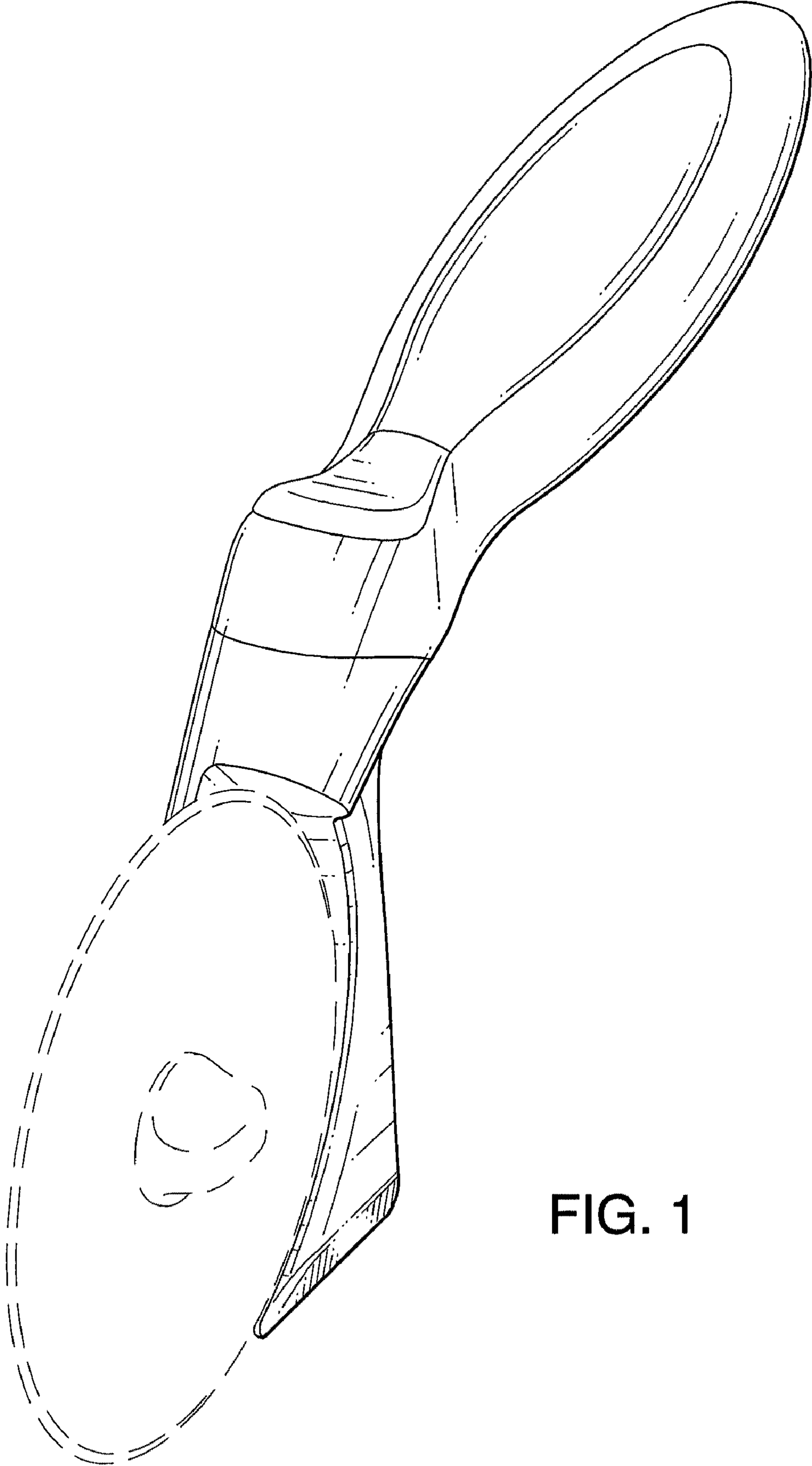

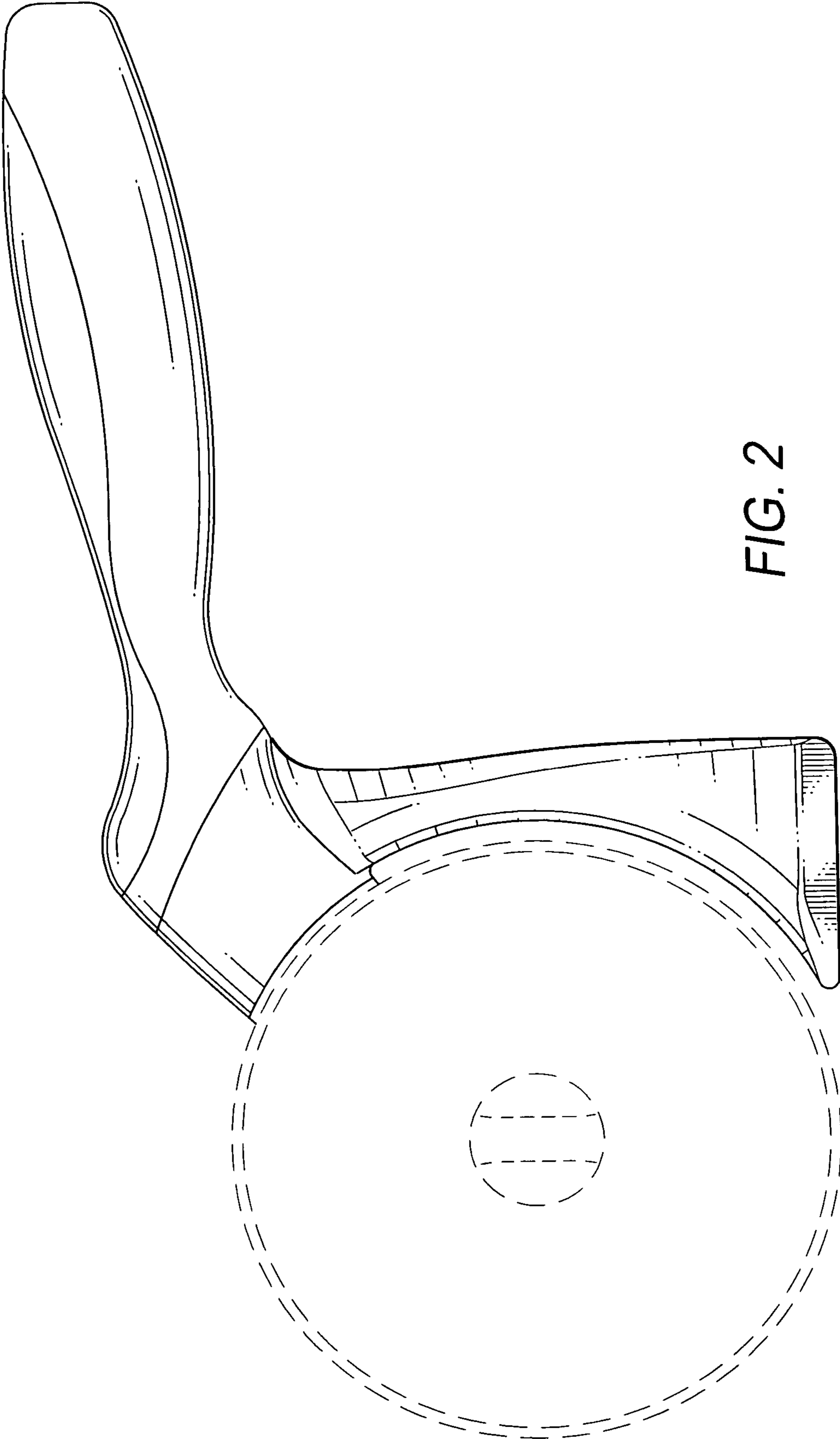

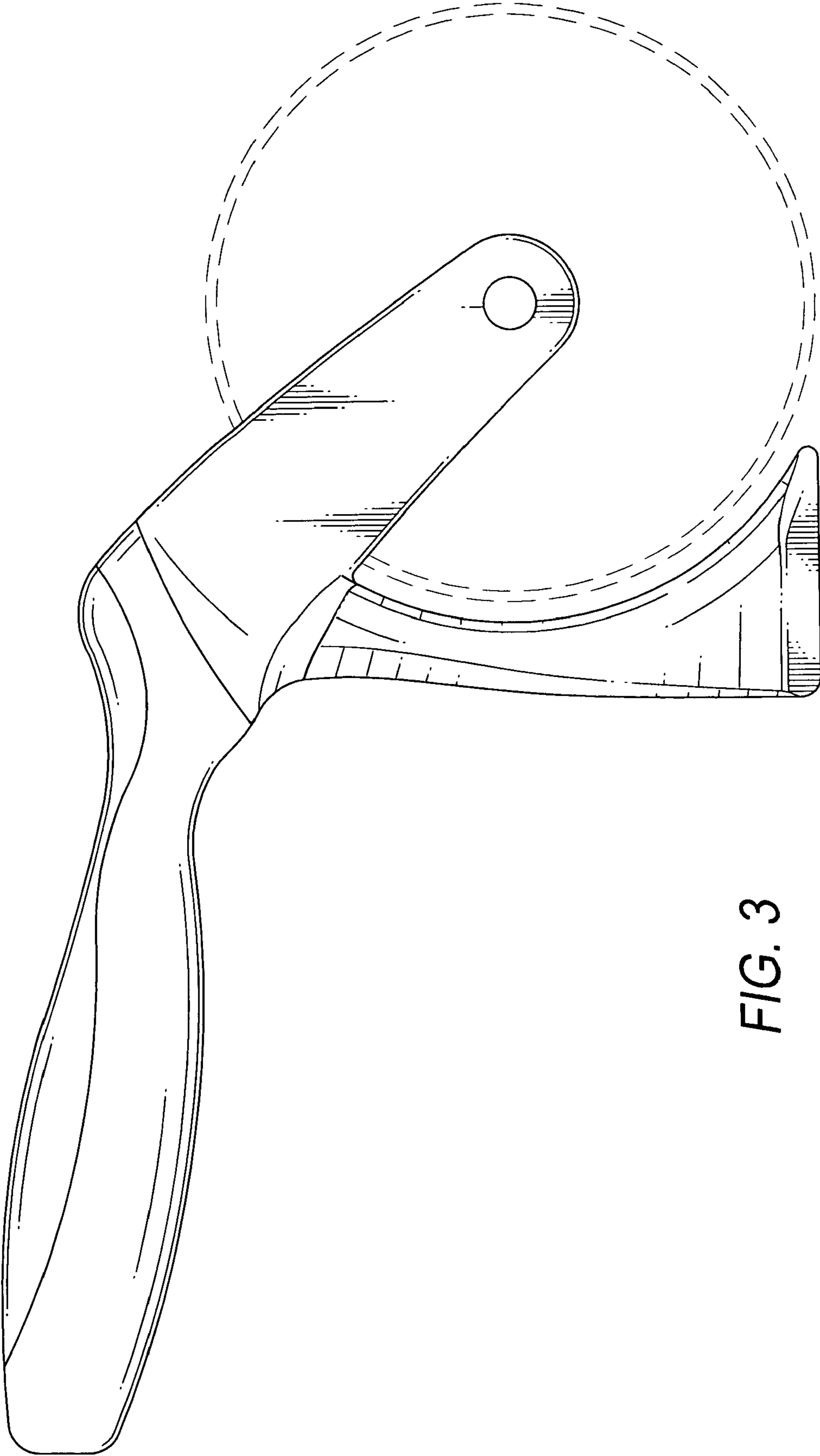

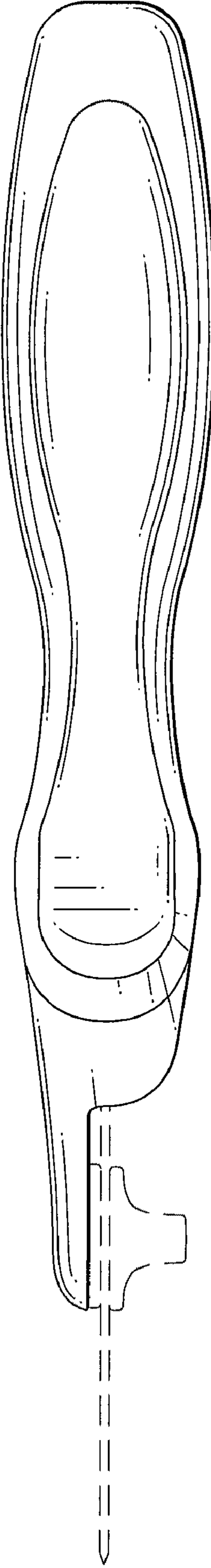

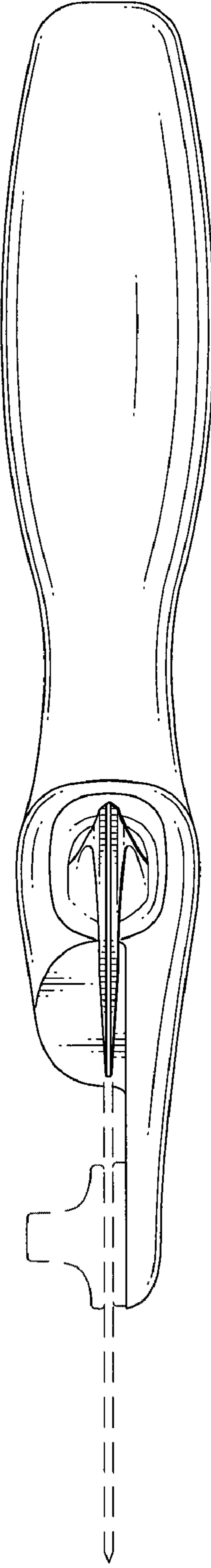

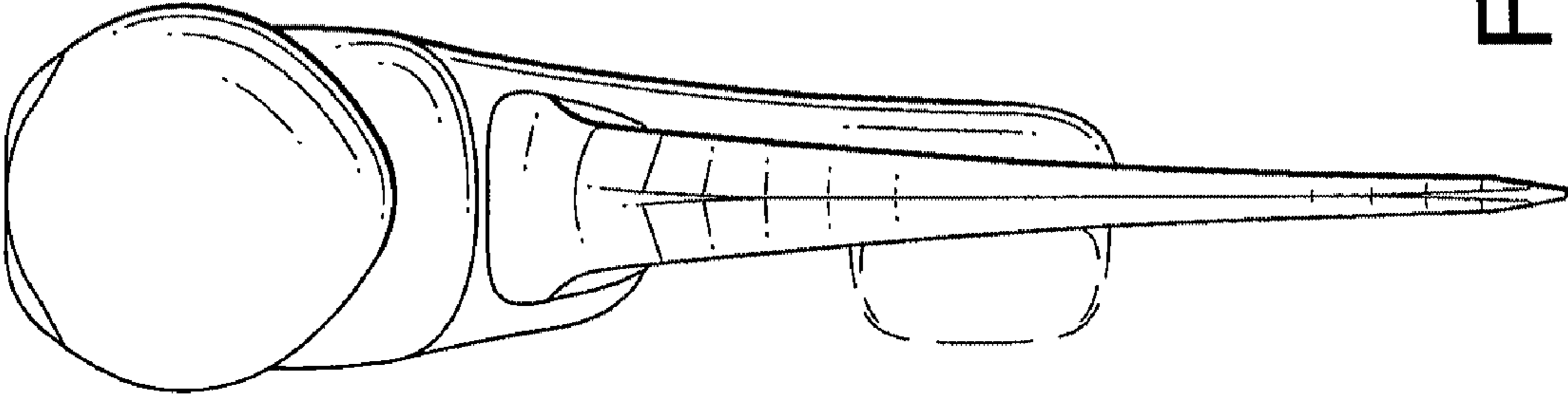

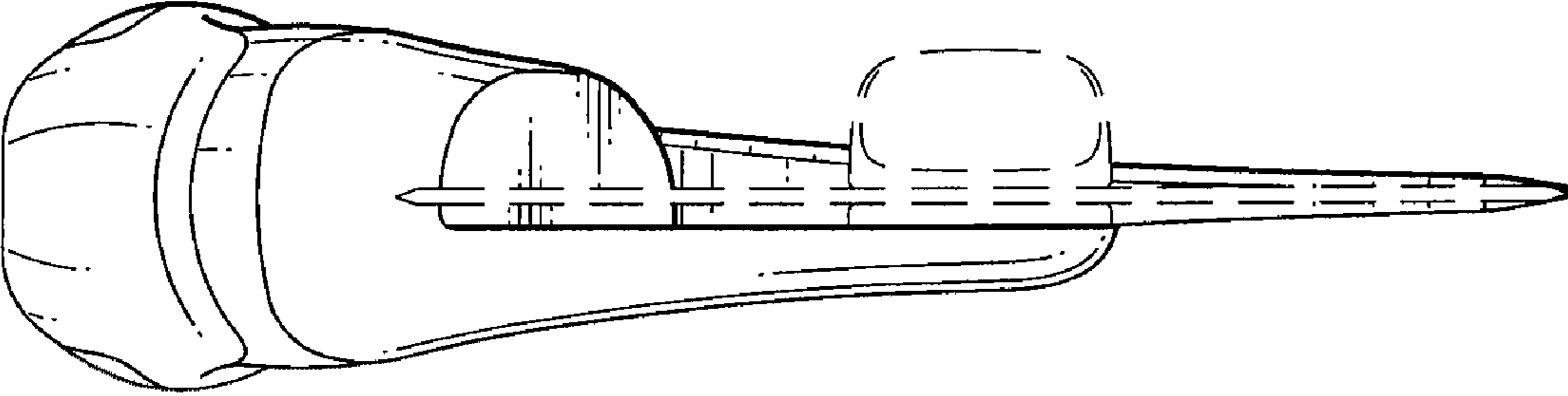
