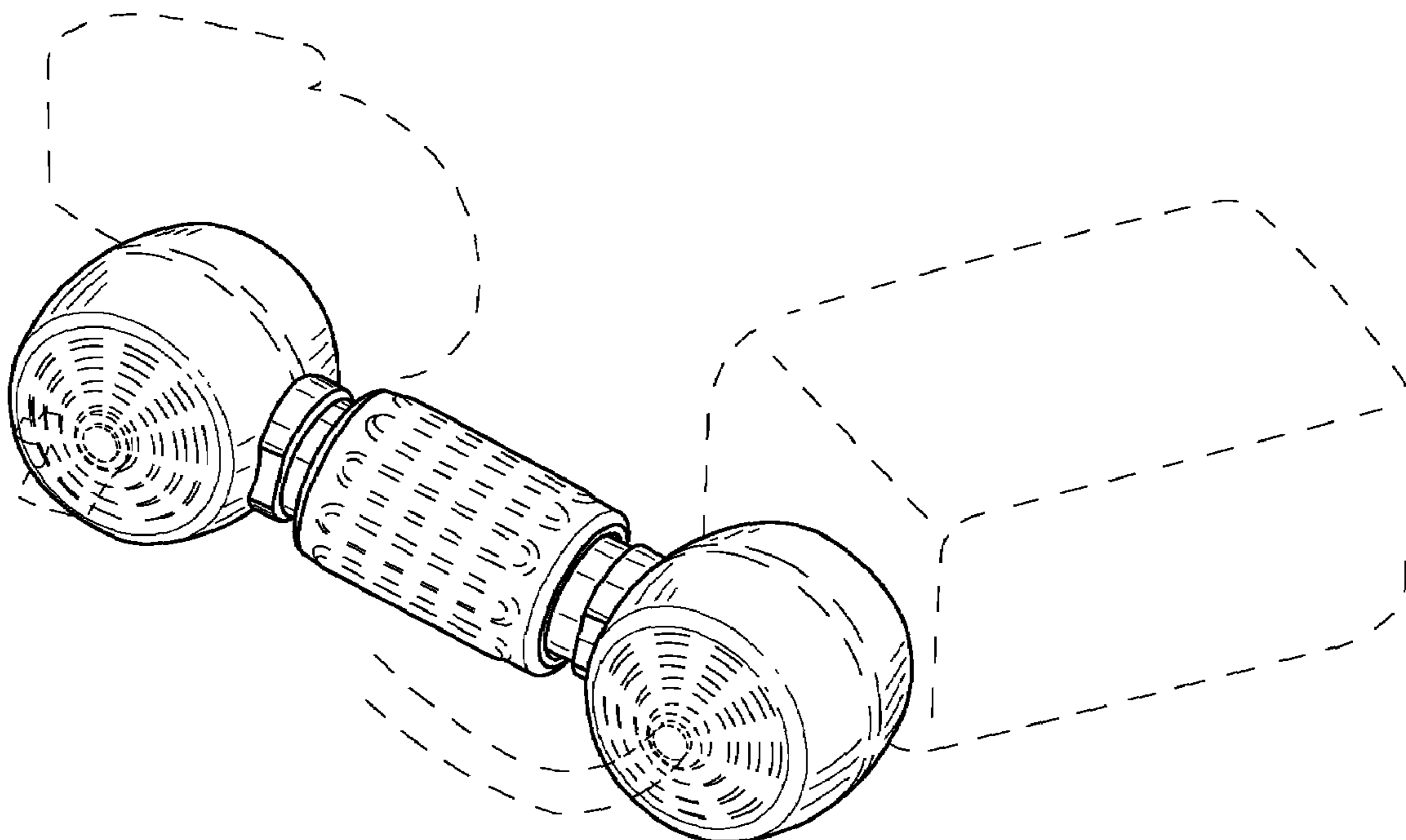
FIG. 2 is a top view of the adjustable attachment mechanism of FIG. 1, the bottom view being a mirror image thereof.

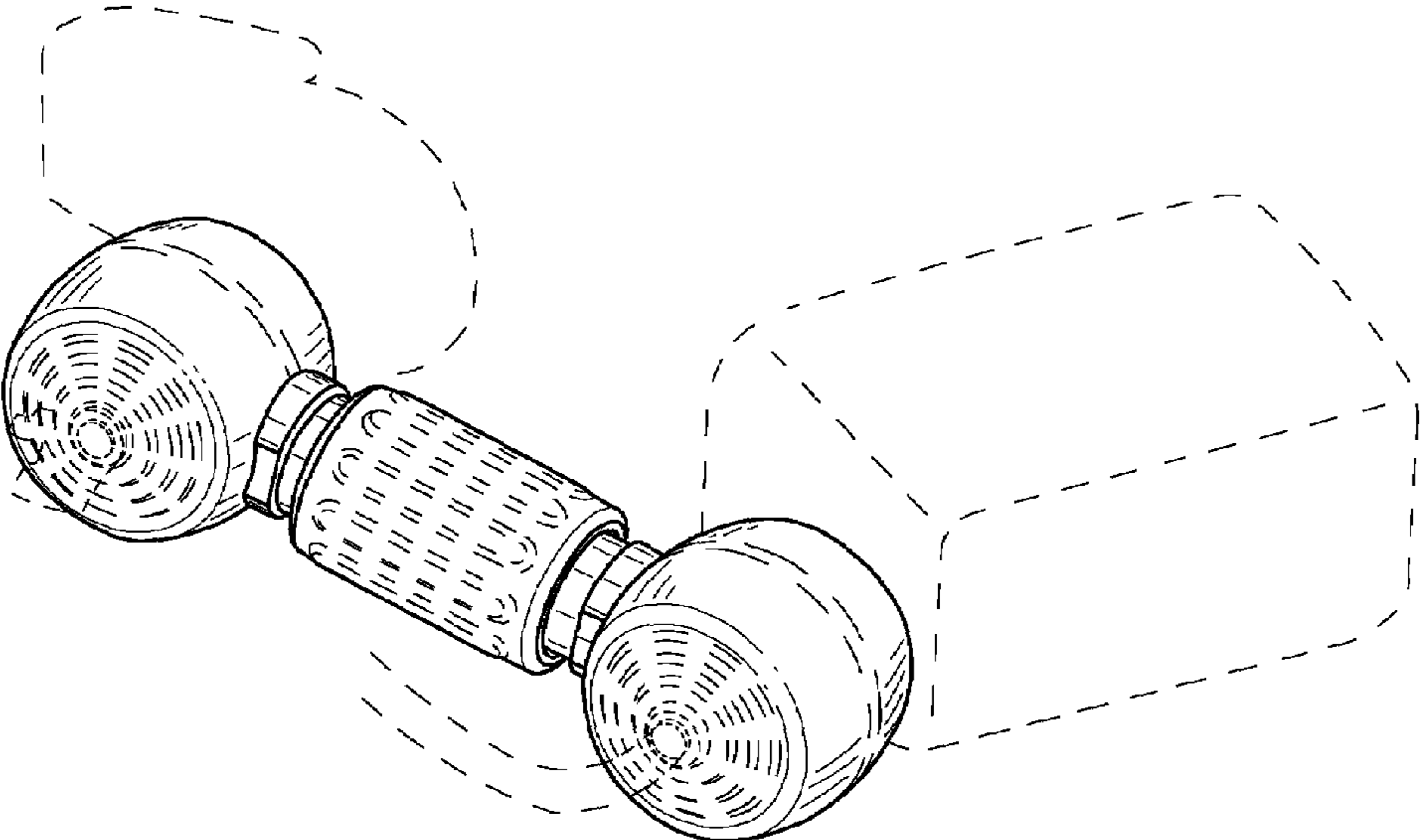

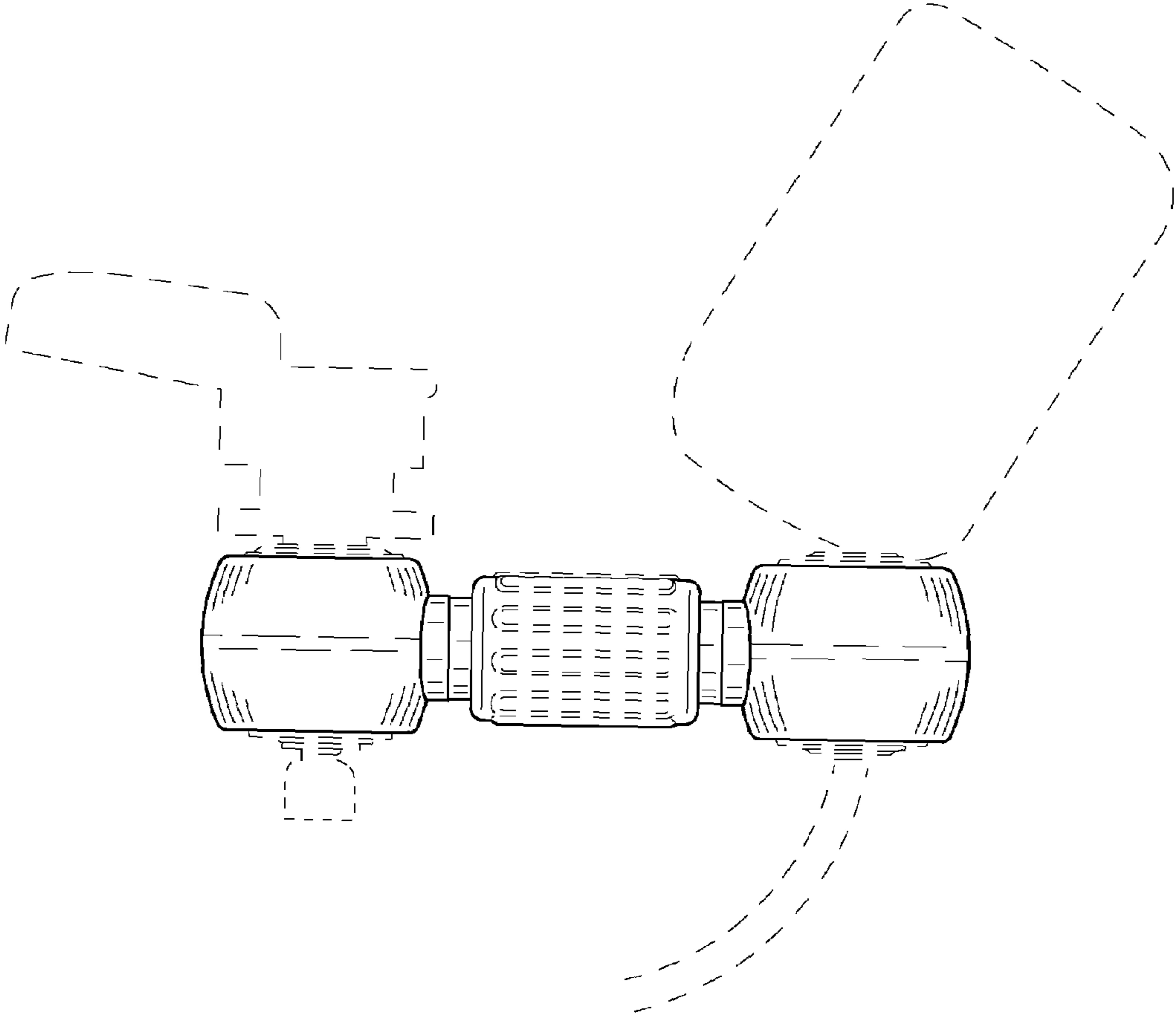

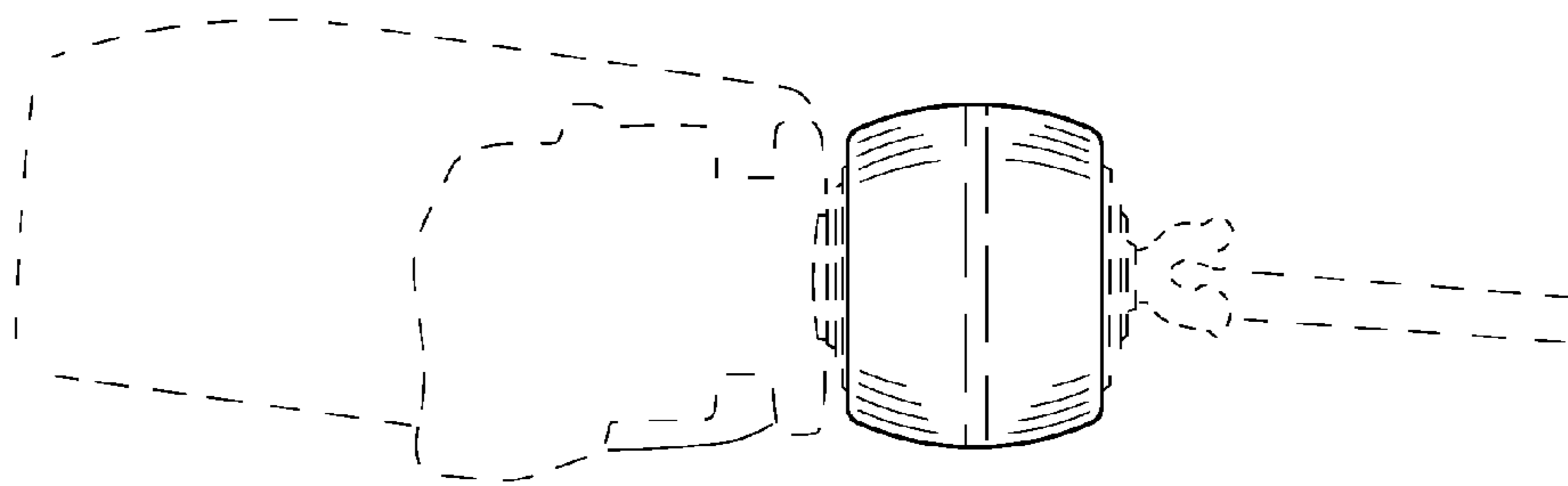

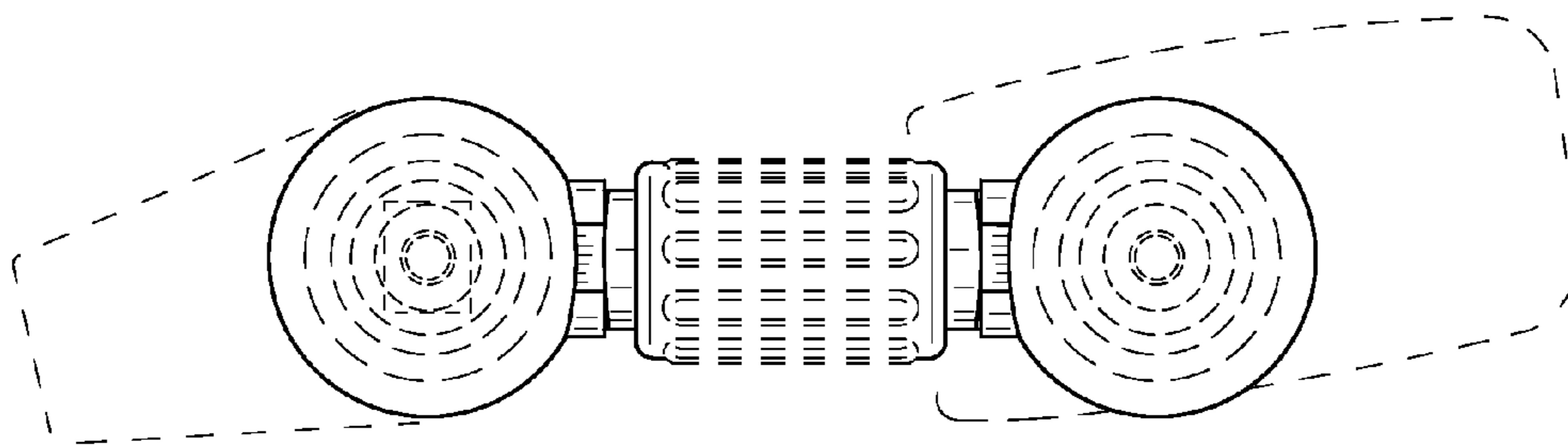
