The ornamental design for a cable organizer, as shown and described.

DESCRIPTION

FIG. 6. is a top plan view thereof;

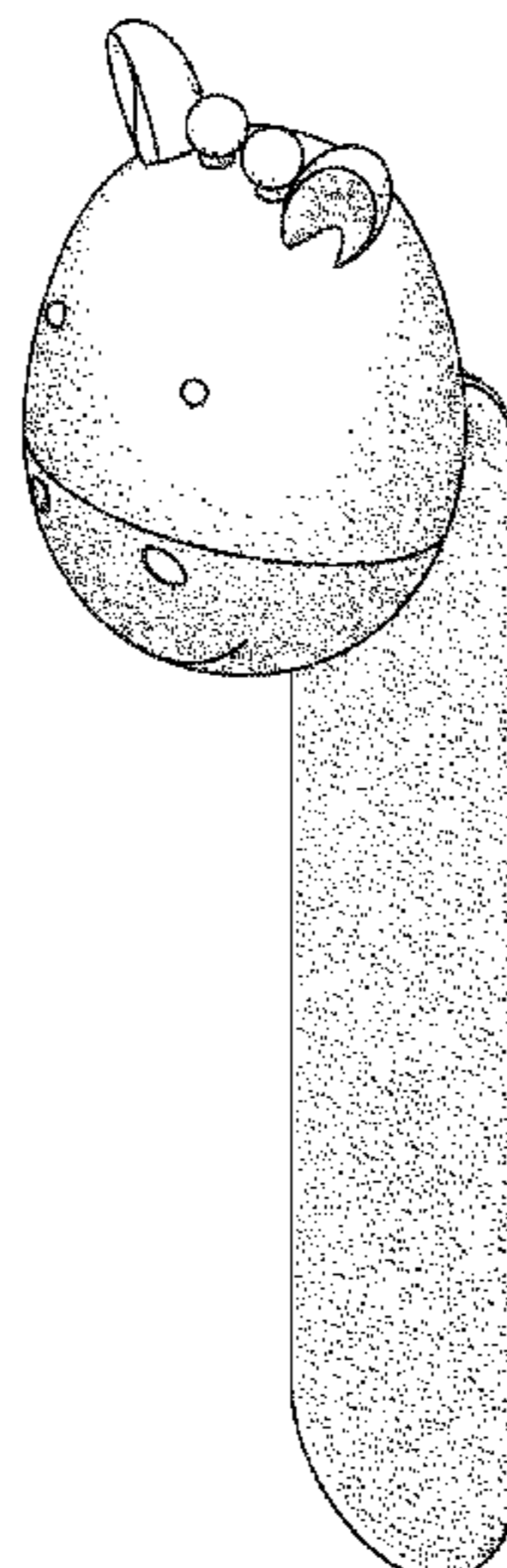
FIG. 7. is a bottom plan view thereof;

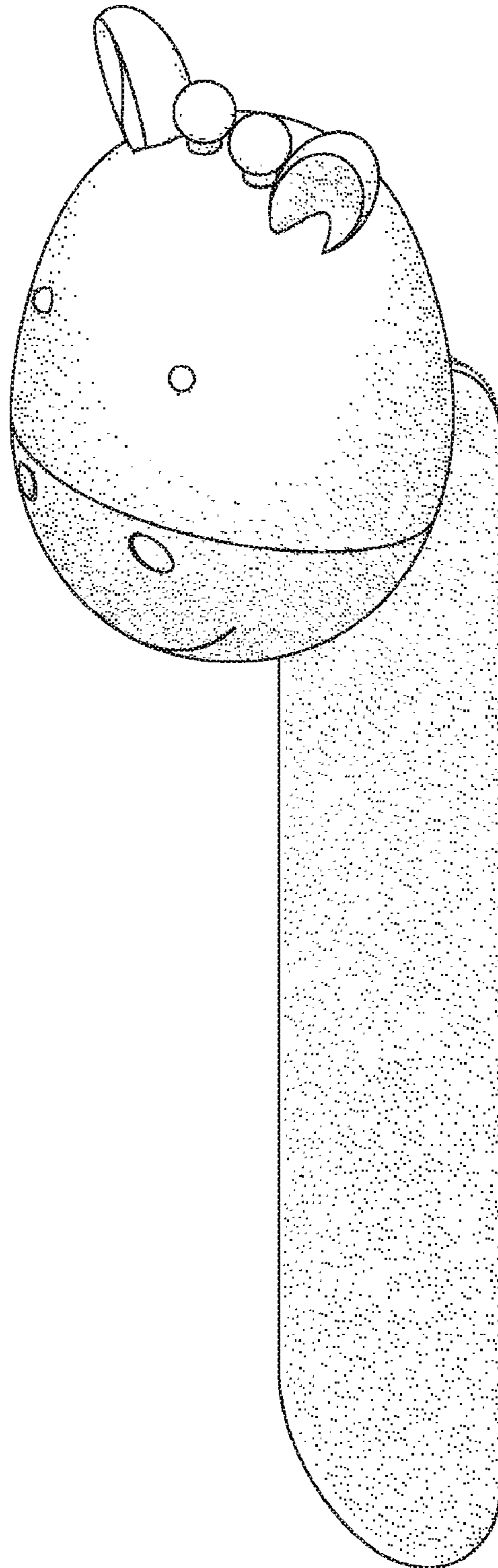

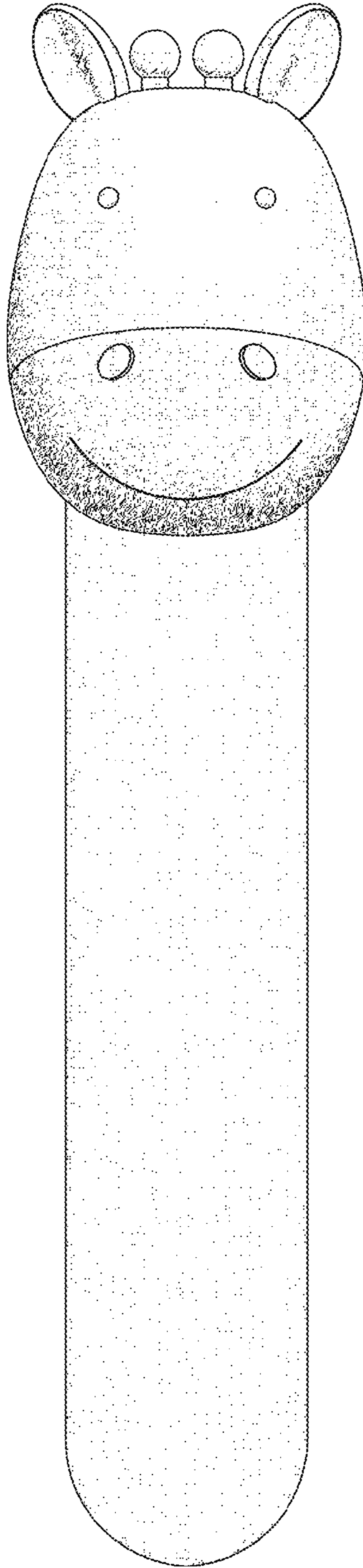

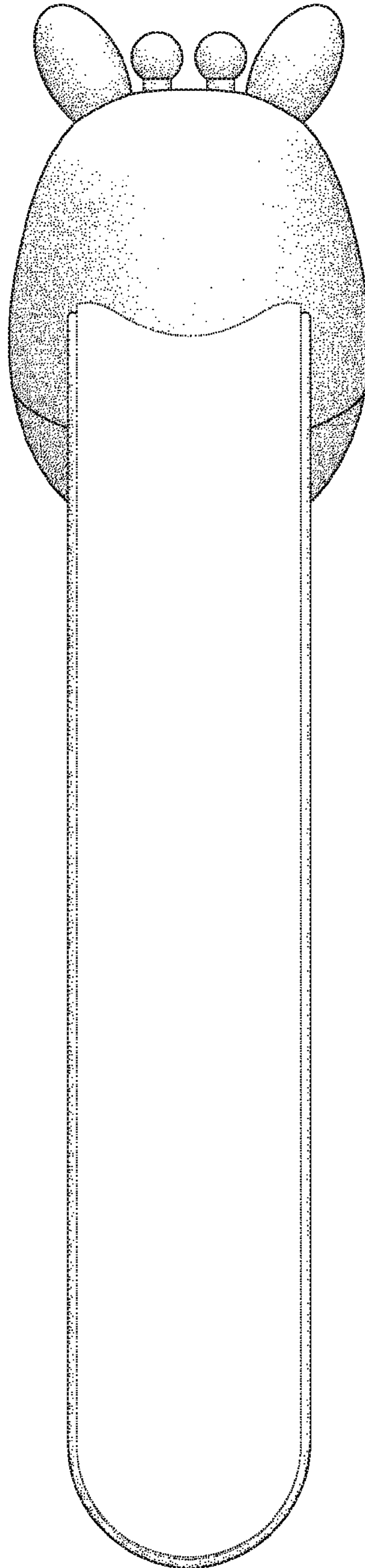

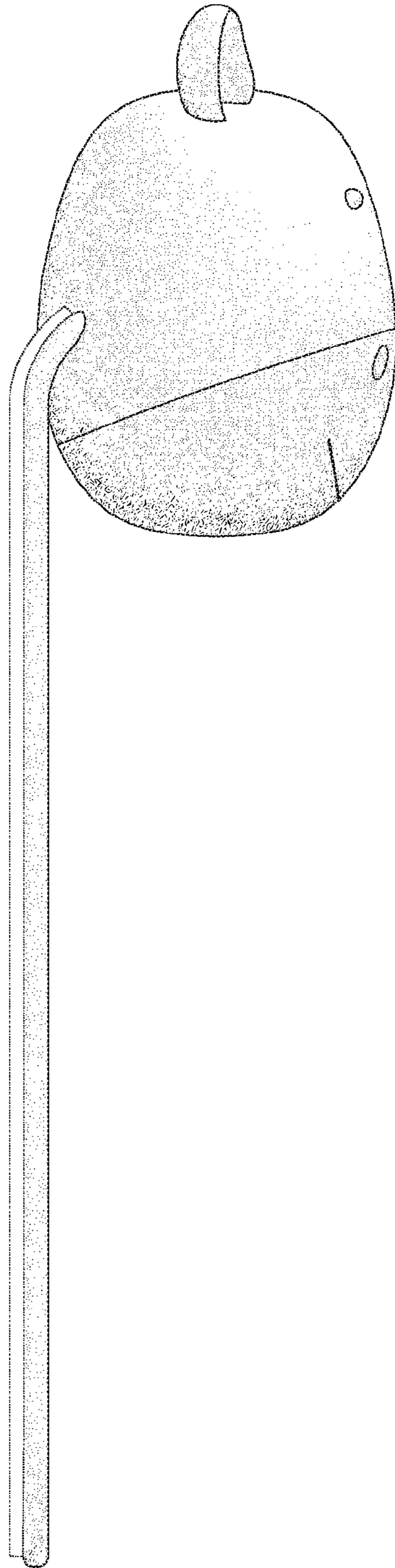

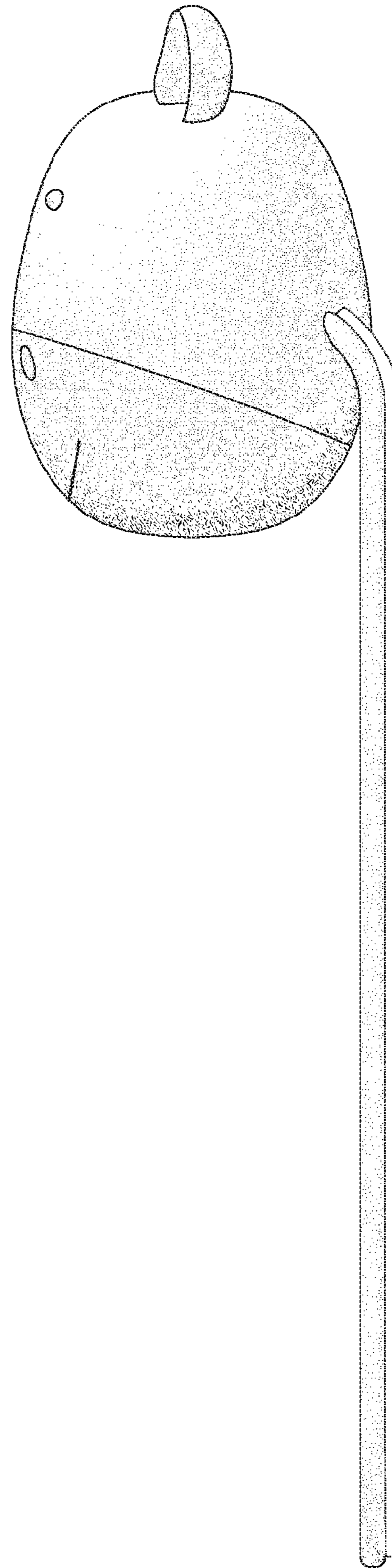

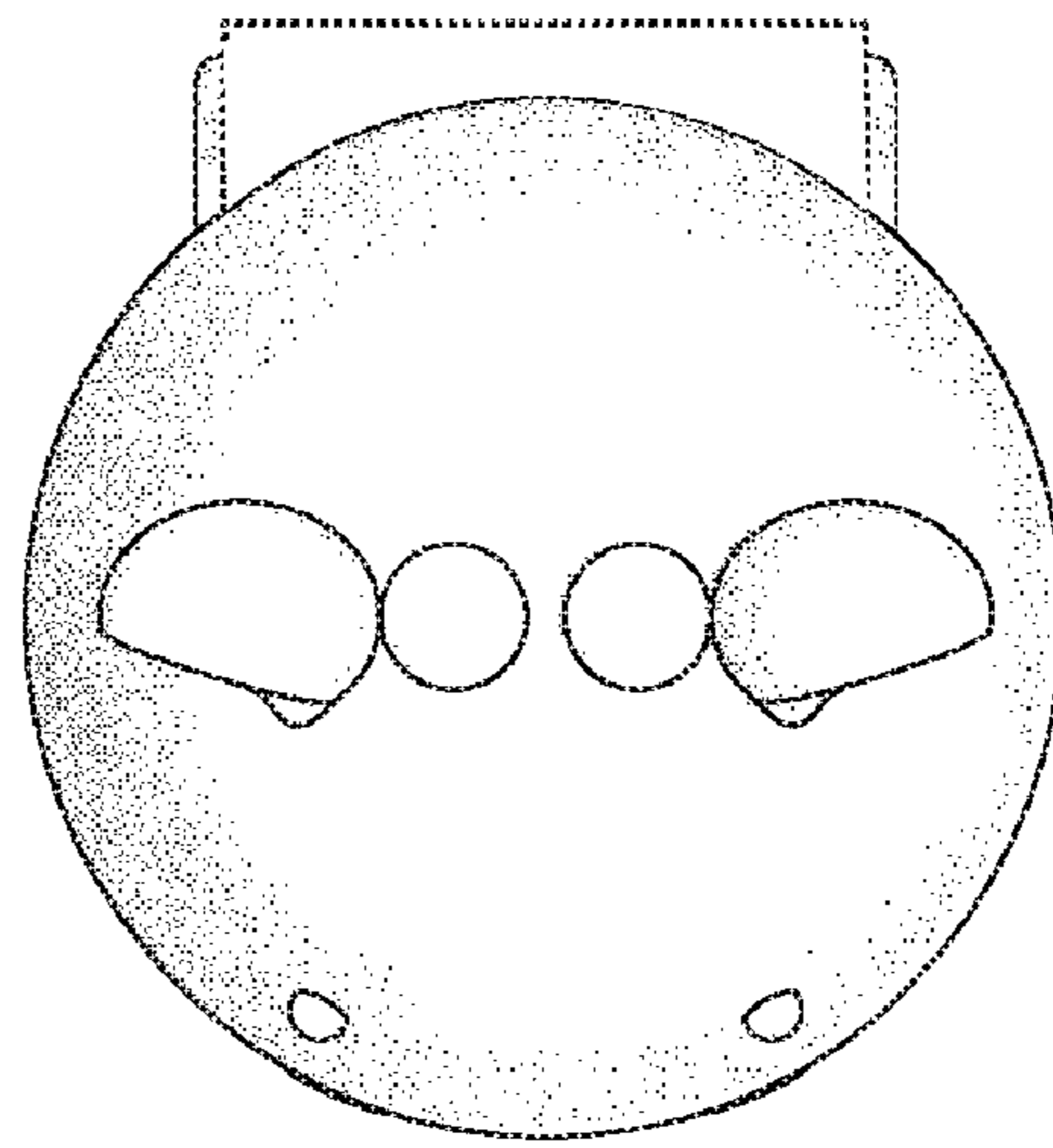

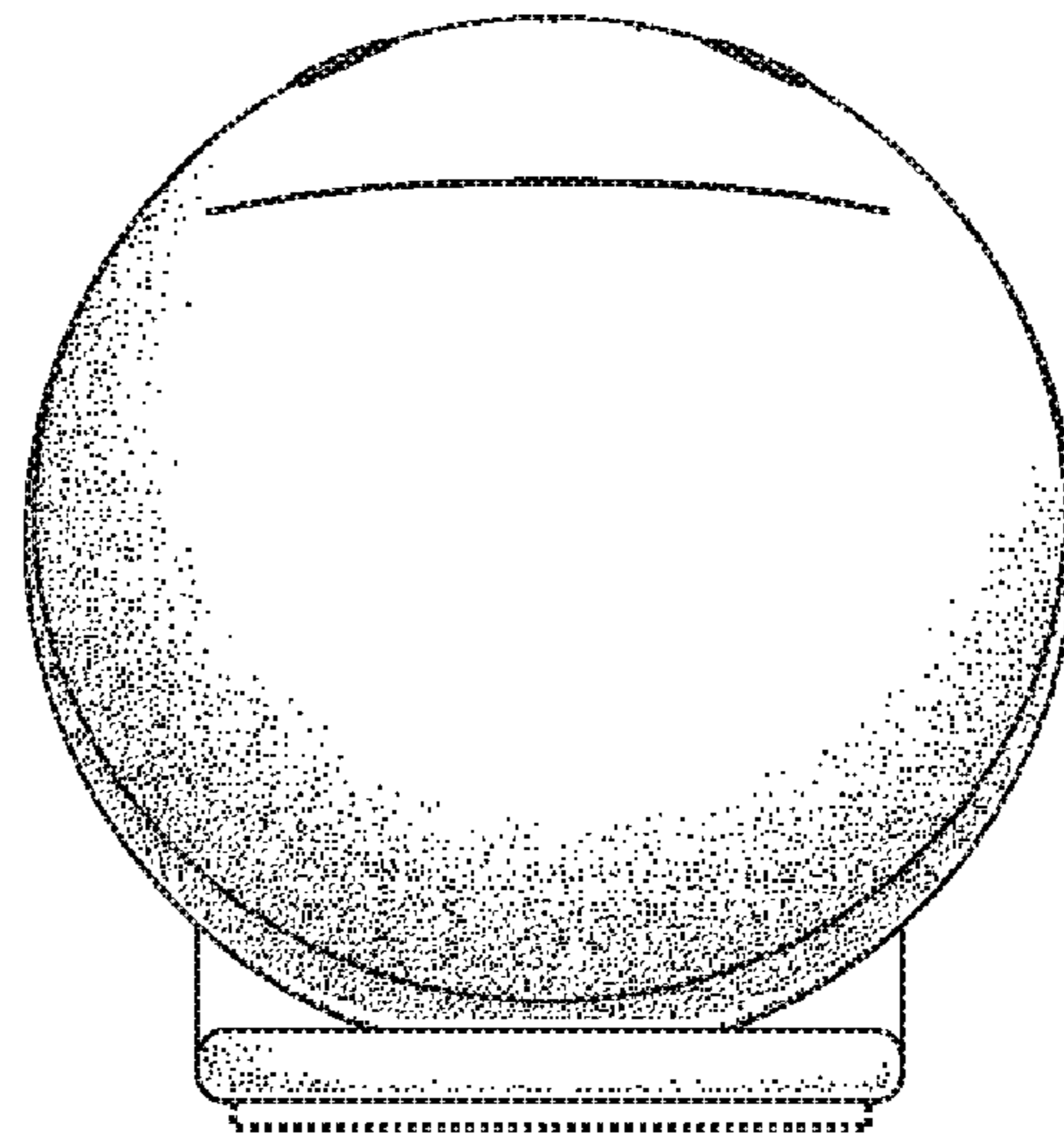

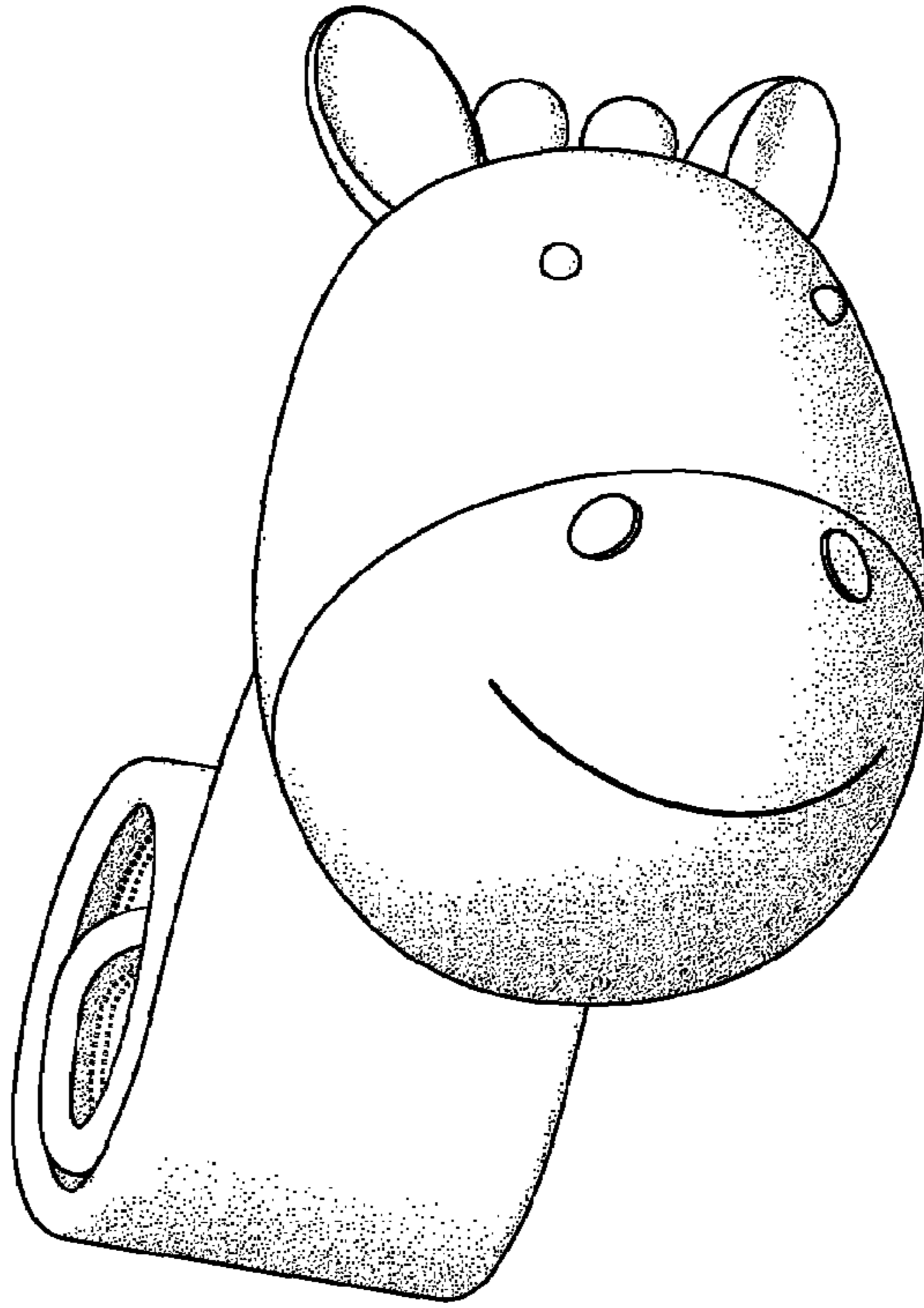
