FIG. 2 is a top view of the shower hook as shown in FIG. 1;

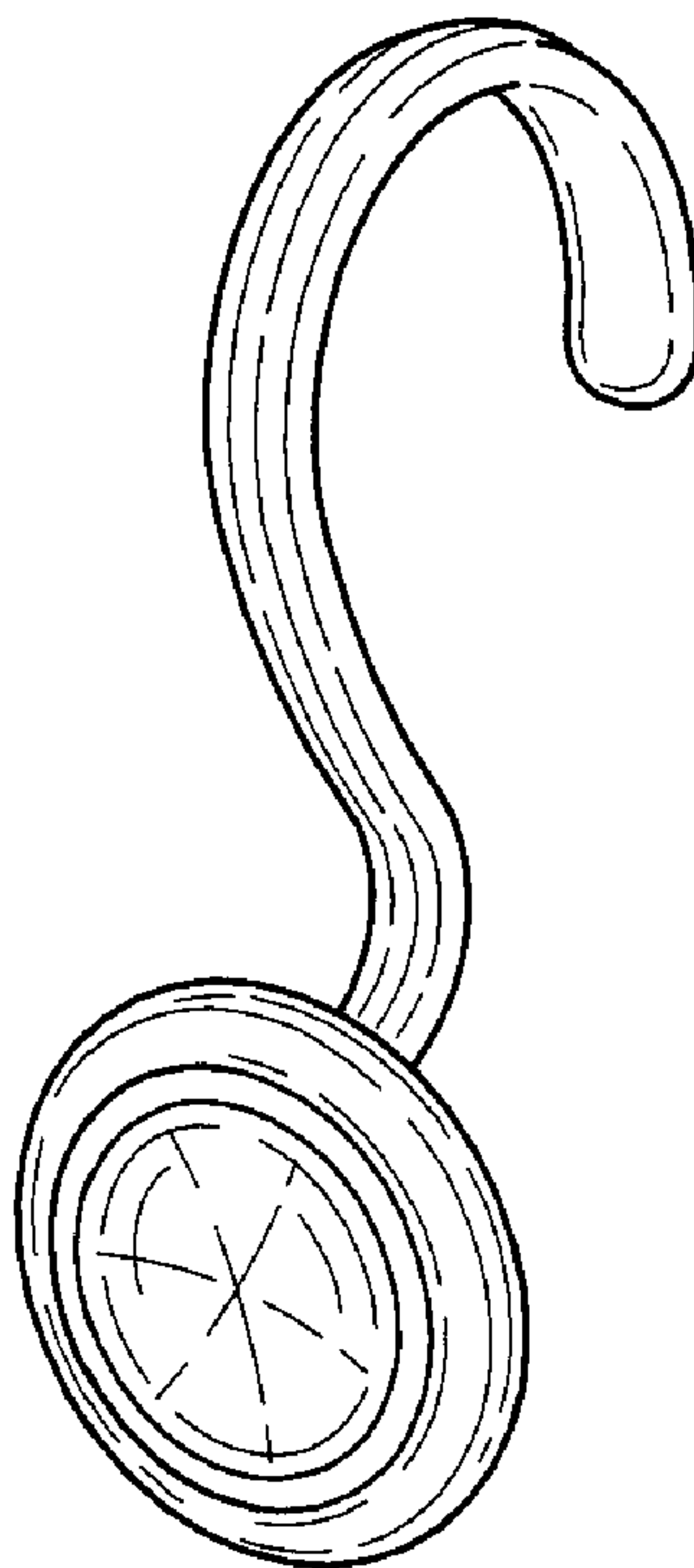
FIG. 3 is a front view of the shower hook as shown in FIG. 1;

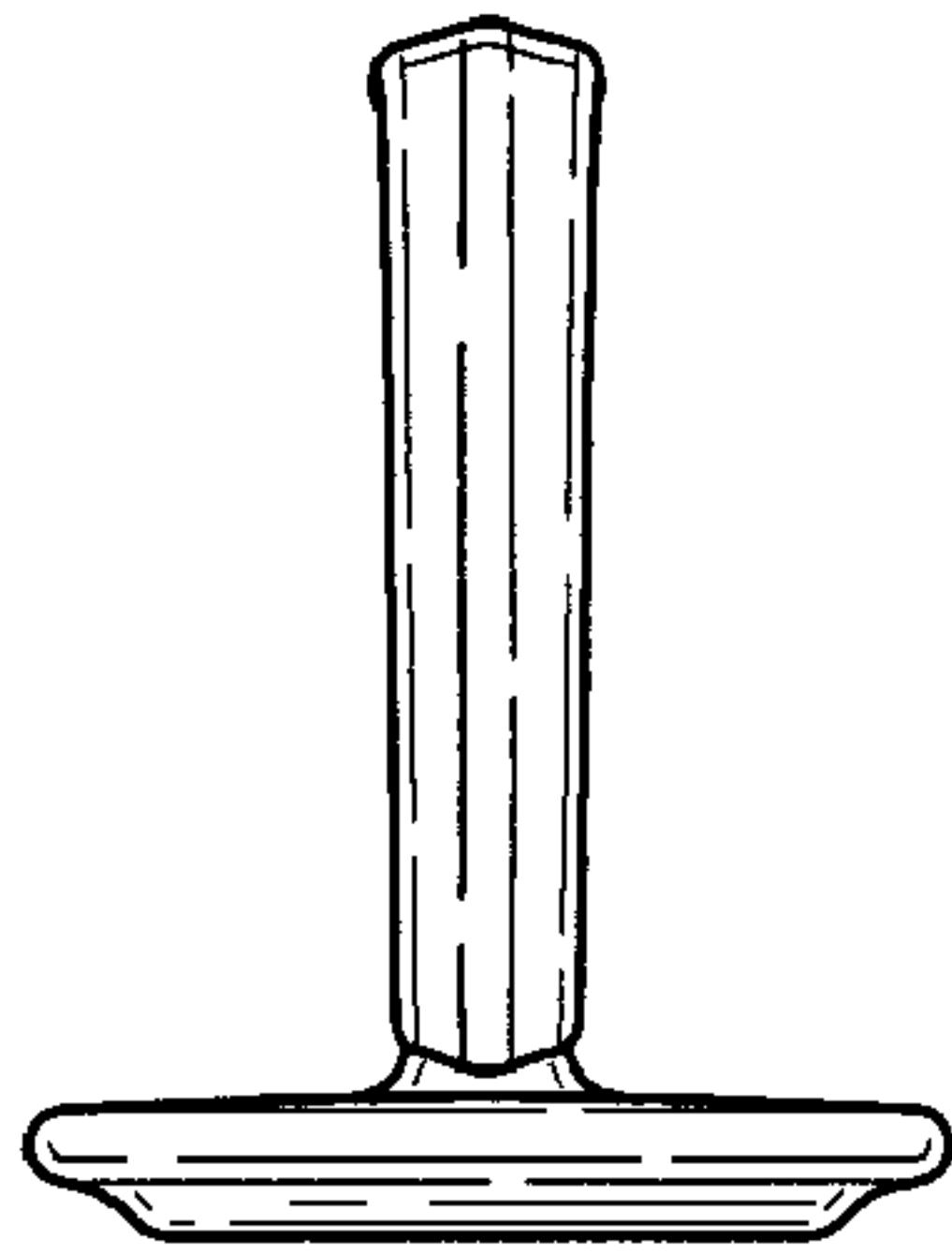

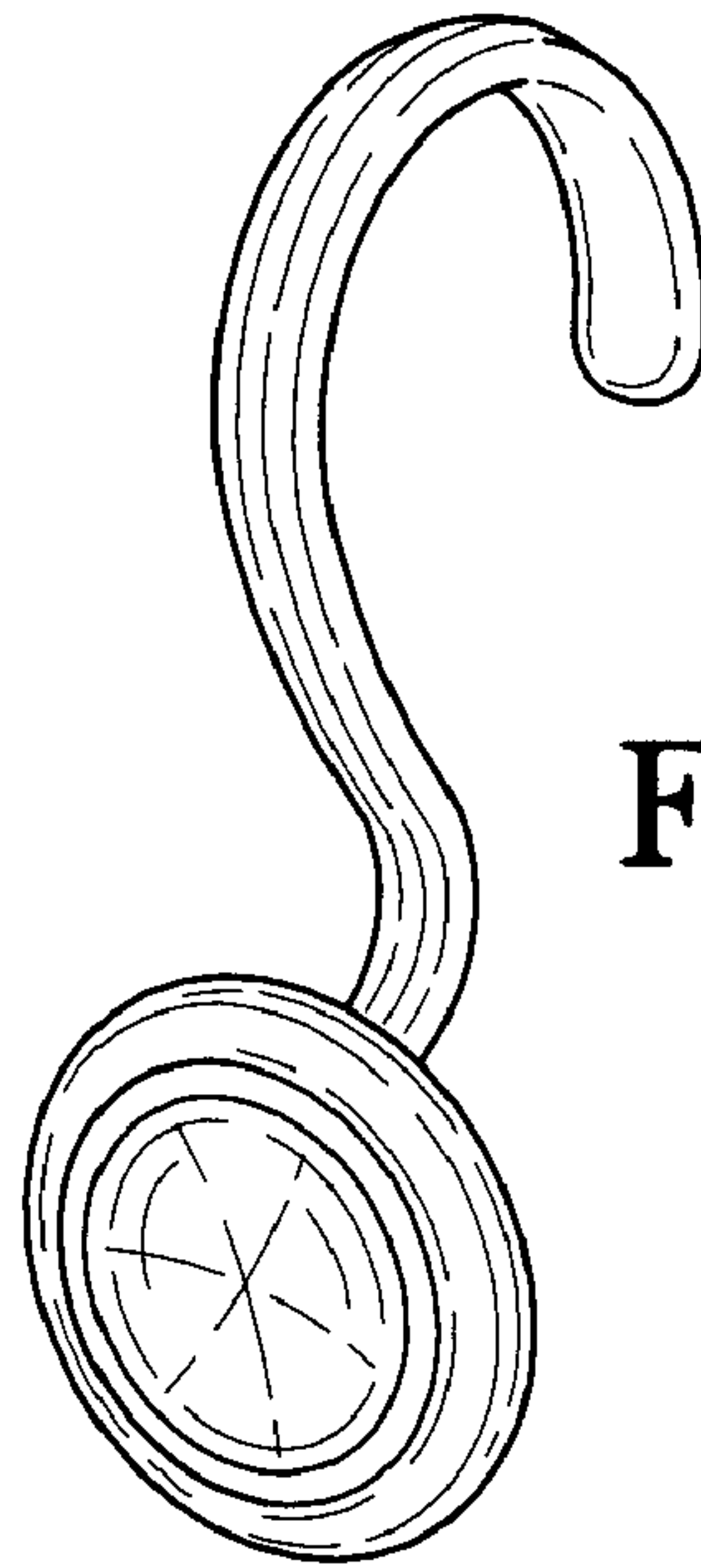

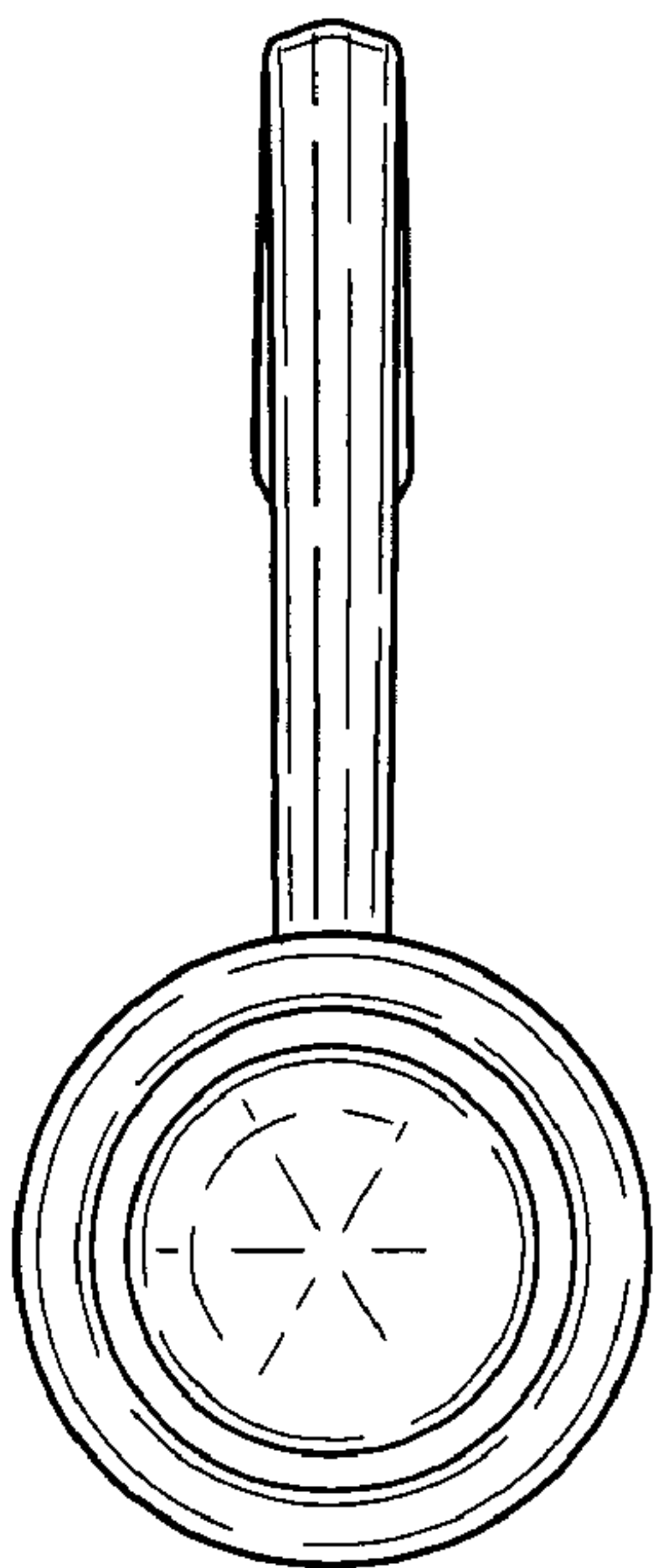

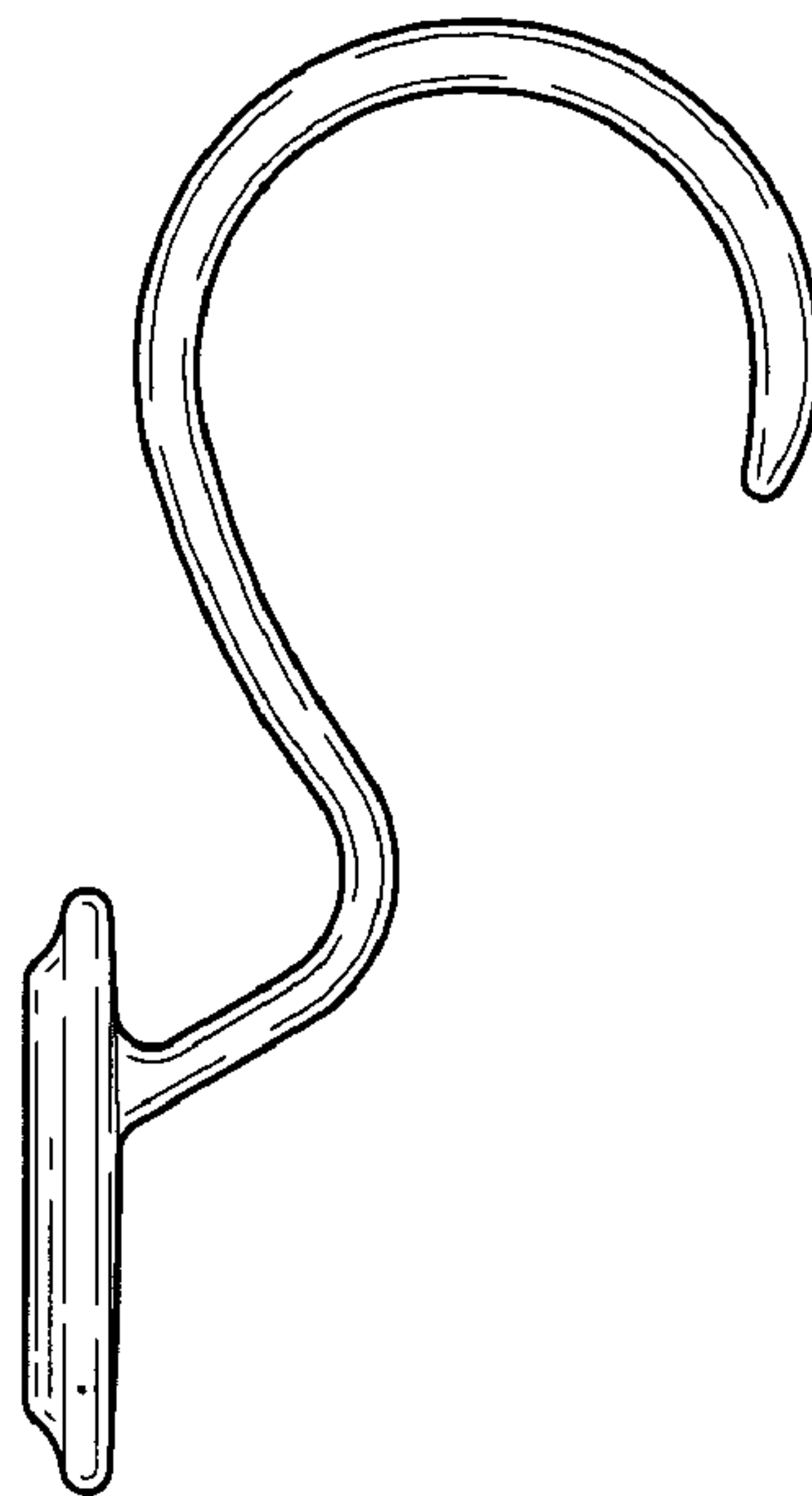

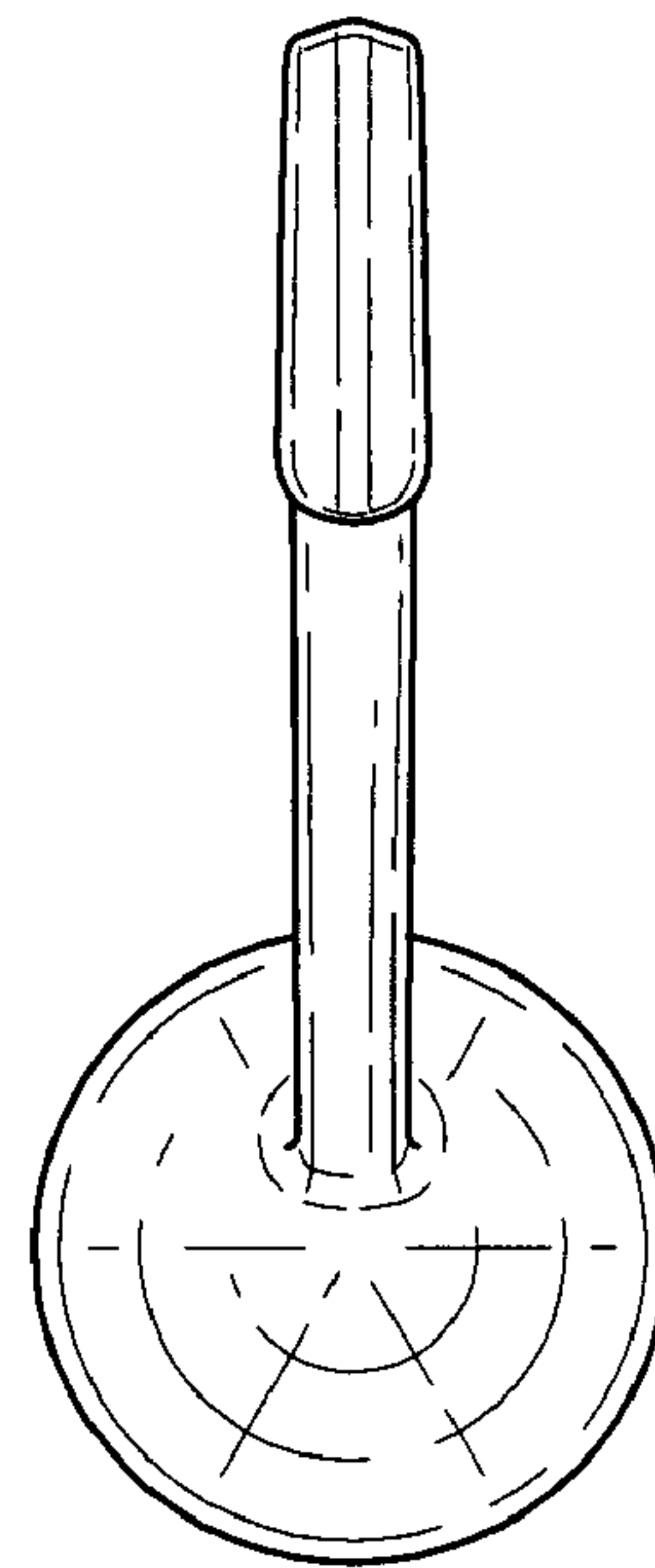

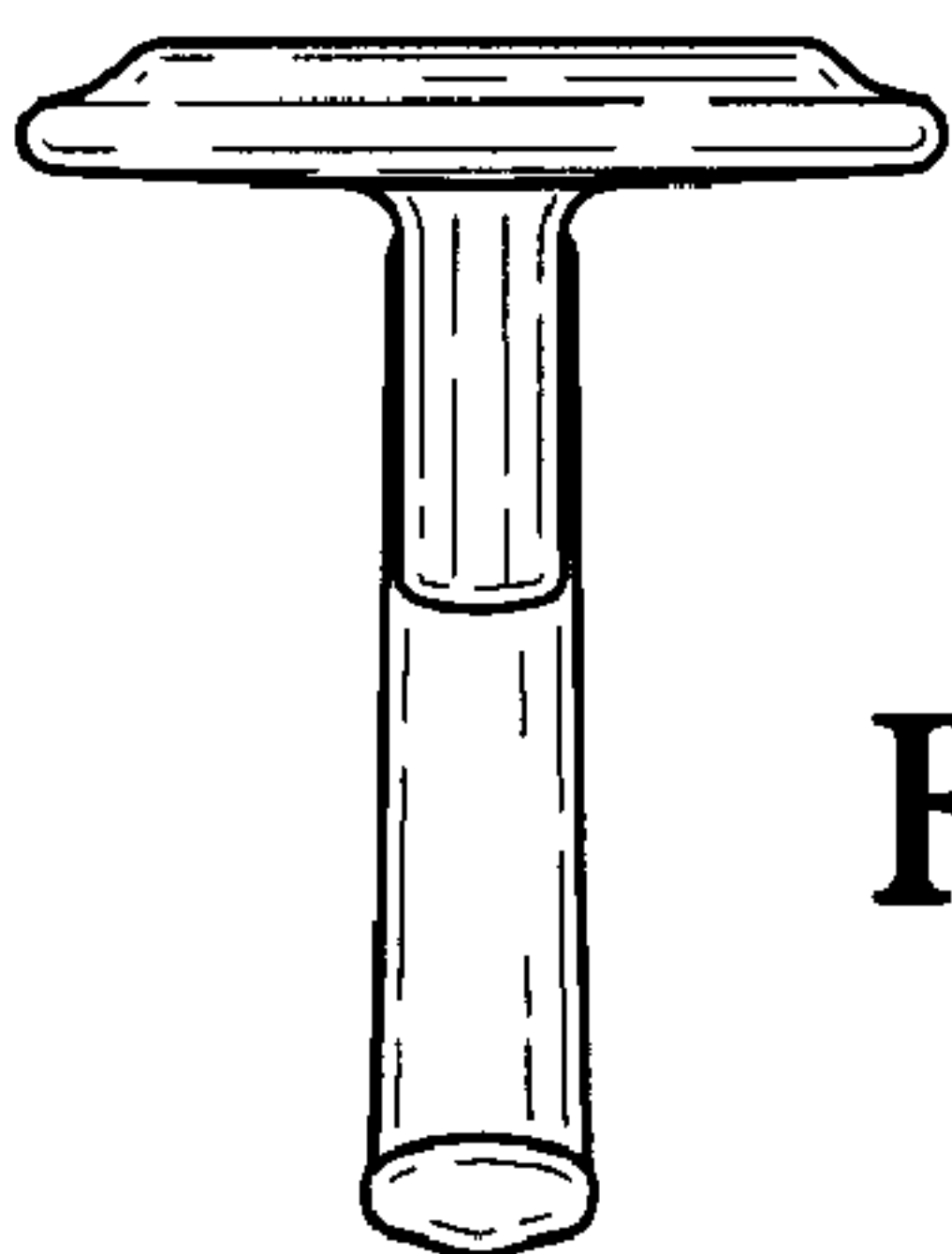
