FIG. 1 is a front elevational view of a container showing our new design, wherein the rear elevational view is a mirror image thereof.

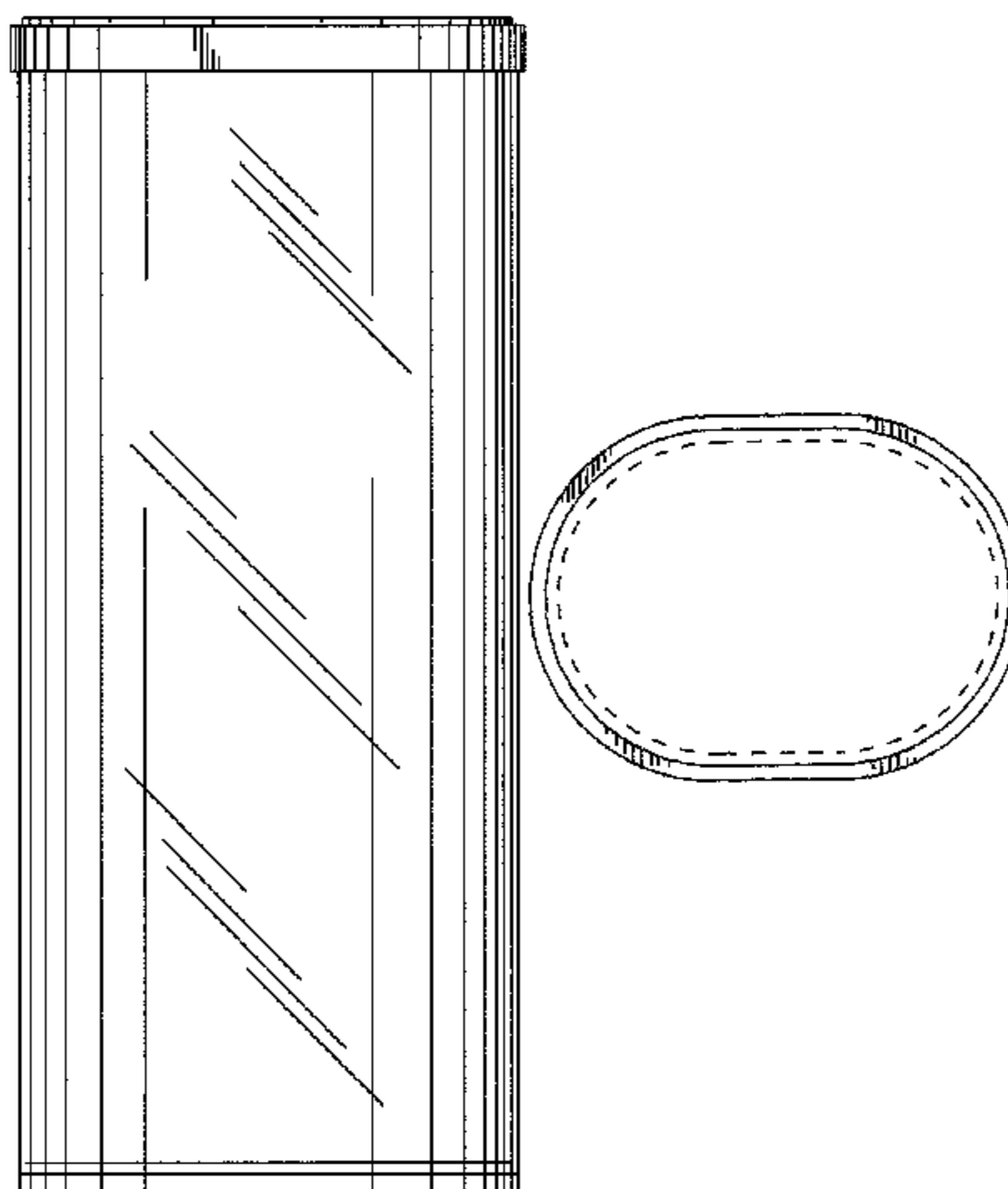
FIG. 2 is a right side view thereof, wherein the left side view is a mirror image thereof.

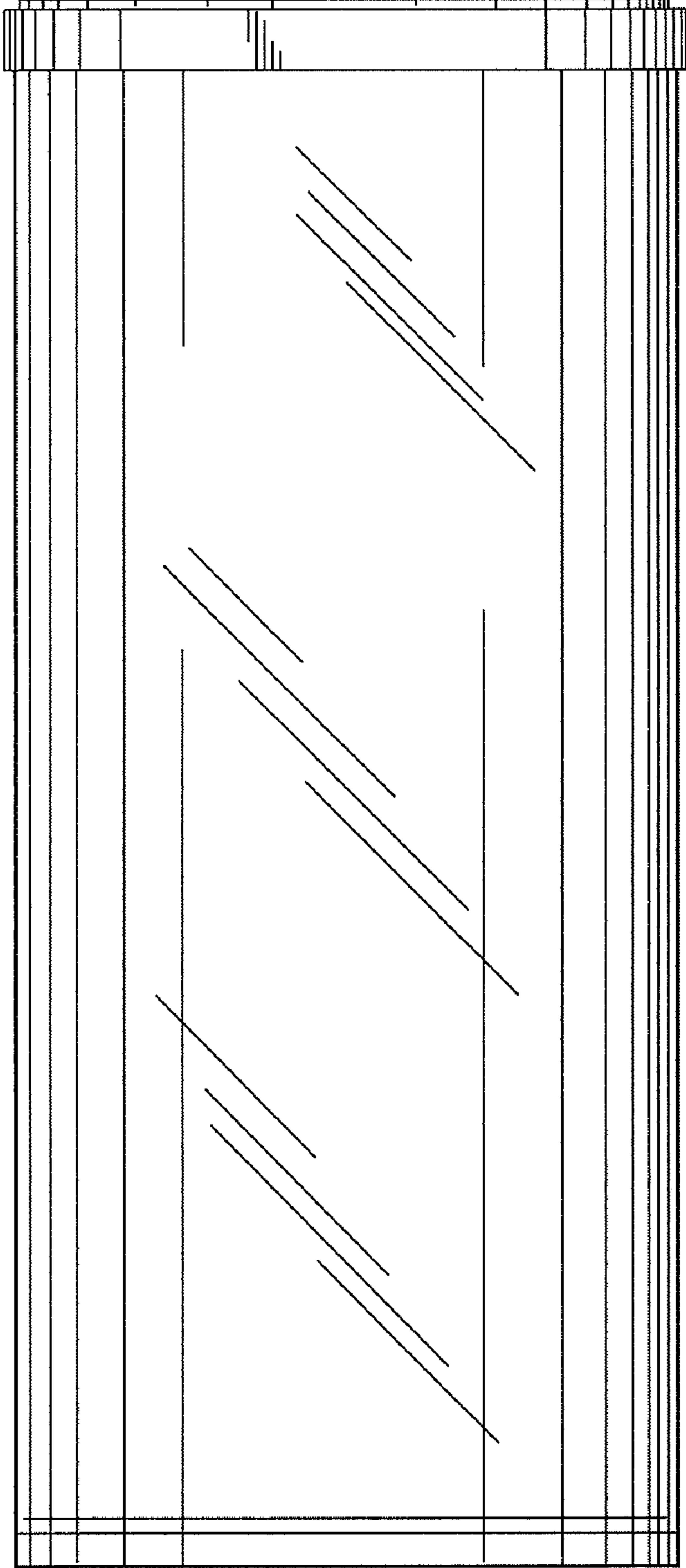

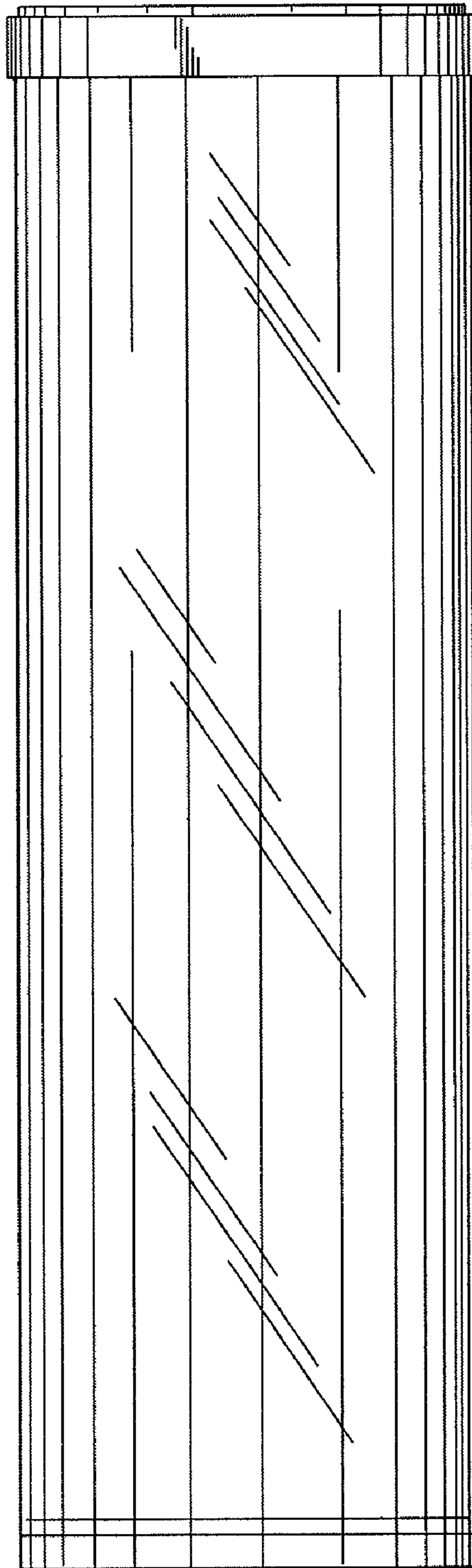

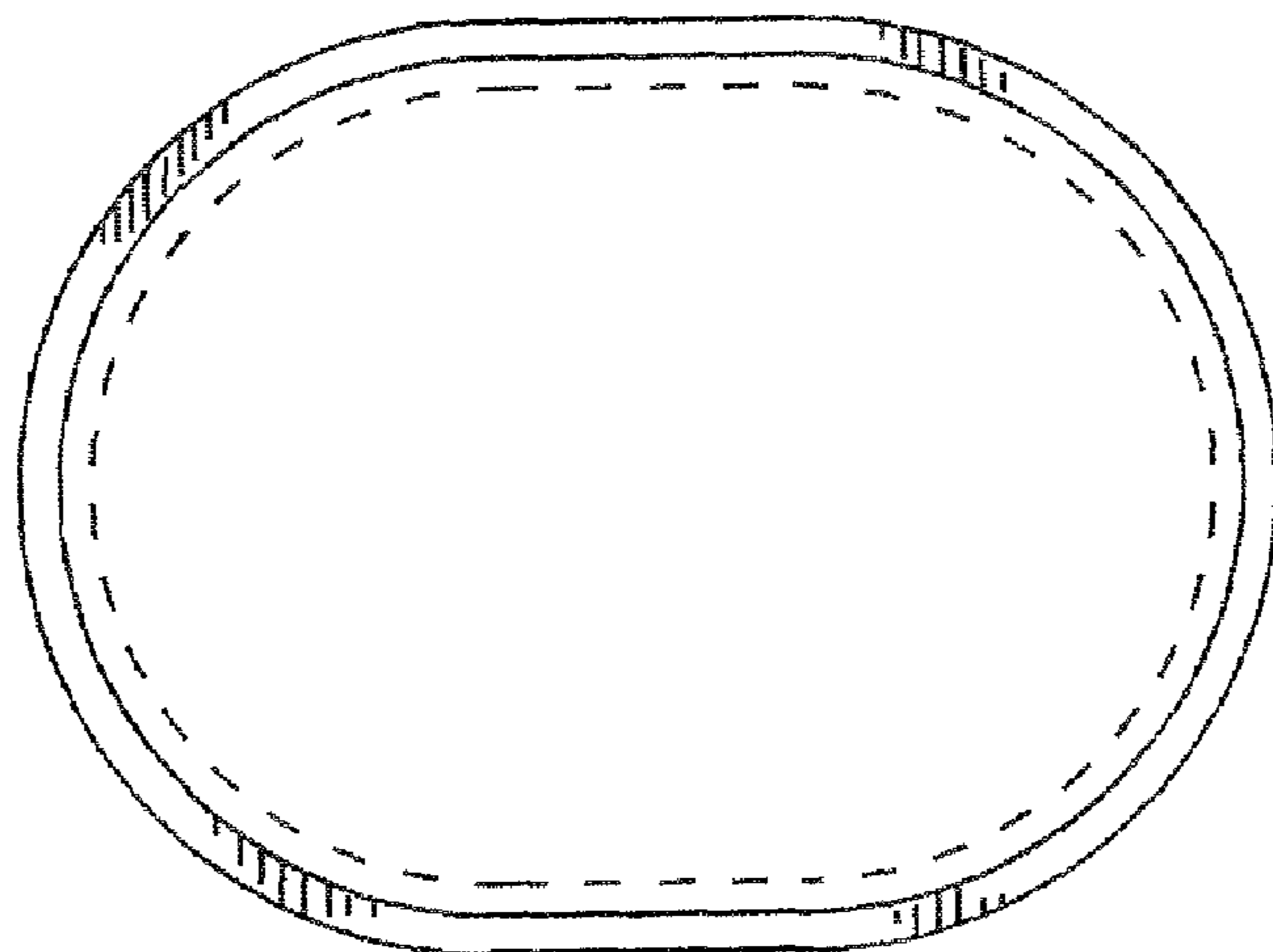

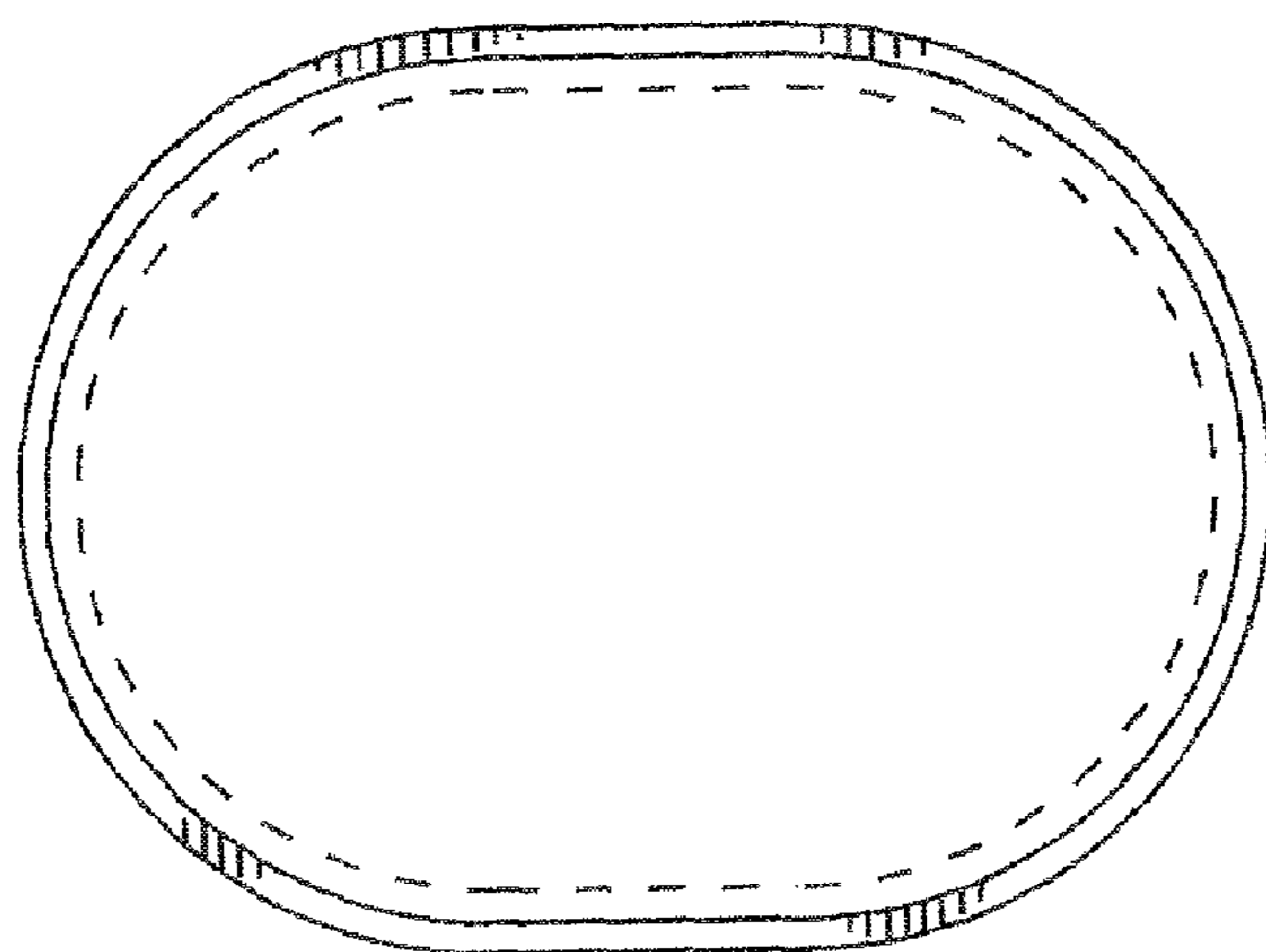
