FIG. 11 is a right side elevational view thereof; and,

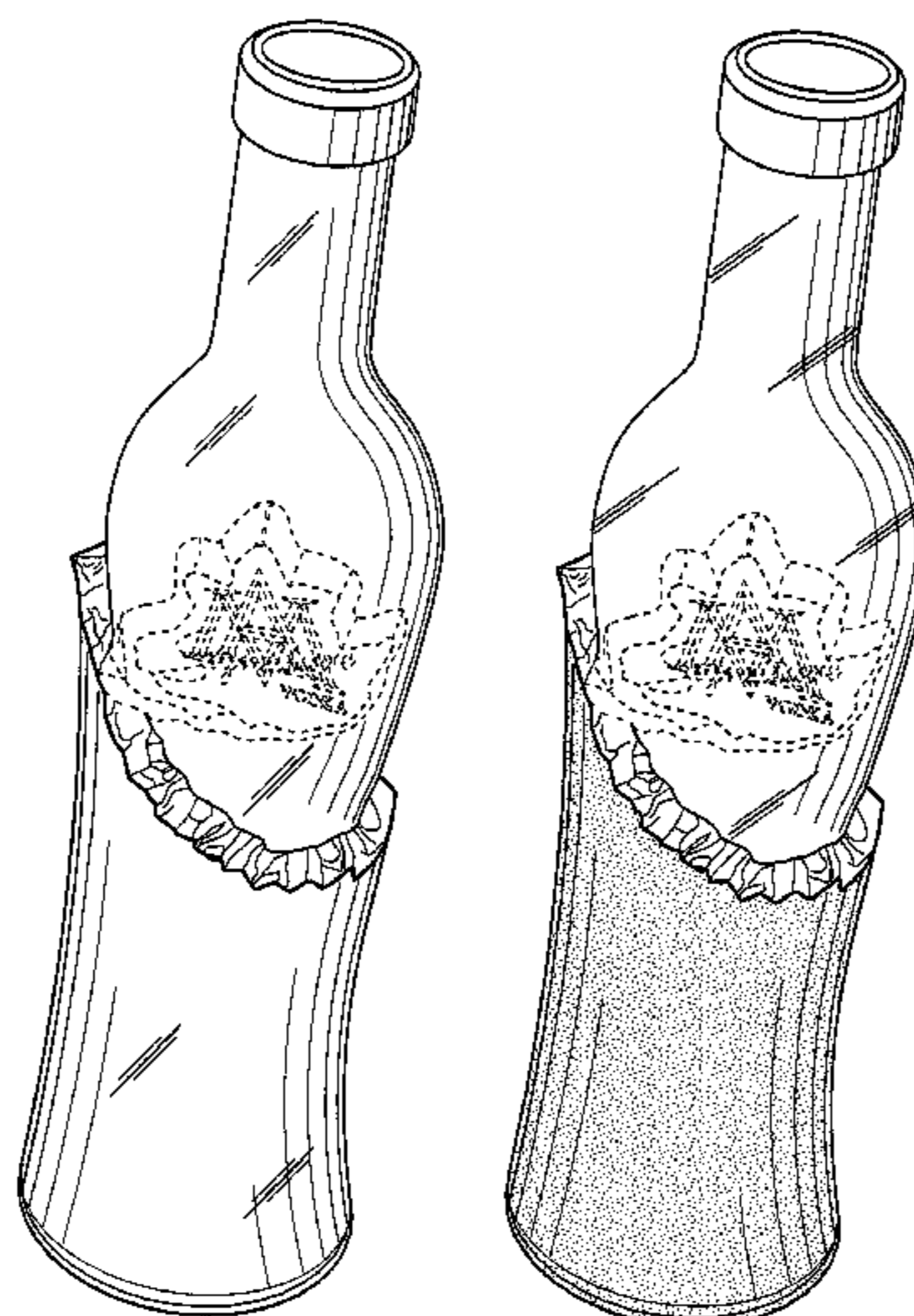
FIG. 12 is a top plan view thereof.

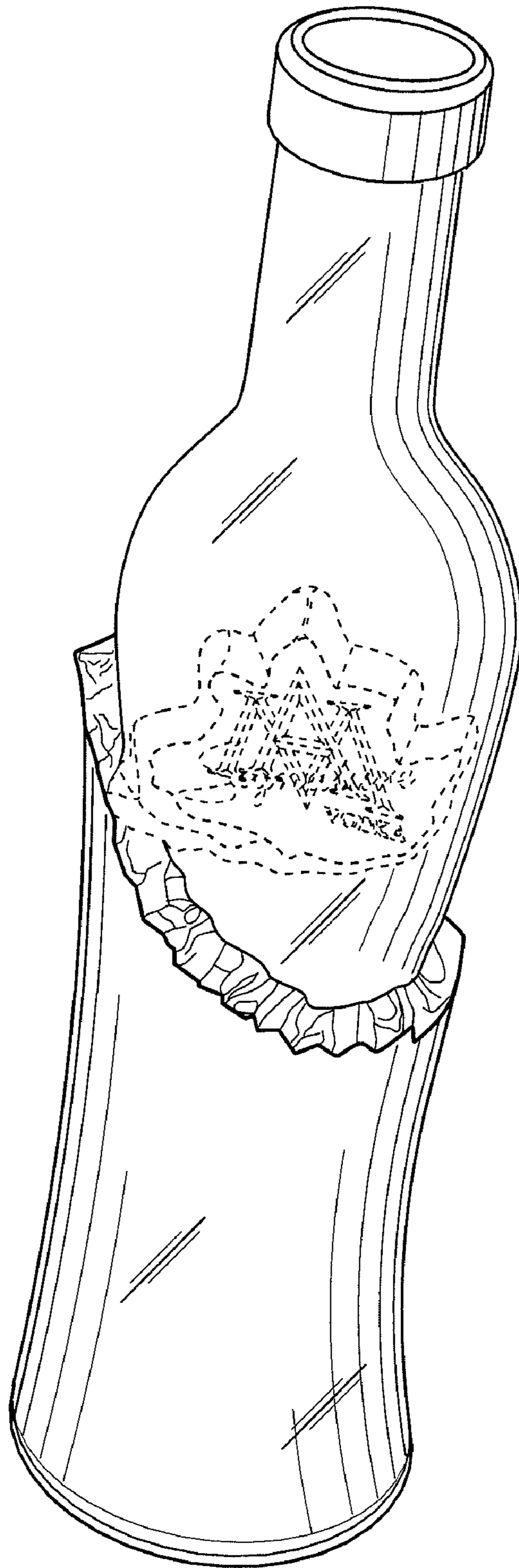

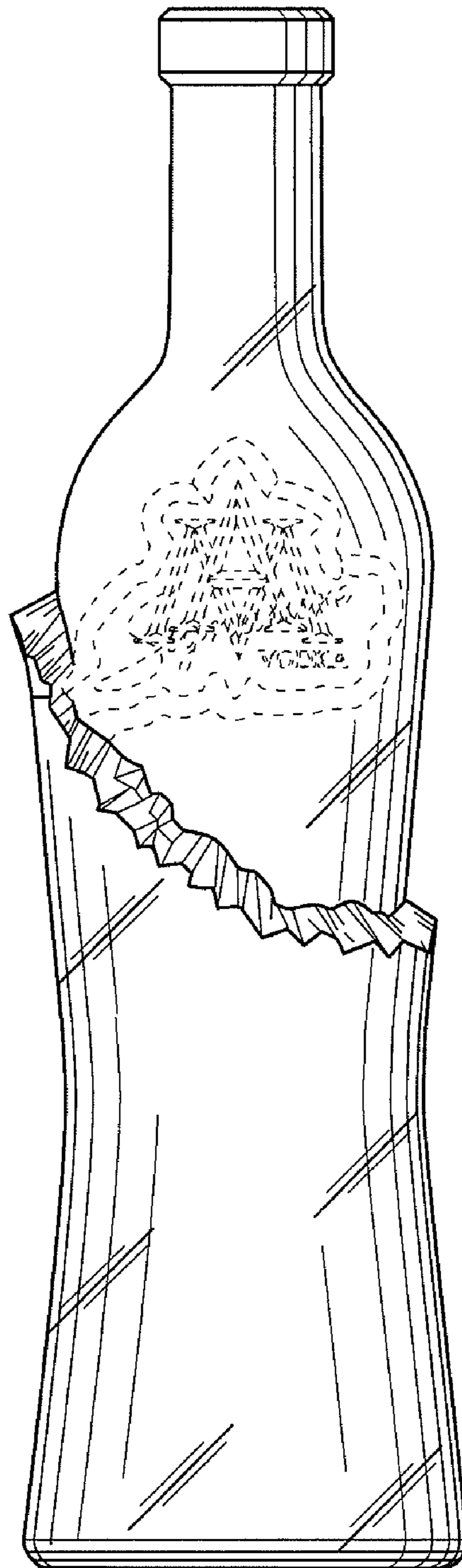

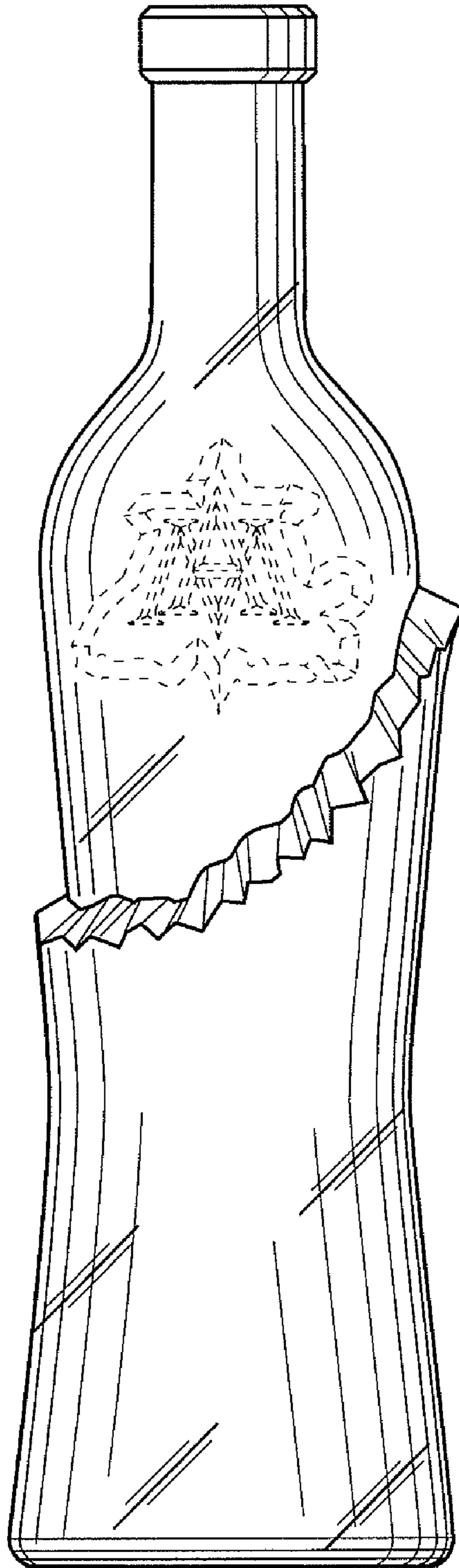

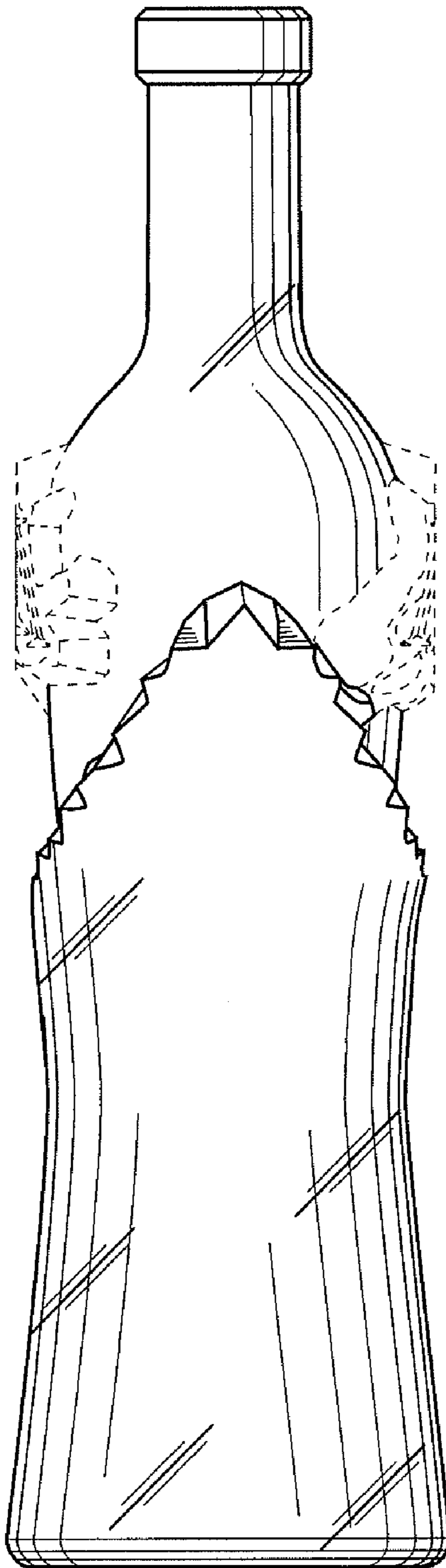

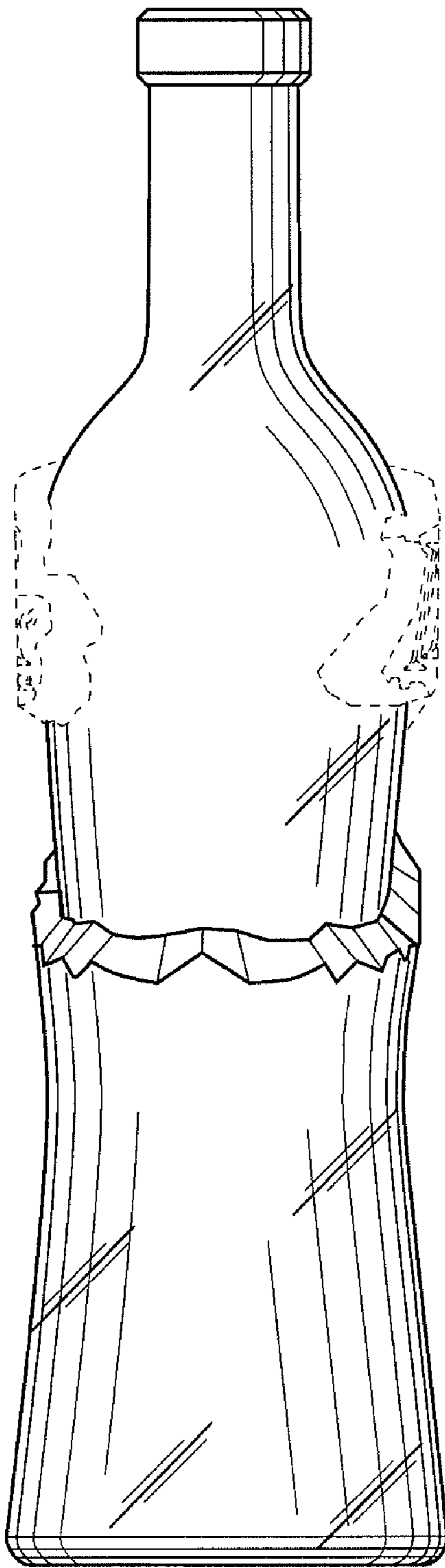

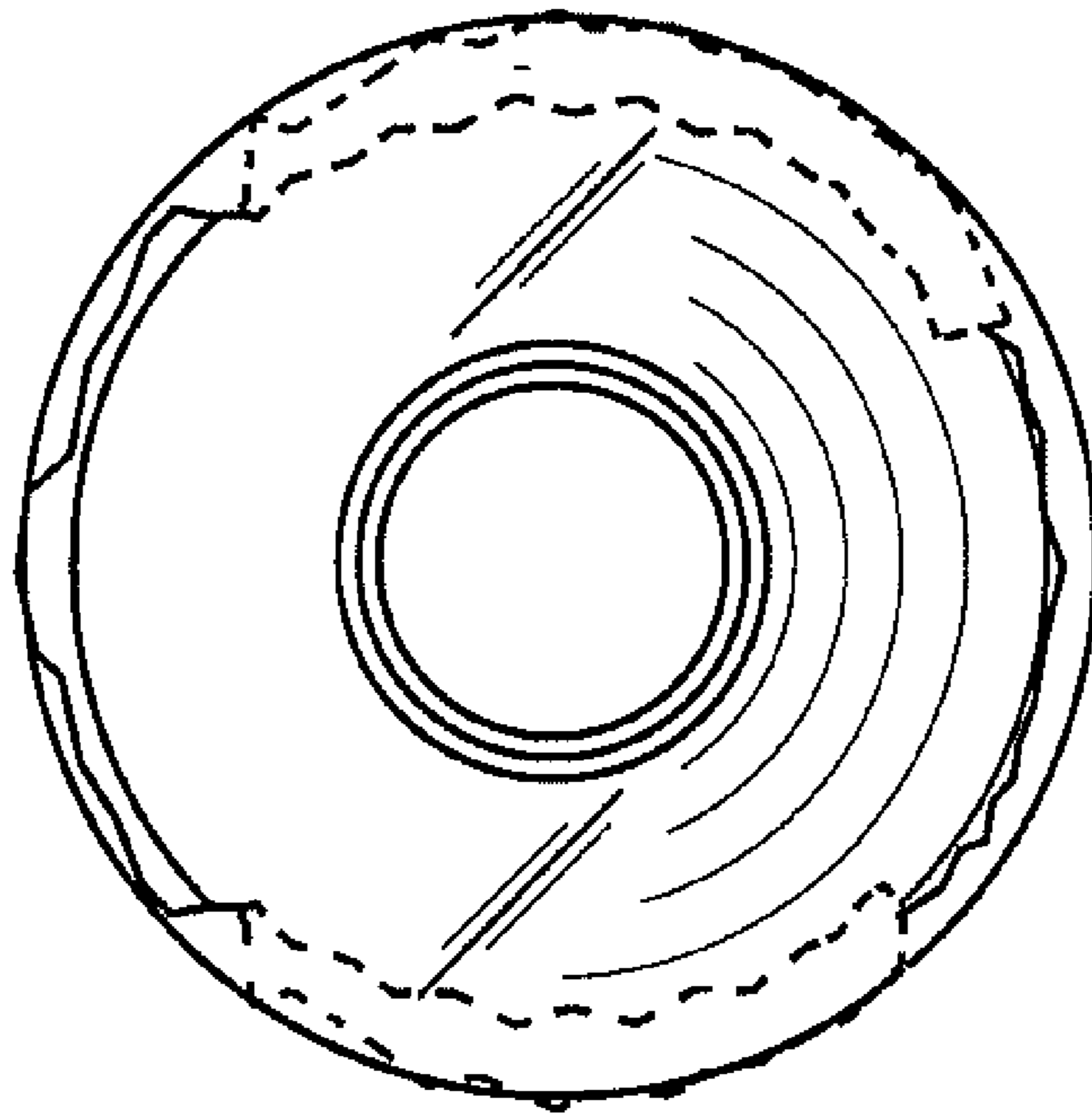

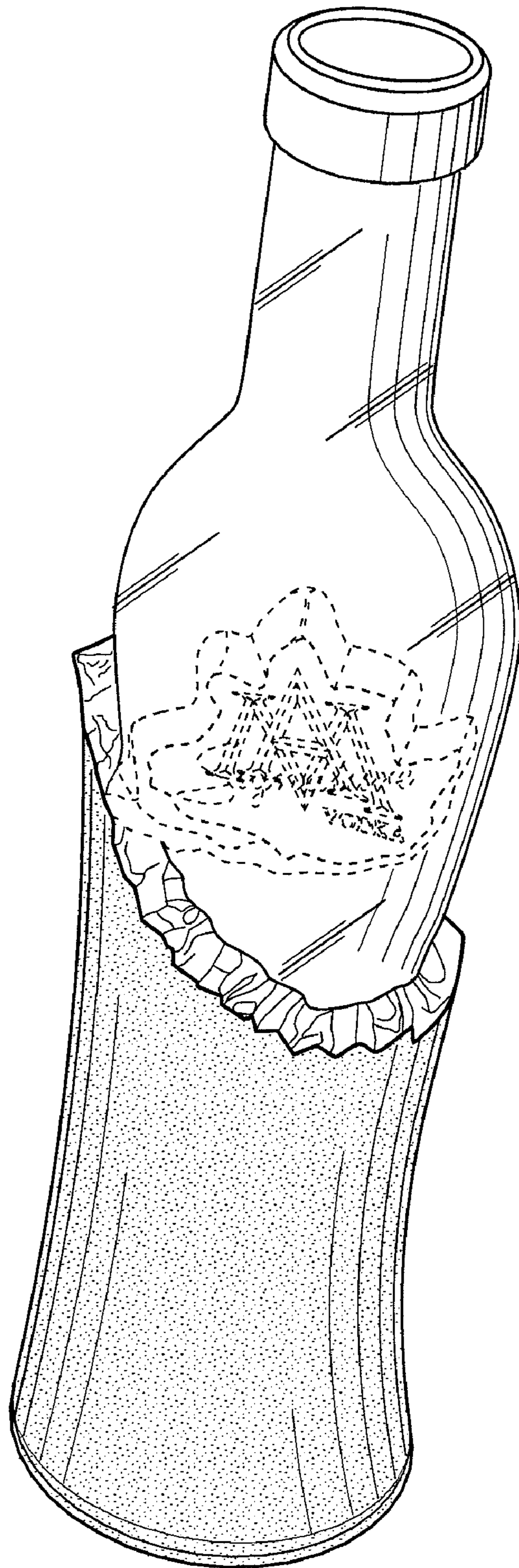

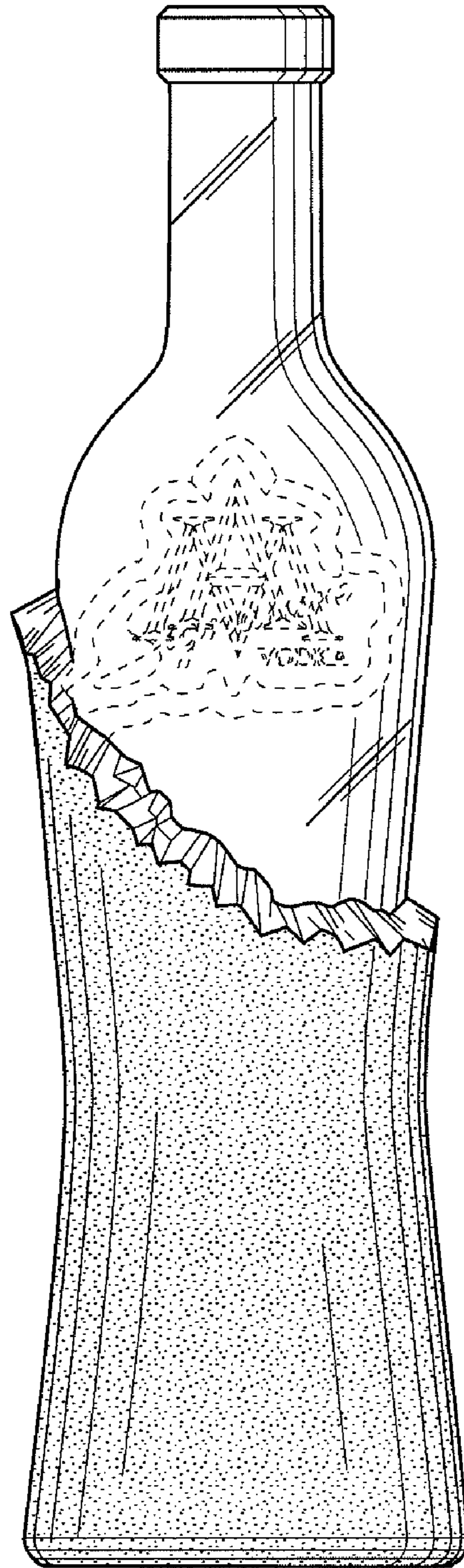

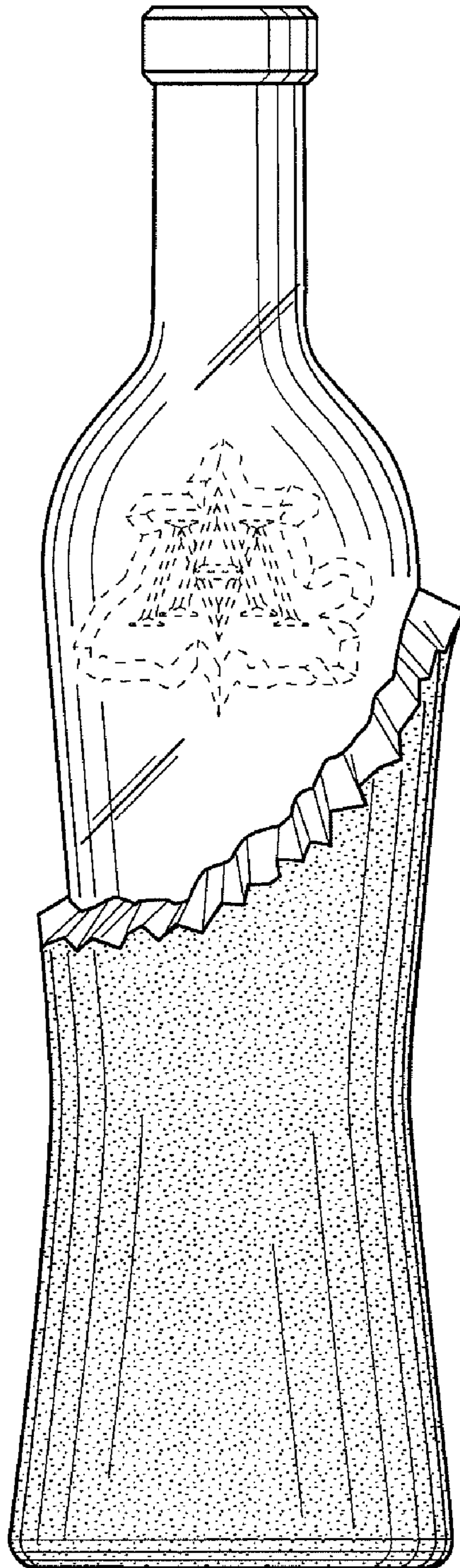

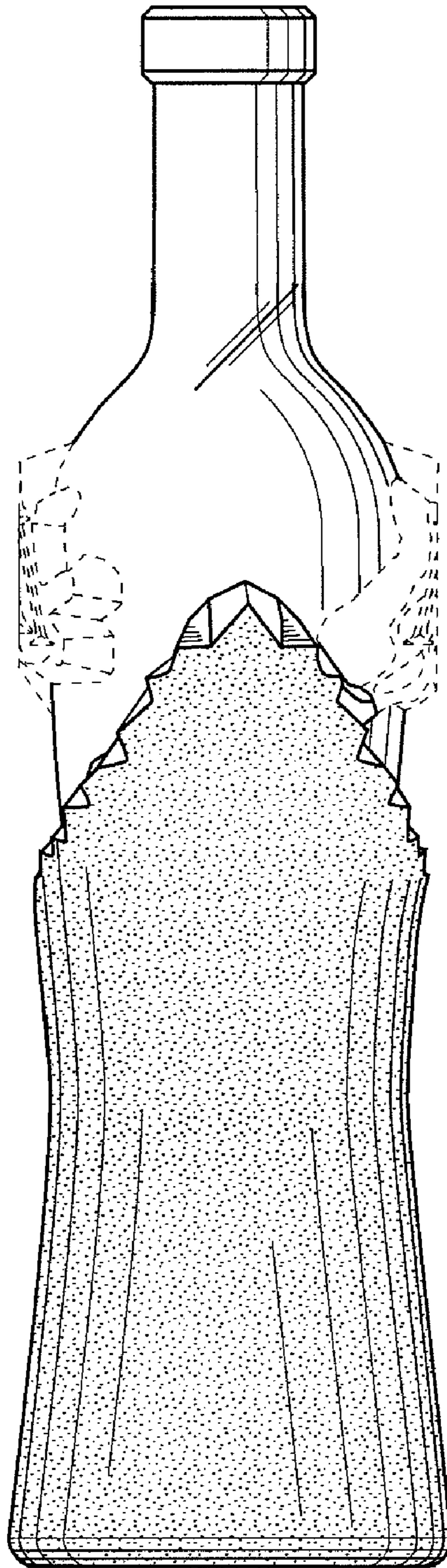

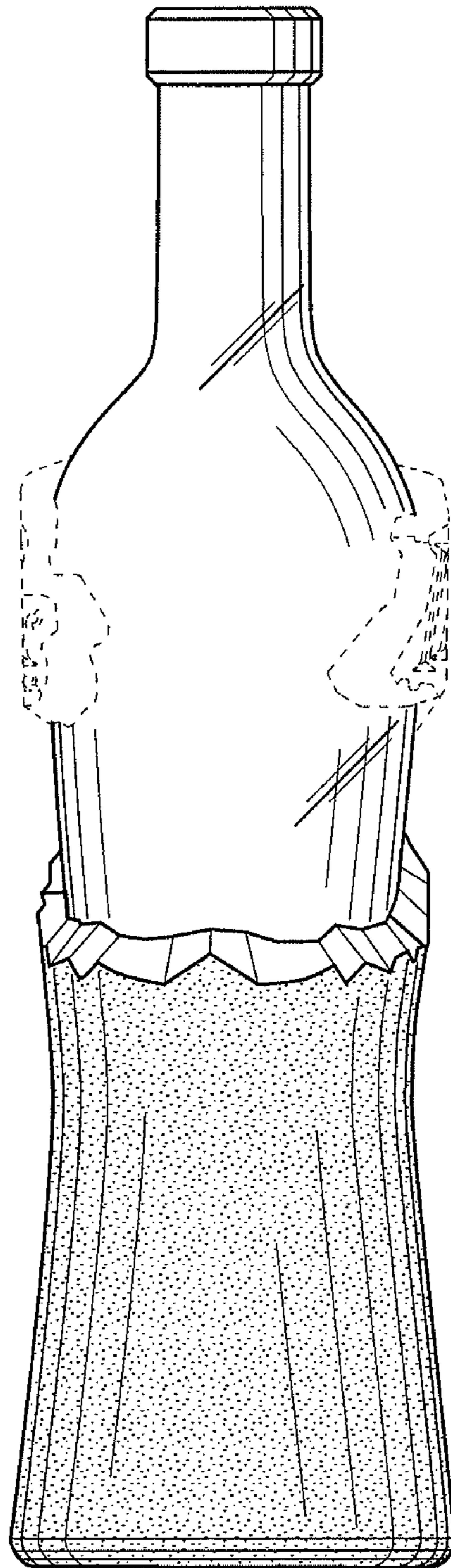

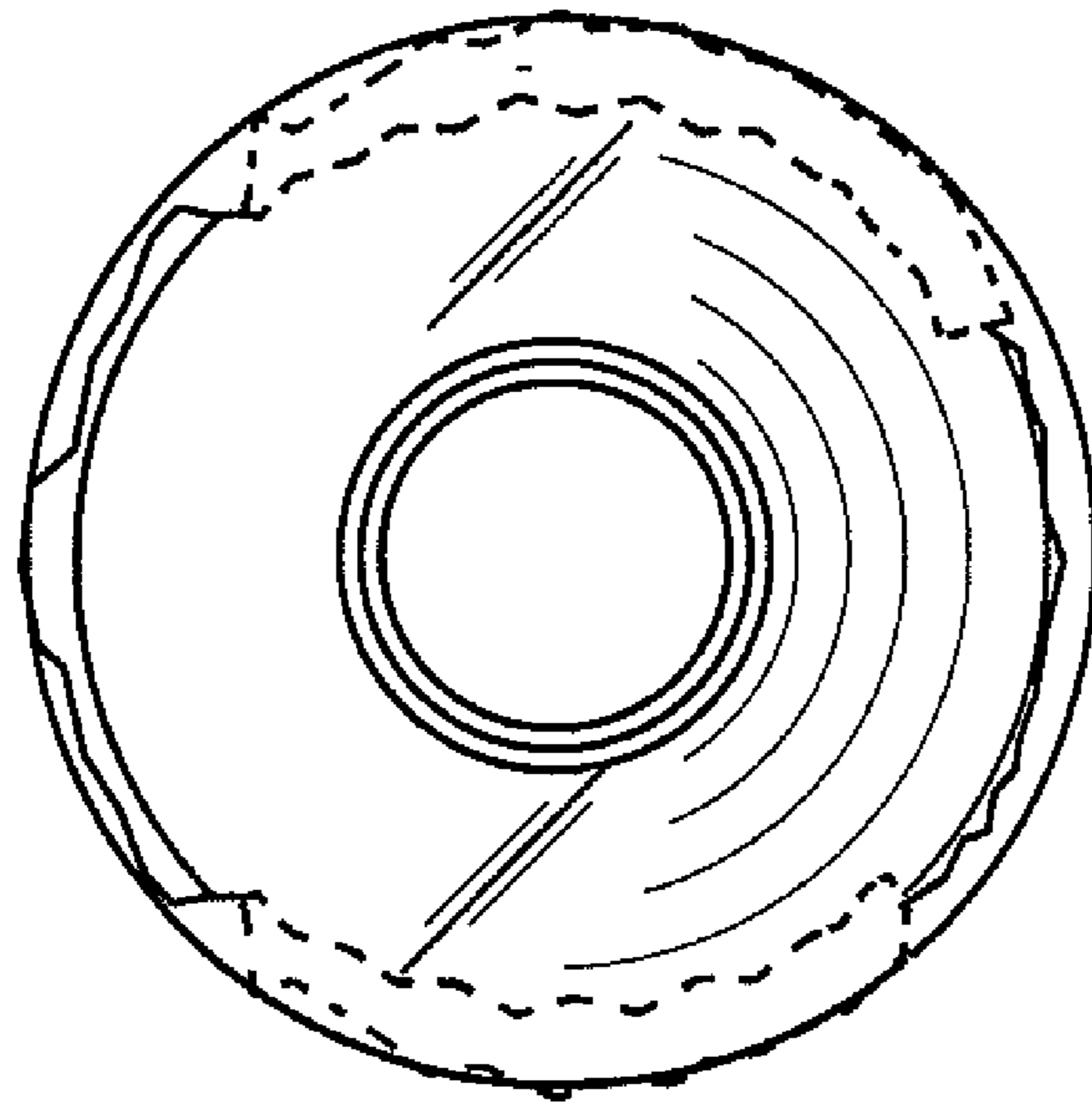
