(57) **CLAIM**

The ornamental design for the bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of the bottle showing my new design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a front and right side perspective view thereof;

FIG. 4 is a rear perspective view thereof;

FIG. 5 is a rear and left side perspective view thereof;

FIG. 6 is a right side perspective view thereof;

FIG. 7 is a left side perspective view thereof;

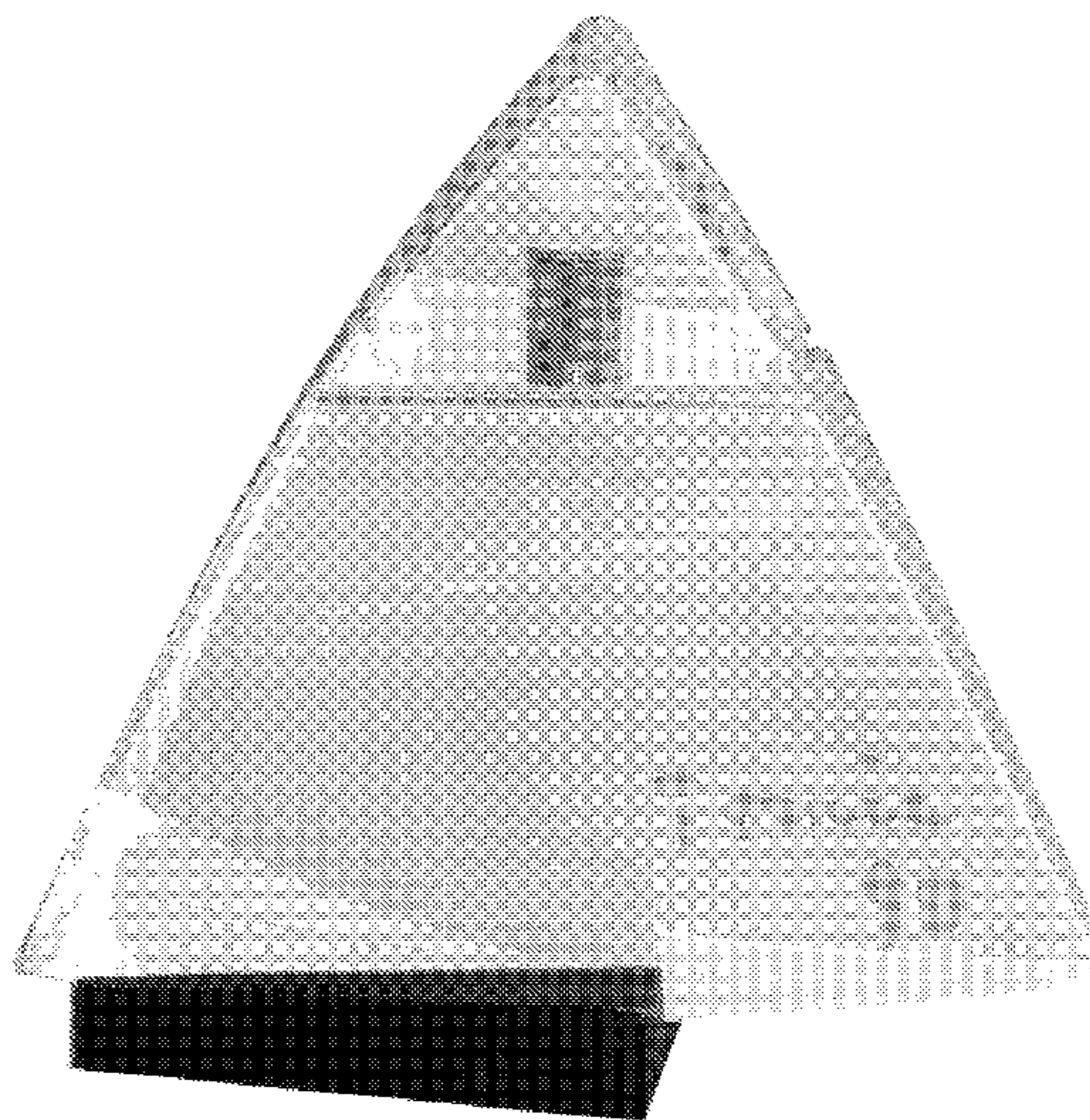
FIG. 8 is a perspective view similar to FIG. 1 but showing the cap in a reversed position;

FIG. 9 is a view of the opposite side of FIG. 8;

FIG. 10 is a rear and right side perspective view showing the cap in a twisted position; and,

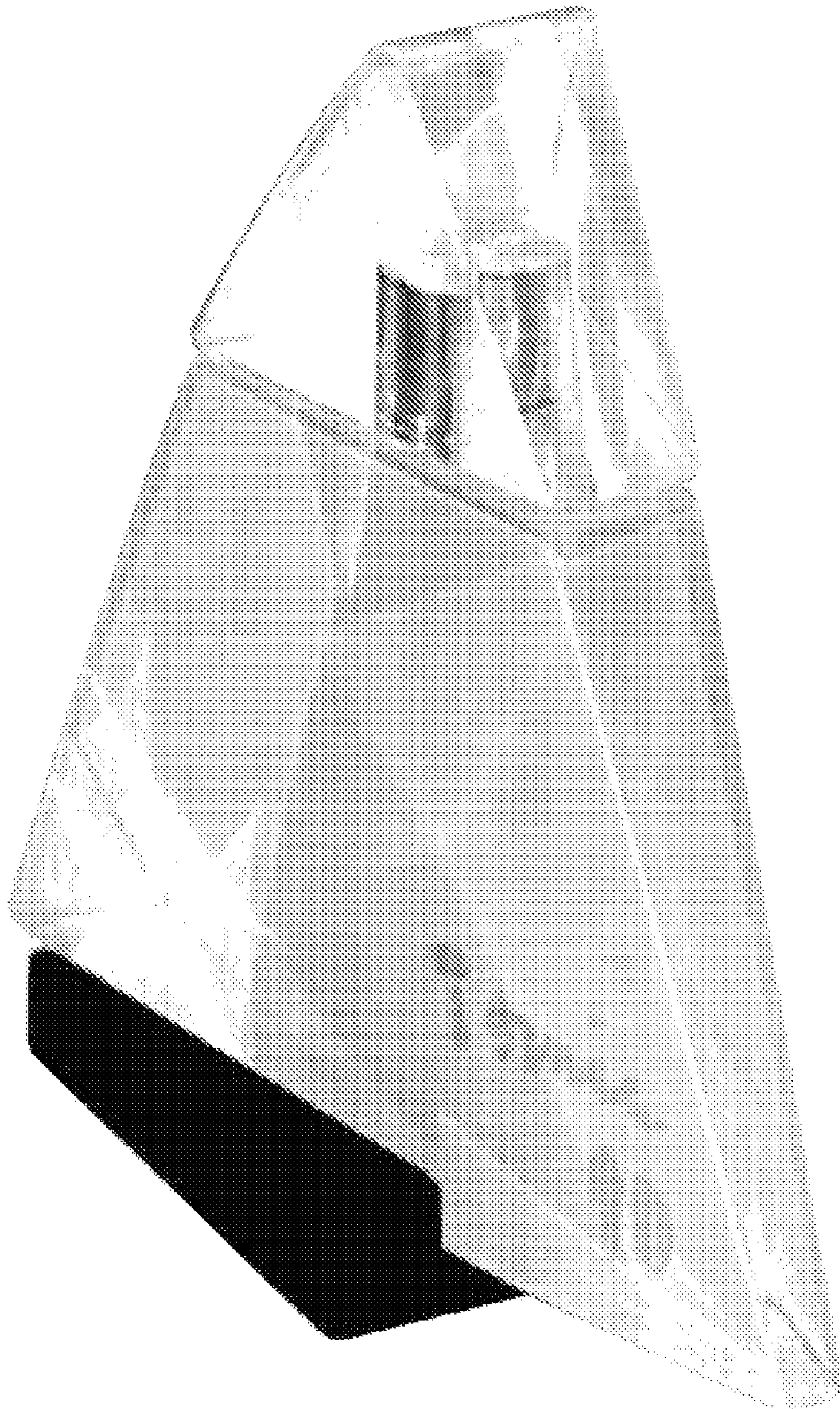

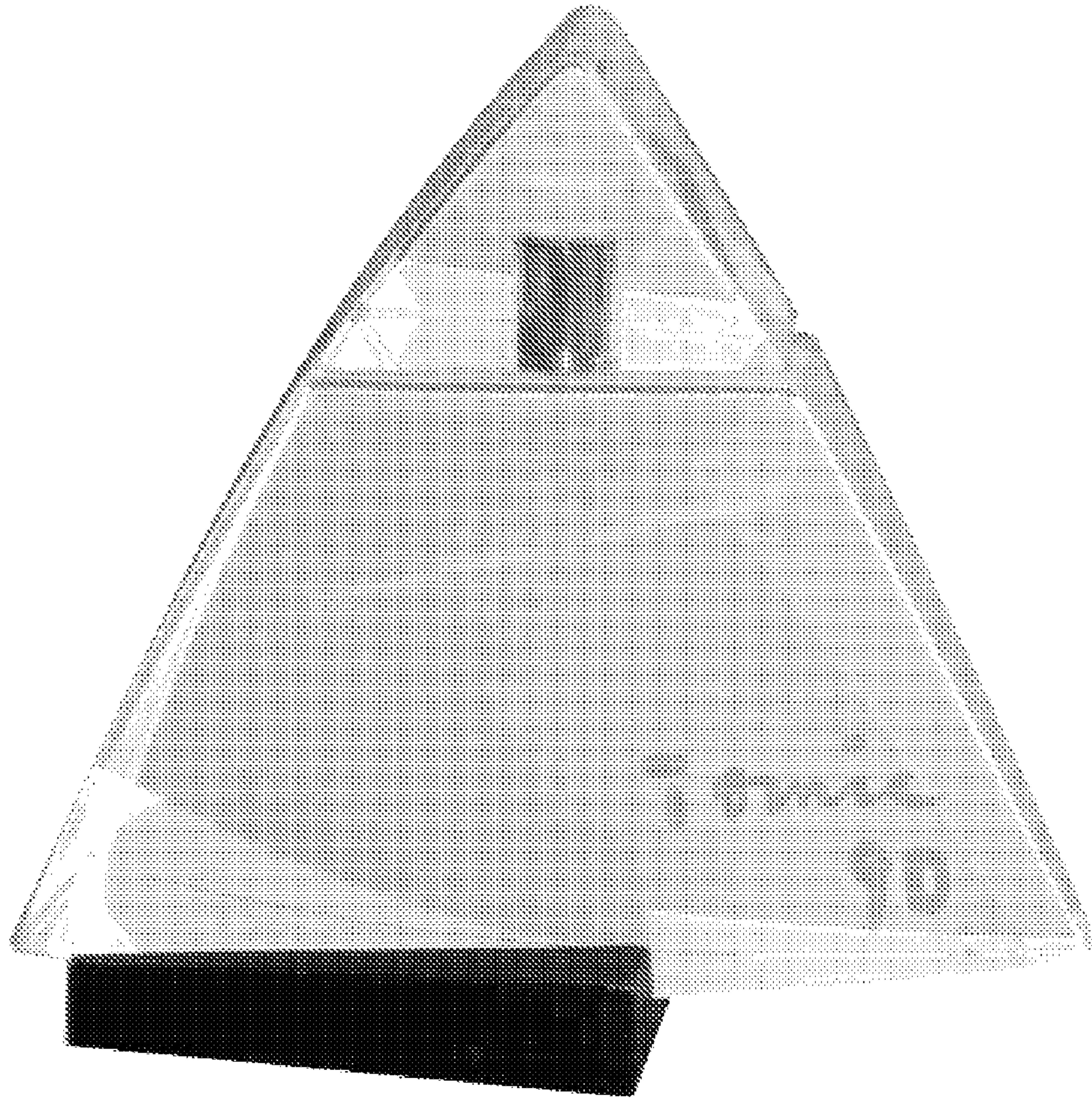

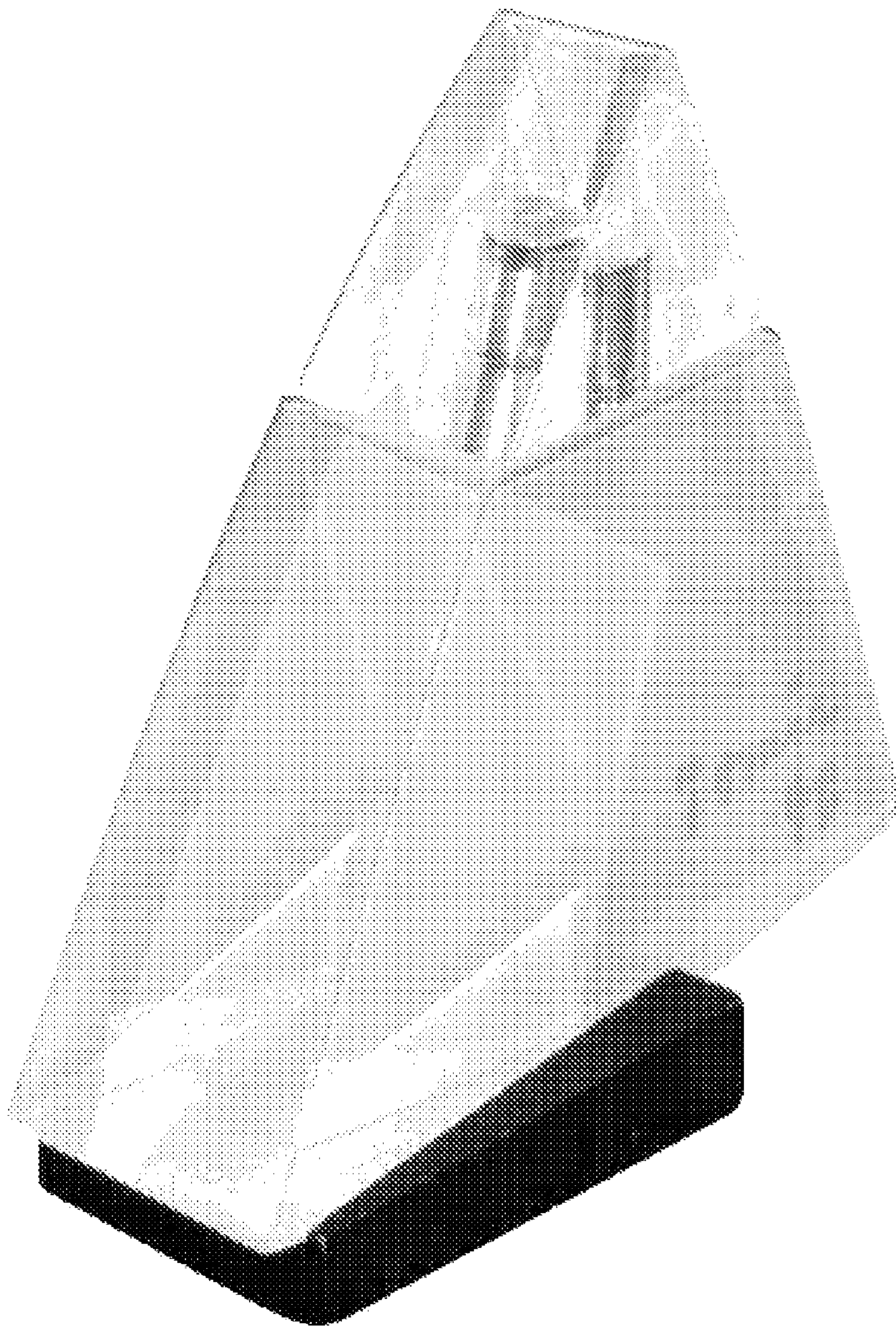

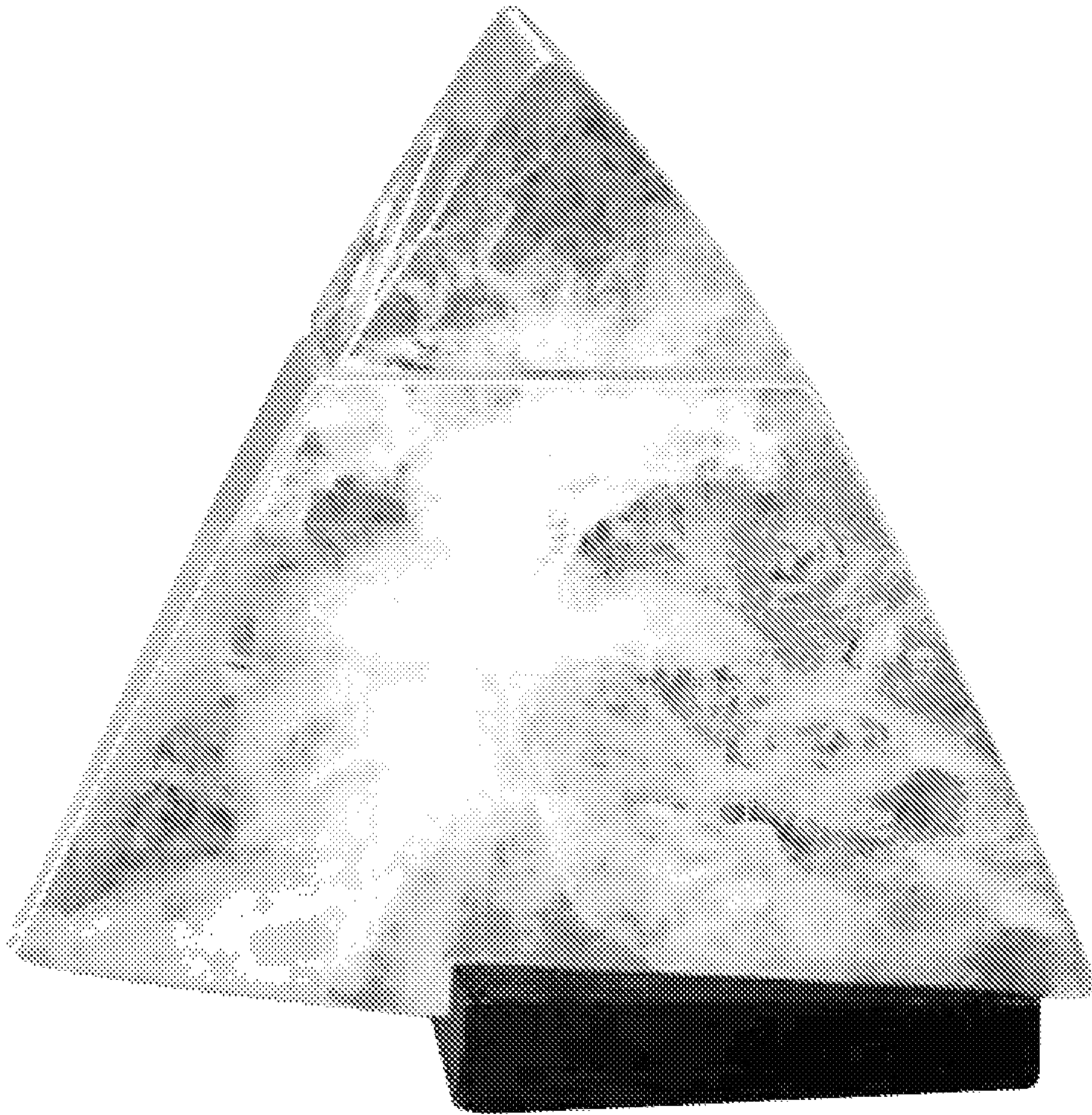

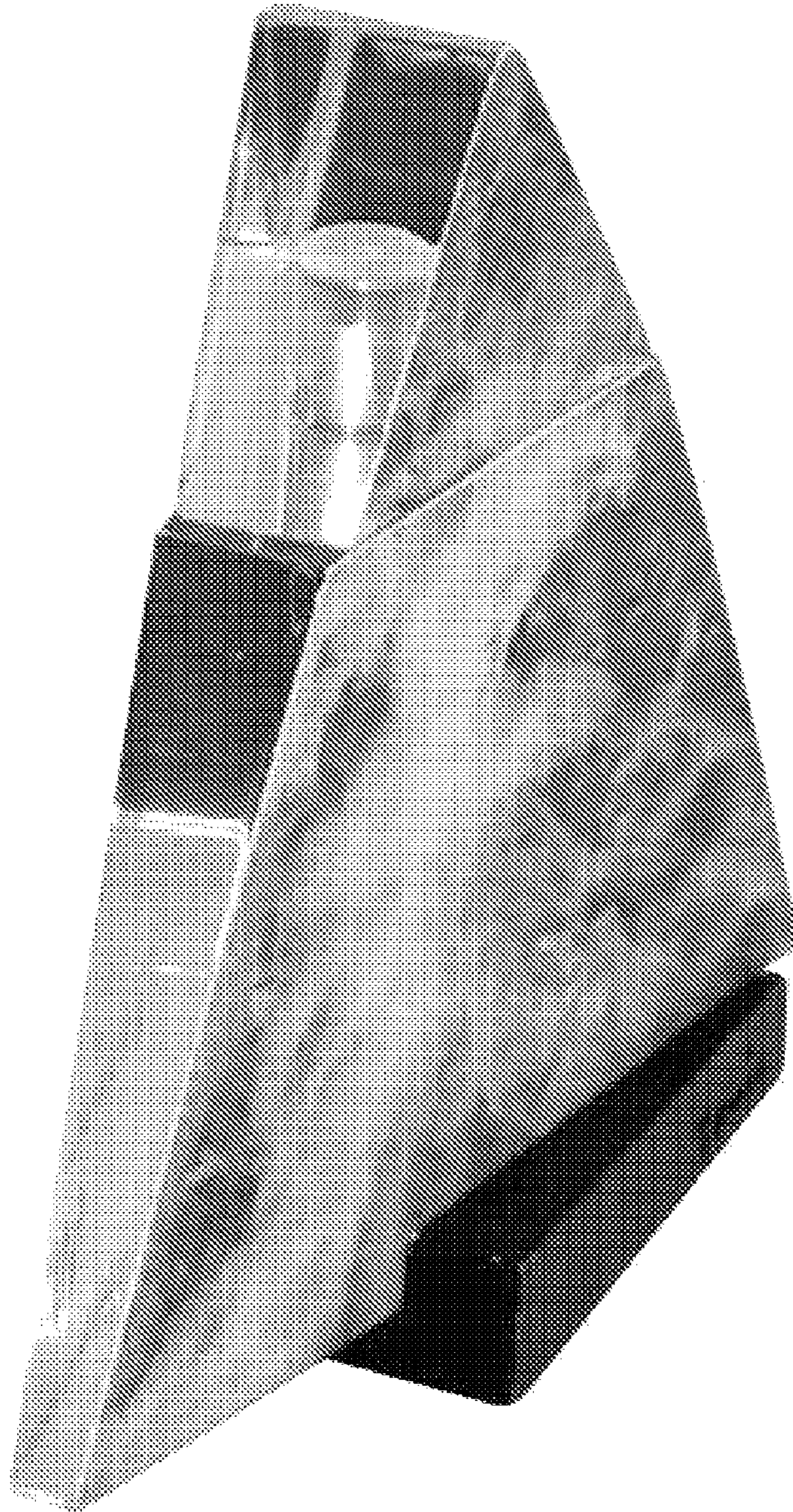

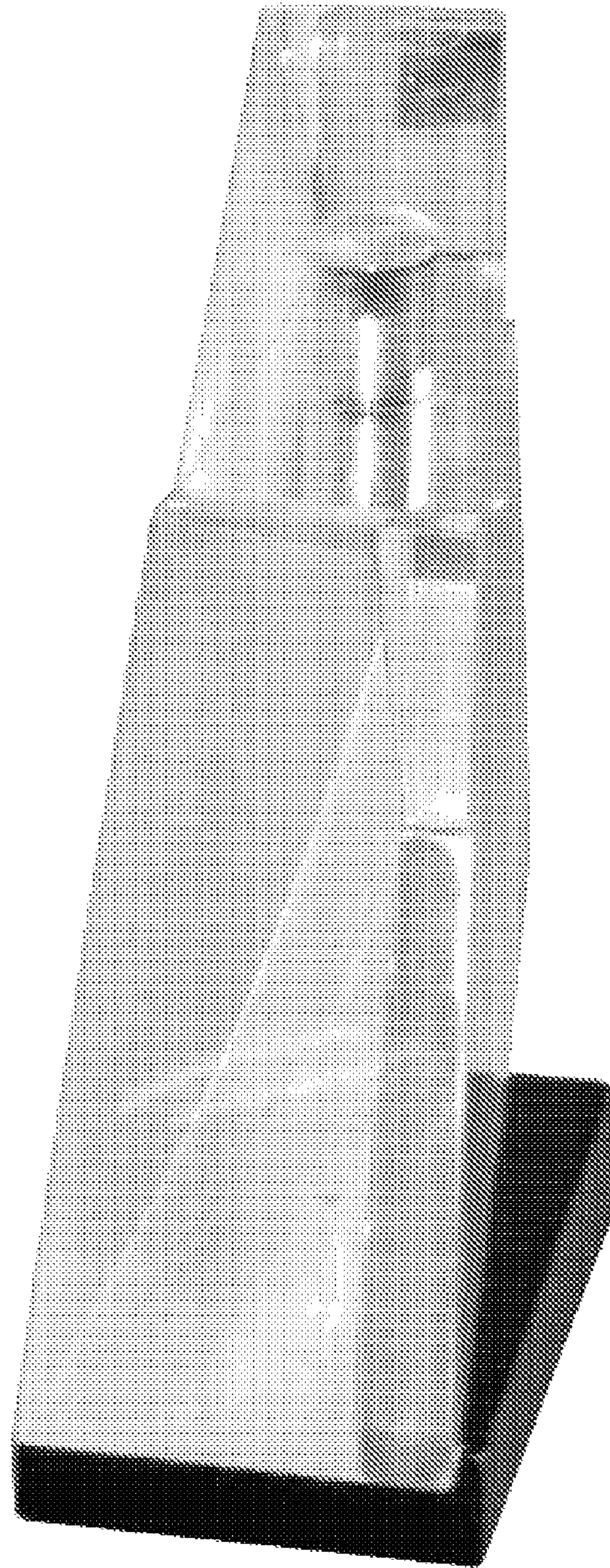

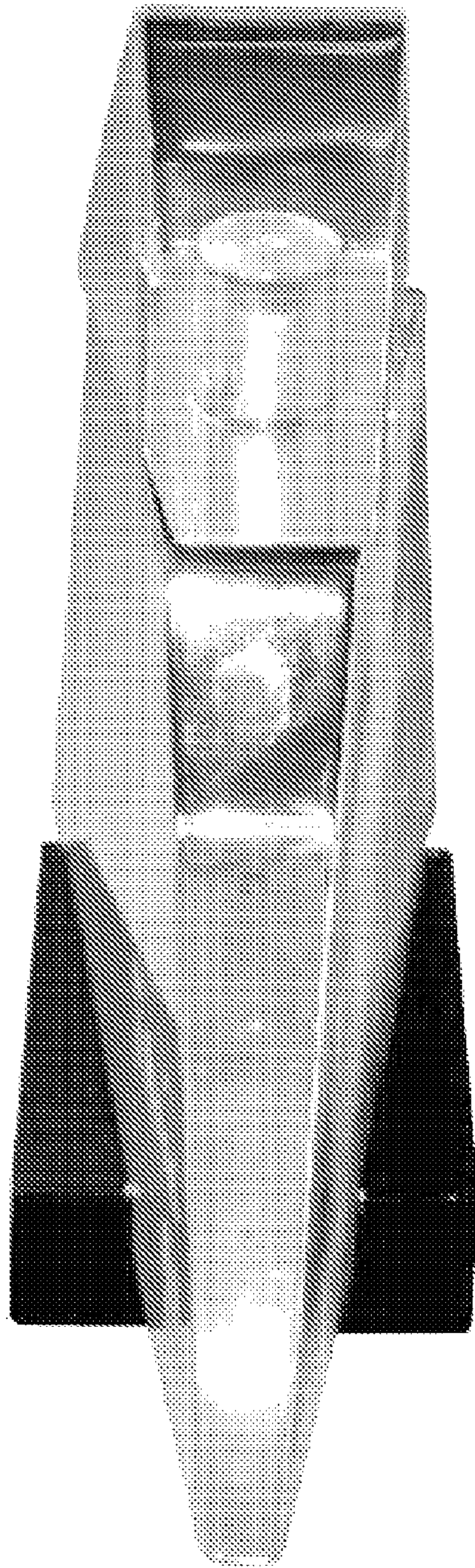

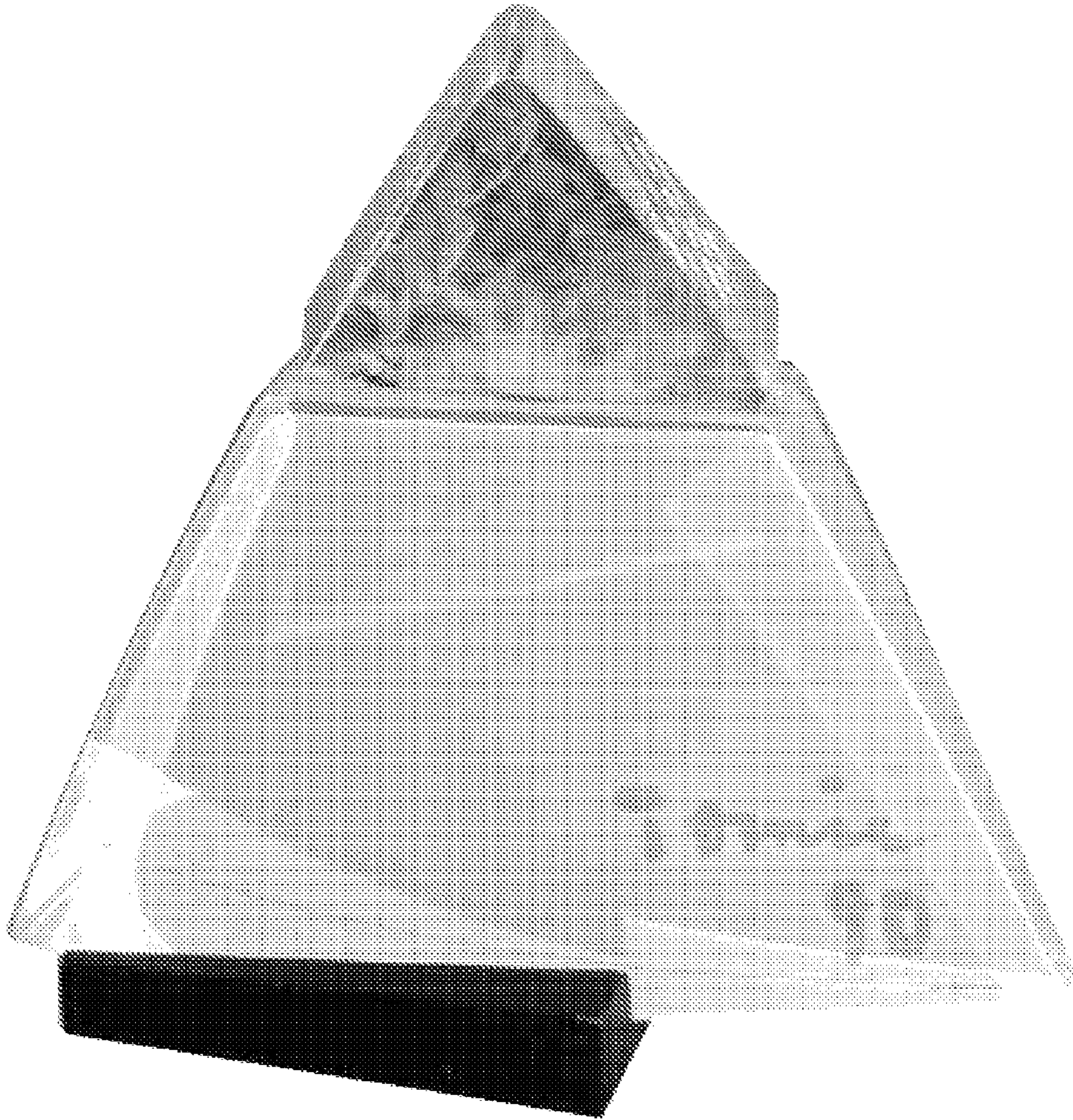

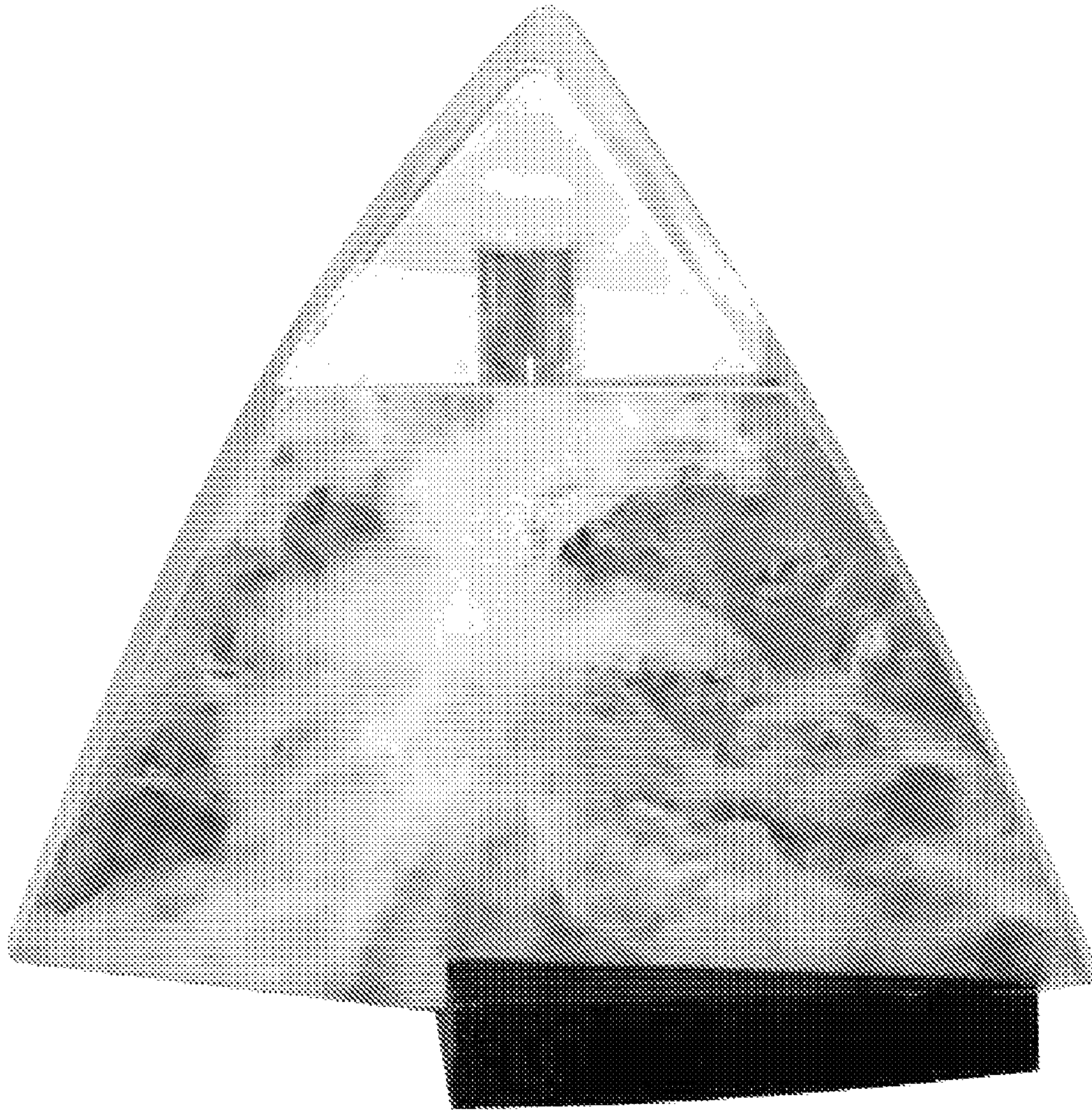

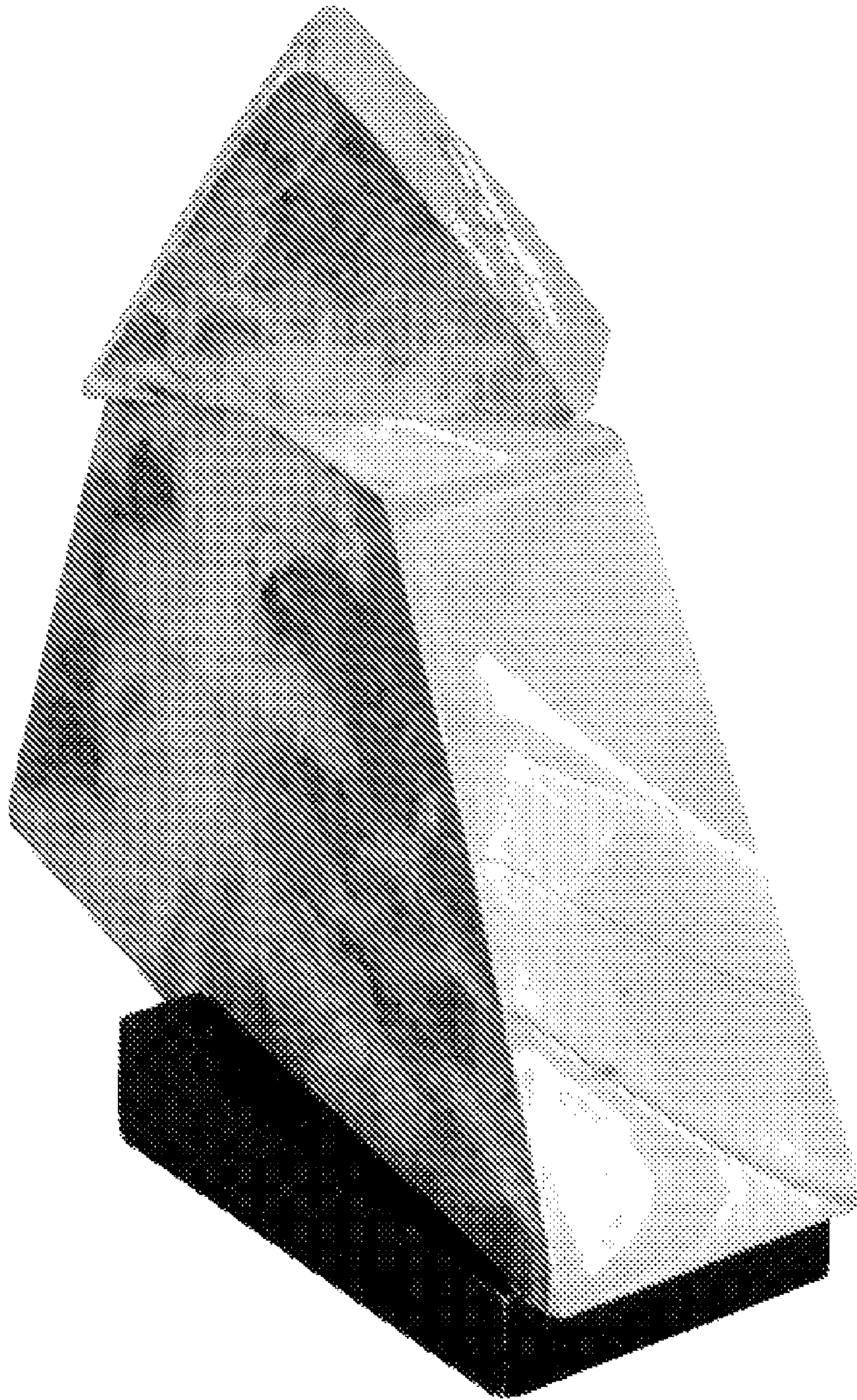

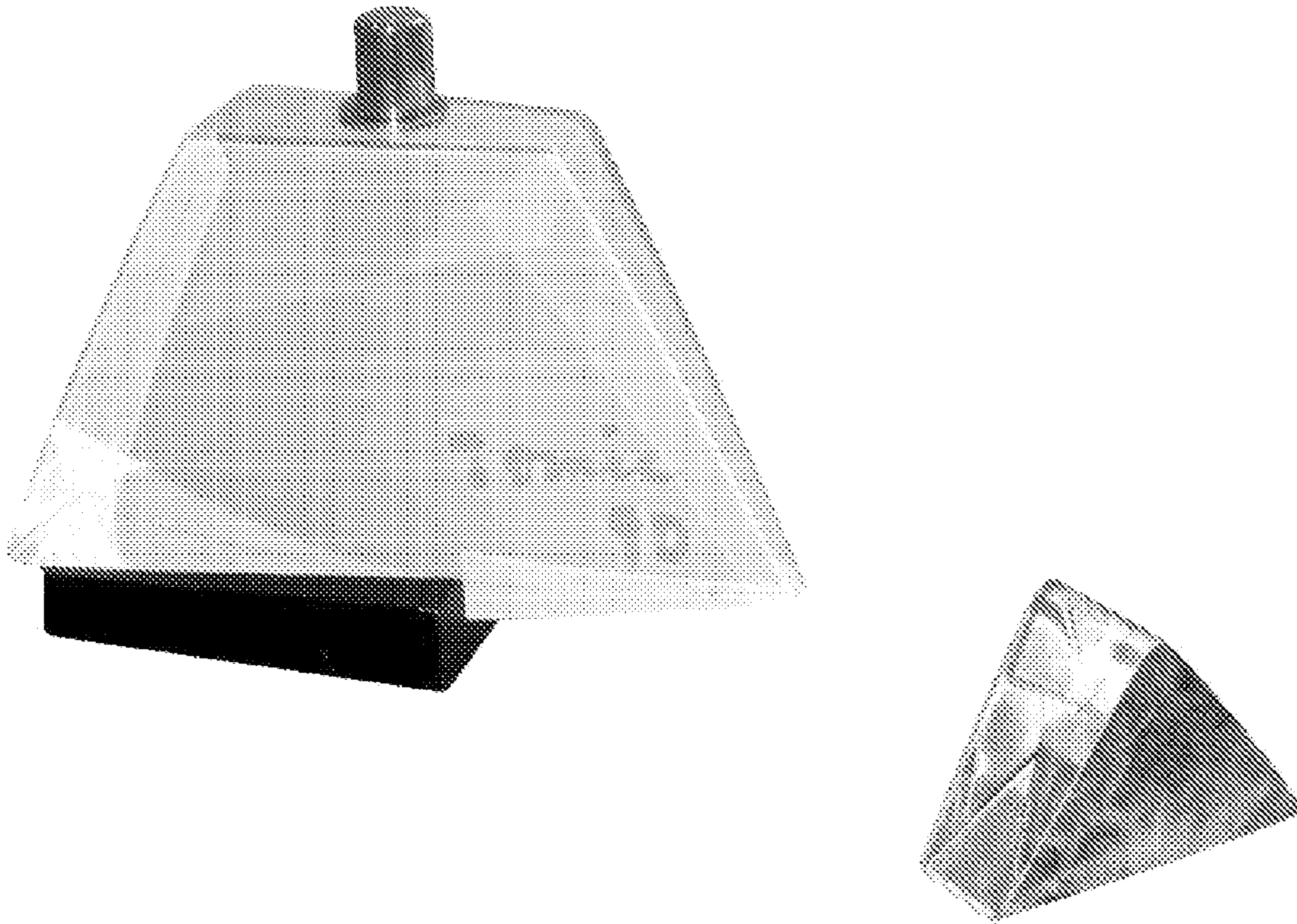
