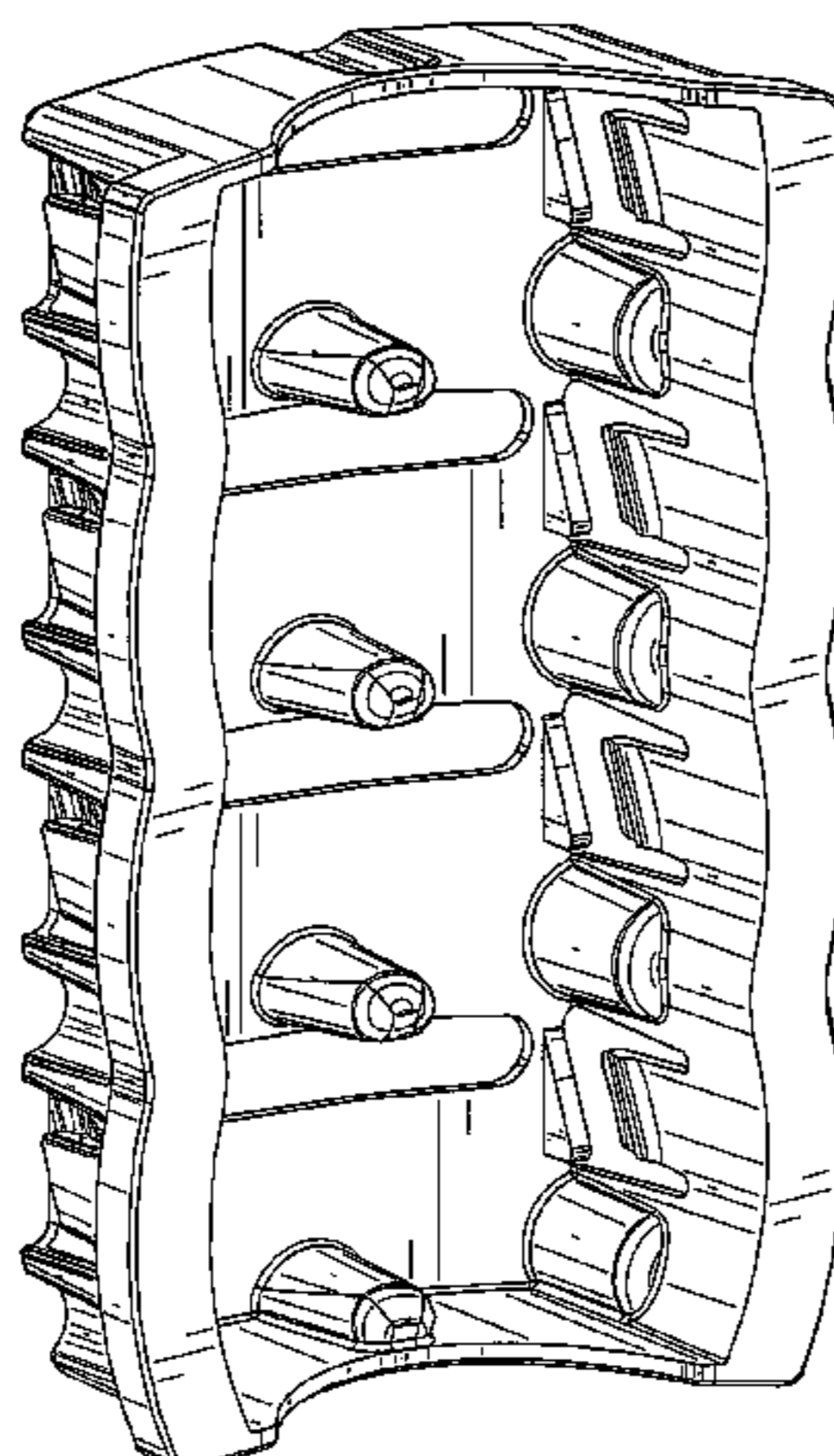
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the razor dispenser, showing the new design;

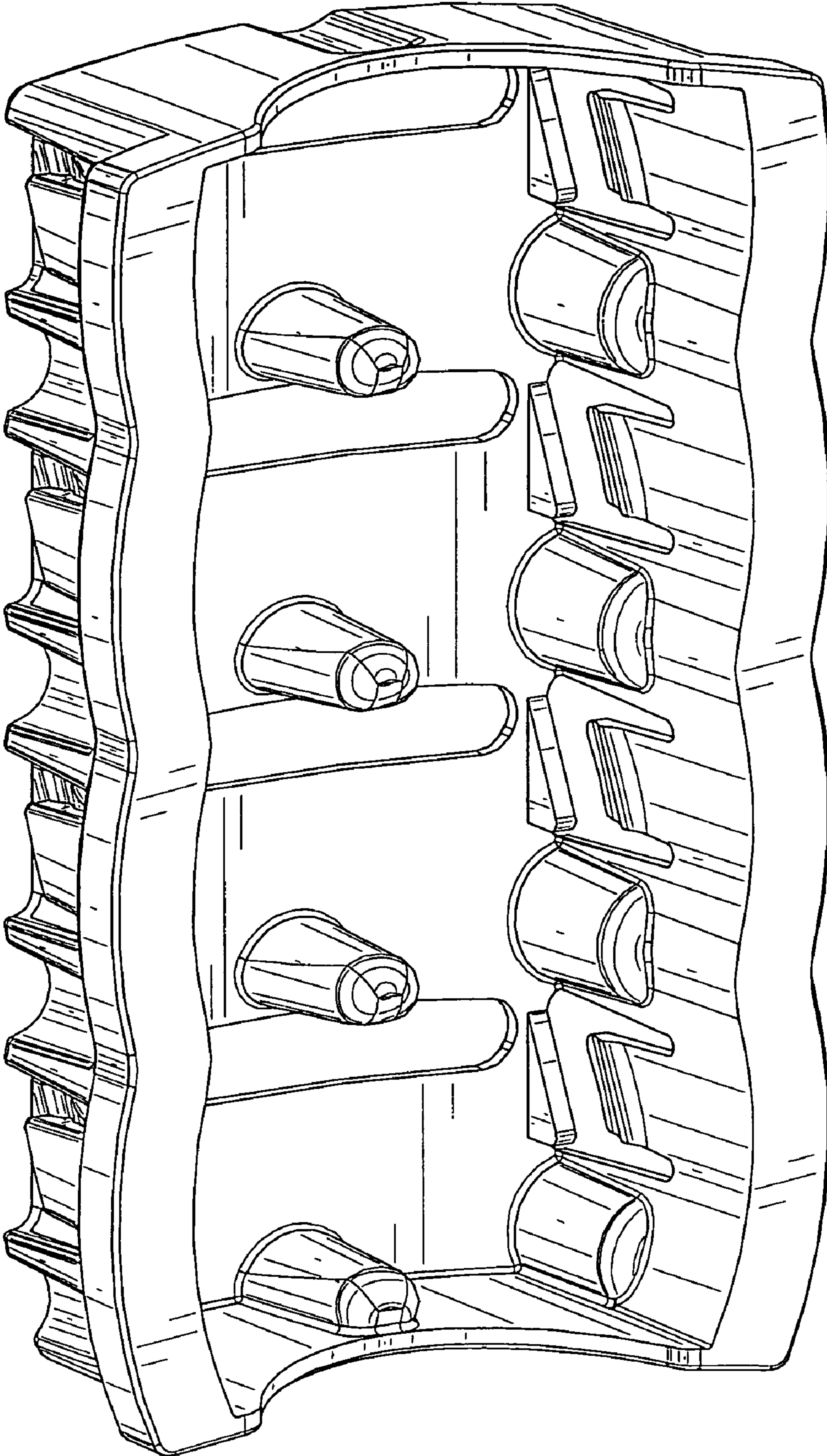

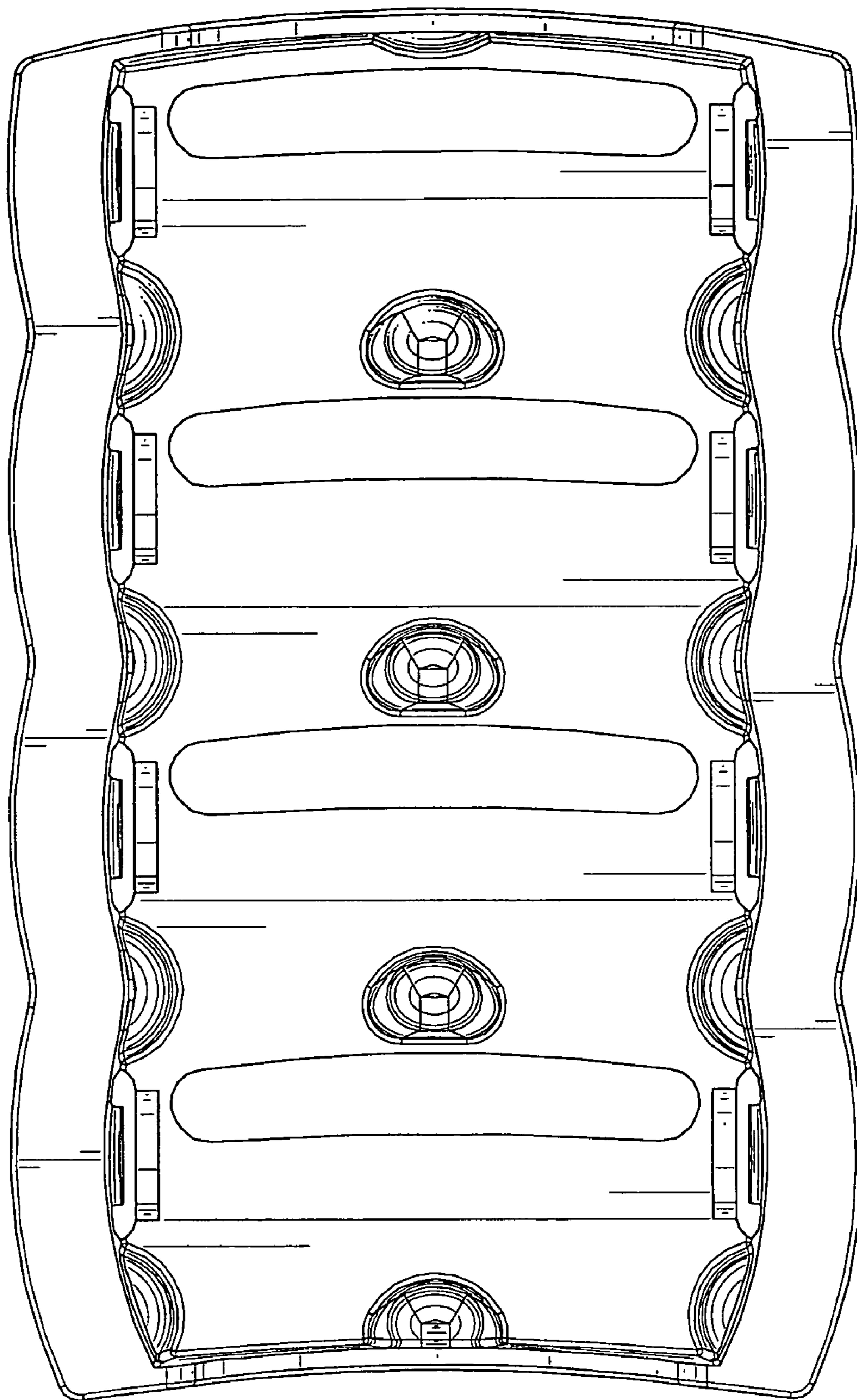

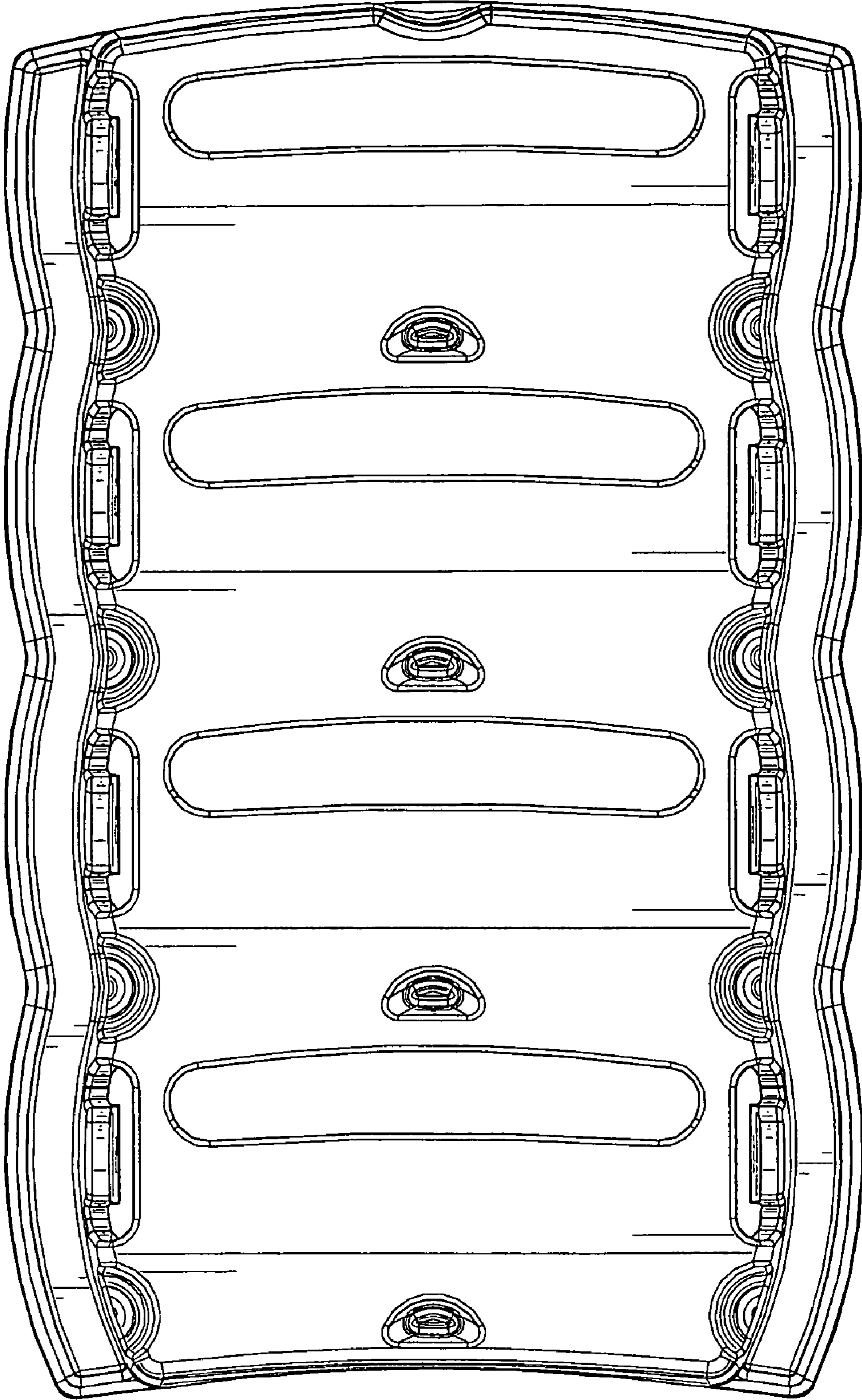

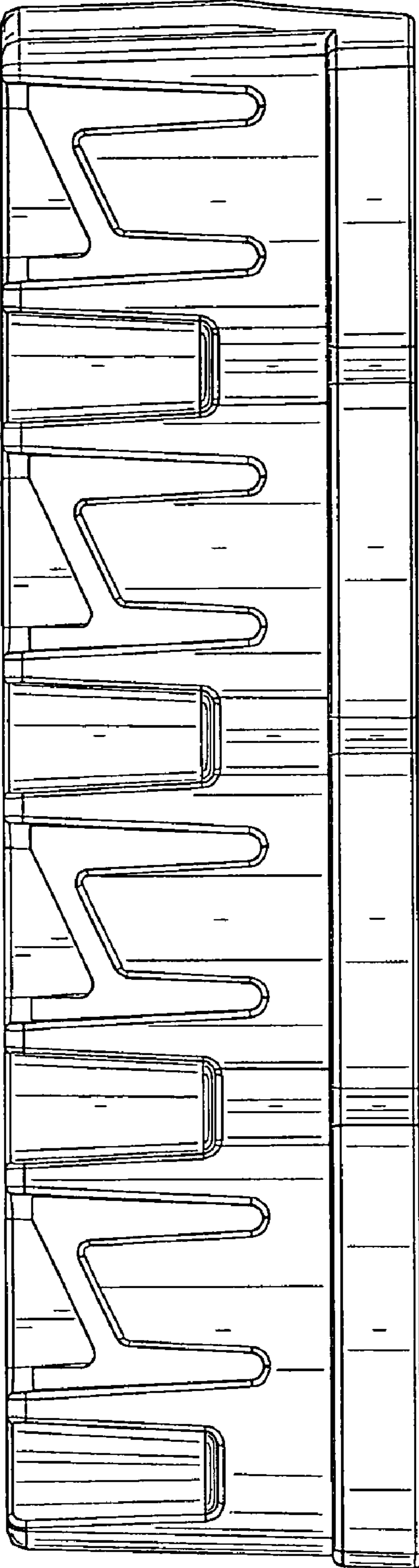

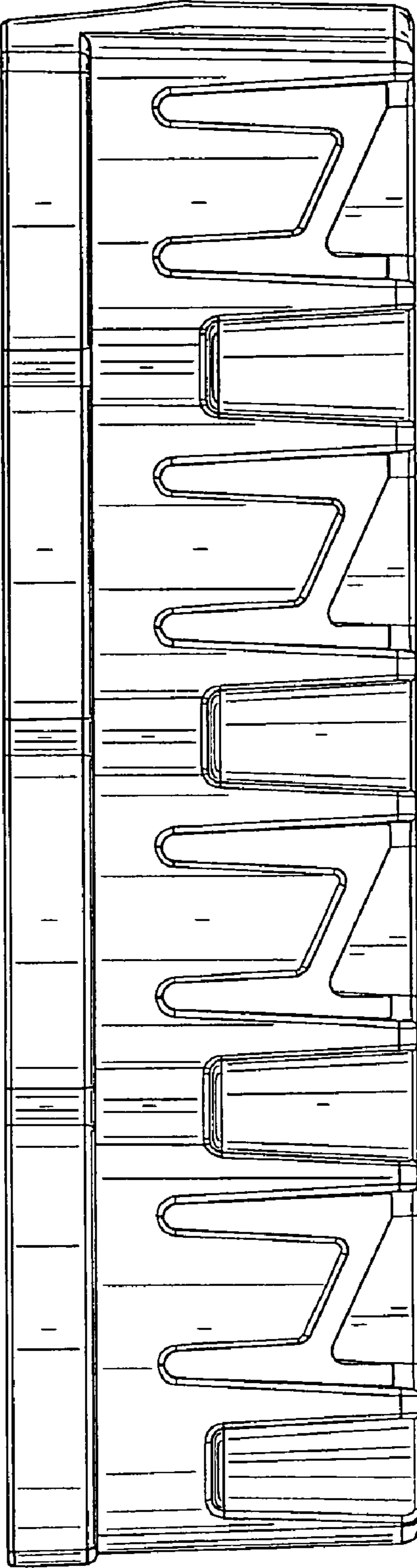

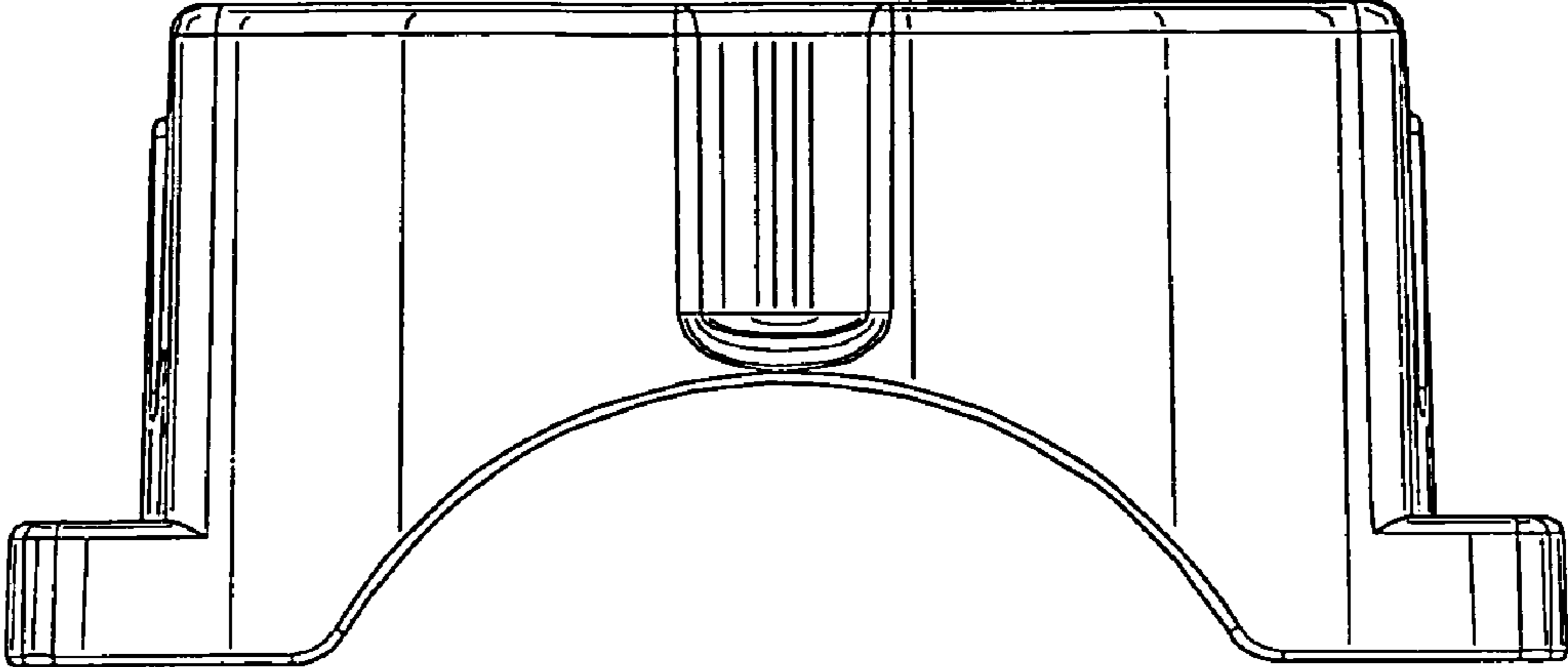

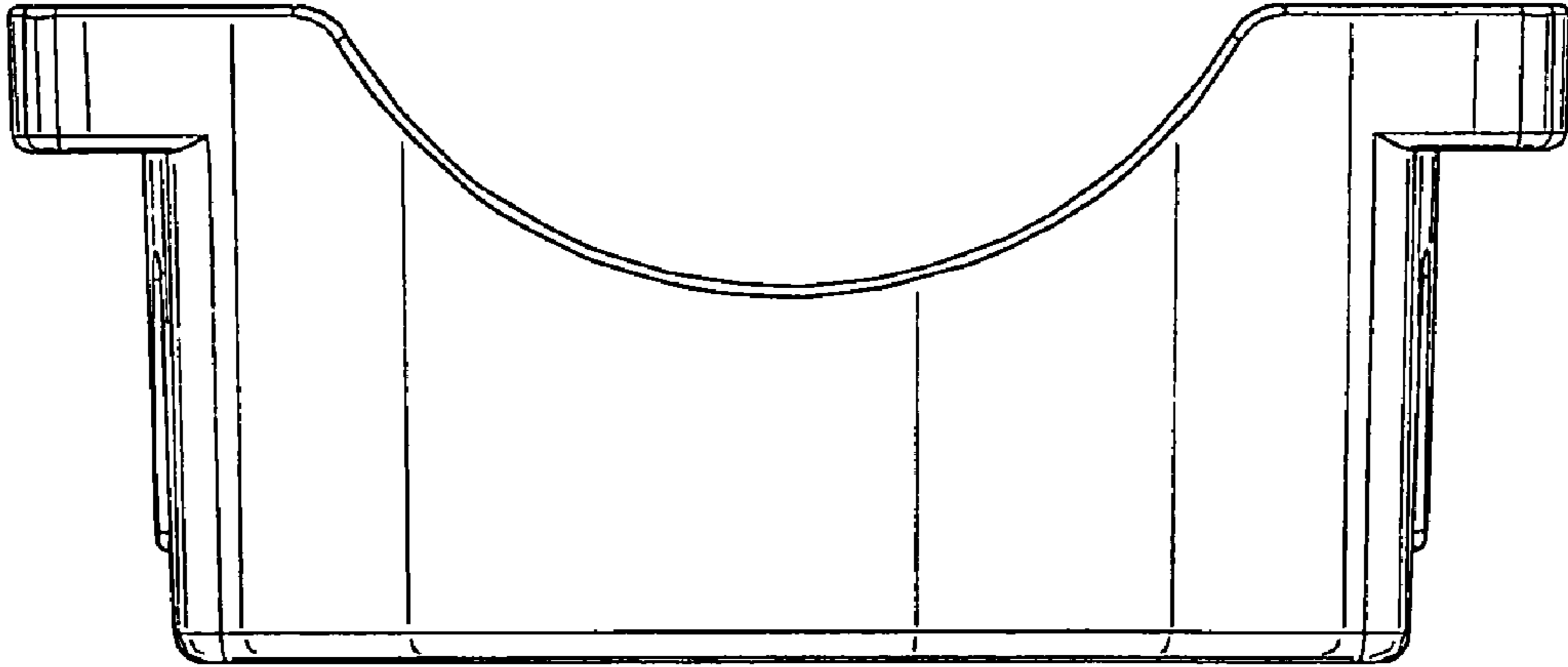
