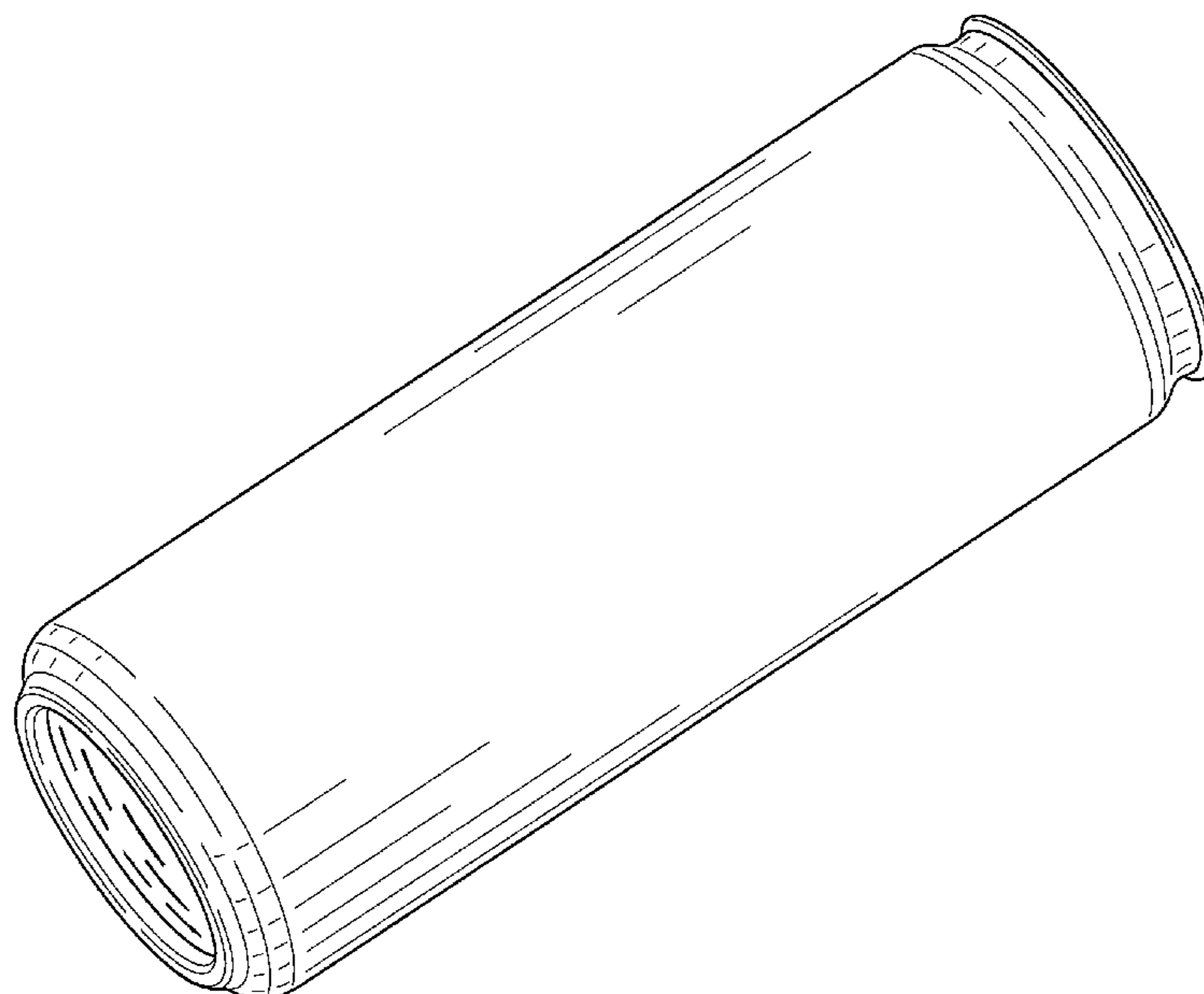
We claim the ornamental design for a container body, as shown and described.

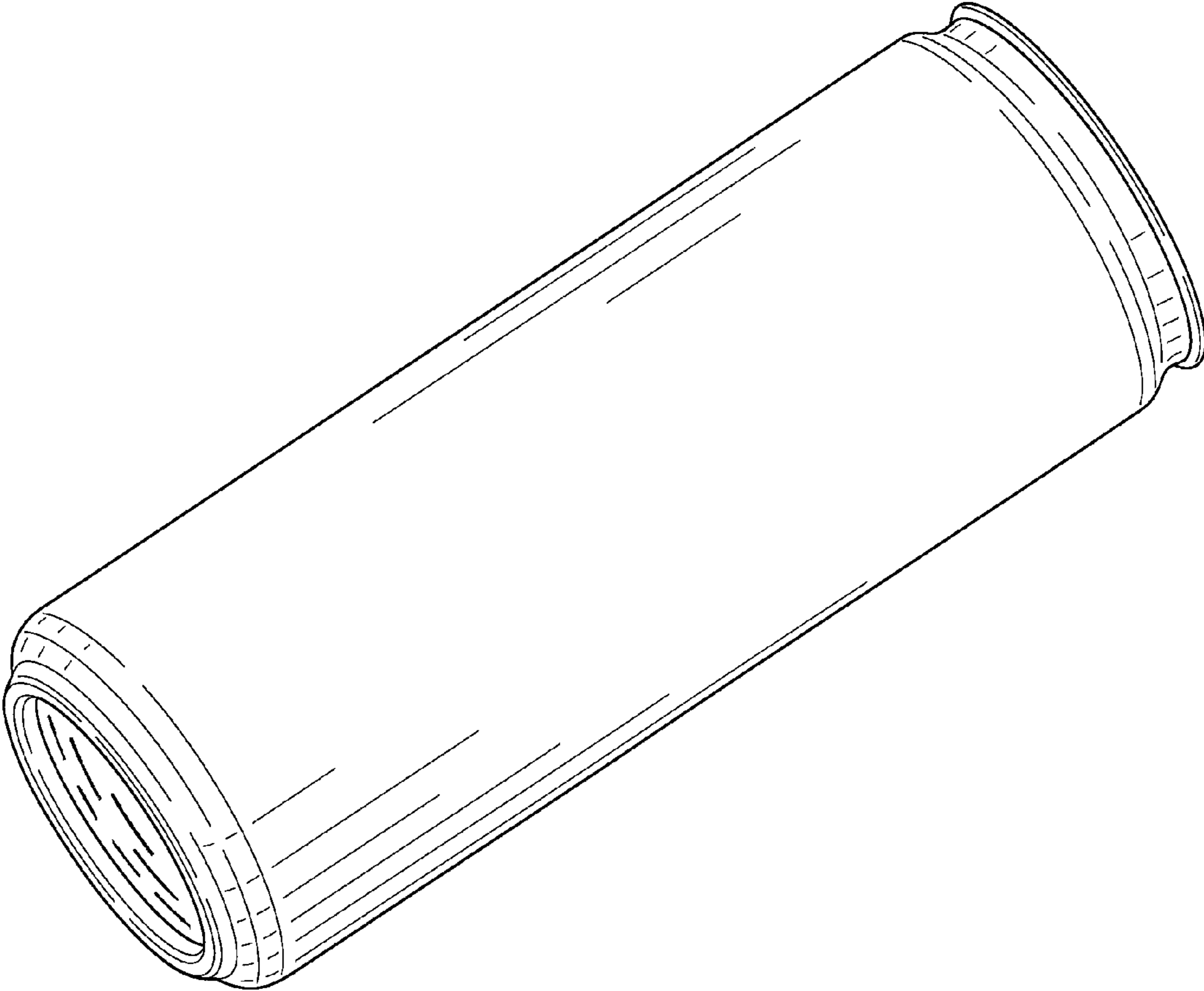

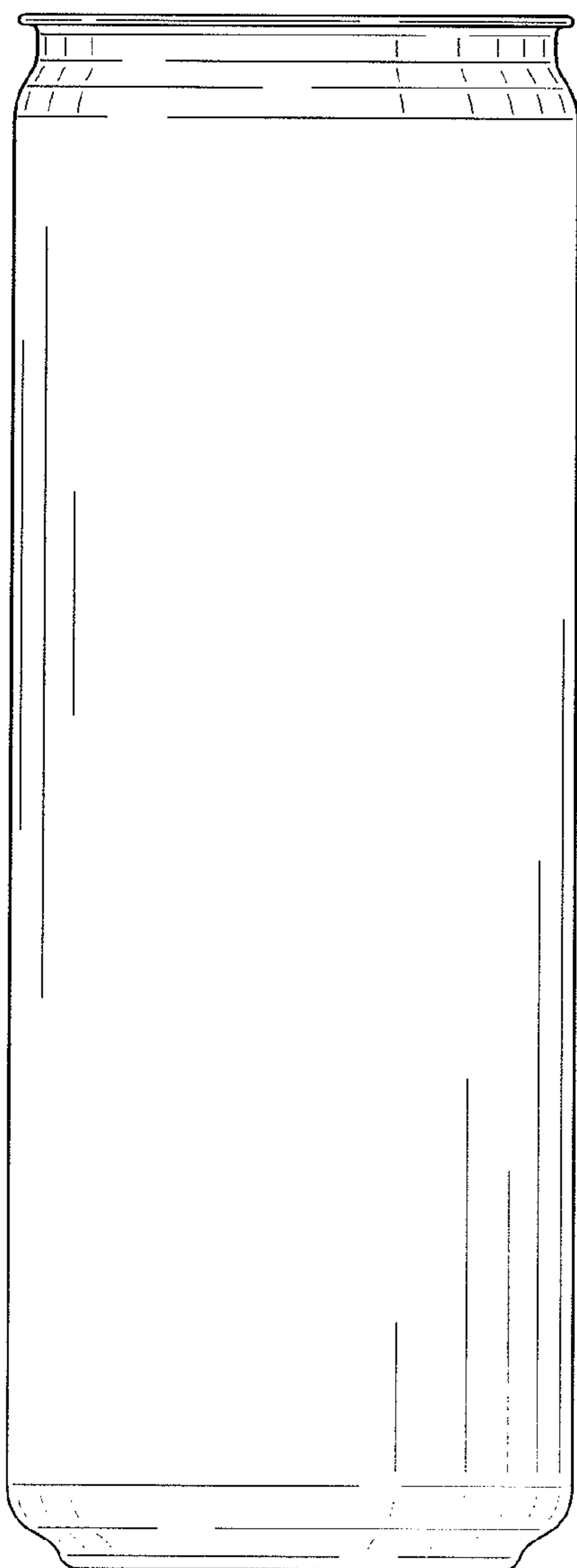

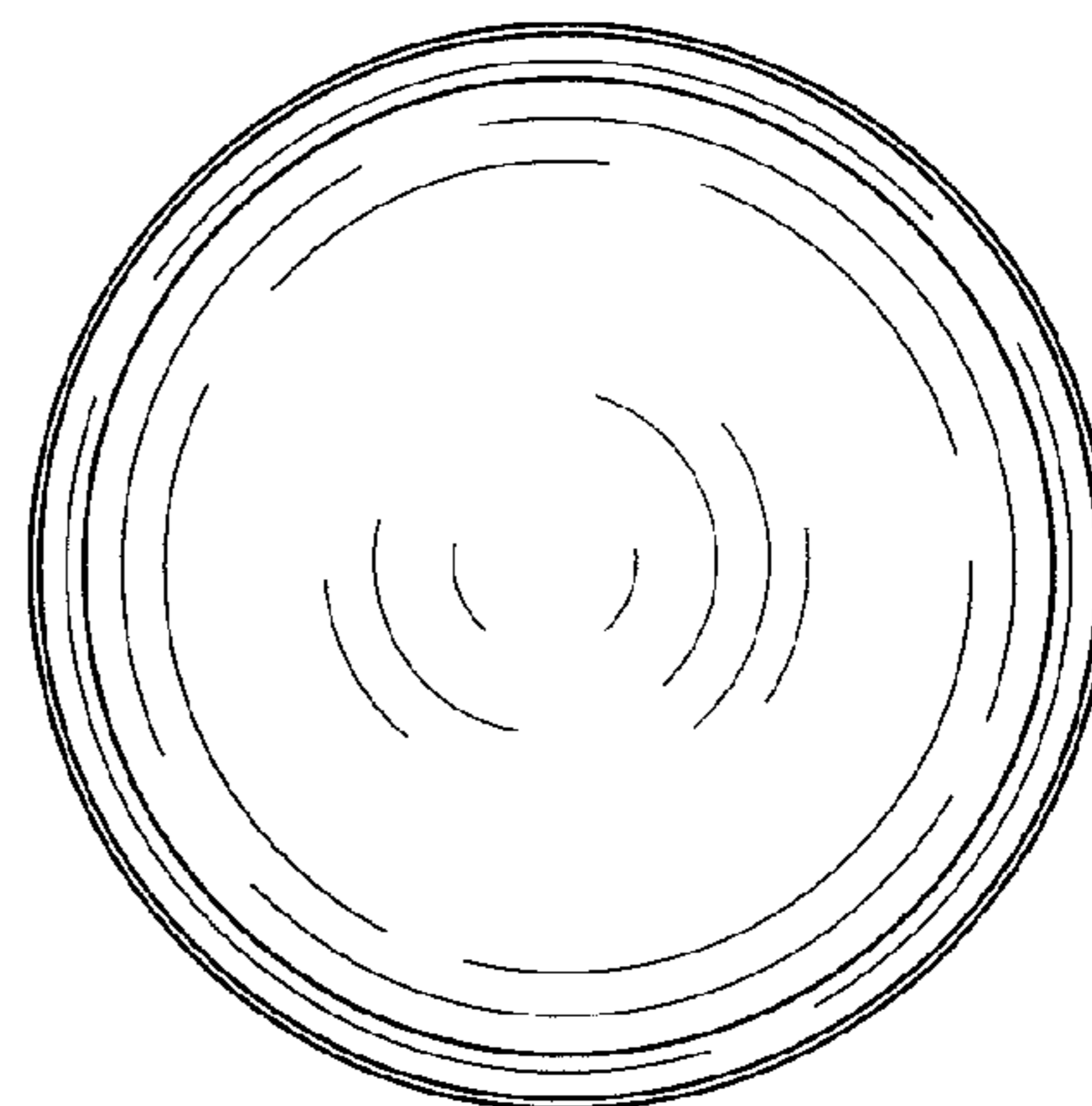

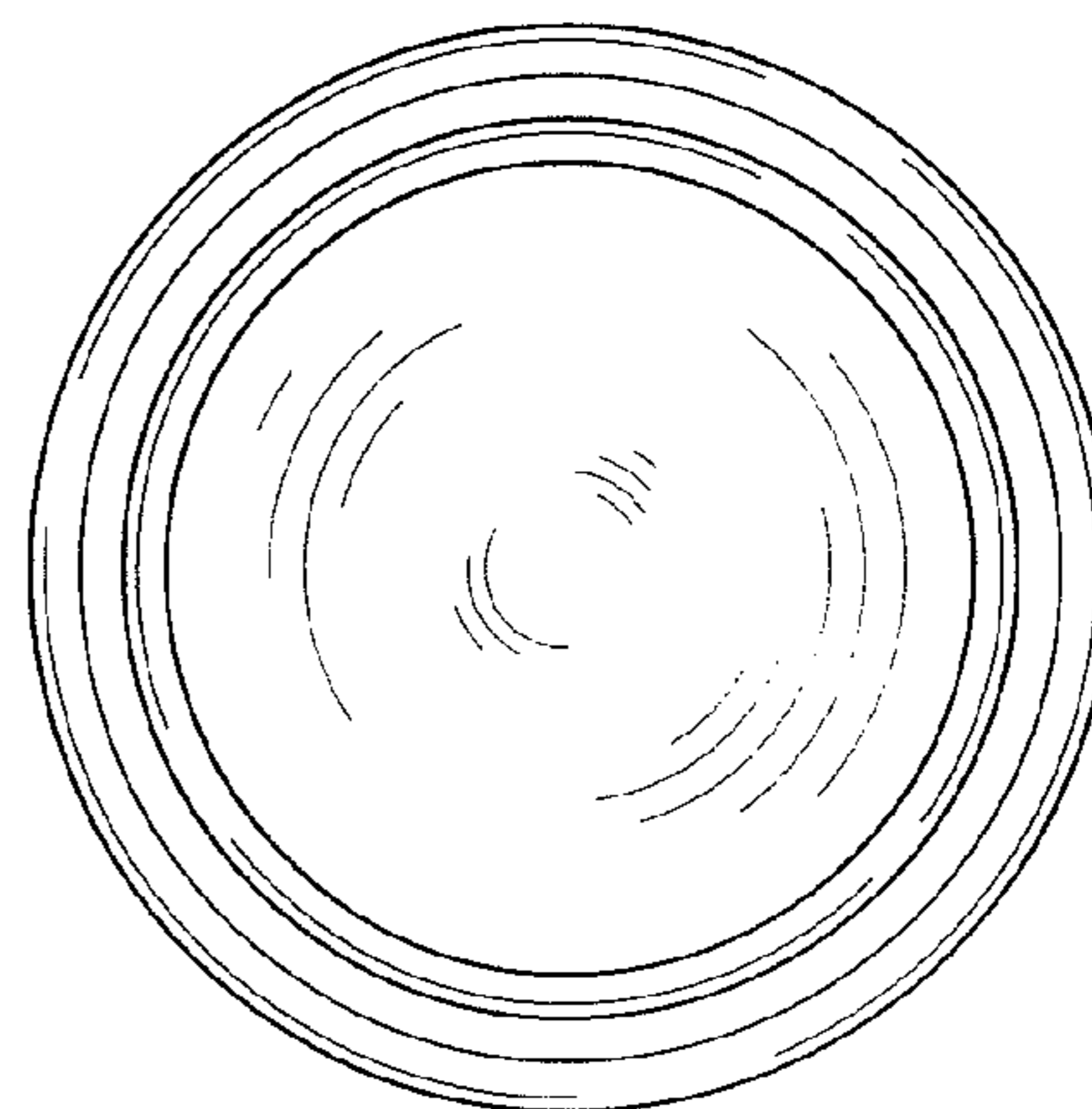
