**DESCRIPTION**

FIG. 1 is an illustrative top plan view of a precious stone showing our new design, a bottom plan view also shown looking through the transparent precious stone;

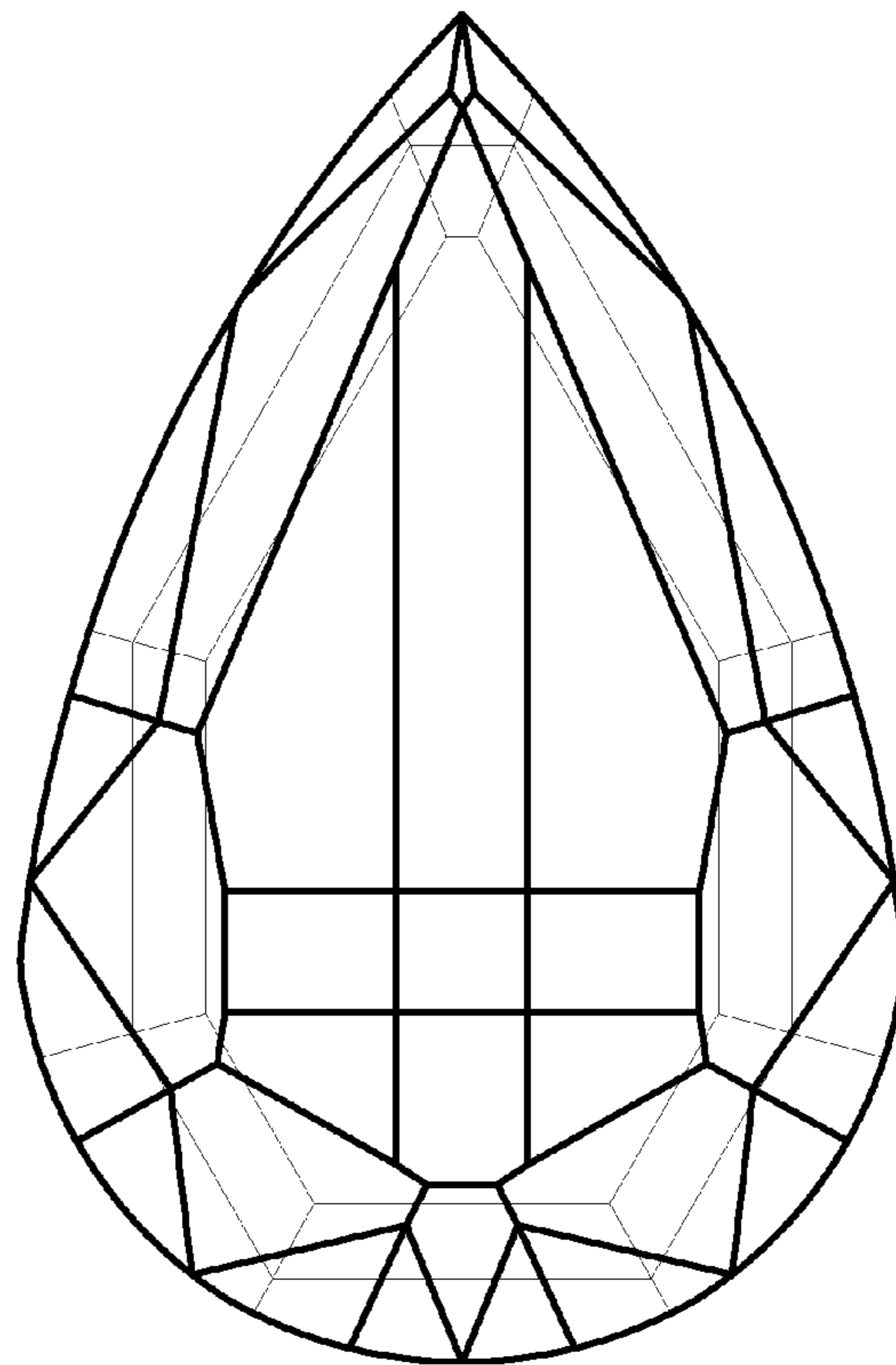
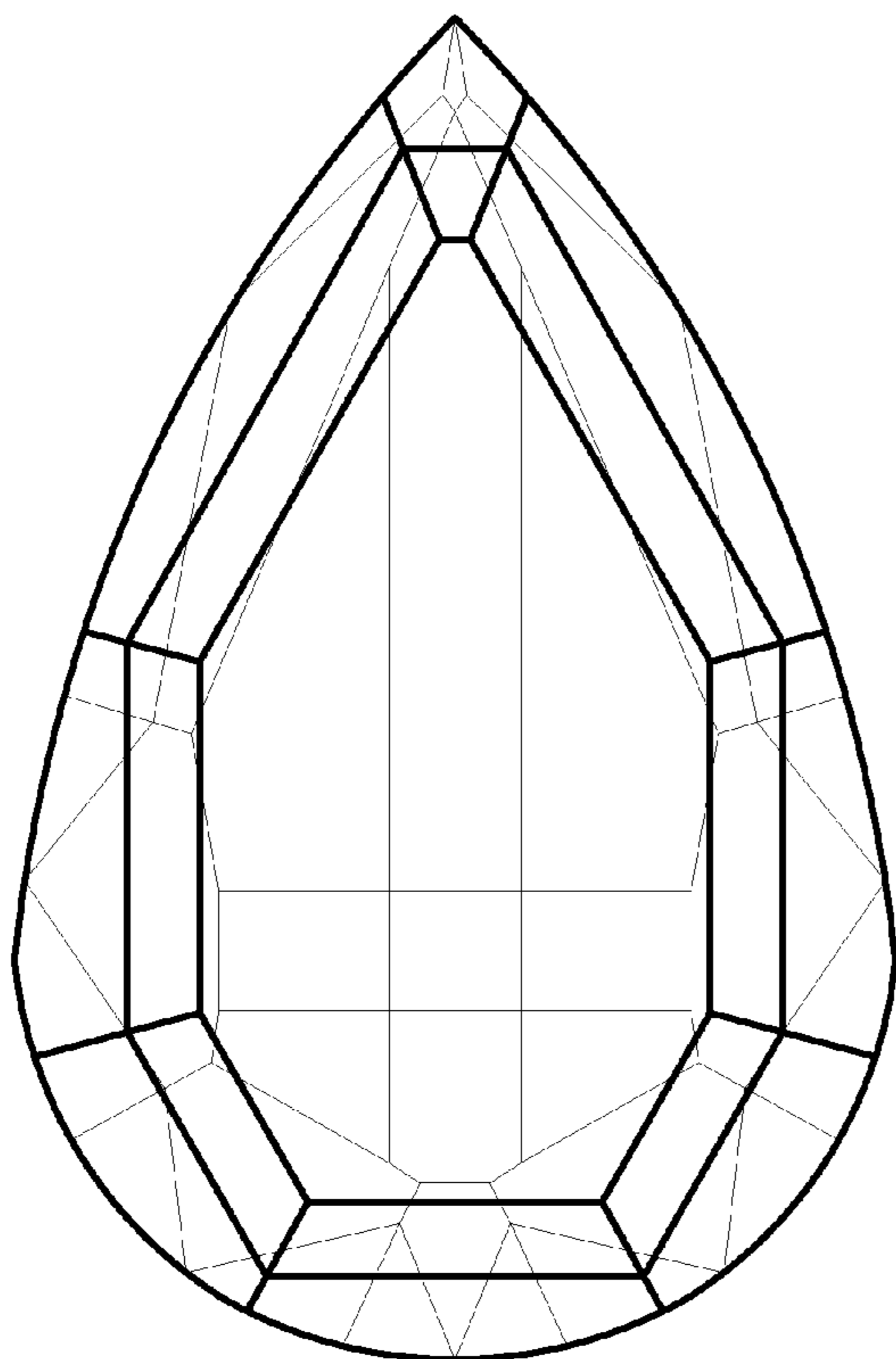
FIG. 2 is an illustrative bottom plan view, a top view also shown looking through the transparent precious stone;

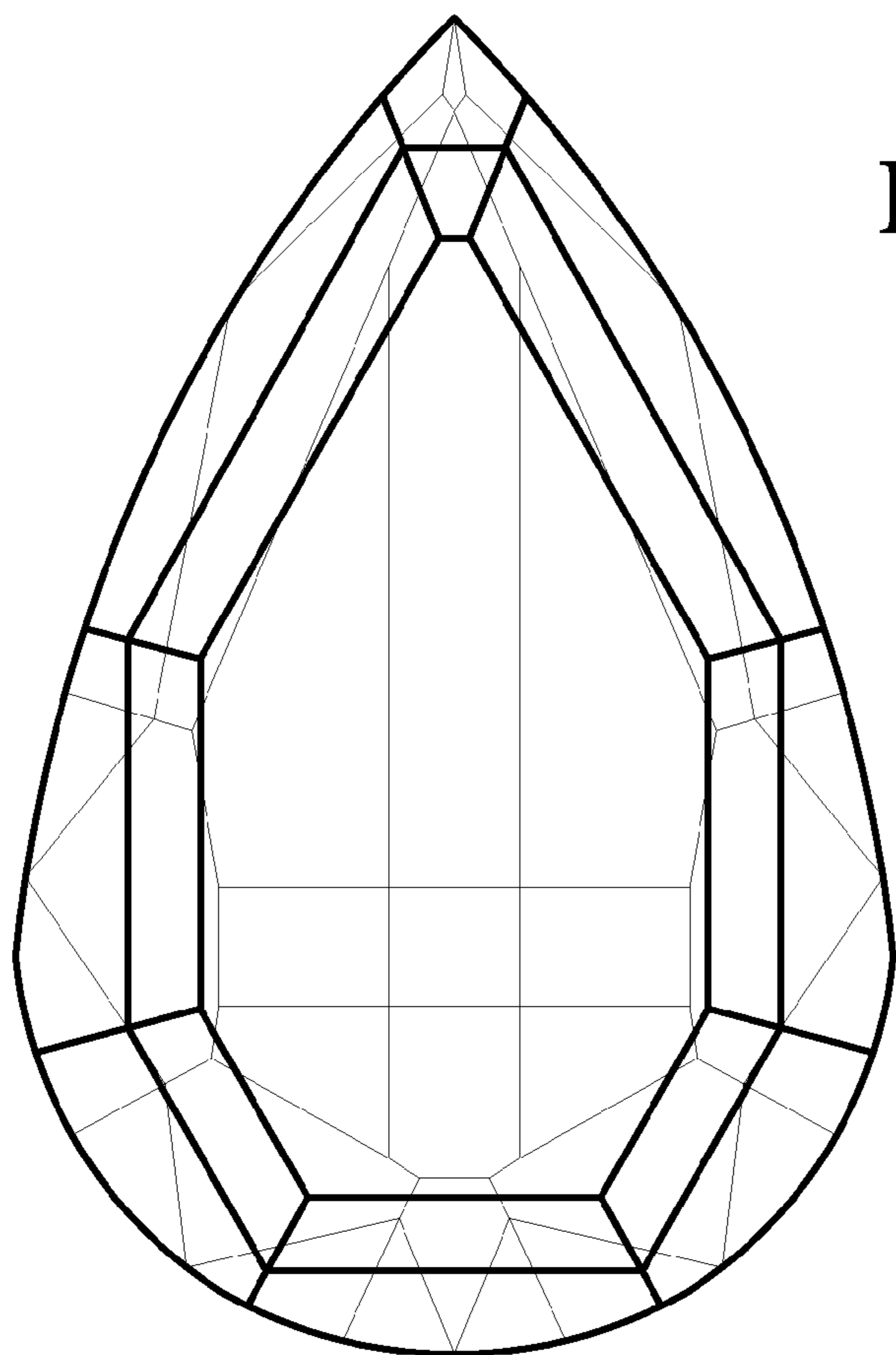

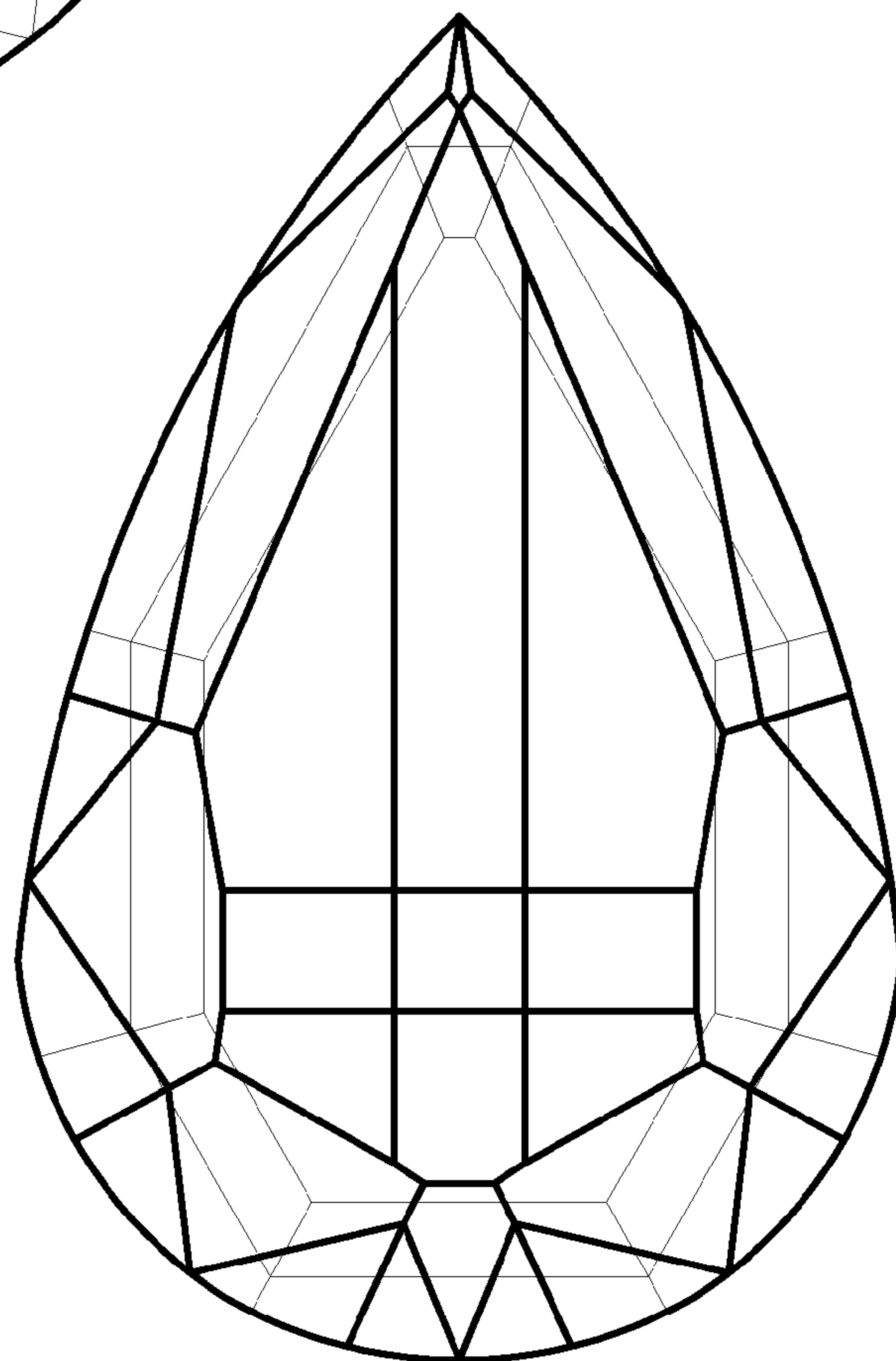

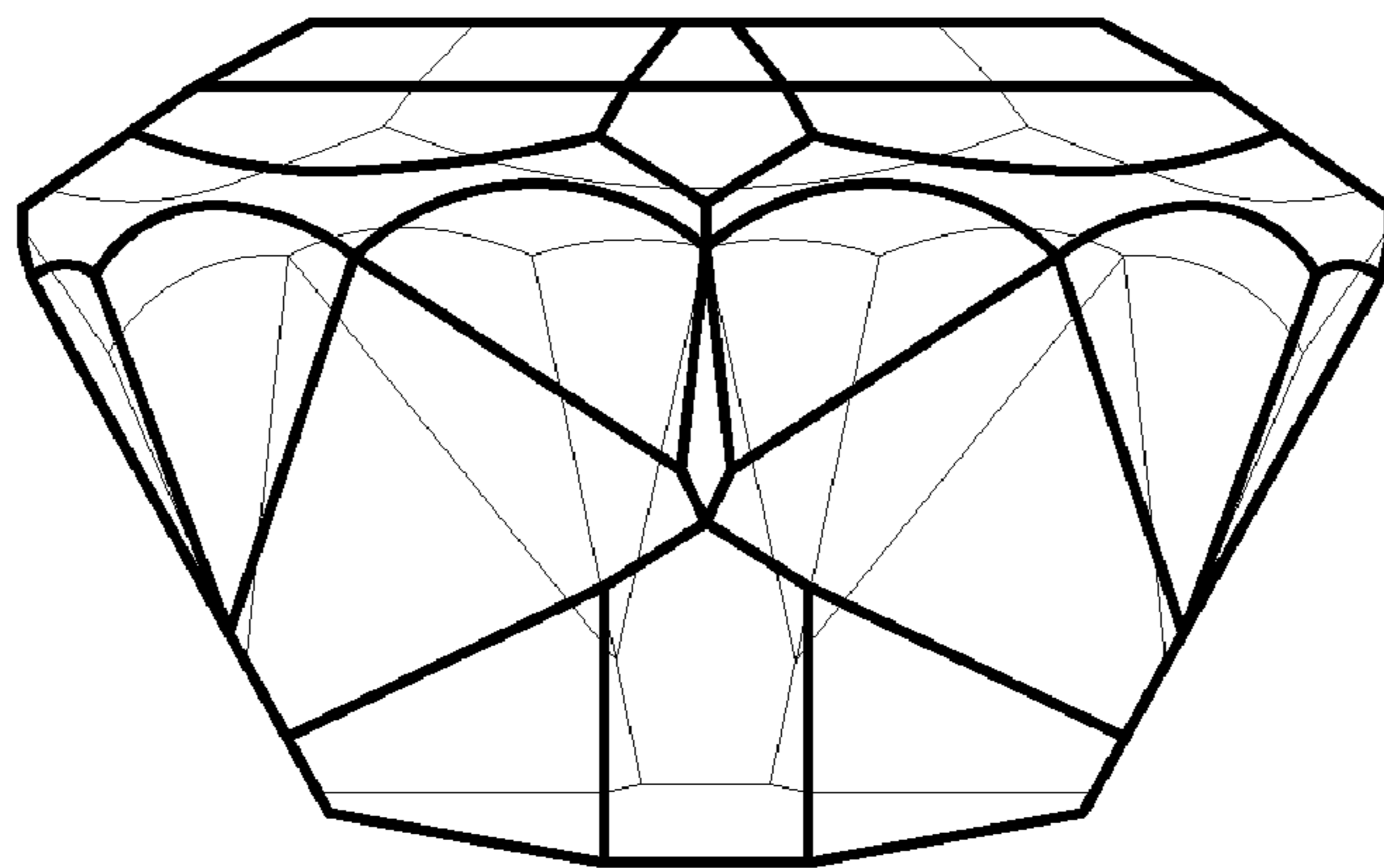

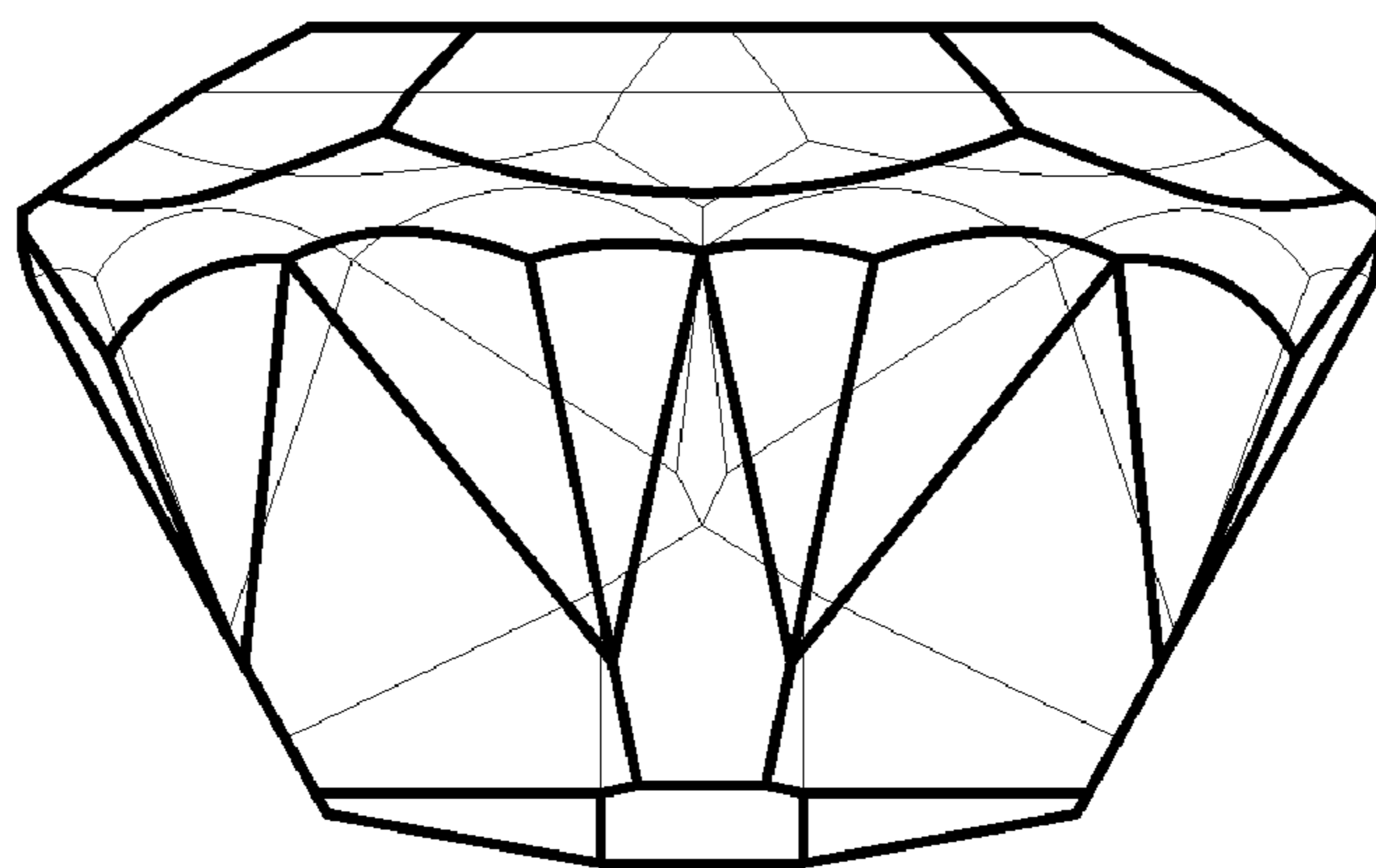

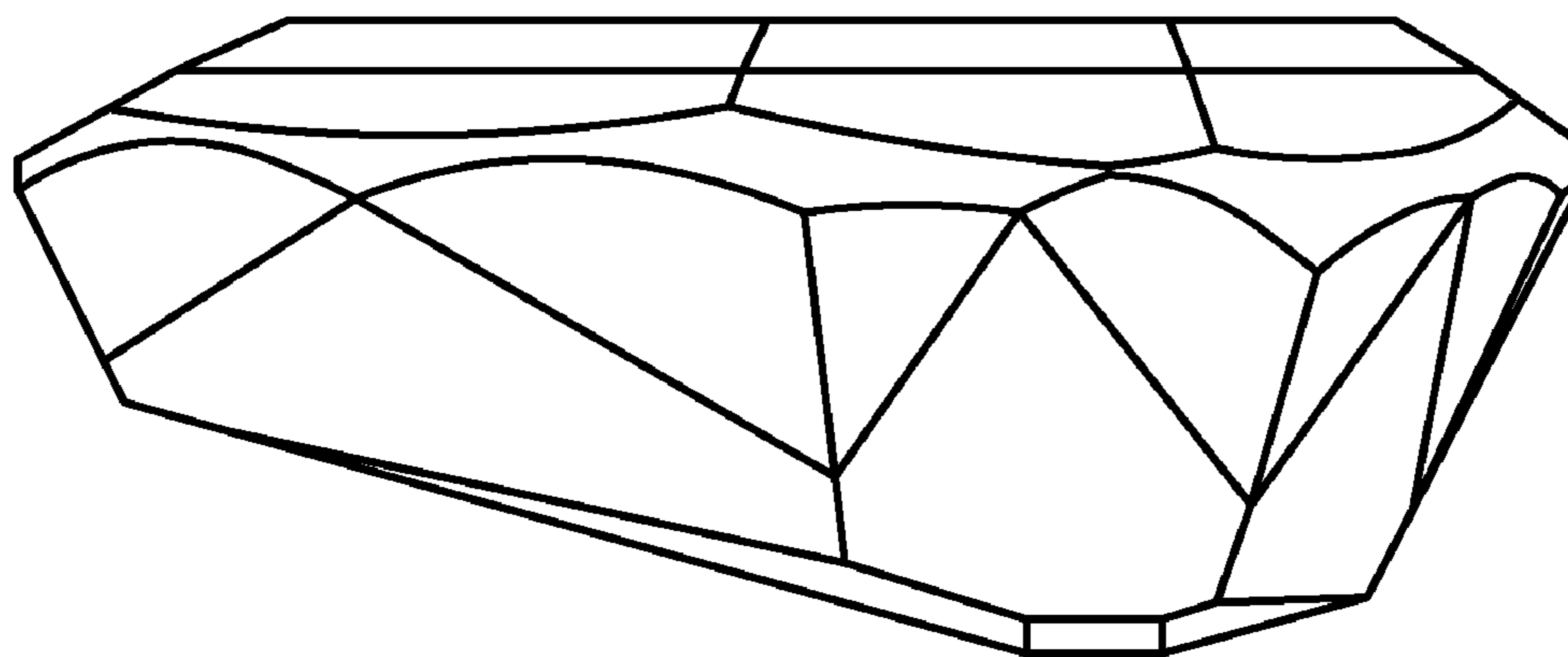

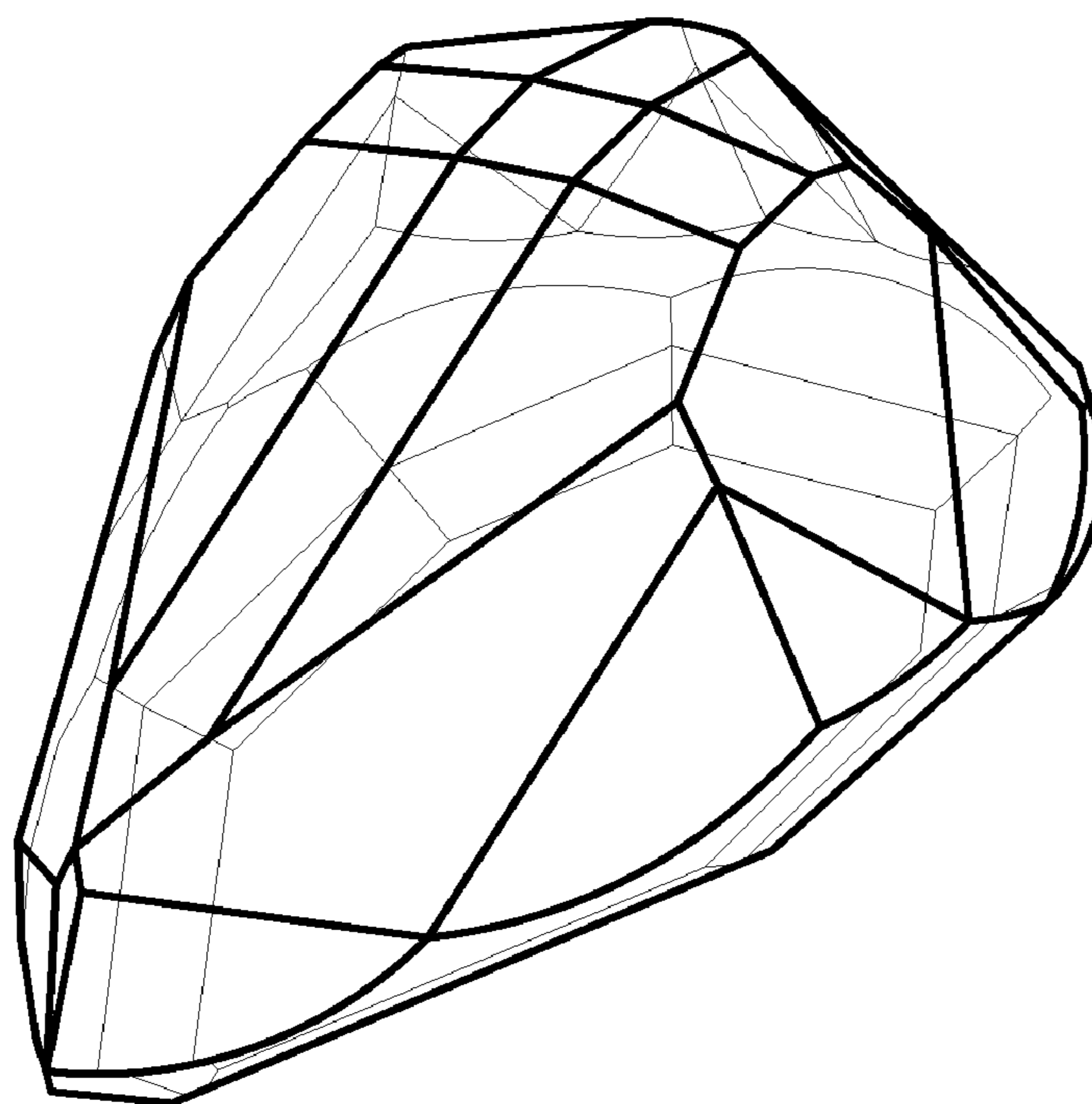
