(57) **CLAIM**

The ornamental design for a radiator grill for a vehicle, as shown and described.

DESCRIPTION

This application is related to the following co-pending application, of the inventors, filed on even date herewith: application Ser. No. 29/290,439, entitled “radiator grill for a vehicle”.

FIG. 1 is a left perspective view of a radiator grill for a vehicle according to our novel design, the right perspective view being mirror symmetrical;

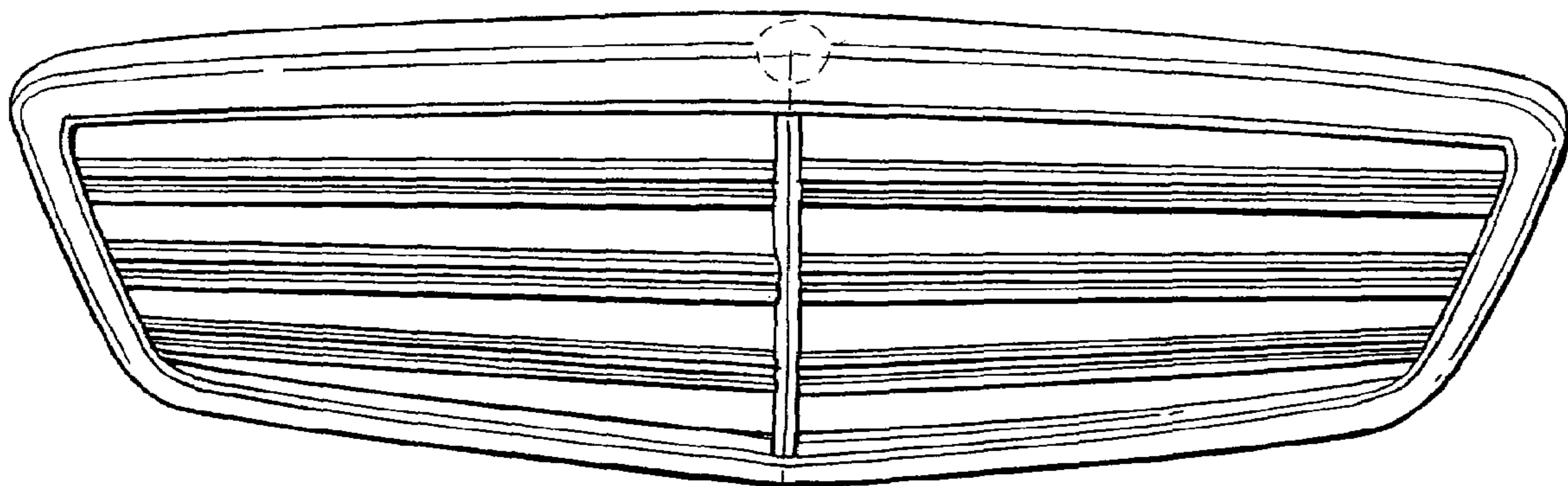
FIG. 2 is a front view thereof;

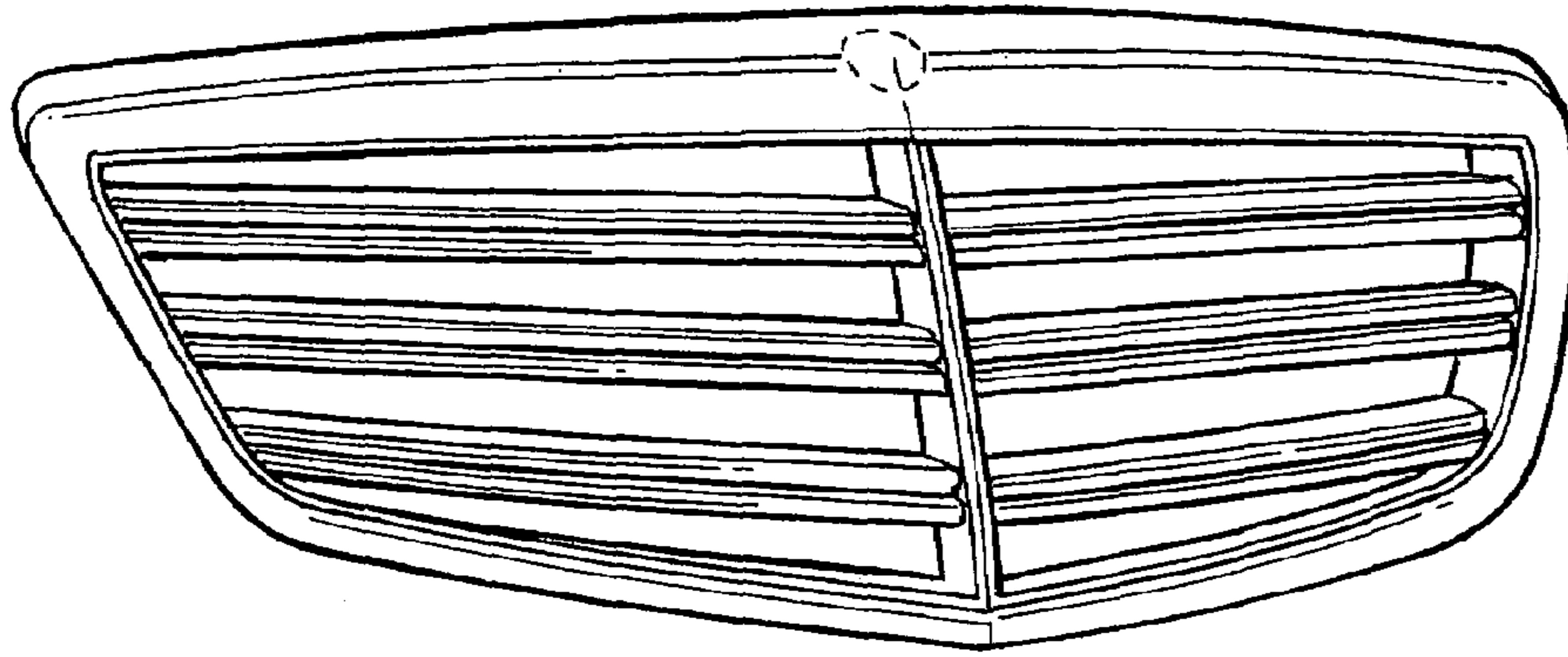

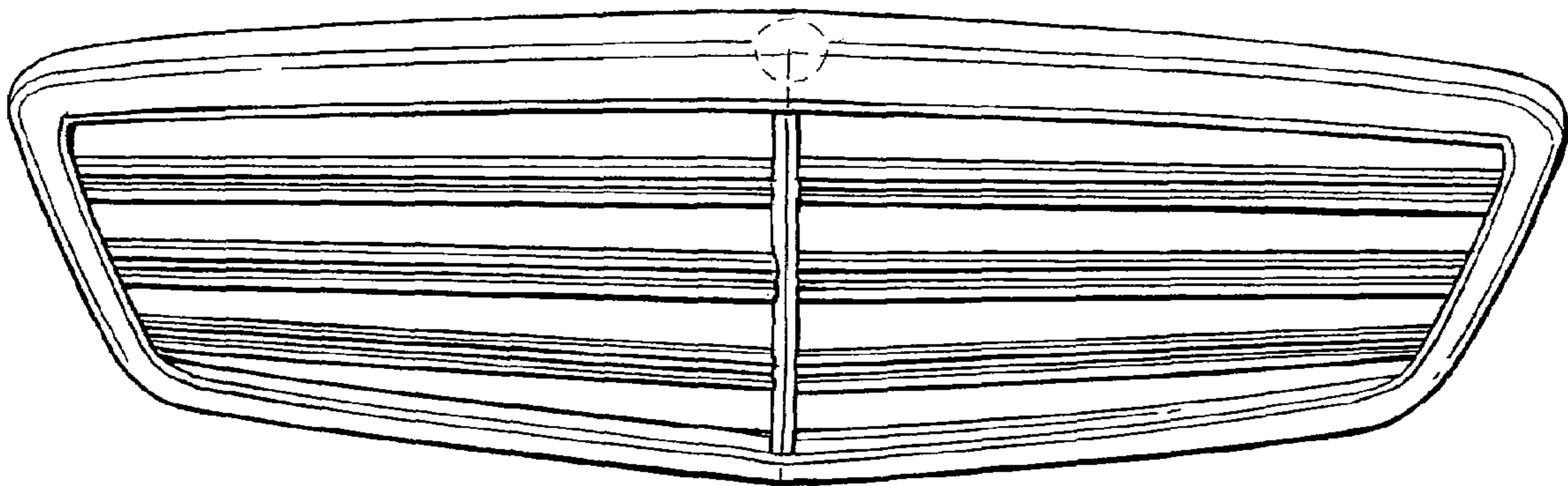

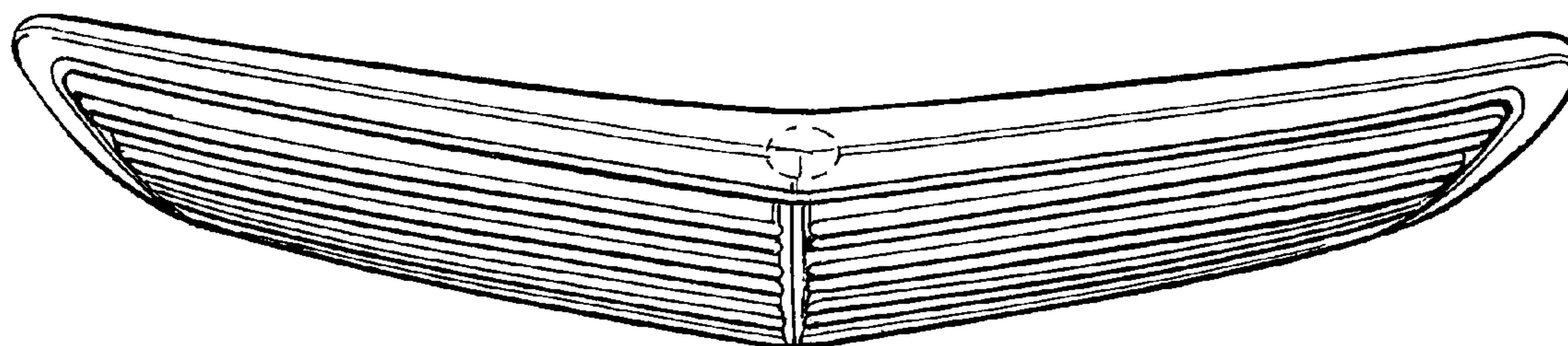

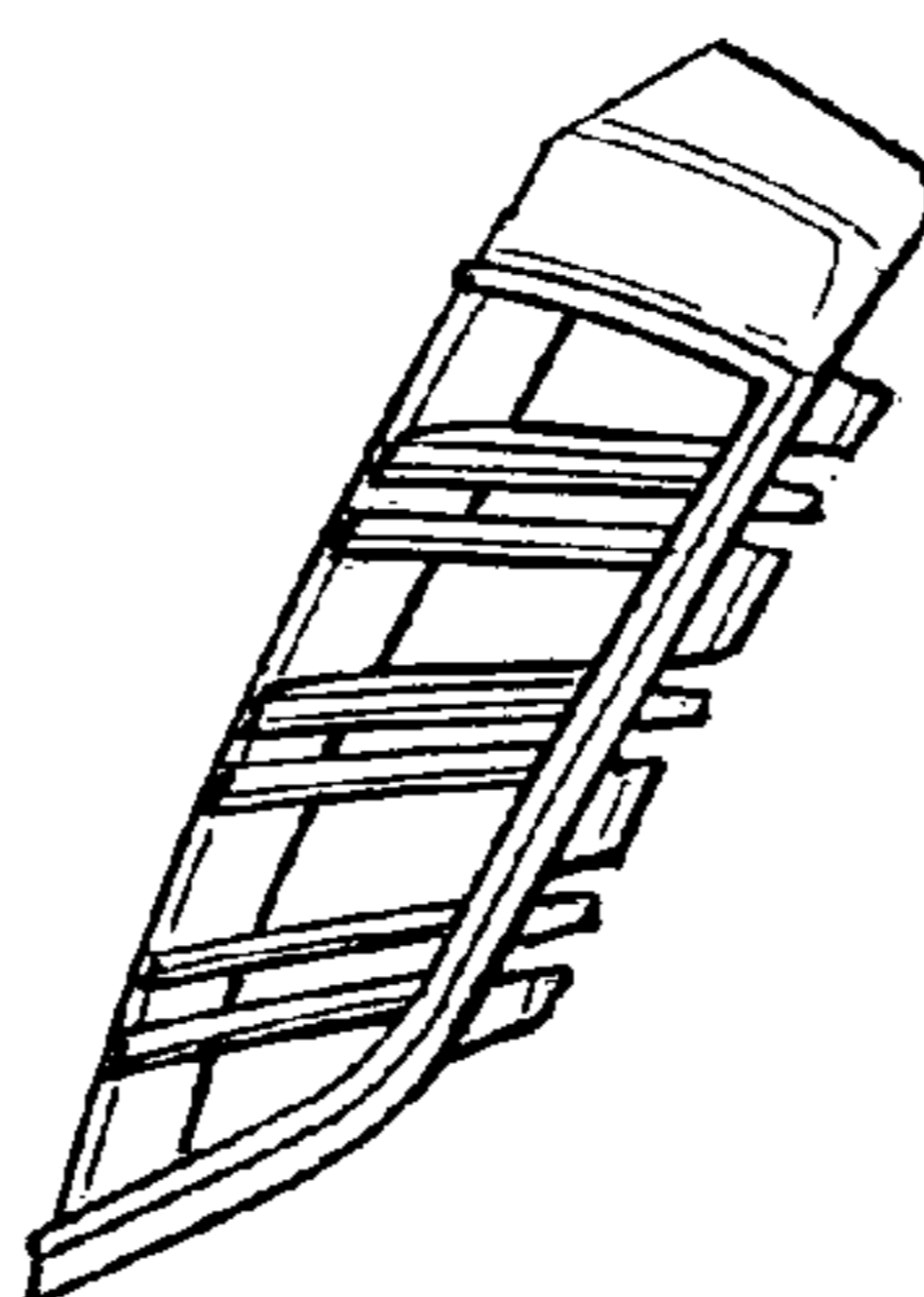
