(57) **CLAIM**

The ornamental design for a front cowl for motorcycles, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the front cowl for motorcycles;
FIG. 2 is a rear view of the front cowl for motorcycles;
FIG. 3 is a top plan view of the front cowl for motorcycles;
FIG. 4 is a bottom view of the front cowl for motorcycles;
FIG. 5 is a right side view of the front cowl for motorcycles;
FIG. 6 is a left side view of front cowl for motorcycles;
FIG. 7 is a perspective view of the front cowl for motorcycles as seen from the right front side;
FIG. 8 is a perspective view of the front cowl for motorcycles as seen from the left front side;
FIG. 9 is a perspective view of the front cowl for motorcycles as seen from the right rear side;
FIG. 10 is a perspective view of the front cowl for motorcycles as seen from the left rear side; and,
FIG. 11 is a view of the front cowl for motorcycles shown in position of use.

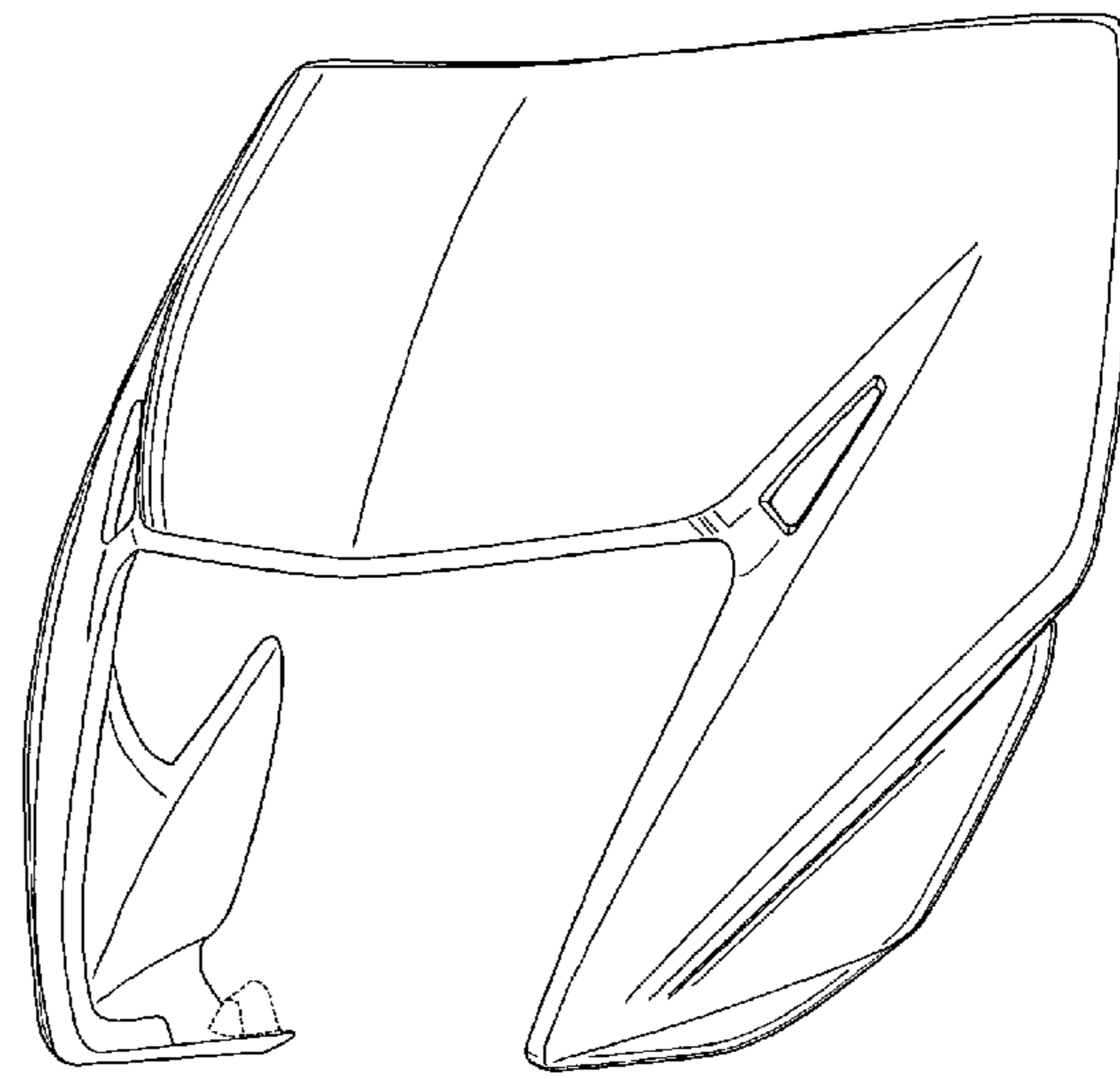
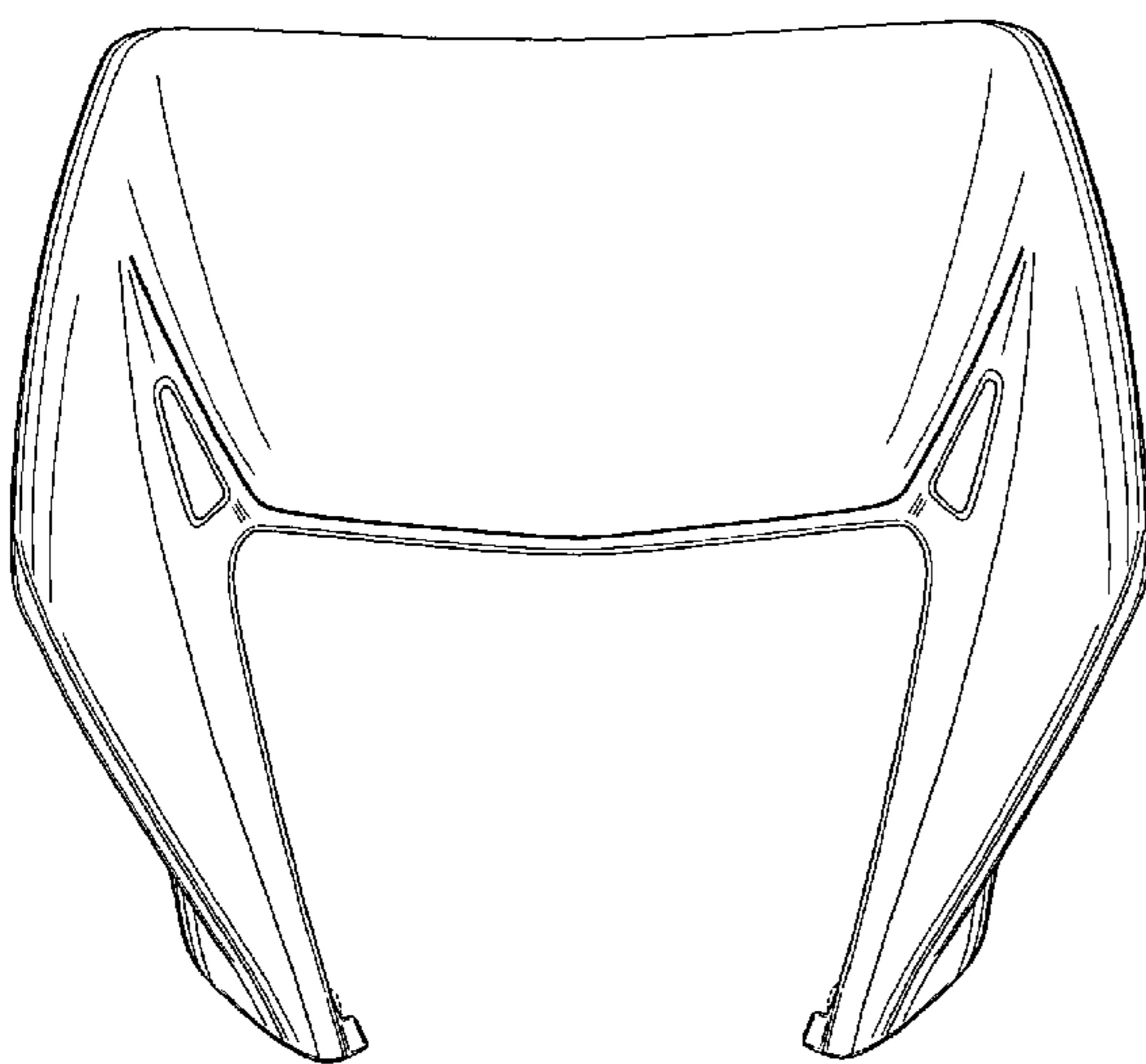

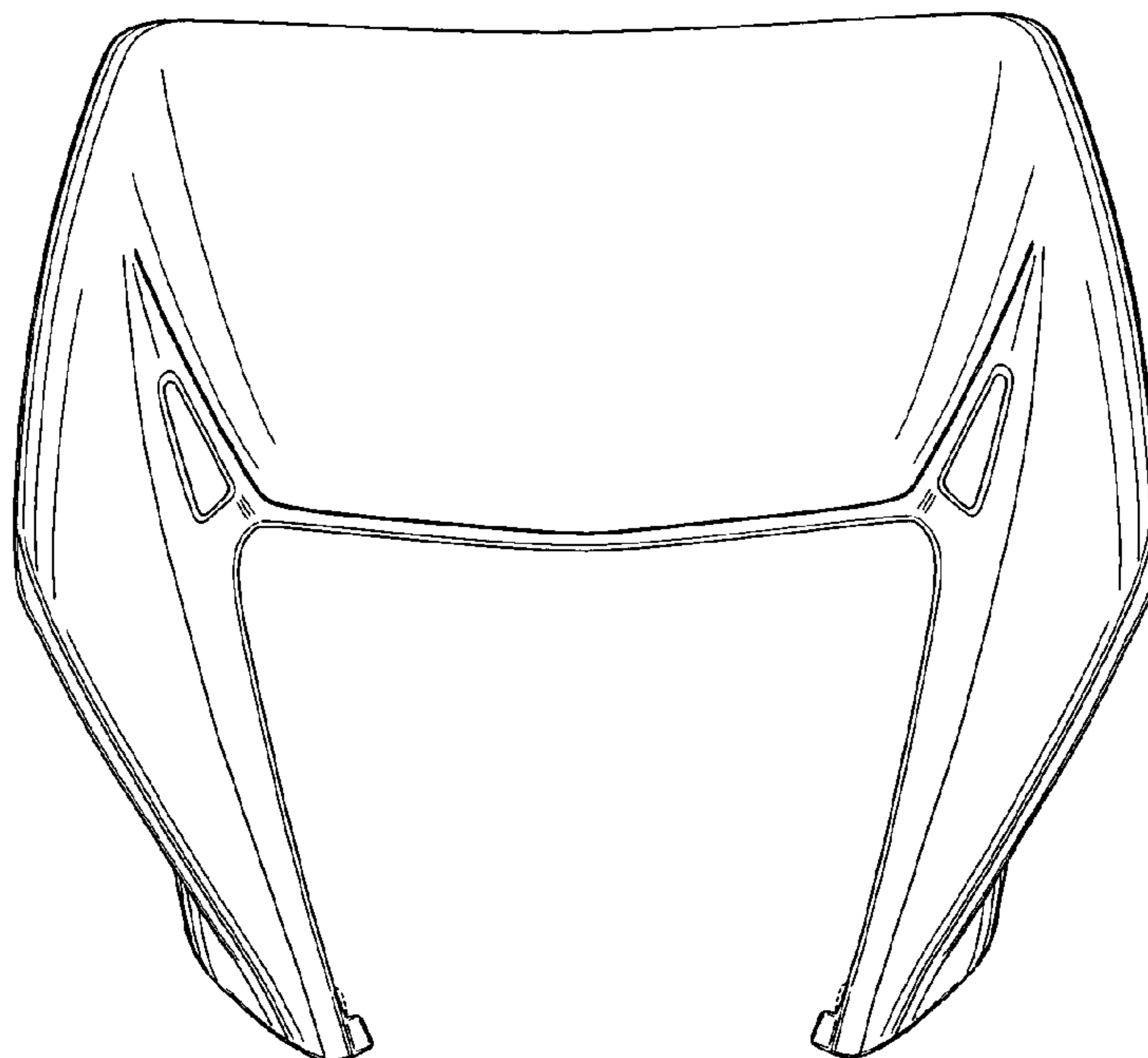

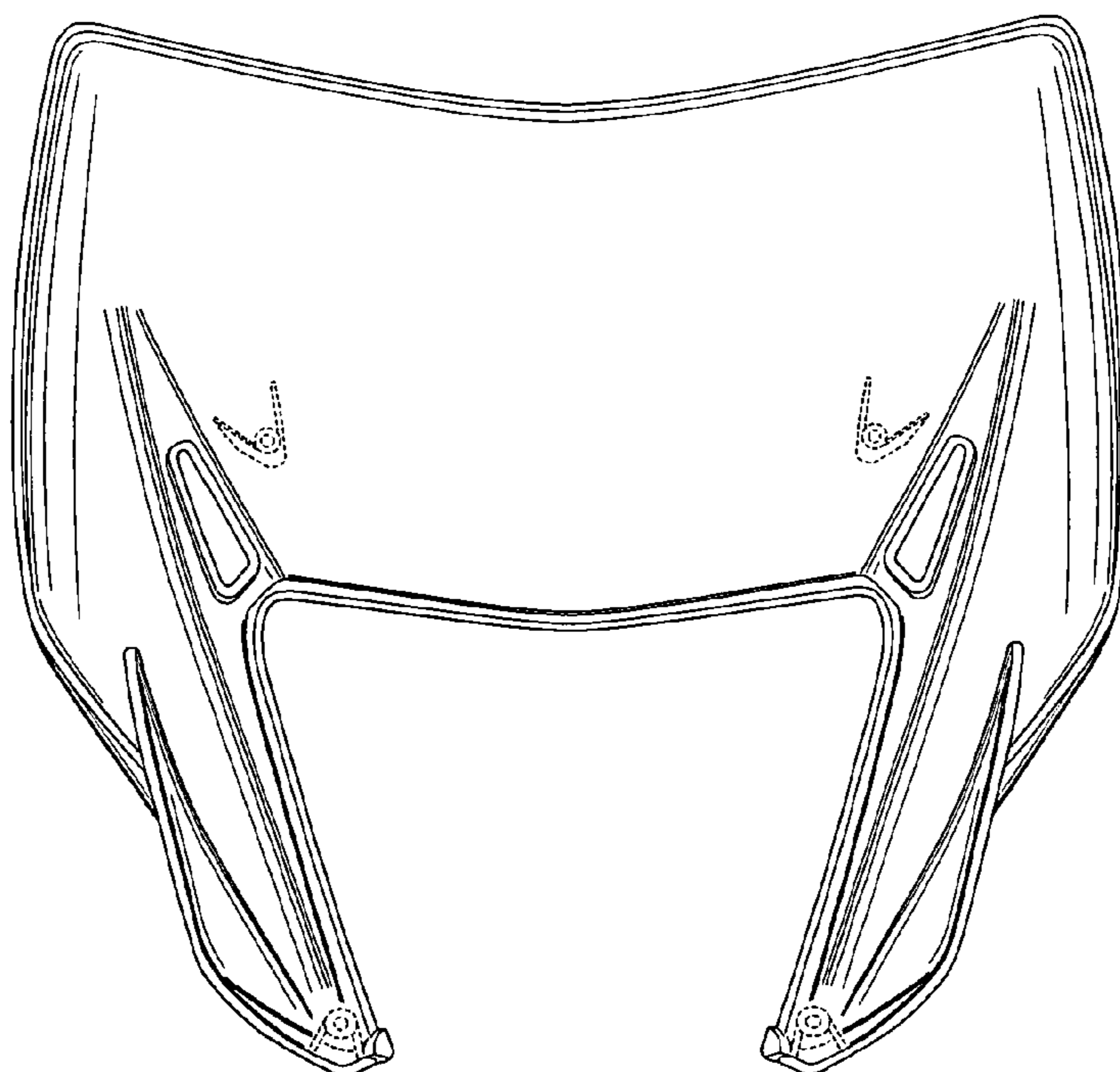

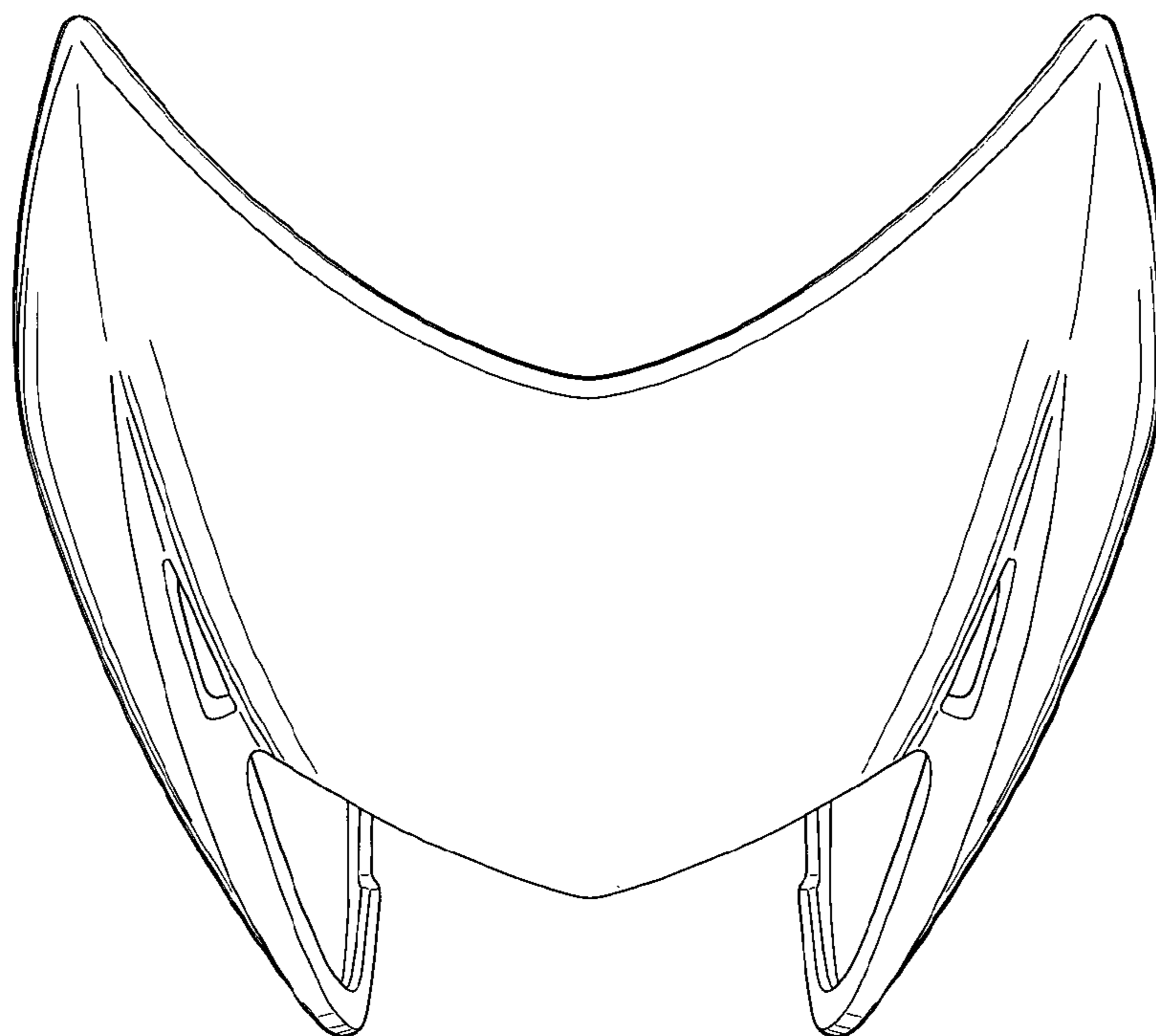

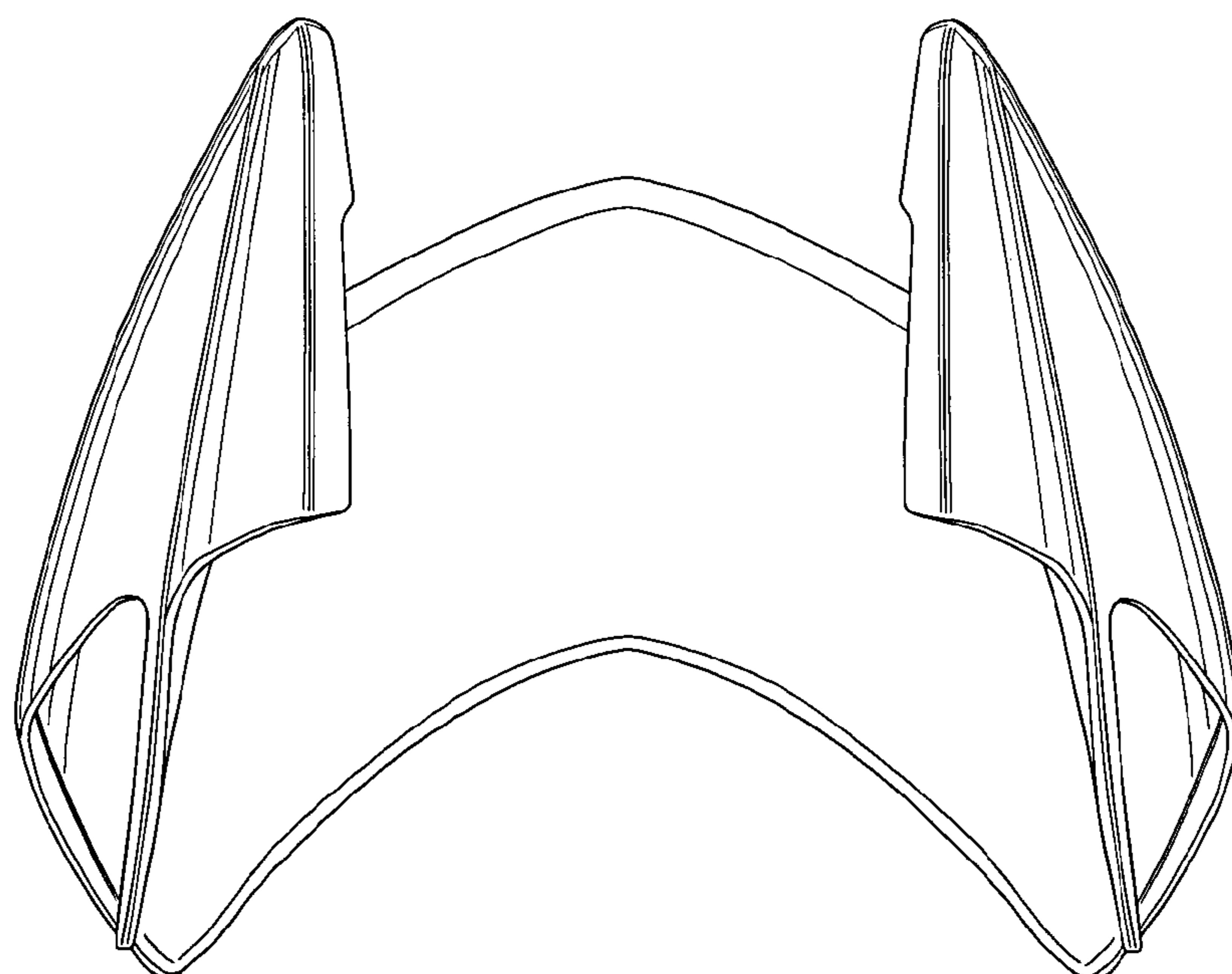

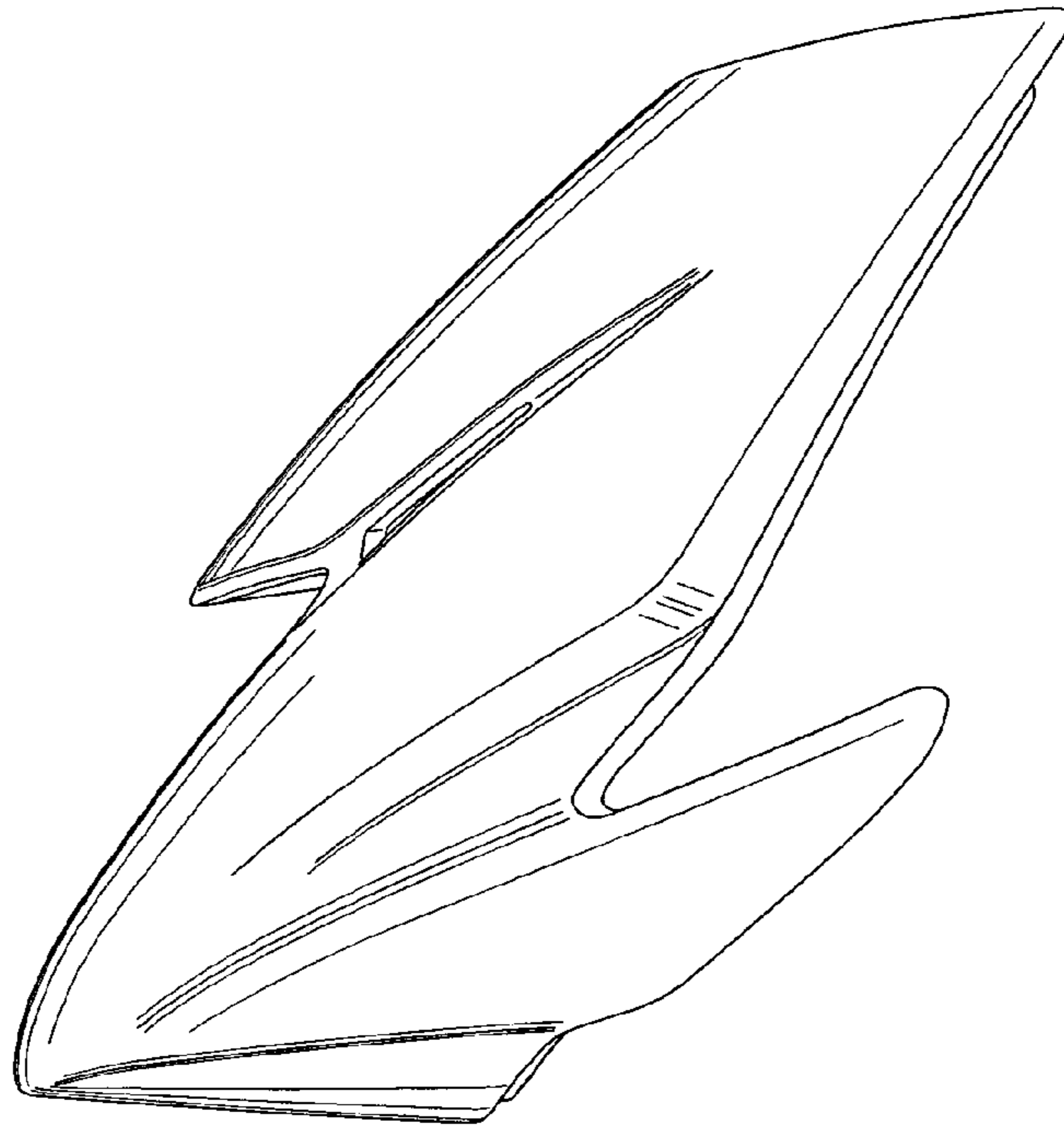

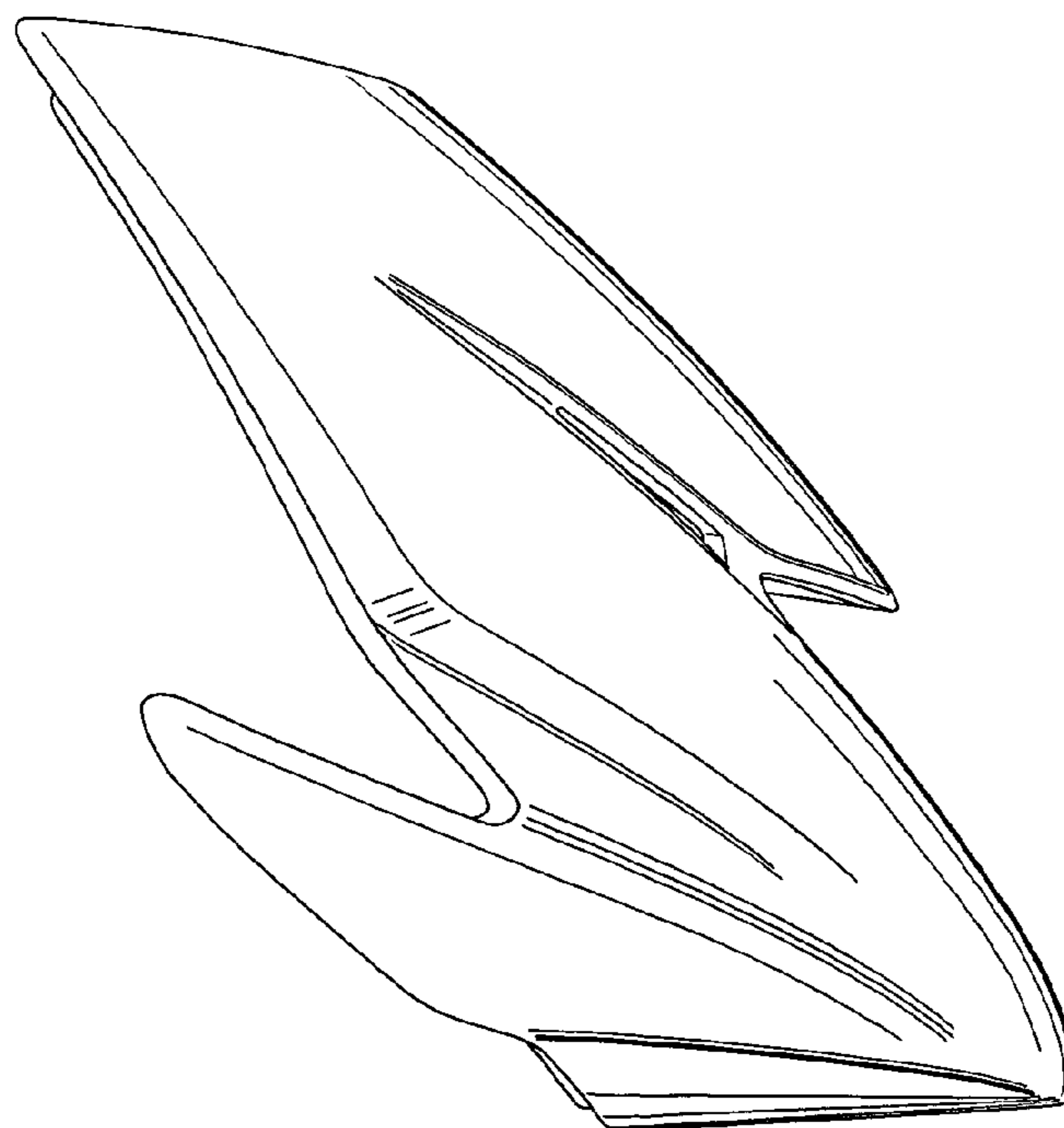

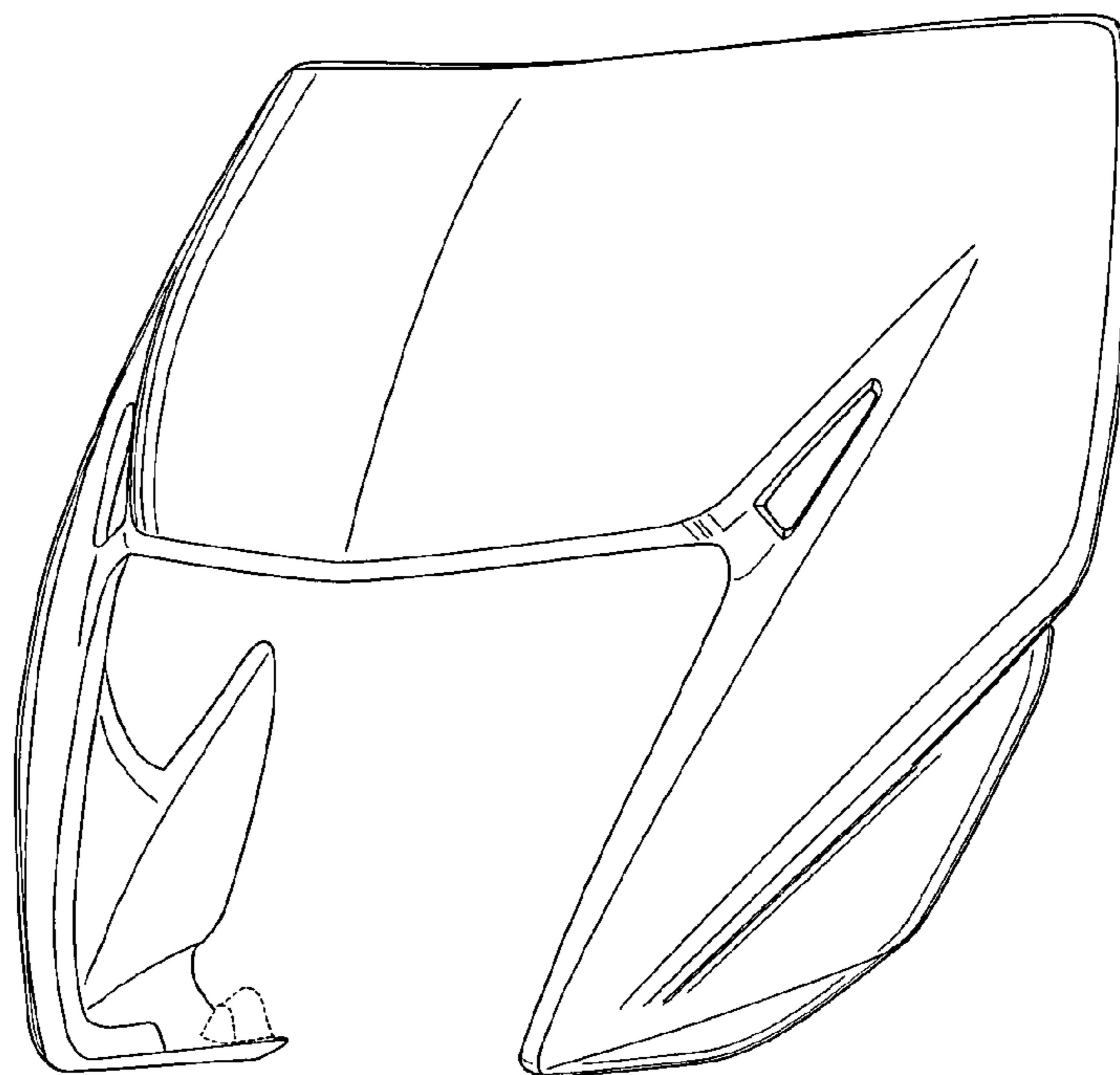

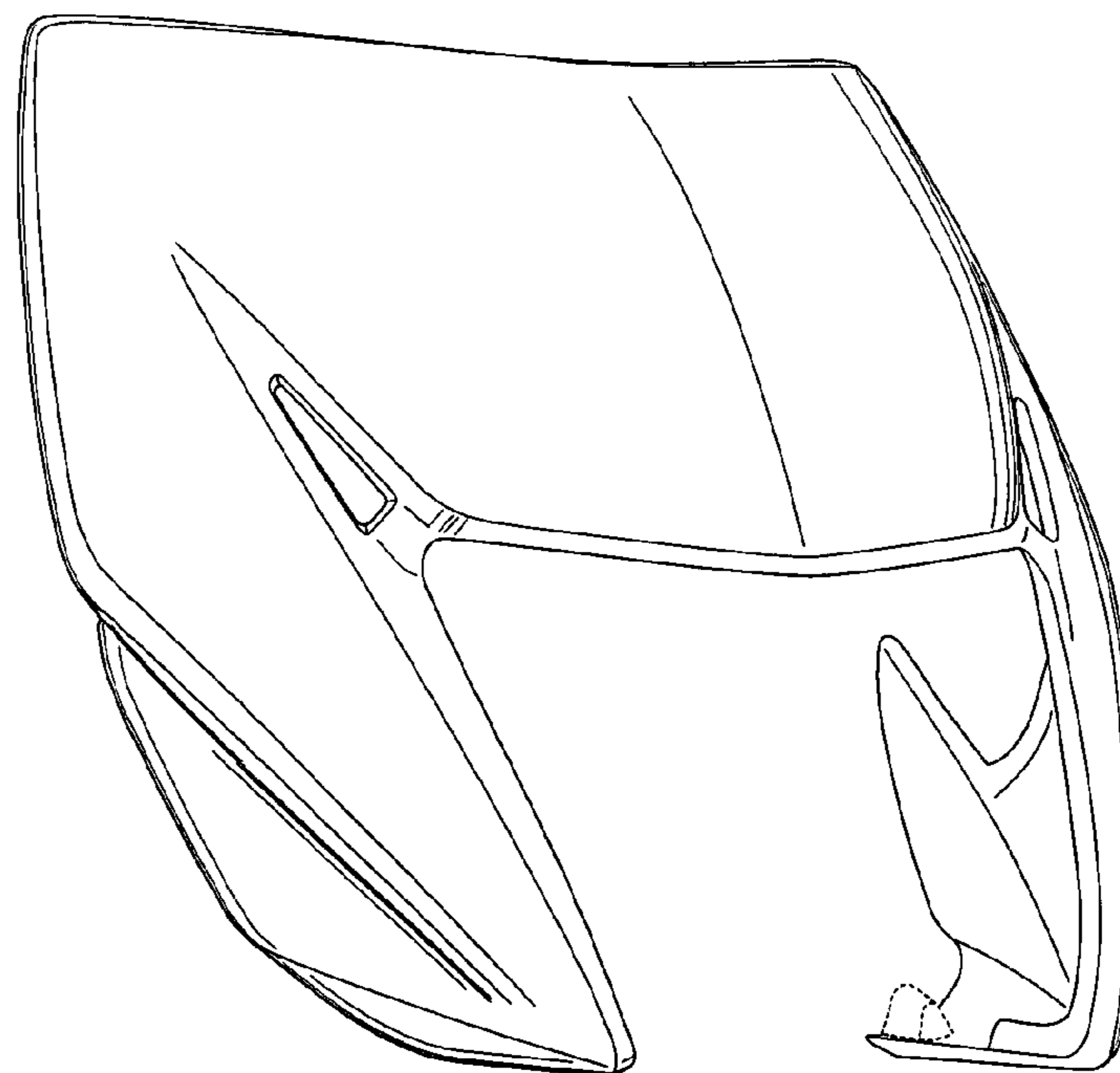

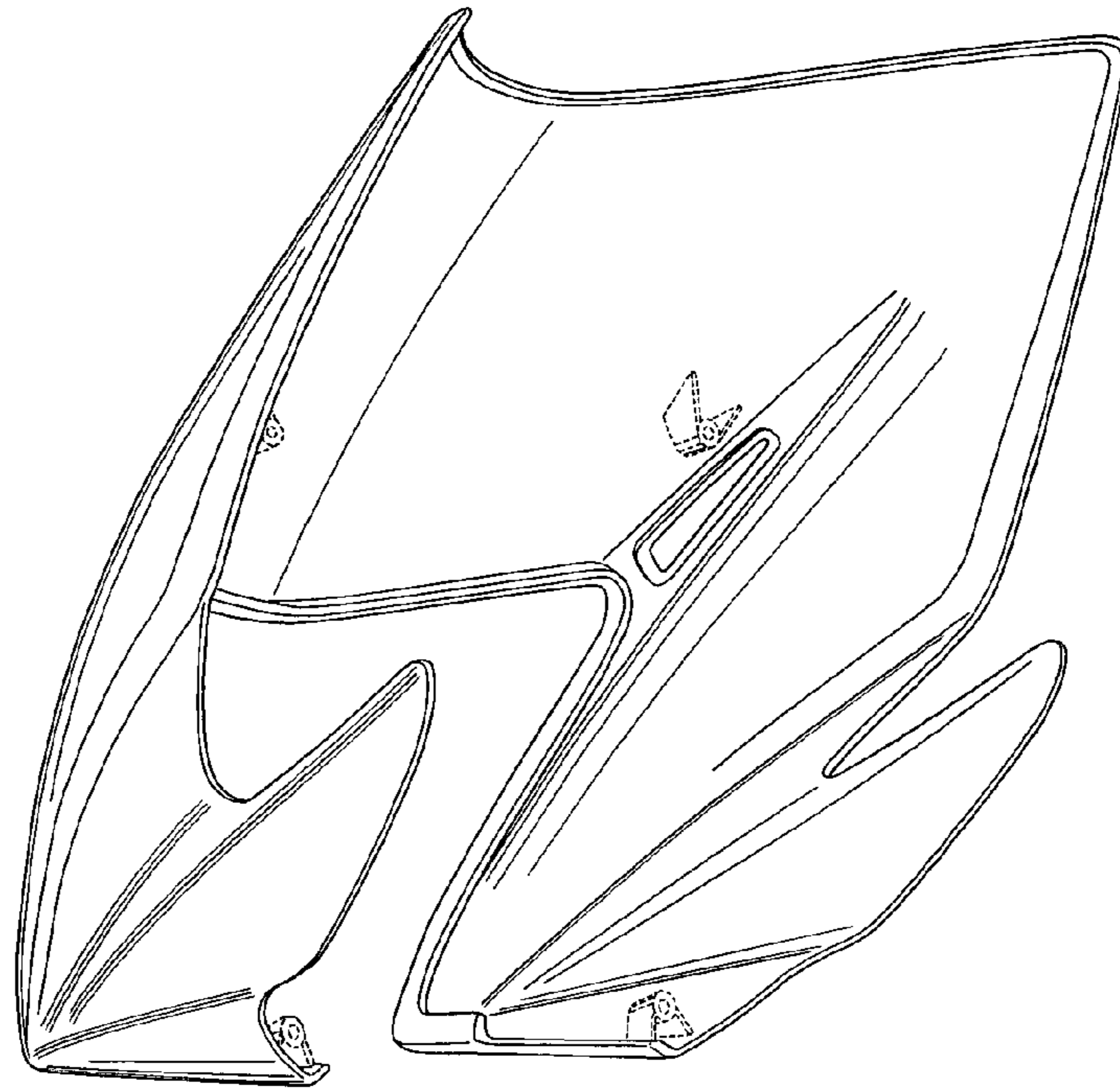

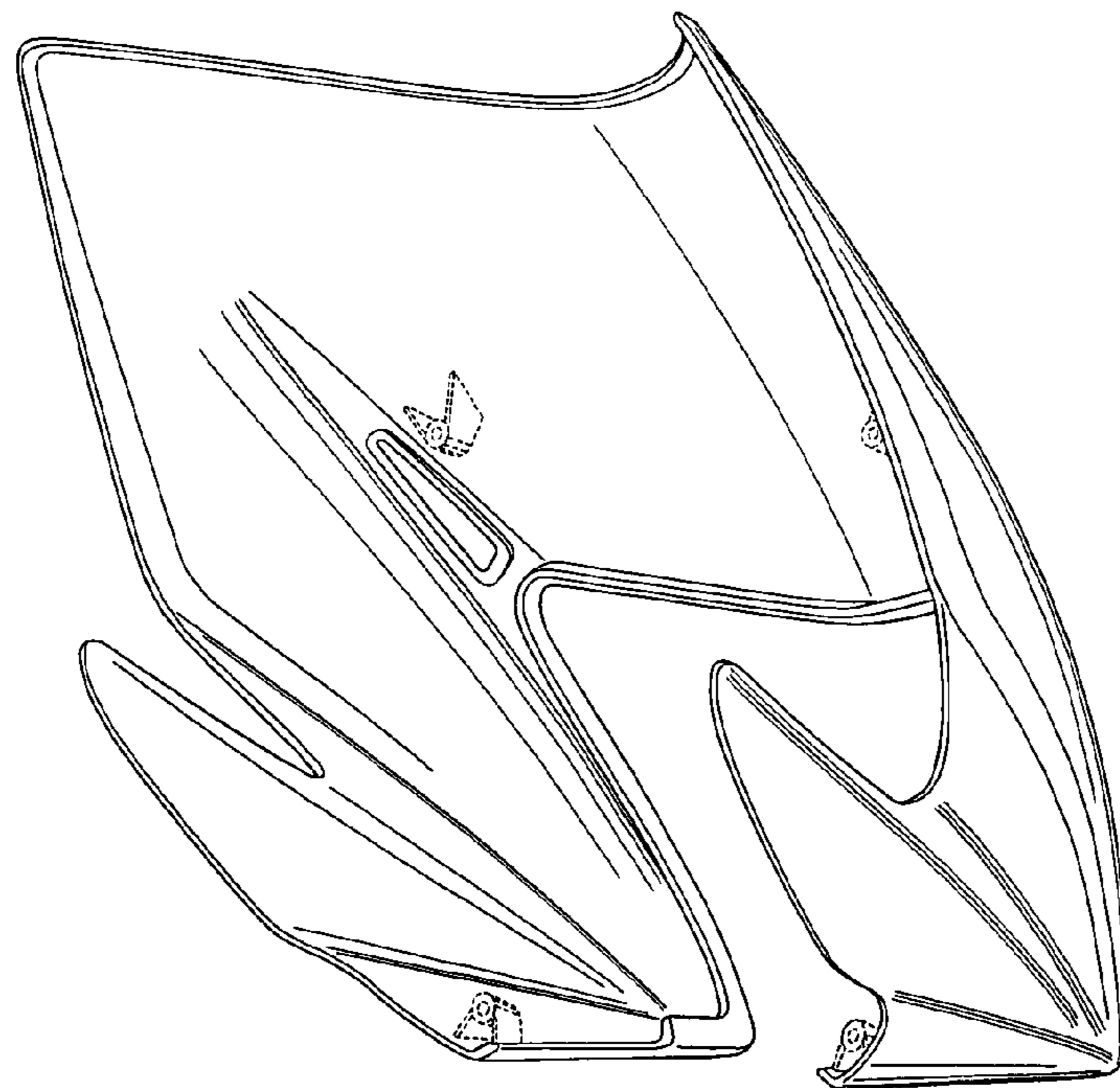
