The ornamental design for an electrical contact, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of an electrical contact, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a cross sectional view thereof; taken along line 6—6 in FIG. 1 thereof;

FIG. 7 is a top, front and left side perspective view thereof; and,

FIG. 8 is a top, rear and left side perspective view thereof.

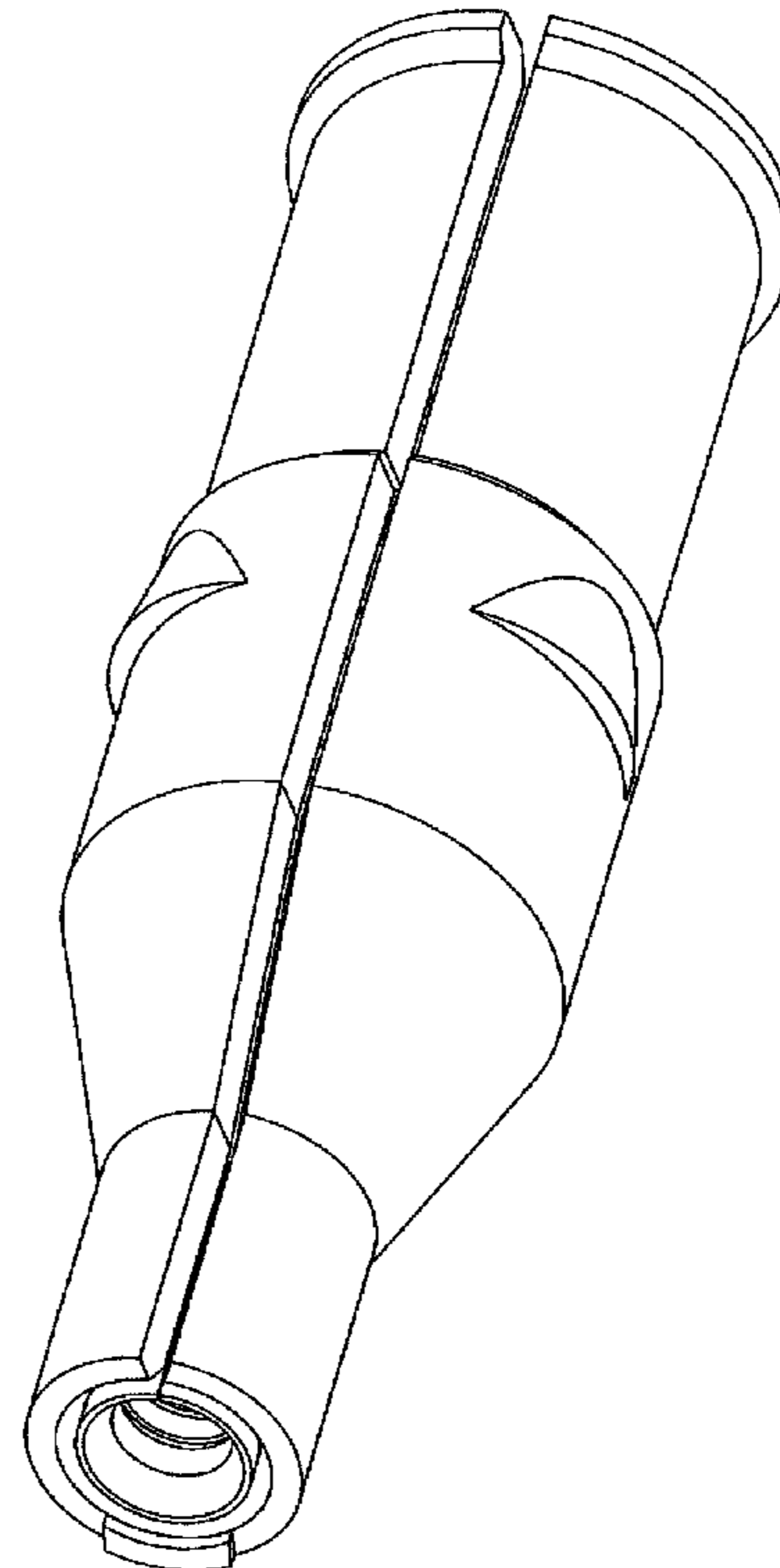
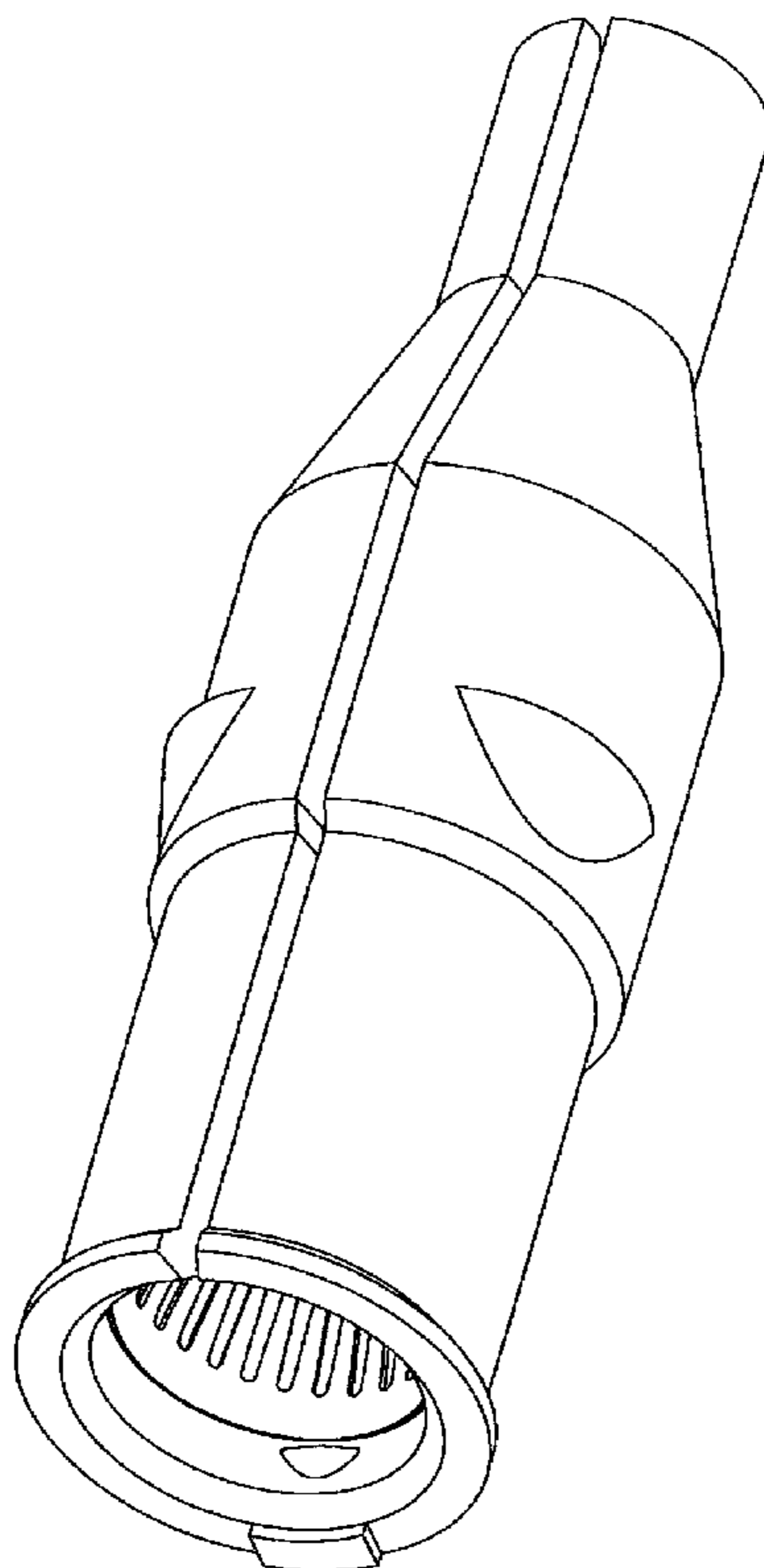

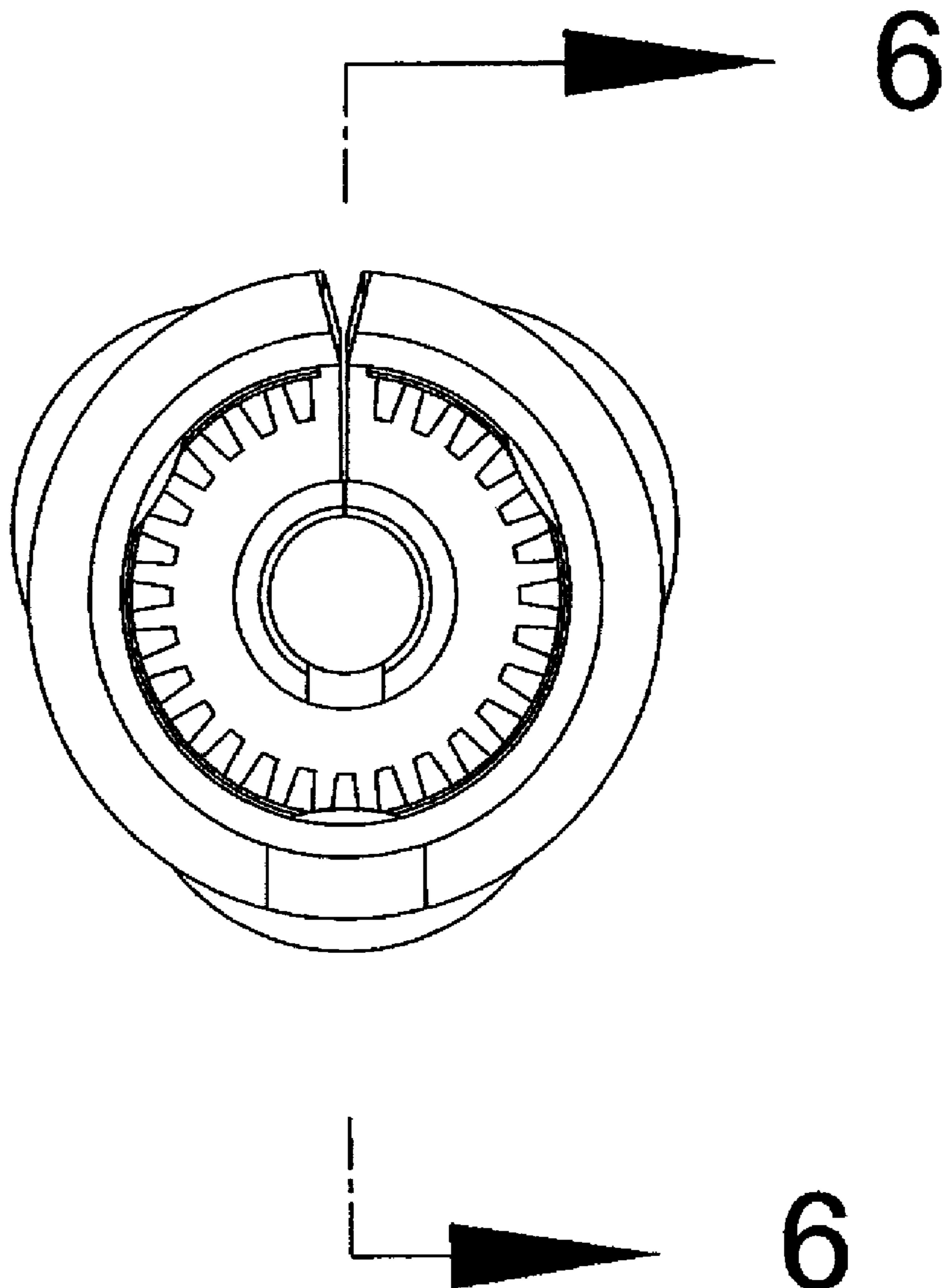

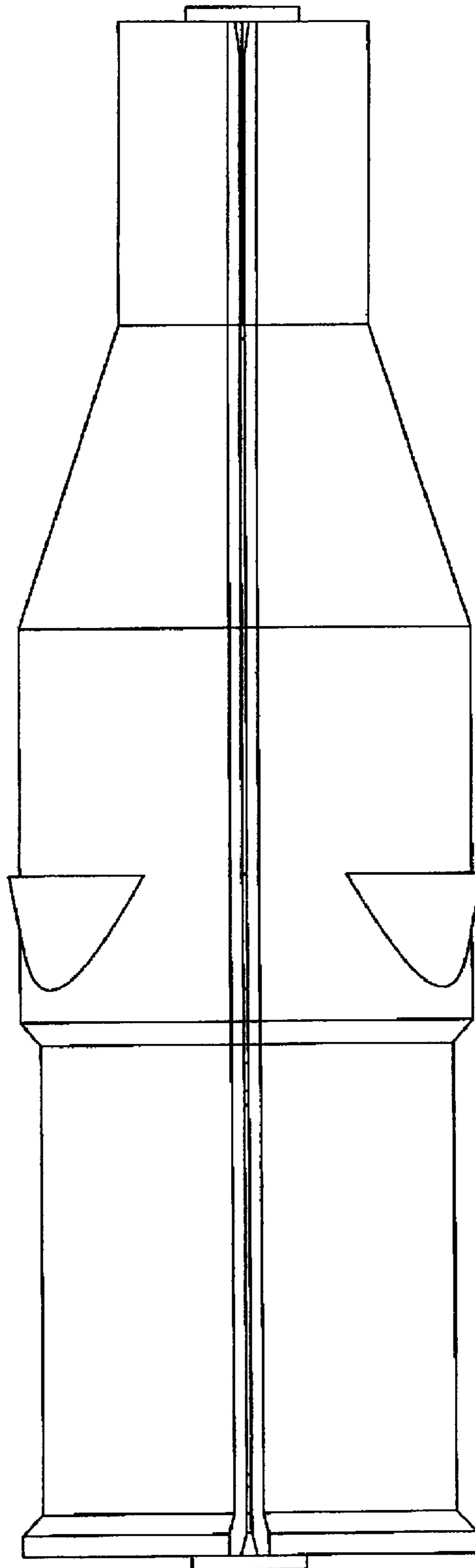

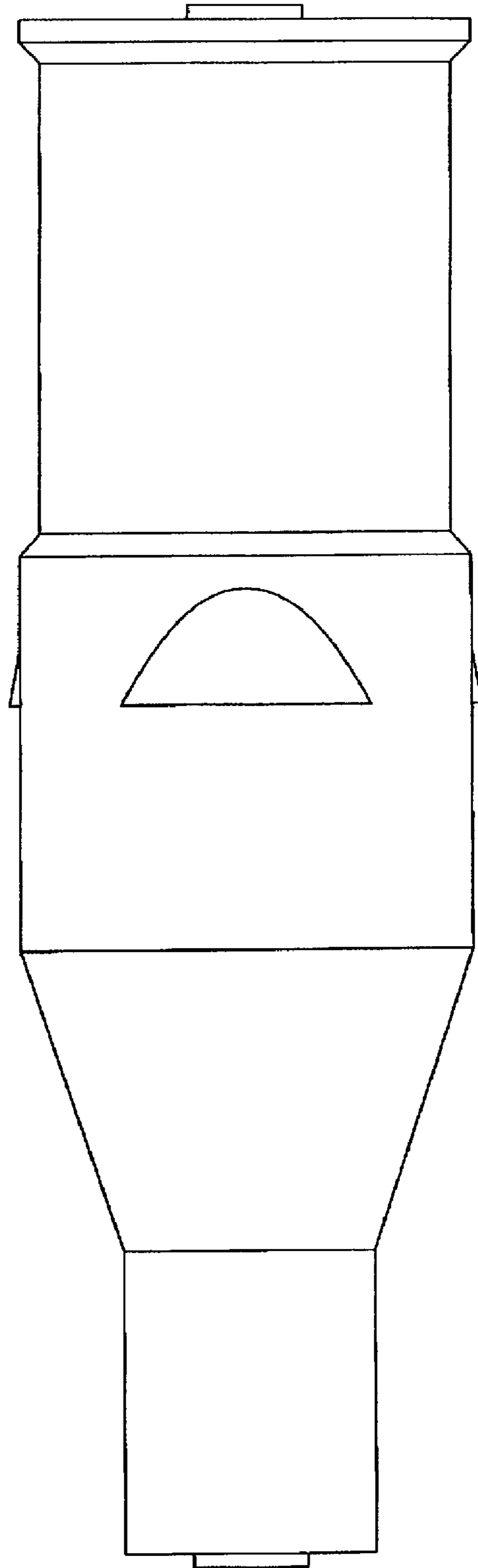

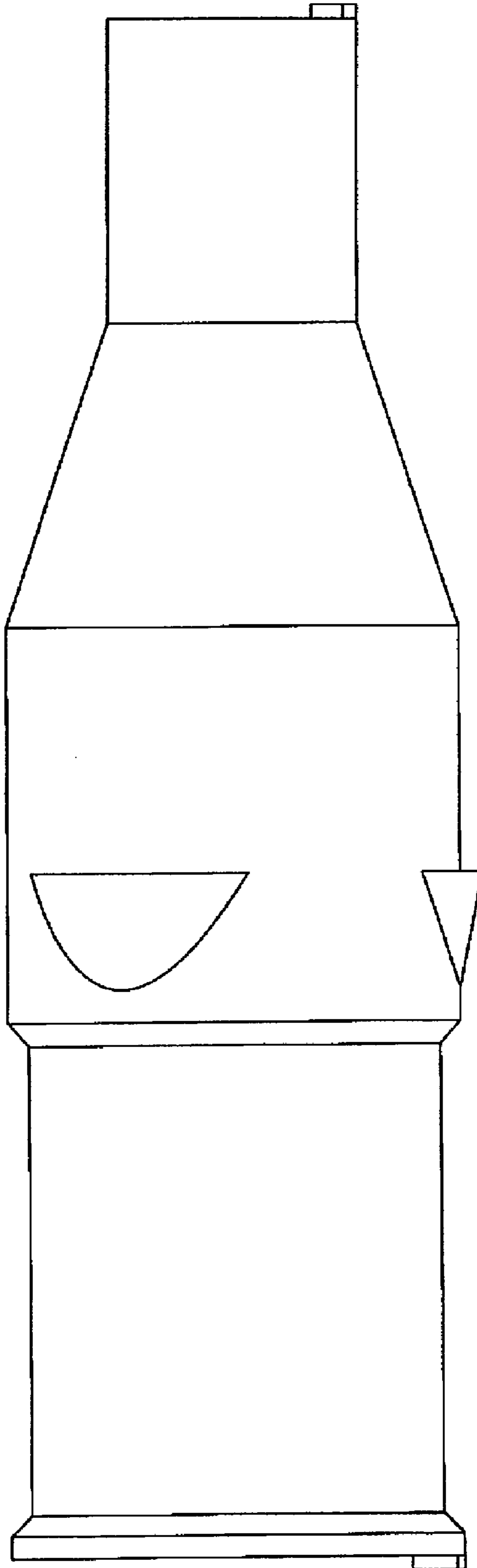
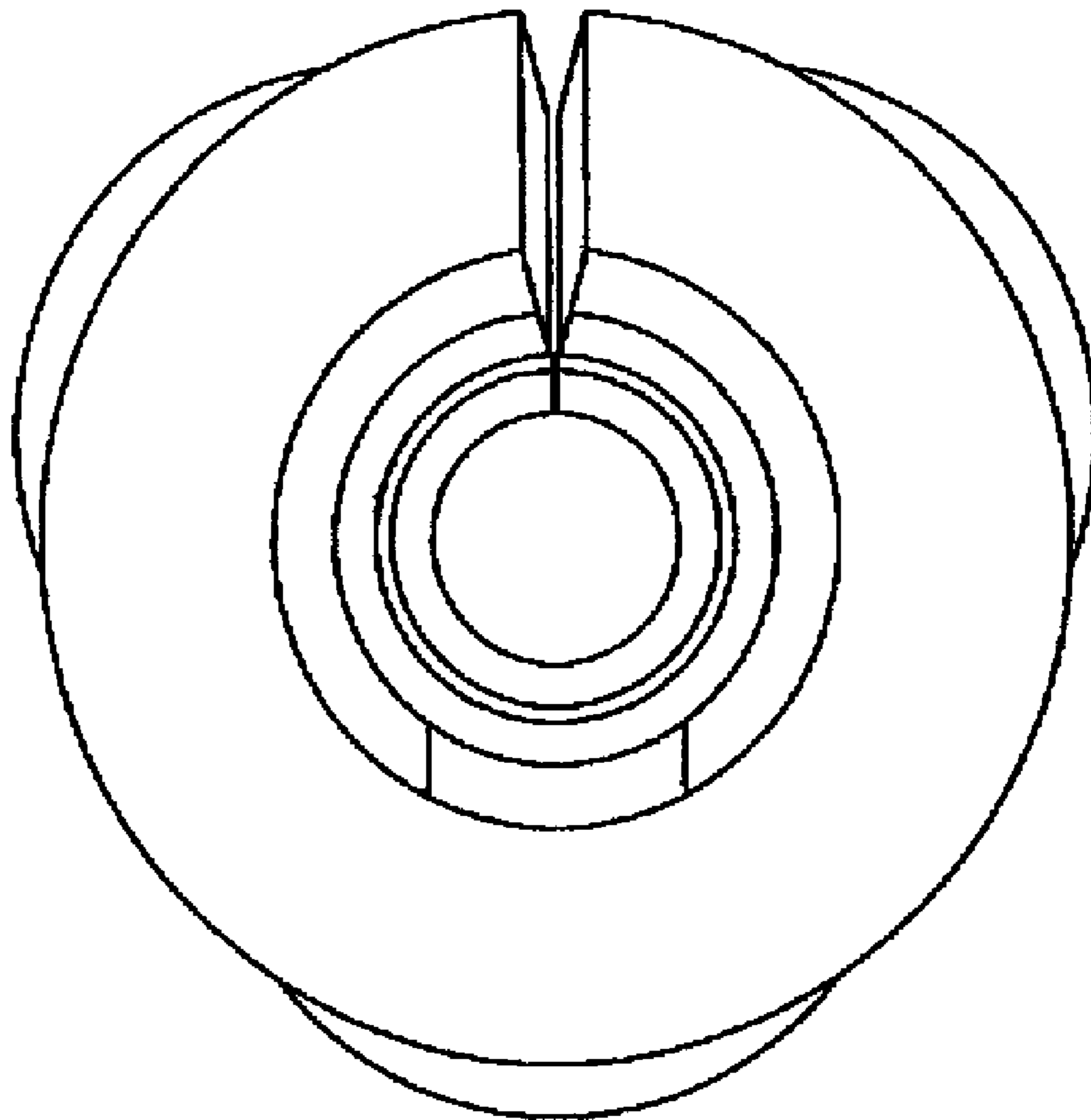

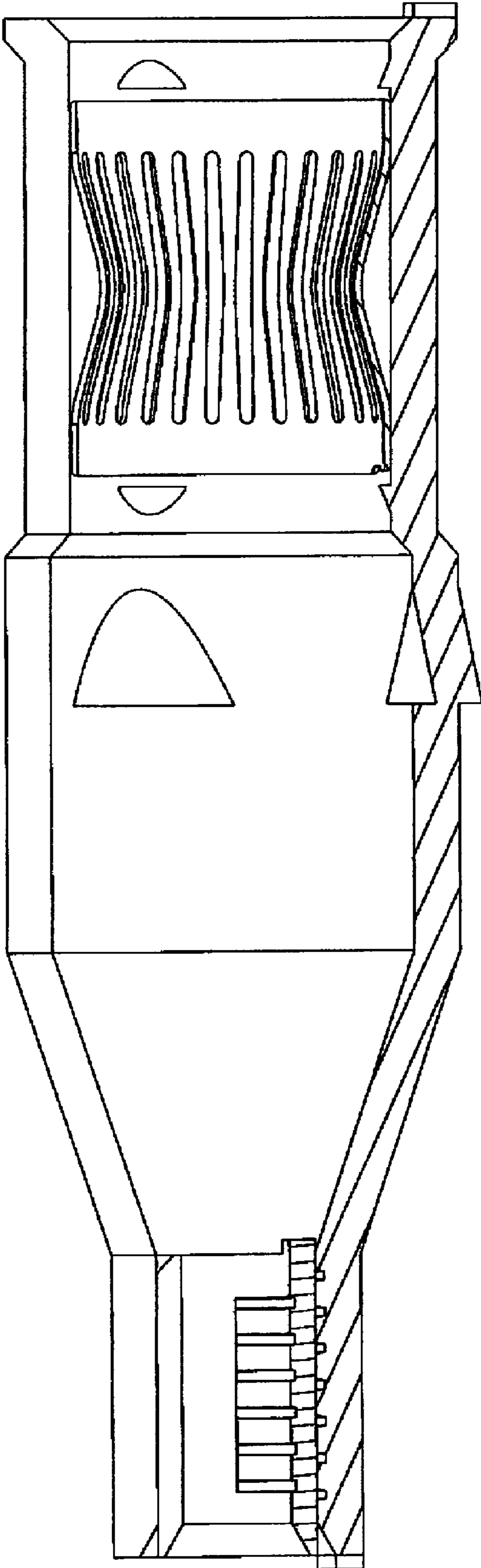
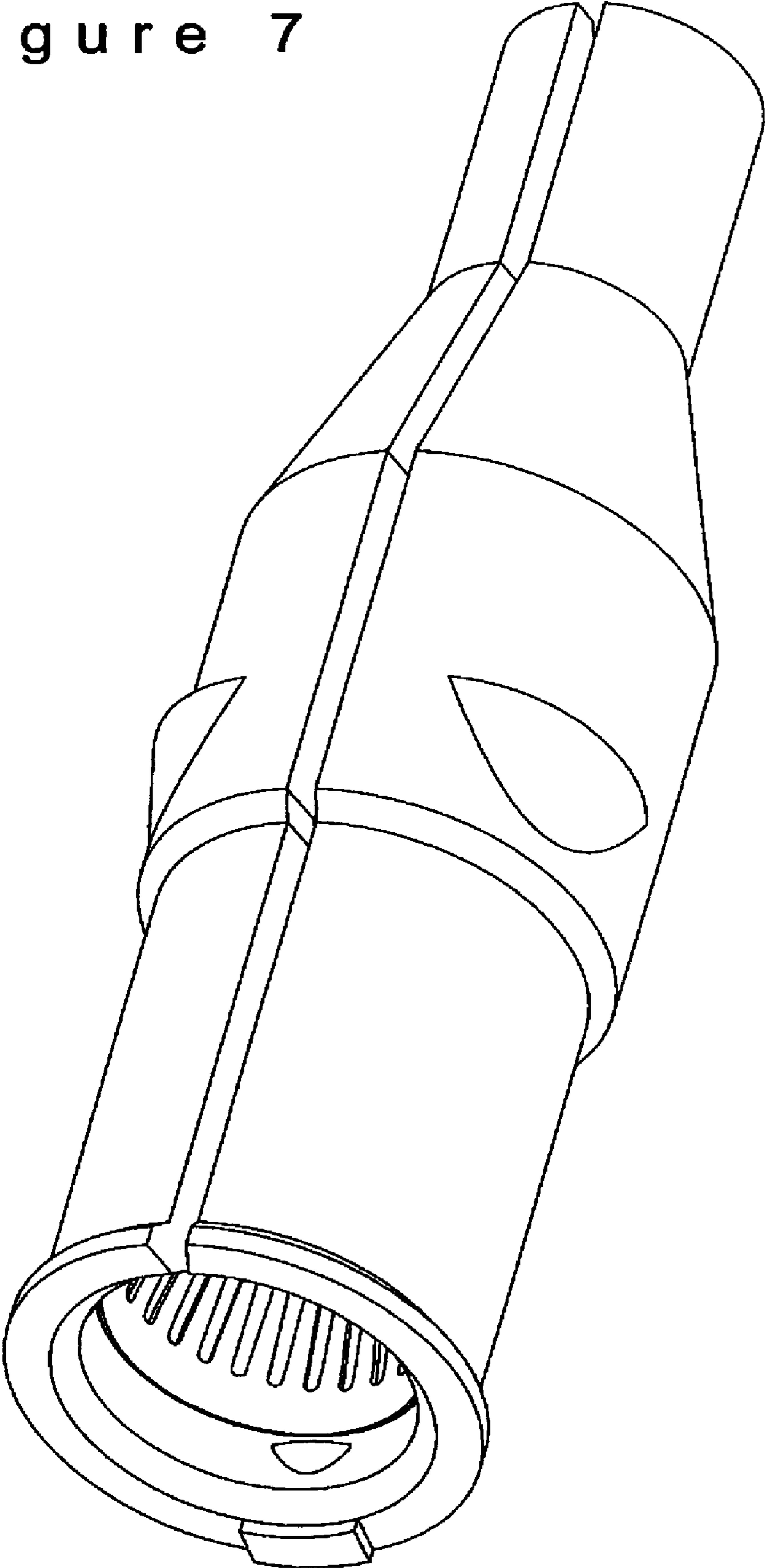

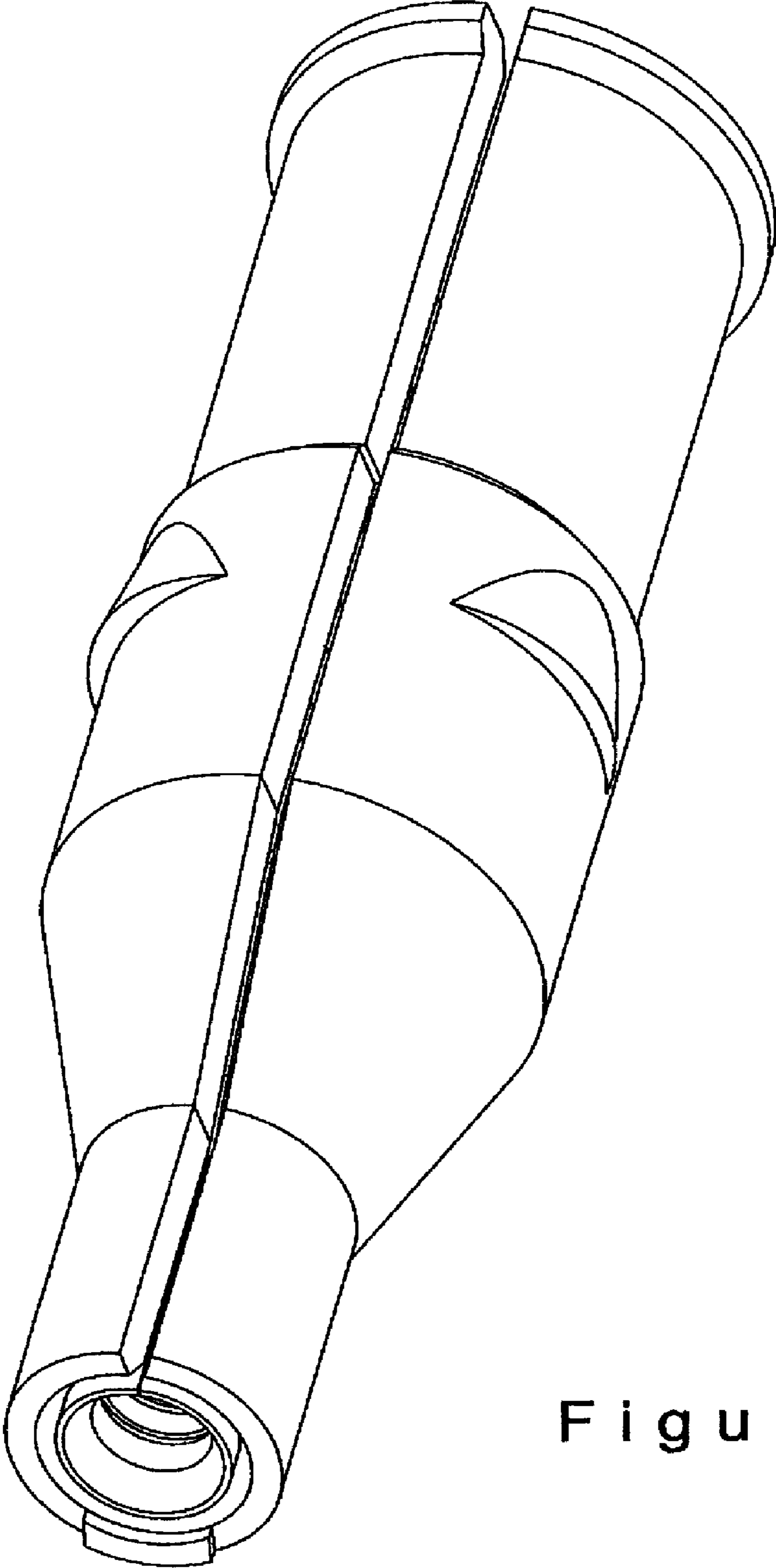
