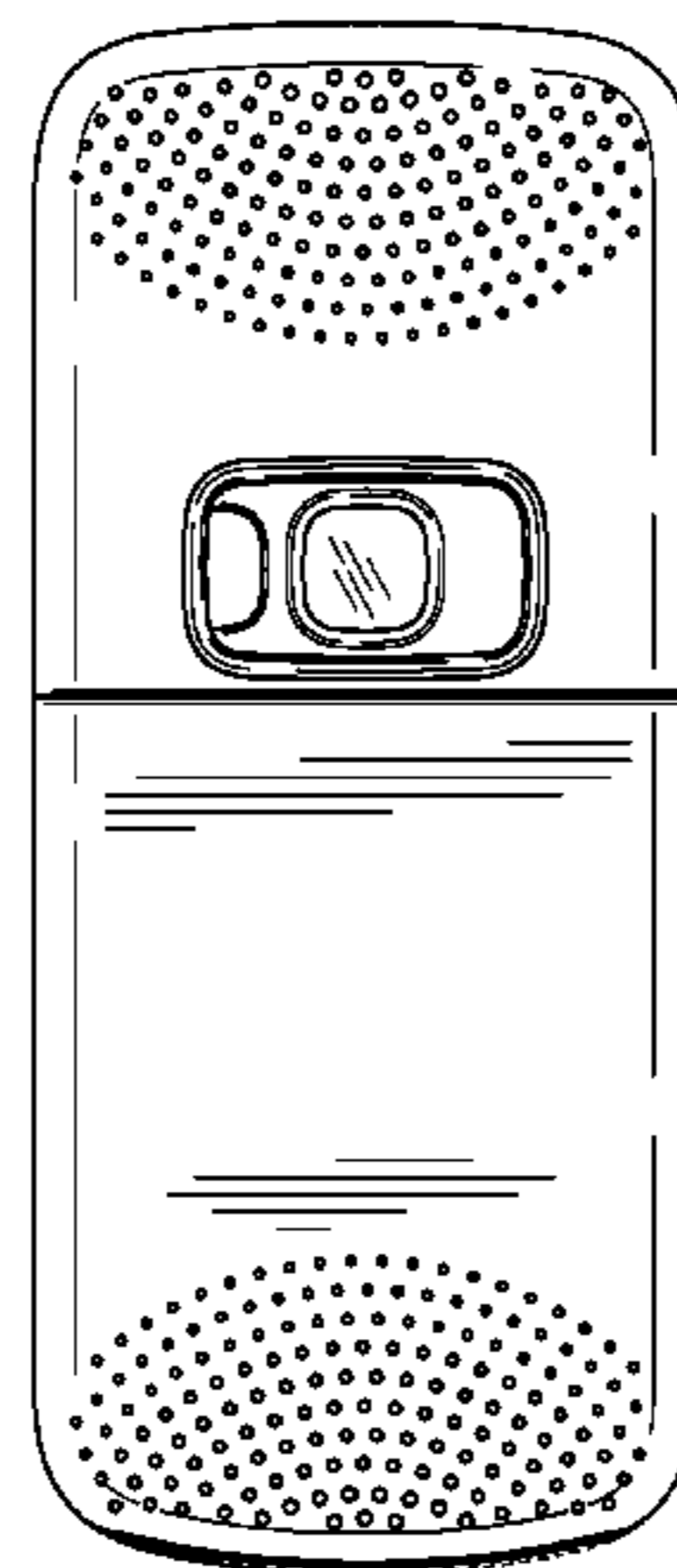
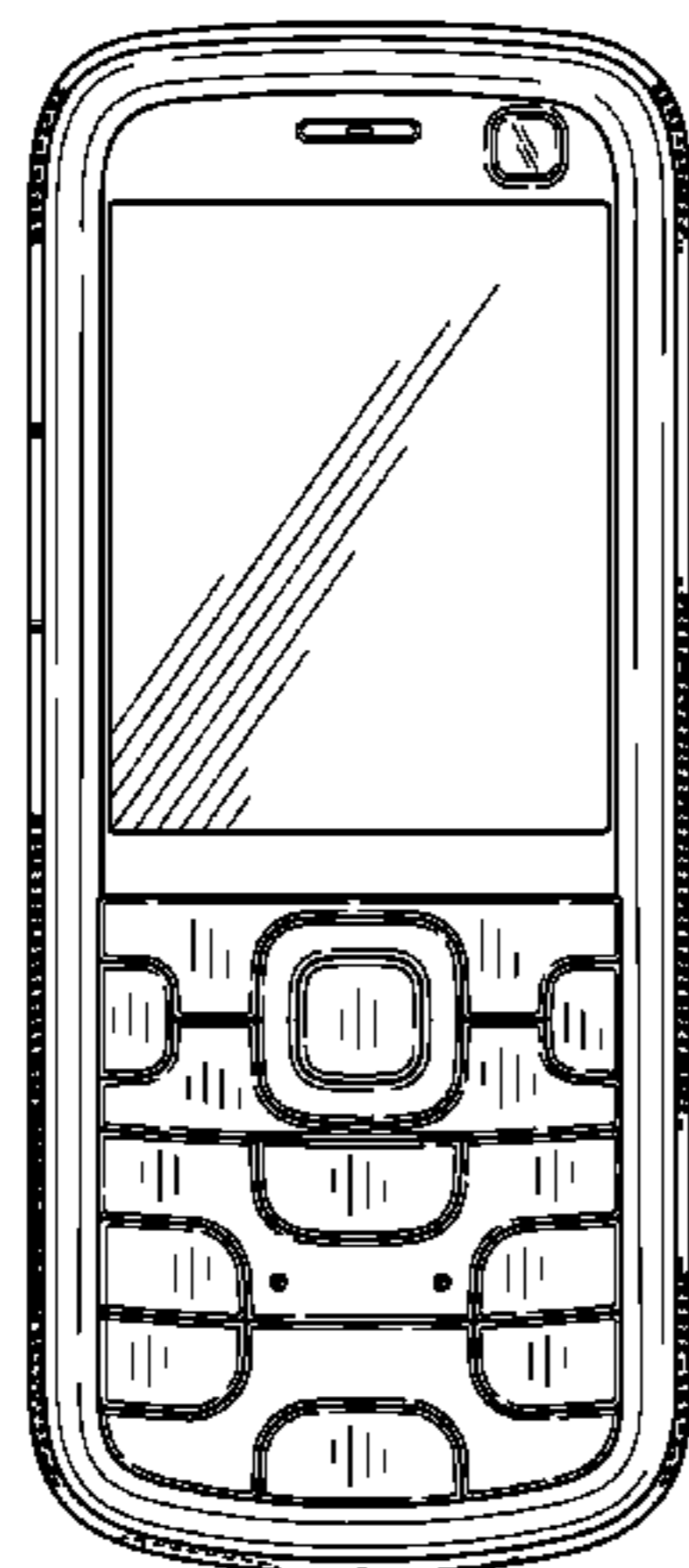
The ornamental design for a handset, as shown and described.

DESCRIPTION

- FIG. 1 is a front perspective view of a handset showing my new design;
- FIG. 2 is a front view thereof;
- FIG. 3 is a rear view thereof;
- FIG. 4 is a right side view thereof;
- FIG. 5 is a left side view thereof;
- FIG. 6 is a top view thereof;
- FIG. 7 is a bottom view thereof; and,
- FIG. 8 is a rear perspective view thereof.

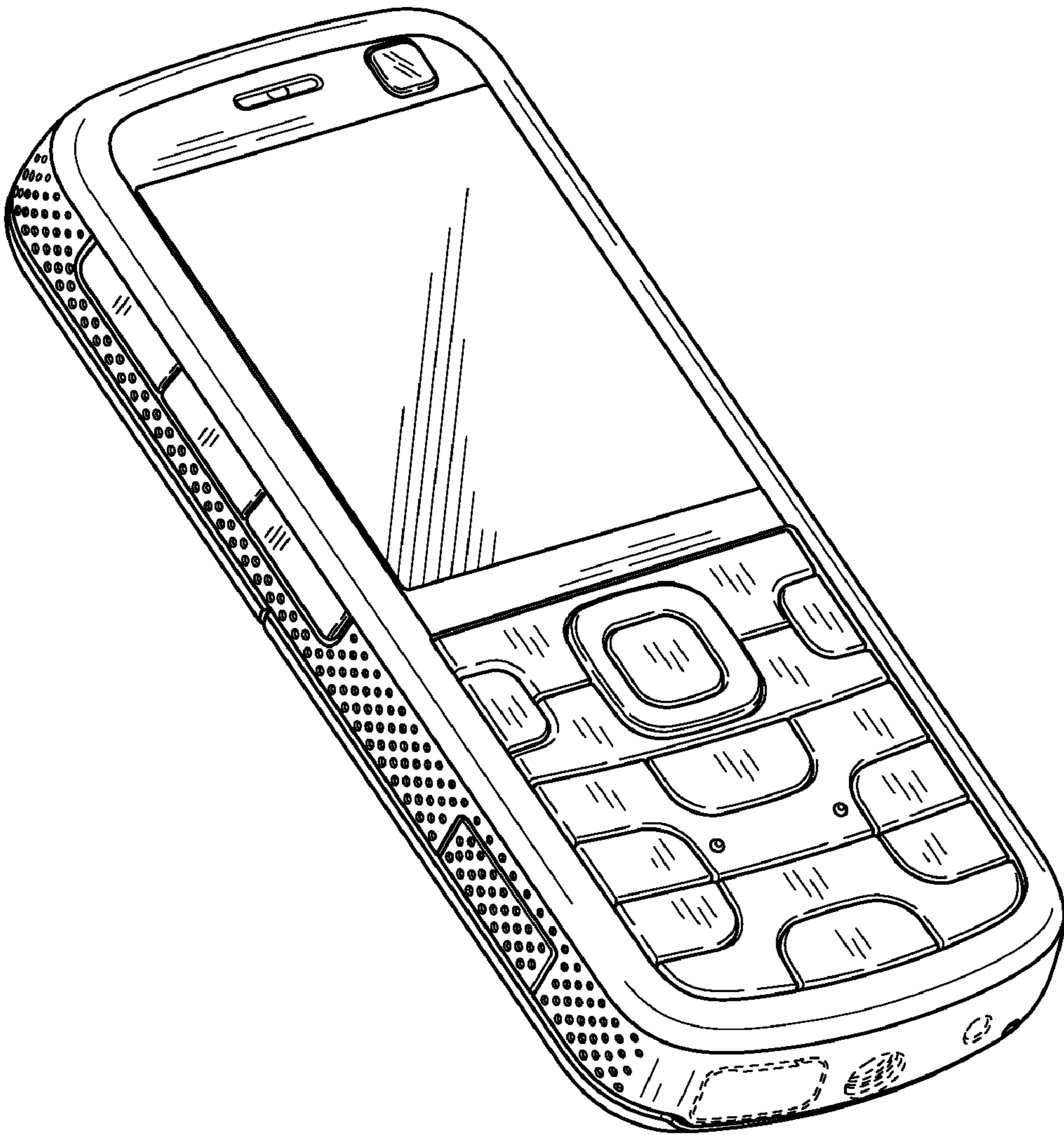

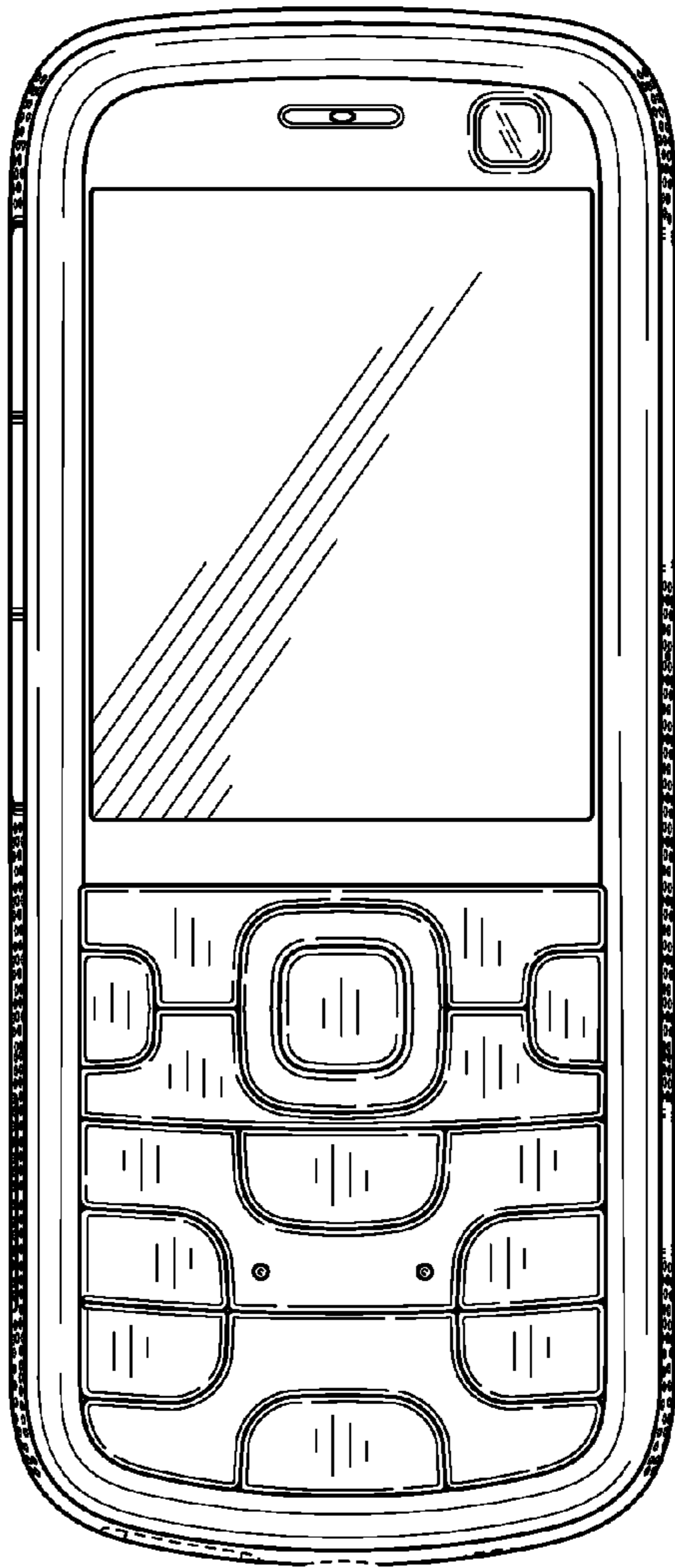

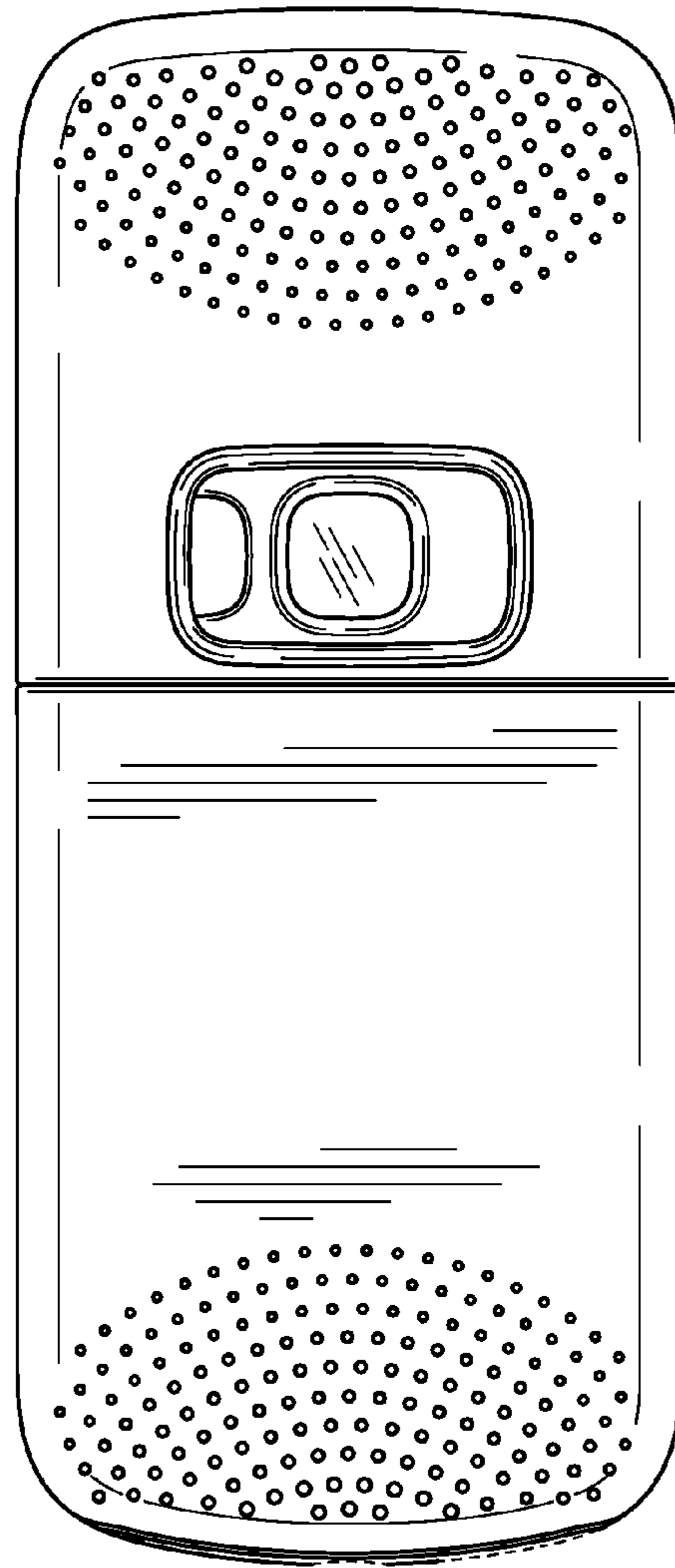

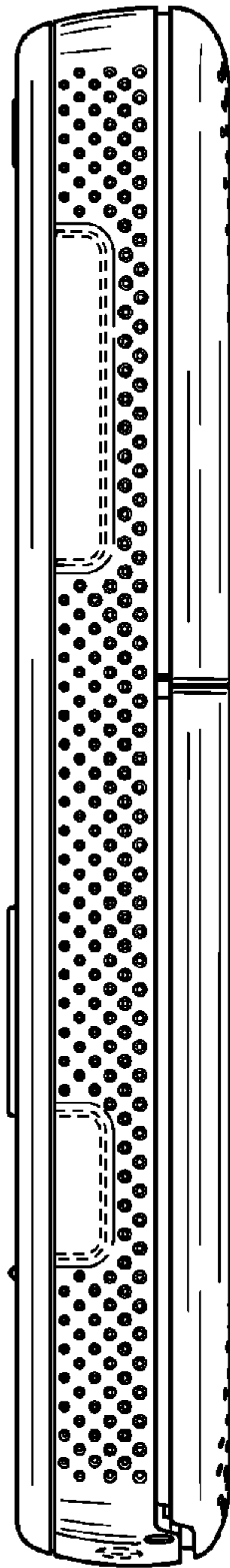

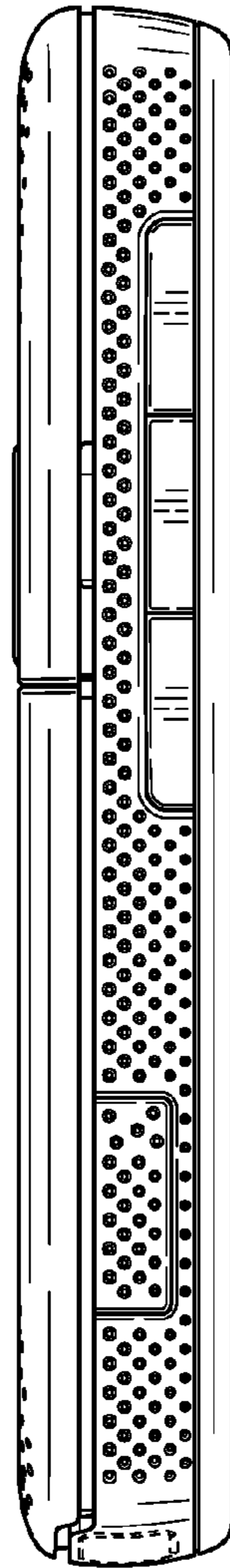

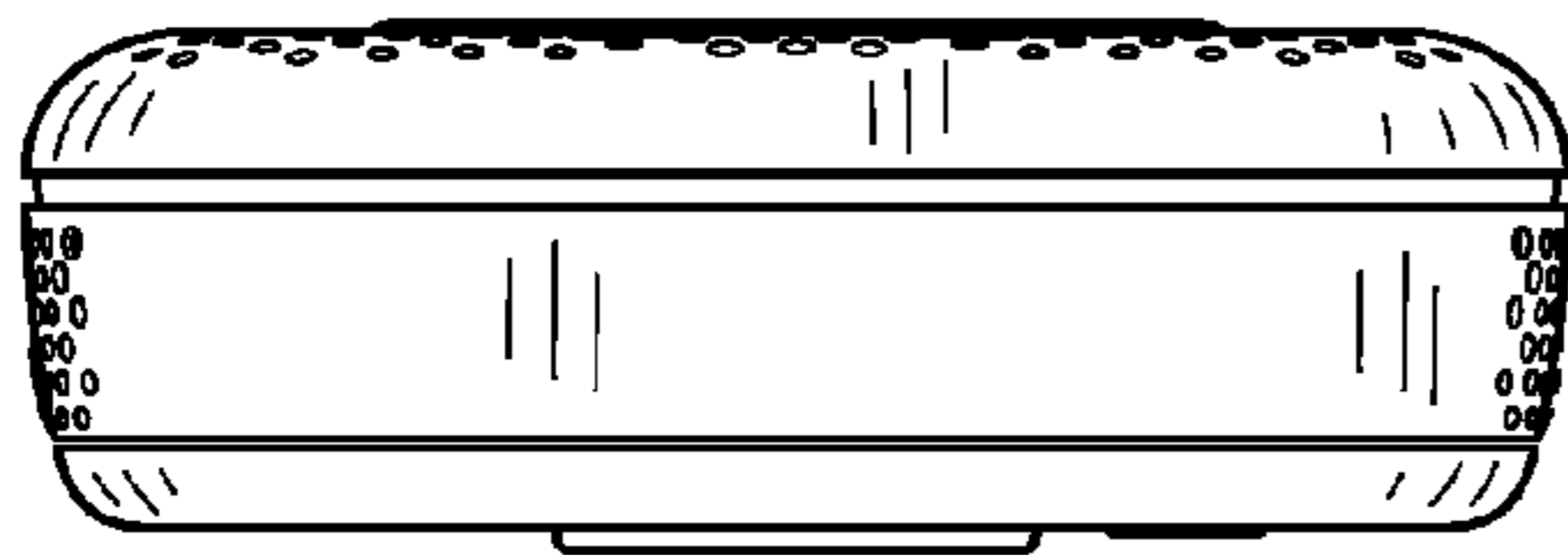

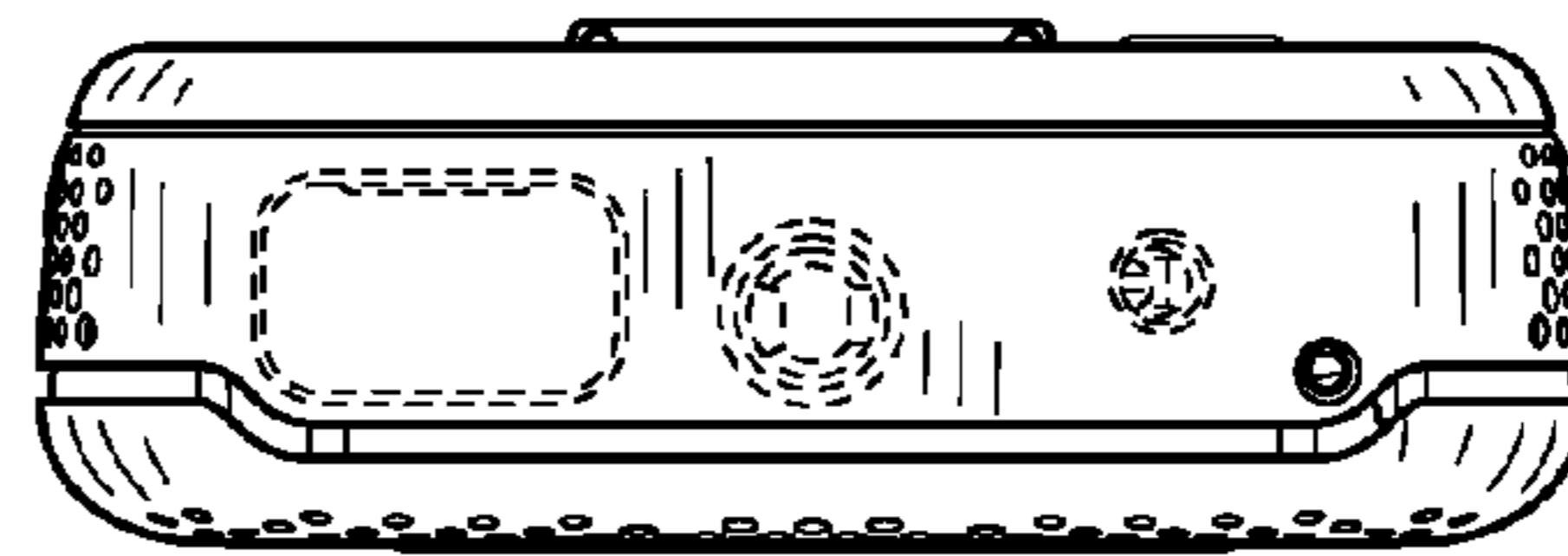

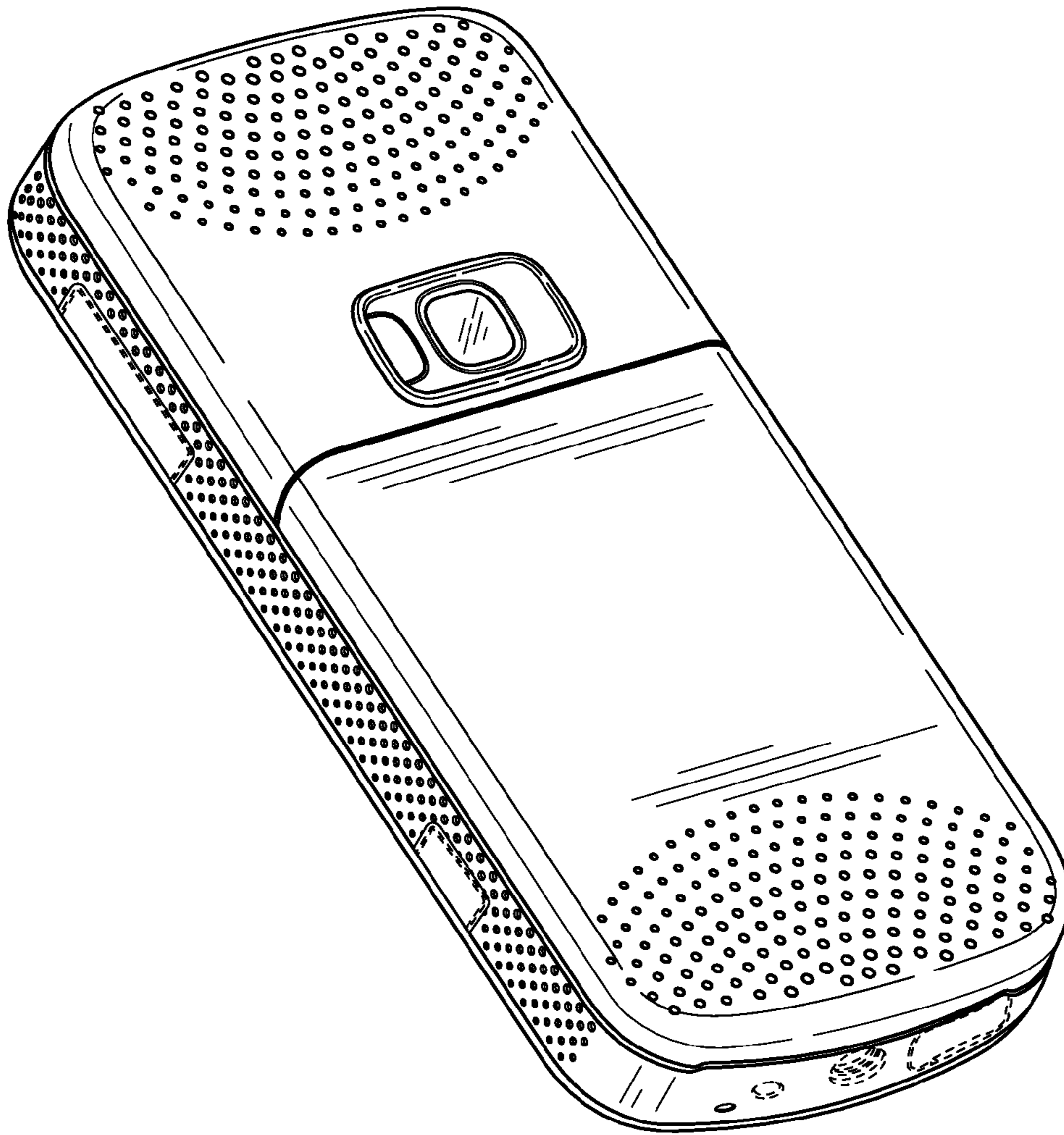
